Collecting Data on Hummingbirds in Placerville



Banding hummingbirds for science helped provide an educational opportunity for children in the Placerville area. Each bird refueled with sugar water before they were released.

PLACERVILLE -- Fred Bassett was in Placerville on July 2, 2021. He is the founder of Hummingbird Research, Inc., which was created in 2009. Fred banded, weighed, and measured wings and bills of 38 hummingbirds over two hours.

While doing the banding, he kindly answered questions from the children and provided

many interesting facts about hummingbirds. He said the oldest hummingbird he was able to track was 12 years old. The average hummingbird's lifespan is only about two to five years, and they have an 80% mortality rate.

Bassett enters the data he collects into the National Bird Banding Laboratory, to further track these migratory birds.

Two Found Dead in Clear Creek Area



IDAHO STATE POLICE STATEMENT: Detectives with the Idaho State Police, in cooperation with the Boise County Sheriff's Office, are investigating the deaths of two men found in an RV. Although the investigation is in its early stages, at this time there does not appear to be an ongoing public safety threat.

What happened: Saturday, July 10, 2021, deputies with

the Boise County Sheriff's Office were contacted about concerns from a neighbor who had not seen the two men for several days. Both lived in the RV which appeared permanently parked in the Clear Creek area of Boise County off highway 21. A deputy conducted a welfare check and found the two men deceased. The Idaho State Police were called to assist Boise County in investigating the deaths.

Further details surrounding the deaths remain under investigation.

Editor's note: Boise County's Sheriff Scott Turner said they were currently trying to contact next of kin and process the evidence.

Alexander "Alex" Drew Mackin
1986 - 2021

Alexander "Alex" Drew Mackin died at the age of 34, on Memorial Day, 2021, in Sandpoint, Idaho. He was born in Austin, Texas on September 2, 1986. His parents Tom and Rhonda Mackin chose to move their young family to Wilderness Ranch, in East Boise County, Idaho and then into Idaho City, where Alex and his sister Lindsay grew up, attending Idaho City public schools, from Kindergarten through High School. Alex excelled at all sports, playing on football, soccer, basketball, and baseball teams, throughout his childhood and young adulthood. He was awarded the Conference Player of the Year, in football, his Senior year of high school.

He loved to shoot, hunt, and fish, especially in the place he loved the most - North Idaho. He was also known for his intelligence, creativity, musical ability, wit, and entrepreneurial spirit. When describing Alex, his friends, family, and co-workers alike most often mention his sense of humor as being what they will remember most.

His accomplishments were wide-ranging and far-reaching. In 2011, he was awarded the Best Undergraduate Poster, at the Montana Academy of Sciences, while attending University of Montana Western, as a Science major. His project was entitled "Geometric realization of (13,3) and (13,4) round robin tournaments."

Alex was truly a self-made man, honing his skills and developing his knowledge online, reading, watching YouTube videos, and auditing lectures. In 2013, he started his own Energy Transport company, Black Horizon, LLC, in Texas. He wrote everything from songs to commentary to novels. He programmed video games, built everything

from custom computers to guitar pedals, and drew up engineering plans for innumerable inventions.

He wandered the United States, working long hours, as a Jack of all trades, with the USFS, and in the North Dakota and Texas oil fields. He called home everything from a truck cab, RV, apartment, or cabin, to a hand built yurt to a tricked out blue van. He played his guitar in bars, to break rooms to backyards, to the CMA Festival in Nashville, all while making life-long friends at each step along his journey.

After a long and exhausting battle with recurring mental illness and debilitating sleep deprivation, that journey came to an end in the woods that he loved, near friends whom he held dear.

Alex is survived by his parents Thomas Patrick Mackin and Rhonda Weinberger Mackin Jameson, sister Lindsay Kathleen Mackin Smith (Mitchell Smith), niece Paisley, aunts Risa Weinberger, Patrice Mackin Elmer and Diane Waits, and cousins Bobby and Julie Fisher and Catherine and Laura Waits. He is preceded in death by his grandparents Beth and Ervin Wenberger and Therese and Patrick Mackin, as well as his uncle Paul Mackin and cousin Andrew Waits.

Memorials for Alex have been occurring all over the country. A local Idaho City gathering is being planned for Labor Day weekend.

John Thomas Tucker was born July 25, 1930 in Boise, ID, the son of Wilbur and Maude (Jennings) Tucker. He died June 26, 2021 at a care center in Emmett, ID at the age of 90.

John graduated from Garden Valley High School in 1948. Following graduation, he worked in various local jobs in Garden Valley, including core drilling.

John joined the military and served in the United States Army Signal Corps from March of 1951 and was honorably discharged in February of 1953. Following his discharge from the military, he began a 20-year career with the Bureau of Reclamation.

In 1963, John married Pilar Elorriaga in Jordan Valley, Oregon. They lived in Jordan Valley for 10 years, before moving to Garden Valley, ID

in 1973. In Garden Valley, John became a rancher.

John was a member of the Elks Club in Caldwell for over 50 years, the Poachers Club, and the Payette River Cattle-men Association for over 20 years.

John is survived by his brother, Jim (Letha) Tucker; his sister, Virginia Marston; and numerous nieces and nephews.

He is preceded in death by his wife, Pilar Elorriaga Tucker.

Funeral services were held on July 8, 2021 at Summers Funeral Home, 3629 E. Ustick Road, Meridian. John will be buried with his wife, Pilar, at the Jordan Valley Cemetery at a later date. Memories and condolences may be shared with John's family at www.summersfuneral.com.

BOISE COUNTY COMMISSIONERS

July 6, 2021

Present: Commissioners Ryan Stirm, Steve Twilegar, and Robert "Ted" Holmes

Pledge of Allegiance

EXECUTIVE SESSION: None

CONSTITUENT INPUT:

A constituent from Clear Creek area spoke about guns being shot off within the neighborhood. He was concerned about stray bullets and shooting over houses to shoot elk. "You don't need to be shooting in your neighborhood!" He suggested making an ordinance for subdivisions. Chairman Stirm stated, "We will certainly take it up with the prosecutor and see what our options are."

Commissioner Twilegar asked if the Home Owners Association had disbanded in 1992. He continued, "Inside your HOA, there should be some language that describes shooting." Twilegar said he believes in "self-governments" and suggested the constituent went to his neighbors to form the HOA.

Commissioner Stirm said they would take it up with the prosecutor, the sheriff, and see what their options were.

Traci Weaver, the new District Ranger from Lowman, said she wanted to stop in to say hello and to see if the commissioners had any concerns regarding the Forest Service.

They asked regarding Kirkham Hot Springs and she said it's "going well this summer, so far." The Forest Service is going to meet with the community again in the early fall. They have some ideas about having it concessionary run, which would open the campground year-round.

Commissioner Stirm mentioned that they were thinking of making an ordinance that would make it a misdemeanor to dump trash outside a receptacle, which would help them with enforcement.

MINUTES: The minutes were approved from June 29th, 2021.

EMERGENCY MANAGEMENT OPERATIONS PLAN:

Commissioner Stirm asked if there were any questions and if everyone had read through it. "We're going to have to change the name on the bottom of who wrote it," Stirm said. It will now say Trinia Richardson. He motioned to adopt the operations plan.

MAINTENANCE AGREEMENT FOR AIR CONDITIONING: This annual agreement would cover all the oil changes and emergency generators throughout the county-- schools, courthouse, and senior centers. This is the first year for this company to agree to this maintenance in the amount of \$1340 for generator maintenance.

SHERIFF: Scott Turner said they are having some issues with getting the mapping done with software, and have exhausted all his resources with the Assessor's office. He spoke regarding purchasing further software with Motorola. Sheriff Turner has been working with Clerk Mary Prisco to include the cost in next year's budget. The first invoice would be due in October.

Commissioner Stirm motioned to approve the contract between the Sheriff's office and Motorola Solutions GIS for one year in the amount of \$10,422.83.

BOISE BRIDGE: Curtis Dill presented information from the Idaho Transportation Department regarding the Boise Bridge, which included the bridge inspections.

ROBIE CREEK ROAD: Dill, acting supervisor for the Road and Bridge Department, said they were getting ready to pave that week. [1 mile of road]

DUST ABATEMENT: Dill said they are working on pricing dust abatement. He said it can be placed down in three ways and is pricing all that, "because it does make our roads last."

FIRE: There was some discussion of the Harris Fire located west of Placerville. Commissioner Stirm asked who had been on that fire, and knew that Horseshoe Bend Fire had been called to be on it. Dill said that Placerville Fire had responded the previous night with UTVs to help and for additional support. The Idaho Department of Lands and Forest Service are primarily fighting the fire. The sheriff said it was on steep terrain, and they were trying to get it contained but were having issues. [Fire has been contained.]

DEMAND WARRANTS:

Chairman Stirm made a motion to pay the Idaho Association of Counties unemployment in the amount of \$3,858.80 for the second quarter fiscal year.

There were two building permits refunded, due to a measurement mistake, and not refunded the total amount due to the inspection.

BROADBAND EXPANSION: An IT person handed out maps of the proposed areas. The grant was discussed, \$10 million dollars in state funds available through the CARES Act that were not spent in 2020. The broadband expansion was discussed, "focusing on household expansion." There's an area in Lowman, from the Lowman Fire Station and up to Lewis Drive, for fiber build. There are about 120 homes and the total cost is approximately \$650,000 that does fit within the grant parameters. "There should not be any expenses from the county." However, the county would submit the grant for the unincorporated community. The facilities will be installed by the internet companies.

EAST BOISE COUNTY AMBULANCE: Director Melissa Potts, working with the dept. over the last three years, reported that in 2017, \$16,542 was brought in for ambulance billing fees. In 2018, \$5,250 was brought in. She came in at the end of 2018, "Here's the change, \$110,100." Commissioner Twilegar asked what changed and she responded, "The billing was getting done." She wanted the commissioners to know that she was "actually bringing revenue in." She stated a typical 40-hour per week job is typically 280 hours a year. However, in 2020, she had 1,418 hours on call. "I just want to give you an idea of how much time we actually dedicate to this." They have to keep track of every single run and enter information into the computer, volunteer reports, patient payments, inspections, continuing education, experience, working with Life Flight,

making sure one ambulance is in service at all times, maintenance on ambulances, etc. The Idaho Bureau of EMS reached out to Potts to gather her advice for other rural EMS agencies on recruitment and retention, "They look at our roster, I keep a roster with the state, and they see how well we grow. And what I told her was the EMT classes is a big thing. We put on one every year." Last year, they had 406 calls, up from 356 from the previous. "It's on track to be more this year. It's just steadily growing as more and more people have discovered Boise County."

Lowman has a driver and is almost ready to be up and running. Placerville is looking to be in service a few days a week.

Commissioner Stirm recounted, "The volunteer agencies are going to struggle for a lifetime to keep going."

Commissioner Holmes asked if they keep track of calls, "I want to see a copy of that. I want to figure out what are your busiest days. I work for the citizens out there, so you guys. My point is, we're going to provide the best service without working overtime for

the citizens out there." He continued, "If it's busier on weekends, and each one of you, correct, is trained and well enough to work independently with a volunteer? I want you to be working in shifts. I want to see that paperwork which shows which is your busiest days and then we want to figure in the possible shiftwork. And that coverage will eliminate some of the overtime." He said he was going to look at the policy to change it to paying for shiftwork. Potts said, currently, they don't get paid overtime. She didn't know where the money would come from, and Commissioner Twilegar said, "Let us worry about that." Commissioner Stirm said, "We'll figure it out."

Potts assured the board that they were not just sitting there when they're waiting for a call; they handle all the business side that needs to be done. "We are actually working." She added, "We don't miss calls. That does not ever happen. We always take calls."

Fire Chief Bonovich with Clear Creek would like to have a longterm plan to protect the fire departments and liability.

Very Few Takers at St. Al's Mobile Vaccine Unit in Horseshoe Bend as Delta Variant Cases Increase

BOISE COUNTY -- St. Alphonsus Health System's Community & Well-Being team was in Horseshoe Bend July 6th -10th providing COVID-19 vaccines to the community. A Mobile Vaccine Unit (MVU) was set up in the parking lot on the Horseshoe Bend School District's campus. Looking like something out of the movie *E.T.*, the MVU was furnished by the Federal Emergency Management Fund. With a sign-in area, vaccine area, and observation room, the MVU was outfitted with an air conditioning unit that left the 100+ temperatures outside.

The make-shift clinic will return the week of July 27-31 to administer second doses of the Pfizer vaccine. Those that opted for Johnson & Johnson's Janssen vaccine needed only the initial dose.

On Saturday, shortly before packing up the MVU, the clinic had given out only 4 doses. According to staff, the turnout had been very low.

According to John Hopkins University, the United States averaged 19,455 cases of coronavirus last week, which is a 47% increase over the prior week. There are currently 5 hotspot states, which includes Idaho and border state Nevada. According to the Chief Administrative Officer, Erik Frederick, of Mercy Hospital in Missouri (another hotspot state) 91% of their intensive care patients are on ventilators and many are in their 20s, 30s, and 40s. Frederick sent out a tweet last week stating, "People say they don't want to be lab rats for the vaccines. If we don't get vaccinated we're all lab rats for the virus. It will keep experimenting on us and finding new ways to beat our defenses. It will change. Evolve. On and on. Please get vaccinated."

According to Central District

Health on Tuesday, July 13th, Boise County saw a jump in cases last week - up to 8. This puts the county at the highest rate per 100,000 in the CDH region and would fall in the moderate risk category per CDH and CDC school guidelines. Ada County also saw a significant jump in case counts - doubling from the week prior.

As of July 8th (usafacts.org), Boise County had 3 new cases and Ada County with 252 new cases reported out of Idaho's 485 total.

From the CDC website, "The B.1.617.2 (Delta) variant is highly transmissible in indoor sports settings and households, which may lead to increased attack rates. Multicomponent prevention strategies including vaccination remain important to reduce the spread." The CDC's website addresses many of the vaccine myths.

The World Health Organization (WHO) has estimated that the Delta variant is 55% more contagious than the original virus that began in Wuhan.

Idednews.org reports that "as the Delta variant becomes the predominant form of coronavirus in the United States, some health officials say this more contagious strain could pose threats to schools and children who cannot get vaccinated."

They added that Dr. Taylor Nelson, a University of Missouri infectious disease specialist told the 74, a web-based education news site, "(It's) one of the most dangerous time periods (in the pandemic) for people who aren't vaccinated."

Dr. David Pate, a member of Governor Little's coronavirus working group, told Idednews.org that "he was concerned and felt that school officials don't seem to be doing enough to plan for a virus that might be more aggressive than its predecessor and that even if young people are less likely to get se-

verely ill or die from the new (Delta) strain, schools could likely become focal points for community outbreaks, especially in areas with low vaccination rates."

Boise County is one of those areas with only 28% of the community vaccinated. Overall, the state doesn't fare much better with only 36.45% of the population fully vaccinated.

In contrast, Ada county has 58% vaccinated (USAfacts.org). On July 9th, the CDC updated its protocols for a safe return to the classroom. They stressed that in-person learning and safely returning to the classroom was a priority this fall and that vaccination was the number one available action to end the pandemic.

The CDC is promoting vaccination as a way to help schools safely stay open and to keep extracurricular sports and activities going. They recommend that masks be worn indoors by all individuals age 2 and older who are not fully vaccinated, and are especially important indoors and in crowded settings where physical distancing cannot be maintained. They also recommend that schools maintain at least three feet of physical distance between students in classrooms combined with mask wearing by anyone not fully vaccinated.
