Blaze Miraculously Contained in Robie Greek Area

ROBIE CREEK -- A fire alert phone call went out to nearby residents in the Robie Creek area late Saturday night, July 24th, detailing that an ongoing fire had gained several acres and was burning up Rocky Canyon Road. Local volunteer firefighters were called out and went to work immediately with hand tools and chainsaws, sometime before 11pm. The men and women were bound and determined to get a line around the fire, with some hope that they could stop this blaze from spreading to neighboring homes and into the community.

This was one of those very close catches that could have easily gotten out of hand, said Robie Creek Fire Captain Patrick Unrein on social media. "After the initial callout, crews were on the scene within minutes. This was very steep terrain and the firefighters attacked it very well. Once again, job well done!"

The Idaho Department of Lands fire crew joined in the efforts after 1am. By that time the local firefighters had successfully forged a fire line along the perimeter of the fire.

Chuck Stamm, a local volunteer firefighter, couldn't to assist us. As we arrived help but take a photo of those hardworking folks that saw the impending threat through the night and were rewarded by their efforts in the morning light. He said that although it was a very long and hot night, they were all smiling inside.

Camille Wassom, a fire-fighter with Robie Creek, said on Sunday morning, "As of 6 am, we called the fire contained. It was an amazing catch by Robie Creek

and Wilderness Ranch Fire, and only a nine-person hand crew! Last perimeter check, it was at just over two acres on some very steep terrain. IDL will stay on the fire for mop up. Good work tonight everyone!"

Wilderness Ranch Fire Chief Colton McCarthy confirmed that the fire burned a little over two acres, including a few pine trees, but mostly grass and brush. He added, "It was a tight road with limited access, so we had to shuttle most of the firefighters in on side-bysides. It was a good catch by all the firefighters. They put in a handline with chainsaws and hand tools and stopped the forward progression of the fire relatively quickly considering the dry fuels and steep terrain the fire was in. We really appreciate the homeowners in the area that helped shuttle our firefighters and supplies into the fire."

Robie Creek Fire Chief Nathan Bowers recounted, "We were called out late Saturday evening to reports of a fire on Rocky Canyon Road. As I stepped out my door, I could see the smoke, and as I was getting dressed at the station, I asked dispatch to call Wilderness Ranch FPD to assist us. As we arrived tive fire burning just above residential structures. As resources arrived on scene, we split up with half of us taking the left flank and the other half taking the right flank. By about 1:30am, we had a preliminary line around the fire and an IDL crew had arrived on scene and assisted us in cleaning up the northwest section of the line to ensure it held. Once we had the line fortified, those that

had to work left to get some sleep and the rest of us settled in for the night to keep an eye on the fire through the night to ensure a weather change would not start things back up again. By 7:00 am, IDL had released both Robie Creek VFD and Wilderness Ranch FPD and began mopup activities."

Chief Bowers continued, "It was a great display of training and teamwork between all departments involved. It was a lot of hard work to get the fire caught, but in the end, we couldn't have done it without the hard work and dedication of the volunteers from both departments giving it their all. I'd like to throw out a huge thank you to the Robie Creek team and Wilderness Ranch FPD for the selfless dedication to get the job done. To IDL for the quick response of getting more resources on scene, and to the residents. The residents shuttled firefighters from Rocky Canyon to the base of the fire, saving precious time and energy. The coffee, snacks, and drinks they provided for our 'midnight snack' were a welcome treat to all."

"I am proud of the way we all came together as a community to prevent a disaster and I am eternally grateful we had no injuries during the fire. In the end the fire burned just under two acres with no structure losses."

All those that responded to the incident included: Robie Creek Fire, Wilderness Ranch Fire for mutual aid, the Boise County Sheriff's Office, East Boise County Ambulance, and an engine from the Idaho Department of Lands. The cause of the fire is still under investigation

Accident on Highway 21



On July 24, 2021, at 10:05 a.m., Idaho State Police investigated an injury crash on SH21 near milepost 16, north of Boise.

Kathleen Peterson, 58, of Idaho City, was driving northbound in a 1996 Isuzu Rodeo. Peterson went off the right shoulder and overcorrected. Peterson then came back onto the roadway, where she overcorrected again and rolled the vehicle.

Peterson was wearing a seatbelt and was transported by ground ambulance to Saint

Alphonsus Regional Medical Center in Boise. Peterson's passenger, Janice Ricks, 50, of Boise, was ejected and transported by Saint Alphonsus Regional Medical Center in

Both northbound and southbound lanes were blocked for approximately three hours.

Present: Commissioners Ryan Stirm, Steven Twilegar, and Robert "Ted" Holmes

Pledge of Allegiance

EXECUTIVE SESSION: Closed session per personnel issue. [Time 9:03 am to 9:37 am] No action required.

CONSTITUENT INPUT: None

MINUTES: The minutes from July 13th and July 16th per special meeting were approved.

PARTIAL TIME PAY-**OUT:** Clerk Mary Prisco said there are several departments, due to staffing shortages, that have accrued compensation time. "The personnel policy states that we don't payout comp time, that we're supposed to manage it and happy to burn it off. In this case, I don't see that that's a possibility." Prisco continued that there was money in the 2021 budget for the payout. Prosecutor Adam Strong stated that this was in lieu of overtime.

The road department is down two employees in Garden Valley, and there are two other open positions. Curtis Dill, interim supervisor, said that several of the operators had scheduled time off.

Clerk Prisco said the court has been without a supervisor for several months and she just received a resignation letter from a court clerk. "Bottomline is, there's way more work than there is people... I foresee the comp time continuing to accrue for at least the next month."

It was discussed that the commissioners pay down the hours, perhaps 80 hours, to avoid paying an increased amount at the higher budgeted pay (cost of living adjustment) for the next fiscal year. Clerk Prisco offered to run the numbers. Commissioner Twilegar would like to see how much to pay it all off, 80 hours and 40 hours. He continued, "I have no problem paying it out, because they are literally doing the work that we don't hire." Chairman Stirm said, "I think it's a great idea to get at least close to zero. I like the idea of 40 hours of rest." and no more than 40 hours on the books.

Clerk Prisco will present 40 hours next week.

DRIVEWAYS: Planning and Zoning Administrator Alex Gross said, "Our ULO does not actually spell out how steep a driveway can be." He continued, "I've had some con-

versations with some fire chiefs around the area who want anywhere from, where they want to come out and inspect it, to no buildings on places with over 10% grade driveway. The Horseshoe Bend fire chief does not want more than 10% grade. The international fire code says 10% is the max. Steeper than 10% can be approved by the fire chief. So, it would take the decision making out of my hands." He asked for direction from the Board as to what to do when there are driveways greater than 10%. This could influence certificates of occupancy and/or building permits. Gross added, "The issue with that is of course life and safety, especially in the wintertime, being able to get firetrucks and ambulances up and down." He said they were going to change it in the permit to make it much clearer.

Commissioner Stirm pointed out, "If they're already there, there's not much you can do about it. If it's already been permitted and it's already been allowed."

Gross said he could issue a stop work order and have them fix the driveway, under the code. Or the second is to not issue a certificate of occupancy.

Prosecutor Strong stated that there will be some pushback and that they really hadn't been enforcing this in years past. There are a lot of driveways "way in excess of 10%."

Commissioner Twilegar added, "The idea of agreeing to anything international just blows my mind."

Commissioner Holmes said with humor, "Anything over 10%, winter is a great toboggan

Twilegar stated, "I get it, I'm on the fire department. I remember we watched a trailer burn, well, it was pretty much gone anyways and there was ammunition going off. So, we were hiding behind trees. But, there was no getting to it. You put it there. I'm all about freedom, man. If you want to do dumb stuff, it's your right as an American to be stupid." The documented needs to communicate better, "but there's no way we're putting this on fire chiefs."

IDAHO DEPARTMENT OF LANDS REIMBURSE-**MENT:** Clerk Prisco explained that the county spent \$99,062 as part of a plan for wildfire mitigation. Commissioner Stirm made a motion to approve the request for reimbursement from the IDL for that amount.

GENERATORS: Commissioner Stirm made a motion to include an additional generator in the county to service and maintenance them in the amount of \$1305.65.

ROBIE CREEK ROAD: Knife River, the company who will pave about a mile at the end of Robie Creek Road, is down about a hundred people. They are looking to be done paving in August. Other pavers could not have it done this year, should it go out to bid again. The topic will be discussed next week.

TRAFFIC COUNTS: Dill gave the commissioners the traffic counts and said, "What we're missing is a current Garden Valley's, because somebody thought it was really cool to rip out all <inaudible> out of the ground. So, they're having to re-due their traffic count." He's working on assembling numbers from past years to better compair the influx of COVID traffic.

LAND: The Garden Valley Fire Department was considering deeding a property within a subdivision to the Boise County road department. This topic will be put on the agenda.

HARRIS CREEK: Dill said there are four guys working on that, and he's bouncing crews around, hauling in more material for the roads.

TRANSFER STATION: Fees for solid waste were discussed, and free tire days.

TRANSFER OF FUNDS: Chairman Stirm made a motion to transfer money from disaster funds for computer servers [no amount given]. He made another motion to adopt a resolution to increase the Boise County general fund [no amount given].

TAX DEEDS: Treasurer Gina Turner said there were three properties going for tax deeds, and the owners will have until September 2022, "and they would have to pay '17, '18,'19, '20, '21, and '22 taxes or we will sell them in September 2022." Commissioner Stirm made a motion to sign the tax deeds.

CUMO MINE: There was no update. Stirm said, "I think the company went bankrupt." Twilegar stated that he wasn't sure if they went bankrupt, but the proper paperwork was not filed for the company. Midas Gold is "pretty heavy right now."

DEMAND WARRANTS: Stirm made a motion to pay

Payee #3 in the amount of \$2,512.50 for confidential legal work [death penalty case]. He then motioned to pay CenturyLink in the amount of \$1,697.19 for the Boise County E911. Stirm motioned to pay the deputy coroner Mike Johnson \$1,099.51 for FBI conference, meal, miles for coroner calls, and film development.

EAST BOISE COUNTY AMBULANCE DISTRICT: Lawsuits were discussed, along with court fees.

Stirm later asked that they look at a plan to man the west side of the county. "Just so everybody understands, the Horseshoe Bend Ambulance Director has resigned. The Assistant Director is resigning." Bud Paine has been in negations with the city to allow his company to take over HSB Ambulance. Chairman Stirm continued, "If that happens, Garden Valley has made it very clear, Mr. Delvalle, that he will terminate all mutual aid agreements with Horseshoe Bend. That's part of that. The other part of that is that in the event that Mr. Paine does take that and he is not capable of providing those services, that

still falls on us as a Board. And therefore, I don't want to leave those folks in that geographic area, to include Horseshoe Bend, without an ambulance service, if something were to happen out of our control."

Melissa Potts, EBCAD Director, suggested talking to that community about creating a taxing district.

COMP TIME: Commissioner Stirm motioned to pay all employee compensation time down to 40 hours. The motion carried with all ayes.

PAY: Clerk Prisco presented the numbers of what the other counties pay for the same jobs, and how much less Boise County pays. Budget items and revenues were discussed in detail. Math was done by the commissioners to get some ideas as to cost for new positions proposed.

The Board reviewed requests made by the different departments. Clerk Prisco said there was a cost of living adjustment made of 6%.

[The budget will be published in the World and a public hearing set.]

Adjourned at 3:09 pm.

Statewide Patrols Target Aggressive Driving During 100 Deadliest Days

BOISE COUNTY SHER-IFF'S OFFICE -- The Boise County Sheriff's Office is teaming up with the Idaho Transportation Department's Office of Highway Safety (OHS) to keep Idaho roads safe this summer. Beginning Friday, July 23, Boise County Sheriff's Office will join close to 60 law enforcement agencies statewide putting extra officers on the roads looking for aggressive drivers.

The effort comes in the middle of the 100 Deadliest Days on Idaho roads, when there is an increase in fatal crashes between Memorial Day and Labor Day. According to OHS

preliminary data, 40 people have died in crashes in Idaho since Memorial Day weekend this year.

Aggressive driving is a contributing factor in half of all crashes in Idaho. It happens when a driver makes the choice to speed, follow another car too closely, run a red light or ignore a stop sign, weave in and out of traffic, or not use turn signals. July 23 through August 8, officers will dedicate patrols to enforcing Idaho's speed limits.

The goal is to save lives, so please stay alert behind the wheel and watch for the posted speed limit signs, they exist for a reason. The roadways can be a dangerous place and speed limits are designed to protect everyone – drivers, passengers, and pedestrians.

Speeding greatly reduces a driver's ability to slow down when necessary or to steer safely around an unexpected curve, another vehicle, or hazard in the road. It also increases danger for pedestrians and people who ride bicycles.

"Any time you speed, you are putting yourself and other people at risk. Slow down and have patience every time you drive, so we can save lives to-
