Idaho City Uses New Engine to Fight a Truck and Trailer Fire

BOISE COUNTY -- As a Dodge dual-tire pickup was nearing the top of Mores Creek Summit, the driver smelled smoke coming from the transmission and pulled over to let it cool off. However, the engine burst into flames and there wasn't much he could do but save a computer out of the trailer before it too was caught in the inferno that sent up a lot of black smoke.

The owner of the truck and fifth wheel trailer, from Boise, was quite dismayed with the wreckage.

Ultimately, it was a good thing our local firefighters were there to save the day. The wind had picked up strongly and begun to blow the fire uphill and into the forest. Idaho City Fire Protection District responded with four firefighters in their new fire engine, secured with

a FEMA grant dedicated for rural fire departments. The 2,500 gallon tanker served well to help extinguish the flames while more help arrived from the U.S. Forest Service. They provided two additional crews and two more fire engines, which took care of the growing 20' by 40' wildfire.

Idaho City Fire Chief Terry Teeter suspected that the transmission was so hot on the truck that it melted the plastic tubing, which leaked transmission fluid. Speaking from experience, he said, "That can burn just like gasoline!"

Teeter, who has served as fire chief for more decades than he would like to admit, was very thankful for their new fire engine on Tuesday and soberly added, "The way fires take off these days, it doesn't take much."

It's not a job that everybody wants and Verline has just been outstanding." Gullick turned to those in the commissioners' chamber and said, "Thank you, I'm going to miss all of you!" Commissioner Ryan Stirm added, "Thank you for your service."

BOISE COUNTY COMMISSIONERS

August 3, 2021

Present: Commissioners Ryan Stirm, Robert "Ted" Holmes, and Steven Twilegar

Pledge of Allegiance

EXECUTIVE SESSION: None

PRESENTATION: Commissioner Stirm stated, "Deputy Hastie, come on up, sir. We wanted to recognize you for your many years of service with Boise County." He explained that Hastie had been a deputy, dispatcher, and a School Resource Officer, "We definitely appreciate your service." Stirm wished him luck in his new endeavors and said he understood that he was going to be a pilot. Hastie said, "A few more years of school and then we'll be overseas, flying aid in and out of remote villages." He thanked the commissioners and commented on his eleven years of service, with "a lot of opportunities." Hastie ended by saying that he was excited for new opportunities.

CONSTITUENT INPUT: A constituent spoke regarding Horseshoe Bend Ambulance District and was concerned about what's being left out of the meeting minutes. Commissioner Stirm thanked him and said, "We'll have to look into it."

Commissioner Holmes later asked if everything were verbatim. Prosecutor Strong clarified that the minutes were not verbatim. Clerk Mary Prisco said the minutes should reflect any actions of the Board.

MINUTES: The July 27th official meeting minutes were approved as written. All ayes.

DEPARTMENTAL ISSUES:

GARDENA BRIDGE: The county road department site and location of the future bridge was discussed with a property owner. The county has 6.5 acres and the property owner has .48 acres and another property. A map was reviewed with Assessor Chris Juszczak. Commissioner Stirm provided some background, "The current bridge that's there, Gardena, is getting to a point where it's just going to be impassible. We've been applying for an LHTAC grant every time it comes up to try to get that bridge replaced." The grant match would be 7.34%, but there is a maximum that they could contribute, \$5 million, and the estimate for the replacement exceeds that amount, as much as \$9 million.

A constituent spoke regarding a possible land swap that could benefit both parties, so that the land parcels are not land locked. It was said by the prosecutor that the area would be the cheapest and easiest place to build a bridge. There is another parcel property owner that the county would need to speak with, prior to proceeding. Chairman Stirm said it was likely to be a long process, and they are still waiting to hear back regarding the grant.

REPEATER: A repeat-

er was discussed for Idaho Search and Rescue. It would be installed at the Warm Springs Transfer Station, at no charge to Boise County. Commissioner Stirm would like the agreement to be correct and the board discussed it with Prosecutor Adam Strong. The issue was tabled.

JUVENILE JUSTICE: Suicide prevention information was shared. There are free resources. The county will put help phone numbers on their website.

ROAD DEPARTMENT: Curtis Dill, acting supervisor for the Boise County Road Department, said they are working on a portion of Rocky Canyon Road. They had four people interview for jobs at the road department, from around the county. Chairman Stirm complimented, "Good job on Harris Creek and Centerville Road!" The rain made the difference and Stirm said, "Centerville Road was probably the best I've driven it in three years, honestly!" Dill said they were adding material to the roads.

BOISE COUNTY POLICIES: None

PUBLIC DEFENSE COMMISSION: Clerk Prisco stated that the county was awarded \$51,000 from the public defense commission for fiscal year 2022. The county was awarded a grant of \$35,000 in 2021, and \$25,000

in 2020. Commissioner Stirm motioned to accept the Indigent Defense Financial Assistance agreement. The motion carried.

TRANSFER OF PROPERTY: The commissioners discussed with their attorney the possibility of accepting property from the Garden Valley Fire District. Prosecutor Strong stated that when property is transferred from one government entity to another, it's a fairly straightforward process. The HOA for Southfork Landing would like to keep a lease on part of it for their deicer. An agreement was discussed. The property would be used, and is currently used, by the Boise County Road Department. This topic will be revisited at next week's meeting.

SOUTHWEST RAC DISCUSSION: Commissioner Stirm said that the Idaho Resource Advisory Council (RAC) reached out to him. He also left a message with Congressman Fulcher. Stirm said the grant information was not given to all of the counties. A constituent stated that there were a lot of Boise County constituents that also contacted the offices. He said they appreciated that and added that it was a pretty big deal statewide. There was \$1.4 million available and anything that would benefit the Boise National Forest would qualify for the grant, including solid waste and road

department paving.

LIQUOR LICENSES: There was a list of licenses read and approved for renewal for 2022.

FEMA RESPONSE TO LETTERS OF SUPPORT: The Board gave their approval for the application for financial assistance to the Idaho City Fire Protection District. Commissioner Holmes said what they needed to do is get with all the firefighters and make up a list of things they need. The grants have to do with firefighting. He suggested, "Get on that as quick as you can. Grab some of that money for equipment and whatever we need."

HOSTING A DISTRICT III MEETING: Commissioner Twilegar said, "Well, I say we do it in person, if we do it at all." Commissioner Stirm agreed. This would be an elected officials meeting on October 13th.

EXECUTIVE SESSION: Closed session per exempt records. Coming back into session after a closed thirty minute session, Chairman Stirm motioned on an emerging case.

Stirm recapped on the Horseshoe Bend Ambulance and services. He wanted on the record that the day prior, he had received a phone call letting him know about Horseshoe Bend EMS services and the Fire Chief of HSB contacted dispatch on Friday evening, "informing them that he no longer wanted them to dispatch Garden Valley Ambulance if Horseshoe Bend ambulance was out-of-service. They wanted Gem County Ambulance to be dispatched." He continued, "There are two issues with that, number one, state communications does not dispatch Gem County, period. They do not. They have to make a phone call to their dispatch center, just like they have to with our deputies, because Gem County is self-dispatch. They dispatch their own fire, their own ambulance, their own police. So, I informed their director at State Communications that the county was not in a position and had not discussed yet adjusting any agreements whatsoever for the response of Gem County into Boise County." Stirm then talked to the Director of Gem County Ambulance District and he informed Stirm, "That under

no circumstances would he be willing to put himself on-call in the event that Horseshoe Bend Ambulance was unable to provide services to their people." Chairman Stirm then called the Mayor of Horseshoe Bend and said, "The city of Horseshoe Bend itself, proper, inside the boundary lines can make any agreement that the city wants to make with whoever they want to make it with. However, once you cross that boundary line onto the county's, that agreement has to be made through this Board." He continued, "However, I'm getting phone calls from the State telling me that people are throwing other counties under the bus and saying they're going to respond, and when those counties are contacted, there's no aid agreement. And that county has no idea that they were even given the option. So, they are putting the cart before the horse." He added, "You need to talk to the right people first, not go to the top and work your way down. You need to work your way from the bottom, up, and figure this out. So, the person who did this went straight to state communications and told their dispatch and circumvented everything in-between, thinking they had some kind of written authority through a fire department agreement that is more for mutual aid than it is for providing actual services." He went on to say that there had been some documentation at the city.

Prosecutor Strong said he had not seen any of the documentation, and didn't know how the area around Horseshoe Bend came to be covered for EMS services. "Outside

of city limits ultimately, in a roundabout way, that falls to this Board," Strong said. "But, if there's some other agreement that's been entered into by the county with Horseshoe Bend city limits, that essentially delegates that area outside the city limits as their response area, as their responsibility essentially, then they would potentially have the ability to enter into a separate mutual aid agreement to cover that area." However, without knowing that agreement, or lack thereof, he really couldn't say.

Chairman Stirm asked, with the Board's blessing, "When we finish the meeting today, I will call the Mayor of Horseshoe Bend and have another conversation with him and let him know basically what Adam [Strong] just said." He would like to also provide the proper steps to enter into an agreement, "and inform him of the truth, which is that the Trivalley agreement is not nullified through State Communications. That's not true. That's not what happened."

Stirm recalled that the document came about with Avimor and who they were going to use for an ambulance. Horseshoe Bend said Avimor had to use them, because they have an agreement that states they cover the Ada County line, Gem County line, and all the way to mile marker 75 and mile marker 10 on Harris Creek Road. He will get a hold of city hall and get a copy of that document. Twilegar would also like to see what the document says.

Prosecutor Strong continued, "There may be some agreement between the county and city at some point dedicating that as their response area, but that's

why we need that document."

BUDGET PUBLICATION APPROVAL: Clerk Mary Prisco spoke regarding the 2022 budget publication for the *Idaho World* newspaper. "The only thing that's a little bit different this year is that typically we have two years of audited numbers. Meaning 2019 and 2020, our audit is still pending," Clerk Prisco said. "So, for both EBCAD and Boise County, I just used the actual numbers off of our financial system."

Commissioner Stirm said this was pretty much what we all agreed upon. The department heads also checked over the budgets, found some errors, and they were corrected. Chairman Stirm motioned to approve the fiscal year 2022 publication for the tentative budget. The motion carried.

EAST BOISE COUNTY AMBULANCE: Commissioner Stirm, serving as the EBCAD Governing Board, motioned to approve the 2022 EBCAD budget publication. This motion also carried.

Stirm motioned to approve the collection agency agreement between Boise County and Advantage Financial Services. All were in favor.

Fee increases were discussed for transporting -- EMS services, the mileage rate, and cost of supplies.

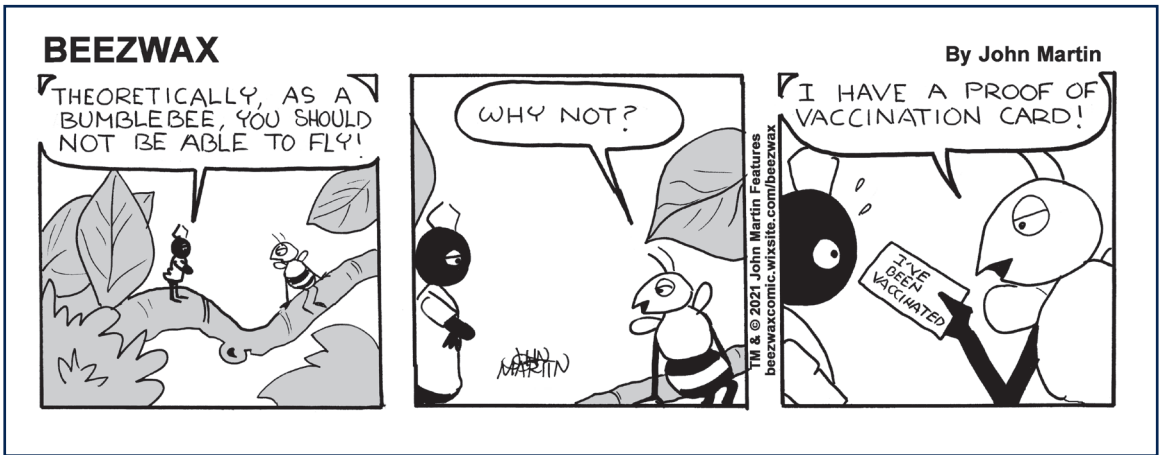
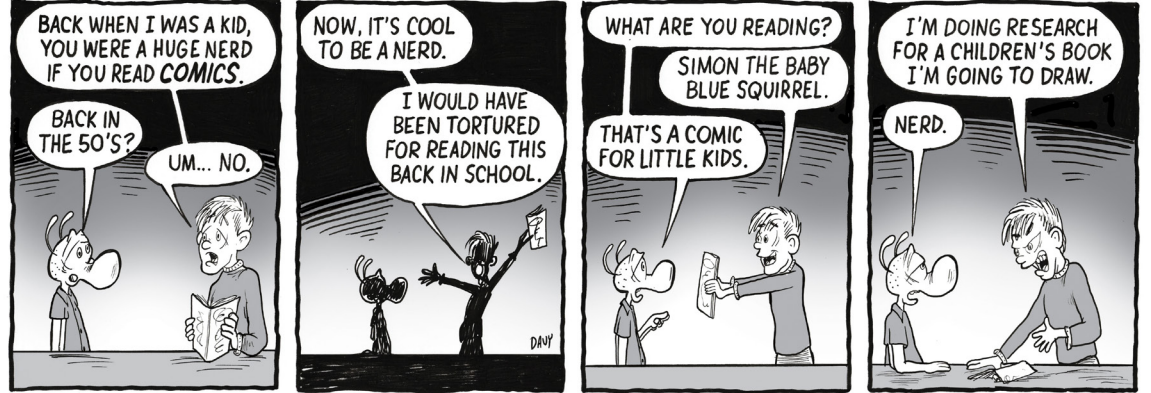

Boise County Schools are Preparing to Welcome Back Students with Guidance from Central District Health

BOISE COUNTY -- Superintendent Dennis Chesnut for the **Horseshoe Bend School District** stated: "Due to the fluidity of the situation, we have created a draft plan, but the school board will not approve it until our August 18th board meeting, so I am hesitant to give you details of a draft plan that may very well be changed by the board." However, he did provide the following, "We are following CDH's illness flow-chart and exposure flow-chart, and as long as the vaccinated individual, teacher or student, who was exposed has no symptoms, then they will not need to quarantine." School begins for Horseshoe Bend students on Wednesday, August 18th.

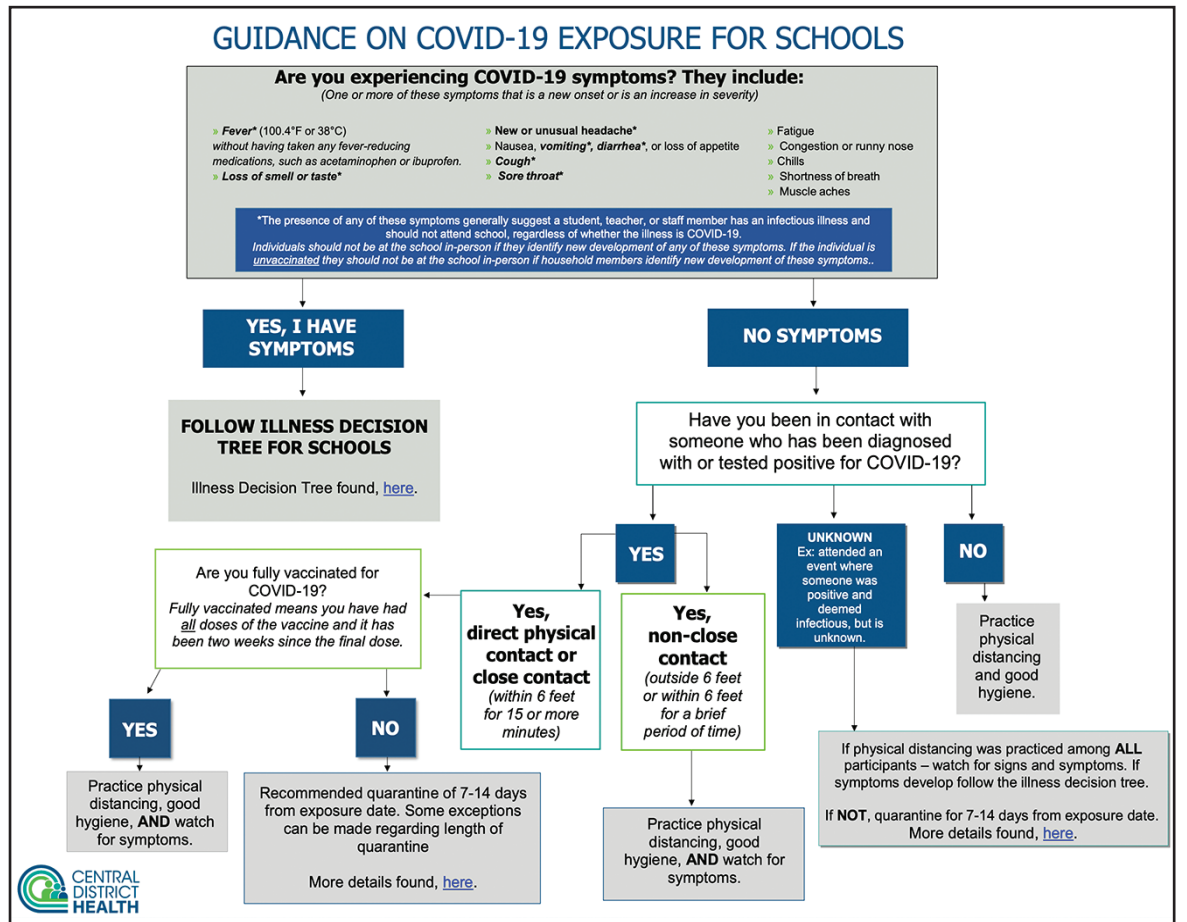
Superintendent Brian Hunicke for the **Basin School District** said there was a special board meeting coming up on August 11th, after which the plan could change. School starts for high school and middle school students on August 24th. School will begin on August 25th for Basin Elementary students.

A notification went out on August 9th stating: "We have been notified this afternoon that one of our HS Football Athletes has tested positive for COVID. This indicates a primary contact for any athlete or coach at football practice... HS Practice will resume on Aug 17th for any athlete who has received a negative test and has no symptoms. For Athletes who choose not to test practice will resume on Aug 24th with the start of

school." Superintendent Randy Thompson of the **Garden Valley School District** said, "As of right now, our plans are to proceed with the start of school in person next week on August 16th." He continued, "We are aware of the changing guidelines and recommendations from the CDC and other agencies. We are also monitoring the updates from Central District Health. I personally attended a conference for superintendents last week in Boise and was in various meetings with the State Department of Education. We are also monitoring for any updates from the State Department of Education. We will adjust our plans if the Garden Valley School Board of Trustees directs any changes." Their school board meeting was held on August 10th at 6pm, which included a review of the "Back to School Plan" recently posted on the website.

Superintendent Thompson added, "We are excited to welcome back our teachers and students and look forward to an amazing year in the Garden Valley School District."

Central District Health released a report on August 10th that Boise County saw nine cases last week, which is a slight decrease from the previous week of sixteen, but is still above the 100 cases per 100,000 people reference line. Boise County is listed in the red (high) transmission category (153.24 cases/100,000).
