BOISE COUNTY**BOISE COUNTY COMMISSIONERS**

September 7, 2021**Present:** Commissioners Ryan Stirm, Steven Twilegar, and Ted Holmes**Pledge of Allegiance****EXECUTIVE SESSION:** Closed session to hire an employee. [Time 9:03am to 9:22am] Commissioner Stirm said there was no action required.**CONSTITUENT INPUT:** None**MINUTES:** The official meeting minutes were approved for August 31.

SHERIFF: Sheriff Turner discussed end of the year capital equipment purchases, including ten "less lethal launchers" that shoot foam and rubber bullets. Commissioner Twilegar asked, "So, what would you use those for?" Sheriff Turner responded, "We've used the ones we have already [2] for standoffs and barricaded people, that kind of stuff. They've bailed us out of a few situations already." He provided the best of three quotes. The sheriff added, "We've used more less lethal ammunitions in the last year than the previous ten years combined." Commissioner Holmes asked how often this was needed? Sheriff Turner responded "almost once a month," and that tasers were limited and don't always work. Commissioner Twilegar wanted to know the distance that officers could shoot someone. Turner answered, "Almost a hundred yards." Chairman Stirm made the motion to approve

the expenditure, not to exceed \$10,000.

DOCUMENTS: Clerk Mary Prisco spoke regarding imaging documents. "We have not the man power or the ability to image all the documents that need to be imaged." Prosecutor Strong pointed out that these were all public records, so the company is essentially doing the county a favor by imaging the documents for free. However, they do keep a copy of things like records, land maps, and surveys.

Assessor Chris Juszcak said that many of the surveyors that they work with subscribe to this data company. This could cut down on time spent in the clerk's office, searching in the vault for documents. He explained, "What we get in return is the digitized document that we can more easily search."

AGREEMENT: Chairman Stirm made a motion to approve the sales agreement between Boise County and Western State Cat. There was a total of three leases.

RECORDS DESTRUCTION: A motion was made to adopt the resolution to destroy certain records of Boise County, being temporary to be held for two years, semi-permanent to be held for five years, or permanent to be held for ten years or more.

AVIMOR SUMMARY OF ORDINANCE: Prosecutor Adam Strong provided a summary to be published in the newspaper [last week]. Chairman Stirm

made a motion to approve the summary, amending the Boise County Land Use Ordinance, governing the Avimor development.

DEMAND WARRANTS: Chairman Stirm made a motion to pay \$46,940 for the September lease payment for "the trucks."

Stirm made a motion to pay payee #8 [death penalty case] in the amount of \$5,600 for confidential psychiatric legal services.

LITTERING ORDINANCE: Commissioner Twilegar would like to move on this ordinance, especially since Kirkham Hot Springs was closed again. The Board talked with the prosecutor of limits, \$350 minimum and \$1,000 maximum, with at least 10 hours of community service. Prosecutor Strong will be drafting the ordinance. Commissioner Twilegar stated, "We have to do our part and I think this is a good start." Commissioner Stirm added, "The point is to make it hurt." Twilegar said that the added signage should help too.

EBCAD: The Board reconvened as the EBCAD Governing Board. Ms. Potts presented an Emergency Medical Technician [EMT] job description and discussed comp time. Chairman Stirm made a motion to approve the EMT job description. He then motioned for a payroll addition for an EMT.

Chairman Stirm then made a motion to vacate the Assistant Director of Education and Education Director positions for the East Boise County Ambulance District and replace those two positions with two full time EMT positions.

DEPARTMENT OF HEALTH AND WELFARE

GRANTS: Ms. Potts said they were awarded a grant for an ambulance with a lift. The maximum total amount between the two grants was about \$63,000.

Stirm made a motion to approve the State of Idaho Dept. of Health and Welfare grant in the amount of \$21,000 for a lift. He then made a motion to approve another grant for EBCAD for a new ambulance in the amount of

\$140,000.

COMPTIME: Paying the time off to 40 hours was discussed. Stirm made a motion to pay comp time for EBCAD down to zero for the director and down to 40 hours for the other employees.

ADA COUNTY PARAMEDICS: Director Potts wanted to make the board aware, "Ada County [paramedics] has been coming into our county a whole bunch and is taking calls." There is a liability for them and Boise County is using their resources. "We've had incidences where they've ordered a helicopter and we've ordered a helicopter, now we have two helicopters," Potts explained. She said Dr. Sturkie, who is overseeing EBCAD, will be speaking with Ada County.

MOTION: Commissioner Stirm made a motion to approve Land Pro Data to come in and do their scanning operation of the county's large record of survey and plat documents for Boise County on the contingency that the county gets a copy. The motion carried.

FOREST SERVICE UPDATE: District Ranger Brant Petersen for Idaho City updated the Board on the RAC funding, or half a million in Title 2 money that can be applied for in grants. Petersen offered to help the board go after some of that money, and said they have been successful in the past. The amount is based on a value of the volume of timber harvested or sold. Petersen has been with the district for eight years and spoke regarding timber sales, "Every single year we've put up volume. Every single year it's sold." He explained that this is the door for the Title 2 application.

The next eligible time is in May of 2022. Peterson went into the reasons why the commissioners were not notified of the grants. "There's two things, one is the emails, last time were from previous Commissioners. It's nobody's fault, it just happened. They sent out emails to previous commissioners' email addresses and I think that's probably how the unintentional oversight hap-

pened. But obviously, we'll make sure that we give it to you guys, with the commissioners, with the county road department." He would like to review roads during the winter to be competitive for the grants.

Peterson said that the RAC is a pretty broad group of individuals, and now there are some openings for a committee member with expertise in history/archaeology, a representative of a school or an administrator, and a timber representative. They decide where the money goes and it doesn't require much time, just during April - May time period.

CUMO: Peterson said that CuMo has a proposal in right now. They set up a plan of operation about eight years ago, which was basically drilling. "So, they're going to go out, establish some pads and drill those pads and then pull the core up and determine the amount of mineral element that is in there." He reminded that commissioners that this went to court and parts of the CuMo decision were remanded back. There had been two fires up there, the discovery of a plant - Sacagawea Bitterroot - and the ground water issue. CuMo became involved with a third party to help write the document and compile the NEPA document. He said the contract didn't work out for them, it took a long time, and it cost a lot of money. Peterson added, "So, we've taken that process back," and will address those three issues. This will be a supplement for the existing Environmental Assessment, so it would start back up through the court system.

Prosecutor Strong posed the question, "As far as you know, they are still proceeding, the CuMo corporation?" Petersen answered, "Yes."

AIR STRIP IN IDAHO CITY: Commissioner Holmes spoke concerning a possible land swap to take responsibility for the air strip and try to improve tourism, "because we're a historical destination." He said all the airstrips are owned by the forestry.

City Council Meetings in Idaho City

IDAHO CITY -- On August 25, 2021, the regular City Council meeting in Idaho City was called to order at 6:00 p.m. by Mayor Phillip Canody. Councilmembers present were: Tom Secor, David Martin, and Ken Everhart. HD Hillyard was absent.

Sabrina Amidon presented the Idaho City council with an event checklist for October 16, 2021, The event was called, "Spooky Fall Festival" at the Cowboy Campground. She gave a brief explanation of the event. Amidon also mentioned that with the help of the volunteer fire department they may be having a small bonfire for the event.

Chief Otter thought the only reason to come to council with this event would be to ask for use of the rodeo grounds parking lot since the event is on their property. Having insurance for a minimal amount would be required and all vendors would need to pay city fees. The council agreed, Tom Secor made a motion to allow the "Spooky Fall Festival" to utilize the rodeo grounds parking lot for parking only, contingent on insurance provided to the clerk. This was seconded by Ken Everhart and all council members agreed.

A bill from August 12, through August 25, 2021 was presented. Ken Everhart made a motion to pay the bill in the amount of \$5,403.65, this was seconded by Tom Secor and all council members agreed.

Under Old Business, Public Works Director Tami Franklin was present to give her thoughts on the need to put into action the limiting of where mailboxes can be within Idaho City limits. She said: "They are a burden on the City's road department, mostly in the winter months, and have been obstructed by city equipment. They are a hazard to the equipment and citizens." She also noted that the City of McCall has posted this on their website as a policy. The Council members and Mayor Canody stated that they should investigate this seriously and maybe pass an ordinance. Idaho City Attorney Joan Callahan will also investigate this as an option.

There was a discussion on the possibility of Idaho City obtaining a "local option tax." However, in order to qualify, Idaho City must be considered a "resort city." While many do not believe we are, the criteria exists and a further investigation will need to happen more information from the Chamber of Commerce. Idaho City has not slowed down at all in traffic and business. City resources are used heavily, so the question is, "why put this burden on the City and its locals to pay for all the extra expense? This will be an ongoing topic until final determination is made on whether Idaho City can or cannot do this and ensure that the residents will not be hit with additional taxes on

their own necessities as a result of this tax.

The Theatre teacher at Idaho City MS/HS, Dana Zoch, met with the Idaho City Historical Foundation to ask about the possibility of having an "Idaho City Historical Ghost Tour" on several weekends on October. She and her theatre students would write and perform historical monologues based on some of the pioneers buried in the Pioneer Cemetery. These performances would be considered a fundraiser for the theatre department and educate people on the history of local pioneers. The Idaho City Historical Foundation gave full support. Idaho City Council agrees it would be a great event and has asked Dana to present an Idaho City Event checklist to Clerk Ptak to have it put on the agenda.

In reference to permanent camping standards and prohibitions, City Council members and Chief Mark Otter discussed the pros and cons of such an ordinance. Chief Otter would like to have something enforceable sooner rather than later because as the weather starts to cool down, people need safe places to live. Quite a few places in Idaho City at this present time are not even close to health and safety standards. Landlords need to step up and ensure the safety and well-being of their tenants. Chief Otter feels this is a situation that needs to be addressed and he has proposed a "fairly strict" ordinance, looking at it from the view of law enforcement. The Idaho City Council and Idaho City Attorney Joan Callahan are working together to put something in place that will work in favor of the uniqueness of our community and in consideration of those it would affect.

It was decided that the Idaho City Council would hold a public meeting on "moratorium on development and building permits." This was held September 8, 2021. This meeting was held to consider the purpose of proposing an emergency moratorium on building permits and development applications that require or involve new connections. Exceptions to this are the previously pending and approved connections already in place (Mores Creek Crossing Phase 1 and 2). Clerk Ptak will get a notice in the *Idaho World*. Ken Everhart made a motion to publish a notice in the paper for a public hearing to be held at the regular City Council meeting on September 8, 2021, this was seconded by Tom Secor, and all councilmembers agreed.

Rhonda Jameson updated the Idaho City Council on the CLG grant and the cancellation of the conference that she was expecting some reimbursement payment. This will not be happening this year. The grant will rollover to next year. There may be some grant opportunities for the Mercantile building, which will be explored.

IDAHO CITY -- At City Hall on September 8, 2021, citizens met with the Idaho City Mayor, Phillip Canody, and Councilmembers: David Martin, Ken Everhart, and HD Hillyard to discuss an emergency moratorium on building permits and development in Idaho City. Mayor Phillip Canody gave a brief history of the lack of water rights that is affecting Idaho City. Early in

the 2000s the water rights were taken away from cities and municipalities throughout the State of Idaho. Idaho City's water rights were constrained and now the current and projected demand for water is beyond the City's water right capacity.

The City is undertaking discussion with the water district to secure additional water sourcing and rights. But they still don't have them.

So it was decided by the City

Council to pass an ordinance to put a moratorium on the issuance of building permits and development applications that require or involve new connections to the City of Idaho City's water system for a period of not more than 182 days. This moratorium will not apply to any permit that has already been issued or application for a building permit that is already complete and pending.

The Historical Preservation commission wants to remind the City that there should not be any trailers allowed in the Historical District as permanent structures. Clerk Ptak asked Rhonda to clarify if the possible upcoming grants should be added to the upcoming budget. It was suggested to add \$10,000 to general budget for the Historical Preservation Commission, just in case a grant does happen.

Under the public works report, Tami Franklin, director, told City Council that the RO system has been getting pressure testing done and disinfection will be the next issue. The fire hydrants are getting flushed and it was found that a few may need some repairs. The samples of water are completed. The construction update meeting went well, and she will be getting quotes on some of the new chemicals needed and safety gear. The start date for the RO could be the middle of September.

Police Chief, Mark Otter, updated the City Council on a couple of items. He would like to re-look into the dog kennel idea but maybe on a smaller scale and just in the Idaho City area. The dog complaints have become more frequent. The old dog kennel may be able to be used and refreshed. He plans on doing more traffic patrolling in the next few weeks, and the battery has been ordered for the traffic speed light on Highway 21.

Clerk Ptak gave an update regarding the building permits; she has already started sending some items to AOKA and the transactions have been smooth. It is an easy system to use and it is convenient for the applicants. She turned in some water bill updates on past due balances and one water was shut off. Clerk Ptak and City Attorney Joan Callahan will be working on getting some liens set up on the larger delinquent

water and sewer accounts. The councilmembers agreed with her and would like to see this on the next agenda.

Citizen comments: John Adams expressed to the City Council and City staff that he appreciates all the work everyone does to look out for the citizens in Idaho City.

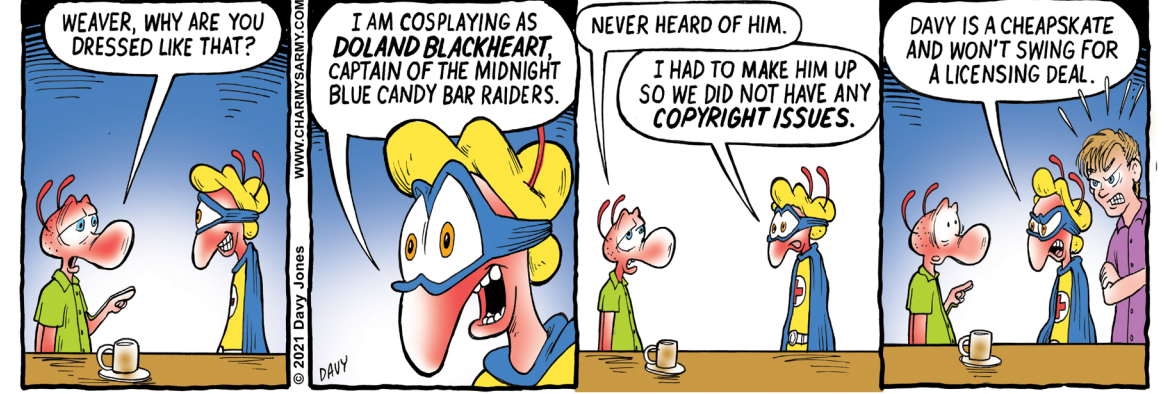

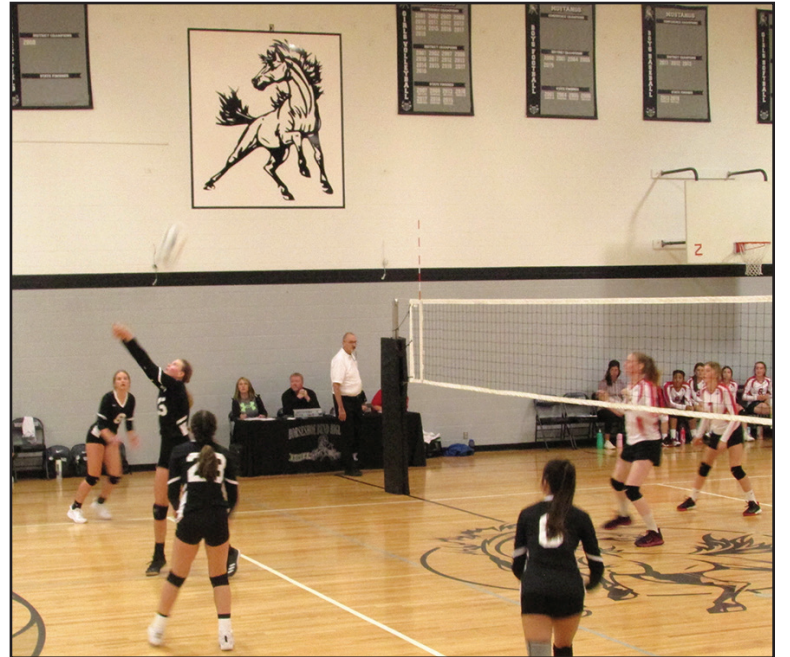
Horseshoe Bend Varsity Lady Mustangs

Deer Valley Subdivision Approval Postponed Again

HORSESHOE BEND --

On Tuesday, September 7, the Horseshoe Bend City Council held a public hearing regarding the proposed Deer Valley Subdivision. All councilmembers were present. After the Pledge of Allegiance and the approval of the agenda, Mayor Pat Goff opened the meeting to public comments.

Randy Leach stepped up to the podium, "First off I want to apologize." Leach told the council that at a prior public hearing concerning the Deer Valley Subdivision he thought the city council didn't care about what the public wanted in regards to the proposal. "We know it's coming, whether it's for good or for bad, we don't know." Leach attributed the controversy regarding the plan to greed. He mentioned another large landowner who sold his property in 1 to 5 acre parcels. "I just don't see where 5 to 6 houses per acre and condos... he's (property owner, David Bailey) going to try and squeeze as many homes... the problem is why can't we have a happy medium? Maybe we can come to something that's a little better for Horseshoe Bend."

Goff began the public hearing at 7:06 p.m. The hearing began with the applicant, David Bailey, representing himself, Bailey Engineering, and Trilogy Development. He provided the council with some new information. Bailey told them that a Charter School would be opening in the new phase of Avimor that is being built in Boise County.

Goff opened the floor for testimony in favor of the development. *No one came forward.*

Mayoral candidate, Dave Jakovac, came forward with neutral testimony. Jakovac told the council that he has been a resident of Horseshoe Bend for three years but grew up in small towns. He was concerned that the plat map did not show N. Riverside Drive continuing across from Highway 52 off Highway 55. (Bailey later explained it was because of the map provided by the county and that N. Riverside Drive would remain as it is.) Jakovac claimed that there would be a 22% increase in water (He stated a 1.7 gallon per month increase in water consumption) and sewage usage from the residents of the new development. He wants the council to make sure that the increase won't effect those that live within the city's limits. He was also concerned that the proposed depth of the housing lots would be inaccessible to fire department equipment. Jakovac's other concerns were that the proposed width of the streets would not allow for street parking and emergency vehicle access and that there was no plan for pedestrian crossing at the Highway 55/52 junction.

Later in the hearing, both Bailey and Horseshoe Bend Fire Chief Jason Gifford disputed that the depth of the lots and the width of the streets would hamper emergency vehicles.

Starting the opposition testimony was Horseshoe Bend City Council candidate Patti Burgess. Burgess claimed that she was "kind of an outsider" having moved here three years ago but loves the way the community comes together when someone is in need. Her wor-

ries are "holes in the EMT services, fire department, and schools." She wants the developer to make improvements to the public library, come up with a better solution to the traffic throughout the city and to collaborate with the school district regarding future remodeling.

Steve Leach reiterated the need for the city to require a completion bond from the developer. (Completion or developer bonds are commonly used to guarantee the completion of improvements in a subdivision should the development be halted or stopped due to lack of funds) Leach told the council that they had been voted in to represent the citizens. "Do you hear them?" he asked. "Please open your ears."

David Renfro asked, "If we replace the population of Horseshoe Bend twice over where does Horseshoe Bend go? What's going to happen to our school? I just think it's a bad idea. We need to go slow on this."

A resident came forward to state, "We aren't the small town with the big heart when we add big subdivisions." She agreed that the city desperately needs housing options but they need to slow down.

Aaron Flores has lived in town for three years. He likes the small feel of the town and acknowledged that "growth is inevitable, but 40% growth is out of hand." He ended with a caution to the council, "You need to consider the implications this will have on this town."

Vickey Andra wanted to know who was paying for all of the infrastructure, roads, and traffic lights and how much money the developer had already paid to the city. She wanted to know how much the new homes were going to cost, "High income houses? That's not what this town is about." She suggested that Bailey go back to the drawing board and "make it two houses per acre." (The developer later stated that no money had been paid out to the city.)

Another resident had concerns that after a signal is installed at ID-55/ID-52, if the intersection freezes in the winter it would cause big rig trucks to slide right through the intersection. "We're looking for an accident to happen."

Kerri Jones gave the following testimony, "I am a Ranft, a 5th generation, my ancestors built this town with morals." Jones talked about how

the Boise-Cascade Mill had built affordable housing for its employees. "What is this bringing us? Why do we need these homes? What are they giving back? Do you want your kids to have a swing set and a trampoline or a backyard with rocks and gravel? These yards aren't big enough." Jones was also concerned that the roads in town aren't wide enough and that the new homes could be an invitation for rapists, murderers, and drug dealers to move in.

Later in the meeting, Bailey said, "There's no reason to believe that the people who move here won't be like-minded people with morals like yours."

Another resident asked the council to consider a moratorium on growth while indicating crime will be a factor in the subdivision and warned of the blight to come after the developer is gone.

HSB Fire Department Chief Jason Gifford spoke. He told the council he had met with Bailey and his wife. He was concerned that the department calls had quadrupled in the past three years and a growth spurt of 40% would only increase the runs the department goes out on. He said, "Growth is inevitable. The problem is not doing it correctly." He asked the council to consider approving one phase of the developers' plan at a time. "Everyone in this room should start thinking 50 years in advance." Gifford thinks the proposal is the "best bet for Horseshoe Bend" but wants to "pump the brakes on how fast it grows."

The testimony closed and applicant Bailey spoke. He wanted to make sure everyone knew that the application is exactly what it is and that he has nothing else planned for the future, but that could change as he doesn't know what can happen in the future. He was asked by the council if he could change the density in the proposal to three lots per acre. Bailey said his proposed Planned Urban Development (PUD) allows for a better configuration. Bailey told the council that he plans to sell the industrial properties to businesses that will benefit the town.

Councilmember Martye White asked for copies of the traffic study done by ITD. Bailey told him they were included in the packets the councilmembers were provided. White said he wanted to know if the traffic signal at ID-55/ID-52 would be on a timer. Bailey indicated he

didn't know what ITD's plans were. "That's my main concern right now, that traffic signal. This is going to be one of the biggest decisions of my life," White said.

Bailey reminded the council that the city's PUD allows for the type of development he is proposing, adding, "Yes it's your decision to listen to the people but it's also your decision to make plans to move this city forward." He went on to say that the developer can provide the appropriate infrastructure to support the development, he thinks most concerns can be addressed, and he indicated that phases can be handled through plat approval.

Councilmember Stephen Chartier asked Bailey if at this stage the plot sizes could be changed. Bailey replied, "From a practical standpoint, no."

Goff told the audience, "Trust me, this is a huge decision."

When someone in the crowd asked a question, Goff explained that the public hearing was a quasi-legal proceeding and as such "the gallery isn't allowed to make comments." He told everyone, "I hope you understand that we don't take this lightly at all." He then closed the public hearing at 8:23 p.m.

Goff told the council they didn't need to make a decision that night. White said, "I'd definitely like to take more time." City attorney Geoff Shroeder told the council that traffic was mentioned several times during testimony and that they should all review the traffic study. He added that water and sewer were adequately addressed but the council should also keep that in mind.

City engineer Amy Woodruff suggested that she and Shroeder draft a finding of facts to send to the council for deliberations.

A special meeting will be held on Wednesday, October 6 for deliberation of the proposed Deer Valley Subdivision.
