BOISE COUNTY COMMISSIONERS

September 14, 2021

[Continued from last week]

Present: Commissioners "Ted" Holmes and Steve Twilegar **Absent:** Commissioner Ryan Stirm

ELECTIONS: "We have a lot going on," said Clerk Mary Prisco. "It looks like we're going to have five elections on November 2nd. We've got Horseshoe Bend office of Mayor, Idaho City office of Mayor. We have one trustee zone for the Garden Valley School District and then we have two trustee zones for the Basin School District - that will cover two precincts, Idaho City and Placerville." She then spoke of a "Perspective Recall Petition that is in effect" and she is working with the prosecutor to do a response to those who submitted it.

Clerk Prisco then spoke regarding the certification of lev-

ies for all the taxing districts, to establish the taxing rate.

COUNTY'S INSURANCE: Clerk Prisco explained the new policy for 2022. "The big change is, in regards to our deductible for employee related / personnel related claims. So, they're moving it from \$5,000 to \$7,500." Prosecutor Adam Strong noted that it used to be \$1,000, then \$5,000, and now \$7,500, "They are getting more and more of those claims." Clerk Prisco agreed, "It tells you something." He clarified, "That's not just specific to us," it a general trend covering all counties across the state.

BUDGET AMENDMENTS: The clerk will be going through the budget looking for places that will need a resolution for budget amendments.

BILLS: Acting Chairman

Twilegar made a motion for the unpaid claims in the amount of \$213,400.34. Twilegar made a motion to approve payment in the amount of \$2,062 for an invoice for confidential legal services for "Payee #1" [due to a death penalty case]. He also motioned to pay "Payee #3" in the amount of \$3,390.

EAST BOISE COUNTY AMBULANCE DISTRICT: Clerk Prisco reminded the board regarding the payout for comp time. Twilegar made a motion to approve the resolution amending the 2021 budget.

IDAHO OFFICE OF EMERGENCY MANAGEMENT: Brad with the Idaho Office of Emergency Management addressed the Board. He stated that they were going to have a 3-day conference in October on cyber security and emergency preparedness. However, they are now looking at doing some classes virtually.

He said \$1 billion will be made available for competitive nationwide funding to build a more resilient community. Twilegar asked what that meant, and the gentleman explained that it covered waste water, water treatment, communication infrastructure, etc. Projects identified in a mitigation plan could be funded up to 100% with the assistance

FEMA grants to address climate change in Idaho. He said the improvements cannot be done on federal lands, only on county, city, or state land. He said there was more information to come.

The representative also spoke regarding a fault line that runs from British Columbia, across Washington and Oregon, and into northern California. "It is a fault that is active about every 300 years, 9.0 or greater, up to 30 minutes." There is also expected to be a tsunami that will occur as a result. They did an exercise of how they would support these areas in 2016 and hope to offer the exercise again next year. Idaho is a boarder to these states, "so as you can imagine, there's going to be a lot of movement, a lot of effort, a lot of support that's needed and required." There are private companies [including Airbnb's], hospitals, and federal partners involved. Twilegar asked what they expected the death toll would be and he replied that it probably wouldn't be in the millions but they would focus their efforts on search and rescue, not recovery. Twilegar asked for a timeline and the representative responded, "it's well overdue." He said they are always watching the faults, "We probably have three or four 2.0s every

day in Idaho." He added that when it's a 4.0, Idaho Transportation Dept. will close the roads and bridges.


CRISIS STANDARD OF CARE: The representative also addressed the crisis standards of care, "I know if you read a lot of the information that's been provided or some of the things you see on TV, it is not necessarily what crisis standard of care is. The crisis standard of care, how it was presented to the committee, is federal requirements on the number of staffing for any individual patient. Understanding the staffing shortages across the state, whether it's nursing, whether it's cybersecurity, whether it's Amazon, is critical at this point. There's just not enough people out there right now to fill the jobs. So, based on that, they can reduce the number of staff. It alleviates the federal per client to have the number of folks attend to a staff. It doesn't mean that it alleviates them from providing any services to an individual or turning anybody away. That is not what crisis standards of care is for. It's about the opportunity, instead of having ten nurses that have to care for one patient, in different phases in their process in the hospital, it alleviates that number. That is really what crisis standards of care are all about."

Horseshoe Bend Lady Mustangs Can't Be Stopped

HORSESHOE BEND -- The Horseshoe Bend Mustang Varsity Volleyball team continues to steamroll their opposition in both conference and non-conference play. The team traveled to Midvale on Thursday, September 23 for a 1A Division II Long Pin Conference game against the Tri-Valley Titans. The ladies took the best of 5 sets, defeating the Titans in the first three sets: 25-15, 25-13, and 25-16.

Statistical standouts were sophomore **Annelie Wilson** with 17 kills (an attack on the ball which is not returnable by the opposing team), 5 aces (a serve which is unable to be played or returned by opposing team), 4 blocks (blocking the ball into the opponent's court leading to a point or side out), and 17 digs (passing a spiked or hard hit ball). Senior **Kenzie Renfro** had 6 kills, 4 aces, 1 block, 8 digs, and 1 assist (pass, set, or dig ball to another player who gets the kill). Freshman **Aliyah Meyer** had 1 kill, 3 blocks, 8 digs, and 29 assists.

The team libero (a player specialized in defensive skills who must wear a contrasting jersey color from their teammates and cannot block or attack the ball when it is entirely above net height. When the ball is not in play, the libero can replace any back-row player without prior notice to the officials), sophomore **Torey Tschida**, had 1 ace, 10 digs, and 1 assist.

On Friday, September 24 the team was at home for another 1A Division II Long Pin Conference game, this time against the Cascade Ramblers. The Lady Mustangs kept the Ramblers to 17 total points throughout the 3 set match, besting Cascade 25-8, 25-7, 25-2.

Stat leaders were **Wilson** with 16 kills, 6 aces, and 5 digs. **Meyer** had 3 kills, 2 digs, and 33 assists. **Renfro** had 8 kills and 3 digs and **Tschida** came out with 9 aces and 13 digs.

The win puts the Mustangs 4-0 in conference play and 10-0 for the regular season.

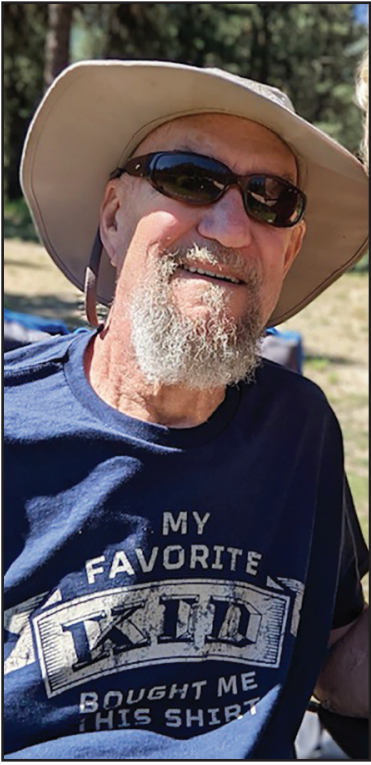

He was the most selfless, patient, understanding, caring, and thoughtful person. He loved to teach everyone around him.

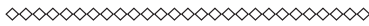

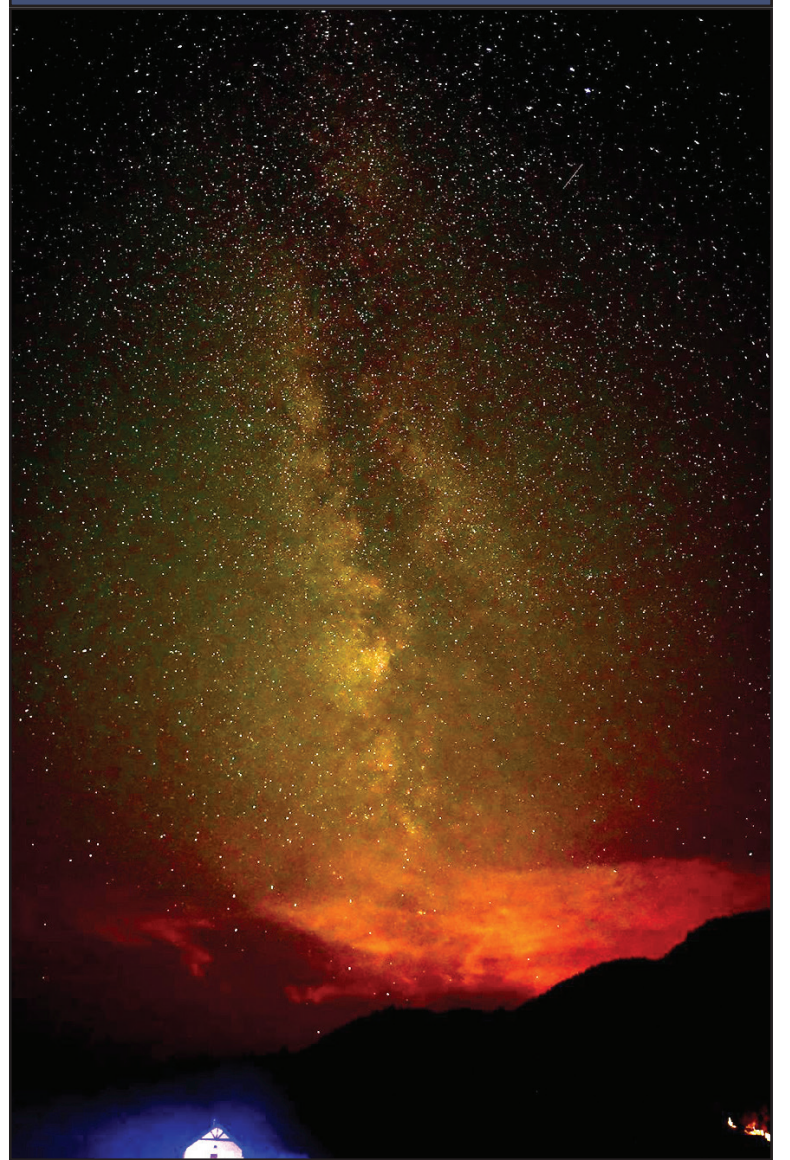

City Council Meeting for Idaho City

IDAHO CITY -- The Idaho City Council met August 30, 2021 in a Special meeting. Those in attendance were Mayor Philip Canody and council members: Tom Secor, Ken Everhart, and David Martin. HD Hillyard was absent. There were two items of new business. The first was to adopt a tentative 2021/2022 budget. Council member Ken Everhart made a motion to adopt the Idaho City Tentative Budget in the amount of \$1,318,628. This was seconded by Council member David Martin with approval from the other council members.

The second item of business was to approve the liquor license renewals. A motion was made by Council member Tom Secor and seconded by Ken Everhart, with approval from all council members.

The following businesses were approved for liquor license renewals for 2022: Harley's Pub, LLC; Idaho City Grocery; Goldmine Idaho City, LLC; Diamond Lil's Steakhouse and Saloon; Goldmine Restaurant; Trudy's Kitchen; and Seasons Dining and Grocery.

The meeting was adjourned at 6:33 p.m.

The following week on September 8, 2021, the Regular City Council meeting was held. Those in attendance were Mayor Philip Canody, council members: Ken Everhart, David Martin, and HD Hillyard. Tom Secor was absent. The pledge of allegiance was led by the Mayor, and Council member, HD Hillyard made a motion to pay the bills dated from August 26, 2021 through September 8, 2021 in the amount of \$94,472.55 this was seconded by Council Member Ken Everhart and was agreed to by all three council members. Mayor Philip Canody stated that a portion of the amount paid would be reimbursed through the WIIN Grant for a water improvement project of \$82,571.13. (This was done when Council Member Ken Everhart made a motion to allow the major to sign the partial payment request #9 for a WIIN Grant \$658,000 in the amount of \$82,571.13, was seconded by David Martin, opposed by Council member HD Hillyard, and Council members Everhart and Martin agreed.

Council Member Ken Everhart made a motion to open the public hearing for the Emergency Moratorium on building permits and development applications. This was seconded by Council Member David Martin, and all agreed with this motion.

Mayor Phillip Canody read the emergency moratorium and asked if there were any written comments. There were none.

Council Member Ken Everhart addressed those in attendance as to why the emergency moratorium was put into place. The city water rights have been an ongoing issue and the City Council has been working to get other water rights

in place, but until then, Idaho City could have the water shut off at any given time if we do not do what we can to reduce the usage. The Idaho City Public Works department has been working to repair leaks, adding new meters. The City has been asking for people to conserve. The City Council is actively doing what they can to reduce water usage and obtain water rights inspite of the fact that the water levels are lower this year.

Mayor Philip Canody asked if the public would like to speak on the issue.

Glenn Miller addressed the council with his concerns on the current building and growth spurt, he is worried about the possible subdivision going in by his property and the water they would be using. Although it would not be within the city's water supply usage area, he is still concerned about the lower water levels and the possibility of new wells depleting the current low water table.

The City Council was understanding and felt this emergency moratorium would give the water table time to replenish since it would end in the early spring and they would have time to re-evaluate the situation. Mr. Miller thanked the council for looking out for the community and being proactive.

Sabrina Amidon asked why the sewer was not involved with the moratorium, council explained that the sewer will still need to be taken care of, but the city does have permission in the reuse permit from DEQ for the present time to keep using the system in place, but will be working towards upgrades in the near future. Right now, the water is the main issue, the city does not want the water to be shut off.

Mike Woodworth, representing Mountain Waterworks, stated that he feels the city is taking the right steps to ensure the water stays in production for the city.

With no further comments, Council Member Ken Everhart made a motion to close the public hearing for the Emergency Moratorium on building permits and development applications, this was seconded by David Martin, and all the council members agreed.

The City Council moved forward with adopting Ordinance 364, after City Attorney Joan Callahan gave an explanation about why Idaho City can pass this

moratorium because of this emergency situation. Council Member Ken Everhart made the motion to have Ordinance 364 be considered immediately, this was seconded by Council Member David Martin and Clerk Nancy Ptak will put a notice in the paper for publication.

The engineer's report was given by Mike Woodworth with Mountain Works. He gave the City Council information about ECWAG findings. The funding options for the intake project are limited. Given delays in the previous City Engineer's design and bidding, and due to the initial natural event (2017 flooding) being four years ago, the USDA National Office determined that the City was only eligible for an ECWAG grant of up to \$150,000. Unfortunately, in recent discussions with USDA, it was determined that the Agency will not be able to look at the 2020 seismic disruption of Elk Creek as a new emergency event. For this reason, the City will only be eligible for pursuing the \$150,000 grant. It is our understanding that given the history of the previous submittal and associated delays, the intake project would not compete competitively for the \$150,000 ECWAG grant. Therefore, the City's best option moving forward is to explore a loan-grant package through USDA's Water Environmental Program (WEF) and/or IDEQ State Revolving Fund (SRF) program. We understand that the City has no bond capacity to pursue such hybrid programs currently. To do so, a revenue bond election would need to be pursued to increase the City's level of financing capacity. In addition, the City's current water rights are at issue and need to be addressed. Mountain Waterworks recommends consulting a water rights attorney to discuss options for achieving compliance with water right limitations. Mountain Waterworks proposes the following recommendations for City Council contemplation and, if agreeable, possible action such as the city to authorize Mountain Waterworks to collaborate with a recommended water rights attorney, the Idaho Department of Water Rights (IDWR) staff, and IDEQ regulatory agency staff relative to the City's water rights. city council members agreed on this plan of action and would like to move forward. The engineers will put together a new task or-

der for the city to review. Council thanked Mike and the whole engineering team for their efforts in finding what works best for the city during this time.

Under new business, Dean Hansen addressed the Idaho City Council. He is currently opening a new business venture in Idaho City at the BoCo Collectibles, LLC. This business would need an alcohol license to add to their menu. They plan to open on a trial basis in October for Idaho City Days with a very limited menu. They hope to have this up and going by May 2022. He gave a sample menu to the city council members, and they liked his business plan and new menu. Council Member Ken Everhart made a motion to approve the new alcohol license to BoCo Collectibles, LLC and this was seconded by HD Hillyard, and all the council members agreed.

As an item of new business, Idaho City was sent a consent form agreement to sign from Idaho Power. This was for the engineering and design of a street light pole on Montgomery street. Currently, the City Council does not feel they want to be responsible for an unknown amount for this engineering and design project. This would come out of the street budget that has already been used to its limit. It was not the understanding of the City Council that the City would be responsible for this project and they would like more information. Since this will be on Highway 21, this might be something to involve with the State of Idaho Transportation Dept. Tami Franklin and Chief Otter will need to get more information.

The Public Works report was given by Tami Franklin. She gave an update on the RO System, where the pressure lines have

been tested and passed. Work is underway to get the start up procedures going. Work is progressing on Bear Run Road to replace some existing lines and meters. Her department is having issues locating some of the water lines with the witching sticks. Council Member Ken Everhart suggested that they get a tool that locates the lines, they use one on his job sites. He said it was worth the money and not a huge expense, he said he would give her the information to get one ordered.

The update from Clerk Ptak was as follows: She has updated the water bills, there seemed to be a billing issue on one account, and Public Works will investigate. The budget should be published in the paper and the budget hearing is set for September 22, 2021. She is having an issue with the computers and will possibly have a couple replaced, they are out of warranty. The election has been approved for candidacy by the County.

City attorney Joan Callahan updated the City Council. She is still finding information on the local option taxes. To aid her efforts, she is finding a U of I law student in need of pro bono hours. They are interviewing potential candidates to help with some of Idaho City's needs. This will be a win-win for the students and Idaho City. A proposal could be given to the council members in December. She is still working on the lease agreement with the Idaho City police car, which should be done soon. She is currently working on the "RV" ordinance and the city mailbox ordinance as she realizes this is something that needs to get in place before winter.

The meeting was adjourned at 7:05 p.m.

Fire Ban and Permits

BOISE COUNTY -- Although the Stage 1 Fire Restrictions for our area were rescinded as of one minute past midnight on September 17, 2021, the Boise County Open Burn Ban remains in effect until October 20th. This combination of rescinded restrictions by federal and state agencies does not override the Boise County Burn Ban, and may cause some confusion.

The currently allowed burning is restricted to campfires in appropriate structures, e.g. approved fire rings in recreation sites and at private residences. Not until October 20 will burn permits for slash piles and the like be approved and issued by Idaho Department of Lands for use in Boise County.

When you have a campfire in an approved location, it is imperative that you have water,

dirt, and a shovel nearby. Make sure your fire is completely out and cool to the touch before leaving it. The best practice is to extinguish the fire with water until it is cold to the touch, then cover it with dirt.

At all times, fireworks, exploding targets, and tracers are prohibited on public lands.

We all have, coming up October 3rd through the 9th, National Fire Prevention Week. It is a time to remind everyone about fire safety in the home and wherever you may be. This year marks the 150th anniversary of the Great Chicago Fire that started on October 8, 1871, which is the basis for fire prevention week.

All of the local fire departments in Boise County will be supporting the observation of fire prevention week coming up, and strongly encourage all to practice fire safety as well.
