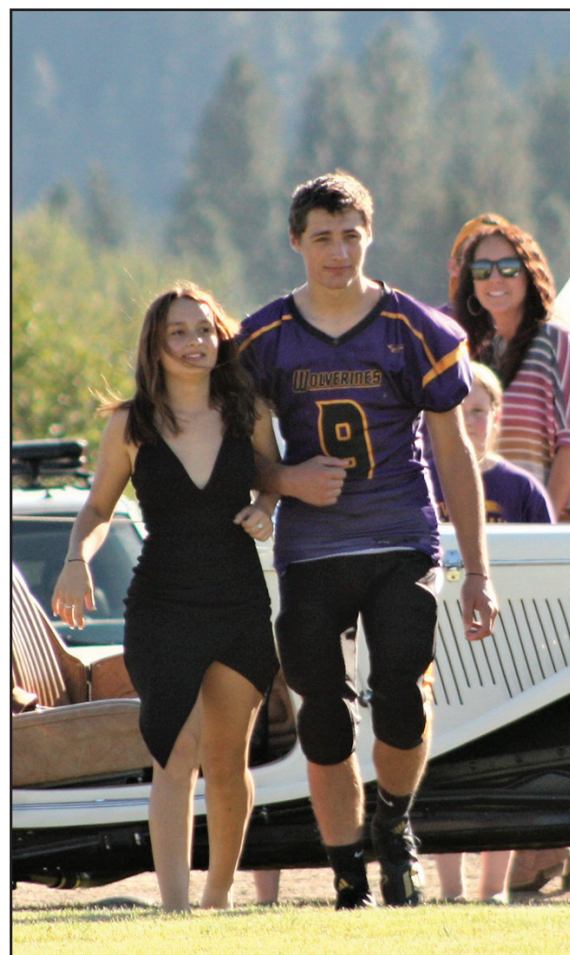

Present: Commissioners Steve Twilegar and Robert "Ted" Holmes

Absent: Commissioner Ryan Stirm

Pledge of Allegiance

EXECUTIVE SESSION: Closed session for a personnel issue. [Time 9:06 am to 9:16 am] No action required.

EXECUTIVE SESSION: Closed session as the East Boise County Ambulance Board under personnel. [Time 9:17 am to 9:55 am] Acting Chairman Twilegar said there was no action required.

INTERNET FIBER IN LOWMAN: The contractor said they were making really good progress. Twilegar commented, "Wow, that's fast!" They are looking to complete the whole fire station area by the end of September. Commissioner Holmes asked if the work would boost the internet up to 1G and that was confirmed by the contractor. Holmes responded, "Outstanding."

MINUTES: The minutes from August 24 were approved by a motion said by Twilegar.

JUVENILE JUSTICE: Ms. Amanda Leader said they are looking to do service projects and have picked up trash and painted over graffiti.

EMERGENCY MANAGER: Ms. Trinia Richardson spoke regarding training in Reno that was coming up and had previously been canceled due to COVID.

ASSESSOR: Mr. Juszczak spoke regarding costs for carpet in his office and software. He also spoke regarding ITD taking over registrations, which would cause a loss for

smaller counties.

PLANNING & ZONING: Idaho Department of Transportation asked for the county to wave a \$25 fee. Commissioner Twilegar partially joked when he said, "Call them back and say, 'If you take the Banks Lowman Road, we'll wave that fee.'" Mr. Gross, P&Z Administrator, said that they told ITD three times, "no." Commissioner Twilegar motioned to wave the bridge fee in Lowman of \$25 for ITD.

TRANSFER STATION: There was discussion of a change in fees for household waste and a public hearing. "Extremely large items are \$20 to \$50," said Mr. Rekow.

ROAD DEPARTMENT: Acting supervisor Mr. Curtis Dill said they have a new hire in Horseshoe Bend. He will be doing interviews for the Idaho City area soon. He asked regarding purchases of surplus trucks.

Update on Old Emmett Road: Dill said, "ITD kind of threw a wrench. They want the intersection rebuilt, which was supposedly supposed to be already approved. The previous superintendent told me it was ready to go, but come to find out, it's not." They are going to work a night shift to dig it up. Knife River Co. will still get the work done up to when the snow flies.

He reported that they put a bunch of road material down on Harris Creek Road and Centerville Road.

PROSECUTOR: Mr. Adam Strong said they are moving forward with trials. "We have been the only county for the last three weeks, four weeks, in the 4th district,

which is Valley, Elmore, and Boise that's been able to do a jury trial. Everyone else in the Supreme Court is shut down because of COVID numbers. Our numbers are low enough that we've been able to proceed. The order last week indicated that they may be changing some of that."

CLERK: Ms. Mary Prisco said that she was able to hire a deputy court clerk and court supervisor.

She spoke regarding the upcoming November election and deadline for candidates to file, which is September 13 for "ballot language." There will be an election for the city of Crouch regarding sales tax. There will be a vote for Trustee - Zone 2 at the Basin School District, and an election may be held for Zones 1 or 3.

Clerk Prisco said they did have some budget amendments that would be presented later in the meeting.

She said a meeting on comp. time payout was going to happen the following week. "If you have employees that have excessive comp. time, we'll be paying out to 40 hours. But if you have somebody that has vacation plans, has a certain use for that comp time," then work with the Clerk's office.

TREASURER: Ms. Gina Turner said, "I'm still working with Computer Arts on our issues. We're slowly making progress, but every time they fix something, *something else breaks*. Hopefully soon we'll be done."

SHERIFF: They are setting up some new software and it will go live soon. Sheriff Scott Turner said they are looking to do some purchases that include tires and uniforms.

CLERK: Ms. Prisco said there was between \$35,000 and \$40,000 from the CARES Act reimbursement. Through the American Rescue Act they may be able to get reimbursement for a purchase her office would like to make of dividers. However, she hasn't applied for these dollars yet. The dividers currently run about \$745 a piece and she wanted to know if there were any other departments that needed these dividers.

BILLS: Commissioner Twilegar made a motion to approve the "ESI bill" in the amount of \$6,200. He also made a motion to approve a new employee for the Road Department. There was a motion said to approve

Ms. Richardson's travel plans to a Wildland Fire conference.

LIQUOR LICENSES: There were long list of county businesses with liquor licenses to be renewed with the approval of the Commissioners.

BILLS: An internet bill was paid to CenturyLink in the amount of \$252.

EXECUTIVE SESSION: Closed session for a personnel issue. [10:59am to 11:30am] Commissioner Twilegar said there was no action required.

EXECUTIVE SESSION: Closed session for exempt records. [11:31am to 11:46am] Twilegar made a couple of motions to place a lien.

PUBLIC BUDGET HEARING: Commissioner Twilegar first asked if there were any public comments. Sheriff Turner made a comment and thanked the clerk's office for all their hard work that went into this year's budget.

Clerk Prisco presented the expense part of the budget with percentages, accompanied by graphs and charts. The largest component of the budget is salary and benefits, which is 46% of the budget. It was 48% last year. Operating expenses for the 2022 budget is 36% and capital is at 19%. The total budget for FY2022 is about \$13,742,000. "On the revenue side, property tax is

our biggest revenue component." It's set at \$5.2 million dollars and the next is departmental revenues with 33%. "Capital projects that would be included in the 2022 budget are *quite* a bit higher than we had in the current year's budget, 2021," said Clerk Prisco. "There is a 6% cost of living increase included across the board for all employees and all elected officials." She said 2019 was the last time there was a cost of living increase. "The county pays 100% of the employee's premiums for health insurance, which means medical, dental, and vision." There was a zero percent increase for 2022, which was the first time in eleven years.

The budget discussion and hearing was closed with no further comments from the public.

Commissioner Stirm phoned in to the Boise County resolution to approve and adopt the budget for FY2022.

EBCAD: There were no public comments made during the public hearing for the East Boise County Ambulance District Budget discussion. Commissioner Twilegar motioned to accept the EBCAD budget for 2022.

PUBLIC HEARING: The hearing will be continued on September 14 at 1:15pm.

Adjourned at 3:02 pm.

City Council Meeting in Idaho City

IDAHO CITY -- Minutes from the regular City Council meeting which was held on August 11, 2021. The meeting was called to order by Mayor Philip Canody at 6:00 p.m., Tom Secor, Ken Everhart, HD Hillyard, and David Martin were present.

The first item of business was Idaho City Days, sponsored by the Chamber of Commerce and represented by Michelle Audette. She stated that this will be held October 1, 2, and 3rd 2021. It will be pretty much the same as last year, but with additional events and more vendors. Parking and shuttle services are still getting some final touches. We are still working on the prices for the port-a-potties and hope the city will still help pay with the extra vendor fees. Currently the vendors are up to 60 in the amount of \$1,494.00. On Friday, October 1st, they will be setting up and warning late night parkers to please not stay overnight. Saturday, October 2nd, will begin at 11:00 a.m. until 2 a.m. Sunday, and then Sunday, October 3, will be from 11:00 a.m. until 7:00 p.m. We have approval from Chief Mark Otter. Tom Secor made a motion to approve the Idaho City Days Event Checklist for October 1, 2, and 3, 2021. This was seconded by HD Hillyard. All council members agreed. Ken Everhart made a motion to approve the alcohol variance for the Idaho City Days for the Idaho City Chamber for the above hours mention, this was seconded by Tom Secor and all agreed. Mayor Canody and the council members thanked Michelle for the hard work the chamber has done to make this an event that has continued to grow and improve every year.

Councilmember David Martin made a motion to pay the bills dated July 29, 2021 through August 11, 2021 in the amount of \$21,067.12. This

was seconded by Ken Everhart. Under Old Business, regarding mailboxes in the Idaho City limits, Michelle Audette stayed to answer any questions the Idaho City council may have. She stated that this discussion was not an item on the agenda from the U. S. Post Office, but she would answer any questions or concerns. She said the new issues are: New customers in Idaho City limits are wanting mailboxes. She cannot approve them without permission from the City. It has become an issue with road work, mostly in the winter for plowing roads, where the mailboxes are located. If they are in the City's right-of-way, they need to be moved. Most of Idaho City does not have room on the side of the roads to place a mailbox safely for the carrier to reach it. Public Works Director Tami Franklin was not present so council decided to table this discussion until the next meeting.

In New Business, the City Council reviewed a consulting agreement with AOKA Engineering LLC for Building Plan review, Code Inspection, and floodplain manager services. Clerk Ptak informed the council that DBS (Division of Building Safety) still has up to three permits. DBS has been working with her on terminating the newer ones in plan review, no work has been done on them yet. There has been a lot of turnover and combination of departments. Kallie Streep from DBS has asked Clerk Ptak to send a letter in an e-mail form to explain why Idaho City would like to terminate. She feels this will help speed up the process and they will be able to move forward. AOKA will take over the new permits and start fresh. Attorney Joan Callahan sent a revised agreement that came from ICRMP. Ganesh Chapapain, CEO of AOKA, is agreeable to the terms set forth. Tom Secor made a mo-

tion to approve and allow Mayor Canody to sign the service agreement with the affective date being when the termination with DBS is executed, this was seconded by Ken Everhart, with 4 ayes.

Tom Secor made a motion to allow Mayor Canody to sign the termination agreement of contract with the Division of Building and Safety, this was seconded by HD Hillyard, and had 4 ayes.

City Council regarding the renewal of BLM- Mores Creek motorcycle bridge - City right-of-way action item. Mayor Philip Canody gave some background on the history of the expired right-of-way. It was put into place in 2004, used as a motorcycle trail access to cross Mores Creek. The City of Idaho City was liable all this time for it: repairs, accidents, etc. It was asked by landowners if the bridge could be moved. It would cost Idaho City tens of thousands of dollars to move it and have all the geological testing done to do so. It was then considered that maybe the Boise Ridge Riders might want to take it over. Mayor Canody will investigate the possibility of this action and Councilmember Tom Secor offered to contact them, specifically Pete Reynolds.

Consideration of recreational vehicle park and conditions. Police Chief, Mark Otter, addressed the Idaho City Council about an ordinance he has been putting together. This is not just to help clean up, but to ensure health and safety for the public. Visitors need to have water and sewer hookup, and a time limit as to how long they can remain without becoming a permanent living situation. The landowners might decide to step up and create a permanent living situation for those who cannot find housing. Recreational trailers are not meant to be lived in as permanent housing. They are not built for it; they do not hold up to it and it becomes a health and welfare issue. He agrees he put it together with "pretty strict" standards with the understanding the council may want to eliminate portions of it or adjust it. City Attorney Joan Callahan addressed this as far as the City codes were concerned and the wording is not exactly clear, therefore Police Chief, Otter would like to get something into place now, before the need to address it comes up. With more people moving into town and new

people buying up properties and eliminating trailers and RV spaces, something will need to be in place.

Police Chief Mark Otter updated the City Council on the new speed sign. A new battery has been ordered. However, while it did work, it seemed to help with slowing traffic to the speed limit. He is working on an office in the Visitor's Center for the police department and is almost set and ready to go. Chief Otter also brought up an idea that he and Clerk Ptak have been working on to help the City of Idaho City with the extra burden the growth has put on the city. The businesses that have all of the growing burden are the new AirBnB structures and rental units. He suggested that the City should investigate

a type of local tax that would not put this extra burden on the local residents and City infrastructure. Chief Otter and Clerk Ptak are looking into other towns and cities and what they are doing with their local taxes or local option tax. They will work with the City attorney and get a proposal for the City Council to consider.

Mayor Philip Canody, called upon City Attorney Joan Callahan to give a quick update. She feels that all is moving forward. She is working on finishing up items that were started by the previous attorney. She has met with Planning and Zoning and feels comfortable with them, willing to work together and learn proper procedures.

Meeting adjourned at 7:27 p.m.

This was a non-conference game with Dietrich, of Lincoln County, ID, Blue Devils on Friday, September 3, 2021.

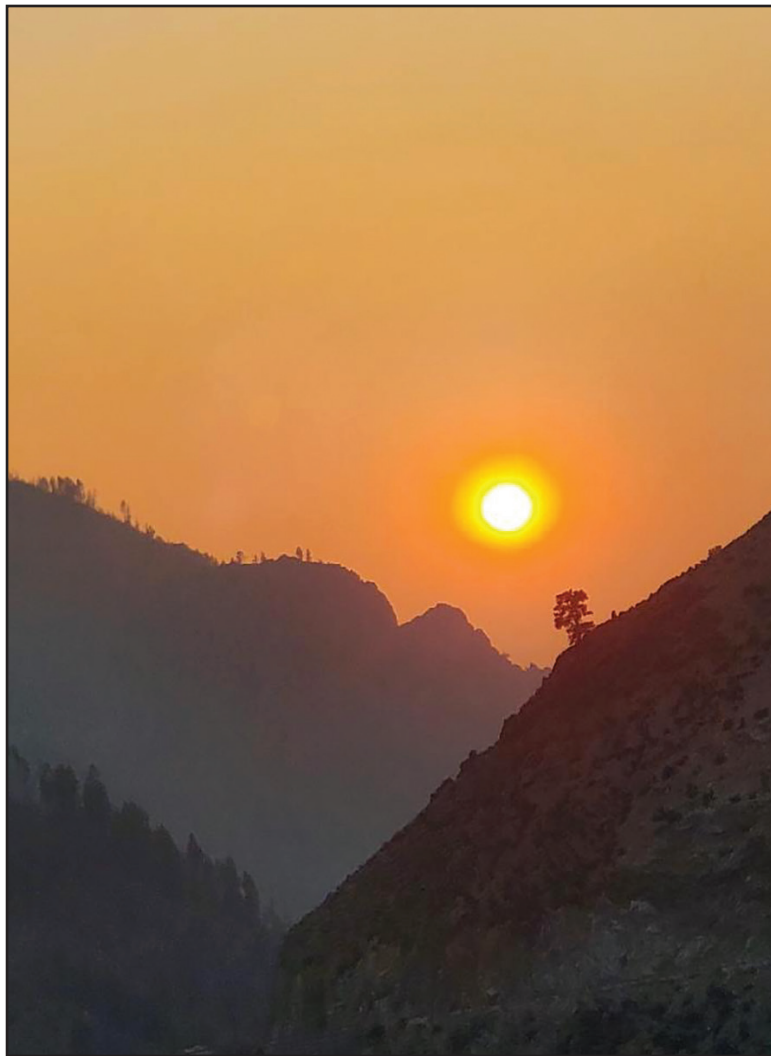

SUMMARY OF BOISE COUNTY ORDINANCE AMENDING THE BOISE COUNTY LAND USE ORDINANCE TO CREATE A NEW CHAPTER GOVERNING THE AVIMOR DEVELOPMENT, ORDINANCE NO. 2021-2

Boise County hereby gives notice of the adoption of Boise County Ordinance No. 2021-2 ("Ordinance"), an ordinance of Boise County, Idaho, amending the Boise County Unified Land Use Ordinance by establishing a new Chapter 8, entitled, the "Avimor Development Ordinance." This Ordinance governs the development and administration of all land in the Avimor Planned Community, and has no applicability to land located outside of the Avimor Planned Community boundaries.

More specifically, this Ordinance: (1) establishes the permitted land uses for land within the Avimor Planned Community; (2) creates a design review and approval procedure for all development within the Avimor Planned Community; (3)

establishes the site development standards and regulations for developing land within the Avimor Planned Community, including setback requirements, building heights, density requirements, hillside development and grading requirements, off-site parking requirements, exterior lighting requirements, screening requirements, construction standards, architectural design standards, landscape standards, street standards, irrigation standards, grading and drainage requirements, and plant selection guide; (4) establishes the signage requirements and sign permit approval process, including setting forth violations and penalties for noncomplying signs; (5) establishes the standards and criteria for approving special uses with specific conditions for land use in the Avimor Planned Community; (6) establishes standards for off street parking and loading facilities within the Avimor Planned Community; (7) sets forth standards re-

garding non-conforming use in the Avimor Planned Community by incorporating Section 4.2 of the Boise County Unified Land Use Ordinance; (8) establishes the standards for administering and enforcing the Ordinance, including setting forth standards relating to zoning permits, certificates of occupancy, conditional use permits, variances, administrative appeals, amendments to the Ordinance, notice requirements, and establishing violations and penalties for failing to obtain necessary permits and certificates and otherwise failing to adhere to the Ordinance; (9) establishes the standards and procedure for subdividing land within the Avimor Planned Community, including setting forth the application requirements, preliminary plat requirements, final plat requirements, fees, parcel division requirements, minimum design standards, street requirements, required improvements, pathway and sidewalk regulations, and

drainage and flood control requirements; (10) establishes the standards and procedure for special development subdivisions in the Avimor Planned Community; (11) establishes the subdivision administration and enforcement procedure, including setting forth violations and penalties, including providing the penalty of a misdemeanor, for failing to comply with the subdivision process as articulated in the Ordinance, and setting forth the appeals process; and (12) provided that the Ordinance will be effective upon its passage, approval, and publication.

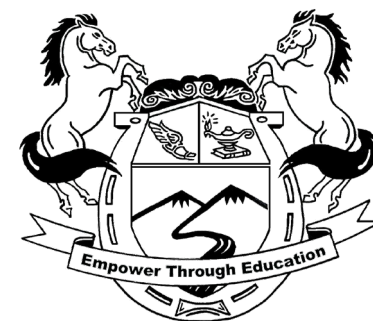
