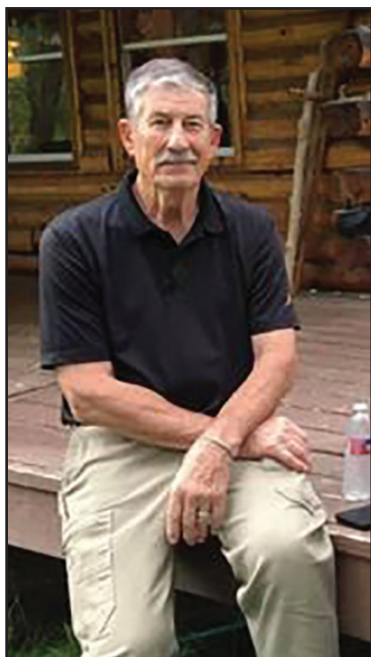

GV Fire Protection Ushers in a New Chapter

GARDEN VALLEY -- The Garden Valley community was stunned by the passing of their

Fire Chief, Jon Delvalle, last month. Chief Delvalle contracted COVID-19 during his work. His passing has left the Fire Protection District to regroup and find a path to keep moving forward with the good procedures Delvalle created for a robust fire department and emergency services.

Robert Glankler has been appointed Fire Chief to keep this new chapter going forward. In a letter he wrote to his staff, the newly appointed Chief reassured his team they would continue on, despite the tragic upheaval. This is good news to the community as well.

In his letter, Chief Glankler stated, "We are not at an ending with the close of [Delvalle's] service but at a beginning, the beginning to carry on in emergency services, and let it not be forgotten in the memory of the Chief...it is time to heal. We must move forward as the

Chief would want and expect. He and I had long discussions on his visions.....it is not to be rushed. Our current task at hand is the continued growth and smooth functioning of the Garden Valley Fire Protection District and EMS Services."

His commitment to the community began when Glankler and his wife, Cheri, and two dogs moved to retire in Garden Valley. He became involved in the Garden Valley Fire Department and quickly became Assistant Chief and Training Officer. His credentials speak for themselves. He is respected throughout California Fire according to Cheri. He is a graduate of Stanford University Paramedic Program, achieving the Bachelor of Science Degree in Fire Administration. Glankler has been a professional Firefighter for 35 years. He has worked in every position from Firefighter/Paramed-

ic, Engineer, Captain, Fire Investigator, and on to Battalion Chief. This includes serving as a Fire Science College Professor and Academy Instructor. He has also served as a Strike Team Leader for wildland fires.

His letter states how important it is to keep a "cohesive team" and will keep communications going to meet challenges which Glankler states are "ever changing." He promises to keep an open door to everyone, so that he can engage in the concerns and suggestions, seek solutions, and make any transition easier. He understands the commitment the volunteer crew makes. Glankler is making sure the visions of the former Chief are followed through as needed. A seamless change will be the focus.

Chief Glankler is a soft-spoken man in conversation, but he has no problem getting in the trenches. "He always led by example," according to his wife. She revealed that his favorite job was the "Truckie." Truckers are the heavy workers, especially with structure fires. Cheri says, "He is very quiet, and he has seen so much.

His old crews respected him a lot because he always helped, never would ask a firefighter to do anything he wouldn't."

Recently, Chief Glankler had actually retired and hung up his suit only to be called back when Chief Delvalle went into the hospital. Glankler felt the call to return, mainly because he cares so much about the community he resides in. The hole left by Chief Jon Delvalle is far too great to ignore but the community will feel a seamless transition in leadership with the GVFDP staff and volunteers. Cheri has mentioned before, "You just can't take [firefighting/EMS] out of him. No such thing as retiring! Firefighters are Firefighters forever."

September 30, 2021

Pledge of Allegiance

Present: Commissioners Ryan Stirm, Steven Twilegar, and Robert "Ted" Holmes

EXECUTIVE SESSION: Closed session for personnel. [Time 9:04 to 9:33 am] No action required.

CONSTITUENT INPUT: None

MINUTES: Chairman Stirm made a motion to accept the official meeting minutes from Sept. 21 and Sept. 23.

SOFTWARE VENDOR: Chairman Stirm opened a discussion regarding the county going with someone else rather than Computer Arts. Clerk Mary Prisco stated: "There's definitely a consensus among the other counties that we've reached our tolerance level with them, but there's also recognition that there's a lack of other alternative softwares."

Prosecutor Adam Strong said that Computer Arts runs the Assessor's Office appraisal system, indigent, financial, Treasurer's Office, and many components. He said it was possible to go with different companies for different things, "I don't think you're going to find one company like Computer Arts that services the needs of the Assessor's Office - unless you have someone go out and design," like Ada County did. "We're probably not big enough for that." Commissioner Stirm suggested reaching out to the other counties who are displeased with Computer Arts.

Commissioner Twilegar said, "It sounds like there's no solve for this." Prosecutor Strong did point out that Computer Arts does cater to Idaho law. Twilegar would like to contact the National Association

of Counties.

POLLING PLACES: A motion was made to approve the agreement for polling places for the Ladies Auxiliary Club hall in Horseshoe Bend, the Garden Valley Senior Center, the Centerville Fire Station for the Placerville Precinct, and the Clerk's office in Idaho City for absentee voting.

TRUCKS: There were trucks discussed for purchase with a plow, sander, etc. They are surplus from the Idaho Transportation Department. Chairman Stirm made a motion to approve the purchase of three Mack Trucks from ITD surplus, not to exceed \$40,000. All eyes.

PUBLIC DEFENDER: Chairman Stirm motioned to approve the 2022 contract for the Boise County Public Defender with a fee schedule.

TRAFFIC ENFORCEMENT GRANT: An agreement with ITD allows for the Sheriff's office to apply for grants. Chairman Stirm motioned to approve the traffic enforcement grant project agreement between the Sheriff's office and ITD.

JUVENILE DETENTION: Chairman Stirm made a motion to approve the Boise County/ Canyon County Juvenile Detention housing agreement.

GARDEN VALLEY SRO

AGREEMENT: Sheriff Scott Turner explained, "This is our yearly agreement. We have a yearly agreement with all three school districts. They don't contribute funds to help pay for the SRO [School Resource Officer]." He said there were no changes from last year, and Sheriff Turner is waiting for the other two agreements to come back from the schools. Commissioner Stirm motioned to approve the Garden Valley agreement.

SOLID WASTE FEES: A motion was made for extraordinary waste fees, per Boise County Resolution 2021-46, which set for those extraordinary items [like hot tub disposal]. Another resolution [2021-47] was adopted for an increase of solid waste fees.

OPERATING ON A CASH BASIS: Commissioner Stirm motioned to adopt Resolution 2021-48, "operating on a cash basis. It's a Boise County resolution to operate on a cash basis and carryover for fiscal year 2022 budget." The motion carried.

AUTOPSY: Chairman Stirm looked at the budget and stated, "It looks like we've gone a little bit over our autopsy budget."

BILLS: Chairman Stirm motioned to approve the claims approval report 9/24/2021 in the amount of \$84,458.

EAST BOISE COUNTY AMBULANCE DISTRICT: Chairman Stirm motioned, as the EBCAD Governing Board, to approve the final payroll budget for FY2022. He then motioned for EBCAD to operate on a cash basis and carry-over to the FY2022 budget.

CRISIS STANDARD OF CARE: Ms. Potts said, "I just wanted to make you guys aware that this is implemented now." She continued that it has a much greater burden on them, if someone calls 911 and they're not sick enough to be taken by ambulance to the hospital. Potts said they are legally required to transport a patient to the hospital if they want to go. "Now it's on us to try to convince them not to go to the hospital. *The hospitals are full.*" She added that they may need to transfer patients to alternate facilities like Twin Falls.

Taking a volunteer and paying them through a FEMA grant was discussed, because there is money available for health care workers.

JUVENILE JUSTICE: They helped with the kid's carnival for Idaho City Days. Ms. Leader said it was a fundraiser for the department.

EMERGENCY MANAGER: Ms. Richardson said they

Digital Land Records Become Searchable

BOISE COUNTY -- Boise County Commissioners approved the request of a private company, Landpro Data, to come digitize and convert to PDF land records for the county. The county will receive a digital copy as part of the deal, and was given the go-ahead because it was not feasible for county employees to undertake such a task. The company set up for two days to photograph subdivision maps, instrument numbers, and when each were recorded. This type of information is most helpful to surveyors. Landpro Data, an office of about ten people, will input information such as subdivision names and instrument numbers together so that it will become searchable. They have been

The team went 25-10, 25-21, 25-11 against their 1A DII Long Pin Conference rivals, the Garden Valley Wolverines, to take the match win on the road on Tuesday, October 5.

Sophomore Annelie Wilson brought in 15 kills (an attack on the ball which is not returnable by the opposing team), 3 aces (a serve which is unable to be played or returned by the opposing team), 5 digs (passing a spiked or hard hit ball), and 1 assist (pass, set, or dig ball to another player who gets the kill). Sophomore Abby Howerton had 5 kills, 2 aces, and 3 digs. Freshman Aliyah Meyer had 3 kills, 3 aces, 1 block (blocking the ball into the opponent's court leading to a point or side out), 8 digs, and 26 assists while senior Kenzie Renfro contributed 9 digs.

The Lady Mustangs hosted the Tri-Valley Titans for Horseshoe Bend's

Homecoming game and Senior Night on Friday, October 8. The assembled crowd honored seniors Lilly Fellom (who was also crowned as Homecoming Queen before the game), Kloe McReynolds, Lexi Roberts, Kenzie Renfro, and Katie Vavra (also a Homecoming Princess) as they played their last home game of the season against the Titans.

Stat leaders for the game were Renfro with 8 kills and 3 digs, Wilson (Sophomore Homecoming Princess) with 8 kills, 2 aces, 1 block, and 6 digs. Fellom was on the board with 4 kills and 4 blocks and Meyer (representing the Freshman class as their Homecoming Princess) had 1 kill, 5 aces, 9 digs, and 29 assists in the 25-10, 25-11, 25-8 match.

The win put the Varsity Mustangs 8-0 in conference play and 14-0 overall for the season. The Junior Varsity team won as well, going 25-23 and 25-13 against Tri-Valley.

The Ladies traveled 220 miles to Arco in the early hours on Saturday, October 9 to participate in the Butte County

Standing 6'1" Wilson is a dominating presence on the court and she's well on the way to all-conference and all-state honors, duplicating her freshman year's outing.

The Lady Mustangs finish up regular season play on Monday, October 11 in New Meadows and on Thursday, October 14 in Cascade before heading to the District Tournament in McCall on Saturday, October 16.
