Arson in Clear Creek Engulfs Structure and Threatens Lives

EAST BOISE COUNTY -- A call for a structure fire went out to the Clear Creek volunteer firefighters on October 21st 2021, between 11 pm and 11:30 pm on White Horse Ridge Road. The residential structure quickly became fully engulfed in flames. Three individuals were able to escape and another is now in custody of the Ada County Jail.

There was real concern of the fire spreading to the surrounding forest, uphill, and over towards Clear Creek Road. Fire Chief Sam Bo-

novich said he was thankful that the other homes were far enough away to be saved. The fire was knocked down prior to running up the hillside, which threatened the safety of homes, the firehouse, and the Lodge.

Thorn Creek Fire also responded with mutual aid. Providing a water tender, they helped work the fire. The fire was successfully contained. Nearby neighbors recalled hearing explosions, which were likely the result of items inside the house caught in the heat of the fire.

Chief Bonovich said this was a difficult residence to fight a fire in, because a structure was built around a trailer. Getting water underneath proved tricky with two floors and the metal roof of the structure.

Boise County Officers took Stephen Buenafe into custody. He was being held without bail, but on Monday, October 25, the magistrate judge arraigned the suspect and set a bail of \$250,000. He was made aware of his rights and of the charges, which include: arson and three counts of attempted murder.

Buenafe was scheduled for his next court date of November 8th at 11am for a preliminary hearing.

Idaho State Fire Marshal Knute Sandahl confirmed that the case “definitely” had an element of arson. There appears to have been an ignitable liquid that was used as an accelerant; however, there are still samples being examined in a laboratory that will need to be confirmed prior to the completion of a formal report.

Hanging Valley Complex Goes Up in Flames in Lowman



State Fire Marshals survey the structure remnants after a fire burned down a cabin and extended into the forest in Lowman. Boise County Sheriff Scott Turner said they estimated the fire must have started burning sometime between 2:30 am and 3am on Thursday morning. The fire was originally called in by hunters who were camped nearby and suspected it was a forest fire. They had heard what they described as gunshots.

The cabin was a complete loss. Firefighters were able to keep the fire from spreading, but was declared a wildland fire. Sheriff Turner said there did not appear to be anything suspicious regarding this fire.

LOWMAN -- Early Thursday morning on October 21, the Lowman Volunteer Fire Department responded to a cabin fire. By the time the fire was reported, the home was completely engulfed in flames and was a total loss.

The fire beginning to spread to the surrounding forest. Garden Valley Volunteer Department also responded with as-

sistance and within an hour or so the Forest Service Hot Shots also arrived. Together the departments were able to contain the fire to about two acres, averting a possibly devastating wildfire.

According to the State Fire Marshal Knute Sandahl, the fire's origin is undetermined at this time.

School Board's Letter to the Community

BASIN SCHOOL DISTRICT -- Basin Elementary deserves congratulations for being recognized in U.S. News as being in the top 30% of the schools in the state of Idaho. The faculty and administration have worked tirelessly for decades to bring the schools into the 21st century and provide the quality of education that the community deserves. During this time the school board has tried to facilitate and lead the district forward and not settle for mediocracy.

One of the enemies of progress in the district has always been misinformation and disinformation. It seems that as of late there has been an explosion of incorrect information directed at the school board. It would serve our community to address some of these comments and provide some facts to dispel the toxic comments

that have been circulating.

1. The lack of voting records on the Boise County site is due to the fact that the trustees ran unopposed during the years of missing records.
2. The deadline for filing was changed and all the trustees missed the deadline in the last election period so there was no election. During the 90 and 120-day waiting period following the election date no community members stepped up to be a trustee from zone 3, 4, and 5 so all three trustees remained in the positions. Mary Ellen McMurtrie does not live in zone 3, but was the only person who came forward, so by Idaho code she was awarded the position.
3. Trustee Kline was accused of not wearing a mask in Fred Meyer while testing positive. Someone copied a picture of trustee Kline and her late hus-

band and cut off her husband to illustrate she wasn't wearing a mask even though the picture was over 6 years old. She had been in isolation for the required 14 days before entering Fred Meyer.

4. There have been no election violations committed by the Basin School Board's five members. As per the Boise County prosecuting attorney there have also been no complaints or violations of open meeting law by any of the members.
5. As per Idaho code the school board chose to accept written comments at the last board meeting to give everyone a voice in a more efficient manner for the board to review various opinions.

6. School districts across the state receive about 80% of the funding required to run a district. The Basin School District relies on levies and grants to make up for the remaining 20%. We work hard to reduce the tax burden by applying for grants and researching ways to improve efficiency and stretch every penny.
7. The board abides by the Idaho Constitution and all Idaho Codes and when in doubt seeks advice from education law experts.

The Basin School District staff members work very hard to educate the community's children. We aren't all perfect but we are doing our best to help each and every student

learn and to prepare them for the next step in their lives. It takes a community to make all this work. Thank you to all of those who advocate for education and for those who are frustrated and angry. We encourage you to come in and discuss your frustrations and hope that we can come up with solutions together to help our students be successful in the future.

Horseshoe Bend City Council Meeting October 2021

HORSESHOE BEND -- The following is a synopsis of the Horseshoe Bend City Council meeting on October 20, 2021. Mayor Pat Goff was not in attendance, councilmember Ben Riley ran the meeting in his place and made the call to order at 7:00 p.m., led the Pledge of Allegiance, and after unanimous approval of the agenda, previous minutes from the meeting, and the authorization to pay the city's bills, Riley opened the dais for public comments. The council's chambers were full of attendees but no one came forward to speak. The council then started on new business.

The Computer Arts software contract was approved unanimously by the council with the same pricing as last year. The next piece of business on the agenda was an action item requesting that the city council meeting date be changed from the third Thursday of each month to the second Thursday, so as not to coincide with the Horseshoe Bend School District board meetings. The change would require altering a city ordinance, something that city attorney Tony Pantera explained would not be difficult. Councilmember Martye White suggested that changing the date of the meetings would interfere with the city's ability to approve and pay bills on time. White also referred to the possibility of new councilmembers coming on board after the November 2 election and requested that they be allowed to take up the matter, saying, "Changing it now would be ridiculous." Councilmember Riley put forward that the school board needed to change the night of their meeting. Councilmember Curtis Corvinus agreed with moving the meeting as it interferes with the Horseshoe Bend Volunteer Fire Department's meetings. (Corvinus is the fire chief). Councilmember Stephen Chartier had no opinion one way or the other. The matter was tabled until next

month for Mayor Goff to present his rationale as it was he that asked for the item to be included on the agenda.

Horseshoe Bend Valley Chamber of Commerce had an action item with a request to utilize the existing flagpoles along Highway 55 to spotlight businesses. The funds raised from the endeavor would help fund chamber sponsored events like the upcoming Trunk or Treat, which will be held on Saturday, October 30 at Barreto Manufacturing (125 mill Road). Chamber treasurer/secretary Nicole Cundiff told the council that the flags/signs the chamber would hang would showcase businesses in the community and connect travelers with business offerings in the city. Chamber lead Kimberly Welsh told the council that there would initially be approximately 3-5 flags and that they would be removed when other events were scheduled that needed the flag poles, such as Horseshoe Bend High School's graduating senior class and the Optimist Club's car show. Welsh told the council the various signs would be displayed for a few months at a time. She suggested that signs the city may want to display, such as welcoming signs, could be hung as well. The cost to the city would be minimal, only the time spent by the public works department in hanging the signs/flags. Corvinus was in favor as long as everything adheres to city code. White said, "I like the idea as long as we keep it to 3-5 signs," adding "We don't want it to look like a circus." Chartier remarked that it would be good for the city. The request was approved unanimously.

Horseshoe Bend resident Amber Henson spoke to the council about COVID-19 money the city had received via a grant. Henson made allegations that the city had failed to use the COVID grant money in the manner it was intended for. Her complaint was the money was intended to livestream council meetings and that equipment had

been purchased for that intent but after receiving the money almost one year ago, no meetings had been livestreamed.

Henson's second issue with the council was over the State of Idaho's open meeting laws. She told the council that she had read the state's manual regarding open meeting laws "word for word" and that the mayor and the city council have been openly violating the laws that applied to open meetings for at least three years. She admonished the council and told them that any fines associated with their violations would need to be paid by themselves as individuals, not by the city. Henson quoted various items and corresponding codes from the manual that she concluded were violations: 1. Agendas were not being posted properly. 2. Meeting minutes had not been made available to the public for at least three years and those minutes need to be available to the public before approval by the council at the next month's meeting. 3. Minutes of executive sessions are not being kept and that there must be a compelling reason before the council can even go into an executive session. She asked the council, "Why is an executive session meeting on every agenda?"

Her last remark to the council was, "You may want to have an executive session tonight to discuss a pending lawsuit."

No EMS update.

Public works: Some part deliveries for the ozone generator are being delayed, so some repairs are being shelved for the time being. A leak in the nitrogen component of the generator was found and repaired.

Grants: Cheryl Pleak reported that the grant money for the EMS LUCAS device (mechanical chest compression system) would be arriving soon. She told the council that if she is seen at the new park, she is not actively working on the park but just getting bids.

A bid for sod came in at \$65,000, but a bid for hydro-seeding was

only \$12,000. A public meeting was suggested to get input from community members regarding what features they would like to see in the new park.

The comprehensive action plan was due on October 1. She said the written plan went to the council in April and it's very important that the council knows the plan. She said that the comprehensive plan was "not just A plan, it's THE plan."

Pleak reported that the new census added 146 residents to the City of Horseshoe Bend, which now has 850 citizens. The census also provided information on rental properties. According to Pleak, 23.5 percent of the housing in the city is made up of rental properties with a current 1.4 percent rental availability. She told the council that the city needs more affordable rental housing to meet the needs of the community. She suggested they try to get Section 8 housing certificates and encourage the development of housing with lots of layers. "We need to look at how we're going to take care of our people," she said.

Pleak also said she had looked into the situation regarding the Boise Street bridge, which is currently closed to traffic due to safety issues. Pleak wants the bridge to be added to the comp plan as a means to get it repaired. She indicated that if it were to be included in the plan as a necessary means of

ingress and egress to the city, then Boise County would be required to fix it.

Pleak also spoke about the city's area of impact plan, which is an indicator of how far out the city can expand.

City engineer: They are working on Department of Environmental Quality permitting and providing support to the city as needed.

City attorney: Pantera said he is working on processing the pending application for the Deer Valley subdivision and revising city codes. The meeting adjourned at 7:40 p.m. The city council meets next month for a workshop regarding the Deer Valley subdivision on Wednesday, November 10 at 7:00 p.m. (rescheduled from Wednesday, October 27)

City council meetings are the 3rd Wednesday of each month at 7:00 p.m.

MUSTANGS HEAD TO THE QUARTERFINALS UNDEFEATED

HORSESHOE BEND -- Under stormy skies and Friday night lights, the Horseshoe Bend Varsity Mustang Football team clinched the 1A Division II Long Pin Conference title for 2021 and ended their regular season 8-0 overall. Led by senior quarterback Colten Meyer, the Mustangs came out with a 2-point lead in their quest for the district championship against the Council Lumberjacks. Meyer racked up 85 rushing yards and 123 passing yards with 1 touchdown on the offense and had 5 tackles and a pick six (an interception returned for a touchdown) in the close 38-36 victory. Senior Decker Larson also got in on the action with 40 rushing yards with 1 touchdown plus 92 receiving yards with a touchdown. Larson also came up with 4 tackles and a quarterback sack while doing defensive duty. Junior Blayne Meyer helped the Mustangs with 3 touchdowns off 136 rushing yards and had an additional 18 receiving yards and 8 tackles of defense. Sophomore Kaelun

Joes had 62 rushing yards for the night along with 11 tackles. On defense, senior Keegan Smith provided 8 tackles, junior Jedi Graham had 6 tackles, and senior Dylan McLean, sophomore Nic Cooper, and sophomore Gavin Tomlinson each had 1 tackle. The Mustangs received the bye this week, thereby skipping first round game play and advancing straight to the quarterfinals against the Kendrick Tigers at Kendrick on November 5 or 6. Kendrick finished 1st in the White Pine conference with a 4-0 conference record and 6-2 overall record. Their record at home is 4-1. Kendrick is approximately 250 miles from Horseshoe Bend (and just under 30 miles northeast of Lewiston). Willis B. Hovey 1931 - 2021

Willis B. Hovey, formerly of Lowman, ID, passed away at an assisted living facility in Boise, ID on October 6, 2021.

Will was born in Kalispell, Montana on September 1, 1931 to Paul and Anna Hovey. Will had three sisters; Helen, Mary and Pauline. He was preceded in death by his parents, his sisters, his beloved wife Dorothy, and her granddaughter Sally Zanders. Will attended schools in Half Moon and Kalispell, Montana. He entered the Army reserves in 1949, and was active in the Army reserves until 1955. Will was presented the Eisenhower Trophy for his service during the Korean War where he was stationed stateside and trained troops on Howitzer long range heavy artillery support weapons. While in Kalispell, he worked for Greig's Dairy. Will married Nancy Kinshella in 1952, they were blessed with five children: Cindy, Vickie, Kathy, Brian, and Leo. Will and Nancy eventually moved to Boise, Idaho. They divorced in 1973.

Will worked in various jobs in the food service business for 45 years. He was eventually self-employed and it was Moon's Café in downtown Boise that was his most loved business. He was renowned for his hand-crafted milkshakes and plate-sized pancakes. He was also known for opening Moon's in the early morning before business hours for people to come, drink coffee on the house, and read their newspapers. In 1974, Will met Dorothy Bryan, they fell in love and were married that year. Once retired, they moved to Lowman, Idaho in 1988 where they built their dream home. They lived happily ever after in Lowman until Dot's death in March of 2018.

Will was a master woodworker and many places in Lowman have his handiwork in their homes. His workshop was an inviting place for friends and family to visit, ask for

advice or just while away the time. Will loved the outdoors and spent much of his time mowing grass, blowing snow, and participating in woodcutting parties. Will was a long standing member of the Lowman Community Church where he enjoyed helping with building projects and maintenance both inside and out. He also put time into the fire station, ambulance building and he helped build the landing pad for Life Flight in Lowman. Will began as a volunteer for the fire station and the ambulance, he eventually received his EMT Certification and served in this capacity until he retired from ambulance service. A memorial service for Will is scheduled at the Lowman Community Church on November 13, 2021 at 2:00pm. Memorials may be sent to the cemetery fund at the Lowman Community Church.

A logging operation is taking place along Granite Creek Road from Placerville, and will continue on through Alder Creek Road in the coming weeks. The purpose of this operation is to clear trees hindering the future path for Idaho Power to run another line to improve reliability to Placerville, Idaho City, and other areas throughout east Boise County. This new line would create power redundancy. The logging operation will likely continue through the middle of December 2021.

Boise County's Road Superintendent Curtis Dill said that motorists should expect long delays, lasting up to one hour, to allow trees to be taken down and cleared from the roadway. Flaggers will be controlling traffic and operations will take place from Monday through Friday. Signage will be placed in strategic areas and motorists are advised to consider alternate routes of travel during this time.

In addition, motorists should expect to see increased logging traffic along Harris Creek Road.

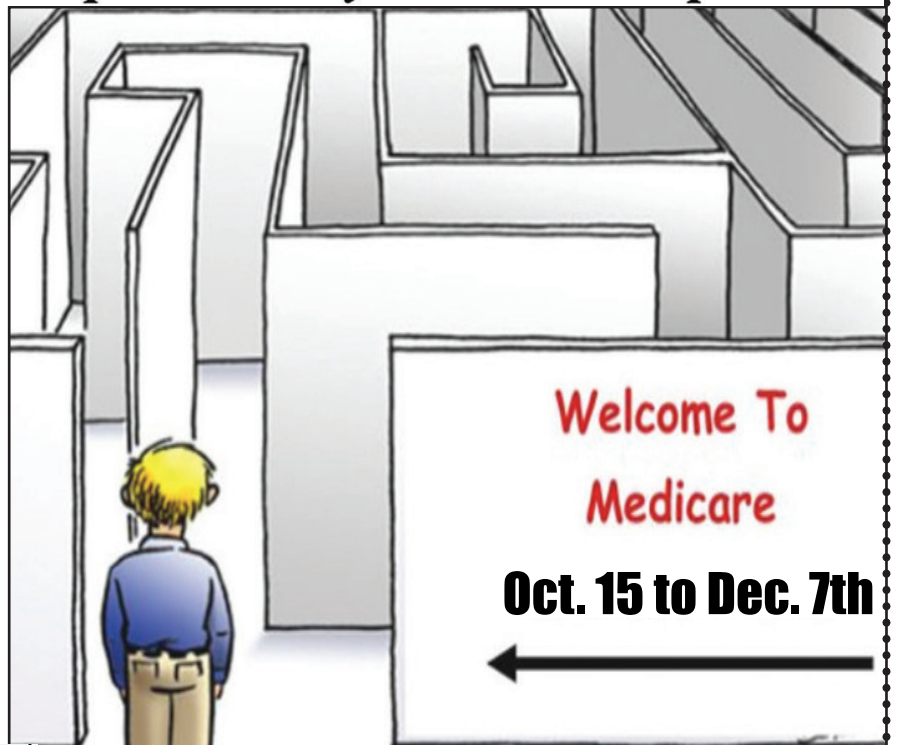
