# Meet Horseshoe Bend Candidates for Office

### HORSESHOE BEND --

A candidate forum for those running for public office in Horseshoe Bend was held on Thursday, September 30<sup>th</sup> at The Locking Horns Riverside Restaurant. Several write-in candidates attended as well as two candidates who will be on the ballot, Councilmember Curtis Corvinus (incumbent) and contender Patti Burgess. Incumbent mayoral candidate Pat Goff was not in attendance.

Running for a seat on the city council, **Patti Burgess** told the crowd that this is her first time running for a government position and that she was “really excited and nervous.” Burgess originally lived in Salem, Oregon for over 20 years and has been a resident of Horseshoe Bend for the past three years. She has been attending city council meetings for the past year and was concerned that there was not many community members in attendance. She attributed the lack of attendance to advertising. Burgess feels not much is accomplished during meetings, because people come in with too much emotion in their presentations and that the “real talk” comes after the conclusion of meetings. She says she has observed little unity between the mayor, the councilmembers, and the community. She touched on her contributions to the community which included organizing a Santa Claus event last year, and orchestrating a caroling group. She says those events were planned so people in the community could relax and have fun and she wants to bring that same approach to the city council. When asked what she would do to unify the community she responded, “To take what happens in the city council and bring it to the public’s notice.”

**Virginia Jakovac** is also a write-in candidate for city council. She agreed that there were a lot of good candidates to consider. Jakovac said she

is running because she cares about the community and that currently there is a disconnect between the city and the community. She told the audience that she is retired and has time to serve. Her experience includes having worked for the Idaho Transportation Department managing and balancing budgets and tracking grants. She’s familiar with how government entities are run. Her vision involves the city council adopting inclusiveness, running responsibly, and using the comprehensive plan to bring about balanced growth in the city. She also wants to see more administrative accountability with capital assets, saying that the city can’t continue to see lawsuits. Jakovac pledged to making solving the current Emergency Medical Service (EMS) issue a top priority. She added that, to her knowledge, minutes of city council meetings are not available past the year 2018. When asked how she would handle the EMS issue, Jakovac replied that she believes the department should have paid positions and added that she would like to see the city with its own police officer as well. When asked how the service would be paid for, Jakovac suggested a forensic audit be done of the city’s finances.

Write-in candidate for city council, **Qandryel Romrell**, spoke next. She feels it is important that the voices of the people be heard. She added that she has many skill sets that she can contribute as a councilmember. Among those skills she listed were high problem solving skills and knowing how to utilize those skills to help others come to a resolution. She says that she wants the council to solve problems right away, instead of sweeping them under the rug. She wants the city to have the resources to take care of itself, and indicated that, currently, the city has to rely on others. Romrell gave an example re-

garding the food bank getting their needed supplies from Boise. She suggested starting a community garden to help supplement the food bank, saying, “Then we’ll be self-reliant.” She is also concerned with the current water situation in Harris Creek and claimed that there isn’t enough water to sustain nearby ranches. Romrell wants to explore taxing those outside of the city limits that have children attending the Horseshoe Bend School District.

Incumbent City Councilmember **Curtis Corvinus** is vying for four more years in office; however, he admitted that he bit off a little more than he could chew by becoming a councilmember. He thinks that the council should be meeting more than once a month and that a taxing district should be formed with those that live outside of the city limits, which would help pay for the fire and EMT services. He believes that a paid position for those departments would be “absolutely outstanding.” He stated that trying to pull the city government out of the “good old boys system” was harder than he thought it would be. When asked what makes him hopeful in running again, Corvinus replied that he doesn’t like what is happening with the city

council and that growth within the city needs to be handled more efficiently. He added that the council could be run more effectively if they were held accountable for public notices and had the minutes from council meetings promptly published.

Write-in mayoral candidate **Jon Dufresne** spoke from the cuff, stating that he had been self-employed all his life and that he “understands laws pretty well.” He made mention of the city’s purchase of the Wood’s property (soon to be the Wood’s Veteran’s Memorial Park) indicating that the purchase was done illegally. He also stated that it would be monetarily unrealistic for a city of Horseshoe Bend’s size to have its own police force. He suggested that the new Deer Valley subdivision should help with the city’s tax base. He put forward that the city isn’t being held accountable, because no one is showing up to meetings to hold them accountable. Dufresne would like the city to turn away from being a “city of no” and into a city of “transparency, cooperation, friendliness, yes, yes, yes, how can we help you!” He feels Horseshoe Bend is a great town but thinks current leadership is the problem. While he is generally for the new Deer Valley subdivision he does not think that annexing more property for the project is advisable.

**Dave Jakovac** is running as a write-in candidate for mayor (His wife is Virginia Jakovac,

candidate for city council). He was raised in Salmon, Idaho and has spent 38 years in engineering. He agrees with other candidates’ comments regarding the need for more transparency within the city’s government. He told those assembled that as of now, the EMS Department is “missing in action” and that calls are going to Boise. He proposed having paid positions for EMS, fire, and police within the city and said that they could be paid for with impact fees from new developments. He said that such positions could be paid for by economic development and gave the new park as an example, saying that it is a valuable piece of property and the community should decide what is to be done with it. He claimed that the traffic study done for the new Deer Valley subdivision is “woefully inadequate” and that the developer’s engineering report “needs to satisfy Horseshoe Bend.” He voiced his opinion that the city needs to protect itself questioning why no lights were on the newly installed bridge at the southern entrance to the town. Jakovac wants to see the city become more “economically viable.” He wants to change the way the city is currently being run by advertising meeting agendas in advance, having someone in city hall who can answer questions, and providing needed documentation to the community. Jakovac would also like to see the council fully

### Pledge of Allegiance

**Present:** Commissioners Steven Twilegar and "Ted" Holmes

**Absent:** Commissioner Ryan Stirm

**EXECUTIVE SESSION:** [Time 9:07 am to 9:18 am] Closed session for pending litigation update from the prosecutor. Acting Chairman Twilegar said there was no action required.

**CONSTITUENT INPUT:** None

**MINUTES:** Twilegar made a motion to approve the minutes from September 7<sup>th</sup>, 8<sup>th</sup> special meeting minutes, and 14<sup>th</sup> official meeting minutes.

**COMMISSIONER STIRM:** Acting Chairman Twilegar stated: "I think that most of you have already heard that Commissioner Stirm's father passed. So, I think we

should send flowers." He then motioned to send flowers to the Stirm family, not to exceed \$100.

**PAYROLL CHANGE:** Twilegar motioned to approve the payroll change salary for the new Road and Bridge Superintendent Curtis Dill. Commissioner Holmes seconded and the motion passed.

**SHERIFF:** Commissioner Holmes said he would like to look at what the sheriff is paid compared to other counties in Idaho, "He's actually underpaid for the responsibility he has." He makes less than some other departments and Holmes would like to bump that up. Commissioner Twilegar said there seemed to be some discrepancy and they were looking at the payroll scale. Clerk Mary Prisco said that the sheriff's wage was increased for this next budget cycle by a sig-

nificant margin.

**PAYROLL BUDGETS:** Commissioner Twilegar motioned to approve the payroll budgets for the 2022 budget, including these departments: Auditor, Assessor, Commissioners, Coroner, County Elections, Treasurer, Emergency Management, Information Technologies, General Operations, Planning and Zoning, Title 3 Mitigation, Road and Bridge Department, Sheriff, Prosecutors, Dispatch, Sheriff Reserve, East Boise County Ambulance District, Court, Community Justice, Indigent, Solid Waste, Noxious Weeds, two snowmobiles, and the Sheriff's vessel.

**SOLID WASTE/ NOXIOUS WEEDS AGREEMENT:** Twilegar motioned to approve the new payroll addition for a part time worker, pending a drug test. However, the prosecutor asked that they table this approval and Twilegar rescinded the motion.

**JOINT/ QUARTERLY REPORT:** Clerk Prisco reported that Treasurer Gina Turner was absent due to appointments, and added, "This is the report that we've not been able to issue because there was a discrepancy in the Computer Arts software. We do finally have that. I don't know how Gina got it resolved, but she did."

The clerk explained that the report is for the quarter that ended June 30<sup>th</sup> and should have been done the end of July. Acting Chairman Twilegar motioned to approve the third quarter Treasurer/ Auditor's Quarterly Report.

**ROAD DEPARTMENT:** Mr. Dill said he had met and spoken with Idaho Power, Renfro Logging, and the Forest Service regarding the project on Granite and Alder Creek Roads for tree removal and powerlines. Their estimated time to complete the logging will be mid-December. Traffic control and a road grader will be on sight to clean the road after every step in progress. "There will be probably extensive delays." Dill will work with the Sheriff's office, but he expects that wait time may exceed 30 minutes. The crews will be working 7am to 4pm Monday through Friday. There will be signage.

Dill said that he did work on Arrowrock Road. Another person was working on Robie Creek Road.

Old Crouch Road needed more engineering work on the drainage plan, because the previous plan was denied by the Idaho Transportation Department. They hope to get that done soon.

**TAXING DISTRICTS:** Clerk Prisco said there was

some talk with the State Tax Commission in regards to extending the deadline for the levy certification. "I'm hoping they do, because what I've seen so far is - and it's because of HB389 [House Bill 389], the law has just completely changed. Most of these taxing districts are manned by volunteers. It's not that they have not been given the information, they have. They have jobs that they get paid for and all that. Anyway, what we have seen so far is there's a lot of errors and on several of the districts, if there's not an extension given, they are probably going to be leaving a fair amount of money on the table. Because these are the taxing districts that have forgone amounts available. They've done nothing to, they have not gone through the administrative process to reserve that and perhaps they don't want to. But, I also think that there's a possibility that they don't understand what's happening.

**EMERGENCY MANAGEMENT:** Commissioner Twilegar motioned to accept an award of \$21,105.28.

**SOFTWARE CONTRACT:** "The software is becoming more problematic," Clerk Prisco said. "We had probably three or four months

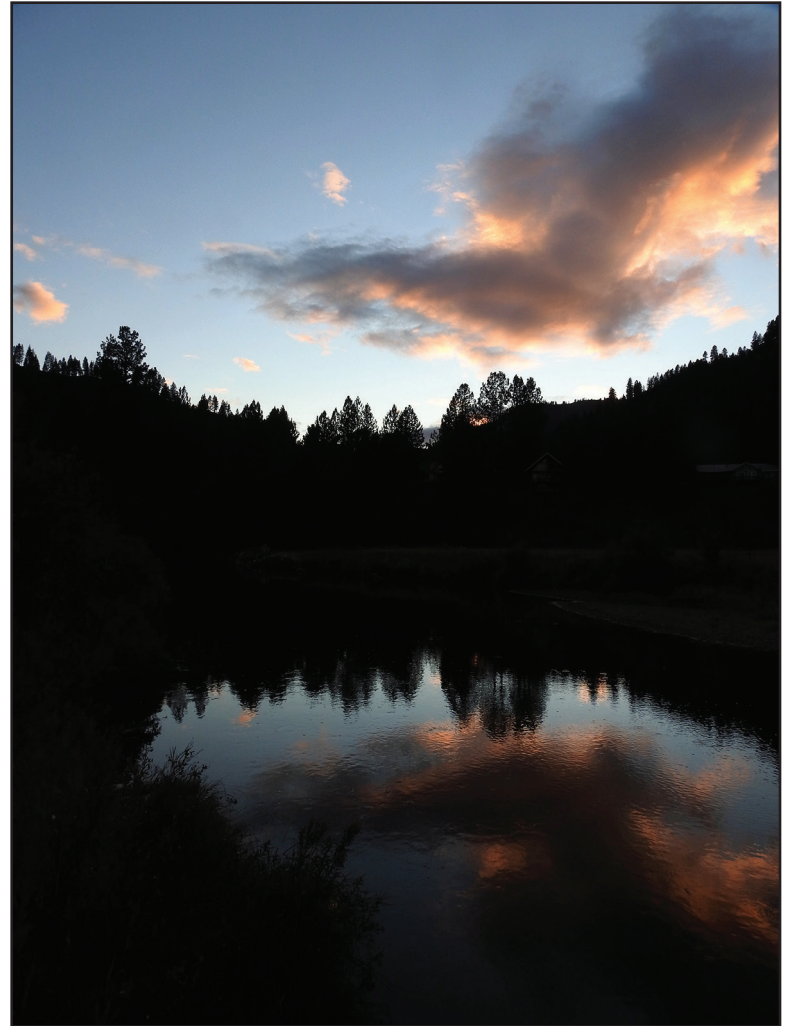

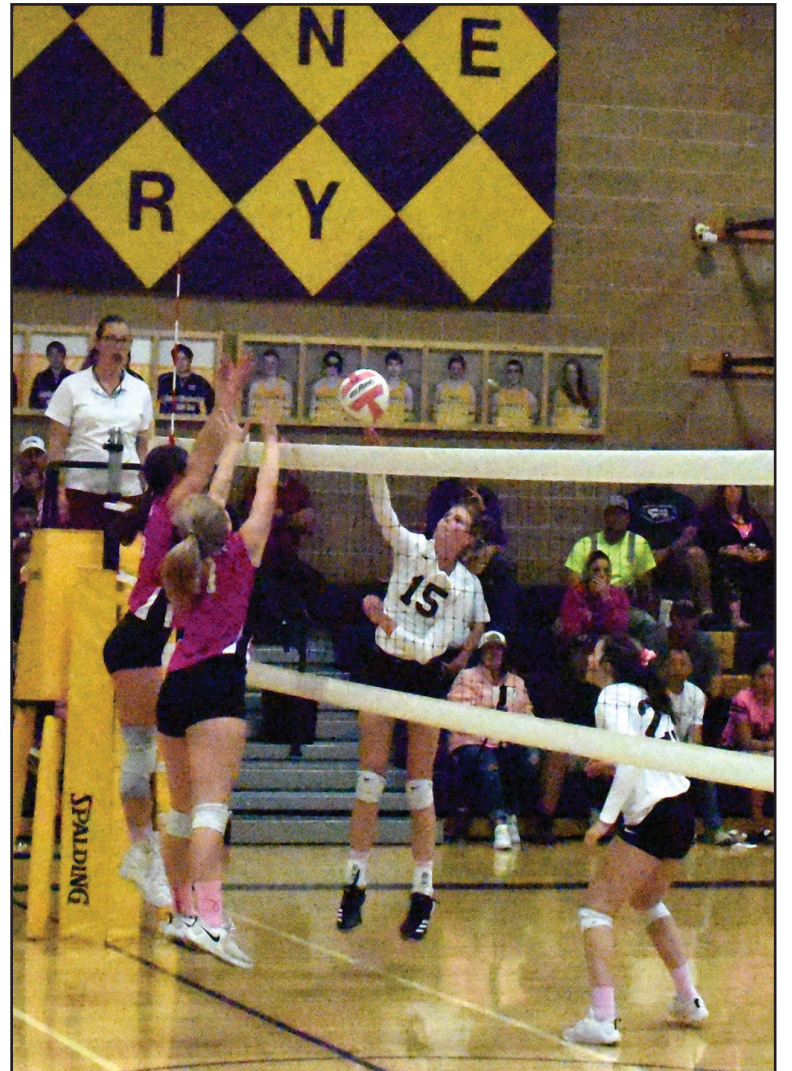

informed before meetings.

After the candidates spoke, a member of the audience, Dale Ortman, suggested to the candidates that residents who were using city water and sewer utilities be allowed to vote in city elections even though they did not live within the city boundaries. Someone suggested that Ortman would not be allowed to keep his farm animals if he was annexed into the city. Ortman stated that he did not wish to be annexed, he only wanted

the right to vote on city matters. Dufresne said that was not possible under state statute.

Another attendee suggested combining the EMS and fire departments. Corvinus agreed that that would be a better plan. Corvinus also announced that he was the newly appointed HSB Fire Chief. Dufresne suggested a debate be held prior to the election and it was agreed that some type of meeting and/or debate would be held on a future date.

went by when we were attempting to work with them on fixed assets for our annual audit." She says the software needs to be reconfigured and reprogrammed. Prosecutor Adam Strong said that this software is very configured to Idaho law, but it wouldn't hurt to look around. Strong also pointed out that it was a terrible contract in which they took no responsibility, the full extent of liability would be to return the county's money.

Commissioner Twilegar recognized the concerns and half-jokingly said, "They could light the county on fire and be okay with it." The prosecutor agreed, "Yeah, pretty much." Twilegar continued, "But for now, we really don't have a choice. On that note, I will make a motion to approve this horrible contract" for Computer Arts.

**AUTOPSIES:** There are autopsies that could not be done in county, so Commissioner Twilegar motioned to approve the pathology services between Boise County and Ada County.

**JAIL:** A motion was made to approve the Ada County Sheriff's Office Jail Housing billing agreement.

**ROAD DEPARTMENT:** A Boise County Resolution was approved to increase the Boise County Road and Bridge Fund for the 2021 budget, in the amount of \$1,018,000. It was said this was for graders.

**RESOLUTION:** Twilegar made a motion to approve Resolution 2021-45 for a reserve budget, capital building and vehicle maintenance.

**CERTIFICATE OF RESIDENCY:** There were several college bound students approved for the certificate of residency, which helps pay for students to attend college in another county.

**911 CALL SERVICE:** Twilegar made a motion to approve the call service in the amount of \$1653.51.

**INDIGENT:** Twilegar made

a motion to approve \$1200 for the indigent fund.

**EXECUTIVE SESSION:** A closed session for personnel issues. [Time 10:21 am to 10:24 am] A motion was made for a new hire, pending a background check.

**4-H:** Rebecca Mills, a representative of the University of Idaho Extension Office in Emmett, spoke regarding a cooperative agreement with Boise County. Youth Programming and 4-H, exhibiting in Gem County. There's a master gardener in Garden Valley now with training.

They have encouraged Idaho City 4-H to enroll with the Ada County program, just for ease of access and the county fair. Two young men talked about their 4-H experience.

Commissioner Twilegar stated: "I commend you boys for doing what you're doing. I encourage you to keep it up. I've yet to meet, very few 4-H kids that didn't turn out as solid individuals as adults."

A woman representative said, "I like to point out that in our Garden Valley club, though we are small, we are mighty."

Acting Chairman Twilegar made a motion to approve the cooperative agreement for the Univ. of Idaho extension program for \$8,500.

**PUBLIC DEFENDER:** Rob Chastain said he had been a public defender for Boise County on-and-off for the past

30 years. He came in to talk with the commissioners.

Clerk Prisco recounted for the commissioners that since the Public Defense Commission has been in place, "the fund that contains the public defense operations, I think three out of five years we've had to make a budget amendment at the end of the fiscal year because we underestimated the cost associated with it." Holmes asked where the funds come from and Prisco answered the indigent fund. There are other funds that the prosecutor spoke about that contribute to the number of cases and workload. Prisco stated, "The cases in this county have just continued to increase, so obviously, that creates an additional cost."

**PLOT AMENDMENT:** Commissioner Twilegar motioned to approve the partial plot amendment of Hanson Subdivision.

**SOLID WASTE FEES:** A public hearing for a resolution covering solid waste fees for "extraordinary items at county transfer facilities." A representative said studies by the solid waste department shows that they are slowly losing money due to fuel costs, contractors' fees, etc. Other than the Horseshoe Bend site, items need to be cut down to less than 6 feet in length. Some items will only be accepted at the Horseshoe Bend site, like hot tubs.

There was no public input.

Acting Chairman Twilegar motioned to approve the draft for the Boise County resolution for setting solid waste fees for extraordinary items. He then motioned to add a 5% increase to all the general assessments, as directed by the prosecutor.

**FINDINGS OF FACT:** Commissioner Twilegar motioned to approve the findings of fact for the partial plot amendment for the Hanson Subdivision.

Adjourned at 2:27 pm.

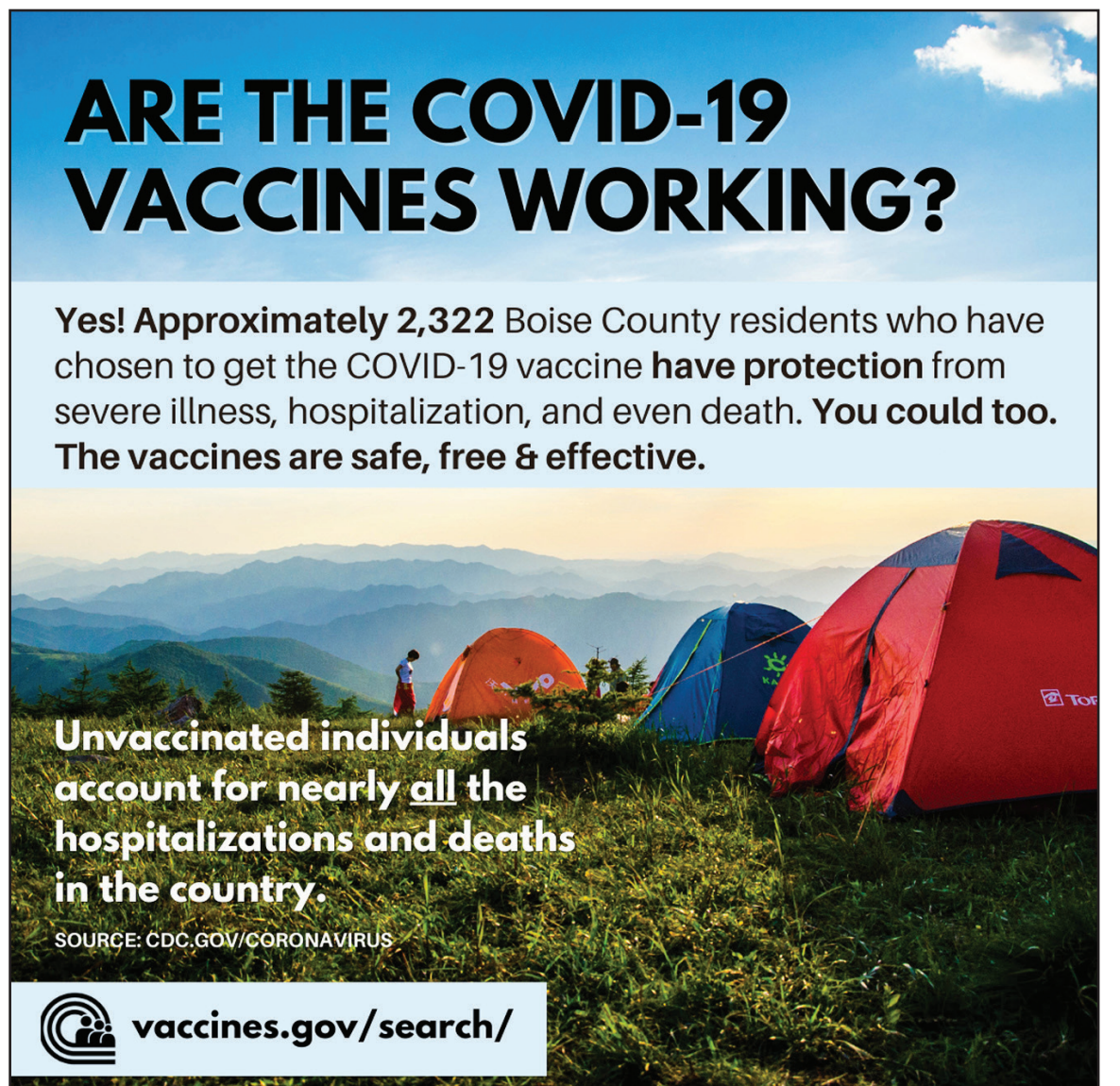

## Fire Prevention Week

**BOISE COUNTY** -- It was 150 years ago this week, October 8th through the 10th in 1871, when the great Chicago fire struck. There have been various stories about how it may have started; one of the longest lasting stories is that Mrs. O'Leary's cow knocked over a lantern when she was milking it. That has finally been disproved, mostly because the O'Learys were already in bed at the time the fire started, which was about 8:30 pm on the evening of the 8th of October.

It had been a long hot dry spell in the area and the Chicago Fire Department had been responding to numerous fires, even a few days prior. At that time, the Chicago Fire only had 17 steam powered pumpers and 185 firefighters. They were already tired and the hot dry wind coming into that area from the southwest caused rapid spread of the fire. It did not help that the Chicago Fire Department was sent to the wrong address to begin with. It was estimated that 300 people died in the fire, even though only 175 bodies were ever recovered. The coroner said that the number would be higher because he figured some would have been consumed in the fire. Chicago lost 17,500 buildings in the fire and a new building code was enacted as a result to hopefully prevent a reoccurrence.

This year, October 3rd through the 9th, is Fire Prevention Week in recognition of that horrendous event 150 years ago.

This year, the U.S. Fire Administration has chosen a theme to present to the public in hopes of preventing fires, reducing the extent of disaster in case a fire does start, and especially ensuring that everyone escapes without injury. This year's

theme is "Learn the sounds of fire prevention."

The "sounds" being pointed out are those noises made by smoke detectors and carbon monoxide detectors. Everyone should have both in their home. There should be smoke alarms on each level of the home and especially in bedrooms. The best location is on or near the ceiling. Carbon Monoxide detectors only need one per level of the house. Mount them at least 5 feet above the floor and NOT too close to a fireplace or wood burning stove.

Since most fire deaths happen between 11pm and 7am, when people are sound asleep, it is important that your smoke detector can wake you up if it is activated. Most are quite loud, and the high pitch has been found to not wake up most children and elderly people. Knowing how your alarm sounds is a simple task. Just press the "TEST" button to set it off. You will know what it sounds like, then. You will also know if it needs a fresh battery. Smoke detectors should be tested every month, just to be on the safe side. If it's older than 10 years, it no longer works at its prime and should be replaced.

If your smoke or carbon monoxide detector does go off, the best practice is to get everyone out of the house and then call 911. Once everyone is accounted for, and no visible signs of smoke are present, you can investigate to see if there is a fire. Just one person should do this.

If your carbon monoxide alarm goes off, it is not advisable to investigate. Carbon monoxide is invisible, odorless, and highly toxic. Fire departments usually have carbon monoxide detectors, and firefighters with respiratory protection can usually locate where the carbon monoxide is

coming from, or determine if it was a false alarm. Also, telling the dispatcher when you call 911 that it is a smoke alarm or carbon monoxide alarm with no other signs of a fire will be helpful for the fire department to know.

A second theme this year is primarily aimed at school age and younger children. That theme is "Firemen are your friends." This stems from the fact that children, especially younger ones, tend to hide when there is a fire. This by itself makes it more difficult for firefighters to search for them. The firefighters wearing self-contained breathing apparatus (SCBA) tend to scare children because, honestly, to many children we sound like Darth Vader from Star Wars. They tend to crawl under beds, behind sofas, into small closets, and so on. Talking with your children about how important it is to evacuate when the alarm goes off is therefore very important. If they want to learn what a firefighter looks and sounds like with an SCBA, contact your local fire department and arrange a demonstration.

East Boise County has more fire trucks now than Chicago did 150 years ago, and possibly about the same number of firefighters. We are all here to keep you and your kids as safe as possible. Almost all kids everywhere love to see fire trucks and firefighters at times other than an emergency, so arranging a fire station visit might be beneficial.

### Public Announcement

A logging operation is taking place along Granite Creek Road from Placerville, and will continue on through Alder Creek Road in the coming weeks. The purpose of this operation is to clear trees hindering the future path for Idaho Power to run another line to improve reliability to Placerville, Idaho City, and other areas throughout east Boise County. This new line would create power redundancy. The logging operation will likely continue through the middle of December 2021.

Boise County's Road Superintendent Curtis Dill said that motorists should expect long delays, lasting up to one hour, to allow trees to be taken down and cleared from the roadway. Flaggers will be controlling traffic and operations will take place from Monday through Friday. Signage will be placed in strategic areas and motorists are advised to consider alternate routes of travel during this time.

In addition, motorists should expect to see increased logging traffic along Harris Creek Road. Renfro Logging in Horseshoe Bend anticipates that there will be four to five truck loads a day.

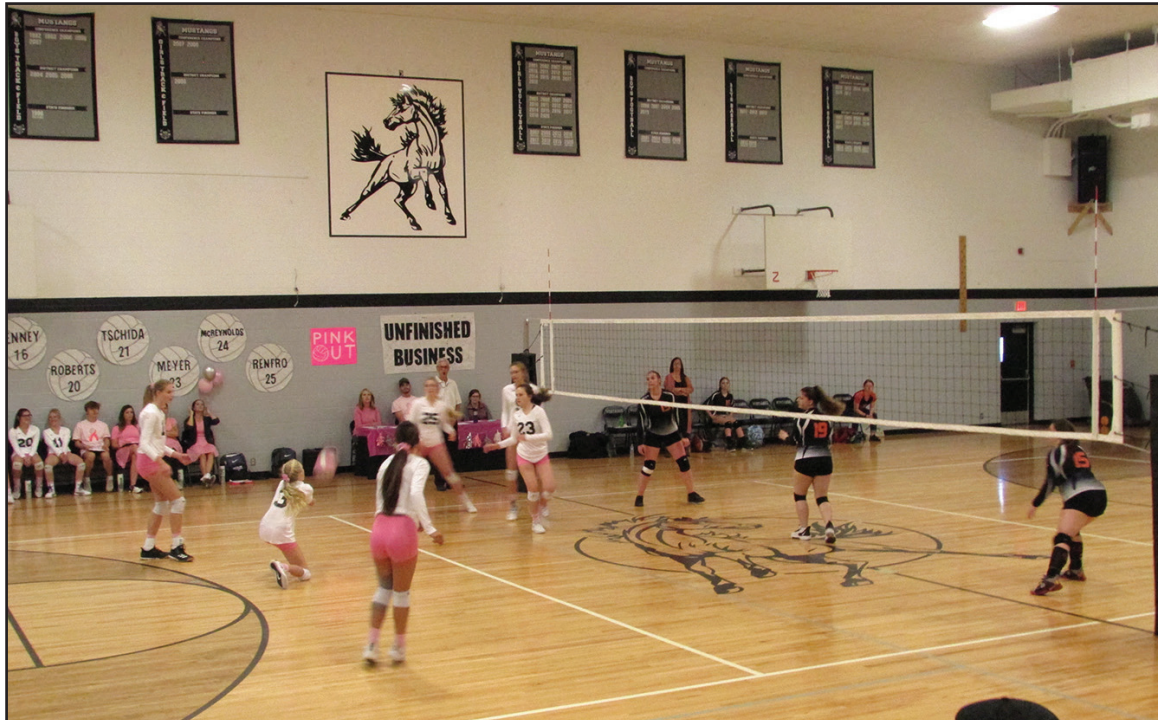
when the ball is not in play), sophomore Torey Tschida, had 1 ace, 22 digs, and 1 assist.
