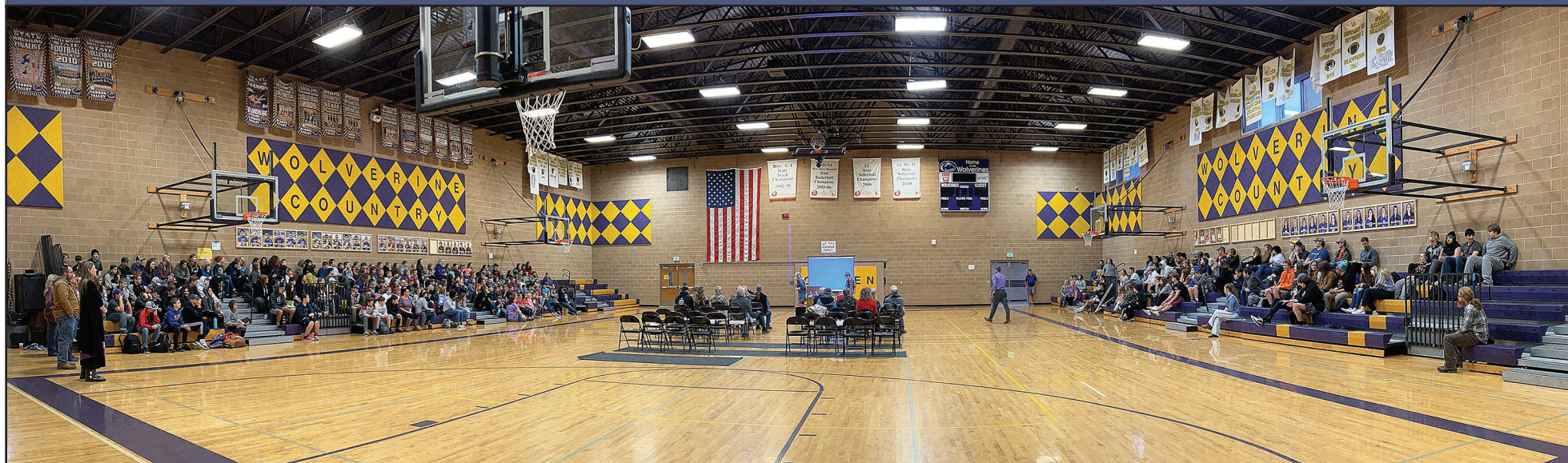

# Garden Valley Celebrates Veteran's Day

**GARDEN VALLEY** -- Veteran's Day was another cold, wet day, but it was tenderly warmed by the hearts of local veterans, the veterans' families, and the community. It was an emotional day of celebration filled with love, honor, and respect. The memories shared touched us all in such a special way that it brightened the gloomy day.

The veterans began the day at 7:30 a.m. by setting up for the events at the Crouch Community Hall. The local Christian-led **Young Life** group of high school students had already set up the tables and chairs for us. What a relief that was! THANK YOU to these incred-

ible young people and their leaders. By 8:30 p.m. the Community Hall was filled with the aroma of fresh brewed coffee, coffee cake, and sweet treats lovingly prepared by or under the watchful eye of our own veteran culinary expert, USAF retired Master Sergeant Lois Davison. Lois directed the kitchen tasks and made sure everyone followed the Health Department's strict guidelines for safe food preparation, handling, and serving.

At 10:00 a.m. the Veterans were standing ready for the Veterans Day flag ceremony held next to the Veterans' memorial bricks at Weilmunster Park. Because of the inclement snow and rainy weather, the ceremo-

ny was conducted under cover facing the flag. **USN retired Master Chief Petty Officer Bob Seal** called for everyone's attention and lead the Pledge of Allegiance to the flag. Then all the veterans introduced themselves and told a little about their service. Bob Seal called on **USAF retired MSGt Charles Snurkowski** to provide the Veterans Day message. Snurkowski began his message with: "We have gathered here today to celebrate Veteran's Day and to recognize all of those among us who have been a part of the great brotherhood and sisterhood we call the U.S. Military, which includes our veterans, active-duty service members, guardsmen and re-

servists. Veterans, it is your service and sacrifice that has kept our Nation safe and free."

He continued speaking about the difference between Veteran's Day and Memorial Day, underscoring that this day is a celebration rather than a time of mourning.

He ended the message by stating: "As Thomas Paine, one of our Founding Fathers, said: 'Those who expect to reap the blessings of freedom must undergo the fatigue of supporting it.' Many of you here today have borne that burden and experienced the fatigue of waging war to bring about peace. Know that your sacrifices and accomplishments are appreciated and celebrated. No matter what branch you served, what job you performed, where you were based, or how long you served; raising your hand and committing yourself to service in the U.S. Military was a brave and selfless act. Thank you for your service."

Traditionally, Veterans Day is observed on the **11<sup>th</sup> hour**, of the **11<sup>th</sup> day**, of the **11<sup>th</sup> month**. After the flag ceremony, the Veterans re-gathered at the Crouch Community Hall for the Veteran's Brunch. At the 11<sup>th</sup> hour Charles Snurkowski called the veterans to attention and requested: "Let's stand in silence for two minutes while we reflect on our own service and the service of our brothers and sisters who served before us, with us, and who will serve after us." After this quiet reflective time, the brunch officially began. The delicious meal included S.O.S. (chipped beef and gravy over toast -a traditional Navy dish),

spiced beef, bacon, perfectly scrambled eggs, coffee cake, a variety of breakfast pastries, peaches, coffee, and apple cider.

## Hunting Accident & Recovery

EAST BOISE COUNTY

-- On November 1st, we responded to a hunter that had cut his femoral artery while hunting. His brother was able to fasten a tourniquet with what they had on hand and went to get help. They were hunting elk in Elmore County near Arrowrock Reservoir. The brother hiked back out, boated back across to their truck on Arrowrock Road, and was able to use the 911 phone at Macks Creek Campground.

Due to the remote nature of this rescue, Elmore County asked Boise County for Mutual Aid. We also had an Am-

bulance from Acute Rescue in Boise, Idaho Mountain Search and Rescue, two Life Flight Helicopters, Boise and Elmore County Sherriff's Deputies as well as a hoist capable helicopter from the Idaho National Guard.

The first Life Flight helicopter landed near the patient and hiked down to stabilize him. The second landed in a flat area about a half mile from the patient. Since weather was moving in, Wilderness Ranch personnel continued hiking to the patient in case the helicopter operations needed to be aborted. The National Guard helicopter was able to drop one of their crew in to package the

patient. They then hoisted the patient up and took him to the second life flight helicopter to transfer him to the hospital.

This was a successful rescue due to the number of resources available to respond and the quick actions taken by the hunters. Please remember, if you are hurt in the back country it can take several hours or even longer to get resources to you. It is best to carry medical supplies, food, water, and things to keep warm for those situations. Think about carrying an emergency notification device as well. This can save hours in response time.



## ACCIDENT FATALITY



On Monday, November 8, 2021, at approximately 7:20 a.m., the Idaho State Police investigated a two-vehicle fatality crash on State Highway 52 at Thornock Road, west of Emmett. A 50-year-old male from Payette was traveling eastbound on State Highway 52 in a 1997 Chevrolet Tahoe. The Tahoe crossed over the center line into the westbound lanes and struck a 1993 Ford F150, driven by a 60-year-old

male from Garden Valley.

A passenger in the Tahoe and the driver of the F150 succumbed to their injuries at the scene of the crash. The driver of the Tahoe was taken by air ambulance to a local hospital. The driver of the Tahoe was wearing a seatbelt. The passenger of the Tahoe and the driver of the F150 were not wearing seatbelts. Next of kin has been notified. The roadway was blocked for approximately 5 hours. The crash is under investigation by the Idaho State Police.

**Editor's note:** The man from Garden Valley was later identified as Nate Stanley.

The injured hunter was stabilized on a platform and brought out of the remote area in Elmore County by helicopter.

## BOISE COUNTY COMMISSIONERS

Transcribed by Eileen Capson

**November 9, 2021**

**Present:** Commissioners Ryan Stirm, Ted Holmes, and Steve Twilegar

**Pledge of Allegiance**

**EXECUTIVE SESSION:**

Closed session for pending litigation and risk management. [Time 9:02 am to 9:31 am] Chairman Stirm said no action was required, after coming back into session.

**CONSTITUENT INPUT:**

Mr. Reed said he has lived in a residence off of Highway 21 for twenty years. He spoke regarding a contractor and his shop. He has filed a criminal case because the contractor walked away with \$15,000. Mr. Reed said he talked to several in the construction field and a woman at the Attorney General's office, "But there's *one person* who doesn't think that this is a crime, and that's Judge Cockerille. This case has now been *dropped*." He showed a photo to the commissioners of what Reed got for \$15,000. The contractor lives in Emmett and was not able to be served and probably moved, Reed said. "If you think about it, who benefits from Judge Cockerille's decision? Yeah, the criminal does," Reed said. Reed told the commissioners that he's organizing a campaign to "educate the public" and purchased a website to put his story out there.

Prosecutor Adam Strong said that his office did attempt to file a criminal complaint on this. He said the judge's position is for Idaho grand theft, "you have to prove that the intent to steal was there from the beginning." He said the problem was that without finding probable cause, they cannot do a warrant for premeditation.

Commissioner Stirm thanked Reed and wished him good luck.

**MINUTES:** A motion was said to approve the official meeting minutes from October 26, 2021. A motion was also said to approve the meeting minutes from October 27, 2021.

**SOLID WASTE:** Mr. Rekow had two certificates of appreciation for retiring employees. Chairman Stirm made a motion to approve the signing of the two certificates of the employees retiring on Nov. 9<sup>th</sup>.

**ELECTION APPROVAL:** Chairman Stirm made a motion to approve the canvas approval for the November 2<sup>nd</sup> election.

**IDAHO POWER PLANNED OUTAGE:** The area of impact covers from Lucky Peak Dam up to Star Ranch and Placerville. It will be impacted on November 22<sup>nd</sup> from 10am to 2pm. Commissioner Twilegar said it was going to be the entire Boise Basin, past Centerville by Star Ranch area, a four hour outage. County services may be impacted.

**TAX CANCELATIONS:** Treasurer Gina Turner said there were twenty-eight homeowner tax cancelations. There will be more coming, Assessor Chris Juszczak said, because there's no deadline

to apply. Treasurer Turner said they were all due to House Bill 389. Commissioner Stirm made a very long motion encompassing all the parcel numbers and their amounts.

**PLANNING & ZONING:** A partial plat amendment was discussed, conditions, and findings of fact were in order. A motion was made to approve the partial plat amendment.

**ROAD DEPARTMENT:** A motion was said for a payroll addition for a temporary seasonal snowplow operator. A sanding truck failed last week. Department Head Curtis Dill said that ITD (Idaho Transportation Department) finally got them a permit to pave Old Emmett Road, but it's too soft now and they will look at the project in the spring. He said they were looking to do an engineer study on Centerville Road for potential paving. Commissioner Twilegar would like them to look at paving Placerville to Idaho City. Commissioner Stirm commented, "It gets pretty dusty here on the holiday weekends, and hunting weekends right before the rain hits. And if it's dry, *sometimes you can't even see in this town*." Dill agreed and said that's why they were looking into paving it next year.

**BURNING:** The county will be cutting down and burning brush piles in the coming week. He said it was a couple of weeks early, but they don't like to burn the week of Thanksgiving.

**COVID-19 POLICY DISCUSSION:** The coronavirus policy discussion was touched on two weeks prior and Stirm said commissioners had agreed they were only going to review section four. Clerk Mary Prisco said one change was from a "disease" to a "virus." Commissioner Stirm asked the clerk if a person becomes sick from contact tracing from work, would workman's composition pick that up? Clerk Prisco answered no, because they may have been ill but they haven't been injured. Prosecutor Strong and Clerk Prisco reviewed some options. Prosecutor Strong recalled that they were federally mandated last year to provide this document, "as of right now, the federal mandate is no longer there. We have sick days for a reason. You have to use your sick leave if you're out sick." He said that the board could take it on a case-by-case basis. Commissioner Twilegar responded, foreseeing this could happen several times a week, "Do we want to put ourselves in position to where we're playing doctor?" Clerk Prisco stated: "The blanket policy is that if you come down with COVID as an employee of Boise County, you have to use your sick leave accruals and/or if you don't have sick leave, then you go to vacation accruals or comp time." She said if there wasn't sufficient accruals, then they would take the situation to the board.

Later on in the meeting, Com-

missioner Stirm made a motion to adopt Resolution 2022-02, a Boise County Resolution adopting the Boise County Coronavirus Policy. The motion carried unanimously.

**CONFLICT DEFENDER**

**CONTRACT:** A contract was discussed regarding a conflict public defender attorney. Prosecutor Strong says that he doesn't review these, because it's a conflict of interest and had an outside council prepare this document. Chairman Stirm motioned to approve the 2022 contract for a public defender between Boise County and Joshua B. Taylor.

**ENGINEERING SERVICES:**

Prosecutor Strong spoke regarding scoping work for engineering, paving preservation, not to exceed \$10,000. Mr. Dill said it's basically the engineering work that this individual has been doing for Boise County roads, but the engineer, Mr. Howard, is with a different company now. Mr. Strong said it would be identifying three roads for paving or preservation. Stirm made a motion to approve the contract, and another to approve a general professional services project not to exceed \$10,000.

**SNOWGROOMING:** The annual operating plans for grooming the snowmobile trails were reviewed with the prosecutor. Commissioner Stirm said for the record, "Number seven states, acquire permission from private landowners where trails cross private land and provide signage that is consistent with the rest of the trail system." Clerk Prisco stated that 8B is the Garden Valley side and 8A is the Idaho City side. They will work on this next year to update the agreement. Chairman Stirm motioned to approve the agreement for the FY2021 operating plan between the county and U.S. Forest Service - Boise National Forest for snowmobile trail grooming for units 8A and 8B.

**JUVENILE JUSTICE:** A grant was awarded in the amount of \$5,000. Commissioner Stirm motioned to accept the "Forever Idaho" grant in the amount of \$5,000.

**CLAIMS REPORT:** Chairman Stirm motioned to approve the claims report dated Nov. 5, 2021, in the amount of \$176,541.02. All were in favor.

**UNEMPLOYMENT:** Commissioner Stirm motioned to pay IAC [Idaho Association of Counties] unemployment in the amount of \$3,414.48 for unemployment wage fees.

**LAND USE:** The CEO from American Reserve Ammunitions in Horseshoe Bend was in attendance. A spokesman said, "We got notified last month that the landowner's insurance company would no longer tolerate us to be on their site. We went to a neighboring site, that's the same zoning, and their insurance told us the same thing. As an anchor of our business, we need to have a

couple of - a location for a couple of powder magazines." He printed off photos of the 8' x 8' x 10' steel structures that are wood-lined on the inside to make them bullet resistant. They are class two portable magazines that are often used at mining sites. He explained, "They are kind of overkill for what we need for just regular smokeless powder and for black powder. Those are the anchor, if you will, for our licensing." He suggested another location in a field, at the north end of town, that would allow them to be out of sight of the highway. It is greater than 300 feet from any residence, by the river, and a berm. The closest structures are the houses on Riverside Drive.

They are requesting a temporary Conditional Use Permit, until they can get their permit which will take time. Planning and Zoning Administrator Alex Gross said the application would take about three

months but suggested the temporary permit because the company would need to be out soon from the current location. Commissioner Stirm motioned to approve the temporary land use for three months to store his container on their property per the agreement, as long as it follows all the guidelines.

**EXECUTIVE SESSION:** Closed session for exempt records. Chairman Stirm motioned to approve the emerging case.

**BOISE COUNTY REDISTRICTING DISCUSSION:** Prosecutor Strong said they would probably need another week, because the "census data is not user friendly." They are referencing maps and data to make their decision. They may go through a company to do this work to move lines, draw proposed maps, as to where the population is going.

## IDAHO CITY COUNCIL MEETING

**IDAHO CITY** -- The regular Idaho City Council meeting was held on Wednesday, October 27, 2021.

Those present were Mayor Phillip Canody, Council Members Tom Secor, Ken Everhart, and David Martin. HD Hilliard was absent.

After the Pledge of Allegiance and the approval of minutes, Council Member Tom Secor made a motion to pay the bills dated October 14, 2021 through October 27, 2021, in the amount of \$174,894.28. This was seconded by Council Member Ken Everhart, and all members agreed. Then Council Member Tom Secor made a motion to allow the mayor to sign pay request #10 and #11 for WIIN Grant S658-00. This was seconded by Council Member David Martin, and all agreed.

The first action item was a water leak at 113 E Hill Road. Trudy Jackson asked for a bill forgiveness. After a discussion regarding future leaks and billing procedures, the council members discussed the possibility of having a minimum amount before asking for forgiveness. They also discussed the policy of the Clerk's Office on the smaller leaks, and the possibility of showing proof of leaks and fixing the leaks. There was concern that homeowners might turn the meters on and off and this should only be done by the public works department. This has become an ongoing issue and needs to be addressed. City Attorney

Joan Callahan suggested the council set some standards from here forward. At the present time, the precedence has been that the City of Idaho City will forgive 50 percent of water leaks if it is requested. Council Member Tom Secor made a motion to reduce the current water usage billing for a water leak at 113 E Hill Road for Trudy Jackson in the amount of \$45.53, half of the billed amount during the leak, this was seconded by Council Member David Martin and all agreed.

A Communicable disease policy was introduced which came from ICRMP. The City Council members had questions regarding the authority and actions that can and cannot be taken during a breakout of any disease. The State of Idaho will always supersede the City in an emergency declaration. It really does not change the chain of command; supervisors will still make the determination unless otherwise notified. The policy should have a cleaner clarification on the chain of command. City Council Members would like to see some changes and update the personnel policy. City Clerk Nancy Ptak and Idaho City Attorney Joan Callahan will look it over.

A permanent camping restriction ordinance was introduced by Police Chief Otter. This ordinance will review some of the items that need to go before planning and zoning. He would like to get this going soon, due to weather

and the influx of people trying to come up to Idaho City and live during the winter months. Health and safety are the main concern. In the past, anything has been allowed, but now new owners of the RV parks are working to clean up and maintain standards. The City Council members were divided on how this should be handled, and it should be reviewed further. All the council members agreed that long-term rental living is what is needed; however, more public input needs to happen. Meetings have been posted, public hearings will have to happen before there can be changes to planning and zoning ordinances.

Ashley Elliott and City Attorney Joan Callahan both suggested investigating other cities, requirements, and seeking suggestions. City Council members requested that this be put on the next agenda.

Chief Otter gave his report and stated that he is working on getting solar batteries for the speed sign on Highway 21. The computers are successfully working, ITD grants are being worked on, and his new full-time officers will be starting in November 2021.

Public Works director Tami Claus updated the council members. The RO system still needs to be purged, sand samples taken, and more testing done. Cascade will come up next week and finish up, concrete will be poured, and sand will be delivered.

Meeting adjourned at 7:53.

cil team began the program by playing the theme songs for each of the military branches represented: Air Force, Army, Navy, and Marines. The Veterans were grouped by service branch outside the auditorium and filed in when their branch's song began. Once the veterans were in place, the most beautiful rendition of the National Anthem was sung by **Michelle Davis**.

Then, Sara spoke about Veteran's Day and the history of how it was originally celebrated as Armistice Day. She concluded with an emotional Veteran's Day video presentation, which put most of us right back in the midst of our military service years, bringing tears to our eyes.

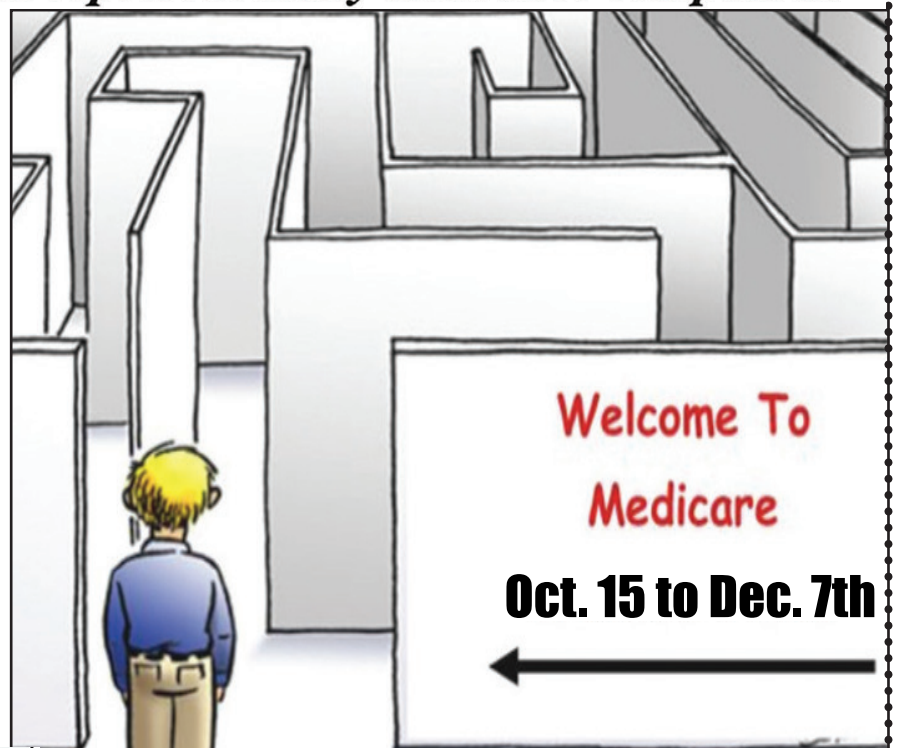

## Horseshoe Bend City Council Meeting

**HORSESHOE BEND** -- A special meeting called by the Horseshoe Bend City Council ended abruptly after audience members repeatedly interrupted the proceedings with complaints regarding the way the meeting was being run. The Wednesday, November 10th meeting was part workshop and part a replay of the city's October 12th meeting. The city acknowledged that they had failed to post the October meeting's agenda on the city website and as such they needed to redo the action items from the previous meeting. Councilmember Martye White made mention of the many observers who were recording the meeting using cell phones, "This was unintentional. I want everyone to know that." A motion was made to acknowledge the violation and it passed unanimously as did motions to clear the violation and void all actions taken in the October meeting. City attorney Tony Pantera instructed the council to redo the previous deliberations in the same order

as presented previously. The first action item was regarding the annexation of a 5.9 acre parcel from Boise County to benefit the proposed Deer Valley subdivision. Councilmember White made the motion for the annexation which was seconded by Councilmember Curtis Corvinus. During the vote White and Corvinus voted aye, councilmembers Ben Riley and Stephen Chartier voted nay, which set the stage for Mayor Pat Goff to break the tie with an aye vote in favor of the annexation.

The second action to be redone was a request to change the zoning of 25.77 acres in the proposed subdivision from industrial to R-3. The property was originally zoned R-3 prior to a 2017 change at the request of the previous owners who had planned to put a mill on the property. Corvinus made the motion after White expressed dismay over the lengthiness required to make a proper motion. Corvinus and Chartier voted nay, Riley and White voted aye, with Goff being called in to break the tie. His

vote of aye passed the motion.

After both motions passed, the workshop portion regarding the proposed Deer Valley subdivision began. The workshop was for the council to discuss and deliberate the Planned Unit Development (PUD) requested by the Deer Valley developers and the related developer agreement. (PUDs are typically communities of single-family homes and sometimes include condominiums or townhomes). Councilmember Riley asked about the development agreement. Pantera told the council that what they were doing now was really preliminary approval and that a development agreement would come next, before a final approval. He told the council that they needed to make sure that the PUD fits into the city's comprehensive plan. In his estimation, the biggest item in the PUD concerned the developer's request for variances on setbacks in the city code.

The councilmembers began looking through their binders with the proposed development plans. Goff told the council that

the requested variances put the rear setbacks to 15 feet as opposed to the city code of 20 feet and the side setbacks to 5 feet instead of 10 feet which is required by city code.

At this point, property owner David Bailey spoke up and told the council that the developer agreement is about "what I'm giving you and what you're giving me in return."

A woman in the audience shouted out that Bailey shouldn't be speaking and stated, then that if Bailey could speak the audience should be allowed to speak. Goff replied, "Appreciate your input, thank you." Someone in the audience asked that everyone in attendance be given access to the paperwork that the council had access to. The woman who complained about Bailey speaking continued to voice her concern. Riley told her that Bailey was answering a question. The woman told Riley that he didn't ask a question but Riley said that he just hadn't gotten to the question. When she continued, Riley said, "I'm done talking to you," to which she replied, "Thank you." Goff told the audience that the applicant was part of the workshop process. Councilmember Corvinus, who is also the Horseshoe Bend Fire Department Chief, said that he was concerned about the department's ability to serve the proposed development. Bailey countered that the council could place a condition that the fire department must have the appropriate equipment to service the development, adding that it was "absolutely reasonable" to say that they can't build buildings that the fire department can't service.

When Riley asked about supplying water for fire services Bailey said that he agreed it should be a condition of approval to have adequate water

flow and availability for fire prevention.

Chartier questioned the policing of the development by the Boise County Sheriff's Department and said maybe the city should get their own police department, "just throwing it out there." Goff agreed and said the price tag would be about \$120,000 for a city funded police department. Chartier said the new development was "just going to put a strain on our system."

Goff asked what the difference between having a new well put in versus a new holding tank would be. Woodruff replied that both were needed.

Resident Jim Flannery asked the councilmembers if they could speak up as the audience had several elderly people that could not hear so well.

Riley voiced a concern that the housing in the proposed development would be much tighter than it currently is in the rest of the city. He also reiterated a point from a previous meeting that it would be nice to have jobs being created by new industries at the same time as housing was developed. Goff asked Bailey if he intended to bring some light industry into the area, to which Bailey responded that he had no plans that were set at this time but there was a possibility in the future for light industrial or commercial development.

Chartier compared the new development to what he has seen spring up in Meridian and doesn't see it as "looking like Horseshoe Bend." White said, "I don't want to see the growth but I don't want to see us doing anything to stop it."

At this time, there was considerable grumbling from the audience members about the way the meeting was being conducted. As the complaints continued Goff adjourned the meeting.

A logging operation is taking place along Granite Creek Road from Placerville, and will continue on through Alder Creek Road in the coming weeks. The purpose of this operation is to clear trees hindering the future path for Idaho Power to run another line to improve reliability to Placerville, Idaho City, and other areas throughout east Boise County. The Garden Valley Post Office covers the Garden Valley,

Lowman, and Banks delivery areas.

Karen and her husband are planning to travel and spend more time with family. Karen's family has a long line of postal workers, including retired Postmasters living in the Boise area. ## Accident on Ridge Road

**BOISE COUNTY** -- Two women went for a drive in the remote area of Boise County on Thursday morning when they encountered problems on the snow covered Ridge Road, between Shafer Butte and Mores Creek Summit. Their Jeep ended up teetering on the edge of a very steep embankment. One passenger exited the vehicle with a dog to check on the situation, but in doing so the vehicle slipped down the side and went end over end to the bottom, an estimated 500 feet. Partway down, the other woman was ejected from the vehicle and badly injured. Two hunters on a side-by-side happened by about ten minutes later and noticed the tracks, turned off their vehicle, and heard someone calling for help. Centerville Volunteer Fire responded, and Horseshoe Bend and Wilderness Ranch

were paged out for mutual aid and extrication. When responders heard an "ah, ah, ah" sound coming from the vehicle, they supposed someone was trapped inside, but it became apparent that the sound was actually coming from the windshield wipers and they turned the car off. There was very thick fog and little visibility, so Life Flight landed on the perimeter near Harris Creek Summit, and the injured woman was trans-

ported with the help of Unit 14 ambulance EMTs of Idaho City. The rescue took four hours and monopolized emergency services from several departments on November 11th.

Centerville Fire Chief Bruce Baumhoff said he has been with emergency services for forty years. He has seen an increase in the number of motorists from the valley and questions if Boise County can do better.
