## Horseshoe Bend Varsity Boys' Basketball

### HORSESHOE BEND --

The Horseshoe Bend Varsity Boys Basketball team was at home on Friday, December 10 for a non-conference game against the Notus Pirates. Horseshoe Bend took an early lead that they never gave up, ahead 28-13 at the half and finishing strong with a final score of 56-33. Sophomore Porter Larson lead the way with 16 total points, followed by his older brother, senior Decker Larson who had 13 points. Sophomore Layth Bromgard was also in the double digits with 11 points. Junior Blayne Meyer put up 6 points, while sophomores Kaelun Jones and Nic Cooper each had 4 points. (The extra two points were

contributed by a Pirate that lost their way on the court and inadvertently put the ball in the Mustang's basket, scoring 2 points for Horseshoe Bend).

The Mustangs traveled to Mountain View High School in Meridian on Saturday, December 11 for a small school showcase game against the North Gem Cowboys. P. Larson was again on top with 17 points, followed by D. Larson with 14 and Bromgard with 4 total points. Unfortunately the team took the loss 35-45. The Mustangs find themselves at home on Thursday, December 16 where they will host the Tri-Valley Titans in a 1A DII Long Pin Conference game.

## Horseshoe Bend Deer Valley Subdivision Workshop

### HORSESHOE BEND --

The City of Horseshoe Bend held a public workshop concerning the proposed Deer Valley Subdivision application on Wednesday, December 8. After the Pledge of Allegiance and the approval of the night's agenda, Mayor Pat Goff told those in attendance that he wanted to hold the workshop in order for all the councilmembers to get answers to any questions they might have.

Councilmember Stephen Chartier wanted to know who would be in charge of any and all inspections that would take place during the construction of the subdivision.

The applicant, David Bailey, told the council that inspections are typically done by the engineer that originally signed the plans. He indicated that public works employees could also do inspections, if that was part of their job with the city, but a certified engineer must sign off on all final work.

Councilmember Ben Riley (who chose not to run for a position on the council which will be seated in January) asked if a letter had been received from the fire district with any objections. When told that the fire district had not responded, Riley suggested that the district fire chief come look at the plans for the subdivision and make sure that they had enough resources to fight any potential fires. Riley said he wanted assurances from someone that resources were available to take care of any fires that might start. He asked if there was a fire road along the rear of the subdivision. Horseshoe Bend Fire Chief and councilmember Curtis Corvinus said he didn't see one on the plans but that the fire district had bulldozers to cut lines if the need arose. Riley responded, "I think these questions need to be answered by the (fire) district. I'm not a fireman so I'm not qualified to make these decisions."

Bailey told the council that all requirements for access to the subdivision have been met. He added that the fire district typically reviews the plans after the preliminary approval

happens and that the fire chief can interpret the plans and setbacks to see if they are adequate at that time. Riley said, "Let's set us up to be successful." He added that he wanted to consult with the fire district before making any decision. Corvinus said that the city has a mutual aid agreement with surrounding cities for fire support.

Councilmember Martye White reminded the council that the Riverbend subdivision in Horseshoe Bend has a Planned Unit Development with the same setbacks that Deer Valley is requesting. Corvus agreed but said the Deer Valley subdivision is more "condensed."

City attorney Tony Pantera told the council that if they decided to open up to taking in more information from outside sources they would need to take input from anyone who wanted to offer it. Pantera suggested not reopening the public hearing.

Goff asked who would be in charge of doing the onsite inspections. City engineer Amy Woodruff told the council that the engineer of record would head it up, but her firm would act as the engineering firm for the subdivision and would work with the public works department. Corvinus said he only saw a potential problem with the two story structures in the development as Horseshoe Bend does not currently have a ladder truck.

Riley asked if there was a guarantee that the developer would not leave the city with an unfinished development. Woodruff said that the city would not accept any infrastructure that was not complete but added that development is a risky business.

Goff said that the city also needs to look into replacing the liner in the cedar water tank that sits above the proposed development. White replied, "My confusion is with the water tower. Are we replacing or fixing? Who's going to pay for it?" Goff told him that "at this point in time, we don't have any asks." White added, "I feel like we're dancing a waltz to a hip hop beat. What are we doing here tonight?" Goff replied,

"We're making sure all questions have been asked and answered." Pantera agreed and said once the preliminary plan is approved by the council, the city and the applicant can come to agreements as to what needs to be done.

Woodruff told the council that the city's water supply system has components that are at capacity or don't meet the Department of Environmental Quality requirements, and it has been that way for years. She went on to say that the developer is willing to talk with the city about funding improvements upfront with a reduction in fees the city would collect from the development. She advised that the city could save themselves from a bond election if they collaborated with the developer for needed water infrastructure.

Bailey agreed with Woodruff and said that the developer realizes that in order to be able to build homes within the city, they will need to finance water improvements in advance of paying fees.

It was suggested that the cost to fund the improvements and to add additional capacity to the water system would be between 100-400K.

Chartier seemed to be on board with approving the development as he acknowledged that things in the preliminary plan could be changed and that there was going to be some "give and take" between the

city and the developer. Goff concurred, adding, "That's the way I see it." Riley still questioned whether the city had the resources to serve another 300-400 people. "Is this what we really want the city to look like?" he asked. Chartier replied, "It's just too dense, this subdivision." White added, "I'd rather see this than a bunch of manufactured homes sitting over there." Pantera broke in, saying, "Some of this is deliberation." He told the council that

the purpose of the workshop was to get their questions answered and that they needed to save their deliberations for the next council meeting. With that, a motion was made by White to adjourn the meeting. The next meeting was originally scheduled for Wednesday, December 15 at 7:00 p.m. but has been cancelled due to the lack of a quorum. The council will meet next on Wednesday, January 12.

# BOISE COUNTY COMMISSIONERS

**December 14, 2021**

**Present:** Commissioners Steve Twilegar, "Ted" Holmes, and Ryan Stirm by phone

**Pledge of Allegiance**

**EXECUTIVE SESSION:** None

**CONSTITUENT INPUT:** [Not addressed]

**MINUTES:** The official meeting minutes from December 7<sup>th</sup> were approved by a motion.

**ROAD AND BRIDGE:** Mr. Curtis Dill said there was another pickup that came available, "so this will at least give me one reliable pickup per a shop." Dill said the truck had been budgeted for. Commissioner Holmes motioned to purchase a 2016 diesel Dodge Ram truck for \$30,500.

**SHERIFF:** Radio equipment that had been budgeted for was discussed for four Sheriff's vehicles. Acting Chairman Twilegar motioned to approve the radio equipment for four vehicles in the amount of \$57,851.25.

**TAX CANCELLATION:** Boondocks Timber, LLC, with 2,200 acres was discussed. Commissioner Twilegar motioned to cancel \$1,702 for this parcel of land.

Assessor Chris Juszcak said the next one was a roadway to a platted subdivision. Twilegar motioned to approve the tax cancellation for Mores Creek Crossing HOA in the amount of \$9.80.

**JOINT QUARTERLY REPORT:** Commissioner Twilegar motioned to approve the Treasurer/ Auditor's Joint Quarterly Report from July 7, 2021 to September 30, 2021.

**CORONER FUNERAL HOME ROTATION ISSUE:** Tabled for a later date.

**GRIMES CREEK ROADWAY:** It was said that the grants were not available this year to make the change to the intersection of Grimes Creek and Highway 21, and the project would be pushed out another year. Paul Rekow with solid waste suggested that they needed a new transfer station or collection station, "but we've got to do something down there. We will be revisiting the size and scope of our project, and if we're not going to use 48-foot trailers, we can use that intersection as it is. We can probably do some improvements on our own to that intersection for [improved] visibility." He said they wouldn't need to completely reconstruct northbound and southbound lanes.

**GRAVEL:** Commissioner Holmes spoke regarding the gravel that's taken off of some roads, "I have a problem with the Forestry selling our stuff... With us doing our work with our [Boise County road] guys, and our gas and our equipment, and then the Forestry [U.S. Forest Service] getting the money for it. I'd rather give it away free." Holmes continued, "So, I'm going to stop the Forestry from charging and I'll explain the reason why. It's coming from our roadways." Commissioner Twilegar said it was on our 41 acres. Rekow added, "The way they look at it is, whether it's a Christmas tree or dirt, it's a forest resource." Commissioner Holmes also addressed, "On boulders and big rocks that they sell for a lot of money down there, we might want to look at storing those and get money back into the county revenue for the future."

**SIGNS:** Mr. Dill and Mr. Rekow both said they had lost signs this past year that were taken.

**FULL-TIME GRANT WRITER:** Commissioner Holmes would like to look at hiring a full-time grant writer. There was a contract for one year with a grant writer and Commissioner Twilegar would like to see if that person would be willing to work month-to-month or six-months. He would also like to have a full-time individual. This topic will be tabled for a later date.

**SNOWMOBILING IN GARDEN VALLEY:** Commissioner Twilegar motioned to approve the ground lease between two individuals for the Scriver parking lot in Garden Valley, between Boise County

in the amount of \$800, from Dec. 15, 2021 through April 30, 2022.

Twilegar made a motion to approve the rental agreement, to be reimbursed by the Idaho Department of Parks and Recreation, through the XL Equipment Company for a frontend loader in the amount of \$4,000 per month.

**SHERIFF'S ANNUAL VESSEL FUND:** Clerk Mary Prisco presented a report for the Sheriff's annual vessel fund, according to the Idaho Department of Parks and Recreation. She said there was a carryover of \$82,962, which was for needed upgrades to the storage facility at the Sheriff's office. The funds are also to purchase a new truck to pull the boat. Acting Chairman Twilegar motioned to approve the request for retention of county vessel funds in the amount of \$82,962.

**CLAIMS REPORT:** Twilegar motioned to approve the claims report in the amount of \$239,892.03. The motion passed.

**AVIMOR SUBDIVISION:** The preliminary plat was approved the previous week, and the final draft of the findings of fact were brought to the commissioners by Planning and Zoning Administrator Mr. Alex Gross. Commissioner Twilegar motioned to approve the Boise County Avimor phase one preliminary plat application findings of fact, conditions of approval, and order.

**DEMAND WARRANTS:** Twilegar motioned to approve the confidential legal services in the amount of \$443.75 [in a death penalty case]. He then motioned to pay another payee

in the amount of \$2,637.50 for confidential legal services.

Commissioner Twilegar motioned to pay the Knife River invoice for the Old Crouch Highway paving project in the amount of \$176,476.90.

Another motion was said for the Sheriff's office for vehicle service in the amount of \$139.50.

A motion was said in the amount of \$184.83 for county internet services in Horseshoe Bend. The Community Justice power bill was approved and paid through a motion in the amount of \$296 for the month of November.

Planning and Zoning asked that there be a refund and Commissioner Twilegar motioned to refund an applicant in the amount of \$2,300. There was an overpayment and a refund

was motioned in the amount of \$55.64.

**INDIGENT:** None  
**EXECUTIVE SESSION:** Closed session for a personnel issue and risk management. Coming back into session, there was no action required.

**2020 BOISE COUNTY FINANCIAL STATEMENT:** A Bailey and Company representative presented to the Board of Boise County Commissioners their findings in their audit of the county. She directed them to the audit report and financial statements. She went over several reports with the commissioners, stating they had one "issue" which is stated as a "finding, it's a repeat finding" on page 55. She said it was an opinion and they tested two programs this year, the Pay-

ment in Lieu of Taxes program and Coronavirus Relief Funds. On the procurement policies, "it's not that you weren't doing certain things, but it's just that the policy was supposed to be there and it's not." She said the county is working on getting that policy together.

**NEXT COMMISSIONERS' MEETING:** The commissioners discussed skipping the week of Christmas. Clerk Prisco reminded the board that the county offices will be closed on Thursday and Friday in observance of Christmas on Saturday. There may be a need for a special meeting, but that was undetermined. The board will be adjourned until December 28, 2021.

**COUNTY PRINTERS:** Commissioner Twilegar motioned to approve the agreement for the county copiers, except for the county road department, in the amount of \$1,294.34.

**PUBLIC DEFENDER CONTRACT:** A limitation on the hours was eliminated and the contract was reconsidered by the board. Acting Chairman Twilegar made a motion to approve the Boise County Public

Defender contract, the conflict attorney, with the paragraph removed. This also passed.

**IDAHO DEPARTMENT OF RECREATION:** The clerk explained that the cost sharing agreement had been missing part of the contract for both the Idaho City and Garden Valley snow grooming agreements. Commissioner Twilegar motioned to approve the cost share agreement between the Idaho Department of Recreation and Boise County, State of Idaho, and the United States Forest Service.

**CITY OF CROUCH ORDINANCE NO. 2021-02  
APPROVED BY CITY COUNCIL August 25, 2021  
APPROVED BY VOTERS NOVEMBER 2, 2021**

AN ORDINANCE OF THE CITY OF CROUCH, BOISE COUNTY, IDAHO, FINDING THAT SAID CITY HAS A SIGNIFICANT ECONOMIC DEPENDENCE ON VISITORS AND TRAVELERS; THAT SAID CITY HAS A POPULATION NOT IN EXCESS OF TEN THOUSAND; PROVIDING FOR DEFINITIONS; PROVIDING FOR THE IMPOSITION OF CERTAIN NON-PROPERTY TAXES, TO-WIT: (1) A THREE PERCENT (3%) ROOM OCCUPANCY CHARGE ON RECEIPTS FROM ALL SHORT-TERM RENTAL (30 DAYS OR LESS) CHARGES FOR HOTEL-MOTEL ROOMS, CONDOMINIUM UNITS, TOURIST HOMES, VACATION RENTALS OR OTHER SLEEPING ACCOMMODATIONS; (2) A TWO PERCENT (2%) LIQUOR BY-THE-DRINK SALES TAX ON ALL SALES AT RETAIL OF LIQUOR BY-THE-DRINK INCLUDING LIQUOR, BEER, WINE, AND ALL OTHER ALCOHOLIC BEVERAGES, FOR CONSUMPTION ON THE PREMISES, OR AT ANY EVENT OR ACTIVITY IN THE CITY OF CROUCH; (3) A TWO PERCENT (2%) TAX ON ALL SALES OF PREPARED FOOD, MEALS AND DRINKS SUBJECT TO TAXATION UNDER THE IDAHO STATE SALES TAX ACT, IDAHO CODE 63- 3601, ET. SEQ. NOT INCLUDED IN THE PRECEDING TWO CATEGORIES; PROVIDING FOR A TEN (10) YEAR DURATION OF SAID NON-PROPERTY TAXES; ESTABLISHING THE PURPOSES FOR WHICH THE REVENUES DERIVED FROM SAID NON-PROPERTY TAXES SHALL BE USED; AUTHORIZING THE CITY CLERK TO ADMINISTER, REGULATE AND COLLECT SAID NON-PROPERTY TAXES; PROVIDING FOR PERMITS AND ISSUANCE; PROVIDING METHOD FOR PAYMENT OF TAXES, AUDITS, DEFICIENCY DETERMINATIONS, REDETERMINATIONS OF DEFICIENCY, APPEALS, INTEREST ON DEFICIENCIES, COLLECTIONS AND ENFORCEMENT, REFUNDS, LIMITATIONS AND INTEREST; PROVIDING FOR RESPONSIBILITY FOR PAYMENT OF TAXES; PROVIDING A PERIOD OF LIMITATION ON ASSESSMENT AND COLLECTION; ESTABLISHING SUCCESSORS' LIABILITY; PROVIDING FOR GENERAL ADMINISTRATION BY CITY CLERK; PROVIDING PENALTIES AND PENALTY CHARGES; PROVIDING EXEMPTIONS; PROVIDING CONFIDENTIALITY OF INFORMATION; PROVIDING FOR SEVERABILITY; PROVIDING REPEALER CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE OF THIS ORDINANCE

The principal provisions of this ordinance are as follows:

1. The effective date of this Ordinance is January 1, 2022.
2. The Ordinance has a ten (10) year term and shall expire December 31, 2032, unless otherwise amended, extended, or replaced.
3. Section 1: Finds that Crouch is a resort city as defined in Idaho code.
4. Section 2: Definitions
5. Section 3: Provides for a three percent (3%) room occupancy charge on receipts from all short-term rental (30 days or less) charges for hotel-motel rooms, condominium units, tourist homes, vacation rentals or other sleeping accommodations, and recreational vehicle (RV) parking spaces; A two percent (2%) liquor by-the-drink sale tax on all sales at retail of liquor by-the-drink including liquor, beer, wine, and all other alcoholic beverages, for consumption on the premises, or at any event or activity in the City of Crouch; and A two percent (2%) tax on all sales of prepared food, meals, and drinks subject to taxation under the Idaho State Sales Tax Act, Idaho Code 63-3601, et. seq. not included in the preceding two categories.
6. Section 5: provides the purposes for which the revenue from the tax shall be used.
7. Section 6: authorizes the City clerk to administer, regulate, and collect such taxes.
8. Section 7: **Permits required and issuance of permits:** Every person desiring to engage in or conduct business of renting hotel/motel room, condominium units, tourist homes, vacation rentals, or other sleeping accommodations, shall file with the City Clerk an application for a municipal non-property sales tax permit for each place of business, or if the business does not maintain a physical location within the City, for each business entity. Every application for said permit shall be made upon a form prescribed by the City Clerk and shall set forth the name under which the applicant transacts or intends to transact business, the location of the business or places of businesses and other such information as the City may require. The application shall be signed by the owner, if he is a natural person; or in the case of an association or partnership, by a member or partner; or in the case of a corporation, by an executive officer or other person authorized by the corporation to sign the application.
9. Section 8: **FILING AND REMITTANCE OF TAXES:** The taxes imposed by this Ordinance shall be computed and paid for each calendar month with taxes being due and payable to the City Clerk on or before the twentieth (20) day of the succeeding month. Persons who have been permitted by the Idaho State Sales Tax Commission to file quarterly sales or use tax returns shall notify the City Clerk in writing and the City Clerk thereupon may require quarterly reporting of municipal non-property sales tax returns. The amount of tax paid shall be computed on the total dollar value of all sales subject to taxation under this Ordinance. Each person required to hold a municipal non-property sales tax permit shall file a municipal non-property sales tax return on a form prescribed by the City Clerk for the same filing period required by the State of Idaho. The City Clerk may also require the submittal of the Idaho State Sales Tax return for the same period. In the event the City non-property sales tax amount and the amount shown on the state sales tax return for the same period differ, written explanation for any difference shall be submitted with the return filing and payment. Such explanation shall be reviewed by the City Clerk to determine whether it is or is not reasonable.
10. Section 8B: **When First and Subsequent tax payments are Due:** The first payment of taxes under this Ordinance shall be due and payable together on the 20th day of February, 2022, for that period beginning January 1, 2022 and ending January 31, 2022. Thereafter all payments shall be made monthly. The first quarterly payment of taxes under this Ordinance shall be due and payable together on the 20th day of April, 2022, for that period beginning January 1, 2022, and ending March 31, 2022.
11. Sections 9, 10, and 11: Provides for Audits, deficiency determinations, and appeal procedures.
12. Section 12: Provides for Collections and enforcement.
13. Sections 13-17: Provide for refunds, responsibility for payment of taxes, limitations on assessment and collection, liability of successor taxpayers, and general administration by City Clerk.
14. Section 18: **Penalties:** Any person who intentionally violates any provision of this Ordinance shall be guilty of a misdemeanor, punishable by up to one (1) year in the county jail, and/or Three Hundred Dollar (\$300.00) fine, or both. Furthermore, each month in which a person intentionally fails to report, or intentionally fails to accurately compute, or intentionally fails to accurately disclose the total amount of sales or rentals or the amount of tax to be paid, as imposed under this Ordinance, shall be considered a separate offense.
15. Section 19: **Penalty Charges:** Any person who is required to collect and pay over any tax imposed by this Ordinance and fails to pay over to the City the same when due shall be liable for and pay a penalty charge equal to five percent (5%) of the tax not paid, or a minimum of \$10.00, whichever is greater. The City Clerk shall assess and collect said fee at the time any delinquent tax payment is tendered. The taxpayer shall have ten (10) days from the date payment is made to file a written appeal with the City Council challenging said penalty determination. If no appeal is timely made as herein provided, said penalty determination shall be final.  
Any person who is found guilty of a misdemeanor in a court of competent jurisdiction for intentionally violating any provision of this Ordinance, in addition to other penalties provided by law, shall be liable to a penalty equal to the amount of the tax evaded, or not collected, or not accounted for or paid over. The City Clerk shall determine and assess such penalties, and the same shall become due and payable upon notice and demand from the City Clerk. The City Clerk shall send written notice of such penalty charge to the

## Idaho City Council Meetings

By Georgene Thomas

**IDAHO CITY** -- On November 10th, the council met and brought up an action item for short-term recreational vehicle use - Ordinance No. 366 and discussed it at length. Councilmember Martin disapproved, Secor refused to discuss it, and Hillyard had several questions but was going to vote in favor of the ordinance. Councilmember Everhart, elected Idaho City Mayor transitioning in mid-January, was also in favor of Ordinance No. 366. Mayor Canody was not in attendance, and with the votes tied, the ordinance was tabled.

On November 24th, the night before Thanksgiving, the bills were paid and nothing was discussed.

In the most recent Idaho City, City Council Meeting, held on December 8<sup>th</sup>, they discussed three policies: (1) Water Leak Forgiveness

Poly, but then they refused to discuss and tabled the policy.

(2) Mailboxes within the Idaho City limits - The council is following the policy of the City of McCall that was suggested by Clerk Nancy Ptak. They tabled this policy as well.

(3) Local Option Taxes that involves extra taxes for all hotels, vacation rentals, and any short-term rentals in the Idaho City limits. This policy was also tabled.

The short-term recreational vehicles use Ordinance No. 366 was debated for over an hour. Councilmember Secor was absent; however, he had previously refused to discuss the matter. Councilmember Martin wanted the ordinance passed immediately. Hillyard had many concerns and was against the ordinance, wanting the policy to be rewritten. Mayor Canody was in favor of Ordinance No. 366.

At one point, Police Chief Mark Otter gave a 30-minute dissertation about how this needed to happen "NOW" before crime erupted, and then the City wouldn't be able to control any of these problems. At the end of their discussion, Councilmember Hillyard wanted something done before he left his office, which would give him only one more meeting. The council plans to discuss the matter on December 22nd.

[Editor's Note: *The Idaho World* had requested a copy of the proposed short-term recreational vehicle use ordinance on November 21, 2021. Clerk Ptak stated that Ordinance No. 366 had not passed yet and was "going in front of the council again."

This reporter has also inquired and found that the city attorney is still rewriting the ordinance.]

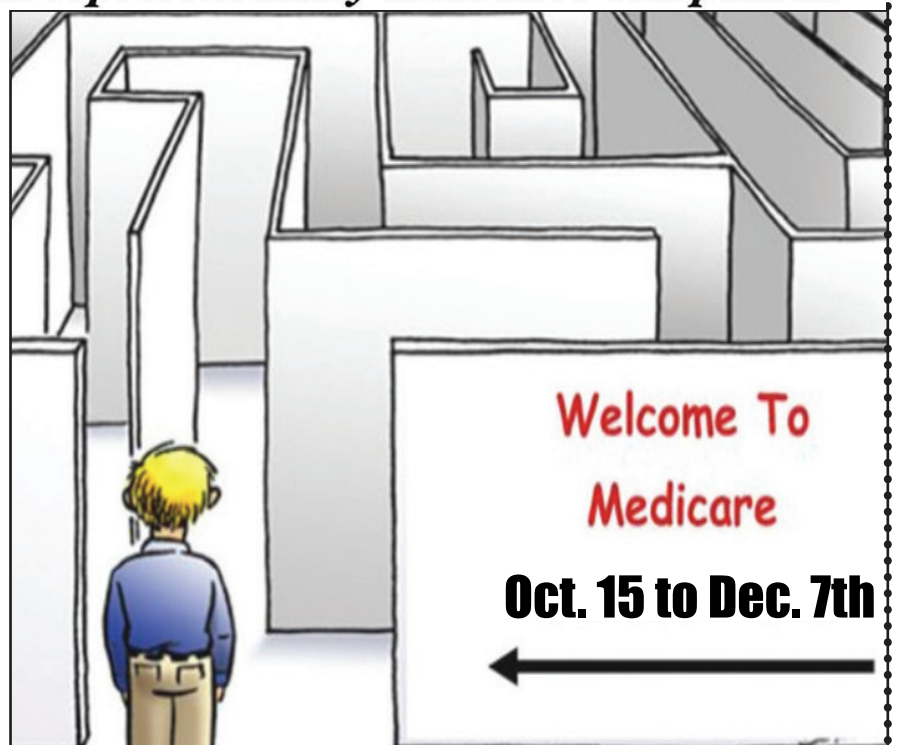
