January 25, 2022**Present:** Commissioners Ryan Stirm, Robert "Ted" Holmes, and Steve Twilegar**Pledge of Allegiance****EXECUTIVE SESSION:** Closed session for a personnel issue. [Time 9:05 am to 9:42 am] Chairman Stirm said there was no action required.**CONSTITUENT INPUT:** None**MINUTES:** The minutes for January 18 were approved through a motion.**ROAD DEPARTMENT:**

An assistant superintendent raise was discussed. Superintendent Curtis Dill of the Boise County Road Department explained that this person had already been doing this type of job for quite a few years. Clerk Mary Prisco stated that this position used to exist and Dill would like to bring it back, but it will need a budget change. Commissioner Stirm motioned to make this employee an assistant superintendent.

FEDERAL LANDS ACCESS GRANT: Clerk Prisco stated, "This grant is *substantial* and I believe it's going to take a lot of time to discuss." She recommended calling an individual to ask questions.**YMC INVOICE:** Clerk Prisco spoke regarding the repairs to the heater in her office, which cost over \$4000. She said she was "a little shocked at the price," but prepared a resolution for later in the day that would move money to the general fund to pay the invoice. Getting quotes from other companies was discussed going forward.**CHIEF DEPUTY CORONER:** Mike Johnson's yearly training was budgeted for and a motion was said to approve the out-of-state training.**MASS GATHERING:** Sheriff Scott Turner said they did get in contact with the Sheriff's Office and he in turn got them in contact with the mass gathering coordinator. Ada County Sheriff will do the traffic control for the Bogus Basin event.**REDISTRICTING:** Assessor Chris Juszczak presented a map and said, "We had spoken about changing the northeast corner by Daggett Creek/ Wilderness Ranch, have it squared off and previously Daggett Creek Road be the divider." This is an effort to better divide the county with regards to the population count. Stirm motioned to approve the re-

vised commissioner redistricting maps.

TREASURER: Treasurer Gina Turner said they have 17 parcels of land that are in question with their taxes and July 19th was a suggested day for delinquent tax deeds from 2018. Commissioner Stirm motioned to set the tax deed date for July 19th.**BOISE COUNTY POLICIES:** None**SHERIFF:** A lease agreement on the repeater, that comes up every 5 years, was discussed by Sheriff Turner. He said that he asked to renew for a yearly lease, "myself and FEMA, we're actively trying to do away with that repeater location to Packer John." The Sheriff said there are additional grant dollars that the department anticipates using sometime this year. A motion was said to approve the lease agreement for one year.**MOTION:** Chairman Stirm motioned to adopt a resolution to move funds for the general operations in the 2022 budget, which would cover the cost for the heater repair in the clerk's office.**BILLS:** A motion was said to approve the claims approval report in the amount of \$121,120.44.**MOTION:** Chairman Stirm motioned to certify the secure rural schools and community self-determination act of 2000 county's certification of Title III expenditures and unobligated funds.**WORKER'S COMP:** Commissioner Stirm motioned to pay state insurance fund in the amount of \$7,053 for worker's comp installment premium policy.**EXECUTIVE SESSION:** Closed session for pending litigation. [Time 10:08 am to 10:35 am] Commissioner Stirm said coming back into session that there was no action required.**COMMUNITY JUSTICE:** Nothing much to report.**ROAD DEPARTMENT:** Dill said the new graders from Brazil have arrived in Galveston, Texas are still sitting in customs. He said, "I'm bumping up the de-icing" for next year. Dill will be bringing to the board potential paving projects for 2022 and will discuss a budget.**WEED CALENDARS:** Paul Rekow discussed briefly the calendar for weeds.**TRANSFER STATIONS:**

The Horseshoe Bend transfer station was discussed, because the paving of Old Emmett Road will disrupt trash days. Rekow is working on alternate collection sites, days, hours, etc.

Rekow said they were probably going to pull back from a "full-blown transfer station" on Grimes Creek and look at something smaller.

ASSESSOR: Assessor Juszczak said he hired someone, but still has some openings.**SHERIFF:** Sheriff Turner said they filled one of their dispatcher spots, but they are still looking for another one. "Other than that, just trying to keep everybody healthy and struggling with people out sick, and being shorthanded here and there, but we're getting by." He, his chief, and another deputy attended a highway safety grant writing class. Sheriff Turner said they get a lot of grant money for this every year, which helps mostly with equipment. He concluded, "other than that, just staying busy."**PROSCUTOR:** Prosecutor Adam Strong said they finally hired a deputy prosecutor and he's looking to start transferring some of the court cases over to him.

Strong said he and the Sheriff were working on some

Bogus Basin issues with Ada County.

They had their first jury trial last week since the pandemic began. He said they have trials that are almost three years old, "That's not good for us; that's not good for anyone." Prosecutor Strong explained that the trials keep getting canceled, "At some point, you're going to start losing witnesses, you're going to start losing memories of things... I want to just get this moving, but unfortunately, it's not up to me." Commissioner Holmes said there were two magistrate judge appointments coming up in February and March.

He reported that the office is staying very busy, "The new investigators in the Sheriff's Office are sending us cases, lots of sex cases, unfortunately."

CLERK: Clerk Prisco said there were some issues with Computer Arts trying to send out 1099s and W-2s.

She spoke with the regional coordinator for the public defense fund about rolling forward with the compliance grant that they weren't able to use in the amount of \$10,000.

Elections are coming up on March 8th, which will include the Basin School District and the Garden Valley School District, which are running a renewal of their two-yearsupplemental levy. Clerk Prisco added, "At the same time, we've got a lot of deadlines for the primary. For the county office candidates. That filing period is February 28th through March 11th. That March 11th coincides with the last day to affiliate or change your affiliation prior to the May 17th Primary." The clerk's office is working on how to get information out to the public.**FUTURE AGENDA****ITEM:** Commissioner Stirm would like the clerk's office "to get us the print-out of all of the reserve budgets for all of the departments." Clerk Prisco said it's only by fund, not department, "the general fund probably has a dozen departments in it." She said that he would be looking at "unbudgeted fund balance." Stirm stated, "I'm not the finance guy, but I don't know what the number looks like for... I would think that you would want at least a year availability to operate your department for a year without - if there was a situation with no income for twelve months, right? No taxes for twelve months. But, I don't know how far you would want to go past a year, a fiscal year." Clerk Prisco responded, "We have a financial policy that tells us how we handle that and I actually

do that analysis every time we have an outside audit." Stirm referenced the Sheriff's office and how they were able to get more equipment and deputies, "but I think that there's probably an opportunity for all of the departments to benefit from that." Commissioner Twilegar mentioned, "I think rather than focusing and studying the money, why wouldn't we just roll that into the general fund and then taxes would be lower for a year." Stirm continued, "There's options on the table if we have a large surplus of cash, or not cash, but a large surplus there, we should look at a beneficial way to advantage that money rather than just let it sit there and not do anything for anybody." He would like to see

those numbers and talk about perhaps some kind of a break. "I just want to look at it and see what it looks like to get a better understanding of where we're at... at least we as a board and as a group have an understanding of where we are at with the county with those reserves." He planned to "make it work for the people."

Prisco recounted that in the previous meeting, the board would like to discuss property taxes. Commissioner Stirm added for Commissioner Holmes, who was absent, "Yeah, property taxes and what our role is in changing that. Can we lower the tax rate? Is there a levy rate? So, we want to have that discussion also." Prosecutor Strong explained that, "They kind of go hand-in-hand." Clerk Prisco added,

"The property tax cycle is exactly that, and then it is all tied in with the budget. So, I think it is important that the clerk be here, the treasurer be here, the assessor be here, and the prosecutor be here." There is a conference coming up that caused some concern that officials would not be present for the discussion. Commissioner Stirm said, "The reason why I'm asking is because I thought I had a grasp on how our property tax system worked and its been brought to my attention that I don't." He would like to publicly explore options for change as far as taxes and levies are concerned to promote transparency.

BRIDGE: A grant application with Boise County as the led agency was discussed to be submitted later that week.

Clerk Prisco said there was a zero percent match. Estimates for fixing the Boise Street Bridge in Horseshoe Bend area were discussed. Stirm said the engineers estimated a 35% increase from their previous estimate from a year ago to submit for the bid total. Clerk Prisco said there was a cost breakout that totals \$3.2 million, excluding the planning and research project. Stirm read that they added in a parking lot, skatepark, volleyball court, etc.

Commissioner Stirm recounted how he went to the City of Horseshoe Bend as a commissioner and asked if they would take the Boise Bridge. They refused, stating, "Why would we take a broken bridge? If you fix it, we'll take it." He added that they would like to sign it over to them, "Because, literally, the county line is right there at the bridge. It should be theirs anyways."

A grant writer was contacted and she confirmed that there was no match amount that the county had to put forth and that the bridge was condemned in 2016. The grant would pay for the removal of that bridge and

the replacement of that bridge. She went into detail regarding scenic byways, raptor bird studies, and riparian wetland possibilities with educational components and partners. Clerk Prisco asked if a public hearing would be required and there will not be one to move forward with this project, just a joint endorsement, but the grant writer will double-check.

The commissioners will review the grant during a special meeting later that week.

CITY COUNCIL MEETING IN IDAHO CITY

IDAHO CITY -- The regular City Council meeting for January 26, 2022, was held with Mayor Ken Everhart and Councilmembers David Martin and Ashley M. Elliott were present, with Tom Secor Jr. on audio.

The first items were approval of minutes from December 31, 2021 and January 12, 2022 and paying bills through January 26, 2022 in the amount of \$39,375.81.

Under the Engineer's Report, there were several action items which allowed the Mayor to give his signature on four different items: (1) allow Mayor Everhart to sign the 2021 Wastewater Reuse Annual Report. (2) allow Mayor Everhart to sign on a partial payment request #2 on Drinking Water 1104. (3) allow Mayor Everhart to sign on a change order #1 which is a new "well cap" in the amount of \$5,726.00. (4) allow Mayor Everhart to sign on contractor pay application #5, which is \$5,914.70.

Under Old Business, the first item on the agenda was a Personnel Policy update. City Clerk and Treasurer Nancy Ptak said that she was working

on updating the policy, from a very basic policy to new rules and regulations. Ptak said she will put a team together to review the old policy and write a new policy to present to the council for their approval.

Regarding the local option tax update, the City Attorney, Joan Callahan, sent a message that she has an intern who has made some progress researching information. This will be put together and presented the 2nd meeting in February for the council to review.

The update on the "water leak forgiveness policy", City Clerk Nancy Ptak stated that the office is frequently dealing with citizens regarding their water leaks and asking for bills to be modified. Most of these are a variety of the same issues. What she proposes is a policy that would be available to the office where they could refer to it and show individuals the rules regarding their water leaks and a written policy. She will get further input and have this policy ready for review from the Council soon.

The business of the "short-term recreational vehicle use ordinance" was discussed. City Attorney Joan Callahan defined the ordinance as

having two pages. She said, "What you have in your packet is one that is a P & Z welfare ordinance change. The second page has what the Chief presented that kicked off the issue and has a bunch of ideas for how to regulate mobile home parks and needs to go to P & Z. It's a part 2 ordinance for the council and a part for P & Z." Callahan continued, "The council has previously listed the short-term ordinance, and its had some debate and they met a stalemate at the end of last year and decided to continue it after the election of the new mayor and councilmembers. P & Z has not been able to take up their P & Z regulations yet." The council members and Mayor Everhart discussed that the short-term ordinance is over single unit properties in Idaho City limits. It does allow people who are building on their property to live in a RV while their house is under construction.

There was discussion from citizens who have an RV on their property, which is connected to sewer and water, could they continue to keep it because it already existed. City Attorney Joan Callahan stated: "Pre-existing uses pertain to zoning. This ordinance isn't a zoning change. It is to prevent people who have been living in their trailers permanently from continuing to do that. This is not outlawing that behavior,

just out-zoning it. This is the difference between pre-existing use and zone changes for pre-existing use that we have now criminalized the conduct for."

The update is: currently Idaho City Council is considering using existing rules and ordinances to implement their goals. In the future this new ordinance will be discussed.

Under New Business, the City Council authorized updating to a new Michrotech system for all City email accounts for \$3,530.50. This will be more secure and will allow the police to have more protected information for their department. The City Council allowed City Clerk and Treasurer Nancy Ptak to send an engagement letter to schedule an audit of 2021 with Bailey and Company, which might happen in May 2022.

The council discussed a membership enrollment with Life Flight Network for the Idaho City employees and families. City Clerk Nancy Ptak will look at the budget, review the figures, and present this to the council again.

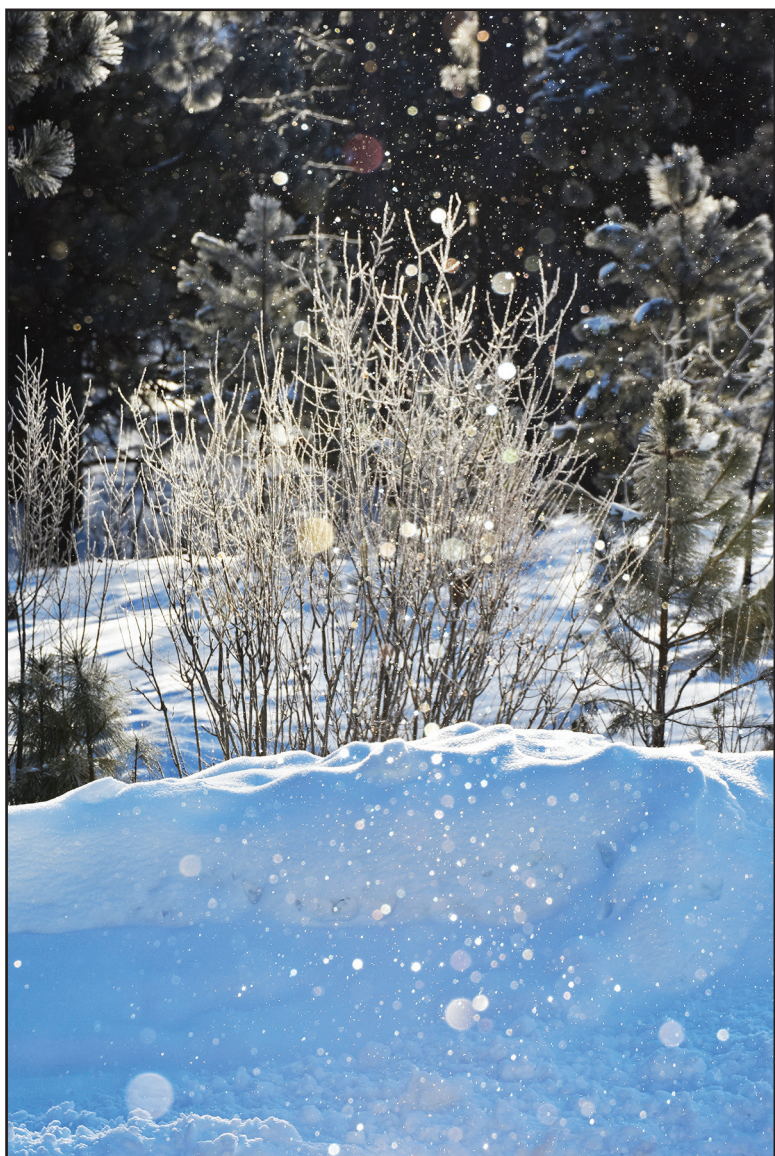
Idaho City Filming Inside City Limits Policy was presented by Clerk Nancy Ptak. She said there was nothing in place and felt that Idaho City needed some policy to protect the residents and the City. Councilmember Ashley M. Elliott asked if Clerk Ptak could

check with other cities to find a policy to review. City Attorney Joan Callahan suggested she contact the State Chamber of Commerce, specifically the filming division.

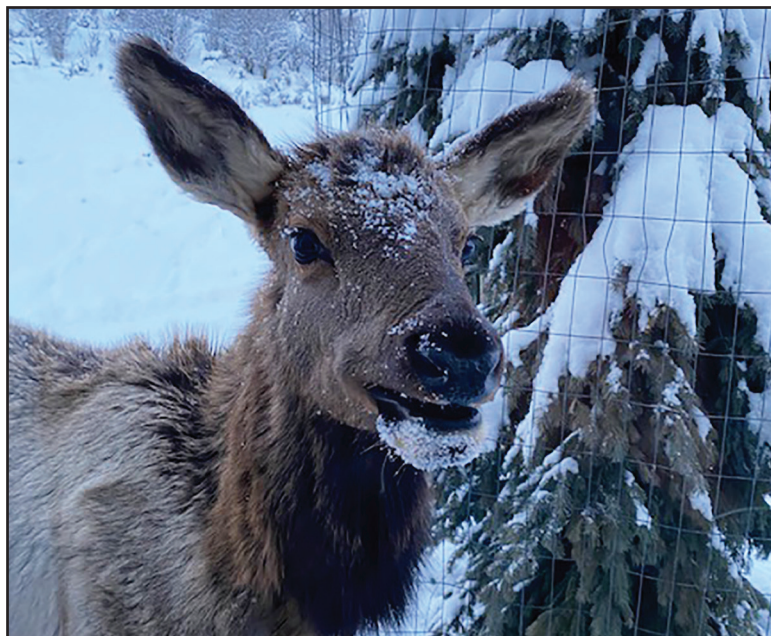
From Committee reports, Clerk Ptak asked City Attorney Joan Callahan to explain what was happening with Planning and Zoning. Callahan stated, "The Planning and Zoning Commission has been having trouble getting a Quorum together regularly. In 2021 they did not meet the required number of times for regular meetings' by-laws. The State of Idaho code requires at least 9 times a year. In January, they were unable to get a quorum for the regular meetings, so we rescheduled a special meeting and we almost didn't have a quorum until one of the members arrived 15 minutes late. So, we were able to actually hold a special meeting and set up a date where enough quorum members could be available to hold a Public Hearing that P & Z needs to hold for a couple of items that needs to come to City Council. There was also a question about their terms, and it looks like they will expire this year. And besides the substantive work which is coming before the P & Z there is a larger issue of getting any work done by trying to establish a quorum. I'm working with Nancy and the committee chairman and hopefully we will get Mr. Mayor in here about how we can get a potential solution to getting back to a regularly functioning P & Z."

Employment updates, the report from public works, Tami Claus stated that her department is having difficulty maneuvering the old sander around the streets of Idaho City. She suggested that they buy a hopper to sand the streets and she will do the research on the cost and present it to the council soon.

Meeting was adjourned at 7:14 p.m. by Mayor Everhart.

Zone 2 is roughly defined as the area east of Highway 55, north of Mill Road, and south of Riverside Drive (but including all homes on Riverside Drive). Zone 5 is roughly defined as the area east of Highway 55 until Pioneer Road, then east of Pioneer Road until Porter Creek. These are very general descriptions of the two zones. If you are unsure if you live in the correct zone you can contact the school and they can help you determine which zone you reside in based on your address. If you are interested, but do not live in zone 2 or zone 5, the school board can appoint someone from any zone after the April board meeting.
