CONTESTED CLAIMS MADE BY REP. MOON

IDAHO CITY -- During Representative Moon's meeting at the Senior Center in Idaho City on February 17th, I was disappointed to hear her quickly dismiss our concerns about her comment, "I worked with one of those cohorts down in Boise County and I did see the curriculum that was being brought in and it was very much CRT [Critical Race Theory]," in the House Education Committee meeting on January 31st. Representative Moon did not acknowledge that her statements on the record were damaging to our preschool program, students, and school community. She claimed that her comments were misconstrued and that she was being politically attacked by the media, however, I personally listened to the recording of the meeting and heard what Representative Moon said. I understand that the comments were made as part of a larger discussion on the Preschool Development Grant Birth to 5 (PDG B-5) that was discussed in the 2021 legislative session, but her comment implies that she met with us and personally viewed our curriculum. We are the only early childhood cohort in Boise County. It also implies that we were either us-

ing the curriculum or considering it. None of this is true, or accurately depicts what happened. First, there was no curriculum that was required as part of the grant. Second, she did not work with us nor did she visit the school to review our curriculum, even though she was invited on more than one occasion. She and I had a phone conversation about her concerns regarding a book that was referenced on the National AEYC site that was part of a guest speaker's literature book list. This book was never part of our curriculum, not part of any recommendation for grant recipients, or referenced or supported by the Idaho AEYC. During this phone conversation in the spring of 2021, Representative Moon said there were more CRT materials she was concerned about, but when I asked her to send me the links or copies of what she was concerned about, she did not do so. When this came up again recently, we filed a formal records request with Representative Moon asking for the evidence, and again we did not receive a response. It concerns me greatly that she is continuing to make comments about our school without having met with us, without having visited our preschool, without analyzing our grant proposal or strategic plan, and without review-



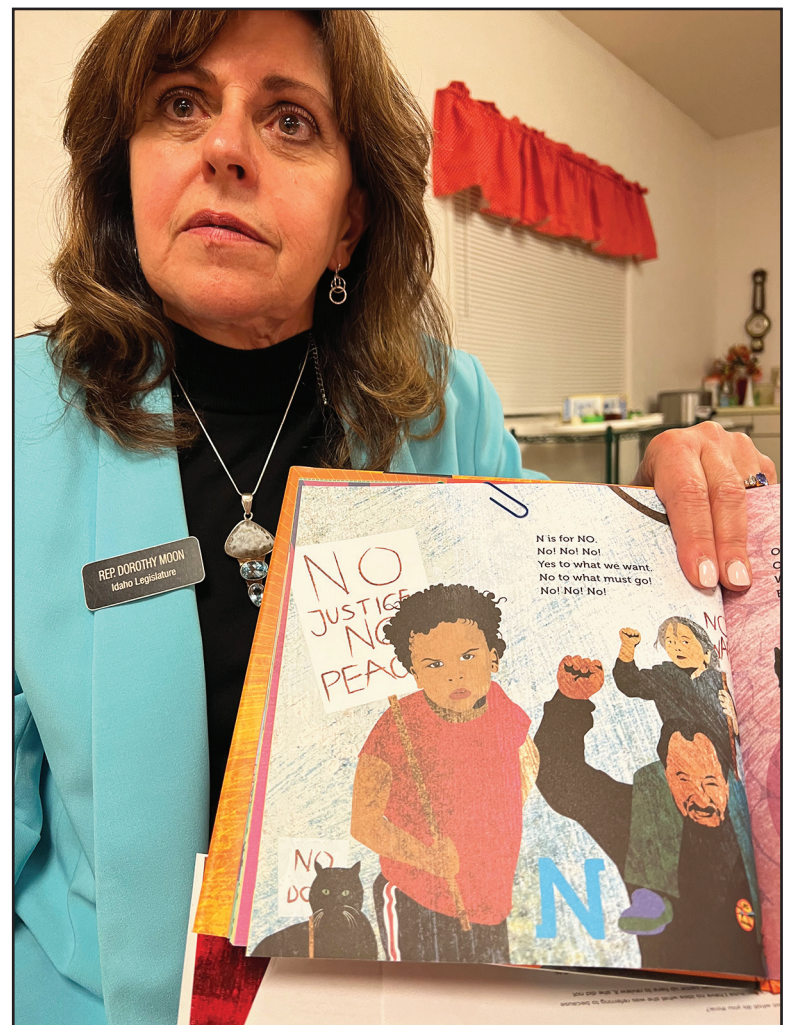

ing our curriculum.

If she is going to specifically reference our district and our program as our Representative, then she owes it to us to do her due diligence to make sure her remarks are clear, fair, and accurate. If her comments were not intended to specifically address concerns about our curriculum, then we should not have been referenced. If she later realized that the comments were interpreted differently than she intended, she could have issued a clarifying statement explaining that she had not reviewed the Basin curriculum, therefore she could not say that she had any specific concerns regarding it or not. Unfortunately at

this point, she has not chosen to publicly acknowledge our concerns or issue a clarifying statement.



Rep. Moon recounted after the meeting that the Idaho Association of Educating Young Children, back in Jan. 2021, were looking to bring in a \$6 million dollar grant to fund infant to pre-Kindergarten students. "This was endorsed by the Idaho State Board of Education and they just loved it!"

She said there were concerns that the federal grant program would bring in things like CRT "that our constituents don't want." Rep. Moon spoke of the Legislature, "We killed the grant. It was a tight vote, but we killed it." She added "I work with some of the cohorts down in Boise, because that's what they were referencing it as, and I did see the curriculum that was being brought in and it was very CRT. Because I was talking about the Idaho Association of Educating Young Children grant. That's what I was talking about. That's all I was talking about." In regards to Boise County, "I speak in generalities when I'm on the floor. I should have said, just one of my rural districts. Is what I should have said." Rep. Moon went on to say how much she likes Boise County.

February 15, 2022**Present:** Commissioners Steven Twilegar and Robert Holmes**BY PHONE:** Commissioner Ryan Stirm**Pledge of Allegiance****EXECUTIVE SESSION:** Clerk Mary Prisco said it regards a Planning and Zoning matter, under risk management and pending litigation. [Time 9:03 am to 9:18 am] Coming back into session, Commissioner Twilegar said there was no action required.**CONSTITUENT INPUT:** None**MINUTES:** Commissioner Twilegar motioned to approve the Boise County Board of Commissioners meeting minutes from February 8th.**DEPARTMENTAL ISSUES:** The Race to Robie Creek was discussed. There were a few details being worked out and the topic will be tabled. The prosecutor said the race has been canceled the last two years.**ASSESSOR:** Chris Juszczak spoke about losing employees and raising the starting pay.**PLANNING AND ZONING:** Alex Gross answered questions regarding inspections.**ROAD DEPARTMENT:** Curtis Dill said, "The weather's changing, so I've got guys hauling [road] material like crazy. We're trying to stage up, because mud season has already started. So, we're trying to get some material on these spots. We're trying some different styles of material to see if we can get some to bind up a little bit." He said the graders were still on hold, "Who knows where they're at. We're still waiting on them." Dill said so far the department was doing well, although there was a big slide on Banks Lowman Road that morning by Pine Flats that required the road to be closed for about four hours to get cleaned up. "Tis the season," Dill said.**SHERIFF:** Sheriff Scott Turner said they are staying busy and they are down in their number of dispatchers. He said maintenance issues needed to be considered for the next budget cycle, "Our sewer froze last week, we've had leaks in the roof," and added, "Idaho Power showed up the other day because all the water running off the back of the building froze all the

power boxes and froze the meter, and broke the meter off the wall." Sheriff Turner said the building was built in 1970, "It's definitely lacking in some tender loving care that I think we're going to have to address." Commissioner Twilegar suggested looked at some adjacent property, or tearing it down and starting over. He added, "That building's just trash." Commissioner Holmes suggested looking into grant money. Commissioner Stirm asked if the earthquake damage was repaired. Sheriff Turner replied, "They fixed it the best they could," and questioned whether it would hold up for another earthquake. He said it was like a "waterfall" in the conference room. He said several county employees got up on the roof and shoveled back the snow about 6 feet and they patched a couple holes, but then had a roofing company come up. Sheriff Turner explained, "Just in the little section that we shoveled, they patched like twenty-some holes."

PROSECUTOR: Adam Strong explained, "Just moving along." He added that in the last three or four months, "we lost three of our four employees. So, we're getting back to hiring..." He's thankful to have a deputy prosecutor.**CLERK:** Mary Prisco spoke regarding the March elections and supplemental levies for Garden Valley and Idaho City. Horseshoe Bend has a supplemental levy that turns in 2023. She said the candidate filing period for the county positions is coming up, Feb. 28 through March 11. The Primary is May 17th, "and lots of work to be done."**DEPARTMENT OF LANDS:** The shooting range for the Sheriff's deputies through the Dept. of Lands was discussed, a yearly lease. Commissioner Twilegar motioned to authorize the agreement.**POLLING PLACES:** Commissioner Twilegar motioned to approve the polling places.**SAWTOOTH 200:** An agreement to provide event law enforcement services and traffic control for Boise County for a bicycle race coming up from Boise to Ketchum. Their mass gathering permit had not been submitted yet. Commissioner Twilegar motioned

to approve this agreement to provide law enforcement services and traffic control for the event.

DEMAND WARRANTS: A bill for fax and phone in the amount of \$196 was approved through a motion for the Solid Waste Department. A motion was made to pay \$77 for phone services. A motion was made for internet services in Horseshoe Bend offices in the amount of \$206. Twilegar motioned to approve the bill for 911 services in Garden Valley in the amount of \$230. A motion was made for the Chief Deputy Coroner for

FBI training in the amount of \$475. He made another motion to approve the Coroner Department for film development in the amount of \$245. Commissioner Holmes noted that the persons that were deceased had birthdates on the document. Clerk Prisco said that would be redacted before it's scanned in.

A motion was said to pay Stewart Title for a litigation guarantee title search, in which there were several of them at \$225 a piece, for a total amount of \$1,125.

FUTURE AGENDAS: A commissioner with the AtlantaHighway District would like to come in and talk with the board. Clerk Prisco explained to the board that their regular meeting was March 1st, but they had a public hearing on the Robie Creek Cell Tower on March 3rd (Thursday) at 9:30 am. The following week is March 8th the election day, so there will be no commissioners' meeting. The next meeting is on March 10th (Thursday), a public hearing for Avimor, and a road and bridge bid.**Adjourned at 10:18, until February 22 at 9am.****Idaho Property Tax Reduction Program (Circuit Breaker)

HORSESHOE BEND SCHOOL BOARD MEETING

HORSESHOE BEND -- The Horseshoe Bend School District Board meeting was held on February 16. After the Pledge of Allegiance, the board member reports were given. Trustee Acacia Fisher brought up the meeting that's being held on March 5 regarding an Idaho Novus Classic Academy Charter School that is being proposed in the Avimor subdivision. She questioned if the board should attend the meeting. Trustee Steve Gorski said he planned on attending the meeting. Superintendent Dennis Chesnut said that it was up to the trustees whether they went or not. Chesnut said the proposed charter was a classical school and added, "This will appeal to some, I'd be surprised if there were a lot." (The school in question is modeled after the Hillsdale American Classical Education. According to a flier, the Novus Academy will be a curriculum school, not a member school).

Trustee Gorski reported that his position as an employee of the state in the Occupational and Professional Licensing department won't be a conflict of interest when deciding on contractors the district may engage with.

The district's bills and financial report were approved unanimously.

Trustee Raquel Pankau inquired about an increase of funds in an account. Chesnut said he would investigate and report back to the board.

The previous meeting's minutes were also approved.

No one came forward to speak during the public forum portion of the meeting.

The superintendent's report included the rezoning of trustee boundaries. The current trustee zones have been updated on the district's website. He is following a recently passed bill that will allow teachers to join the state's health insurance plan. He is trying to as-

sess if the plan would work for the district. He said that the new plan would cost the district more than they currently pay, but that the plan offers lower deductibles, better coverage, and more affordable family coverage. "There are some real plusses," Chesnut said. However, there is about a \$3,500 difference between what the district currently pays, and the money that the state is offering to offset this difference doesn't work for small schools. He said while the plan is better, more information is needed to make sure it is affordable for the district. Chesnut added that he would like to make it happen, but any change would need to be negotiated with the teacher's association. He also said that there was a one-year time limit to opt in.

Horseshoe Bend Maintenance Supervisor Jerry Kelleher reported on planned improvements to the skatepark, which is adjacent to the softball/baseball fields. A new grant, written by Kelsey Williams, came in and the plan is to add a gazebo, lighting, plant trees, and expand the gravel area.

He said the Horseshoe Bend Valley Chamber of Commerce would like to partner with the district. The chamber has applied for a grant, written by chamber lead

Kimberly Welsh, which could possibly help pay for bathrooms, a concession stand, and a water splash park (and in the future, a dog park could be added). Kelleher showed the trustees a plat drawing with all the anticipated features. He said the property in question was in the flood plain, so there would be no plans to build anything substantial on it.

Chesnut announced Boise State University may be providing an intern in social work to the district to partner with the community school and provide services to students and families at no cost to the district.

Trustee Gorski inquired about MAP (measures of academic progress) testing results. The tests are not compulsory. They provide detailed, actionable data for each student that the district uses to determine learning growth. Chesnut said secondary numbers were not in yet, but with regards to the elementary results, "It wasn't bad."

Trustee Pankau thanked Williams for the recent school skiing trip to Tamarack resort.

No suggestions were offered for changes to the current COVID-19 operating plan. The board appointed the district business office manager, Tonya Rogers, to the board

treasurer position. Bethany Hardy interviewed for the vacant trustee position in Zone 2. Trustee Pankau asked her why she wanted to be on the board. Hardy asked the board to introduce themselves before she answered any questions. After introductions were made, Hardy asked Trustee Fisher if she had been to her home for donuts at Halloween, then she replied to Pankau's question. "I just want to be involved in the community." She stated that she was a member of the HSB Valley Chamber of Commerce and "what better way to support the school" than being on the board. While Hardy has no children at the school, she said, "I'm passionate about education." Trustee Gorski asked Hardy about her thoughts on education. Hardy said that her family has a background in foster care and she sees a lot of families living with less means and she "knows how much support these kids need." She added that she has heard many good things about the school and "wants to support children that might not get a lot of support at home." Hardy stated that she has a Master's degree in English and she has "hopes to elevate students' minds."

Chesnut confirmed her address in Zone 2 and the board unanimously elected Hardy to fill the vacancy. The position will run through 2024. Hardy will be officially sworn in during the March meeting.

The board approved the spring sports assistant coaches and accepted the resignation of Librarian Tammie May at the end of the current school term. The board approved the purchase of a new school bus (the last bus was purchased four years ago) using 90k in the bus depreciation fund along with 17K from the general fund, which Chesnut said would be mostly offset by the first year's depreciation.

Lastly, the board approved first and second readings of policies.

Before the meeting concluded, Trustee Gorski told the board he knows of a local surveyor who would be interested in creating an internship for students that might be considering making a career in surveying. Chesnut asked him to pass the information along to him.

The meeting adjourned at 7:47 p.m. The HSB School Board meets on the third Wednesday of each month at 6:30 p.m.

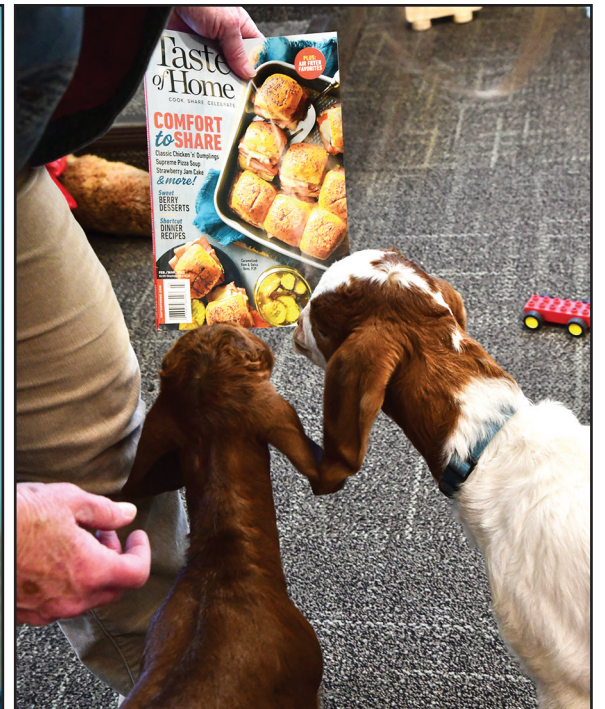
