### BASIN SCHOOL LEVY PROPOSAL INFORMATION

#### Basin School District Levy 2023-2024 Proposal Information

Basin School District 72 has started the budgeting process for the next two fiscal years. Currently, the Idaho State Department of Education provides approximately 80% of the district's budget and the remainder is made up with levy, federal revenue, grants, and donations and fundraisers. This year, inflation is around 4.7% which means that everything costs more than what the district budgeted for, just like local businesses have experienced. The inflation translates into around \$77,000 for this year, so the district added \$45,000 to the current levy of \$450,000 to make \$495,000. This amount is short of the predicted inflation.

#### Why can't the district run on what the state gives them?

For those new residents who have not lived in Idaho since 2007, the legislature re-

moved local county funding for schools and promised full funding from the state. At first this worked, but after a few years the revenue decreased and schools were funded to about 80%. Each district has their own unique needs, and there are state statutes that allow school districts to ask the taxpayers to make up shortfalls, so most districts turned to supplemental levies to do this. Across Idaho, about 89% of school districts have supplemental levies. The State does not provide 100% of the cost to run a district.

#### What does the supplemental levy pay for?

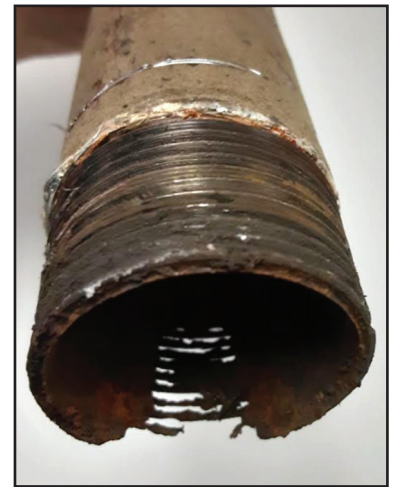
The district has three categories: Maintenance and Repairs, Athletics and Activities, Personnel and Programs, plus Contingency.

#### Maintenance & Repairs

The Basin Elementary School was built in 1962 and Idaho City Middle/High School in 1995. Many of the

original materials like plumbing (see fire sprinkler picture), electrical, roofing, and interior items are aging out. Maintenance and repairs concern a variety of needed repairs and replacements including: carpet replacement in the elementary school; the copper hot water line in the middle/high school which continues to leak with pinholes popping up on a regular basis; the HVAC in the middle/high school is mostly breaking down after 27 years; roof repairs are needed for the areas that the ice has sheared off; concrete repair is needed all over the district due to salt and freezing and thawing damage; the elementary restrooms

need to be retrofitted for a washing station and plumbing fixtures updated; the fire sprinkler pipes are rusting through, causing frequent leaks; the district holds many events for the community during the winter and needs a sand spreader to prevent people from slipping on the icy parking lot; the metal doors have rusted through along with the 27-year-old locks that are breaking down, the elementary gym does not have padding on the walls and the high school gym's minimal padding has many rips and tears; the elementary mobile unit halls need insulation in the ceiling; the rugs throughout the district are over 10 years old and need to be replaced; the

elementary walls need to be painted, and the football field requires replacement lighting.

**February 1, 2022****Present:** Commissioners Ryan Stirm, Steven Twilegar, and Ted Holmes**Pledge of Allegiance****EXECUTIVE SESSION:** Closed session for a personnel issue. [Time 9:04 am to 9:11 am] No action required.**CONSTITUENT INPUT:** None**MINUTES:** There were two sets of minutes. Chairman Stirm motioned to approve the Boise County Board of Commissioners meeting minutes from January 25<sup>th</sup> and the special meeting minutes from January 26<sup>th</sup>.**POLLING LOCATIONS:** Commissioner Stirm said that the polling locations looked "pretty standard" for the March 8<sup>th</sup> election. Clerk Mary Prisco said "it established all of the [voting] precincts within Boise County." Chairman Stirm made a motion to approve all of the Boise County polling locations for the March 8<sup>th</sup>, 2022 school district levy elections.**TREASURER/AUDITOR JOINT QUARTERLY RE-****PORT:** Clerk Prisco drew the attention of the commissioners to the last page of the report and stated that there was a difference between herself and the treasurer of \$5.17. Prisco added, "That will be taken care of when we finally close fiscal year 2021, because that has been popping up and we haven't been able to close." Chairman Stirm motioned to approve the Joint Quarterly Report for 2021.**SNOW GROOMER:** Stirm said that Idaho Parks and Rec. gave them new snowmobiles, "and so they want to surplus their old one." He said the old one was not used anymore and didn't have a problem with making it a surplus. Chairman Stirm motioned to approve an individual with the 8A snow grooming program to surplus the 1999 snowmobile and the summer tires and wheels for the 2006 dually truck.**TREASURER/ ASSESSOR:** Assessor Chris Juszczak said this should be the last tax cancelation, "unless we loss anything to fires." Stirm made a motion for tax cancelation

for two land parcels.

**PLANNING & ZONING:** Administrator Alex Gross spoke regarding setting up Zoom meetings from Idaho City, citing the pandemic as one reason. He said, "We are doing some research into a Zoom license for the entire county. You'd use it for your meetings." The Sheriff could use it for his trainings, etc. Gross said it would be a whole county Zoom license for \$150 a year, which could include one hundred participants in the meeting. He added that if there was something major going on, then they could pay an extra \$50 to bump up the amount to five hundred participants for a month. Some hardware will need to be purchased and they are pricing that now. Gross suggested using it for a few hearings coming up, for example the shooting range and cell tower public hearing.

Commissioner Stirm said, "If we're going to do it, we might as well do this room too. Because that way we can livestream our meetings every week. That way folks can watch them if they happen to be at home and want to see them." An inexpensive video conference camera was discussed. Commissioner Stirm motioned to approve the IT Director to purchase a Zoom license and equipment for the

Commissioners' room and for the P&amp;Z hearings not to exceed \$1000. However, the director suspected it would be under \$600.

**SOLID WASTE:** Several business were approved through a motion by the board for hauling and dumping.**BOISE COUNTY SEARCH AND RESCUE:** The memorandum of understanding with this new 501c3 was briefly discussed and the prosecutor will review this prior to approval. The topic was tabled.**RECORDS DESTRUCTION:** Chairman Stirm motioned to adopt the resolution, which allows for the destruction of certain records with the Boise County Sheriff's Office, via state statute.**SHERIFF'S E-TICKETING GRANT:** Stirm motioned to adopt the resolution increasing the Boise County Justice Fund Sheriff's Department 2022 budget.**ROAD DEPARTMENT:** A resolution was passed through a motion to increase the Boise County Road and Bridge Fund to cover the salary increase for the assistant lead position in Horseshoe Bend.**DEMAND WARRANTS:** Stirm made a motion to pay Dell \$42,000 for twenty computers and software with money from a grant.**CENTRAL DISTRICT HEALTH:** Commissioner Stirm serves on the CDH board and recounted the last meeting, "It was the shortest Central District Health meeting I've ever been to. And it was very, just semantic stuff." He said they didn't even pay the bills, "just approved meeting minutes and had a few discussions about a few things, and it was over about that fast." He said the meeting lasted about an hour.**EAST BOISE COUNTY AMBULANCE GOVERNING BOARD:** Director Melissa Potts spoke regarding the extensive billing process with the redundancy. She said that they are already paying a company to do the billing and they should be using their service. Stirm advised, "go forth and prosper."

Potts discussed an upcoming EMT class in April, every other weekend, Saturday and Sunday, through the end of June.

She said that Unit 13 from Placerville was brought over temporarily to Idaho City because they have received multiple calls at one time and they have people in Idaho City "that can grab an extra rig and go. It's just a temporary thing, but it makes sense for now."

Adjourned at 11:11 am.

**Special Meeting****January 26, 2022****Present:** Commissioners Steven Twilegar and Ryan Stirm (via phone conference)**Absent:** Commissioner Robert "Ted" Holmes**IDAHO FEDERAL LANDS ACCESS PROGRAM GRANT APPROVAL:**

Commissioner Twilegar said, "The main thing is the Boise Street one lane bridge over the Payette River. It's going to include two bike lanes." Plans also include a parking lot, rest area, a skate/ volleyball/ pickleball/ river enhancement park, and a paved greenbelt trail along the Payette River. The sum of what the county would be asking for with this grant is \$6,445,000. That would break down to \$4 million for the bridge, \$700,000 for the environmental inspections. Road engineering, surveying, and permitting would be \$800,000, with \$160,000 going to the skatepark. The Payette riparian wetland raptor habitat would receive \$87,000. Twilegar said, "From my understanding, [the project] has no matching [funds]."

Clerk Mary Prisco stated for the record that the board had the option to contact the City of Horseshoe Bend Mayor Goff and others. Commissioner Stirm recounted that the city had not had any issues with the proposal, that

they would also like to see the bridge repaired, and if in good condition would take over ownership of the bridge.

Commissioner Twilegar called Mayor Patrick Goff on the phone, set it to speaker, and informed him that they were discussing the Boise Street Bridge project and grant proposal. Twilegar said the county was set to proceed with the zero percent match and, "We'd like you to own that bridge in the end." Mayor Goff answered, "Absolutely." Twilegar let him know that this was a cost estimate because the engineering had not been completed yet.

Commissioner Twilegar made a motion to approve applying and submitting the application for the 2021 Idaho Federal Lands Access Program joint endorsement, "the Boise County Payette River project and the federal land agency is the BLM [Bureau of Land Management]."

**AVIMOR:** Prosecutor Adam Strong reminded the commissioners that there was a public hearing scheduled for the same week as the election on March 8<sup>th</sup> and suggested moving the hearing date. Commissioner Twilegar motioned to move the public hearing to March 10<sup>th</sup> at 11 AM. [Notice has been posted in the legal section of the Idaho World.]

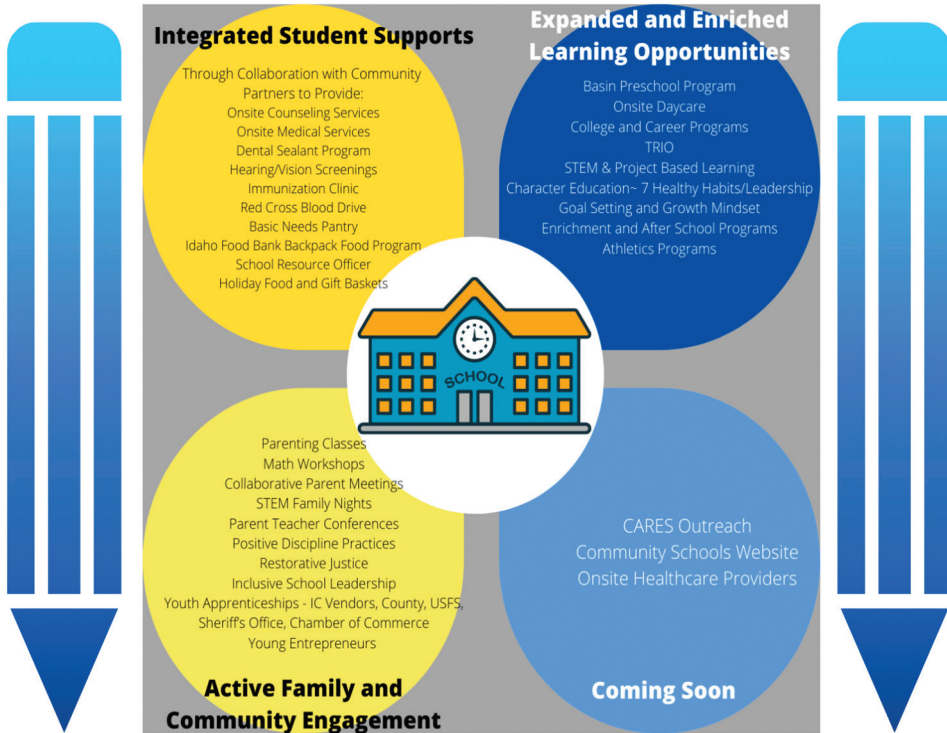

## Community School?

What is a Community School?



In a community school, the programming is structured around three primary areas: **Integrated Student Supports, Expanded and Enriched Learning Opportunities, and Active Family and Community Engagement.**

### What is a Community School?

A Community School is a partnership with local community resources to address barriers to physical, mental or emotional health that children may face. The collaboration of local assets of a community allows for efficient and effective utilization of resources to advance the well-being of children and their families. Basin School District became a community school in the fall of 2018.

Since its inception, the school has partnered with: The Mercantile, Gold Mine Gas Station, Boise County Community Justice, Boise Basin Boosters, Boise Basin Hunger Project, Boise Basin Library, PTA Wildcats and a number of other local organizations and businesses. Regional sponsors/partnerships include: United Way of Treasure Valley, Idaho Food Bank, Lion's Club, Central District Health, Idaho STEM Action Center, Office of Drug Policy, Idaho Out of School Network and the VFW.

### Integrated Student Supports

The integrated student supports are coordinated programs to address out-of-school barriers for students and families including mental and physical health services. Currently, Basin has partnered with two private counselors who provide counseling services onsite in order to reduce missed school hours. These providers are not district employees or paid by the district. Rather, the district provides a space for these service contractors and improves community access. The Clawset houses clothing items, winter gear, shoes/boots, hygiene products, food pantry items, school supplies, and some household items. We rely solely on the generous donations of the community to stock the Clawset. Boise Basin Hunger Project provides food items for the food pantry to support families who do not qualify for the Backpack Program, sponsored by the Idaho Foodbank. Through the partnership with The Mercantile, the Clawset has been reorganized, pared-down, and rearranged to better utilize the space more efficiently.

### Active Family and Community Engagement

Schools function as neighborhood hubs. Family and community members are partners in promoting student success. Schools provide workshop opportunities for parents as well as ensure that family and community members have a voice in decision making processes. Parenting workshops, math nights, STEM family nights, as well as Parent/Teacher Conferences provide an opportunity for parents, teachers, and children to participate in learning, collaborate with teachers, and actively engage the family unit in the school.

## Basin Schools' Superintendent Letter to Education Committee:

### Dear Members of the House Education Committee;

On January 31, 2022, Representative Dorothy Moon addressed the Idaho State Board President, Kurt Liebich, in a House Education Committee meeting with disinformation about the Basin School District's Preschool curriculum. Moon said, "I worked with one of those cohorts down in Boise County and I did see the curriculum that was being brought in and it was very much CRT." The last time Representative Moon came on the Basin SD campus was in 2019 to donate a step award to Basin Elementary School. When Representative Moon expressed concerns about the Preschool Development Grant B-5 (PDG B-5) funding last legislative session, our Basin Elementary principal spoke with Representative Moon directly. She explained that the Basin Early Learning Collaborative was part of the PDG B-5 project and that the collaborative was not using any CRT materials and resources. It was also explained that the program was able to select its own curriculum and resources based on the local community's needs. The Basin Elementary Principal

has invited Representative Moon to come to the school to view the preschool curriculum numerous times, but neither Representative Moon nor anyone else has requested to view the district's preschool curriculum. Representative Moon did not meet with a Basin education cohort. As a leader of this school district, I can confirm with great conviction that the Basin School District's preschool curriculum does not contain Critical Race Theory as alleged by Representative Moon. In addition, the district has not received any CRT concerns regarding their curriculum or negative feedback from the parents of preschoolers.

The Basin School District preschool program is the oldest continuous community-supported preschool program in the state of Idaho. All of the preschoolers who have started the program and finished as seniors in the district, except for one who got a GED, have graduated and their Go-On rate is higher than the state average. We are proud of the preschool program, and we believe our community strongly agrees.

There are three school districts in Boise County; Basin SD (Idaho City), Horseshoe Bend SD, and

Garden Valley SD. Superintendent Dennis Chesnut (Horseshoe Bend), and Superintendent Randy Thompson (Garden Valley) both have stated that they are also not teaching or using materials containing Critical Race Theory and they, too, have not had any contact with Representative Moon.

The Basin School District welcomes parents, community members, and State Representatives to view any of our curriculums before false statements are made to the public. These egregious claims further divide our attention away from our number one focus – the success of our students.

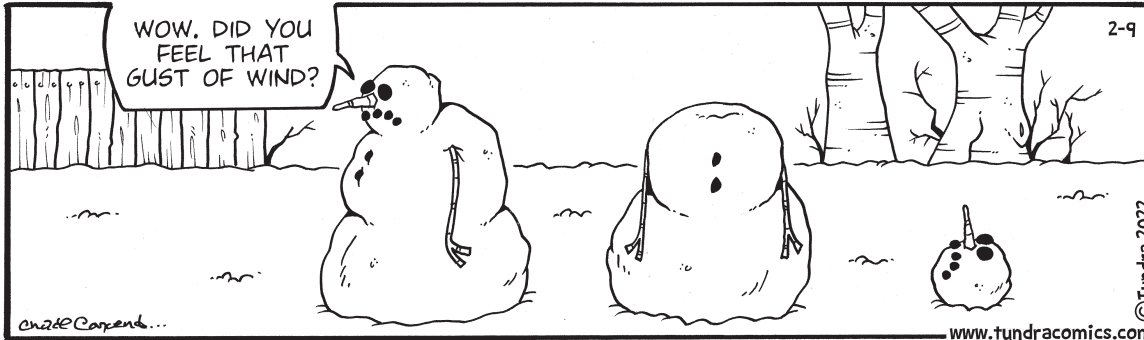

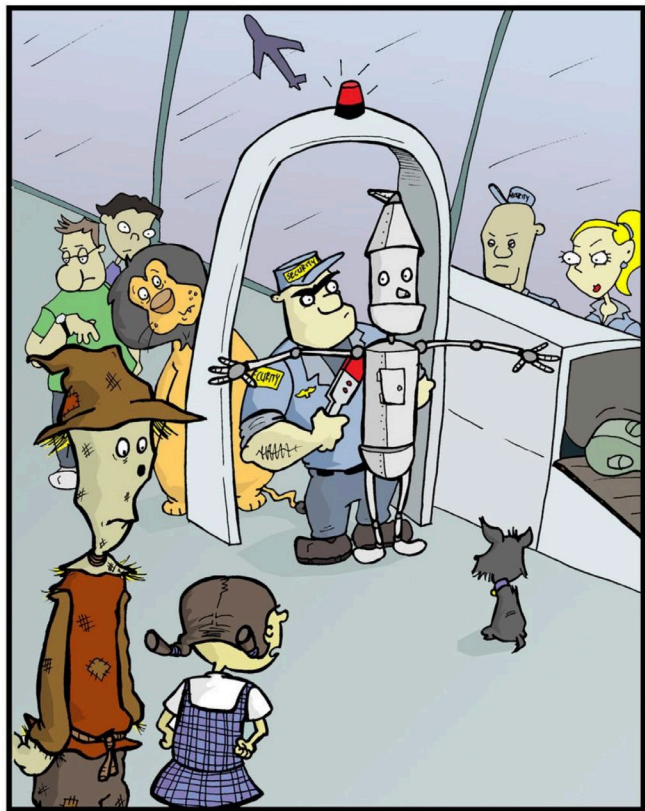

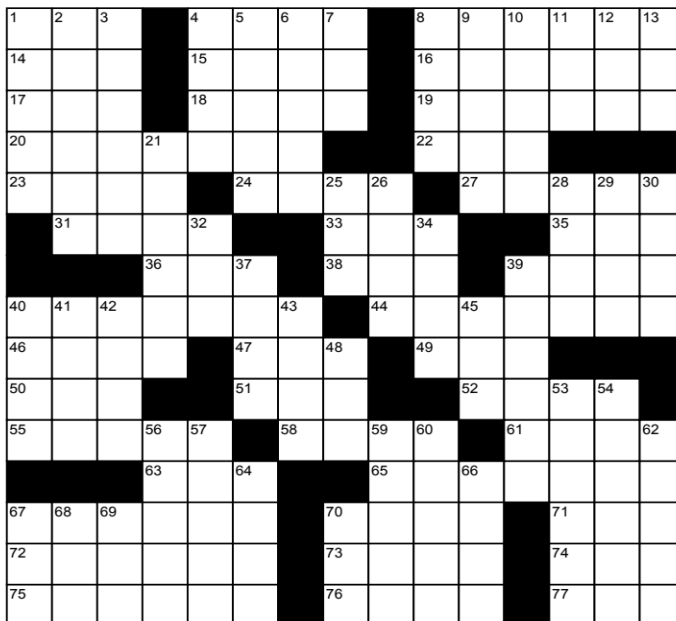

### Athletics & Activities

The Idaho State Department of Education does not fund athletics. Unless we move to a European system of after-school sports clubs, the district has to find creative ways to fund athletics. The majority of this fund is used to fund athletic and extracurricular transportation and the cost of running the athletic programs. The district has been applying for grants, fundraising, and soliciting donations to pay for programs such as the baseball and softball startup cost last year, and has collected around \$30,000 at no cost to the taxpayers. The district has applied every year for over five years to find a grant that would pay for new playground equipment. PTA has raised funds for small purchases and recently a senior installed recycled tires for her senior project. The district is asking for a two-year split funded play structure for the district and the community. The existing play structure was sanded and painted again this year but the plastic parts and wood have seen their better days. The last item concerns updates for the monitoring system.

### Personnel & Programs

The district has several key personnel that enhance our community and help the students with a variety of issues. The Student Resource Officer has been funded for many years now and has proven to be a valuable asset to the community and the district. Our community schools' program is proving to be very successful in keeping students in school. Our preschool program is the oldest continuous public preschool in the state and has proven to help students be successful. All but one of our preschoolers who stayed through their senior year have graduated, and the one

earned a GED. The Go On rate of our preschoolers is higher than the state average. The district is one of only a few districts who do not have a school nurse. The fact that a student may have to leave school for the better part of the day to see a nurse in the valley prevents our students from getting the most out of school. The nursing position will contain other duties and may offer a nursing class in the school.

### Contingency funds

There are many unexpected financial issues that can arise throughout the year. Discretionary funds give the district a little flexibility when there is an emergency that requires unplanned expenditures. This year, we have experienced freezing pipes, leaks, and added paraprofessional one-on-one special education personnel. The district is also advised to keep at least three months' worth of emergency funds in reserve. If we do not have an emergency, we would like to work on replacing the asbestos tiles in the elementary gym. Currently, we have to seal them with 12 coats of wax.

### Taxes

If you have moved from another state to Idaho, you may not know Idaho is 50th in funding per student and 29th in pK-12 education achievement according to US News. I invite you to visit the district to see the taxpayers are getting their money's worth. Our staff

not only educate the students during the regular school day, many of them teach, tutor, and coach before and after school. The students today are a long-term investment in Idaho's future.

Under the current levy and property values as of last month, the average homeowner would pay around \$80 per \$100,000 value. If property values go up, the cost per \$100,000 goes down.

### Elementary and Secondary School Emergency Relief Funds (ESSER)

You may have heard the district is receiving federal funds to offset the cost of the pandemic. What you may not know is the funds are to be used for COVID-19 related costs only. The district provides free breakfast and lunch through the federal programs, about a third of the HVAC systems have been updated, and purchases

made of disinfectants and other cleaning supplies, PPE, Chromebooks for students, and technology upgrades. Solutions have been implemented for spreading students out, and finding substitutes, and extra paraprofessionals and teachers. These funds cannot supplant any current budgeted items. All purchases with these federal funds have to be in addition to the budget and related to COVID-19 issues.

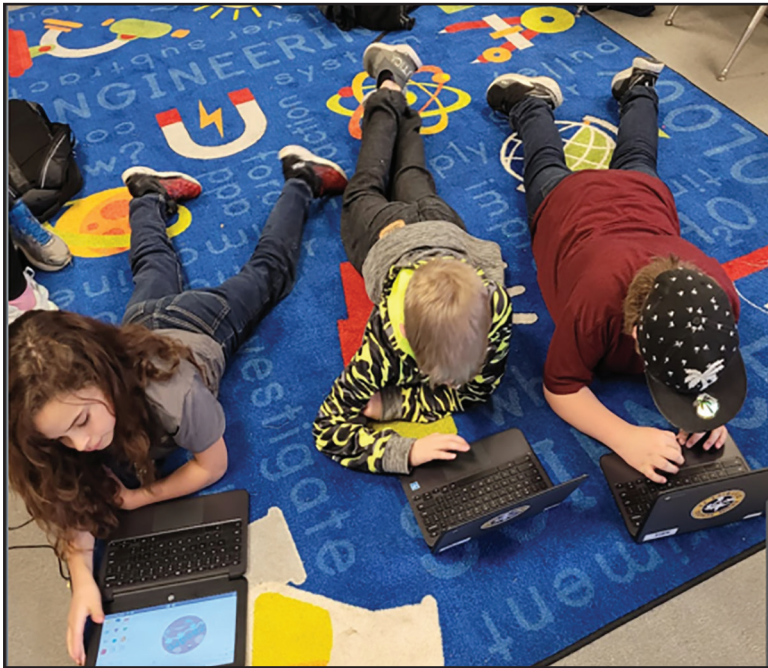
