### COMMISSIONERS APPROVE CELL TOWER

#### HORIZON CELL TOWER APPEAL - March 15th

**Present:** Commissioners Steven Twilegar, Ryan Stirm, and Robert “Ted” Holmes.

**Chairman Twilegar stated:** “Under the ULO [unified land ordinance] 4.3, the board must review the CUP [conditional use permit] to determine if the proposed use would cause any damage, hazard, nuisance, or other detriments to personal property or natural resources.” The Board of Boise County Commissioners looked at nine points to make a decision. Twilegar had concerns that the proposed tower would negatively impact the property values of the area. Commissioner Stirm agreed. Commissioner Holmes said he had visited the site and questioned if there was not a better location for the cell tower.

“Is it ‘harmonious and appropriate?’” Twilegar added, “Well, I guess not, but where’s it going to be harmonious and appropriate in this county?”

Chairman Twilegar addressed the final point: “The use does not result in the destruction of any significant natural, scenic, or historic feature.” He added, “I believe that the proposed tower would obviously inhibit the scenic features of the area.” Twilegar read from a written statement, “Folks move to Boise County because of the scenery, nature, and the rich history. It’s difficult for me to comprehend an argument that an 150-foot tower would not somehow damage the scenic and natural environment of this particular neighborhood. The tower is situated such that the

same view would obviously be negatively impacted. Because of these reasons, I believe the CUP does not meet the requirement for the ULO and we must move to our second stage, which is the federal requirements.” Commissioner Stirm agreed, recognizing the mountains and scenic views. Commissioner Holmes said he looked at other towers on National Forest and none were on private property, and sky-lined. He said sky-lined towers “increased distance and range, and less towers in-between when you sky-line. So, there’s a plus to that. I don’t know if they did their homework on that.” Commissioner Twilegar said the applicant had addressed that.

Chairman Twilegar continued with the federal requirements, “Would the denial of the CUP prohibit the provision of wireless services?” He then read, “Is there a significant gap in coverage? – I think you could say that most of the county has a significant gap in coverage. Secondly, is the proposed location the least intrusive location.” Commissioner Holmes answered, “No.” Then Twilegar continued, “Right, so, there’s a problem. I think there’s little question that there’s a significant gap in coverage, obviously, but the question is whether the location is lease intrusive is definitely up for discussion.” The board considered if the proposed cell tower location was the least intrusive location when considered to other feasible locations.” Twilegar pointed out that others had offered their

land for the cell tower and such private land had been considered, but without any actual evidence that it would be feasible or accessible.

Commissioner Stirm stated, “The fact of the evidence that we were given, there was no other site that was mentioned in the record and given proof to, where we were given a different option for a different site.” There were eleven sites

that were not deemed feasible. Commissioner Holmes was still not in favor.

Chairman Twilegar said, “I would love to see this tower located almost anywhere else... But I think the homeowners got out-lawyered, I really do.” He added that another location was something he couldn’t consider, because he wasn’t sure if a proposed leasable piece of land offered by a landowner in the area was feasible or accessible. “I hate to say it, because we represent the people, but I’m bound by the evidence that was presented and I would probably lean towards approving it, just because of that. I hate to say that.”

Commissioner Stirm agreed that he would like to see it go anywhere else “that wasn’t just directly in smack dab of the middle of homes... But I think that the way that the federal law reads, and the evidence that we’ve been given, that our hands are tied.”

Commissioner Holmes said,

“I disagree with both of you. If I was sitting in court on a trial, without a doubt, you’ve got to prove your case, and I don’t think they proved their case.”

Site specific conditions were considered and the exact location on the land lot of the Robie Creek Firehouse #2.

Chairman Twilegar motioned, “to approve this Horizon application for a cell phone tower at Robie Creek Volunteer Fire Station property, including the site specific conditions that the Planning and Zoning has indicated and move the tower to back on the site.” Commissioner Stirm seconded the motion. Commissioner Holmes stated, “For clarification, this is not voting for it yet. This is a vote to go back to and re-address the issue. We will be coming in for another vote.” The other two commissioners refuted that statement, saying that this was the vote. Holmes added his nay vote. The motion still passed.

**Present:** Commissioners Steven Twilegar, Ryan Stirm, and Robert "Ted" Holmes

**Pledge of Allegiance**

**EXECUTIVE SESSION:** None

**MINUTES:** Chairman Twilegar motioned to approve the minutes from March 1<sup>st</sup> and March 3<sup>rd</sup>. All were approved.

**DEPARTMENTAL ISSUES:**

Commissioner Twilegar asked regarding a grant writer position description and if the clerk had found a description. Twilegar will work on the job description and wanted to re-address it next week.

**PLANNING & ZONING:**

Alex Gross presented quotes for generators to provide alternative power for the county offices. Twilegar was surprised by the high cost and suggested they look into mobile or portable generators. Commissioner Stirm said the National Guard recycles their generators. Commission Holmes thought they might get a better deal at the Home Depot with an install fee than from any of the four businesses that quoted Gross. There was talk of using the Emergency Manager generator at the Sheriff's office.

**PARKS & RECREATION:** Chairman Twilegar

motioned to approve the yearly agreement between Boise County and Idaho Department of Parks and Recreation for 2022. The motion passed.

**RESOLUTION:** Clerk Prisco spoke regarding rate increases in pay for employee salaries for certification. Commissioner Stirm motioned to adopt Resolution 2022-13 to amend the Boise County reevaluation fund for the FY2022 budget. All were in favor.

**ATLANTA HIGHWAY DISTRICT:** Chairman Twilegar motioned to approve the contract between Boise County and the Atlanta Highway District. All were in favor. A member of the audience said he had driven on Arrowrock Road, "Thanks everybody, I drove that road this morning, and the Boise County side was really in good shape."

**TECHNOLOGY:** An individual said, "I want to give an update: I'm sure that everybody knows that we were attacked Monday night. It's still ongoing." He suggested software offered for small rural communities and schools. He will look into it. They are receiving hundreds of thousands of emails a day. "It's hard to know what's valid and what's not." He added, "So far, we're holding strong." Treasurer Gina Turner also talked about

a way they are keeping hackers out.

**BILLS:** Chairman Twilegar motioned to approve the bills in the amount of \$153,606. The motion carried.

**PLACERVILLE FIRE:** Chairman Twilegar motioned to approve a letter to the Dept. of Justice from the Commissioners in regards to the Placerville Fire Protection District, minus the non-profit organizing verbiage. Clerk Prisco clarified they were not set up as a nonprofit but are a part of a taxing district. The motion carried.

**DEMAND WARRANT:** A motion was said to pay an internet charge of \$206. This was approved. Twilegar motioned to pay another internet charge for 911 services to Garden Valley in the amount of \$230. The motion carried. He then motioned to approve a demand warrant for Bank of America for \$77.

**ROAD BIDS:** Commissioner Twilegar opened the bids and said they would announce whoever bid. Sunrock bid to pave Old Emmett Road and Horseshoe Bend transfer station in the amount of \$240,840. Alder Creek Road and alternate #1 was \$236,500. Centerville Road and alternate #2 was \$231,997. Old Emmett Road and alternate #3 was \$213,200. The total base bid

was \$922,537.

The second bidder had a total bid of \$979,525, and Knife River Corp. had a total bid of \$1,145,200.

Commissioner Twilegar said they were going to have their engineer look things over, make sure everything was bid properly, and likely look at the bid the following week.

**AVIMOR:** A public hearing to vacate part of the Avimor community plan. Mr. Gross said there was appropriate posting on the property and in the *Idaho World*. There were no comments received back.

There were no public comments. Chairman Twilegar motioned to approve the vacation of several parcel lots of land from the Avimor community.

Adjourned at 11:06 am.

## HORSESHOE BEND CITY COUNCIL MEETING

**HORSESHOE BEND** -- The following is a synopsis of the Horseshoe Bend City Council meeting on March 9, 2022. There were seventeen people in attendance for the meeting, along with four joining in via the city's Zoom link. All council members were in attendance except for Marty White. The city attorney was not present. Mayor Goff made the call to order at 7:00 p.m. He then led the Pledge of Allegiance, and after unanimous approval of the agenda, minutes from the previous meeting and the authorization to pay the city's bills, Goff opened the dais for public comments, reminding the audience that they could only comment on items on the night's agenda.

Former mayoral candidate Dave Jakovac took the podium and told the council that the Veterans Memorial slated for the new Wood's Memorial Park had been approved for the current city park and the city needed to formally change the location before proceeding any further. He stated that illegal funds had been used to purchase the park and claimed that the city raised their water rates in 2021 to pay for it. He added that the planned park was on property "not even zoned for a park." He asked how the city was going to budget for the maintenance of the park. Jakovac stated that the city had been given property for a park in 2010 but that the city said they had no funds to maintain it. He urged the city to take care of priorities such as sidewalks, crosswalks, and EMS services.

Another mayoral candidate, Jon Dufresne, took the dais. He told the council that the city's budget didn't allow for any park development. He wanted to know where the money for the park will come from when the city doesn't even have emergency services. He agreed with Jakovac that the property purchased for the park was done with illegal funds and that the city had covered it up.

He then went on to speak about current litigation that the city has

against him and threatened that if the city didn't drop the lawsuit against him, he intends to sue the city for "misappropriated funds" in regards to the purchase of the new park property and ask for "immediate injunctive relief."

Resident Laressa Gilleard, who lives near the new park, suggested that while the Veteran's Memorial had been approved, the new city park is just a "proposal" and that there is currently no funding or access to the park site. She asked that the veterans not be put out into the weeds and dirt. She added that while she had no problem with a Veterans Memorial in the city, she objected to its location. She closed by stating that it would be a shame if legal issues shut down the construction of the memorial.

Mayor Goff interjected and told the audience that money had been raised for the memorial and the surrounding area, "It will be happening," he said. He said that park maintenance would be included in the next budget.

Gilleard said she wanted a public hearing to address concerns about the park. Goff said public input would be sought and that the park would be a work in progress just like the old city park was.

Resident Gay McGee spoke next. She said she was disturbed by what she had been hearing. She told Dufresne, "I'm offended by your waste of the city's and the taxpayer's money for your lawsuits."

Dr. Nicole Cundiff from the Horseshoe Bend Valley Chamber of Commerce told the council that the chamber was now 135 members strong and they have raised \$30,000 for the Veterans Memorial. She commented that the chamber had been instrumental in procuring a grant for much-needed sidewalks and that the chamber wants to continue to work with the city.

Gilleard returned to the podium to say that the city already has the Mill Pond and the Fish Ladder for community access to the river and that those weren't taken care of properly, adding about the

new park, "It will be an absolute mess." Goff replied, "All we can do is manage it as best we can."

Gilleard then commented on Dufresne being sued for having trailers on his property when others in the city are doing the same. "It's about what's right and what's wrong. It's all about who you know around here," she said. Goff responded sarcastically, "Exactly."

Grant writer Cheryl Pleak gave her report, starting with the large amount of study that has gone into the park and the potential for grants to pay for a large portion of it. She has submitted preliminary plans to the city regarding ideas for the park and is currently looking into corporate sponsors. When she mentioned that she had spoken to someone who may donate a Syringa tree to the park, someone in the audience shouted, "I don't want a tree by my house." Pleak went on to say that the tree would actually be a piece of art made from metal materials. Pleak also said that she had included in her plans a gazebo that could be used as a rental for weddings, parties, concerts, and would generate money to pay for park maintenance.

She said the \$250,000 2022 Pedestrian Safety Grant (that the HSB Valley Chamber was instrumental in securing for the city) would pay for a sidewalk on the west side of ID-55 from the bridge to the high school, possibly as far as the canal, and would also pay for a crosswalk with a light at the school's main entrance. Goff asked for a motion to approve the grant and the vote was unanimous in favor of.

EMS reported that six out of the ten people taking the EMS course had completed and passed and were now doing ride-alongs to practice and observe EMS work.

Public works reported that they would be having a UV disinfection and tune up training. The ozone generator was working well and everyone was really pleased with it. A leaky seal on a pump in the vault had been repaired.

Goff asked Pleak to look into a

grant for a tiny house for the paramedics to use when on call.

The city engineer reported that they are currently working with public works on the water treatment plant and the Deer Valley Subdivision plans.

Goff concluded the meeting by saying, "I just hope that everyone can come together. Horseshoe

Bend is a great place to live in." He added, "I think I know what needs to be done here. I think that's why I was voted in. Pray for Ukraine."

The meeting adjourned at 7:37 p.m. The HSB City Council meets on the 2nd Wednesday of each month at 7:00 p.m.

## CITY COUNCIL MEETS IN IDAHO CITY

**IDAHO CITY** -- The Regular City Council meeting was held on March 9, 2022. Mayor Everhart was absent. Councilmember Tom Secor Jr. conducted the meeting with Councilmembers David Martin, Ashley M. Elliott and Mari Adams in attendance.

The minutes from February 23, 2022 were approved, and bills from February 24, through March 9, 2022 were paid in the amount of \$45,500.14.

Under the Engineer report, there was an IDEQ reimbursement form, a January 2022 progress report, an invoice from Mountain Waterworks for \$5,620.75, a notice of acceptability of work, along with a consent of surety to final payment of \$10,786.30. Councilmember Tom Secor approved to allowing the mayor to sign on the partial pay request on DW 1104. These payments will eventually be reimbursed by a grant.

Under old business, Clerk Ptak presented eight action items which had been developed in a workshop which was held last week. (1) Personnel policy for employees of Idaho City. This involved the number of holidays, sick hours, vacation days, and compensation hours with new revisions. Attorney Joan Callahan interrupted and said this policy had to be adopted by resolution, and there was no resolution drafted. Councilmember Secor suggested that they wait until the next meeting to discuss and pass this item.

(2) Communicable disease

policy, and (3) Social media Policy also had to be adopted as resolutions, so the council decided to wait until the next meeting. Council asked Clerk Ptak to put these on the agenda for the next meeting.

(4) Water leak forgiveness policy or "water adjustment policy." It was suggested that links to the Idaho City water codes be posted on the website, so there will be an explanation available to the public. Attorney Joan Callahan stated that this policy gives the office direction on general policies and can be adopted. Councilmember Martin motioned to adopt the "Water leak forgiveness policy," this was seconded by Councilmember Secor and was passed by all the councilmembers.

(5) Idaho City filming inside city limits policy needs to be made into an ordinance first. Attorney Joan Callahan stated "If you want to adopt the standards to acquire this type of permit and the insurance standards, we can put together a companion ordinance and then get an application for both. So, you would have an ordinance to require the permitting and a resolution to set the fee." Clerk Ptak stated that this would require a public hearing first and the council will address this in a later meeting.

(6) Financial control policy will take more time to develop and will be an ordinance and can be discussed in the future.

(7) Customer Service Policy according to Clerk Ptak, could be adopted because it only involves direction and pro-

cedures in the office and for employees only. This was adopted by the councilmembers.

(8) The emergency operating plan they are still developing will be put on the agenda again.

Under new business the Council discussed "City business license fees." They are comparing Idaho City to other city's fees and requirements. There is generally both a renewed business license and a new business license fee. Attorney Joan Callahan stated that when determining the application fee, it takes time to put a new business into the system and process all the information, therefore it should be more than a regular license fee. The council took no action on this item and it will be discussed later.

Under Ordinances and Resolutions, the "Short term Recreational Vehicle use ordinance No. 367 was discussed. This was presented by Attorney Joan Callahan, she said this is the 3<sup>rd</sup> or 4<sup>th</sup> revision. "This policy will regulate how long and under what conditions people can live in a recreational vehicle. One of the biggest issues was brought up by Councilmember Elliott, it looks like we need to examine the existing codes section on trailers. This is current-

ly what has been in your code since 1959 and the horrible language is outdated on it. However, with Councilmember Elliott's suggestions we are now marking the current chapter for entitling it obsolete. So, I suggest we repeal that at this point, so we don't have two potentially conflicting ordinances that could cause some confusion. However, that is my suggestion and take in mind that it might repeal something you feel is useful. This other section allows you to live in a RV longer than 14 consecutive days in a mobile home or recreational vehicle park or if you are connected to an approved and independent connection, water and sewer services provided, that appropriate steps would be taken between the months of October and May to protect water and sewer safety. In the next section there are excep-

tions when you are building on your land. You can live in your RV for 180 days or as long as you have a current building permit."

The city council could not decide on all the details of this ordinance and discussion on ordinance No. 367 will be continued at future meetings.

Under employee updates, Public Works Director Tami Claus stated that there is an issue with water on Hill Road, but they are currently working on it and should solve it.

Clerk Nancy Ptak said they are updating their water and sewer reports. If there is no payment for 90 days, the recipient will be notified and has 7 days to reply and set up a payment plan, or the water and sewer can be shut off within 24 hours.

The meeting adjourned at 7:20 p.m.

Their season opener was a doubleheader against the 2A Marsing Huskies. Without enough teams in the 1A DII Long Pin Conference, the Mustangs play up in the 1A Western Idaho Conference. For reference, 1A DII schools have less than 84 students while 1A schools have between 85-159. 2A schools, such as Marsing, have 160-319 total students.

During game number 1, the Mustangs let their nerves get the better of them and took a mercy loss 18-6 after 3 innings.

After a short break between games, the Mustangs regrouped and with senior Kloe McReynolds on the mound, the girls traded the lead with Marsing throughout the game. Horseshoe Bend found themselves up by one run, 16-15 at the bottom of the 6th, but Marsing brought in two at the top of the 7th while the Mustangs could only score one to end the game in Marsing's favor, 18-17. Offensively for the Mustangs, sophomore Torey Tschida brought in four runs with one RBI off two doubles, a single, two base on balls. Se-

nior Eline deBoer also put four runs and one RBI in the book off of two doubles and two singles. Sophomore Abby Howerton scored three runs with two RBIs off three singles and a hit by pitch. Sophomore Kaylin Penney had two runs and three RBIs from two singles. McReynolds had two runs and one RBI off a triple and a walk. Junior Joise Stone had one run and two RBIs from a single.

The team will travel to Wendell on Tuesday, March 15, to play the 2A Trojans and will be at home against the 2A Cole Valley Christian Chargers on Friday, March 18. First pitch for both games is at 4:00 p.m. **Track:** Sophomore Kallyn Rogers was the sole Horseshoe Bend competitor at the Melba Icebreaker on Friday, March 11. 

## Basin Elementary is Recognized for being a STEM School

**IDAHO CITY** -- Basin Elementary Principal Jamie Pilkerton said it has been an eight to ten year process to get to where they are now, recognized as one of seven S.T.E.M. schools in the state of Idaho. She thanked partners and guests: Dr. Kaitlin Maguire – Idaho STEM Action Center, Dr. Sara Hagenah – Boise State University, Cathy Ammirati – Micron, and John McFarlane – Idaho STEM Action Center.

ReBekah Lulu recognized some of the “pioneer” students in the STEM program and asked the high school students to stand with a round of applause.

Dr. Hagenah said, “This school is joining a very small, but very elite group of schools. This is the seventh STEM Designated School in Idaho. And what’s incredibly impressive is, you guys pushed through during a pandemic to get your STEM School Designation.” She said there were several other schools in contention,

but Basin was the only school to push through. Dr. Hagenah added, “You should be incredibly proud of the work you’re doing.” She emphasized that as a STEM school, the students would have so many more opportunities available.

Cathy Ammirati explained the reason why the Micron corporation likes to fund this kind of opportunity is “because we need more STEM-abled people in the world. And that will make the world a better place, and will give you all better opportunities for yourself and your families.” As an example, she mentioned that semi-conductor work requires STEM skills, and that jobs in similar lines of work tend to pay well.

Dr. Sara Hagenah of Boise State University gave a “huge shout-out to the community” because people are talking about the Basin school across the state!

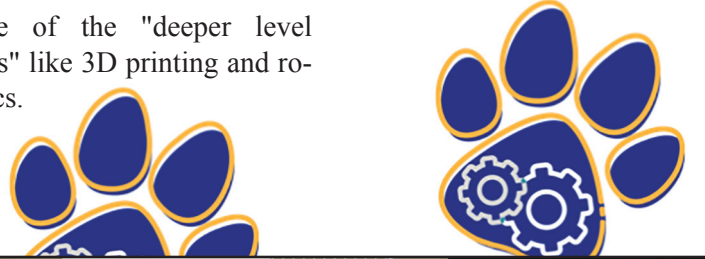
Principal Pilkerton said in an interview, “Our future in STEM is to really look towards
