MEET YOUR BOISE COUNTY CANDIDATES

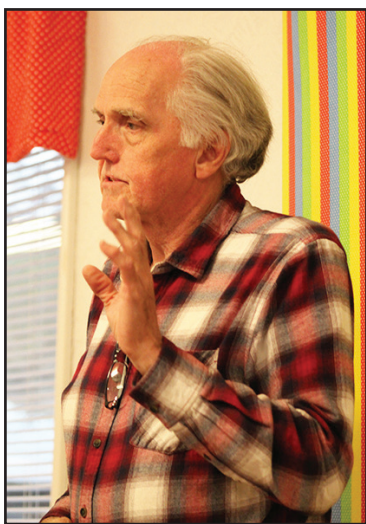
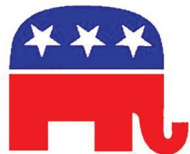


Lyndel Strong welcomed everyone out to the Boise County Republican Women Candidate Meet and Greet on April 21st at the Boise Basin Senior Center in Idaho City. She said that their organization was formed a year and a half ago and they meet every several months to discuss issues, "but our main goal is to educate voters."

Strong reminded voters of the May 17th Primary Election and said that early voting would begin on May 2nd.

She invited candidates up from her list to tell those present who they were within a two-minute time limit. At the conclusion of introductions, the candidates were available for questions for the next hour and a half.

Light refreshments were served, including brownies and cookies.



Gary Freeman, Senate Dist. 8, said, "If you want to be a free man or free woman, vote for Freeman!" He lives in Featherville, grew up in Richfield, and graduated from Twin Falls. He has served on two White House task forces and has "really broad experience." He spoke about truth, science, and getting the facts. He's concerned for small businesses, is a conservative Republican, and would love to be of service.

Jon Krueger, Senate Dist. 8, was raised in the Treasure Valley area, served in the U.S. Air Force, retired, and now lives out near Mountain Home. He said that he enjoyed serving those at home while deployed in the Air Force, but also felt a divine calling that he wasn't quite done serving. Krueger is a strong conservative, "I believe that our legislature needs



to be put more on a path of conservatism."



Geoff Schroeder, Senate Dist. 8, attended the University of Idaho, joined the National Guard full time, and has lived in Mountain Home for 32 years. He retired from the Army Guard, went to work for

the school district, and served two terms on the Mountain Home City Council. He then went to work for a law firm, doing consulting in writing ordinances. Because he's a "failure at retirement," he decided to go to the Univ. of Idaho College of Law. He represents sixteen cities in twelve different counties across Idaho. "Of the four candidates running for this seat, I believe I'm the best qualified. Because every single day, I'm in the trenches, working with state laws. I'm a sitting prosecutor. I prosecute for five different cities." He added that he's on call 24/7. "I'm familiar with legislation, I can evaluate it, and believe I can do the best job for you. Thank you."



Rob Beiswenger, House Seat A, ran a business in Indianapolis and worked with kids with autism – behavior therapy – and had close to fifty employees. They helped kids get into schools. That's where he learned about payrolls and small business management. He attends church in Garden City. He belonged to an Indiana grassroots lobbying group that fought for the Right to Work Law, and union workers are no longer required to pay union due on the condition of employment. There Beiswenger said he "learned a lot about politics and standing up for what's right. And to do the right thing." He has two daughters, 11 and 9 years old.



Matt Bundy, House Seat A, said he moved to Idaho twenty-five years ago, all his kids went to school here, and he loves Idaho. He is retired from his twenty-year aviator career with the U.S. Air Force as a Lt. Colonel, from nuclear deterrents against the Soviets to bombing the Taliban. Bundy now teaches high school, a senior American Civics and Government class. "We're doing the right things in history. We're teaching our kids about Idaho. We're teaching them about the Constitution. I love to read the Constitution with my students, and memorize the Preamble." He concluded by asking for their vote and said, "Let's all do the right thing for Idaho in our future."



Megan Blanksma, House Seat B, grew up in Nampa and lives in Hammett, Idaho, [exit 112 off I-84] with potato farmers. She has two kids in college that each had Mr. Bundy as their government teacher. She currently serves as the Ma-

Present: Commissioners Steven Twilegar, Ryan Stirm, and Ted Holmes

Pledge of Allegiance

CONSTITUENT INPUT: Warren Grover, running for County Commissioner - District 3, asked the Board regarding the minutes published in the *Idaho World* newspaper. He asked if they get an unedited version of the minutes. Clerk Mary Prisco clarified that the *World* gets an audio recording of the meeting, which is essentially a public records request. She said that what is published in the legal notices is the condensed minutes. By statute the county is required to publish the condensed minutes in the paper of the county [newspaper of public record]. He asked then if the newspaper was required to publish everything that was said at the meeting, and she answered, "oh, no."

MINUTES: Chairman Twilegar motioned to approve the minutes from April 12, 2022. The motion passed.

ROAD RALLY: Curtis Dill with the Boise County Road Department said that no one had contacted him yet, and there have been issues in the past. He said, "We're required to go prep the roads, and then the road rally happens, and then we're required to go back and re-prep. And as we're sit-

ting right now, we don't have the manpower, capabilities, to keep up that right now." He said with the number of paving projects they have currently in progress and everything else, "I can't concentrate on rebuilding a road for a race."

It was brought up that the rally had been going on for an estimated ten years, although it has been missed the past couple due to COVID-19. Commissioner Holmes suggested, "Since it's this far along, we bite the bullet on it. The rally goes, get it done and then we sit down and negotiate prior to anything in the future."

Chairman Twilegar had some concerns and suggested they table the approval for a week.

MUSIC FESTIVAL: A music festival was brought before the board that will be held in Horseshoe Bend, "an overnight deal," as asked by Commissioner Holmes. It was said to be a two-day event with a maximum of 500 people, which it has been larger in the past, and Sunday would be just half a day. Commissioner Stirm said the dates were July 29 to July 31. Law enforcement and EMS will have a contract. Commissioner Twilegar motioned to approve the application mass gathering permit for the Connection Music Festival, contingent on the payment of the Sheriff's

Department presence.

TREASURER/AUDITOR'S JOINT QUARTERLY REPORT: The second quarter joint quarterly report was presented by Clerk Prisco and Treasurer Gina Turner, which ended March 31, 2022. Chairman Twilegar motioned to approve the Treasurer/Auditor Joint Quarterly report. All were in favor.

SHERIFF: Sheriff Scott Turner discussed the bids for fuel stations. He anticipated that although it was a large cost up front, it would offer "a tremendous amount of savings to the county as a whole, for all of our departments. I know my fuel bill, just for the last two weeks of March, was over \$4,000 for two weeks. So, the opportunity for us to bid both fuel and to have our own fuel onsite, especially for my department and the road department," the yearly savings to their budgets would be substantial. He said it would be a worthwhile endeavor.

Chairman Twilegar said this was not budgeted for and the clerk confirmed that they would need to look at what projects were budgeted for and identify that money. The topic will be tabled.

COMMUNITY JUSTICE: Commissioner Twilegar motioned to have CMH replace the doors at the Horseshoe Bend Annex in the amount of

\$2,001.05.

LOCAL BRIDGE FUNDING: Kimberly Welsh said that they are working to get the worn-out or damaged bridges funded through the local highway technical assistance corporation in Boise County. She said the governor just signed a bill to replace many of the stressed bridges and Boise County has five of them. She said that the county would be able to apply for funds for three of the five stressed bridges. The Boise Street Bridge is likely to be the highest scoring bridge requirement for replacement at no cost to the county. Next in line would be the Gardena Bridge, a single lane bridge that crosses the Payette River, and that is also known as the Brownlee Road Bridge. Welsh said that they are also in "very good shape for funding on that bridge." The final bridge that seems the most stressed is the one that goes over Grimes Creek. She said, "The other possibility is Harris Creek, but that road is closed." She stated that the fifth bridge was the bridge that crosses the Middle Fork of the Boise River.

Commissioner Twilegar motioned to approve the memorandum of understanding with the local highway technical assistance council to replace the Boise Street Bridge over the Payette River, Brownlee Road Bridge, also known as the Gardena Bridge, over the Payette River, and the Grimes Creek Road Bridge.

CONNECTION MUSIC FESTIVAL: Chairman Twilegar motioned to approve the agreement to provide event law enforcement services and traffic control for the Connection Music Festival.

BAILEY & COMPANY: Clerk Prisco presented "two different engagement letters for Bailey and Company [the county's auditing firm]." One is for the East Boise County Ambulance District and the other is for Boise County, for the 2021 audit. She said there was "an extreme delay from what we normally have, in terms of when the audit was done, because of the fact that Computer Arts was not able to close our books, fiscal '21 books, until the end of February."

Chairman Twilegar motioned to approve the agreement with Bailey & Company, certified public accountants,

through Boise County. Commissioners Twilegar and Stirm were in favor, and Holmes' vote was not heard. He asked if this was that same accounting firm, and Stirm said it was.

EBCAD: Commissioner Twilegar motioned to approve Bailey & Company as their certified accountants for East Boise County Ambulance District.

DEMAND WARRANTS: Chairman Twilegar motioned to approve the demand warrant for Bank of America in the amount of \$1266. He then motioned to approve Horizon Wireless bill for \$312 for various invoices. All were in favor of these motions.

EXECUTIVE SESSION: Prosecutor Adam Strong said that Sheriff's office did have a pressing executive session under risk management. Chairman Twilegar motioned to go into executive session under risk management. [Time 9:42 am to 10:15 am] Commissioner Twilegar said, after coming back into session, there was no action required at that time.

PLANNING & ZONING BOARD: An individual from the Horseshoe Bend area, with a background in development and consulting, was presented to the Board to fill a vacancy on the Planning and Zoning Commission. Lou Esposito said he would like to be of service and that he is a longtime Idahoan. Commissioner Holmes said Esposito had a good resumé and would be a good asset to the county. Commissioner Twilegar asked about his stance on the "letter of the law" and about protecting the county from lawsuits.

Commissioner Twilegar motioned to appoint Lou Esposito through the Boise County Board of Planning and Zoning. Esposito raised his hand and solemnly swore to support the Constitution of the United States, the Constitution of the State of Idaho, and faithfully discharge the duties of Planning and Zoning Commission to the best of his abilities. He was congratulated.

FUTURE AGENDA ITEMS: Law enforcement and the mass gathering permit for the Idaho Road Rally will be discussed next week. There will be an elected and department head meeting. Another discussion on the Bogus Basin tax exempt status.

Adjourned at 10:27 am until April 26th, 2022.

City Council Meeting in Idaho City

IDAHO CITY -- On April 13, at the Regular Idaho City Council meeting, Mayor Ken Everhart was present, along with Councilmembers David Martin and Mari Adams. Ashley M. Elliott participated through zoom. Councilmember Tom Secor Jr. was absent.

They participated in the Pledge of Allegiance, approved the minutes of March 29, 2022 and paid the bills from March 30 through April 13, in the amount of \$18,450.38.

Peter Reynolds presented the checklist for the **2022 Idaho City 100 Motorcycle Enduro-Boise Ridge Riders**. This event will be held on June 3-5; the course will be between Idaho City and Centerville. In addition, there will be a mini-bike event for youth. They have 300 participants, and proof of insurance has been submitted. This was approved by the councilmembers.

Under the business of the Engineer's report, Idaho City is considering the possibility of engaging a "Water Rights" attorney. A motion was made by Councilmember David Martin

to accept the engagement letter with Dylan Lawrence from Varin Thomas Attorneys at Law to assist with the acquisition of water rights for the City and allow the mayor to sign the engagement letter. This was seconded by councilmember Mari Adams. Ayes in favor.

The **Idaho City Historical Foundation** submitted a letter to City Council to accept a letter of intent for Kay Jackson for a 3-year term serving on their Commission. This was approved by the Councilmembers.

Eugene Meyer presented an action item requesting that the City place snow in a different area as it damages the property on Walulla Street. City Council agreed to comply with request.

Under employee updates, **Public Works** will strive to accomplish filling all the potholes in Idaho City. There will be a new person cleaning the Community hall and other areas of the city at night in order to complete their 100 hours of community service. The original antique lights will be reinstalled in City Hall.

Regarding **Law Enforcement**, Chief Mark Otter will be

doing extra patrols Thursday-Sunday nights for the next several weeks. The graphics for the Law Enforcement car will be applied next week. Several grants have been applied for to cover the cost of the extra law enforcement personnel. Brent Watson is the new part-time officer. A POST approved State Reserve training will be conducted in Idaho City.

Clerk Ptak presented her updates:

The Mayor and Councilmembers are now eligible to be added to Life insurance.

A budget meeting will be set at the next meeting.

The email migration to a new domain is in process.

Work on installing the generator for City Hall should begin next week.

Water and sewer updates: Those behind on their bill were served a 7-day shut off notice unless they make a payment toward their outstanding bill. City Attorney Joan Callahan will be working with Clerk Ptak on addressing severely delinquent accounts.

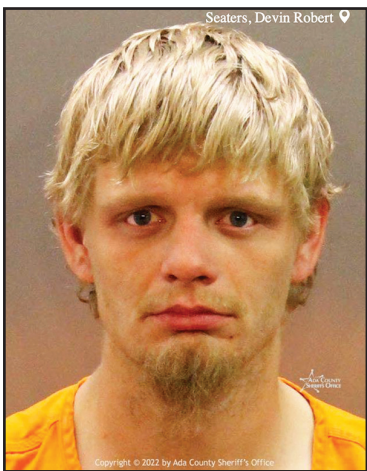
Meeting adjourned at 6:42.

Attempting to Flee or Elude Officers

BOISE COUNTY -- Boise County Deputies have been working to direct speed patrols in the early morning hours.

Last week, Devin Seaters, 23, was arrested early in the morning on April 21st for eluding officers and speeding northward on Highway 21. He had allegedly failed to yield for a traffic stop which led deputies on a pursuit that ended in the Clear Creek subdivision. Seaters handed the car keys over to his mother, so that she could get to work. The suspect was apprehended without further

incident. Boise County Deputies made a judgment call, had compassion, and decided not to impound the vehicle.

There were several additional outstanding warrants for Seaters' arrest, including five probation violations, a criminal charge of driving without privileges, and two failures to appear in court. Bail was set at a total of \$80,800.

The Boise County Sheriff's Office asks that motorists remember to check their speed and buckle up their seatbelts.

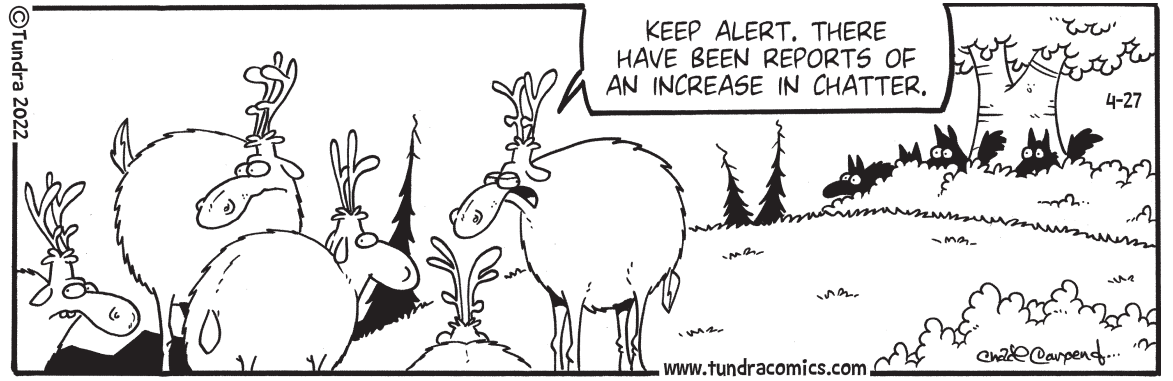

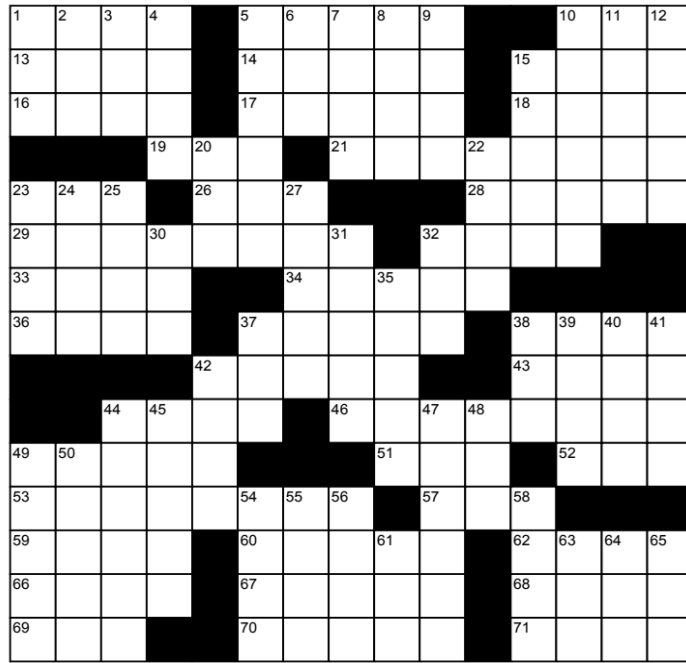
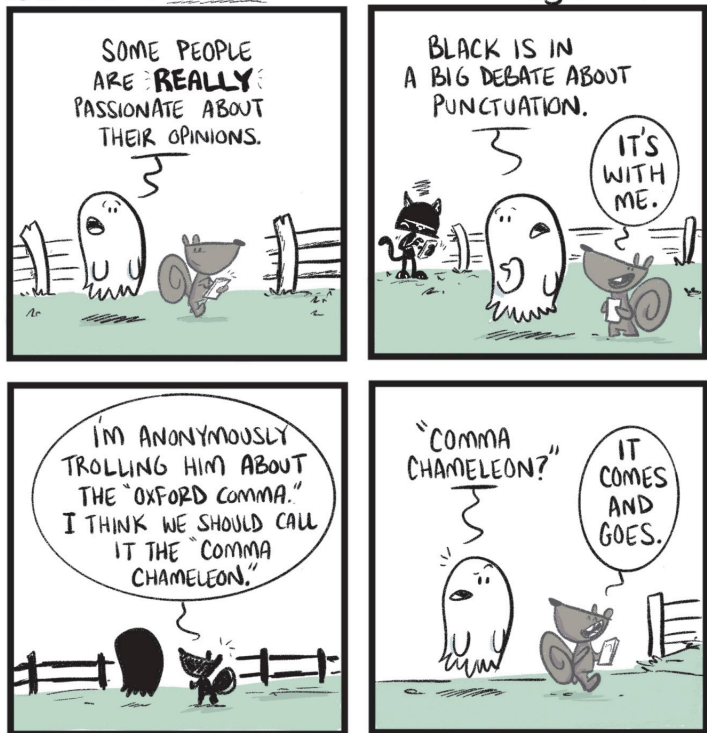

**Ronald Lewis Carpentier
1934 - 2022**

On Easter Sunday, April 17, 2022, Ronald Lewis Carpentier passed away peacefully in his home with family by his side. Ron was born on November 26, 1934, in Boise, ID, to Ernest and Arline Carpentier. Ron had an older brother, Richard, and they lived a great childhood. They grew up in Boise (on 15th & Brumback) and at the family homestead in Garden Valley (founded in 1863), and all over Idaho; while their father worked as a State Assessor. Ron attended Washington Elementary, North Junior High, and Boise High, where he met the love of his life, Beverly Balderston.

Ron had a wonderful childhood - playing football, skiing, water-skiing, and getting into general mischief with his "Gang", John Carley, Ron Daly, Gary Ferney, Bill Sellars, and Dick Ennis - all great friends from the Treasure Valley. Ron worked several jobs, one being a "Bellhop" at the Boise Hotel in downtown Boise. In high school, Ron also joined the ROTC, knowing he wanted to serve in the military soon after he graduated in 1952. Ron took a little time off, learning the basics at Boise Junior College, then he enlisted in the Air Force in 1954 and became a top Pilot Instructor, logging hundreds of hours and preparing the best of the best to fly for our country. In 1956, while Ron finished Flight Instructor School (and got his wings) in Selma, Alabama, Bev took spring break from BJC and joined her "Babe" there to be married.

While serving his active duty at Webb AFB, in Big Springs, Texas, they (well, mainly Bev) gave life to Kevin Ernest, then Kamali. After concluding active service in 1959, Ron returned to college to become an Engineer in Seattle, while the Easter bunny brought the first baby in the Pacific time zone, Kelly Logan. Ron tried working a job with Boeing, but that just wasn't exactly what the two of them wanted in life. So... they packed their things, their three young children, and moved to Pocatello for both of them to finish school at Idaho State and become Pharmacists. Eventually, the whole family moved in with Ron's mom, Arline (in Boise), while a house was built on Hillway Drive in the Northend of Boi-

se. Ron, ever the Patriot, joined the Reserves (then after that, the National Guard) and spent a week every year serving at Gowen Field or in Mountain Home. Ron started his Pharmacy career at Bruce Hill's Rexall drug (at 8th & Fort) and then had a long career at Potter Drug on Orchard St.

Ron was the perfect father, and Bev was the perfect mother. They always gave the family all the attention they needed, whether it was going on vacations to the Grand Canyon, Yellowstone, Seattle, or Montana; all the while instilling culture and social values that we all grew to love and appreciate. Ron was one of the best joke tellers of all time. Almost every day, he came home with a new joke; told to him by one of hundreds of his customers. His memory was amazing. He could tell jokes to all his customers, and make their day. He knew everyone's names, details about their family, and still gave pharmaceutical advice to make their lives a little better. Ron also continued to do anything he could to help everyone around him, in the community, and his family:

- He was a member of the Armed Forces Committee of the Chamber of Commerce
- He became a Charter Member to the Advisory Board of Planned Parenthood
- Ron was a Long-Time member of the Capital City Pharmacy Association, serving many years as President

- He received the Burroughs Educational Award in 1978, \$750, donated to ISU
- He became a member and leader of the charitable organization, The Capital City Kiwanis Club, spending many weekends, holidays, and whenever needed, to help the community in any way he could, becoming President in 1983-84 and receiving the Kiwanis Distinguished President Award in 1985

- He was a St. Al's Tree of Life Donor, and a BSU Alumni donor
- He was a Bronco Booster of the "Buckaroo Club", and held season tickets for the football games for many, many years
- He was a member of the BSU "Circle K" supporting Key Clubs from Borah & Kuna high schools
- He was a member of the Builder's Clubs for East & West Junior High
- He became a Cub Scout Pack, then Troop, then Den Leader, giving even more of his free time to help young boys become the best they could be, helping them get their badges, and camping out at the old Carpentier Homestead in Garden Valley.

- He attended every one of his children's events: Plays for Kami, Music Concerts for Kevin & Kelly, and every momentous occasion that came along.

- Ron worked, played, partied, and enjoyed life more than most people can even imagine. A new

- concept, the "Chain Drug Pharmacy/Grocery store," Smith's Food & Drug, came to Boise in the 80s. Ron was offered the highest salary of any Pharmacist & Manager in Idaho - to bring his expertise, professionalism, humor, and (of course) hundreds of customers from Potter Drug.
- In 1986, Ron received the prestigious Idaho State Pharmaceutical Association, Pharmacist of the Year award.
- From 1986-87, he was the ISPA's secretary
- From 1987-88 he served as ISPA's Vice-President
- From 1988-89 he became President-Elect
- From 1989-90, Ron became the President of the ISPA

- Still somehow finding "time" to enjoy himself, Ron built a radio-controlled racecar track at the homestead ranch, complete with pond, fountain, jumps, hairpin turns, and even a shaded area to relax. Ron & Bev travelled the country with their friends Alan & Barbara Earl, whom they also gave (for a dollar) 2.02 acres to build their own namesake cabin on the ranch property.

- Ron made it through very difficult illnesses and injuries for 20

- years, until he finally realized that he had done everything he wanted to do... and enough was enough.

- Ron Carpentier was too good to be true. But that was Ron, and he was especially lucky to experience a rare 66 years of being married to the same caring, incredible woman all of his life, who took care of him through the roughest 20 years anyone should ever have to experience. ## VANDALISM of Campaign Signage

**EAST BOISE COUNTY --** Late Sunday night, April 24<sup>th</sup>, or in the early hours of Monday morning, April 25<sup>th</sup>, one or more individuals vandalized candidate campaign signs/banners along the Highway 21 corridor. Starting at the location closest to the Ada County border, they removed or pulled up campaign signs and banners all along the canyon and within the city limits of Idaho City.

This was not the Idaho Transportation Department that did this, and a number of the signs were actually removed from private property where permission to place signage had been granted.



The Grimes Creek Road turnoff from Highway 21 was littered with campaign signs that had been removed from the ground. The event seems isolated to the Hwy. 21 corridor. Several signs had been spray painted. The Sheriff's Office is asking for the public's assistance in identifying the culprit(s) of malicious injury to property.

**HORSESHOE BEND** -- An anonymous email was sent to the *Idaho World* alleging funds had been stolen from the Horseshoe Bend Volunteer Fire Department. After reaching out to senior members of the department, the following post appeared on the Horseshoe Bend Fire Department's Facebook page. Horseshoe Bend's new Fire Chief Jeff Johnson wrote: "To clear up any rumors and with full transparency and heavy hearts, we have an announcement. Recently it was discovered [that] a member of the Fire Dept. had been using Fire Dept. funds for personal

use. Immediately upon discovery, an internal investigation was conducted and evidence gathered. On April 11th at approximately 5pm, Law Enforcement was notified with our findings, and intentions to file criminal charges. April 13<sup>th</sup>, BCSO Detective Sprague interviewed four members of the Fire Dept, including the individual in question. The individual fully admitted to all wrong doings and gave full cooperation. This is still an open and pending investigation, and the individual has been removed from the Fire Dept. Please know the members of the HSB Fire Dept. pride ourselves on

integrity, honesty, and caring. Doing the right thing and protecting our community is what we as a group stand for. In light of these events, it has shown us gaps in our system and we are learning from this error and implementing checks and balances to ensure all funds are fully protected in the future. We appreciate the continued community support and kindness as we work through this difficult time."

Several attempts were made to reach Chief Johnson for further comment, but those calls were not received and those questions were not answered prior to publication.

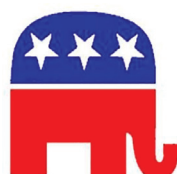

majority Caucus Chairman for the House Republican Caucus, which she was elected to. Blanksma spoke about the re-districting and moving further north. Her father lives in Atlanta, Idaho. She prefers to snowmobile from the other side in, but has gone in from the Idaho City way. "I'm proud to be an Idahoan. I think we have a great thing going here. We've got the growth that we're experiencing. It's difficult to handle right now, but I think we've got some really good people in office that are trying to maintain our Idaho values while still trying to handle that growth and prosperity. And I look forward to continuing to work with those folks, so I would appreciate your vote."

**BOISE COUNTY** -- The May 17<sup>th</sup> 2022 Primary is quickly approaching! Important information that you need to know:

### Absentee Voting

• May 6<sup>th</sup> is the last day to request an application to absentee vote.

• An absentee ballot can be requested through the Secretary of State's website at [www.voteidaho.gov](http://www.voteidaho.gov) or an application can be obtained from the Boise County Clerk's Office. There is also a link to the SOS site on the front page of the Boise County website [www.boisecounty.us](http://www.boisecounty.us)

• Voted absentee ballots must be **received** by the Boise County Clerk's Office, by 8 pm on May 17<sup>th</sup>. Please remember that it often takes five days (or more) for intra County mail to reach its destination.

### Voter Registration

• Currently, voter registration is closed and online registration will not reopen until May 18<sup>th</sup>. If you are not currently a registered voter, you may register to vote and vote, on the day of election, at your designated precinct location.

### Party Affiliation

• The deadline for party affiliation was March 11<sup>th</sup> at 5:00 pm. If you are currently unaffiliated and wish to vote Republican, Libertarian or Constitution, you may affiliate with the desired party on the day of election, and receive that party ballot. If you are unaffiliated and wish to vote Democratic, you can vote the Democratic ballot without affiliating.
