Chimney Fire Causes Extensive Damage

ROBIE CREEK -- Volunteer fire departments rushed to the scene of what appeared to be a chimney fire at a home in Robie Creek on April 2nd. No one was home at the time of the fire, and luckily a neighbor was able to rescue the family's dog. An emergency responder relayed that the family had been building the home for some time and had just finished many of the touches, like siding and a balcony off the side. The homeowners later said on social media that they had been in touch with their insurance company and were working with a neighbor to rent their home. Becky Evans wrote, "Words cannot explain the feelings we have right now. We are overwhelmed with the love and help we have received so far. I don't even know if we'll ever be able to thank all of you. We are extremely grateful to our local fire departments Robie and Wilderness Ranch."

Robie Creek Fire Chief Nathan Bowers recapped the incident, "With the help of Wilderness Ranch FPD, QRU and Robie Creek volunteers, we were able to extinguish the fire with no injuries. There was extensive fire damage to the attic and subsequent major water damage to the second and first floors. Preliminary investigation puts the origin of the fire in the chimney chase between the first floor and the attic. I'd like to take this time to point

out the importance of cleaning and inspecting the chimney of your wood burning appliances at least annually or more frequently. Also, pick up a stick of Chimfex to keep by in the event of a chimney fire to extinguish the fire and reduce the chances of having the chimney fire jump to your attic or other nearby combustibles. A good resource for chimney fire prevention is www.csia.org."

The Idaho State Fire Marshal's investigator provided a second opinion and verified that the fire resulted from a breached flue and chimney chase. The fire caused significant damage, but the house was not ruled a total loss. The Fire Marshal's Office recommends that Idahoans routinely check their chimneys for creosote buildup and take the necessary precautions to prevent an unwanted fire.

Present: Commissioners Steve Twilegar and Ryan Stirm.

Absent: Robert “Ted” Holmes

Pledge of Allegiance

CONSTITUENT INPUT: A constituent brought it to the attention of the commissioners that the county website had not been updated with the new redistricting map of the voting districts. Additional information that needed updating was brought to their attention. The constituent would like this updated before the election in May.

Another constituent asked regarding the minutes from the 2022 and had an issue finding them on the website.

MINUTES: Chairman Twilegar motioned to approve the minutes from March 22, 2022. The motion carried.

POLLING STATIONS: Chairman Twilegar verified that they were for the Primary 2022 Election on May 17. He motioned to approve the “seven areas.” This passed. He then motioned to approve polling places at the Wilderness Ranch Fire Station and the Mutual Improvement Lady’s Auxiliary’s Club building. These passed.

ROAD DEPARTMENT: Curtis Dill presented the name of a new hire for the Horseshoe Bend area. Twilegar mo-

tioned to approve the new hire and Stirm seconded. All were in favor.

HVAC: Assessor Chris Juszczak gathered some quotes for HVAC. Chairman Twilegar motioned to have YMC do the HVAC inspections for 2022. The motion passed.

PLANNING & ZONING: Mr. Gross presented a letter, resume, and information on an individual he would like to have appointed to the Planning and Zoning Commission.

Commissioner Twilegar motioned to approve the findings of fact for the cell phone tower in Robie Creek.

DEMAND WARRANTS: Chairman Twilegar motioned to approve the indigent payment for rent of \$400.

He then motioned to approve the reimbursement of mileage for a regional court assistance officer in the amount of \$105.28.

Twilegar then motioned to approve a power bill for the Prosecuting Attorney’s office in the amount of \$98.48. He then motioned to pay the Idaho City water and sewer bill at 406 Montgomery Street in the amount of \$97.01. The motion carried. Chairman Twilegar then motioned to pay the monthly lease on the Prosecuting Attorney’s building in the amount of \$550.

EAST BOISE COUNTY AMBULANCE: Melissa

Potts said they will be having an EMT orientation on April 10 and the class will start the last weekend of April. Twilegar motioned to approve the contract in the amount of \$5,995. This was approved.

EXECUTIVE SESSION: Closed session to discuss the hiring of an employee. [Time 9:22 am to 9:44 am] Coming back into session, Chairman Twilegar said he was going to be making a “conditional offer” to an individual, on the condition that he gets his inspector’s license.

CENTRAL DISTRICT HEALTH: Commissioner Stirm said they had a meeting and Mr. Labrador brought up a good point that he personally supports. “Central District Health is going to take a neutral stance on masking in schools, period. Yes or no, we feel it’s not our decisions.” Stirm said that Labrador is drafting that up and will present on April 15, and it will be voted on.

He said the budget was coming up for CDH and “it’s going to be a heartache for a lot of folks with the Central District Health budget, mostly because, if any of you are familiar with the House Bill that passed last year. The counties are now responsible for 100% [to offset their health district’s budget]. And the state is no longer responsible of any por-

tion for that budget. He said that indigent funds would be used. He added, “I don’t know what our contribution is going to look like.” He encouraged people to really pay attention to this issue and “add their two-cents” because the budget is no longer state funded. It’s expected to be a considerable amount of money. There will be less money to spend on indigent cases. Stirm explained that with the Medicaid and Medicare expansion, there have been less indigent cases because more people are qualifying under the expansion. He clarified that CDH is “huge” because they cover Health and Welfare, various clinics, including: health, wellness, and environmental health. Stirm encouraged people to look at Health and Welfare’s past budgets, “We may seriously be looking at a situation where we have to cut some programs or something.” Ada County will take 80%, “but it hits us a little harder than it hits them.”

GRANT WRITER: The new grant writer, Nancy discussed options and what grants they would like to pursue. A new board of individuals from throughout the county was discussed, and the topic will be readdressed at the next Boise County board of commissioners’ meeting.

A meeting with representatives from Boise to discuss funding opportunities was also addressed.

HERBICIDE: The county is already distributing herbicide. (See page 12)

ROADS: Mr. Dill said they were going to be working on the Old Emmett Road intersection and will be ready for paving by the beginning of June. They are also working on Alder Creek Road.

He said they are getting more material on the roads and he’s pushing for dust abatement.

The Race to Robie Creek is coming up and so they are getting Rocky Canyon Road ready, but it’s mostly in the shade and has not thawed. Stirm joked, “Is it a Race to Icy Robie?”

ASSESSOR: Mr. Juszczak said they are getting staffed, and will go out in the field to look at building permits soon. They are crunching numbers, “and the numbers are unreal.” He added with some sarcasm, “Everybody is going to love this office come June.” The commissioners partly joked

that they were going to blame it on the assessor. Juszczak responded, “Blame it on the people... asking for a million dollars for a \$300,000 house, and getting it!”

SHERIFF: Scott Turner said that the season was picking up and they’re getting ready. They are looking for more dispatchers.

Sheriff Turner said, “I’m tired of the trash in our backyard,” and that he’s been in contact with the Forest Service. “We’ll see how that works out.”

JUVENILE JUSTICE: There is money set aside for projects for county offices. Ms. Leader will be bringing quotes to the board.

April is Child Abuse Prevention Month, symbolized by the color blue. If you see blue pinwheels and blue nail polish, that’s what it represents.

May is Mental Health Awareness symbolized by green.

PROSECUTOR: They closed the murder case in Horseshoe Bend, agreeing to life in prison without parole. Prosecutor Strong said they have been busy going forward on the civil stuff, contracts, and some trial. He said the reason why they decided to pull the death penalty was in consultation with the victim’s family that they made that decision. “In Idaho, it takes almost 40 years for the death penalty to be carried out. And that’s forty years of appeals that the family didn’t want to have to show up for and the uncertainty every six months,” the prosecutor said.

PLANNING & ZONING: Alex Gross said they were a little bit ahead of where they were over the past two years ago with the number of building permits. Land use applications are coming in.

Adjourned at 10:38 am.

HSB Mustang Softball

HORSESHOE BEND -- With their starting pitcher out sick on Tuesday, March 29, the Horseshoe Bend Lady Mustangs took the field against the Idaho City Wildcats with rookie pitcher, sophomore Kaylin Penney. In her debut on the mound Penney kept her cool and showed great promise for the team in the future. She went 3 ¾ innings before being replaced with another rookie pitcher, sophomore Torey Tschida who struck out two batters and only allowed four runs in the 28-18 loss for the Mustangs.

Offensively, Tschida had one double and three singles with three RBIs for three runs. Sophomore 2nd baseman Abby Howerton scored two runs with two RBIs after getting on base with a single, a walk, two hit by pitches, and an error. Sophomore third baseman Kallyn Rogers made two runs with two RBIs from two doubles, two singles, and a hit by pitch. Freshman catcher Tiahna Quijas was good for two runs with an RBI from two walks and 1 hit by pitch. Freshman

left fielder Ashlyn Wolsleben scored twice, getting on base with two walks and an error. Penney had two runs and an RBI off a single, a walk, and a hit by pitch. Sophomore center fielder Olivia Bauer had two walks with 1 run and an RBI. Sophomore 1st baseman Annelie Wilson scored one run off a base on balls and sophomore substitute Jullian Wellan scored one run after getting on twice on hit by pitches.

With the resignation of the team's senior starting pitcher, the Lady Mustangs relied on rookie power during their home game against the Glenns Ferry Pilots on Thursday, March 31. The Pilots, coming off a state championship last year, were formidable competition for the young Mustang team. With Tschida on the mound, the Mustangs gave the Pilots a challenging game. Striking out six and allowing only ten of the eighteen runs scored by Glenns Ferry, Tschida has the makings of a great starting pitcher for the Mustangs. Offensively the Mustangs scored three runs in the 18-3 loss to the Pilots.

Junior Josie Stone scored off

a single, senior Kenzie Renfro scored off a walk, as did freshman Wolsleben. Penney and Howerton each had a hit with Howerton's good for an RBI. Wilson had an RBI off a short grounder to the pitcher which put her out at first base.

The team is at home on Wednesday, 4/6 against Garden Valley and on Thursday, 4/7 against Idaho City. The Mustangs have their first away game on Monday, 4/11 at Glenns Ferry and travel the next day to Rimrock before playing at home on Wednesday, 4/13 against the Greenleaf Friends Academy. All games start at 4:30 p.m.

Baseball: The Horseshoe Bend Mustangs Baseball team defeated Idaho City at home on March 29 with a final score of 14-4 and lost an away game to Glenns Ferry on Thursday, March 31 15-5. The team is at home all next week. On Monday, 4/11 against Glenns Ferry, Tuesday, 4/12 against Rimrock, and Thursday, 4/14 against Greenleaf Friends Academy. All games start at 4:30. The Varsity Mustangs are 2-4 overall and 2-1 in league, 3rd place.

LEGAL NOTICES

Boise County Notice To Control Weeds 2022
Idaho Code 22-2407. LANDOWNER AND CITIZEN DUTIES.

(1) It shall be the duty and responsibility of all landowners to control noxious weeds on their land and property, in accordance with this chapter and with rules promulgated by the director.

(2) The cost of controlling noxious weeds shall be the obligation of the landowner.

(3) Noxious weed control must be for prevention, eradication, rehabilitation, control or containment efforts. However, areas may be modified from the eradication requirement if the landowner is a participant in a county-approved weed management plan or county-approved cooperative weed management area.

(4) The landowner shall reimburse the county control authority for work done because of failure to comply with a five (5) day notice, as outlined in section 22-2405, Idaho Code.

(5) If an article is infested with noxious weeds, it shall not be moved from designated premises until it is treated in accordance with the applicable rules, or in accordance with the written permission of a control authority.

The state of Idaho has 67 noxious weed species listed. For information about noxious weeds you can visit the below sites or contact Boise County Weed Department, Paul Rekow at 793-2447.

Weed control efforts may be directed at reducing or eliminating new or expanding weed populations while know and established weed populations, as determined by the weed control authority, may be managed by any approved weed control methodology, as determined by the seed control authority.

Prohibited Genera. Plants in this category are prohibited from the state and may not be sold or moved within the state. Brooms: Tagaste, Escabon or Tree Lucerne, Scotch Broom, French Broom and Spanish Broom.

MEETING OF THE CITY COUNCIL IN IDAHO CITY

IDAHO CITY -- A special meeting, which was a re-scheduled regular City Council meeting was held on Wednesday, March 20, 2022. Mayor Ken Everhart called the meeting to order at 6:00 p.m. Those council members in attendance were David Martin, Ashley M. Elliott, Mari Adams, and Tom Secor Jr.

After the Pledge of Allegiance, and approving the minutes of March 9, 2022, the Council accepted the checklist for the **Gold Dust Rodeo** which will be held on June 24 and 25, 2022. This was contingent on obtaining insurance, and they also approved an alcohol variance for the rodeo.

The Council agreed to **pay the bills** from March 10, 2022 through March 29, 2022 in the amount of \$34,436.40.

Under the **engineer's report**, Ed Stowe and Mike Woodworth from Mountain Waterworks did research on **water rights** that can potentially be transferred to the city. They want to meet with a water rights attorney. Mountain Waterworks, along with the Idaho Department of Water Resources, will set up interviews with potential attorneys. They will interview attorneys and have City Attorney Callahan review the candidates to find a water rights attorney suitable for the city. They will pay for a few hours of consultation time and then get an attorney under contract with the city to work on water rights issues.

A **Water System Planning grant** was applied for. The

well project is on the verge of being closed out and is waiting for DEQ approval. There have been some issues with sand production. Mountain Waterworks will work with Mayor Everhart to discuss solutions.

Councilmember Tom Secor made a motion to allow the mayor's signature on partial pay request on DW1104, payment #57, in the amount of \$8,565.00.

Under Old Business the council discussed the responsibility of **Planning and Zoning** to clarify, define, and establish the regulations of recreational and mobile home parks.

City Attorney Callahan stated that zoning regulations need to be first looked at by P&Z and they need to set the standards to ensure that health, safety, and welfare standards are being met. Minimum standards need to be established for this specific use of property within the city limits. The discussion of the Council reiterated that there is a need to establish the definition of an RV park and a mobile home park and that the Planning and Zoning Commission will need to watch the video of this City Council meeting to assist in establishing standards for RV and mobile home parks.

New Business involved the **Cowboy Campground**, and their season kick off weekend. This was brought up by Sabrina Amidon, who will be hosting a new annual event on May 21-22, 2022. This will focus on camping, safety, and educational events. Church services will be offered on Sun-

day morning. The trail between the city and the rodeo grounds is a concern due to the speed of motorized vehicles. Chief Otter will work with Public Works Director Tami Claus to post speed limit signs and then law enforcement can enforce speed limits.

The **Personnel/Communicable Disease/Social Media Policies were changed to Resolution 2022-01** and a motion was made by Councilmember Ashley M. Elliott, seconded by Councilmember Mari Adams. There were four ayes, and the motion was approved.

Ordinance # 367, a short-term recreational vehicle was discussed. This was written by the City Attorney Callahan and it was placed in the Councilmember's packet, but not available to the public until it appears in the *Idaho World* newspaper. [Page 11]

Councilmember Secor made a motion pursuant to Section 50-902, Idaho Code, the rule requiring that ordinances be read on three different days, two readings of which may be by title only and one reading of which shall be in full shall be dispensed with and that Ordinance No. 367 be considered immediately. Seconded by Councilmember Elliott. Secor-aye, Adams-aye, Elliott-aye, Martin-nay.

Councilmember Secor moved that Ordinance No. 367 now be before the council and approved, it was seconded by Adams. Secor-aye, Adams-aye, Elliott-aye, Martin-nay.

Ordinance No. 367 will be effective upon publication in

the *Idaho World* newspaper.

Under Committee reports **Parks & Recreation** needs new members to form a committee so events can be planned, and improvements be addressed. An ad will be placed in the paper.

Representing the **Historical Preservation Commission**, Rhonda Jameson presented a list of goals and projects for the next year. The Historic Preservation Commission will be updating the Historic District Address Listings. Rhonda Jameson is suggesting having an arborist assess the trees every few years to help preserve the trees in the Historic District. Kay Jackson submitted her letter of intent to be on the commission for another three years. The Historic Preservation Commission has recommended that Kay Jackson be appointed.

The **Idaho City Chamber of Commerce** has established a new board.

Employee updates began with **Public Works** Director Tami Claus indicated that Hill Road improvements are finished. The bathrooms will be getting a deep cleaning. The bathrooms by the ballpark will be opened closer to the beginning of T-ball. Sand was

placed in the potholes for now, asphalt will be used to fix the potholes soon. A new process to repair the potholes will be used so that repairs will last longer. There was a lot of sand in the RO filters. Engineers suggested flushing the well every day until the sand disperses and to run the well every day, Monday through Friday.

Law enforcement is sharing the space in the Visitor's Center.

Beth Wilson, President of the **Idaho City Historical Foundation**, would like permission from City Council to make repairs to the roof of the Idaho City Arts Council shed. First, it needs to be established if the shed belongs to the city or the Arts Council.

Water and sewer updates presented by Clerk Ptak stated that the RV park on Elk Creek is behind on their bill. The property is in the process of being sold but is taking time.

Discussion on how to handle the debt was discussed. It is believed that the debt will be paid upon sale of the property. Current owner should be put on a monthly payment plan through an attorney letter to keep a lien from being applied to the property at this time.
