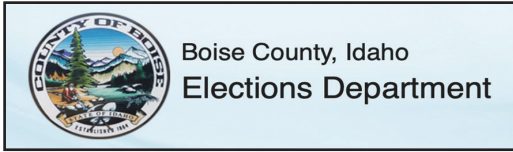

May 10, 2022**Present:** Commissioners Steven Twilegar, Ryan Stirm, and Ted Holmes.**Pledge of Allegiance**

CONSTITUENT INPUT: Debra Jackson, running for County Clerk, had three points of inquiry. First, she asked about the county's server, "the server went down Saturday, April 30th, and they were back up sometime on Tuesday, May 3rd, causing the Board of County Commissioners meeting to be canceled last week. My questions are: What caused the server to go down, and what was the remedy, and is there a backup server so that the county data would not be lost?" She then handed out papers and spoke regarding the Democracy Fund "a self-proclaimed nonprofit group. The Democracy Fund is part of Silicon Valley billionaires on the dark network which helped Mark Zuckerberg funded center for technology and civic life recruit local election officials to accept controversial private funding of election administration." She said that he funded leftist groups and heavily donates to the democratic party candidates, saying, "this is all online – you can google it. When a Boise County election official applied for and accepted monies from this foundation, did they do their due diligence as to where the

money was coming from and did they realize they were accepting Zucker-bucks?" Jackson then addressed signature verification and said she had submitted a letter to the voters of Boise County, published in the *Idaho World*, attesting to her experience in the 2020 Presidential Election. "The county clerk and the Secretary of State will not allow poll watchers to observe this process, stating that personal identifying information would be seen on the screen during the signature verification process." She then asked, "Has the Secretary of State's office and Boise County remedied the problem [of viewing comparison signatures on a computer for the absentee voter ballots]? You could not view the signatures on probably more than a majority of the absentee ballot envelopes coming in. The signatures were not viewable on the computer to be able to compare it. My question is: Has that been remedied and if so, when?"

Assessor Chris Juszczak addressed the server issue, "It was two Sundays ago, approximately 2:30 it came in, there was no response from our server." The IT person predicted it was an electricity issue, a "spike or a brown-out." Juszczak reported that the server was older and out of warranty. "We were able to get

a skeleton of that server. We didn't lose any information." He said the server was back up and running on Tuesday at 4pm, but this past Sunday at about 2:30 in the afternoon and it was the same thing with the virtual servers. They have also lost the ability to get the county's emails up-and-running. Juszczak said the county does have "two huge battery backups with built-in surge protectors in the server room." He said the county was backed up to Computer Arts because they use their software, but the emails are lost. An individual said that he believed there was Cloud backup, but it would "take forever" to obtain the backup and create disks with the information to reconstruct it.

Commissioner Holmes asked if the server were secure, and Juszczak answered, "Anybody can get in there." However, it's locked right now but "anybody who has access to the building, you know we all have our key card. These are what track who's coming in and out of the building." Juszczak said the last time they had an issue with the server was about four years ago with an email virus.

Chairman Twilegar said, "It just seems wildly coincidental that on Sunday twice... At the bare minimum, we definitely need to secure our servers. I

don't think that anyone would be dumb enough to do something like that, but you never know."

Commissioner Holmes asked regarding the printout from the State of Idaho, provided by Jackson. "Did we know about this; taking money from this organization?"

Clerk Mary Prisco offered to address his "comment." She said, "We did not *apply* for that grant. It was a grant offered through the Secretary of State's office... The Secretary of State sent it out to all forty-four county clerks as having the amount of money that each county was eligible for and we used that."

Prosecutor Adam Strong stated that historically this grant is fulfilled by federal dollars through the Help America Voting Act, "it's not private dollars." He said there was a separate issue, "that twenty counties applied directly to the nonprofit to get grants from – *we were not one of those counties*. So, if the HAVA Grant has some other funding from a nonprofit, that would be new, because that's typically federal dollars..." Strong said he would like to see that documentation and Chairman Twilegar agreed.

Jackson retraced that she had researched the "Democracy Fund" scale and the document put together by the Secretary of State, "It appears that those monies were given to the state through the Democracy Fund. I don't have documentation of that occurring, but why would he put that nonprofit fund's name at the top of the page, listing what all the counties, according to the census, would get per a person? And that's how they came up with the totals given to the counties."

Chairman Twilegar said he would do his own research on this subject.

CLERK: Mary Prisco said she had submitted an article addressing the election process (which was published in last week's newspaper). In regards to challengers and watchers, "There is law that surrounds that and the Secretary of State's office, Secretary Denney put out a directive, 2022-03," on the 27th of April. "That gave the county clerks direction on those challenger watcher laws." In regards to the watchers, "They are not allowed to look at the screen on our back office voter registra-

tion system, which is the state voter registration system. For each individual voter, there is personal, confidential information on that screen and I don't think any of us would want, you know, just anyone to see that confidential information. They are allowed to be there when it's processed. They just have to stand in a spot where they can't view the screen." Chairman Twilegar clarified that the statement had come from the Secretary of State's office.

Jackson said that the software was not updated over the past two years to remove the identifying information from the envelopes in order for poll watchers to observe. Commissioner Holmes asked regarding having an outside source present to assure that there is no problems with one person verifying. Clerk Prisco said, "There's some confidential information on the screen." Commissioner Holmes said bluntly, "You're looking at it." She said, "Excuse me? Do you have a security clearance?" Prisco explained, "Yes, I'm the elections' officer." Holmes said, "Yeah, and so are they when they raise their right hand as poll watchers." Prisco explained, "They're not becoming an elections' officer." Holmes said, "You're an elected official. Who do you represent?" Prisco answered, "The people of Boise County." Holmes said, "Thank you very much." Prisco asked, "So, what is your point, Mr. Holmes?" Holmes replied, "My point is, I don't feel good about these elections on the signature verification. I've been a cop and it's even hard for me when I went to a class on signature verification. On a positive, usually you need two to three people to verify it before they sign an affidavit that it's actually a signature." Clerk Prisco responded that the program has a dropdown with images for voter registration cards with their signature, "and that is what we use to compare to the signatures on the back of the outer envelope of the received absentee votes. That's what we do."

Jackson restated from her letter in the *World* that, "the image was 1/3 the size of a postage stamp. The entire document was reduced to that size. There was no way you

could enlarge it to actually see the signature to compare it. So, my question is, has that been remedied where they're actually being able to see all absentee voter signatures when they're doing the comparison? Or are they, as in 2022 [2020] when I was ordered, when I couldn't see the signature to mark it as *matched*, when I was not able to actually see the signature to compare it." Commission Holmes asked if she signed and approved those. Jackson answered, "I was ordered to mark them as *matched*." Clerk Prisco clarified that it was in 2020 and that "numerous software changes" have been made; at this time you can see the image registration with the signature. Commissioner Holmes added, "As a county commissioner representative, [for the] voters out there, to see this process. I want to *see* the signatures. I want to know and feel comfortable that they can be legitimately verified properly."

Clerk Prisco assured that she was "working off the law and the direction of the Secretary of State." Chairman Twilegar said he didn't want to go and break any laws.

Commissioner Holmes said he would call the Secretary of State's office, "And get it from the horse's mouth. I'll explain the problems and say, you know what? I represent my voters in my county and I want things done *right*, Mr. Secretary of State." He added, "We see confidential information all the time as commissioners. We

are elected, just like you. You don't have a security clearance. I don't either. But if you could see it, then we can too."

COUNTY DATA: An individual said that "all of our data is backed up, both locally and to the cloud... We are not in danger of losing any data." Holmes asked regarding emails. The individual said that included emails.

MINUTES: The special meeting minutes from Tuesday, April 26th were approved. Rick Aspril (candidate for commissioner) asked if the constituent input was included from the regular meeting on April 26th, and Chairman Twilegar answered in the affirmative. Twilegar motioned to approve the special (emergency) meeting minutes from Monday, May 2nd. This was also approved. Holmes said he had remembered "a lot more constituents than that giving input on the 26th." Prosecutor Strong said that Aspril had been later on in the meeting under an agenda item. This was verified and Twilegar motioned to accept the minutes from the regular meeting held on April 26th and all were in favor.

IDAHO CITY ROAD REPAIR: It was stated by Commissioner Twilegar that there was no documentation that Montgomery Street was turned over to Idaho City for its maintenance. He motioned to assist the city, and the county, to provide up to \$2,500 for the delivery of asphalt for Montgomery Street. All were in favor and was approved.

ROAD DEPARTMENT:

Curtis Dill said they are losing another individual due to pay and cost of living in the Garden Valley area. He has spoken with other counties and the Idaho Transportation Department, "they work out like a housing-type deal to help." He suggested RV parking and county property. He said that, technically, he needs to have his guys close, within 30 minutes. Prosecutor Strong said that for an RV park, they would need to get approval through Planning and Zoning for a conditional use permit for multiple use, "which is not an overnight process." This will be addressed at a later time.

Dill said, starting next Monday, they will have the asphalt for Old Emmett Road and will start prepping for paving the 1st of June. The first part of Alder Creek will also be paved.

TREASURER: Gina Turner said she was about ready to send out reminder notices for taxes.

ASSESSOR: Chris Juszczak said several of his employees worked on Saturday to meet a deadline, because they had been locked out of their computer with the server down. He explained, "Without software, there is nothing that my office could do." Clerk Prisco asked if they were going to end up with more than 40-hours, and Juszczak confirmed this.

Commissioner Twilegar motioned to pay county employees up to the amount that they normally work, "even if they didn't, because the server failure was not their fault." All were in favor.

Horseshoe Bend City Council Meeting

HORSESHOE BEND -- The following is a synopsis of the Horseshoe Bend City Council meeting on May 11, 2022. Nine people were in attendance for the meeting, along with one Boise County Sheriff Deputy. Six individuals joined in via the city's Zoom link, including City Attorney Tony Pantera. All council members were in attendance except for Curtis Corvinus. Mayor Pat Goff made the call to order at 7:00 p.m. then led the Pledge of Allegiance. After unanimous approval of the agenda, minutes from the previous meetings on April 13 and May 4, and the authorization to pay the city's bills, Goff opened the meeting with new business.

Susie Keeth came to the podium with a building permit/action item on the agenda. She opened by telling the council that she has lived in Horseshoe Bend for six years and that compassionate people live in the community. She shared an analogy about camping in trailers and RVs, and how people think those camping in smaller trailers are less worthy and that social media is doing the same type of comparisons adding, "People are just trying to make a living, housing is very tight. A lot of people are struggling to find affordable housing." She went on to say that she has made several attempts to obtain a building permit, but they have not been approved and that her property has everything needed except a water hook-up for another residence to be added. She said she had been asking for a fair and reasonable accommodation request for over one year, but had received no response from the city. She told the council that she was eligible for the request because she has a disabled daughter and granddaughter, and wants them to be able to live on her property, but she can't obtain financing for the build without a permit from the city. She called on the council to provide an answer for her reasonable accommodation request.

Goff told her the process involved an administrative review. Pantera told Keeth that her original building permit application required her to split the property and he went on to say, "The lot just needs to be split." He told the council that the city clerk had told this to Keeth repeatedly.

Pantera added that he was attending the meeting remotely

because he was out with COVID from the previous week. He stated that there was "no nexus between (Keeth's) stated disability and the request for accommodations." He told the council he would provide Keeth with a written response by the end of the week. Keeth asked if there was an appeal process. Pantera replied, "Not really, no." Keeth said she wanted a forum to discuss her issue. Pantera told the council that the letter from a nurse practitioner attached to the request for reasonable accommodations identified the disability, but not a reason for accommodations. However, he agreed to call Keeth for further discussion.

During the discourse between Keeth and Pantera, former mayoral candidate Jon Dufresne kept interjecting his own comments into the discussion. After being admonished by Goff, Dufresne continued and was escorted out of the meeting by the deputy at Goff's request.

Theresa Martin was next with new business. Martin resides at the same property as Keeth. She requested that the water hook up that had been removed from her property by a previous owner be restored. She claimed the \$7,100 fee to hook up to the city's water system was exorbitant. She stated that she was agreeable to paying for a new meter to be installed, but that since the existing infrastructure was still intact, she should not have to pay for it again.

City Engineer Amy Woodruff explained that since the service had been disconnected and removed from the system years ago, the fee associated with restoring it took into account the system's capacity and the monthly fee associated with remaining on the system (even if no water is being used). Martin argued that she doesn't believe that she should have to pay to restore the service. Goff reminded her that she bought the property as is.

Woodruff told the council that city ordinance requires Martin pay the fee to be reconnected to the system, but the council can address the issue through a public hearing. Martin argued that there is nothing in the city code regarding the matter. Goff replied, "Let's discuss and see if we can come up with something a little more reasonable." Martin asked that the council consider the issue and not do like Pantera does by

not returning calls.

City treasurer Teri Nolan told the council that they should be careful not to set a precedent by granting Martin's request. Martin and Keeth spoke out over Nolan and were reprimanded by Goff that the council was trying to conduct business and they were to cease interrupting.

Next on the agenda was the placement of gravel for parking at the new Veterans Memorial Park. Goff told the council that for the most part, the gravel would be donated, but may cost between 2K-2.5K, to be drawn from the park budget. He asked the council to vote on it.

Councilmember Martye White asked if they needed to go to bid on it. Goff said since it was under 50K, no bid was needed and the majority would be donated. The gravel will cover 15,000 square feet and allow for 31 parking spaces.

White asked who would be donating the materials and labor. Goff named a few donors.

The Horseshoe Bend Valley Chamber of Commerce provided the following list of donors: Bailey Engineering (Engineering and design plans), Douf Bergey (Laser work for elevation and staking), Premier Aggregates (gravel/road mix), Dobson Gravel, Backcountry Dirt Worx, Ryno Engineering, Mike Renfro/Blue Mule Trucking (Hauling gravel and topsoil), Severance sand and Gravel (topsoil), Anonymous donor (\$5K for test, compact, grading to prep lot for aggregate).

White responded that the approval is a "no brainer." He asked Pantera if he saw any issue. Pantera responded, "No concerns at this point." Woodruff told the council that the parking area could be paved in the future. White motioned for the approval of the donated gravel installation (without mention of additional cost to the city), Chartier seconds and the motion is approved unanimously.

EMS Report: Councilmember Patti Burgess said that two ambulance drivers have taken the test and just need to be signed off.

Public Works Report: Michele Brothers communicated that the department has been working on cleaning the greenbelt, trimming and removing trees. Public restrooms are open. Final bridge inspection by the USDA went well. The new generator is working great.

Grant Writer Report:

Cheryl Pleak told the council the comprehensive plan has changes and needs to be addressed at a public hearing in June. Goff suggested holding off until July, so the staff can review the changes properly. Pleak says that staff and council were given copies three months ago, in February.

She requested a time to talk to the council about upcoming grants and park development. She concluded by stating that her plan for the Veterans Memorial Park also had plans for a gravel parking lot and commended the council on approving the plans for the parking area.

City Engineer Report: Woodruff said they are currently working on getting sidewalk bids out soon and they continue to support the public works department.

City Attorney Report: Pantera said, "I don't really have much to report."

Mayor's Report: Goff stated that he hates the divisiveness in the community. "We need to hear a lot more voices."

He concluded by saying he just wants a "happy community."

The meeting concluded at 7:39 p.m. and went into executive session.

The Horseshoe Bend City Council meets on the 2nd Wednesday of each month at 7:00 p.m.

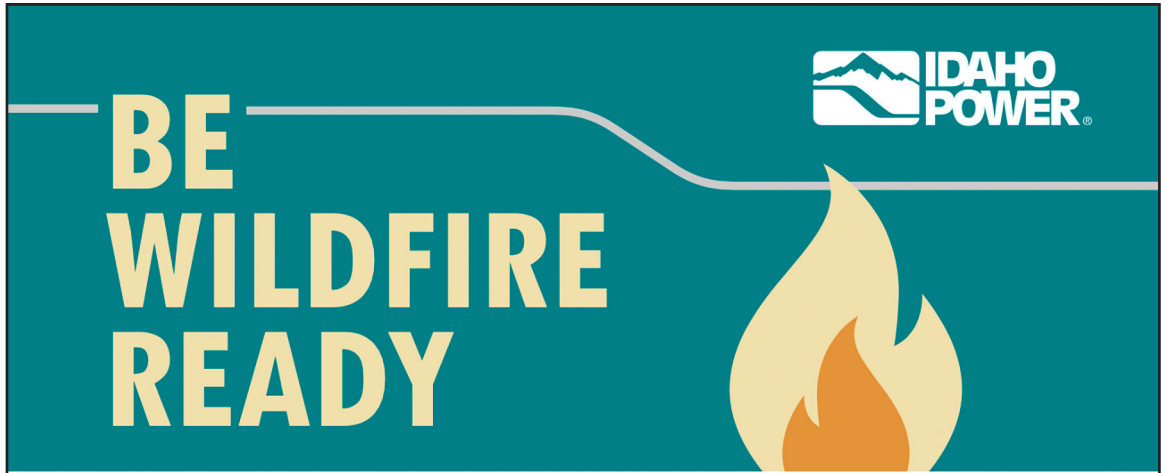
