May 10, 2022**Present:** Commissioners Steven Twilegar, Ryan Stirm, and Ted Holmes

[Continued from last week's newspaper]

SHERIFF: Sheriff Scott Turner spoke regarding "a cloud-based fuel management system" for the county that could be set up by individual departments. "We own the system, we maintain the system, and we manage it." It would record which department and which vehicle was taking the fuel. [The county is considering buying fuel tanks and gas in bulk to save money.]

Sheriff Turner said that otherwise, the department has been very busy. He spoke about the spring snowstorm, "We had almost sixty cars on Horseshoe Bend hill that slid off." He reported that they had three Boise County Deputies and three Idaho State Troopers on Horseshoe Bend hill for about six hours. It took the Idaho Transportation Department two hours to get to the scene and plow. Then they were able to start moving traffic and pulling cars out of the ditch.

PLANNING & ZONING: Alex Gross presented some land parcel numbers to the board and asked that they wave these application fees. Chairman Twilegar motioned to wave the fees for the three

parcels of land, for reasons that were discussed in executive [closed] session. The motion carried.

Gross also presented bids for a vehicle purchase for their department. He said they go to construction sites with the current vehicle, a Chevy Equinox, over Alder Creek Road and Harris Creek Road often. "I had to put the bumper back on that car, personally, in my garage. I didn't rip it off, but I put it back on." Gross suggested that it might be a good vehicle for the Sheriff's dispatch people. Sheriff Turner confirmed that it could be used "to go back and forth to trainings, and to transport evidence back and forth to the lab."

Gross would like to purchase two budgeted for Toyota Tacoma trucks, "so our staff have vehicles," with appropriate four-wheel drive and four cylinders. They are the base model, without the rear seats included, "These are as cheap as Tacomas get." Gross said that in the long-run these trucks are going to save the taxpayers money on fuel and maintenance costs. "They are tough little trucks." Commissioner Twilegar motioned to purchase these two Tacoma trucks in the amount of \$57,712.

A tentative public hearing was scheduled for Avimor development on July 12th.

CLERK: Mary Prisco had an issue to address later, during contracts.

PROSECUTOR: Adam Strong said his office was, "just going forward with all their normal stuff." He added, "Other than that, nothing out of the ordinary. We're busy, but nothing too busy in our office."

ROAD DEPARTMENT: A change order was brought before the board for added work to be done for a paving project. Curtis Dill reasoned that their highest traffic was to the dump and the equipment to do the work is already going to be there. The road department constantly has to fix that section in Horseshoe Bend. Commissioner Stirm said, "Why make it transition from asphalt to dirt in a couple tenths of a mile before the dump?" Chairman Twilegar motioned to approve the extra mile up to the dump on the Old Emmett Highway for Sunrock to pave, in the amount of \$149,840. All were in favor.

PAYROLL: Commissioner Twilegar motioned to move three employees on payroll from solid waste to noxious weed control. All were in favor.

PORTA POTTIES: Commissioner Twilegar to approve \$600 for the rental of porta potties for the countywide emergency exercise. All were

in favor.

NOXIOUS WEED CONTROL: Commissioner Twilegar motioned to approve the agreement between the Idaho Transportation Department and Boise County for 2022.

EMT GRANT: Clerk Prisco said, "We could be eligible to able to receive a maximum of \$13,885." Although there is not an exact amount at this time, she advised the board to accept the additional grant dollars. Chairman Twilegar stated, "I will make a motion to accept any amount of money that they decide to give us, \$13,000, above or below," for the grant. The motion carried.

FINANCIAL SYSTEMS GRANT: Clerk Prisco asked for an additional special meeting later that week, because they were not going to meet as a board the week of the elections.

CLAIMS: Chairman Twilegar motioned to approve the claims approval report approving budget balances.

LIQUOR LICENSE: A liquor license was approved for the Eagle Rodeo [held in Horseshoe Bend].

CERTIFICATE OF RESIDENT: Two applicants were approved [which includes money for college outside of Boise County].

OVERPAYMENT: Chairman Twilegar motioned to refund an overpayment for a building inspection in the amount of \$400. The motion carried.

PROPANE: Chairman Twilegar motioned to approve a propane purchase and delivery to the Horseshoe Bend Annex in the amount of \$580.

BANK OF AMERICA: Twilegar motioned to pay \$139 for an Amazon purchase. This was approved.

PROPANE: Twilegar motioned to approve a propane purchase and delivery to Garden Valley Fire in the amount of \$659. The motion carried.

PLANNING & ZONING HEARING APPLICATION: A conditional use application for Mores Creek Rim Road was inquired about by the board. Alex Gross, P&Z administrator, said that it was a matter for closed executive session.

CONSTITUENT INPUT: A constituent asked regarding the meeting minutes sent to the county newspaper, the *Idaho World*. He asked about the potential of putting audio

recordings online for the public to access. Commissioner Stirm said that they would need to get with their IT guy to see if it were possible. Commissioner Chairman Twilegar said, "We're not really going to look at it anytime soon, I can tell you that, with what's going on in the county with the servers and everything. I mean, yeah, the more transparency, the better. We're going to do Zoom meetings, we're going to start doing all sorts of cool stuff."

The constituent also asked regarding the budget surplus and posting it on the website. Clerk Prisco reiterated that the audited financial statements were posted on the website. She said, "The word surplus doesn't really have meaning in county government." Prisco referred to them, respectively, as non-spendable, restricted, committed, assigned, and unassigned funds. The constituent asked about what was required by law and what was held above that amount.

CENTRAL DISTRICT HEALTH: An individual came before the board to present the proposed budget for Central District Health for the year 2023. He spoke about increases for staff. The individual said, "Our budget has increased substantially, primarily due to federal funding that we're getting through Health and Welfare. A lot of it was tied with the COVID response. It's transitioning to our community resilience." He said there will be community resources, parents as teachers, and other help to make families successful.

The individual spoke about the substantial increase requirement in cost to the counties. He said they did receive some funding from the state.

Boise County's share for CDH for 2022 was said to be \$53,566. The speaker said House Bill 735 was about Medicaid expansion in January of 2020, and that made for fewer medical indigents in the county. Due to that savings, the counties would support their public health districts. The individual said, "Starting on July 1, the counties will be responsible for one hundred percent."

Stirm said this money would come out of the general fund, unless the commissioners create a levy for indigent money.

IDAHO CITY -- When life's not fair, work harder. That was this year's motto for the Idaho City High School track team. This year came with its fair share of "that's not fair" moments for a lot of us but none more than one of our seniors. Ruth Heffington was a standout athlete in three sports and her passion for track drove her to work harder than ever her senior year. In addition to achieving high academic success, she put in long hours trying to be the best in all her sports. Ruth, like many high school athletes, learned the importance of hard work in order to achieve your dreams. Ruth did everything right, including early morning workouts, lifting hard in weights class, and giving up free time to increase her chances of achieving her goals. Goals that included school records, conference records, a state championship, and maybe even the opportunity to run track for a university as she fulfilled her dreams of a career

in the medical field. Ruth understood these dreams wouldn't come easy, and included a lot of work, work she wasn't afraid to do. As our track season was

approaching her biggest challenge was discovered after the onset of pain and a trip to the hospital. Ruth discovered she had a serious back injury that was going to prevent her from achieving these dreams. Faced with a decision early on in the diagnosis, she was left with no other choice than to undergo a back surgery that would take her out of competition for her senior year of track. This news was, dare I say, not fair. Ruth missed one day of practice for the surgery and returned the next day propped up in a chair with a smile, practicing being a good teammate. As the weeks progressed, she took on the responsibility of coaching some of her peers in hurdles. Not a role she was comfortable with, but she wanted to contribute and serve her team. Ruth went on to help two of her teammates qualify in her events (hurdles) for the state meet. Rauri Mulrey, a sophomore, and Mary Plumlee, a freshman. As Ruth recovered and did her physical therapy she started to think maybe there was enough time left in the season, and maybe she would be able to just compete in one track meet. With only a few meets left, the day came when she would get that opportunity to compete. As the gun went off, Ruth was doing it, she had overcome back surgery and was running down the track competing. After finishing the race she was unsatisfied with her performance. One thing about top athletes: they have high expectations. The next week she wanted to re-

turn to the hurdles, a race she had dominated as a junior. She ran the 110 hurdles and 300 hurdles at our district meet and even qualified for state. Having only limited time to get her skills up to that high level of competition seemed impossible, but unsatisfied with just making it to state, she wanted to be in the top eight after prelims and make finals. As the first day of State began, Ruth gave it everything she had and wouldn't you know, she not only qualified in one but both races for finals. Being seeded 7th in one and 8th in the other, making podium seemed impossible. Ruth fought hard against a tough field of athletes that had been training all year, and when the day was done Ruth had earned that podium visit. A bittersweet moment receiving a 6th place medal, but do you think she learned an important lesson in life? This old coach thinks she learned one of the best lessons....when life's not fair, work harder. After coaching for ICHS for over 20 years, I have learned a lot from my athletes. Thanks, Ruth for giving me and many others a valuable lesson in life! When things don't go as we think they should, it's easy to get trapped

in that negative way of thinking....that's not fair. Fight that urge, odds are good that it's not fair, few things in life are fair, and the more you look at it through those glasses the more injustices you will see and it becomes a bitter life. Working harder sometimes means taking on the responsibility of your environment or changing it. Don't be quick to find fairness in life, instead look for opportunities.

ICHS had a great showing at the state meet this year. We took 8 students to Middleton and they all represented our school and town at the highest level. Millie Rigsby (senior) placed 2nd in the high jump, Selena Exon (sophomore) placed 7th in the high jump, Mary Plumlee (freshman) competed in the 300 hurdles, Ashlyn Porter (freshman) competed in triple jump, Rauri Mulrey (sophomore) competed in 4 events the 400, 110 hurdles and placed 4th in the 300 hurdles and 7th in the discus, Liam Barber (Junior) placed 10th in the shot put, and Brody Backus (Junior) placed 7th in the shot put and 2nd in the discus.

House Bills 316 and 735 were also discussed by Prosecutor Strong, who said they were under the cap for the levies. He said, "In theory, the county should be spending less money... and there should be a savings to property tax payers." Clerk Prisco said there were a lot of moving parts and that their costs for the indigent program had been declining.

The individual said the amount Boise County would pay was based on population and market value, \$82,000. "I'm sure it will come to no surprise to anybody that market values have increased in our health district by 25% and population increased by 5%." They are having a difficult time retaining employees, primarily due to pay, and are asking for a cost of living increase.

He spoke about rabies and stated that if an individual gets scratched or bit, they need to capture the animal and bring it in for testing. There was an individual that died from rabies in Boise County last year.

It was said that a budget would be posted on the Central District Health website page.
