Lyndel Strong welcomed everyone out to the Boise County Republican Women Candidate Meet and Greet on April 21st at the Boise Basin Senior Center in Idaho City. She said that their organization was formed a year and a half ago and they meet every several months to discuss issues, "but our main goal is to educate voters."

Strong reminded voters of the May 17th Primary Election and said that early voting would begin on May 2nd.

She invited candidates from her list up to the podium to tell those present who they were within a two-minute time limit. At the conclusion of introductions, the candidates were available for questions for the next hour and a half.

Light refreshments were served, including brownies and cookies.





Ryan Stirm is currently serving as Boise County Commissioner – District 3. He invited anyone with questions to come and ask him. "I think most of what I've already done for the county pretty much speaks for itself. If you have any questions about what I have done for the county, I'm more than happy to answer those. We spent a lot of time working on wages, getting wage improvements for county employees. Spent a lot of time getting roads improved. We're paving a mile of road a year now." He added that they have a pretty good plan in place to hopefully continue with the paving projects in the future. "As a county commissioner, I will continue to keep those things rolling as we have in the last few years. Thank you!"



Lindy Lindstrom, Commissioner Dist. 3 candidate, has a ranch in Horseshoe Bend. He is a fifth generation Boise County resident. He has been married for thirty-one years to his wife, Lisa. They have three children and four grandchildren. "Boise County was a great place to raise our kids. It's been a great place for my kids to raise their kids, and my goal is for my grandchildren, for it to be a great place for my grandkids to raise their kids. I've been timber-falling since I was eighteen years old, so I'm very aware of our roads in Boise County. And we need to fix our roads. We need to help and support our first responders. I support anything that helps our next generation, and keeps the youth engaged and growing." Lindstrom says he's more of a listener and a doer than a public speaker. "So, I look forward to

listening and serving the rest of Boise County."



George Butters, Commissioner Dist. 3 candidate, said he worked in the transportation business for thirty years, and was a bus driver supervisor. "So, I've got a lot of experience in working with people." He is currently the Fire Chief for the Placerville Volunteer Fire Department and also on the Placerville City Council. "I'm community service oriented. I'm doing it for the community." He would like to improve the roads, property taxes, and the emergency services in Boise County. "Especially, make sure that our school buses can get up and down these roads in bad weather. Growth is a big issue. We're not going to be able to stop growth. No matter what anybody else says, but we can manage growth." He's concerned with the planning and zoning in this county. Butters explained what was important to him, "Listening to what the residents want, instead of having the companies coming in saying, well, we're going to do this. No, we need to take control of that."



next few days. Prisco has been a CPA [certified public accountant] for over thirty years. She is in her twelfth year as Boise County Clerk, since 2011. Prior to that, she worked with an international accounting and auditing firm, "and that's what provided me with strong financial and auditing skills." Prisco spoke about the Transparency Project, "I'm proud to say that Boise County is one of eight pilot counties, that we're working with Brandon Woolf and his team at the State Controller's Office. So, it's very exciting, what they're doing."

She then provided a background on the many roles of a clerk: Clerk of the District Court, Recorder, Auditor, Chief Financial Officer. Chief Elections Officer, and finally, Clerk to the Board of County Commissioners. "I have additional responsibilities beyond that, designated as a County Risk Manager and Human Resources point-of-contact."

## BOISE COUNTY COMMISSIONERS Transcribed by Eileen Capson

### April 26, 2022

**Present:** Commissioners Steve Twilegar, Ted Holmes, and Ryan Stirm (via phone).

### Pledge of Allegiance

**CONSTITUENT INPUT:** Geoff Schroeder, candidate for State Senate, from Mountain Home, introduced himself. He represents sixteen cities across Idaho as their attorney. He's the main prosecutor for Mountain Home.

Steve Moore of east Boise County had concerns regarding the needed update to the Boise County website for the legislative and commissioner's districts. He said it still had not been done, "and we get comments from people in Wilderness Ranch that they have no idea that they are in District 3."

Treasurer Gina Turner and Clerk Mary Prisco said they too pulled up the map and it is correct under the Commissioners' page. Moore clarified that it was under the Elections Division.

MINUTES: Commissioner Holmes said, "I have an issue with the minutes. I'm not going to approve any more until I see constituent input on there." Clerk Prisco said, "I don't think that's accurate. If someone speaks during the constituent input time..." Mr. Schroder injected that he spoke last time. Holmes said, "It's not on here." Chairman Twilegar said, "Well, we need to probably review, obviously, better."

**POLLING PLACE:** Commissioner Twilegar motioned to approve the agreement for the polling place at the Lowman Emergency Services Station, #80.

MASS GATHERING: The Idaho Road Rally was discussed. Curtis Dill with the Road Department said they were going to work on the watering of the roads to keep the dust down, because there were some complaints. The rocks being kicked up were also a problem, so they are going to run a grader. They will work on further plans for next year. Commissioner Twilegar motioned to approve the permit application for the Idaho Road Rally. All were in favor.

**OLD EMMITT ROAD:** Dill said they are paving two miles of road to fix some problems, but the paving will end a half mile short of the landfill, where 95% of their problems originate. He asked that the board approve that little section while they are there paving. "It would save us a lot of problems," said Dill. It was anticipated to take another \$70,000. Commissioner Holmes asked which funds that would come out of and Clerk Prisco identified which funds were available and their amounts.

Commissioner Holmes asked regarding any other paving projects this year, and Dill responded that they were looking to pave the first mile of Alder Creek.

Chairman Twilegar asked about the piece from Placerville to Centerville Road. Dill said he was trying to prep for that for next year. He wants to get some engineering studies for Centerville Road.

IDAHO CITY STREETS: Tami Claus, Idaho City's Supervisor for Public Works, said there's a large amount of traffic, tourists, trucks, and buses on Montgomery Street. "Main Street is really in bad shape," Claus said. She asked for help in taking care of the streets this year, "maybe providing trucks and asphalt. We'll do all the work."

Chairman Twilegar said, "I would love to. I think it's more of a legal issue than anything." Prosecutor Adam Strong said, "I'm not saying that you can't do it. I think it's a policy decision from the board. But I just want to point out to the board that there have been other cities in this county that have requested help with their roads."

Claus said she had combed through the meeting minutes from 1994 to 2000 and nowhere in there does it say the city owns that road. She said that city minutes back in 1979 state, "this is a county road. They've always helped us. We've done the work. They've helped us with everything else." She said the county bought the signs there, even the culvert, and the city did the work. "It is a county road," she repeated and provided copies of the city minutes.

Holmes stated they were also down in their number of personnel. Assessor Chris Juszczak was asked to join the meeting and he stated that the road most likely belonged to the county, because they never deeded it to the city. Claus said the area that needed work was Montgomery Street, just past the Prosecutor's office. It would be less than a quarter of a mile. They will be "cutting out the bad spots," and not doing the whole street.

**FUEL BIDS:** Commissioner Twilegar said, "I think this is something we should do, especially with the price of gas. We would be paying a premium for it." The bid documents had a deadline of October 1<sup>st</sup>.

**PLANNING & ZONING COMMISSION:** Chairman Twilegar motioned to remove a member from the commission and was approved.

The member had been tending to his father out-of-state and had a long absence, then asked to be removed from the board.

**ROAD RALLY:** Twilegar motioned to approve the agreement to provide law enforcement services and traffic control for the Idaho Road Rally 2022.

**GRANT:** Commissioner Twilegar motioned to accept a grant in the amount of \$6,697. This passed.

LITTERING ORDI-NANCE SUMMARY: Prosecutor Strong stated that two

**EXECUTIVE SESSION:** Closed session to discuss pending litigation. [Time 9:57 am to 10:03 am] Coming back into session, Twilegar said there was no action at this time.

**EXECUTIVE SESSION:** Closed session to discuss the hiring of employees. [Time 10:03 am to 10:12 am] Twilegar said no action was required.

**MINUTES:** Twilegar asked Holmes if he was "satisfied with the minutes" and then motioned to approve the minutes from April 19<sup>th</sup>. All were in favor.

JUVENILE JUSTICE: The department will be putting on movie nights this summer in Idaho City and Garden Valley. Horseshoe Bend has their own program. Amanda Leader said they are also trying to form a Boise County Health Coalition. She said there were more cases.

**ROAD DEPARTMENT**: Curtis Dill said they are still working on the Banks Lowman Road near Lowman. They have prepped Old Emmett Road and have started prepping the first section of Alder Creek Road. They are also getting a lot of road material on the gravel roads. They hope to get dust abatement going at the end of May.

**EMERGENCY EXER-CISE:** The countywide exercise is planned for May 14<sup>th</sup> near Placerville. There will be a live burn on private property. Forest Service will also attend.

## **City Council Meeting in Idaho City**

**IDAHO CITY** -- The Regular meeting of the Idaho City Council was held on April 27, 2022 at 6:00 p.m. All of the councilmembers, David Martin, Tom Secor Jr., Ashley M. Elliott, and Mari Adams were present along with Mayor Ken Everhart.

The Pledge of Allegiance was said, the minutes were approved, and the council paid **bills** in the amount of \$7,704.93.

Beth Wilson, representing the Idaho City Historical Foundation, presented a checklist for the Yard Sale of Historic Proportions, which will be held on May 28-29 in the City park. Individuals can join and sell their own items with a vendor's license. The Idaho City Community Club will be selling hot dogs, chips, and drinks. Music will be available, and the Historical Foundation will be selling alcohol.

On the **4**<sup>th</sup> of July following the parade, the Declaration of Independence will be read by individuals and there will be non-profit organizations selling snow cones, beer, and refreshments. The city councilmembers approved all these items and passed an alcoholic variance for the events.

City Ptak presented the city

with a **Life Insurance proposal.** Currently the City is paying \$64.80 per month for \$20,000 life insurance for full time employees. The proposal will now be for an additional \$4 per month and will add the mayor and city councilmembers and the increase will be to \$25,000. The councilmembers agreed to this and made a motion to approve it.

Under ordinances and resolutions, the councilmembers approved **Resolution #2022-02** which is the financial controls policy, this has been examined and approved by City Attorney Joan Callahan.

**Ordinance # 368** is a zoning correction and map amendment for Mores Creek Crossing Subdivision. There have been two readings and it will be put on the agenda until it passes.

Under Committee reports, Rhonda Jameson said that the **Historic Preservation Commission** would like to bring back a **Clean-up Day** for Idaho City, even if this was only using trucks to get rid of dead trees and garbage. She is working with Chief Otter to resolve code infractions on people who have violated Historical site policies.

Lisa Hansen from the **Idaho City Chamber of Commerce** said there is a new board with seven members. Their goals are to refurbish the sign on Highway 21 and put up a "Worship with Us" sign that signifies the different worship centers available in our area. The Visitors Center, BBIA, and Chamber will work on having a better relationship to optimize the space available at the Visitors Center.

Employee Updates: Public Works Director Tami Claus reported that the sewer line on Hill Road needs to be replaced and all the meters that were accessible were read. After some investigation, she reported that Montgomery Street is a Boise County road. She is asking the commissioners to provide the materials and Idaho City workers will provide the labor to rebuild the road. She estimates that it will take two days in May to repair Montgomery Street.

Law Enforcement, Chief Otter has done reminders on code enforcements. There have been a few arrests, one was failing to pull over and trying to outrun an officer. There have been some thefts on the construction sites in Mores Creek Crossing. The suspect was found, and the materials were returned. Chief Otter is currently taking an EMT course.

Clerk Ptak has set the budget hearing date for August 24, 2022 during the regular city council meeting. The budget

will need to be adopted on July 27, 2022. She plans to have meetings with councilmembers following the regular city council meetings and tackle small sections so this goal can be accomplished.

The meeting was adjourned at 7:35 p.m.





Letter to Boise County Voters:

Did you know that once you mail off your absentee ballot in Boise County there is no oversight or transparency in the signature verification process?

This means Boise County Poll Watchers/Challengers will not be granted access to the signature verification process because when a voter's record is accessed, personally identifiable information (Driver's License number, date of birth, or last 4 digits of the Social Security Number) may be shown. Boise County uses the Tenex Solutions software that is not programed to separate out personally identifiable information during the signature comparison process.

When I worked for Boise County during the 2020 Presidential Elections, there were massive amounts of mail-in (absentee) ballots due to the Covid scare. We had a signature verification issue, where in many instances, I could not view the signature on file for the voter to compare it with the signature on the returned envelope containing absentee ballots. The image displayed on the screen was 1/3 the size of a postage stamp making it impossible to view a signature and compare it. The SOS's office was notified and unable to provide a solution in a timely manner. I was instructed by the Elections Clerk and County Clerk to "approve as matched". To this day, I do not know if the problem was resolved. Today the Boise County Clerk and the Secretary of State refuses to allow citizen oversight into the very process that had national implications in the 2020 election, namely, absentee ballot handling and processing.







• Expedite the interim signalization at the intersection of the 55/Banks Lowman until the State constructs improvements years down the road. It will save lives!


