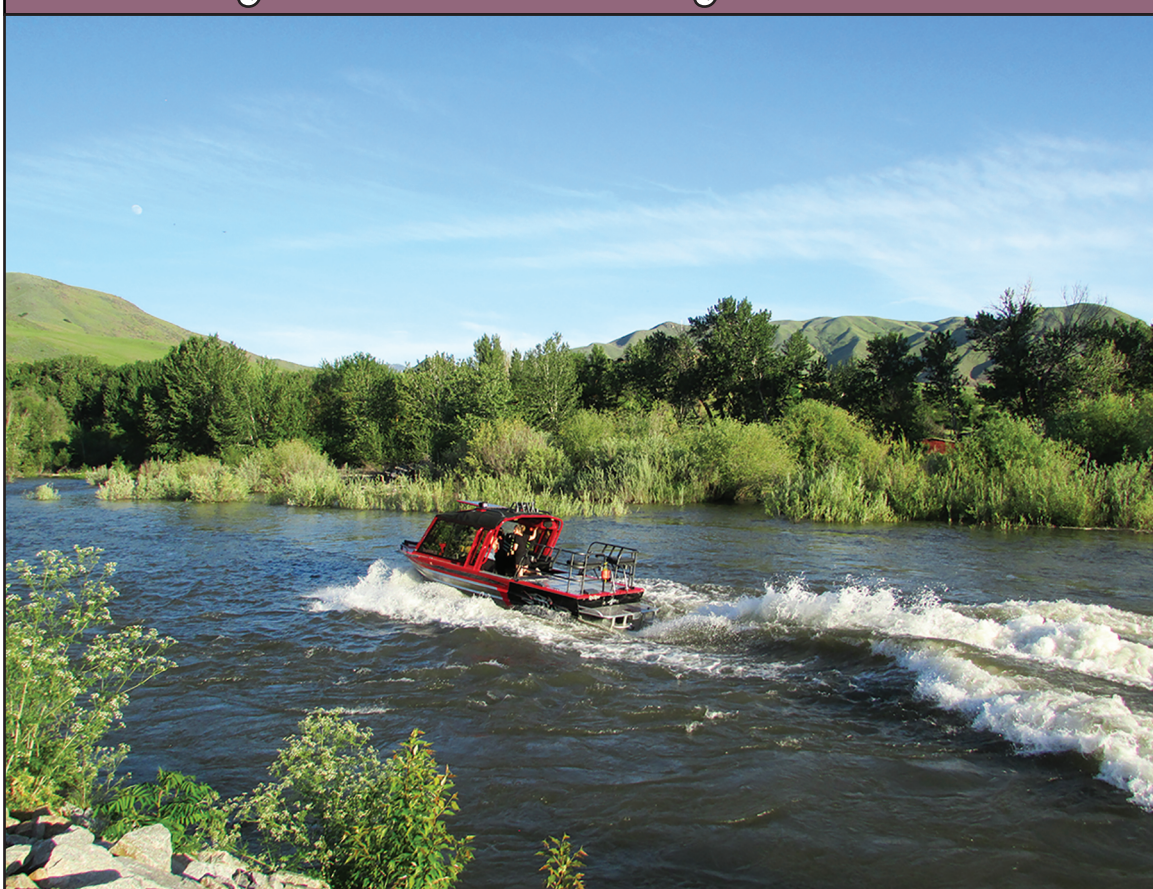

BOISE COUNTY -- On June 2, 2022, a calm sunny Thursday, Keeley Lowrance and her family left her house in the Garden Valley area to take care of some chores. A short distance from her home on the Middle Fork Road, near the Terrace Lakes Community, she saw a common site in the county, a side-by-side driving down the road. The side-by-side, or UTV, stopped at the stop sign but then pulled a burn out, throwing dust up, and continued straight out onto the road. The driver was not looking forward, instead looking at the dust plume behind him and driving on the wrong side

of the road, headed straight for Lowrance. She saw that the driver was not looking in her direction and that there was a young child in the passenger's side. Her so-called "mom instincts" kicked in and she did her best to veer away, but unfortunately, the side-by-side hit her square-on, impacting the front on the driver's side. Lowrance's head hit the truck, and she was left bleeding with a severe concussion from the impact.

The 14-year-old juvenile driver of the side-by-side came over to see if she was alright. The only occupants in the side-by-side were children, neither of which had helmets on. The

Present: Commissioners Steven Twilegar, Ryan Stirm (via phone)

Absent: Commissioner Robert "Ted" Holmes

CONSTITUENT INPUT: None

MINUTES: Chairman Twilegar motioned to approve the minutes from Monday, May 16th, 2022. He then motioned to approve the official meeting minutes from May 24th and the special meeting minutes from May 24th. These were all approved.

BIDS: The HVAC systems in the courthouse were evaluated and a company came up to look at the issues. An individual from

YMC Mechanical spoke to the board about the ducts, intake, and circulation. Clerk Mary Prisco provided information about where the funds would come from in the budget. Chairman Twilegar motioned to approve the bid in the amount of \$8,905 to put in an extra thermostat for the courthouse building and duct work. The motion was approved.

IDAHO GOLD PROSPECTOR'S ASSOCIATION: Asked to do cleanups and to provide signage in a section of Grimes Creek. The clerk recommended that the road department be involved in deciding the appropriate signage. Prosecutor Adam Strong said he had concerns

that the association may want to put signage on the closed portion that belongs to the U.S. Forest Service, so they may need to reach out to them for approval.

ROAD DEPARTMENT: Curtis Dill said they had another letter of resignation this past week, so they are bringing back a seasonal worker because they are short-handed. Commissioner Twilegar motioned to bring back this seasonal worker.

SOLID WASTE: They have a fulltime employee that would like to reduce his time to parttime due to family issues.

PLANNING & ZONING: Commissioner Twilegar said, "Well, Alex is here

to talk about some AEDs. We had a little incident on the street the other day. When you spent a lot of time trying to resuscitate somebody and you want to buy some AEDs." Alex Gross, Planning & Zoning Administrator, presented two different AEDs (automated external defibrillator). He recounted that as he was leaving to go help with the emergency, he was shocked to find that the county offices did not have an AED. Commissioner Twilegar agreed. Gross recommended two AEDs be placed at the most populated buildings, the Miner's Exchange and the courthouse.

Grants for the AED machines were discussed and the goal is to place them in every deputy patrol car.

Sheriff Scott Turner said that they may be able to get a match from St. Luke's because they are in network.

Commissioner Twilegar motioned to spend up to \$4,000 for AEDs for the courthouse and the county building. Commissioner

Stirm seconded it and the motion passed. Twilegar mentioned that another employee of the county had started CPR on the individual. Gross suggested that the county should consider offering CPR classes, along with First Aid.

JUVENILE JUSTICE: Chairman Twilegar motioned to approve the memorandum of agreement to support the community based alternative services program and substance abuse disorder services program. This also passed.

DEMAND WARRANTS: Chairman Twilegar said "wow" for a warrant for solid waste disposal in Horseshoe Bend in the amount of \$22,287.88. He motioned to approve this warrant and the motion carried.

Three witnesses for the court asked for mileage reimbursement, in the amounts of \$138.65, \$103.66, and \$210.82. The motion carried.

Adjourned at 9:32am.

Horseshoe Bend City Council Meeting

HORSESHOE BEND --

The following is a synopsis of the Horseshoe Bend City Council meeting on June 8, 2022. seven people were in attendance for the meeting, along with one Boise County Sheriff Deputy. Two joined in via the city's Zoom link. All council members were in attendance.

Mayor Pat Goff made the call to order at 7:00 p.m, then led the Pledge of Allegiance. After unanimous approval of the agenda, minutes from the previous meeting on May 11, and the authorization to pay the city's bills, Goff opened the meeting with new business.

Resident Larry Beckman approached the dais and asked the council to consider a lot split application for his property located at 123 Locust Street. He stated that he had previously submitted a survey that had been done by Doug Bergey of Bergey Land Surveying, as well as the application. He questioned the next step in the process.

City engineer Amy Woodruff thanked Beckman for following city code and recommended the approval of the lot split to the city. Councilmember Martye White made a motion to approve the lot split, which was seconded by Councilmember Curtis Corvinus. The motion passed unanimously without further discussion.

Also in new business, Mark John took the podium and spoke on behalf of his son, who owns property at 120 River Avenue. He requested that the city allow for the rezoning of

the property from residential to mixed use. He stated that the property was surrounded by a trailer park, the city water treatment plant, a yard full of salvage, and a yard with vehicles in non-running condition. The son wants to build a shop on the property to install solar panels on recreational vehicles.

City attorney Tony Pantera told the Johns that they needed to file a rezone application and a public hearing would need to be held. John said he had completed the rezone application, but City Clerk Gina Elmer said that he only completed a status report, not an application. Pantera said once the application was received, the city would publish it and schedule a public hearing. Mayor Goff told John to turn in the paperwork and that hopefully it could be included on the July city council agenda.

Horseshoe Bend Chamber of Commerce executive team member Kaylene Woods spoke next, thanking the council for the zoning changes on the property located at 382 Highway 55, site of the future Horseshoe Bend Veterans Memorial. Woods thanked the community for turning out for the dedication ceremony on May 30. She said that the chamber has secured \$80,000 in donated materials and time for the memorial's construction and installation. She brought working drawing plans that she shared with the council to use as a starting point on the park that will surround the veterans memorial. Goff said that the park would probably be an action

item on July's agenda. Woods then presented the council with a program from the dedication as well as commemorative cups.

Another chamber executive team member, treasurer/secretary Nicole Cundiff, spoke briefly about the upcoming Casino Night that benefits the Horseshoe Bend Volunteer Fire Department, Swift Water Rescue Team and EMTs.

Department Reports:

Emergency Medical Services: Goff told the council that future plans to build living quarters for the EMTs were still in the works.

Public Works: Both zone generators are up and running and doing great according to spokesperson Michele Brothers. Trees along the levee are being trimmed and the department is working on weed control measures. Public works will be meeting soon with the US Army Corps of Engineers regarding the chain of command of the levee.

Grant Writer: Cheryl Pleak started by telling the council, "I really don't have much to talk about." She said she had anticipated a public hearing for the comprehensive plan that she had previously presented to the council. Goff told her that he was still looking it over. Pleak then offered to answer questions on plans she had submitted for the proposed Woods Veterans Memorial Park. She said that she had heard from someone that the council wasn't interested in her pursuit of a grant that would cover 50% of the park's construction. Goff said that the city didn't have the additional 50% to cover building out the

entire park at once. Pleak asked if the Horseshoe Bend Valley Chamber was now in charge of the park. Goff told her that the chamber was only responsible for the veterans memorial. Pleak said she has been working on getting people to donate a statue, a town clock, and a waterfall feature for the park and then said, "I'm just going to sit down and shut up." Goff suggested that she get together with Kimberly Welsh regarding plans for the park. Pleak told the council that they needed to follow the comprehensive plan zoning for the park, which requires that a sound barrier and fencing be installed, she added that she had done a lot of work on the park's plan. Goff replied, "Okay." Pleak then walked out of the meeting.

City Engineer: Woodruff reported that they were currently working on the loan for the sewer main that was installed on the new Highway 55 bridge. She told the council that the Idaho Transportation Department (ITD) wants to partner with the city on the walking facilities that will be installed on the west side of Hwy. 55 in front of the schools. The project is being funded by a grant from the Local Highway Technical Assistance Council. ITD wants to add curbs and gutters to the project. Woodruff said the inclusion of ITD means the project will not go out for bid this year, but expects it to be on the 2023 calendar. She then advised the council to carefully look over the comprehensive plan and make sure it is a reflection of the community's vision, not an individual. Goff mentioned holding a workshop on the comprehensive plan and Woodruff agreed that it would

be a good idea. White asked Woodruff to further explain ITD's involvement with the pedestrian walking project. Woodruff explained that ITD just wants to expand on the project. White then said, "My trust in ITD right now is very slim." He mentioned the cost overruns for the bridge project and told Woodruff, "Be real careful dealing with them." Goff said that they needed to ensure that the city wasn't contributing any money to the sidewalk project. Woodruff asked the council to make sure the plans for the proposed park included a site for a potential water well.

City Attorney: Pantera said he was working with the Mayor and Elmer on a variety of projects.

Mayor: Goff spoke of the "phenomenal crowd" at the Horseshoe Bend Veterans Memorial dedication and his gratitude for our veterans. The meeting concluded with the council going into executive session to discuss pending litigation.

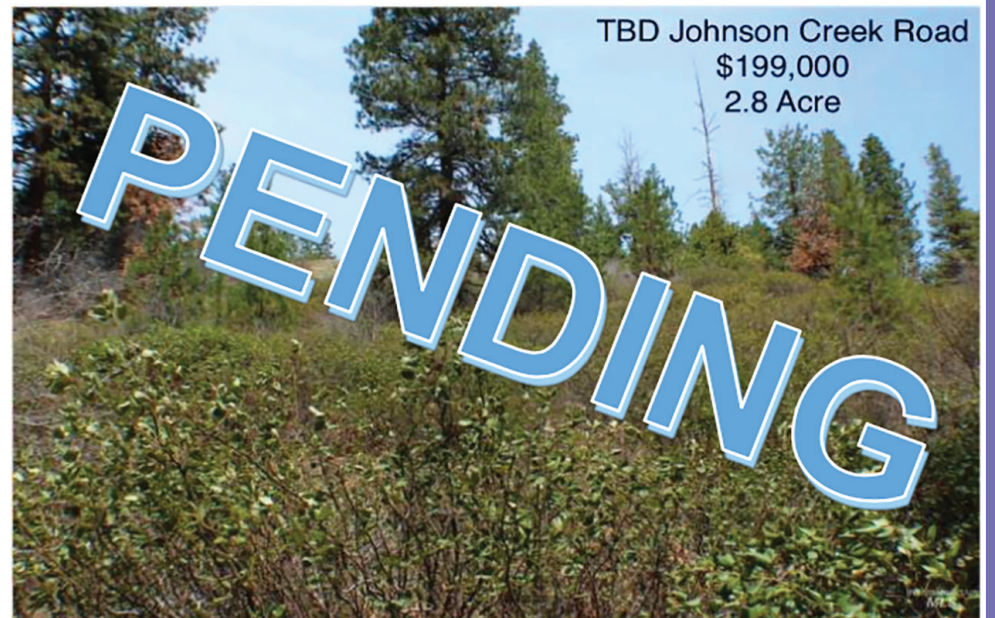

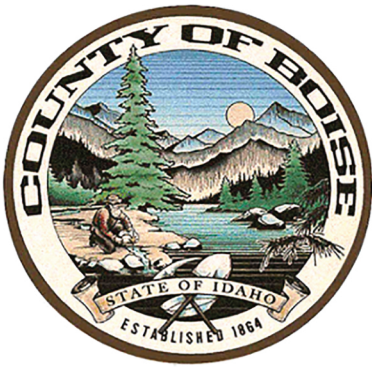
