Commissioners Address Computer Server Failure

BOISE COUNTY -- Elected officials gave an update on the "server situation" on June 2nd during the Boise County Commissioners' meeting. Chairman Steven Twilegar led the meeting, with Commissioner Robert "Ted" Holmes present, and Commissioner Ryan Stirm available by phone.

Treasurer Gina Turner seemed very concerned and explained, "I am waiting, panicking, breaking the law." The county is unable to send out tax statements.

Assessor Chris Juszczak warned those in attendance that the assessment notices would not be going out on time. "We've already notified our attorneys, the State Tax Commission... I don't know how long it's going to take to get the assessment." He recognized, "The only thing that we cannot do is shorten the appeal process."

He's hopeful that the computer software would be "stitched together" using the different backup files, including some corrupted files.

Juszczak said the Assessor's office staff would likely be working 60 hours a week, including weekends, for several weeks to get accurate assessments. He added, "We owe that to the taxpayers."

The IT Director reported, "There's a few things here and there that we're sweeping up -- that we are noticing, but all-in-all, we're back up completely." He talked about a five year plan, getting the right equipment, and that it would take some time.

Clerk Mary Prisco said, "No one could have imagined this, and it's not just the server that's crashed, there are other issues with Com-

puter Arts." According to her, county has received less than satisfactory customer support from the company they purchased software, and had also lost seven days of data that needed to be reentered. She explained, "Many of us were having to use our personal email accounts to communicate." Prisco began to list all of the state statutory deadlines and the budget planning process, and then added, "I don't have any idea on the revenue side what is available for property tax." She indicated that she would be reaching out to the State Tax Commission, "It's huge! I think it's unprecedented."

Chairman Twilegar spoke up, "This is a reoccurring theme and I'm sick of it! The

Computer Arts thing has got to be solved." He would like to form a committee to get rid of the system. "This is not

a company we want to be in business with, especially for the money that we're paying them."

SCHOOL SAFETY

BOISE COUNTY -- During the Boise County Commissioners' meeting on June 2nd, Debra Jackson asked "based on the last school shooting," if our schools had a plan. Sheriff Scott Turner said, "All of our three school districts have plans in place, our SROs (school resource officers) are part of those plans. They practice those plans. We do training throughout the year at all of the three different schools for active shooter training." Sheriff Turner said they had done training with students both in and out of school, "and it's worked out very well." He added that all three schools have active shooter plans and mass casualty plans, which are practiced on a regular basis. Garden Valley actually has firearms and a shooting team within the school, among the school staff.

City Council Meeting in Idaho City

IDAHO CITY -- The regular meeting of the City of Idaho City Council was held on Wednesday May 25, 2022. The Mayor, Ken Everhart, and councilmembers, David Martin, Ashley M. Elliott, Mari Adams, and Tom Secor were present. After the Pledge of Allegiance, the approval of the past minutes of May 11, 2022, and paying the bills from May 12 through May 25, in the amount of \$9,849.35, the first item of business was discussed. This was a public hearing on the proposed residential zoning of land to be annexed into Idaho City, which is located at 6 Proffer Lane. The only comment was from Nancy Holbert, a resident, who had a

concern that neighboring properties are not being annexed on the same road. It was verified that there are no properties between 6 Proffer Lane and Idaho City property. A motion was made, seconded, and all councilmembers agreed. Later in this meeting, Ordinance No 369 Voluntary annexation of 6 Proffer Lane, Councilmember Tom Secor made a motion pursuant to Section 50-902, Idaho Code, the rule requiring that ordinances be read on three different days, two readings of which may be by title only and one reading of which shall be in full shall be dispensed with and that Ordinance No. 369 be considered immediately. This was seconded by Martin, Secor-aye, Adams-aye, Elliott-aye

and Martin-aye. Ordinance No 369 will be effective upon publication in the newspaper.

The Engineer's report stated that progress is being made on obtaining water rights. The "water rights attorney" will give a recommendation soon. Mountain Waterworks is requesting a letter of support to access state revolving funds. The Idaho City drinking water facility plant was ranked # 15 overall for the DEQ grant and is preliminarily set to be funded for \$25,000 in grant money to be used to offset the cost of the facility plan. The Mayor and the City Clerk will follow up with the request for \$25,000.00.

Regarding "Old business", the Idaho City Arts Council and the Idaho City Historical Foundation agreed on the real estate lease agreement and did not make any changes to the document. Later in this meeting, Resolution 2022-23 Real Estate Lease Agreement with the Idaho City Arts Council and the Idaho City Historical Foundation was passed.

Under "new business", Boise Basin Interpretive Association, President and Chairman, Rhonda Jameson introduced the new board. Megan Miller is the new treasurer, Anna Foster is the new secretary, plus a few volunteers to run the BBIA at the Visitors Center. Jameson reported that a new safe was purchased for the building, a keyless lock deadbolt system is being investigated to install on the door. She then requested to clarify an agreement per the Visitor Center Plan of Operation with Boise Basin Interpretive Association, Inc. Jameson proposed to allow a volunteer to display "Idaho Lady Hunt-

ers" clothing in exchange for the per diem compensation by committing to volunteering three days per week. And this volunteer might also design a new line of clothing for the Visitor's Center to sell. Jameson indicated that the BBIA would not be able to staff the Visitors Center seven days a week without this agreement. Attorney Joan Callahan clarified that the BBIA would not be profiting off of the City property without the City getting something in exchange and related that the council could vote to waive the line item in the document that would restrict this arrangement, providing that the merchandise is appropriate for the Visitors Center. Resident Nancy Holbert expressed her concern that there could be a conflict with the individual who is profiting. Mayor Everhart recommended that each volunteer contract for only three months so that every three months a different potential volunteer could have this opportunity. Councilmember Ashley Elliott made a motion to allow souvenir items to be displayed and sold at BBIA in exchange for volunteer time donated for a three-month period with the condition that any other Idaho City Business be allowed the opportunity to participate in this exchange. Mari Adams seconded, Tom Secor abstained, Mari Adams-aye, Ashley Elliott-aye, David Martin-aye, motion carried.

Rhonda Jameson will draft a new agreement between Boise Basin Interpretive Center and the City of Idaho City. Attorney Joan Callahan will review the document prior to it being presented to the City Council.

The next item of business was a "Child Pedestrian Path-

way" presented by Nancy Holbert. She would like to have the City of Idaho City sponsor a grant submission to have the crosswalk by the Visitor's Center improved by repainting it and installing a lighted pedestrian-generated crossing signal. The existing pathway located by the Visitors Center should be connected to Main Street. Holbert wants a letter of support that the Idaho City Council is in support of the grant for the Child Pedestrian Pathway and to obtain a signature from the Mayor indicating that Idaho City has agreed to be the sponsor. Councilmember Secor made a motion to allow Nancy Holbert to pursue funding for the Child Pedestrian Pathway and to allow the Mayor's signature on the letter of support. This was agreed to by all councilmembers.

The meeting had updates from Clerk Ptak about water and sewer adjustments that are being corrected. The owner of the Springs properties is requesting Idaho City Water and sewer hookups due to septic system failure and the fact that DEQ will not allow improvements to their septic system. Preparing for additional sewer lines is a slow process. City Council will need to research wastewater capacity to see if this is feasible at this time.

Meeting adjourned at 7:41.

GARDEN VALLEY RADIO HISTORY

GARDEN VALLEY -- Come celebrate their ten-year anniversary on July 2nd from 6-9pm!

Terry Loyd (above) is the radio station manager, goes by the handle "Babe Boomer," and usually is on Friday and Saturday afternoons from 1-5pm. She started her career in radio in Sun Valley in the 70's and continues it now in retirement. She enjoys playing genres in motown and early classic rock and sharing stories about the musicians and the history of the music.

All the DJs who are on the air from 9-1 and 1-5pm Monday thru Saturday appreciate requests during their show, at 208-462-4350. They also share community happenings and acknowledge the wonderful sponsors who keep the station on the air. Friday evenings 5-9 "Youngblood" livens the place up with some heavy metal. Sundays are auto programming all day.

Bob Davis "RC" (pictured - right) is a relief DJ who has been around radio since his high school days. His friend, Al Sharf, persuaded him to get involved with GV's radio. Playing mostly classic rock, he also throws in some country and jazz.

GARDEN VALLEY -- Rex LeFevre, who moved to Garden Valley in 2006 from Northern California, had a dream of bringing radio to our valley. With the help of a group of locals, they began the foundation of what was to come by applying for a Low Power FM license in 2010 - and non-profit status for Garden Valley Communications, Inc.

Terry Loyd, a Garden Valley local with a background in radio, met Rex in 2011 - and shared the same dream of a local radio station. When a raging fire on July 4th, 2012, threatened evacuation of the homes in Terrace Lakes area, "Golden Eagle Radio" launched as a microwatt radio station, to keep the community informed.

In 2014, Garden Valley Community Radio became a

licensed LPFM station, known as KXGV-LP, and increased their power to 100W. The station is supported by generous underwriters, community donations, and an all-volunteer staff. Each DJ does their own programming, offering a wide variety of music and local in-

formation for the residents of the Garden Valley area.

Rex LeFevre passed away in January 2015, but his legacy lives on through his dream, and those that support our unique community radio station, "Broadcasting from the edge of the Wilderness."

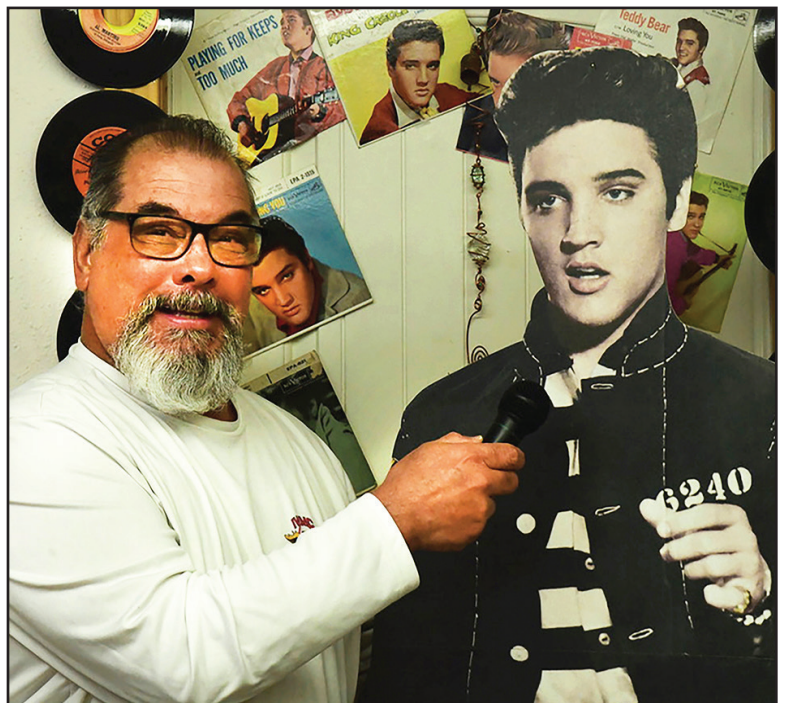

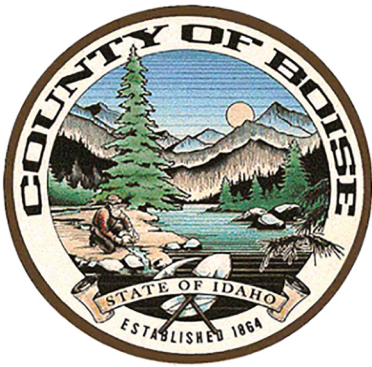
