# Horseshoe Bend Steeped in Rich History

**HORSESHOE BEND** -- As part of the Horseshoe Bend Community School Summer Program, elementary school principal Cora Larson, along with Jess Cooper and Deb Marks, treated members of the community to a Horseshoe Bend Historical Tour on Saturday, July 2. The knowledge they imparted was part oral history and part written works compiled by the Horseshoe Bend Historical Society. They provided a rich history of the area from the time Native Americans lived in the area to the Grimes' Party discovery of gold to sawmill town to current day. The town was originally named Warinersville, in 1865, after the first postmaster in the area. That name changed two years later to Horse Shoe Bend before eventually becoming Horseshoe Bend.

The tour started with a visit to the Gunderson Cabin, which was relocated from the Jackass Basin to the Historical Society's property across from the high school

in 2013. The location of Sonora Mexican Restaurant was formerly Woods Grocery, a barber shop, and 15 Club named for Highway 15, which was replaced by the current Highway 55. The Horseshoe Bend Library sits on what used to be the original four-room schoolhouse. The school was moved to the library location from its original position at the turnoff for the waste transfer station. The Depot next to the Locking Horns Riverside Restaurant was moved from its original place next to the railroad tracks south of the city park, and a Catholic Church once stood where the future Horseshoe Bend Veterans Memorial will be built. The city's main street once graced current-day Boise Street and included a Conoco station and garage, a confectionary store, Quinn's store, the post office, the city park, a bank, the Earl Shelly Cigar Store, Wesco Gas & Oil, Livery Feed & Sale Stable, and a hotel.



The original Horseshoe Bend power plant still stands in its location along the Payette River. Construction was completed in 1903 and the plant supplied power to street cars and the Pearl Mine.



The American Legion Hall was once the Horseshoe Bend Bank Building. Originally a two story structure, the upper portion was destroyed by fire and consequently removed. The bank's safe still resides in the basement.

**IDAHO CITY** -- The fourth week of June was an exciting one for Idaho City area kids and teens, as Mountain Kids Day Camp had another great week of camp. You'll no doubt see many kids walking around town proudly displaying their bright green camp t-shirts. There were 61 campers and about 100 volunteers learning about the Bible and having fun at Camp Ivydale, June 20 - 24. Of the volunteers about half were counselors, and most of those were local teens who volunteered their time to make a difference in the lives of Idaho City kids. Many of the teens were once campers themselves when they were younger, and this was a chance to give back to their community. Campers are ages 6 - 11, and they were "lavished with love for a week."

Campers enjoyed many activities such as archery, pottery, woodworking, exploring electricity, swimming, making a terrarium, and lots of arts and crafts. A spin-art machine made by local resident Floyd Hope was a huge hit with everyone - those pictures turned out beautifully, and each was unique. Ashley Pecora, the Arts and Crafts Coordinator, showed the kids how to make gorgeous colorful tiles painted with ink and rubbing alcohol. On Wednesday, Heidi Ware, from the Intermountain Bird Observatory, came

to demonstrate catching and banding hummingbirds.

MKDC was fortunate enough to have 12 brand new colorful new ukuleles donated three years ago. Retired Boise music teacher Paul Olson came each day and patiently and enthusiastically taught campers and counselors how to play several chords and songs. There was even a "ukulele concert" at the Thursday evening family dinner.

Many local Idaho City area folks helped as volunteers this year. Local adult counselors included Dee Morris, Teri Jo Adams, Chris Heacock, Jenny Parker, Nancy Parker, and Tara Higgins. Joe Sirani and Jim Obland encouraged kids to learn and experiment at the Exploring Electricity booth. Arts and Crafts Coordinator Ashley Pecora led a contingent of volunteers including Natalie Luthy, Katy Temple, Linda Sirani, Edith Smart, Joyce Obland, Jerri Savage, Nina Tong, Cassie Shrader, Sarah Tortorica, Pat Knoble, Kara McCarrel, who did arts and crafts with the kids. Rhonda Jameson led early morning games; Jill Moughamian led mid-morning games and music and guided the campers in making terrariums. Kendra Lanham and Bec Emery helped kids make clay pots on two pottery wheels - a great experience for the campers! Lonnie McDonough enthu-

siastically coached archery, along with Bruce Cooper and Andrew Kalac using the beautiful equipment made possible several years ago by a \$1000 grant from the VFW, and some new targets donated this year by Endless Archery in Nampa. Woodworking, led by Tim Davis and Mike Dynes from Nampa, was very popular this year, with new wood projects including stepstools, napkin holders, and Bible holders. Darcie Altree, from Boise, was our cheerful Camp Nurse. Michelle Audette taught swimming lessons Monday - Thursday, resulting in many kids making significant improvements in their swimming skills. Ray Eklund was the pool manager for the second year and did a great job. It was certainly a team effort with lots of encouragement given to each child! Even though the water was very cold, all the kids really loved the swimming!

The kitchen crew, led by Chris Phillips, assisted by Cheryl Davis and Elaine Olson and several others, made sure the campers had plenty of snacks all week. Cheryl Davis, of Nampa, coordinated the Family Dinner. The Rocks Water donated delicious drinking water for everyone to drink all week.

The excellent speakers this year were from Emmett Church of the Nazarene, Pas-

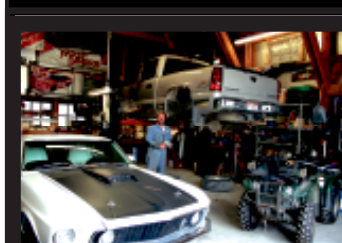
tors Nathan Capan, and Pam Lidik both taught and creatively entertained the children, teens, and adults all week. Lisa Kindelberger and Jill Moughamian led the fun music each day, partnered with dancing and action. Steve Higgins helped each day as Junior Counselor Coordinator, and Howard Henning was Huddle Group Coordinator, which both took lots of hard work and energy. All camp staff are volunteers - and, except for the lifeguard this year, no one gets paid.

One big highlight of the week was the baptism of 7 campers on the last day. Jennifer Alban, Executive Director of The Isaiah Foundation, the non-profit which runs the camp, said, "I really appreciate the support of the parents and community people who have contributed both their time and financial support to make camp happen. This is a huge team effort, and we do it for God and for our local kids and their families."

# BOISE COUNTY COMMISSIONERS

**July 5, 2022**

**Present:** Commissioners Steven Twilegar, Ryan Stirm and Clay Tucker

**Pledge of Allegiance**

**SWEARING IN OF NEW COMMISSIONER:** Chairman Twilegar stated, "Well, because Commissioner Holmes left early, we have the obligation to swear-in Mr. Clay Tucker." Clerk Mary Prisco lead Tucker in the oath: "I, Clay Tucker, do solemnly swear that I will support the Constitution of the United States and the Constitution for the State of Idaho. And I will faithfully discharge the duties of Boise County Commissioner, District 2, according to the best of my ability, so help me God."

Commissioner Twilegar offered Tucker a seat on the Board. The nameplate for Commissioner Tucker should be coming shortly.

**MINUTES:** Twilegar motioned to approve the meeting minutes from June 23<sup>rd</sup>. Commissioner Stirm second and Commissioner Tucker abstained because he was not a sitting board member at the time. The motion passed.

**CONSTITUENT INPUT:** Debra Jackson spoke regarding a parking problem in Robie Creek that constricted the roadway for residents and emergency vehicles. She said Sheriff Scott Turner, "did an excellent job of reaching out to the Army Corps of Engineers and in working with social media and radio, in getting the message out that vehicles would be towed if they were parked illegally. He just did an outstanding job!" Jackson stated that although law enforcement is often a "thankless job" she was there to publicly thank him for being innovative and solving the problem along Robie Creek.

Jackson also thanked the road department for fixing the deep potholes along Robie Creek Road.

Commissioner Twilegar agreed and thanked "the two departments that probably get the most beating publicly." Stirm agreed too.

**RESOLUTION:** A resolution to amend the budget for the Sheriff's office for the expenditures of two radios.

**RESOLUTION:** A resolution to transfer a piece of equipment, a no till drill, to Squaw Creek Soil Conservation group from Noxious Weeds Department.

**BID:** A live auction for the Planning and Zoning vehicle, a 2006 Ford Explorer, was discussed. Twilegar motioned to send the vehicle to auction. The motion carried.

**ASSESSOR:** Chris Juszczak asked to pay out comp time for his employees needing to work overtime, which is in the budget. Clerk Prisco confirmed that department was the hardest hit by the county's server corruption and loss of data. "This is one way that, in our limited resources, we can actually show our gratitude to these people for working weekends and long hours." He said the assessment notices will be in the mail the coming week.

Commissioner Stirm asked what this would do for the Board of Equalization [for residents to refute the costs]. Assessor Juszczak said it would push it back in the timeline.

Commissioner Twilegar motioned to approve compensation payout for the additional time of employees due to computer problems. This was seconded by Stirm and all were in agreement.

**ROADS:** Curtis Dill said they were down four guys, and would be down five guys in a coming week because he is retiring. "We're just trying to hammer what we've got right now. Making it happen." They are doing road patching right now and hope to work on dust abatement next week.

Commissioner Twilegar asked about potholes. Dill said they had two trucks running last week fixing potholes on Montgomery in Idaho City, and Centerville Road.

**GRANTS:** The writer said she was working on everyone's grants, and that there was a lot of money out there. Jackson asked if the board was going to prioritize the grants she was going to go after. Twilegar would like to address that next week.

**SHERIFF:** Sheriff Turner said he spoke with the road department about getting signs out along Robie Creek Road [to warn people that their vehicle could be towed if it were illegally parked].

He said that the 4<sup>th</sup> of July weekend went well and that Monday was the slowest day. Sheriff Turner did say that it was a busy weekend. There was one self-inflicted gun shot wound.

**PROSECUTOR:** Prosecutor Adam Strong said they have also been busy and catching up on cases. "It's not slowing

down."

**CLERK:** Clerk Mary Prisco said she was trying to figure out how they were going to do Board of Equalization and the budget for the county at the same time. She said, "There's all these statutes that guides the timelines for the budgets." Prisco said they would not be able to hold the department workshops as they had in the past because of time restraints. She is looking to streamline the process.

**SOUTHFORK LODGE:** A retail alcoholic beverage license for the Southfork Lodge, with new owners, was motioned and approved.

**DEMAND WARRANTS:** None



Lindy Lindstrom of Horseshoe Bend was also in attendance for the swearing in. He was elected in the Primary election, and will run unopposed in the General Election on November 8th. Lindstrom will be sworn in as County Commissioner for District 3 in the first part of January 2023. He will serve a two year term and was elected with 44.56% of the votes.

**EXECUTIVE SESSION:** Clerk Prisco said they would address pending litigation and risk management under the closed session. [Time 9:23 am to 9:37 am] Coming out of executive session, no action was required.

**PUBLIC HEARING:** The

public hearing for Avimor will be postponed a week, due to a fault on the part of the applicant.

Future agenda items were discussed and the board adjourned at 9:40 am.

They meet again on Tuesday, July 12, 2022.

## WIC Income Adjustments

Idaho's Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) will implement new income guidelines effective July 1, 2022, that raise household income eligibility limits to help offset cost of living increases. This review and adjustment happens annually.

To be eligible for the WIC program, an individual must be a pregnant or breastfeeding woman, a woman who has recently been pregnant, or an infant or child younger than 5 years old. In addition, the individual must live in Idaho, have a need that can be helped by WIC foods and nutrition counseling, and have a low-to-moderate income.

To be eligible on the basis of income, an applicant's gross income (e.g., before taxes are withheld) must fall at or below 185 percent of the U.S. Poverty Income Guidelines. For example, under the new guidelines a family of

three can earn up to \$42,606 annually; under the old guidelines a family of three could have earned up to \$40,626 annually.

If you or a family member are in the categories served by WIC and currently receive Medicaid, SNAP, TANF, or CHIP, you are automatically income-eligible for WIC.

WIC provides nutritious supplemental foods such as fresh fruits and vegetables, milk, eggs,

cheese, cereal, juice, beans and peanut butter at no cost to qualified families. WIC services also include health screenings, nutrition counseling, breastfeeding information and support, help from registered dietitians, and referrals to other services.
