Make the Call ~ 988 Suicide and Crisis Lifeline

988 Suicide & Crisis Lifeline is now available for anyone having a behavioral health crisis

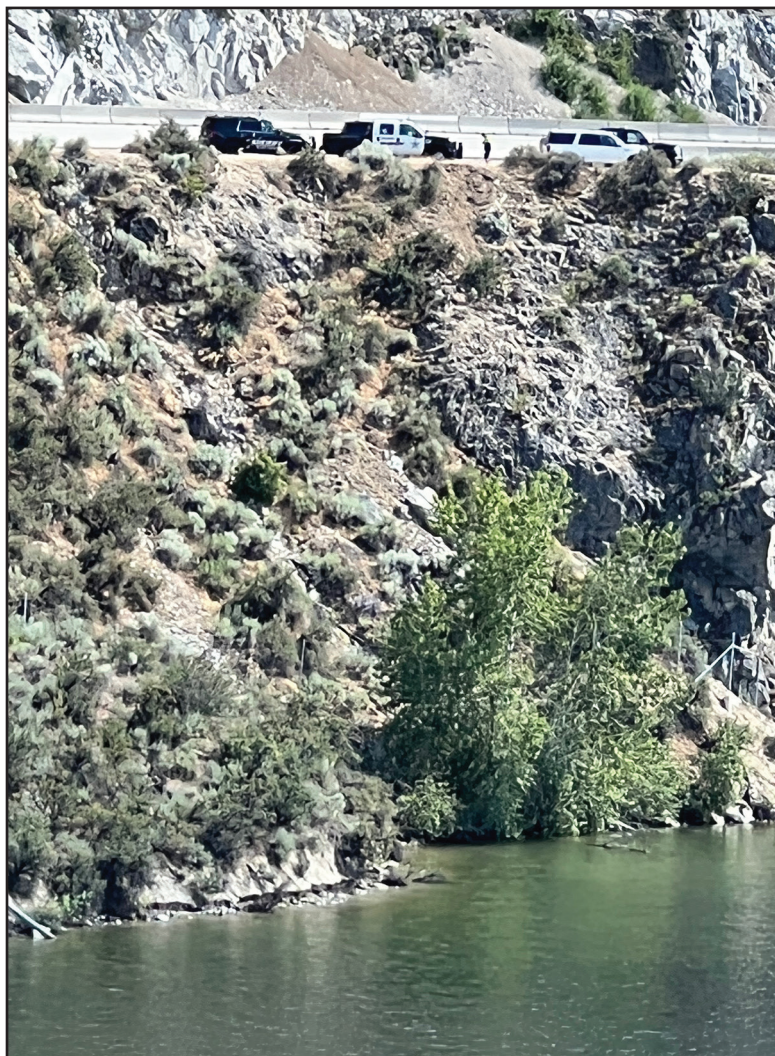

BOISE COUNTY -- Idaho residents can now call or text 988 at any time to talk to a trained professional who can help them through any kind of behavioral health crisis. The new emergency phone number launched on July 16 and is available nationwide.

Anyone experiencing behavioral-health related stress -- thoughts of suicide, mental health issues, substance use crisis, or any other kind of emotional distress — can call or text 988 at any time. People can also dial 988 if they are worried about a loved one who may need crisis intervention.

"This is a big step forward in the improvement of our behavioral health crisis care continuum in the state," said Dave Jeppesen, director of the Idaho Department of Health and Welfare. "988 is easy to remember and will help Idahoans in crisis get connected to compassionate, accessible care and support."

All calls made from an Idaho area code to 988 are routed to a central hub in Washington, D.C., and then re-routed to the Idaho Crisis and Suicide Hotline. The new three-digit number is available in multiple languages for everyone in



On July 17th, there were multiple officers from Ada County that responded to a suicidal woman threatening to jump from the Moses Creek Bridge (the High Bridge), located near the county line.

Boise County Sheriff Scott Turner said that there is a higher percentage of suicidal individuals that come up from the valley, compared to those in-county. However, normally, the officers see a couple of suicides every month and they do have their fair share of mental holds. He also mentioned that jumping from this bridge oftentimes will injure a person, but it's not enough to kill them, especially at this time of the year [with the increased water level]. He would like to see better long term care for mental health issues, and more resources for those in rural counties.

Idaho and the U.S. to call and connect with the existing National Suicide Prevention Lifeline network. Text is available in English only. Veterans can call 988, and

then press 1 when prompted to reach the Veterans Crisis line.

"Idaho is joining states and territories across the nation in transition to the easy-to-remember, three-digit number for the 988 Suicide & Crisis Lifeline. This is a top priority for me and our entire leadership here at the Department of Health and Human Services (HHS)," said Miriam Delphin-Rittmon, Ph.D., the HHS assistant secretary for Mental Health and Substance Use and the leader of Substance Abuse and Mental Health Services Administration (SAMHSA). "I am committed to continued work with our national partners to achieve a smooth transition, and I greatly appreciate the partnership with our state and tribal leaders in Idaho. Thank you to the crisis centers and behavioral health professionals in Idaho who are

working hard at the local level to support people, prevent suicides and save lives."

The national 988 emergency line strengthens and connects the patchwork network of more than 200 locally operated and funded crisis call centers across the country. Previous phone numbers used for crisis in Idaho will continue to operate. People can still call 800-273-8255 or text 208-398-4357, but the same thing is accomplished by simply dialing or texting 988.

BOISE COUNTY -- After almost three years since it was first proposed to Congress, July 16, 2022 marked the launch of a new 24/7 nationwide 3-digit number for people experiencing a behavioral health problem: 9-8-8. This new system takes existing local and national crisis support numbers, such as the Veterans Crisis Line, the National Suicide Prevention Lifeline, and the Idaho Suicide Prevention Hotline, and merges them into a free and confidential behavioral health crisis helpline accessible by calling, texting, or online chat anywhere in the United States. Previous telephone numbers used for crisis support will still continue to operate.

In Idaho, 9-8-8 is managed by Idaho Crisis & Suicide Hotline. Support is available 24/7. Formerly known as the Idaho Suicide Prevention Hotline, the focus of the hotline has expanded from solely suicide prevention to include support for behavioral health problems, such as substance abuse. There are many ways to access this confidential lifeline—call or text 9-8-8 or visit the website at idahocrisis.org to access the online chat feature and find additional resources.

We encourage everyone to program the 9-8-8 number into their

cell phones and please, do not be afraid to reach out for help! We also want you to know that you do not have to be in the middle of a crisis in order to contact the lifeline. If you have concerns or need resources for a friend, loved one, or maybe even a neighbor, you can contact the lifeline. For example, last year we sent a text message to the hotline and asked for referrals for therapists who specialize in working with first responders. Within minutes our request was fulfilled and we were able to share that information with an individual in need.

If you are interested in learning more about resources related to behavioral health services or training opportunities for suicide prevention, we would be happy to share them if you reach out to us. For statewide information on resources and referrals, contact the Idaho CareLine by dialing 2-1-1 or (800) 926-2588, texting 898211 between 8:00am to 6:00pm, Monday through Friday, or by visiting the 211.idaho.gov website.

BOISE COUNTY**City Council Meeting in Idaho City****By Georgene Thomas**

IDAHO CITY -- The Regular City Council meeting of July 13, 2022 was attended by all council members: David Martin, Tom Secor Jr., Mari Adams, and Ashley Elliott through Zoom. Mayor Ken Everhart called the meeting to order at 6:02 p.m.

After the Pledge of Allegiance, the approval of minutes, and paying the bills from June 23, 2022 through July 13, 2022 in the amount of \$30,782.83, the meeting went to the Idaho City Event Checklist for the Jack Pine Round Up. Dan Meyer presented the checklist and said the insurance certificate will be sent prior to the event. Councilmember Tom Secor made a motion to approve the event checklist and an alcohol variance. This was seconded by David Martin and passed by the council members.

The Mountain Waterworks Engineers report was given by Mike Woodworth. He has been working closely with Dylan Lawrence, water rights attorney at Varin Thomas, to secure water rights for the city. They have had meetings with IDWR (Idaho Department of Water Resources) and the Watermaster to identify alternatives for the city to address their water rights issues.

Mountain Waterworks worked with the city to put together a letter of interest to DEQ for accomplishing a "Drinking Water Facility Plan and submitted the letter in January. The final rankings from DEQ came out last month and the City of Idaho City was selected for funding 50% of the cost of the Drinking Water Facility Plan. Mountain Waterworks has submitted a contract for the scope of the work. The last facility plan was completed in 2009. The facility plan will need to be current, less than 5 years old, in order to attempt to obtain funding for any new projects. Councilmember Tom Secor made a motion to allow the mayor to sign the contract with Mountain Waterworks to move forward with the Drinking Water Facility Plan, Councilmember Mari Adams seconded, 4 ayes.

AMENDMENT FOR CLOSEOUT OF THE DRINKING WATER PROJECT. THIS AMENDMENT PROPOSES TO TRANSFER THE REMAINING DOLLARS IN THE SRF ACCOUNT TO COVER ENGINEERING STARTUP

COSTS. THERE IS NO NET COST TO THE CITY, AND MOUNTAIN WATERWORKS WILL WRITE-OFF THE AMOUNT OF TIME INVESTED BY ITS STAFF WHICH EXCEEDS THE AVAILABLE FUNDING.

Mountain Waterworks submitted an amendment to closeout the Drinking Water Project by having the city transfer the remaining money in the SRF account to cover the startup costs. Mountain Waterworks will write off the remaining balance.

Councilmember Tom Secor made a motion to authorize the Mayor to sign the amendment for closeout of the Drinking Water Project by Mountain Waterworks as proposed, seconded by Martin, 4 ayes.

Old Business included a request to extend the city sewer infrastructure to The Springs. Kurt Gindling, representing Jessie Pearson, owner of The Springs, presented the information that they were given a warning from Central District Health that if the septic system fails, The Springs will not be able to make any repairs or adjustments to the septic system or replace it. When the septic system fails, the business will be shut down until a solution can be reached. They would likely need to have the city sewer system extend further down Highway 21 to include their business. They would like the City to supply a written statement indicating if extending the sewer line is feasible and if it is in the future plans. The owner of the Springs is willing to donate land for the lift station and would help to secure grants for the funding.

Councilmember Tom Secor addressed the issue, stating that when The Springs was designed around 2012, the owner of The Springs knew that the septic system was a problem. The mayor at the time reached out to Boise State to design the project. The city paid for the design, which included the lift station, but at that time The Springs did not want to pursue that avenue.

Mike Woodworth from Mountain Waterworks stated that the City received a new wastewater draft permit from DEQ which allows it to do the reuse that it is currently doing. There are some compliance activities to evaluate the impacts that the wastewater treatment plant and process is having on Mores Creek and the groundwater.

Mayor Everhart indicated that the city's wastewater plant is nearly at capacity and the city is working on plans to expand but it will be a long process.

Gindling asked if there were plans in the future to extend the sewer lines down Hwy 21. Mayor Everhart replied there have been discussions to expand the city sewer lines. If a property is within 1000 feet of the sewer line, then they need to access Idaho City sewer services. If the sewer line is extended to The Springs, it would need to be understood how many homes would also need to connect and how much this would impact the current infrastructure.

Woodworth, City Engineer, suggested the City apply for a planning grant for wastewater from DEQ for next year in order to move forward with the research on this project. The Springs and the city could work together with a cost-sharing agreement for the project. The DEQ grant applications are due in early January and results of awards are available around June.

Plans for the original design for sewer lines at The Springs were filed with DEQ and Jessie Pearson should inquire about getting a copy of those plans.

Gindling also asked that the Clinic Building which is owned by The Springs would like to hook up to city water. It was previously determined that the Clinic Building can hook up to city water once the water moratorium is lifted. The council previously approved the work to connect to the city water and this can be started at this time. Public Works Director Claus will inspect the work upon completion.

At 6:19, the mayor, all councilmembers, Dylan Lawrence from Varin Thomas, and Mike Woodworth from Mountain Waterworks joined an executive [closed] session. This was held to discuss the acquisition of an interest in real property and to communicate with the council about the imminently likely legal proceedings under Idaho Code Section 74-206 (1) (c)(f). This lasted until 7:08 when they returned to the city council meeting.

Under Employee updates, Public Works Director Tami Claus reported that her crew replaced two fire hydrants, and they have plans to replace two more and "Digline" will be

called. MAG, for dust control, will be applied to the street on July 20, 2022. Most of the streets will be treated at a cost of \$10,500.00.

Under law enforcement updates, Chief Otter reported that summer has been busy. The Forest Service does not currently have law enforcement personnel, so the city is being impacted by crimes occurring.

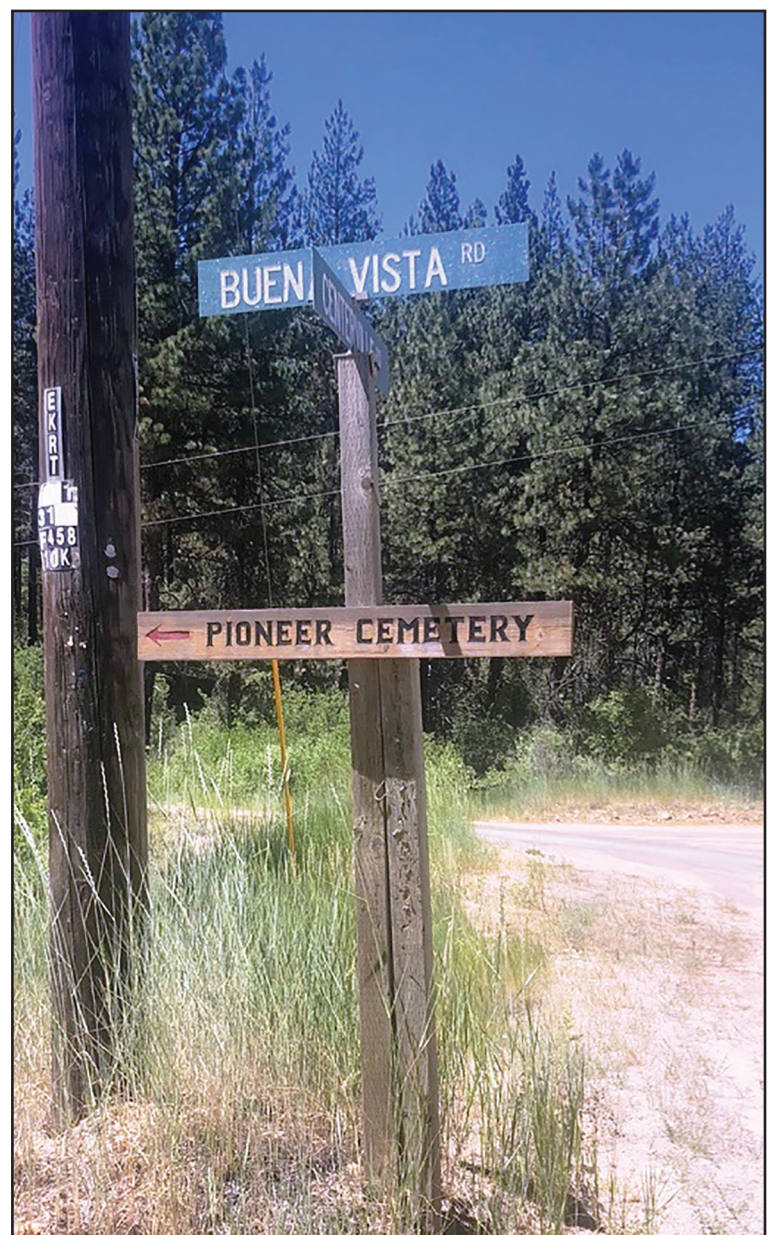
The signage for the patrol car is complete and will be installed soon.

Chief Otter is attending a conference and will be informed about what grants are available for purchasing speed limit signs and to fund extra patrols.

Budget updates were given by Clerk Ptak, she said the last day to adopt the budget is August 8, 2022, so the councilmembers agreed to meet on August 3, 2022 as a Special Council Meeting to adopt the budget. Councilmember Tom Secor asked for \$4000.00 to be set aside for the water fund for next year to purchase wa-

ter rights. Mayor Everhart suggested that the amount should be \$5000.00 with the addition of homes being built.

Water and Sewer updates were discussed. 108 Elk Creek has previously been notified that there is a large leak on the property. The owner needs to repair the leak. Public Works Director will talk to the owner about shutting off the meter until the leak is fixed. City Attorney Callahan suggested that the City draft and present a formal demand letter to the owner to fix the leak. She also added that she sent a letter to the property owners at 302 Elk Creek Road about the delinquent sewer bill. She has not received a response from the property owner. They have been contacted twice. One more letter will be sent indicating that if they do not begin a payment plan, a lien will be placed on the property. The monthly sewer bills will continue to accrue.

July 12, 2022

Present: Commissioners Steven Twilegar and Clay Tucker

Absent: Commissioner Ryan Stirm

Pledge of Allegiance

CONSTITUENT INPUT: None

MINUTES: Chairman Twilegar motioned to approve the minutes from Tuesday, July 5th. Commissioner Tucker second the motion and the motion carried.

MOTION: Chairman Twilegar motioned to move a dollar per an hour, due to an empty position, to a filled position of an employee in the Assessor's office. Assessor Chris Juszczak said there was enough in the budget. This was approved.

BOARD OF EQUALIZATION: Chairman Twilegar motioned to approve a letter for the "cover letter" that goes for the appeal process. Juszczak reassured that they sign it every year. All ayes.

SHERIFF: Sheriff Scott Turner discussed the Ford trucks that were ordered and now have manufacture dates of August 15th. Turner would like to rotate out three more trucks next year, as budgeted for, and was told by Ford that they need to put in for those trucks mid-July, or they may need to wait a year to get those trucks. The board decided, since no money needed to be put down, to have the sheriff put the department's name on the waiting list.

ROAD DEPARTMENT: Curtis Dill said, "We need to figure out something. I've lost four guys. I've got one retiring, and I've got a mechanic that's looking somewhere else now. I'm just looking at a direction of what can we do? I'm not the money person." Tucker asked what the starting wage was, and Dill answered, "\$16.63." Commissioner Tucker said he was on the Idaho Association of County's website and the starting wage says \$18 and agreed with Dill that the amount needed to be closer. Dill said the issue is mostly from the cost of living increase.

Commissioner Twilegar said he would like to see an eight percent raise across the board for county employees, "just so that we can keep people." He added, "We need to pay our people, there's no other way around it." Twilegar then asked about getting trained on a road grader, "some non-destruction training."

A dust abatement tank was discussed. Tucker confirmed

that it had been budgeted for and would be helpful. Chairman Twilegar motioned to purchase the dust abatement unit for \$15,704. Tucker seconded the motion and the motion carried.

PLANNING & ZONING: Alex Gross pointed out to the board that they had three commissioners on the planning and zoning commission whose terms will expire in August. He asked that the terms be renewed. Commissioner Twilegar expressed, "I hope they all stay."

Twilegar motioned to renew these three positions as planning and zoning commissioners. Tucker seconded and the motion passed.

A new name of a person was presented to the board to sit on the commission.

CLERK: Clerk Mary Prisco said, "We're at least a month behind where we would normally be." She asked that the department heads bring any changes to the attention of the clerk's office by July 26th, including budget requests and operations.

JUVENILE JUSTICE: Amanda Leader spoke regarding tree trimming and radio problems. She presented some quotes for a new vehicle radio. Clerk Prisco recommended that the cost be taken out of the general fund. Twilegar motioned to approve the purchase from White Cloud Communications in the amount of \$2,660.

She also presented a quote for the tree trimming. Twilegar recommended that they go with someone local and offered to provide names.

GRANTS: The grant writer, Nancy presented some paperwork. Prosecutor Strong advised the board about debt. She recommended a "catastrophic preparedness" grant for the sheriff's office. Twilegar was hoping she could draft something by July 29th.

She also spoke about grant money for roads, radios, equipment, and vehicles. Nancy requested that the department heads and commissioners prioritize "what the county needs the most, and then go after it."

Clerk Mary Prisco spoke concerning the Southwest RAC grants that were missed last year because the notification emails were sent to the previously elected commissioners.

RECORDS DESTRUCTION: Commissioner Twilegar motioned to adopt Boise County Resolution 2022-23 for destroying certain records.

AGREEMENT: Commissioner Twilegar made a motion to accept the agreement between the U.S. Forest Service for 2022 in regards to noxious weeds. The motion carried.

CLAIMS: Twilegar said the claims approval was "a whopper right now because we paved the roads." Clerk Prisco agreed, "It is a big one." Chairman Twilegar motioned to approve the claims approval report in the amount of \$946,355.76. Commissioner Tucker received some background from the clerk and explanations, and then seconded the motion. The motion passed.

DEMAND WARRANTS: Planning and Zoning's administrator Alex Gross said that there was a mistake that they caught. There had been a few building permits that were overcharged. Commissioner Twilegar made a motion to refund \$576 for building permit fees, another for \$1,040, and for a building permit that was withdrawn in the amount of \$1,176. There were several other refunds.

OFFICE SUPPLIES: Commissioner Twilegar motioned to approve a demand warrant for office supplies in the amount of \$1,279.

INDIGENT: None

EXECUTIVE SESSION: A closed session to discuss hiring an employee. There was no motion required.

EXECUTIVE SESSION: A closed session to discuss a personnel issue. There was no action required.

AVIMOR PHASE TWO PRELIMINARY PLAT: The public hearing was asked to be tabled until next week, because Avimor failed to put their public notice sign out by the highway. Chairman Twilegar motioned to move the public hearings for Avimor and Howell Vineyard Subdivision to the July 19th meeting.

EXECUTIVE SESSION: A closed session for pending litigation and risk management.

PLANNING AND ZONING COMMISSION: Alex Gross introduced a potential P&Z commission board member to the board of county commissioners. The Board of County Commissioners asked him some questions. Chairman Twilegar motioned to approve Matt Mills as a new Boise County Planning and Zoning Commissioner. The motion was approved. It was said that Mills would be sworn in at a later date. [Mills was sworn in that afternoon at 2:07 pm dur-

ing the commissioner's meeting as a Planning and Zoning Commissioner.]

COMPUTER ARTS: Chairman Twilegar recounted that the software program was probably very good at one time for many of the Idaho counties, but they have sold it off and now "provide almost no support at all. We need a piece of software that talks to each other, from department to department, and we don't have that. We don't know if it exists." He would like to explore other ideas. Assessor Juszczak said he agreed, "We should be in the software business, 100%." Prosecutor Strong recommended putting together a list of the main components used throughout the county under Computer Arts software. Clerk Prisco spoke about the different applications, documenting the weaknesses, etc.

The IT person spoke about other software packages for small counties. He said, "I think we need to set up presentations," from these different companies.

IDAHO STATE TAX COMMISSION: George Brown, the Property Tax Administrator with the Idaho State

Tax Commission, and Shaunna Roeber, consulting appraiser, accompanied him from the commission. Brown said, "We're here to discuss the situation with your assessment notices. Your assessment notices went out a little late." He spoke about "handling the timeline," and later said, "there's not an emergency situation here." Brown offered that after the appeals come in over the next three weeks, every Friday they will process the abstracts from the Boise County Assessor's office. Commissioner Twilegar said, "We've been very fortunate with the low levels of appeals around here." Roeber offered, "Anything you guys need, let me know what days you hear them [appeals], and I can be here for any questions. If people are upset about dates, whatever, we'll make sure they're squared away." Twilegar replied, "We appreciate the help." Brown said, "Mostly we just want to make sure that whatever due process is necessary, it happens."

Commissioner Tucker had numerous questions about the appeals process and had done individual previous research. Adjourned at 2:56 pm.

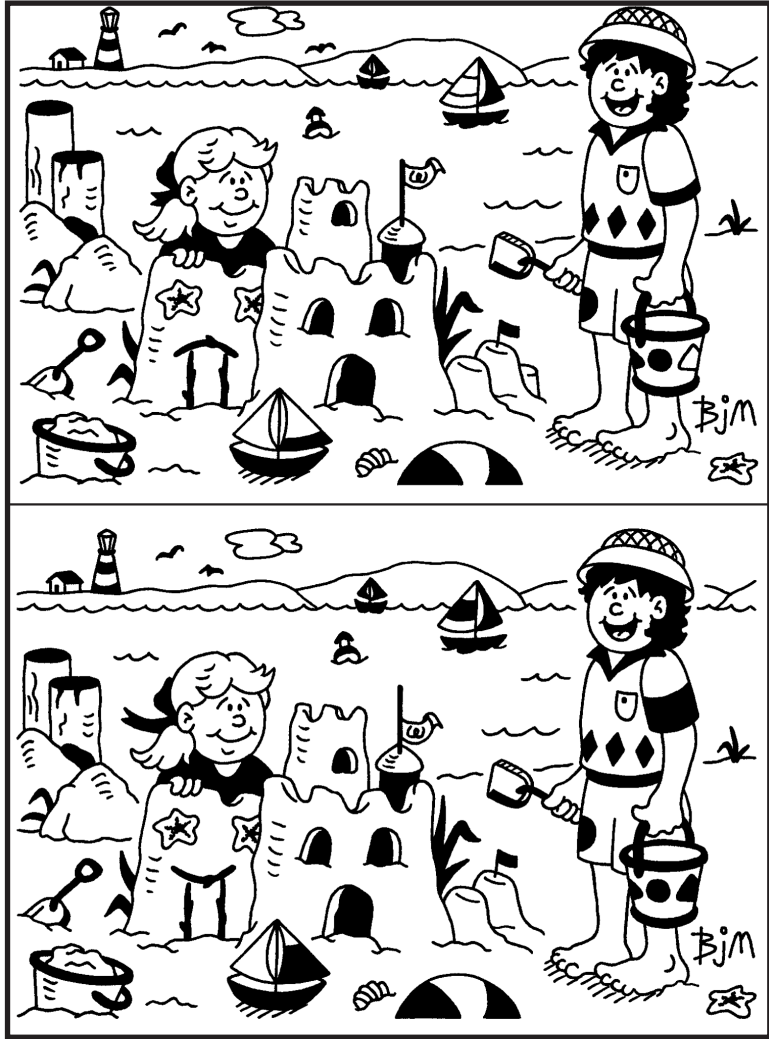

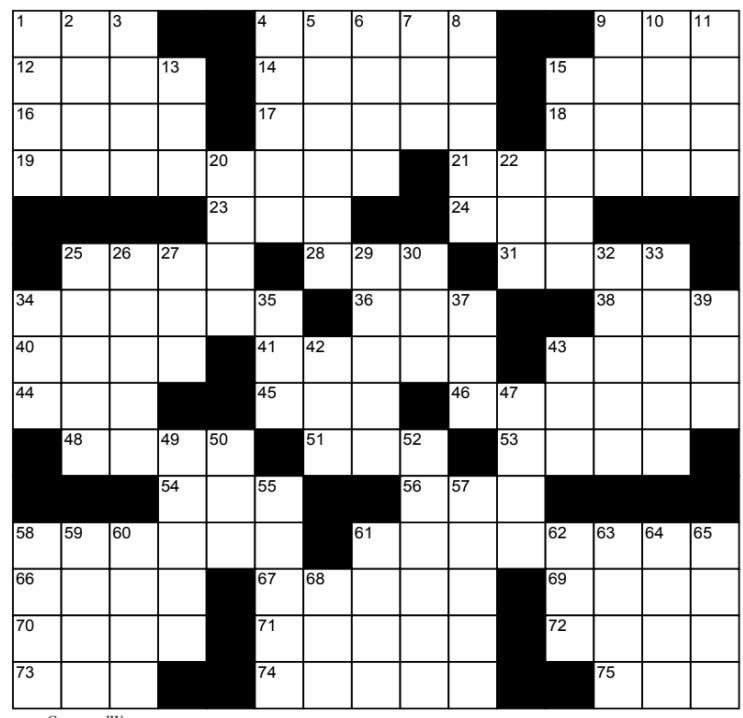

I joined 20+ volunteers (average age is 65+) who give 4-20+ hours of their time and talents each week to sort, process, clean, price, organize, and sell items generously donated by this community. Standing for 4+ hours a volunteer shift, lifting, carrying boxes and bags of donations, moving furniture, and more has taken the place of my gym membership. At the end of our sorting days (Mondays and Thursdays) we all have great satisfaction in knowing the shop is clean, organized, and fully stocked for the next shopping day.

How can you help? The volunteers genuinely appreciate donations that are in new or gently used condition, clean, with no rips, chips, breaks, stains, or tears, with all pieces and parts needed to be usable. Furniture and large items should be delivered during sorting days and when the shop is open for business so we may review, accept, and bring the items inside and keep the front of the shop looking nice. Do we accept all donations? Unfortunately, no. Furniture and large items pose a challenge for available space inside the shop. We do not accept mattresses, box springs, headboards, or large kitchen appliances. Items past their useful life simply do not sell.

How have you helped? Prepare for the Unexpected With a Disaster Go Bag

BOISE COUNTY -- At their rural Idaho home, Darren and Lori Wood pack matches, bottled water, a first aid kit, and ready-to-eat meals into backpacks. The couple isn't going camping — they're preparing for disaster by putting together a "go bag."

The Woods' home sits in the foothills, about 15 miles outside of Idaho City. Knowing that wildfires or other potential disasters can occur without warning, the Woods don't want to leave anything to chance. For them, a go bag is a valuable resource.

"I don't know why you wouldn't have one," Darren said.

Lori agreed. "Especially out of town, up in the hills," she said. "There's only one way in and one way out in a lot of places. So you want something quick to take with you if you have to get out." In addition to having a bag of essentials ready, the Woods keep plenty of fuel in both of their cars.

Having moved from Meridian in 2017, they said the change of environment has helped them to be purposeful when choosing their supplies.

"Living here versus living in town, it makes you really think a little bit and try to prepare more for being a little self-sufficient," Darren said.

During one recent winter, the couple experienced a power outage that lasted 16 hours. "We're on a well," Darren said. "So if you lose power, you lose your water." Even so, they are prepared to shelter in place, using their go bags as "stay bags," which have water packed inside and a 50-gallon plastic drum full of water they keep filled for emergency situations.

Preparing in advance with a disaster-ready kit has helped families nationwide through extreme and abnormal weather events, which experts warn are on the rise.

"Having a personal preparedness plan increases your chances of staying safe," according to a training program from the Columbia University's National Center for Disaster Preparedness.

Lori reflected on how she felt a couple of years ago when they suddenly felt an earthquake. "It did give you a sense [that] something is happening," she said. "But yet, you didn't feel panicked to gather things because you had it."

Darren and Lori sit down twice a year to refresh their emergency supplies. They like to have season-appropriate gear on hand. "Darren has made sure that I have shoes, or boots because I love to wear flip flops," Lori said. "So I have real shoes in my bag, real boots — hiking boots."

The Woods credited their disaster-preparedness to the help they received as Jehovah's Witnesses, both through periodic reminders at their congregation meetings and from tips for putting together go bags on the organization's website jw.org.

"Life is precious, so we encourage all to heed the Bible's advice to take practical steps to protect ourselves from dan-

ger," said Robert Hendriks III, spokesman for Jehovah's Witnesses in the United States.

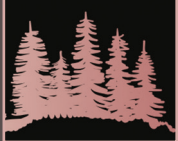

BOISE COUNTY -- The search continues to be ongoing for Milt Alley. He was driving on Thursday afternoon, July 14th, along Highway 17, when at mile marker 1, his truck accidentally went into the Middle Fork of the Payette River. The family has been asking for help in this effort. Special thanks to the local rafting companies, search and rescue teams with dogs, law enforcement, and the community as a whole.

Alley's truck was recover from the river, along with his dog that later died, a backpack was found downstream near Banks, but there has been no sign of Alley.

Boise County Sheriff Scott Turner said on Sunday that everything had been searched numerous times, by water, along the banks, and from the air. An individual that has successfully helped the Boise County Sheriff's Office with missing person cases, volunteered to fly his helicopter over the search area to get a bird's-eye view of the river. Although he had a good view of the bottom, he was unable to see any sign of Alley.

Idaho Power Works Year-Round to Keep Grid Safe, Reliable

BOISE COUNTY -- Safety and reliability are among Idaho Power's most important goals. The company works constantly to maintain and improve the grid to safely deliver as much energy as customers need when they need it.

This effort starts with equipment that meets or exceeds industry standards. The company monitors weather, energy markets and the grid. Inspectors use thermal imaging, drones and helicopters to find equipment that needs to be repaired or replaced.

In areas of high wildfire risk, workers wrap wood poles in fire-resistant mesh and clear vegetation that might become fuel. Crews trim trees to keep them from touching lines, reducing fire risk and improving reliability. The company installs spark prevention units (SPU) and fire-safe fuses — technology that provides around-the-clock protection of equipment on Idaho Power's system. For example, if lightning causes an abnormal increase in voltage, the SPUs protect other equipment on the line from failing and producing sparks.


Idaho Power recently produced a video to highlight some of this work, as well as other measures aimed at keeping the grid safe and power reliable. The results speak for themselves: Idaho Power keeps the lights on more than 99.9% of the time with some of the lowest prices in the nation.
