They also recognized the hard work of various teachers.

A silent auction and live auction were held, in which the proceeds went to help pay for food provided. The remainder went to the Garden Valley Alumni Scholarship fund, which was established around 1979. Graduating Garden Valley seniors have benefited from their continuing generosity ever since.

One of the most famous alumni is Jan Youren, who is in the Cowboy Hall of Fame and was interviewed on the Conan O'Brien show. An autographed picture of Youren was placed in the auction. Auction items varied from plants, pictures, ceiling fans, a miniature piano, to baskets of goodies, and more.

Donnella Faye Savola, 93, passed away peacefully of natural causes on August 2, 2022 at her home of 71 years in Horseshoe Bend, Idaho. She was born on August 12, 1928, in Boise, Idaho to Ernest Alfred and Eunice Camille Cushman Stoops. Ernest worked for the Boise Police Department and was Chief of Police in 1924. Donnella grew up in Boise and Garden Valley, Idaho.

Donnella married Albert Savola in 1948 in Boise, Idaho. They were happily married for 24 years until Albert's untimely death in 1972. Donnella was a member of Grace Lutheran Church, Horseshoe Bend. Nan, as she was referred to by all, enjoyed gardening, reading, traveling, sewing, and crocheting. Most of all she enjoyed spending time with her family. Nan's grandchildren, great-grandchildren, along with her yard and garden were what made her the proudest

Placerville Volunteer Fire Department's New Sign

PLACERVILLE -- On August 8th, personnel from the Placerville Fire Protection District, Idaho City Fire department and the City of Placerville combined forces to install Smokey the Bear at the Placerville Fire Station. The sign was a combined effort with the Idaho Department of Lands, Forest service, and the Placerville Fire Department. Funding for the Sign was provided by Idaho Department of Lands to promote public awareness of the danger level.

On July 1st, the Boise County Burn Ban went into effect, limiting all fires to 3 ft in diameter, and no more than 2 ft in height. The ground around fire must be cleared 10 ft around it and not within 50ft of any structure, with someone over the age of 18 monitoring till it is completely out. "Completely out" means that no heat is detectable when you put

your hand on the burned area. In addition, equipment must be present to extinguish the fire once it is lit.

A violation shall be a misdemeanor, punishable by a fine not exceeding one thousand dollars (\$1,000), or by imprisonment in the county jail not exceeding six (6) months, or both.

We are starting to get into the real danger season now, with the temperatures exceeding 100 degrees, humidity below 20%, and winds picking up. These conditions will put us in what is known as RED FLAG WARNINGS. In the past we have seen fires go from 1 acre to 500 in just a few hours, with evacuations ordered to minimize the risk to the people in the area.

DO YOUR PART AND USE 911 TO REPORT A FIRE AS SOON AS YOU CAN. STAY SAFE AND ENJOY BOISE COUNTY; KEEP IT GREEN.

Present: Commissioners Steve Twilegar, Ryan Stirm, and Clay Tucker

Pledge of Allegiance

MINUTES: Chairman Twilegar motioned to approve the meeting minutes from July 26th.

CONSTITUENT INPUT: None

LIQUOR LICENSES: A motion was said to approve the liquor license for Harley's Pub, 2022 – 2023, Senora Mexican Restaurant, Donna's Place, and a catering permit.

WORKERS COMP: Commissioner Twilegar motioned to approve the premium for August in the amount of \$7,132.

INDIGENT/ EXECUTIVE: None

EAST BOISE COUNTY AMBULANCE: As the board

of directors, Commissioner Twilegar motioned to approve the Health and Welfare subgrant. All were in favor.

BOARD OF EQUALIZATION: The county commissioners convened as the board of equalization. Twilegar said, "The purpose of today's meeting is to hear testimony of appeals, filed and scheduled for this date." Individuals were allotted five minutes to state their case regarding their assessment notice. The appraisers/ assessor was also given five minutes to present their evidence, that the assessed value is correct. Each person was sworn in prior to giving testimony.

One resident from Clear Creek with a home by the creek said, "There's no way in hell that would sell for \$600,000. So, I mean, you guys aren't obviously going to help me, so I

guess we'll just pay the taxes."

After that person left, Chairman Twilegar stated, "Well, I get that people are upset, *but the market is what the market is.* We don't make the market what it is, I can tell you that."

Clerk Mary Prisco said, "The budget is 3%, but your guy's base is this much bigger. So, the levies go down even if the budget goes up 3%."

Taxable values were reviewed with constituents for the remainder of the meeting. Commissioner Twilegar read each of the discussed assessed values, homeowner exemptions, and new taxable values into the record.

BUDGET: Commissioner Twilegar reminded the board members that the amount printed in the *Idaho World* would be the maximum budget they could potentially pass.

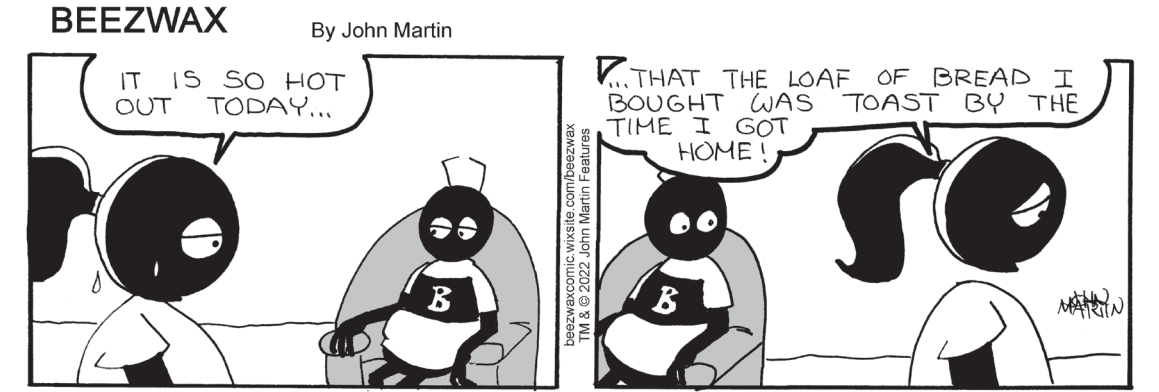
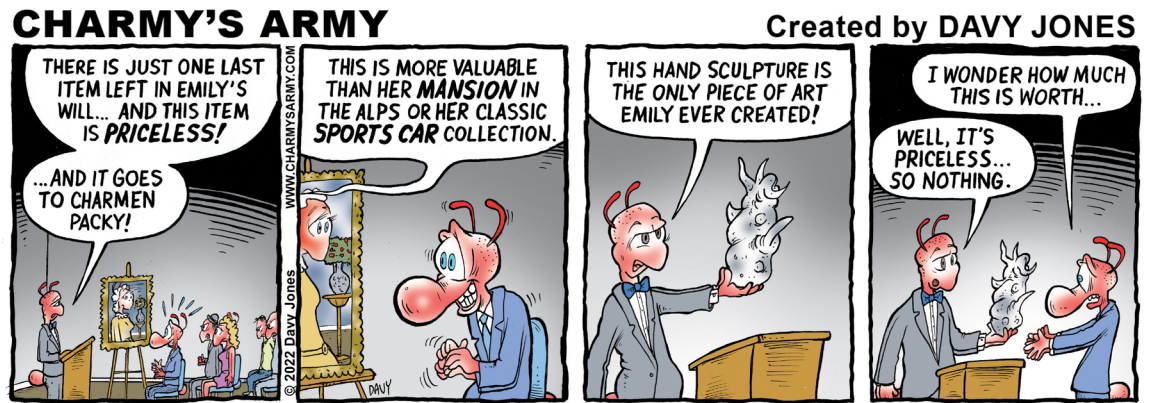
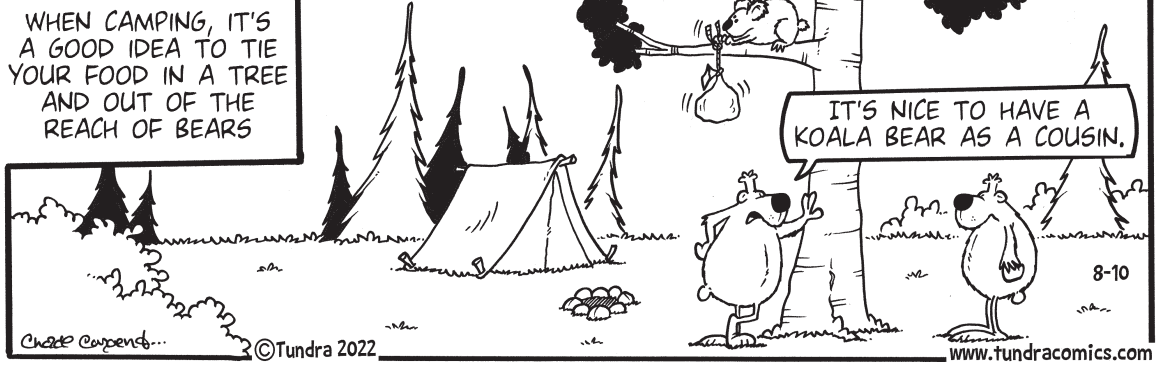

BOISE COUNTY**City Council Meeting Held in Idaho City**

This report of the Idaho City Council Meeting addresses the meeting on Wednesday, July 27, and the Special City Council Meeting on August 3, 2022.

IDAHO CITY -- The regular meeting of the **Idaho City Council** was held on **July 27, 2022**. Councilmember President Tom Secor called the meeting to order at 6:03. Councilmembers Ashley M. Elliott, Mari Adams, and Tom Secor were present, David Martin was on remote through zoom, absent Mayor Ken Everhart.

After the Pledge of Allegiance, it was reviewed that: "74-204 (4) An agenda may be amended after the start of a meeting upon a motion that states the reason for the amendment and states the good faith reason the agenda item was not included in the original agenda posting. Final action may not be taken on an agenda item added after the start of a meeting unless an emergency is declared necessitating action at that meeting. The declaration and justification shall be reflected in the minutes."

The agenda needs to be amended for the following reason: There is a need to discuss immediate or emergency measures to address water levels and water leaks.

Councilmember Tom Secor made a motion to amend the agenda to include item #1 under Ordinances and Resolutions – Immediate or Emergency Measures to Address Water Levels and Water Leaks, Action Item, seconded by Elliott. All ayes, motion carried.

IMMEDIATE OR EMERGENCY MEASURES TO ADDRESS WATER LEVELS AND WATER LEAKS, ACTION ITEM

City Attorney Callahan indicated that it has been a challenge for the water facility plant to keep up with the water demands in the city. She researched whether the city can shut off a property owner's water if there is a major leak on the resident's property. The city can shut off a resident's water for a delinquent bill, but it is unclear if the city can shut off a property owner's water in order to stop a leak. City Attorney Callahan suggested that City Council discuss what should be in Idaho City Code to address the situation in order to allow the shut off of service when there is a water leak on a resident's property. It should take into account how imminent is the threat posed by the water leak and if immediate action needs to be taken

with an emergency ordinance that would give the city the power to affirmatively shut off a resident's water or to limit the number of hours per day that resident's water can be on in order to prevent the leak from creating imminent peril to the city's water plant.

Public Works Director Claus expressed that with the amount of water that is flowing through the water plant she can't clean out the sand bay. She is also concerned that if the water to this resident is turned off temporarily without the leak being fixed, it could cause additional damage to the resident's water line when turned back on, due to the water surge that will occur.

It was suggested that there be an emergency ordinance signed at the Special City Council Meeting on August 3, 2022 to address this issue. Chief Otter will deliver one more demand letter to this resident to inform them that the city will fix the leak, at the resident's cost, on a specified date if the resident does not fix the leak prior to that time.

As the meeting continued, the following reports were given:

There have been no letters of intent for the Parks and Recreation Commission.

Under Planning and Zoning commission, there is not a full quorum at this time. There have been three letters of intent received at this time. Clerk Ptak has been working with City Attorney Callahan to see if the number of members can be lowered from five to three in order to continue to hold Planning and Zoning meetings.

Gary Secor is in the process of annexing his property and would like to obtain a building permit, but the process has been stalled due to the lack of quorum on Planning and Zoning. He is asking to have the city approve the building permit without having to go through the process with Planning and Zoning.

Niehoff property is in the process of obtaining a property split. Clerk Ptak would like to know if these property adjustments can be brought straight to City Council, if there is not a Planning and Zoning quorum.

City Attorney Callahan noted that Idaho law requires the commission to have at least three board members. She suggested that Planning and Zoning should require five members for its Commission, and if there are three filled seats there would be a quorum with two members able to make decisions until the remain-

ing positions are filled. City Council members noted that they would like the number to remain at five commission members.

Executive session was held to discuss the acquisition of an interest in real property and to communicate with Counsel about the imminently likely legal proceedings under Idaho Code Section 74-206(1) (c)(f).

Employee Updates:

Public Works Director Claus indicated that one of the Public Works employees is out on medical leave. Staff members have donated sick leave. On Monday they were having problems with the water plant keeping up with the water demands of the city. A new pump has been ordered. Public Works is having a problem accessing the sewer plant using the easement.

Chief Otter indicated that law enforcement is very busy. There is a plan being developed for emergency procedures at the school. Jon Adams is administering a Tac Med training course for all law enforcement.

Chief Otter had a meeting with ITD. The city can buy solar speed limit signs and be reimbursed by ITD. ITD is offering a program that will pay for a full-time officer for three years. This can be applied for in January 2023 and would begin in October 2023.

Clerk Ptak presented the 3rd Quarterly Financial report as well as the July 2022 monthly budget. Ptak also presented a billing adjustment sheet for water and sewer accounts.

City Attorney Callahan indicated that an additional letter was sent to the property owner with the severely delinquent water and sewer account. No response was given by the property owner. She suggests that the necessary paperwork be completed to put a lien on the property. She also suggested

doing an ordinance change to match the water and sewer code provisions to be able to take a civil action against the property owner to avoid having to put a lien on a property.

Councilmember Updates:

Council President, Tom Secor presented Councilmember Martin with a certificate of appreciation for his years of service. Councilmembers expressed their gratitude. Councilmember Martin said that it was a pleasure working with everyone. He indicated that Public Works needs more money in their budget. He suggested a tiered water billing system.

Citizen Comments:

Jessica Ledbetter - Inquired if she could have a caretaker on her property, living in a motorhome. She was previously informed by Chief Otter that no one can live in a motorhome without access to services. Chief Otter replied that it was possible to have a caretaker live on the property if the motorhome was hooked up to a dedicated city water and sewer line.

She is concerned about an easement on her property that is for access to the sewer plant.

Marc Carignan - Reiterated Councilmember Martin's comment that a tiered water payment system would be a good idea to incentivize residents to conserve water.

Ordinance No. 367 is a concern that is allowing a trailer park on the Cowboy Campground to have four permanent spots that will be hooked to City sewer and water.

Wants to have the following defined in code – Residential Trailer/Mobile Home/Manufactured Home Park or site, Recreational Vehicle Park, Campground. The definitions should include proper site layouts, snow clearing, and water/sewer hookups. He is concerned about unintended conse-

quences for the health and safety of the City. He would like the Ordinance revisited to make sure that it has clear definitions of land use for what is allowed in the City.

The Special City Council Meeting held August 3, 2022

was called to order by Mayor Ken Everhart. Councilmembers Mari Adams, and Tom Secor were present, Councilmember Ashley M. Elliott was present by remote communications, zoom.

The first item of business was to adopt an ordinance to stagger terms for Planning and Zoning Commissions. The property owner contacted Clerk Ptak today (August 3, 2022) at 2:55 p.m. stating that the repair of the leak would be started on Friday, August 5, 2022. The city will

know on Monday if it will be necessary for Public Works to enter the property to fix the leak or to shut the water service off to this property. This ordinance clarifies that the city has authority to enter a property to address water leaks. This ordinance will also give the city the authority to turn off the water to a property that has a water leak that is not repaired after a demand for repair has been made.

Found Deceased ~ Missing Person

BOISE COUNTY – James Daly was reported missing since Wednesday, August 27th. The Boise County Sheriff's office had asked the public to please keep an eye out for this gentleman, because there was a good chance that he was in the county. Deputies searched for several day at lookouts, as well as many well-travelled areas. Sheriff Scott Turner was surprised that with all the people driving on the county roads, no one had found Daly yet.

However, the black 2017 Ford F-150 with a camper

shell was found on August 4th, located off of Centerville Road on an old powerline road, not visible from anywhere. According to the Boise County Sheriff's office, a contractor with Idaho Power had brought in some equipment through the trees to trim around the powerlines when the individual was found about forty feet from his truck. He died of a self-inflicted gunshot wound. There was reportedly no note left behind by the Ada County man.
