Smokejumpers Honored in Idaho City

IDAHO CITY -- The Idaho City Historical Foundation was established in 1958 as a nonprofit organization. Its mission is to preserve, restore, and interpret the history of Idaho City and the Boise Basin. ICHF is supported by donations, memberships, occasional grants, and fundraisers. It receives no annual financial support from city, county, state, or federal governments.

The Strauss House was Kenn Smith's home until the end of his life. He died August 22, 1997, and willed his home on Montgomery to the Idaho City Historical Foundation. Kenn Smith, a longtime member of ICHF, knew that the story of wildfire is a large part of Boise Basin history. His many years as a smokejumper based in Idaho City, combined with Idaho City's long history as a U.S. Forest Service District office, led to the idea that Smith's home could become a place to tell the story of historic firefighting in the west. The museum will interpret this important history and recognize the dedication of many individuals, agencies, and organizations managing wildfires.

From August 12-15, the National Smokejumpers Association held their reunion in Boise, Idaho. One of the side events of this reunion is a day-long field trip to Idaho City. The Idaho City Historic Foundation hosted this field trip, welcoming about 150 former smokejumpers and their spouses to Idaho City. To honor Kenn Smith's legacy and his history as an Idaho City Smokejumper, ICHF decided to open the Kenn Smith Wildfire Museum, along with the other historic buildings in town, during this visit. Food and beverages were also provided by ICHF at the local park.

August 9, 2022**Present:** Commissioners Steve Twilegar, Clay Tucker**Absent:** Commissioner Ryan Stirm

Pledge of Allegiance

CONSTITUENT INPUT: None**MINUTES:** The minutes from August 1st and 2nd were motioned for approval by Chairman Twilegar. Commissioner Tucker second the motion and the motion passed.**PUBLIC DEFENSE:** Clerk Mary Prisco spoke of the renewals of contracts for a public defense lawyer or with a firm.**TAXING DISTRICTS:** Clerk Prisco said, "I think there's a potential that some of our taxing districts [in the county] might also need a little bit more time, because we just – last Friday, early afternoon was when I was able to send out final values to all our taxing districts. Which is something they need, in order to do, prepare their L2 forms." She said if the Board of County Commissioners approve that, then she will send a correspondence to the State Tax Commission.Commissioner Twilegar made a motion to approve this request for an extension for the L2 forms to the 19th of September. All were in favor.**ROAD DEPARTMENT:** Curtis Dill said they were working on dust abatement. There were several applicants that he interviewed. He said it was a busy time. They graded Centerville Road and then were going to work on Bear Run Road in Idaho City. Chairman Twilegar said, "We're getting some good comments about the dust abatement. It's huge!" Dill said, "It will make a big difference. We'll see the biggest benefits next year." The material on the roads is expected to weather better.**ASSESSOR:** Chris Juszcak said they are working on

getting their property tax reduction forms submitted to the state. He said that they only had one open position in his office.

SHERIFF: Commissioner Twilegar turned to the sheriff and said, "Well, you had some fun yesterday, didn't you?" Sheriff Turner replied, "I've got something for executive session under risk management."

He then said the department had two deputies graduate from P.O.S.T. on Friday. One graduated as class president, top academic, and overall top in his class.

Sheriff Turner said, "Other than that, it's still busy."

There is some concern with an old repeater, solar panel, and battery backup. The sheriff will be bringing a proposal for a replacement, but there's a concern that they will not be able to get the items in time before winter hits and there is no access.

ROADS: Commissioner Twilegar made a motion to approve the funds transfer agreement between the United States Department of Transportation Federal Highway Administration to Boise County, to receive \$10,069.68. Both commissioners were in favor and the motion passed.**GRANT:** Chairman Twilegar motioned receive subgrant money of \$12,000 from Central District Health, under an agreement.**REPORT:** Twilegar motioned to approve the claims approval report in the amount 118,798. Tucker seconded and the motion carried.**LIQUOR LICENSE:** There was a long list of liquor licenses that were motioned and approved.**DEMAND WARRANTS:** A couple of building permit fees were refunded.**EXECUTIVE SESSION:** Commissioner Twilegar motioned to go into [closed] ex-

ecutive session under risk management and personnel [with the sheriff]. [9:27 am to 9:41 am] Coming out of executive session, Commissioner Twilegar said there was no action required.

BUDGET: Clerk Prisco spoke about the budget, the economy, and the trickle down of funds to the counties from the state. She said, "We received last week, given this component, we received not quite \$200,000 – oh, \$175,000 or so. So, they are projecting higher distribution from the state this year."**EXECUTIVE SESSION:** Clerk Prisco asked for an executive session for personnel. Chairman Twilegar then motioned to go into executive session. [Time 10:11 am to 10:48 am] Coming back into session, Twilegar said, "no action required."Twilegar said they should reiterate a few items. Clerk Prisco spoke about the Idaho Association of Counties document, "I am proposing, because of the circumstances that we have encountered this assessment budget [inaudible] that we published in the *Idaho World*, which will be in there, it's going to be there this Wednesday, with the tentative budget for the FY2023." Prisco added, "I put a cushion in there so that we will have some additional time."

Twilegar reiterated, "For the record, that's primarily stemming from the fact that we had some serious IT problems and then everything got pushed back, the board of equalization, and now the budget. And what you're saying is, in a normal year, we wouldn't put in any so-called cushion, but we don't want to leave ourselves to where we don't have the operating [funds], in order to operate the county."

Clerk Prisco stated, "So, what I have published in the *Idaho World* in previous years was what the Board of County Commissioners had decided for the budget. So, it's a very clear, concise budget that I'd publish in there in preparation for the public hearing. This year, we don't have that luxury and so, my thought is to put a buffer in there so that we will have some time and then during the public hearing, that's when we can discuss all the changes from what was published down to what we will actually, ultimately adopt, long before Septem-ber 6th for the 2023 budget."

Prosecutor Adam Strong advised that planning a high buffer wouldn't lock them into a higher budget. Clerk Prisco said for the record, "The law is that what you publish, what the taxing district publishes... what you publish into public [view] can only go down, it cannot go up. So, it's not uncommon to publish a budget that is then reduced." She then spoke of the 2021 audit and all of the funds. Prisco referred to the restricted and unrestricted funds in the budget to support the operations in the county.

Chairman Twilegar said they were going to be giving everyone raises.

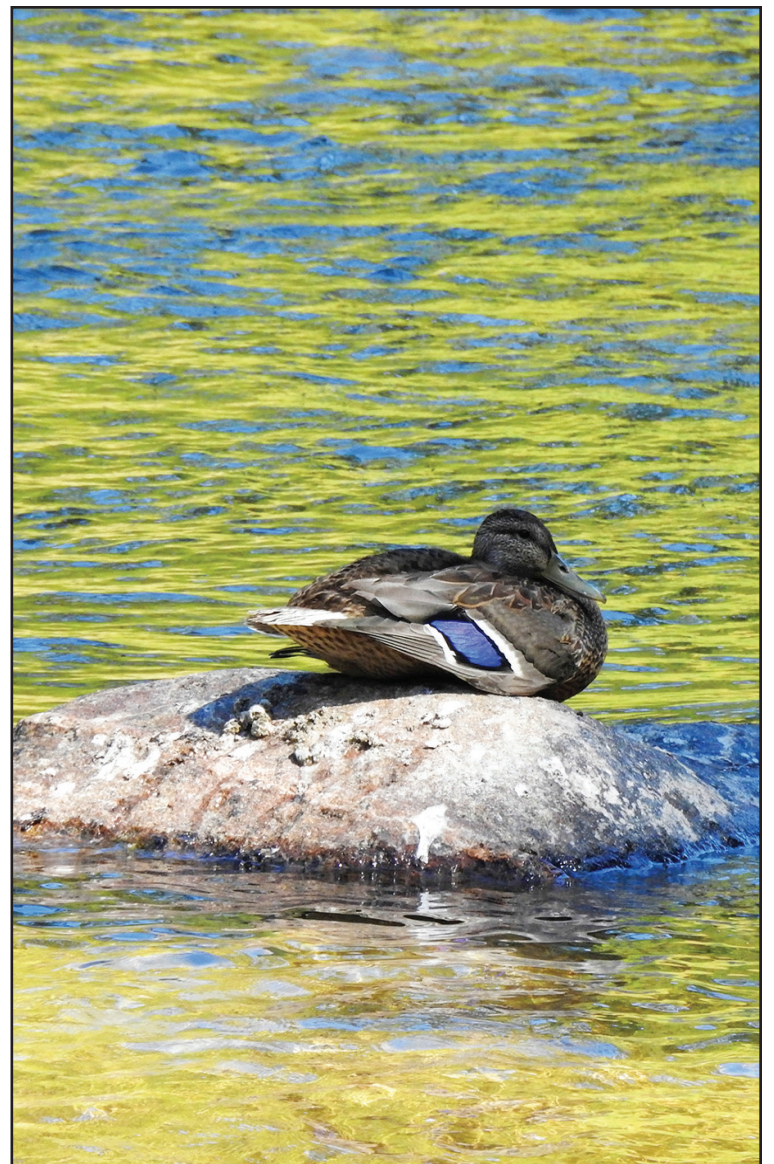
Clerk Prisco said, "I looked at the Department of Labor site and they used the federal consumer price index, the June of 2022 to June of 2021, was a 9.1% increase. I personally feel really uncomfortable with that high a number, but I wanted to get that on paper for you... And then the 8% is what we've been talking about, generally. So, those percentages were applied to the current budget, salary dollars." There

was also an impact to the benefits.

Twilegar pointed out that it has been difficult to get and retain employees, "We're paying literally less than McDonald's for some of our employees. Why the hell would you want to stay in Boise County?" The board has, at the moment, decided to go with 8% raises, but that could change. Prosecutor Strong cautioned, "That is still part of the tentative budget. So, a lot of the department heads here, I would not run out and promise everyone – We're getting 8%!" Commissioner Twilegar pointed out, "This is a goal. We're not saying that anybody is getting 8%, this is what we do in the budget. It's a process, preliminary, this is a pie in the sky, wishing, and 8% is a lot. That's the goal, but for the record, we're not by any means guaranteeing or saying we'll get there. Let's just see."

On Friday the 12th, the board met with the clerk regarding the budget to see it prior to being published in the *Idaho World*.

Adjourned at 11:45 am.

Placerville Fire Prevention District Establishes Out-Of-Area Charges

PLACERVILLE FIRE PREVENTION DISTRICT-POLICIES & PROCEDURES FOR OUT-OF-AREA CHARGES

The State Fire Marshal has determined that the Placerville Fire Prevention District, a taxing district, can charge for services provided. The commissioners of the Placerville Fire Prevention District have chosen NOT to charge residents who live within the boundaries of the Placerville Fire Prevention District for services rendered

The commissioners of the Placerville Fire Prevention District have further chosen NOT to charge subscribers who

live outside the boundaries of the Placerville Fire Prevention District for services rendered. Occasionally, the Placerville Fire Department is toned out to respond to fire, medical, or other incidents outside the service boundaries of the Placerville Fire Prevention District. Residents who live outside the service boundaries of the Placerville Fire Prevention District have the option of subscribing for services but few do.

Accordingly, the Placerville Fire Protection District hereby establishes the following charges when toned out for non-subscribers outside the boundaries of the District

BASIC CALL:

\$3,000.00

HOURLY RATES:

Based on the current Idaho Department of Lands (IDL) cost sheet for equipment and personnel.

MINIMUM RESPONSE:

A minimum of four (4) hours will be charged for personnel and equipment costs for any call for which the Placerville Fire Prevention District charges. These minimum charges will be in addition to the Basic Call charges.

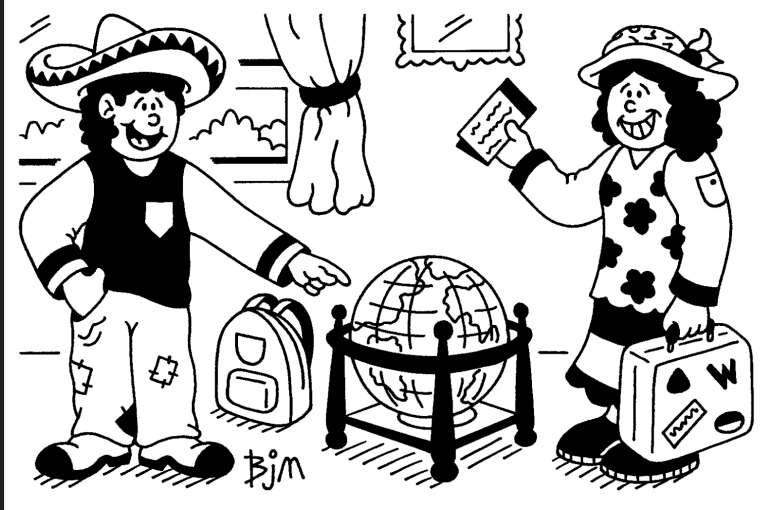

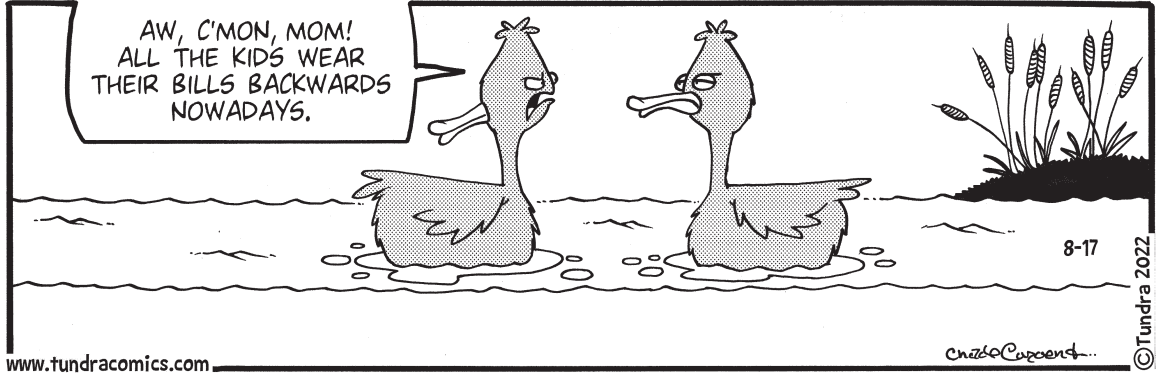

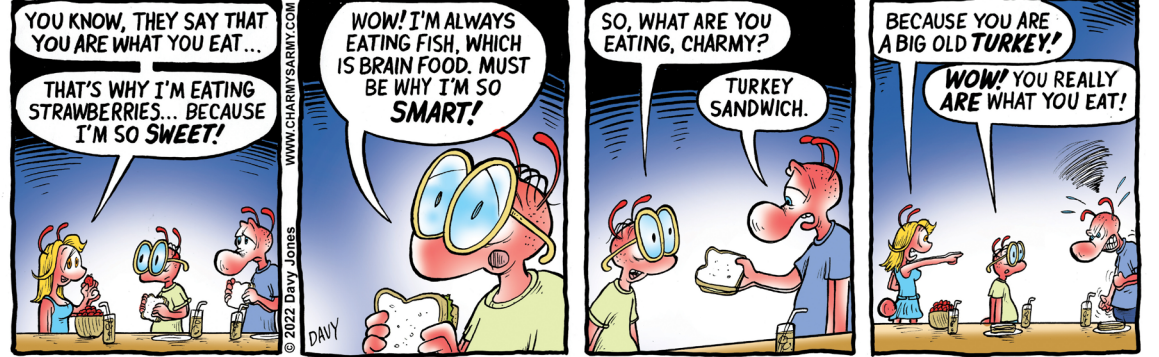

WHEREAS, during that time a special bond was formed between the Smokejumper Unit and the residents of Idaho City and the City is proud to have been a part of the Smokejumper history.



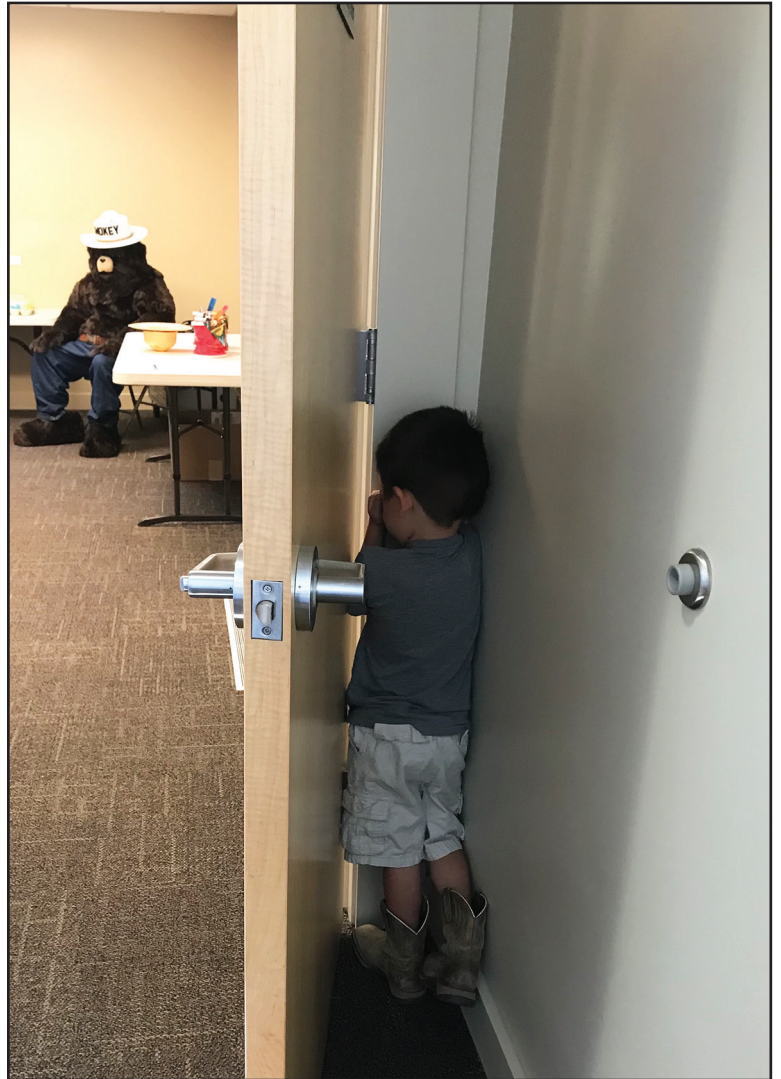

Boise County Deputies were first on the scene, with shovels, they dug a line around the fire, before it had any chance of escaping and becoming a larger wildfire. Nearby campers reported seeing a suspicious vehicle driving quickly away from the area.

The U.S. Forest Service is conducting this investigation and has apparently already identified the vehicle and its driver. This is a federal crime and the case will be tried in federal court.
