County Commissioners Hear Gun Range Appeal

August 18, 2022

Special Meeting and Public Hearing for the proposed Crowfoot Shooting Range in Horseshoe Bend

Present: Commissioners Steven Twilegar, Ryan Stirm, and Clay Tucker

DEMAND WARRANTS: Commissioner Twilegar motioned to approve two invoices. Each were for the Sheriff's office, a total of two 2022 Chevy trucks, at \$49,523.80 each. The motion was approved.

PUBLIC HEARING REGARDING THE APPEAL FOR THE PLANNING & ZONING DECISION ON THE CROWFOOT SHOOTING RANGE: Commissioner Twilegar reminded the room full of people, and those in the overflow, to remain courteous.

Alex Gross, Planning and Zoning Administrator, gave a review of the appeal regarding the proposed outdoor shooting range at the Avimor planned community on Pearl Road in Horseshoe Bend. He recounted that there had been a public hearing held by the Planning and Zoning Commission in October of 2021, and then the matter was tabled to learn more, because there were some concerns brought forth. Gross reported, "On April 7, 2022,

the commission held a public hearing, in which the applicant and public provided testimony. The commission closed the public hearing and all testimony was received and deliberated the conditions that were set forth for you [the county commissioners], as well as testimonies, and approved the application." Appeals were signed on May 3, 2022. Gross provided "a substantial record," contained in two binders, of public comments, both for and against the project.

An attorney for several of the homeowners, Terri Pickens Manweiler, presented their concerns. She said, "There are several concerns about this application, none of which have been adequately addressed... The major issues are public services, public health and safety, fire hazards, sound quality, traffic, wildlife, liability and literally, the overall comprehensive plan." She stated that the Crowfoot Range was to be a 40-acre site with a proposed 115 parking spaces. She estimated there would be fifty shooting stations and two long-range rifle stations. "That means, if you have one hundred and fifteen parking spaces, you could have up to two-hundred people, four people sharing a

station, fifty stations, all shooting at the same time. *That's the possibility.*" Manweiler stated there was no operation plan, no cease fire, no electricity, and it would be an unmanned range. The developer planned on bringing porta potties in, instead of bathrooms, which would be in 100-degree heat during the summer. There's

concern that patrons would alternately use the side of the road, where her clients live. "The design of this shooting range is not in compliance with the NRA [Range] source book in any way. Any human being that has ever spent any time at a gun range knows you don't shoot your rifle into the sun. Yet, that's how this one's designed." Manweiler said the long-range station has the potential to shoot over Highway 55, even though there's a dirt berm there.

She stated there was concern for fire safety and that resources were not just three to five minutes away. The closest fire station is in Eagle, and their drive time is at least ten minutes. The area is known for high winds and there was no water planned to be on this site.

Manweiler then pointed out that a "sound test" would not be required until the construction was complete. There was also no traffic study done.

Mathew Parks, representing Crowfoot Gun Range, said there were fire mitigation plans in the record, and NRA source book information, "This all was provided by my client to demonstrate that they are going to build a safe gun range that is going to meet all of the legal requirements and go beyond that." He corrected that the parking lot was for 70 cars.

Parks said that within the conditions of approval by planning and zoning, many of the concerns discussed earlier were addressed there. There was fire information from the Eagle Fire Department. Parks said the range was going to be vegetation-free, which would be done either chemically or mechanically. He added, "In fact, the Eagle Fire Department has offered to construct the fire break as part of their annual training exercises... There's going to be vegetation pre-burns surrounding the entire shooting range for the short range. For the long range, there's going to be a 300 foot vegetation-free burn along the northeast side. The reason why we can't have it burn the entire length of that long range is because of the topography." He said it actually dips down to a little creek.

He discussed several other conditions of approval, including Pearl Road being widened to accommodate fire trucks. He asked the board to rely on the Eagle Fire Department's approval and to not overturn the planning and zoning's decision.

The land does not have any water rights and will have no water on the site.

Parks then addressed the noise issue and said, "It's kind of hard to have a sound test that

judges the sound that's admitted from the gun range until the gun range is actually in operation. And that is what the Idaho code requires... Once that's installed, a sound test will need to be conducted that meets the requirements of the Idaho code." He said it was a condition of approval and the conditional use permit could be revoked if it failed. Parks said it met the requirements for an NRA outdoor shooting range, that there would be no shooting into the sun glare, because there would be a shelter that will provide protection and the shooting would be done into a 140 foot berm.

There had been no comments received from the Idaho Transportation Department regarding traffic concerns.

Commissioner Stirm asked Parks if he was familiar with the area, and then stated: "So, you know that Eagle Fire has never responded to the top of Pearl Road." Parks questioned, "Never responded to Pearl Road?" Stirm continued, pointing to an individual in the audience, "That gentleman right there [Horseshoe Bend Fire Chief Jeff Johnson], I worked with that man for five years and I can tell you that once you cross the Ada County line and you call 911, you get Boise County. The Horseshoe Bend Fire [Department] is who you should be talking to, not Eagle Fire, because even though they have an agreement that Pearl Road is that line, he has to get mutual aid to get fire people up here."

Stirm then asked if they had contacted Boise County Solid Waste to bring up a bin for trash. Parks replied, "There is no agreement for trash, but obviously, there will be an agreement."

Commissioner Stirm then asked, "Who is going to control access to this property?" The attorney replied that it would be a code that could be "re-changed."

The commissioner then asked, "Are you aware of the process that is required to get a helicopter to fly on BLM [Bureau of Land Management] property in the means of a fire? It's like an hour and a half, minimum." He added, "What I would like to clarify is that there's a fire mitigation plan, does that fire mitigation plan address the fact that, if a wildfire does happen to spark, under any circumstances, that

you're understanding that the Class 3 and above resources are an hour and a half away? You are not going to be able to stop that fire within an hour and a half with Horseshoe Bend or Eagle Fire, because neither one of them is prepared to handle a wildfire of that magnitude." The attorney replied by saying, with the other objectives in place, like no vegetation and a fire break, that "we need to rely on of the professional opinions of Eagle Fire Department that reviewed that plan and had no objection."

Stirm then asked, "So, there's no plan, based on what I have read, to man the range with any type of safety officer or human being, at all?" The attorney said, "That is right, it is going to be an unmanned range." Commissioner Stirm then asked what the largest caliber of firearm allowed on the premises would be. Parks did not have an answer. Stirm reiterated what the lawyer said, that there would be no tracers or incendiary rounds, "which is common sense, but who is going to be there to stop those folks from doing that, if it's an unmanned range?" Parks responded that this was a 501c3 and they did not have the funding to have someone at the range all the time, and it would be a membership range.

Commissioner Tucker had nothing to add at that time.

Chairman Twilegar expressed, "I have serious concerns about not even addressing the operation plan or the safety plan. I agree with you, in the fact that there are people shooting everywhere." He was concerned in regards to the potential fifty shooting ranges, which had no plan for a safety marshal, or volunteer, with a set of rules. "Who knows how many of these people just bought their gun for the first time, or knows how to operate it?" Twilegar expressed that most gun ranges had somebody there that knows how to operate guns, "And I'm not saying that's a deal killer, but I feel like that hasn't even been addressed and I think it should be." Parks said these rules would be in the plan of operations before the range is in operation, and his client wants the gun range to be "a community asset."

The public hearing was then opened to constituents, who were allotted three minutes to pose questions, concerns, or

their support. Several voiced their concerns regarding who would be responsible and available to contact if things went wrong. Another close resident reiterated something he heard on the news, that the partner owner of Avimor would move the gun range to be farther away from their homes, but closer to the existing Horseshoe Bend homes. There was great concern for the sound restrictions and disbelief that they could be met. One individual stated, "Ada County, Eagle Fire District wrote their letter saying that they could do a response time of sixteen and a half minutes. There was a fire on Pearl Road last week. Was Eagle there? They didn't even show up!" She said the volunteer firefighters had to leave their jobs and go up there. There was also grave concern that stray bullets could go over Highway 55.

Jeff Johnson, Horseshoe Bend Fire Chief, complemented Eagle Fire Department and said that they receive some of the best training in the world, "but it's just the simple fact that this shooting range is showing up in the furthest spot in their district, away from them." He said, "There's no way that a sixteen minute response time is feasible." He averaged that HSB Fire received between five and eight fire calls a month, "In that capacity, the fact that there were three different calls already this year that are wildfire related, that we have traveled into Eagle's district - So, Saturday was one of them, just south of Pearl Road." Chief Johnson said his department had even responded near the rodeo grounds, over the hill from Avimor. "Sorry, but I'm not

going to feel confident that if we have an issue up there that Eagle [Fire] is going to be able to make it."

Johnson also expressed concerns for traffic and the double-blind corner, "We respond to accidents on top of the hill all of the time." They have thirteen people on the volunteer fire department, and he considers them lucky if they have five or six respond.

Commissioner Twilegar asked if there were a mutual aid agreement with Eagle Fire, and the Chief was unclear about the conditions.

A veteran helicopter firefighter pilot, knowledgeable of the area, mentioned that there were recently two other fires started at gun ranges. He said, "Let's not make any mistake about this, it's not when, *I can't give you when*, but it will happen. And that is the worst place to have a gun range. Humidity's low, winds are very high, the gradients are high at 4,500 feet. I know all this because we don't even try to stop fires once they're in that area. We'll find a viable boundary that we can back off to, to try to stop a fire." He asked that the commissioners protect their homes, by ensuring this range does not go in.

Another individual in opposition stated, "This is going to be the largest shooting range in Idaho, *the largest*. This is not an understatement." He said to put it up on top of a mountain, with this vegetation, and conditions, was setting up disaster to happen. "Look at George Norris Shooting Range [Caldwell]; it's been on fire five times this year already!"

An individual in favor of the range from Garden City, a former California firefighter, said that the Parma, Nampa, and

Gem County ranges were unmanned ranges. He said there weren't any problem with range fires, but weed mitigation was important.

The public testimony closed and the attorney for the development said this gun range was not new, but approved by commissioners with the approval of the master Avimor development. "I'd also like to note that the range is going to be open to Boise County residents," because Avimor will have over two hundred homes in the area. He said the reason why they went to the Eagle Fire Department, rather than the Horseshoe Bend Fire Department when submitting the application was because "they are somebody who is listed as someone who will provide comments on this." Parks said the jurisdiction is in the Eagle Fire District, and they are working that out. The Crowfoot Shooting Range would be located on private land, 1.7 miles from the closest residents.

Commissioner Tucker asked, "So, if you are approved, you start shooting, fail the sound tests - stop shooting completely until you have more mitigation?" Parks said that was correct and it was a condition of approval. He added, "If it's a failed test, Boise County could suspend or terminate the conditional use permit."

Manweiler then pointed out that the range is in a "bowl" and the sound would carry to all the residents nearby. She expressed some real concerns for what she described as a lack of an operations plan and for safety issues.

EXECUTIVE SESSION: The board went into an executive session.

City County Meeting in Idaho City

IDAHO CITY -- The regular Idaho City Council meeting was held August 10, 2022 and began at 6:02 p.m. Those in attendance were Mayor Ken Everhart and Councilmembers Ashley Elliott, Tom Secor Jr., and Mari Adams.

Items of business were conducted, including the approval of minutes from July 27 and August 3, 2022, and the bills July 28 through August 10, 2022 were paid in the amount of \$25,599.14.

Idaho City Event Checklist had two items. The first item, Idaho City Days Event was presented by Michelle Audette and Jacob Kessler. This year it will be held September 30 through October 2, 2022. Main Street will be blocked off at the highway, Walulla Street will be blocked as well, a main stage will be assembled at the Visitors Center, there will be beer sales, and park-

ing attendants will be provided to prevent people from parking around Idaho City.

Audette asked Idaho City to donate back profits equal to the amount of the Porta-potty rentals. They would also like to use the Idaho City dumpsters for trash. There were three motions to approve the Idaho City Event Checklist, including an approval for an alcohol variance for the days involved and another motion to reimburse the Chamber of Commerce for the cost of the porta-potty rentals in the amount of \$1,340.82. Each of these motions were passed.

The last checklist was presented by Beth Wilson from the Idaho City Historical Foundation, informing the council about the Smokejumper Day on August 13, 2022. They made a motion to approve the event, and gave an alcohol variance from 10:00 a.m. to 3:00 p.m. The motion carried.

Under old business, Zane

Amy from Valley Wide Propane offered a proposal for providing propane to Idaho City. Councilmember Tom Secor asked if the \$1.99 per gallon rate was a set amount or if this rate fluctuates. Amy indicated that the rate does fluctuate. Mayor Everhart wanted to know what the cost has been historically during the wintertime. Amy responded that the rate was currently at \$2.39 per gallon. Mayor Everhart recommended that Idaho City Council compare the city's recent propane bills and discuss the information at the next meeting.

New business had three items.

Harley's Pub LLC - 2023-01 requested a liquor license renewal. This was approved by the Councilmembers.

Shelly Heffington presented a "Noise Ordinance Variance" during the Jack Pine Round-up on August 26-27 for Steve Twi-

legar at the Gold Mine from 10:00 p.m. - 1:00 a.m. This was agreed to by all the councilmembers.

The Idaho City Fire Protection District and transfer of land deed was presented by Brent Adamson. He asked the council to transfer the land deed for the building being used by the Idaho City Fire Protection District. Mayor Everhart and Councilmember Secor indicated that there was a discussion relating to the transfer of the land at the time that the Fire Protection District was formed, and the city does not want to part with this asset. Adamson stated that the Fire Protection District would be able to apply for additional grants if the land belongs to the Fire Protection

District. The building on the land was built by the Idaho City Volunteer Firefighters and they would like to also own the land associated with the Fire Protection District. Mayor Everhart stated that at the time the Fire Protection District was formed it was believed that the District would grow and acquire their own property. City Council will continue to discuss this matter with input from the City Attorney.

Employee updates, Public Works director Tami Claus reported that they will be replacing a fire hydrant and installing a valve and water meter at the fire station on Tuesday, August 16, 2022. Water will need to be shut off for a short period of time. There is also a leak at the water plant that is being fixed and a water heater is being repaired at the Visitors Center.

Clerk Nancy Ptak presented estimates for carpet cleaning at City Hall. There were three quotes presented and Clerk Ptak indicated that the company with the lowest quote would be used. She also presented a list of water and sewer delinquent accounts. This month's

ecutive session, closed to the public, to discuss the process. Coming back into session, Chairman Twilegar asked that audience members keep groaning and eye rolling to themselves.

DELIBERATING: Commissioner Stirm had some staunch concerns regarding the fire department and said he held paperwork stating who was the authority in the area of question that would prevent him from voting.

Chairman Twilegar said, "I love gun ranges. I've grown up shooting," but he had a couple of concerns for the Avimor development that weren't potentially met. "The first one is in number four: The use will not be hazardous or disturbing to existing or future neighboring uses." He added, "The fact that you've already got Rock Creek [in Gem County] there, I mean, how many more gun ranges do we have to add around you guys?" The second concern was the traffic on the hill of Highway 55, and Twilegar asked if there was something more reasonable that wasn't within 1.7 miles of a house. "It's clear to me that it's going to be a disturbance and the danger of fire."

Commissioner Stirm said, "When I interpret 'harmonious' to the surrounding area, I think, put a swimming pool in a subdivision. Right? That's

harmonious, kids get to play, whatever. Everyone benefits from that, nobody really loses in that scenario, right? Even pools have life guards, right?" He said "Personally, this looks thrown together to me." He said his concerns were for the wildlife, in the chemically burned vegetation, and fire potential near homes. Stirm reiterated that there was already a shooting range there, "and the fact that people would randomly go up there and shoot other things like TVs... The last thing I want to be known for is for setting a precedent that it's okay to disrupt a home, in order to provide a service for a few individuals." He said, as a gun owner, "I feel like there's a complete lack of effort on making this a safe situation for anybody." He expressed that Eagle Fire does not know what they are agreeing to, and stated that Ada County would not travel on dirt roads with their ambulances. He's also concerned that there will be underaged children shooting "daddy's gun collection" and the code to open the gate would be easily spread. He also mentioned that there were no limits on the caliber of gun.

Commissioner Tucker had a difficult time coming to a conclusion with the noise ordinance, and said he wished he had more information. Prosecutor Adam Strong advised there was an option to review all of the information. Twilegar said,

"Basically, we can't do a sound test until it's built." Tucker then admitted that he lives next to a shooting range and said, "I don't even notice it."

Twilegar said that they needed to look at all the evidence, "feelings have nothing to do with it." They discussed the conditions placed on the conditional use permit.

EXECUTIVE SESSION: Commissioner Twilegar motioned to go into executive session and explained to the audience, "We don't want to get ourselves in trouble here." Coming out of executive session, Chairman Twilegar said there was no action required.

DECISION: Commissioner Tucker requested more time to make a decision. Commissioner Stirm said with a chuckle that he was ready to vote, but Chairman Twilegar said that he wouldn't mind more time too to go over all of the evidence.

Commissioner Twilegar motioned to table this issue until September 1st at 9:30am, at the Commissioners' room in Idaho City.

Prosecutor Strong advised the commissioners that they were not to do any further investigations, or talk to anyone, but "to go through the record as it exists currently."

Commissioner Twilegar apologized, "Sorry folks, I know you wanted a decision today."

Adjourned at 2:33pm.

water bills were sent out without the current month's water consumption included and next month's bills will include this consumption as well as the next month's. Clerk Ptak also presented the water and sewer adjustments for City Council approval.

City Attorney Joan Callahan indicated that there will be an executive session added to the next regular City Council meeting.

Two citizens had comments,

the first one was presented by Jim Obland, who believes that his water bill is incorrect. He presented documents with his calculations disputing his current bill. Public Works Director, Tami Claus, will inspect the meter as soon as possible to see if there is a leak. City Council assured him that late fees would not incur while the matter is being resolved.

The other citizen was Bob Amidon from the Cowboy Campground. He was given a cease-and-desist order for installing sewer lines on his prop-

erty and opening a trailer park on his property. City Council indicated that he received the cease-and-desist order because he did not present his plans to Planning and Zoning for approval and did not acquire the proper permits. He will need to present his plans at the next Planning and Zoning meeting and he will not be allowed to connect the city sewer line until the city inspects the connection.

Meeting adjourned at 7:12 p.m.



The Idaho City Fire building was discussed at the August 10, 2022 Idaho City Council meeting. Mayor Everhart and Councilmember Secor indicated that there was a discussion relating to the transfer of the land at the time that the Fire Protection District was formed, and the city does not want to part with this asset. Brent Adamson, representing the Fire District, stated that the Fire Protection District would be able to apply for additional grants if the land belongs to the Fire Protection District. The building on the land was built by the Idaho City Volunteer Firefighters and they would like to also own the land associated with the Fire Protection District. Mayor Everhart stated that at the time the Fire Protection District was formed it was believed that the District would grow and acquire its own property. The City Council will continue to discuss this matter with input from the City Attorney.

HORSESHOE BEND -- The 2022-2023 school year began on Wednesday, August 17 for students in the Horseshoe Bend School District. The students were greeted by familiar, friendly faces and a new fourth grade instructor, Mrs. Kim Hyde. The high school students were surprised with a new Student Center where high schoolers can hang out during the morning muffin break and at lunch. The center is modeled after a typical college student union, complete with cafe tables, comfortable seating, microwaves, indoor and outdoor games, a business center for printing, and a charging center to boost up those cell phones.

The middle and high school students attended a welcome back/ pep assembly where Coach Jeff Longacre talked about the upcoming year for the athletic department.

WILDFIRES

U.S. Forest Service Summary on August 23, 2022 of the Boise National Forest Wildfires

BOISE COUNTY -- Sixteen wildfires within the Boise National Forest were started from the thunderstorms Friday, August 19, 2022, and continued through the weekend across southwestern Idaho. Firefighting crews safely and aggressively initial attacked all of the fires and have successfully put out 9 of the wildfires caused by the recent storm.

Crews from the Boise National Forest, Idaho Department of Lands and other out of the area resources have held most of the wildfires below an acre with the largest, the Oxtail Fire holding at 15 acres with line constructed around its perimeter. All of the fires are staffed, and fire personnel continue working to suppress all of the fires.

Additional resources are arriving and will be in Garden Valley and Cascade for initial attack response. As fires are called out and resources become available, along with the additional incoming resources, firefighters should have the capabilities to handle any new fires.

No area or trail closures are in place and no structures are threatened. Visitors should be cautious as they may encounter firefighting crews and vehicles.

Hot, dry conditions will con-

tinue across the remainder of the area through Wednesday with increasing southwesterly winds along ridge tops. Weather and fuels conditions are right for any fires that have not been discovered to become active.

The new Bear Cub Fire is another holdover from the recent storm and is burning in rugged terrain with very low probability to move from its location due to the lack of burnable material in the area. It will be monitored by air.

The Oxtail Fire west of the Deadwood River and north of Deadwood Reservoir, has been held at 15 acres. It is in an old burn scar and burning grass, brush, snags, pine and subalpine fir, with a lot of fuel on the ground. Smoke-jumpers, two Hotshot crews are on the ground and air resources are providing retardant and water support as needed.

The Wet Fire acreage has been mapped at 11.5 acres. The wildfire is burning in thick fuels and snags. Helicopters have been dropping buckets of water to assist crews on the ground who continue to make good progress.

The Canyon Fire is on the east side of Hwy 21 up slope at mile marker 103. It is burning in sub-alpine fir and is located in steep terrain. Air resources have been providing bucket support and retardant from single engine air tankers (SEATs). 3 crews are ac-

tively engaged in lining the main fire and several spot fires that occur from the subalpine fir.

There are approximately 160 firefighters on these fires with numerous others supporting the fires logistically.

Additional fires will be "called out" in the coming days as crews continue their diligent work to extinguish them completely.

Current Fires include:

- Oxtail: 15 acres – Oxtail Creek west of the Deadwood River
- Wet: 11.5 acres – 5 miles west/southwest of Silver Creek Lookout
- Canyon: 10 acre - Near mile marker 103, upslope and east of Idaho State Highway 21.
- Bear Cub (new): 0.1 acre – Bear River and Cub Creek area.
- Silver: 0.1 acre – off NFS 671 road near Silver Creek Summit Trailhead (estimated contain and control 8/24)
- Bull: 1.5 acre –Trail Creek

(contained 8/23)

- Lost: 0.25 acres – Near Rough Creek and west of Red Mountain Lookout (contained 8/23)

- Huckleberry: 0.75 acres - 4 miles southeast of Lowman (called out 8/23)

- Wild: 0.1 acre – Northeast of Deadwood Reservoir and east of NFS 555 road (called out 8/23)

- Bald: 1 acre – 2 miles south-east of Thorn Creek Lookout (called out 8/23)

- Scriver: 0.6 – Scriver Creek and NFS 693 road (called out 8/23)

Contained: The status of a wildfire suppression action signifying that a control line has been completed around the fire, and any associated spot fires, which can reasonably be expected to stop the fire's spread.

Controlled: The completion of control line around a fire, any spot fires, and any interior islands to be saved; burned out any unburned

area adjacent to the fire side of the control lines; and cool down all hotspots that are immediate threats to the control line, until the lines can reasonably be expected to hold under foreseeable conditions.

Fires are contained, controlled and then called out.

HORSESHOE BEND -- When the *Idaho Statesman* released its 25 Must-See High School Players in the Boise Region list, one of Horseshoe Bend's own made the elite roster. Senior Blayne Meyer made the cut as both a running back and a linebacker. According to the *Statesman*, "The first tackler won't bring down the 5-10, 170-pound senior. He may have the speed to run by everyone, but he'd rather run over a couple of defenders along the way. 

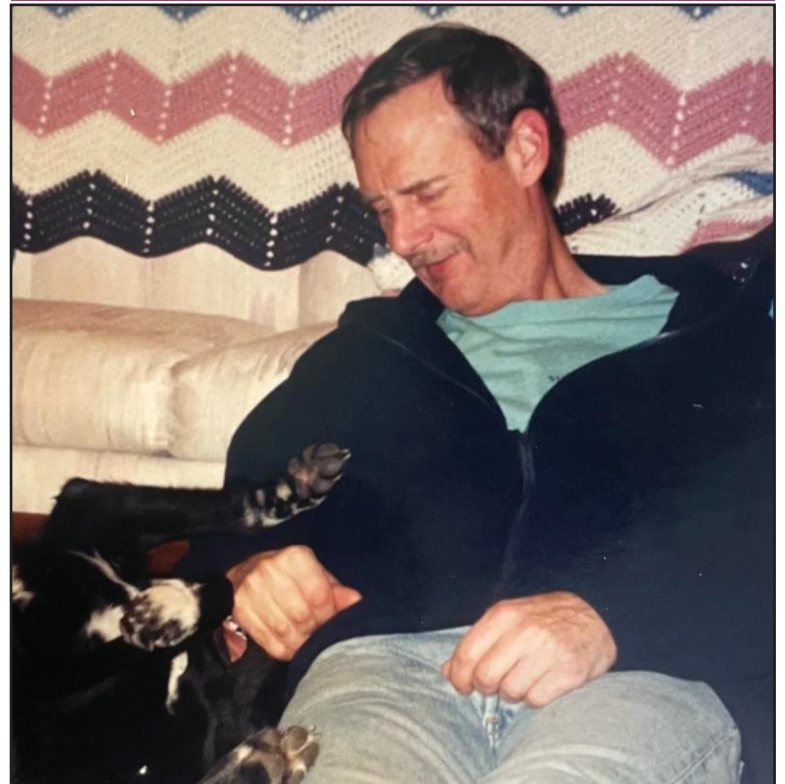

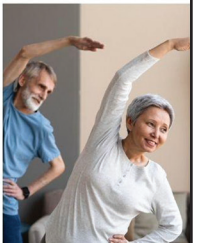

An eight acre burn resulted from a vehicle fire on Friday, August 19th, near Hilltop Station.
