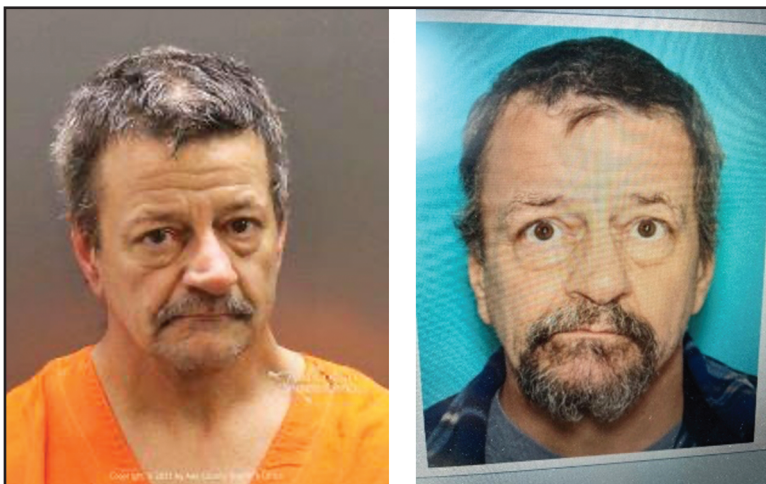
### Felon on the Loose

**IDAHO CITY** -- Neighbors located just south of Idaho City reported hearing between nine and ten gun shots early Saturday afternoon. Officers responded to a residence on Miles Drive and found the evidence of shell casings from a 9mm handgun. Aggravated assault and attempted murder charges were initiated during the investigation. Boise County deputies were unable to locate the suspect that they initially thought was on foot. Neighbors dutifully armed themselves and kept their doors locked during this time.

The Boise County Sheriff's Office has identified the suspect as Danny E. Thompson, a white male, 55, 5ft. 8in. tall, with brown hair and eyes.

According to Sheriff Scott Turner, this individual had been released from prison, in the eastern U.S. after serving time on a murder charge. On separate charges, Thompson was paroled in Idaho, just five days prior.

Thompson has some family ties in the Idaho City area and

has been a disturbance for law enforcement in the past.

The Sheriff's Office is still trying to piece together why this individual was released from prison and are hoping to get a tip from the public as to the whereabouts of Danny Thompson. There is a \$500,000 warrant out for his arrest. Thompson was last seen in the Idaho City area on August 27th. He is also known to have associates in the Canyon County area. He could possibly be driving a white Hyundai

Accent.

The Boise County Sheriff's Office warns the public: "Thompson should be considered extremely dangerous. If you have information on Thompson's location, please contact your local law enforcement or call 911. Thompson is currently wanted by the Boise County Sheriff's office for 1st degree attempted murder and felon in possession of a firearm."

**IDAHO CITY** -- In 2009, my mom had me. We were living on a horse rescue and boarding ranch in New Plymouth, Idaho. I've been around horses my entire life. My first actual horse was in June of 2021 and he was a 20-year-old dun named Spirit. Ever since then, I've been obsessed with rodeo and horses. I started riding broncs in the Jack Pine Round Up in Idaho city. That next spring, I started riding bulls with Rodeo Fever (Kevin and Sheila Hensen). They buck Jr. Bulls at rodeos throughout Idaho and parts of Oregon. My first rodeo was the Eagle ProRodeo in early June. I got better equipment, and got better at riding. I won second place in Weiser, it was amazing. As my first cover at a rodeo, I was able to win a check for \$119. After that, I was invited to Caldwell Night Rodeo, a pro-rodeo. The weekend before CNR (Caldwell Night Rodeo) I had drawn a new bull Kevin had bought. He was not at all friendly in the chute, but when I got situated again, I rode him for about 4 seconds. Thursday night in the CNR I rode my bull for about 5 seconds. Friday night, I fell off at about 3-4 seconds.

People ask me a lot... Why do I ride bulls? Well, when my sister and mother died in 2017, I was in a deep slump for most of my life. Then I got involved with rodeo and bull riding. My dad was not very fond at all of me riding bulls, but do I still do it? Yes. I'd rather spend the rest of my life in the chutes or on a horse than in a kitchen. So, Bulls and Broncs are my Passion.

**August 23, 2022****Present:** Commissioners Steven Twilegar and Clay Tucker**Absent:** Commissioner Ryan Stirm**Pledge of Allegiance****MINUTES:** Chairman Twilegar motioned to approve the minutes from August 16<sup>th</sup>. The motion carried. He motioned to approve the minutes from August 18<sup>th</sup> and the motion carried.**SECURE RURAL SCHOOLS:** The allocation of funding discussion was started by Clerk Mary Prisco who stated, "Well, we haven't had to do this for quite a few years." Title 1 funds go to the roads and part goes to the schools. Title 2 funds go to a pool of funds that go to a resource advisory, which the county can apply for grants. Title 3 funds come directly to the county and are specifically for "fire-wise communities, planning, and we're also allowed to use it for emergency search and rescue on federal lands." Chairman Twilegar made a motion, per the clerk's direction, to distribute the monies percentages - 85% to Title 1, 8% for Title 2, and 7% for Title 3. The motion passed.**DOCUMENTS:** There was a discussion with constituent Debra Jackson regarding pdf documents posted to the county website.**ROAD DEPARTMENT:** Curtis Dill presented the name of an individual, with a CDL license from Horseshoe Bend, that could fill the open position. The commissioners motioned to approve the new hire for Horseshoe Bend. Dill then said that he had someone in mind to fill a parttime position in Garden Valley.**SHERIFF:** Sheriff Scott Turner presented an annual agreement with the Idaho Transportation Department, a grant for traffic enforcement for FY2023.**PUBLIC DEFENSE FUND:** Clerk Prisco said the grant award from the public defense commission was the standard \$25,000, and a one-time payment of \$1000. She also asked that the commissioners "roll-over" an existing \$10,000 from 2021, which is restricted funds. Chairman Twilegar motioned to approve the 2023 indigent defense financial assistance agreement in the amount of \$36,000.**JUVENILE DETENTION:** Prosecutor Adam

Strong said there was the same juvenile detention center for both Ada and Boise county, which was the same agreement as last year. "It's [on an] as needed basis, so when we have a juvenile who is needed to be taken to a detention. We can't take them to the jail." Commissioner Tucker confirmed, "It's \$216 dollars a day?" Clerk Prisco agreed and said there was a lesser charge if it was less than a day. Tucker said, "Seems expensive, but..." Commissioner Twilegar filled in, "Yeah, it's better than building a building though." Prosecutor Strong explained that it was more expensive because there are more requirements for juvenile detention facilities and there aren't normally as many inmates.

Chairman Twilegar motioned to approve the memorandum of agreement between Boise and Ada County for juvenile detention. He then motioned to approve a similar agreement between Boise and Canyon County for juvenile detention. Both motions were approved.

**RECORD DESTRUCTION:** Clerk Prisco explained that contents of the boxes were related to the jury commissioners. Chairman Twilegar motioned to destroy certain records [listed], which was approved.**REPORT:** Commissioner Twilegar made a motion to approve a claims approval report in the amount of \$88,785. The motion carried.**LIQUOR LICENSE:** Commissioner Twilegar motioned to approve several liquor licenses. All the motions carried.**TITLE 3 FUNDS:** Clerk Prisco explained the funds, and "the amended certification." She added, "The amounts recorded as funds not obligated," she said were at an incorrect amount. Prisco said this was realized with the 2021 audit. She asked the commissioners to approve the amended amount of \$131,348. Commissioner Twilegar asked out of curiosity, "How far off was it?" Clerk Prisco said, "The original report amount was like \$56,000." She said they have to put a notice in the *Idaho World* newspaper "for what we intend to use the funds for and the amount assigned to each type of use." Then there's a forty-five day waiting period for the public to provide input.

Commissioner Twilegar made a motion to adopt this change in the amount of \$131,348 for the secure rural schools fund.

**PLACERVILLE FIRE:** Sheriff Turner said that most of the fire departments had a fee for those outside their response area or action district. Prosecutor Strong said "It's ultimately up to them to figure out their own fee structure, and if they're wrong, someone can challenge them on it." He added, "Fees, under the state of Idaho, cannot exceed your actual cost."

The sheriff said he's seen where individuals have said, "I don't want the fire department on my property," because they will charge the homeowner a fee. "It puts us in the middle of what's right and what's wrong."

Twilegar commented, "You think the \$3,000 is bad, what about the forest fire you let go?"

**DEMAND WARRANTS:** Prosecutor Strong spoke about a bill for the excessive number of hours a company was charging the county when they only "moved a couple of thermostats around." Twilegar commented, "Let's not pay them... Labor: \$1,890." There was \$540 in overtime. Prosecutor Strong read, "Moved some thermostats away from an electrical panel. It does not seem like 25 hours' worth of work."

The road department presented an invoice for a set of three parking places for heavy equipment they use for the winter. Chairman Twilegar motioned to approve the invoice for the parking for \$220.

**EBCAD:** Commissioner Twilegar motioned to approve the subgrant with "an actual number of \$21,000." All were in favor.**BUDGET:** Clerk Prisco went through numbers and asked to go into executive session under personnel.**EXECUTIVE SESSION:** Commissioner Twilegar motioned to go into a closed executive session, and in coming out, he said there was no action required.**BUDGET:** Clerk Prisco briefly mentioned several fund changes and payroll adjustments.**PLANNING AND ZONING:** Alex Gross, P&Z Administrator, said he received a letter from the city of Eagle that explained that Avimor had applied for annexation. He

suggested preparing a letter in support of the annexation.

Gross said he had some hearings scheduled for September 27<sup>th</sup>, but had learned that the commissioners were going to be away at a conference for the

Idaho Association of Counties. He will move those, remain, and re-notice. However, one applicant already had one sign made, which the commissioners thought they should compensate.

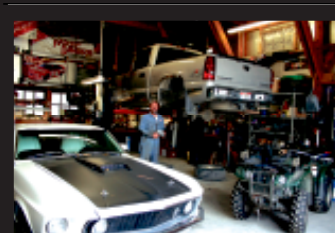

## City Council Meeting in Idaho City

**IDAHO CITY** -- The Regular Idaho City Council meeting was held on Wednesday August 24 at 6:00 P.M. They started with the Pledge of Allegiance, the approval of the minutes for August 10, and payed the bills from August 11, through August 25 in the amount of \$21,034.17. Then the councilmembers listened to Mike Tam, who introduced the Java the Pup Celebration of Life Block Party for September 24, 2022. The council did not have an event list, so Tam will finish the list and present it at the next regular City Council meeting. Tam wanted to make sure that the date of September 24, 2022 was available for his event and City Council verified the date was available. Tam would also like to donate a statue of a service dog to the City.

Under the title of 2022/2023 Fiscal Year Budget Hearing, a motion was made to allow citizen comment by the public. Mayor Everhart read the line items on the budget and asked for citizens' comments or concerns.

Clerk Ptak stated that the budget had been printed in the *Idaho World*. There were no public comments; Councilmember Tom Secor made a motion to close the public hearing, this was seconded by Councilmember Mari Adams, and motion carried.

The councilmembers made motion and allowed the Mayor's signature on Idaho Department of Environmental Quality American Rescue Plan Act Drinking Water Grant Agreement No DWG-250-2023-1.

Under Old Business regarding the Idaho City Fire Protection District negotiating the transfer of the land deed, Councilmember Ashley M. Elliott suggested that there might be a way to come to an agreement. Mayor Ken Everhart stated that he has verified with the City Attorney, Joan Callahan, that Idaho City cannot give away property. At the time of acquisition of the land and the building, the Fire Department was an "Idaho City Entity." Councilmembers Elliott and Adams would like more information on how the original grant was structured. Brent Adamson, Idaho City Fire Protection District Commissioner, offered to provide the City Council with the details of the grant. Further information would be needed to make an informed decision on a prop-

erty exchange, and whether this is feasible.

Idaho City currently has four propane tanks. Clerk Ptak indicated that customer service is a high priority when deciding on which company to use. Valley Wide Propane has sensors which will alert their business when the propane is getting low and they will automatically come and fill the tanks. Council decided that they would like Clerk Ptak to get a quote from an additional company for comparison.

**New business items were:**

Idaho City High School using donated building materials to build an indoor sports facility. Al Hanson, the Idaho City High School Activities Director, asked to use the building materials that are located across from the City Shop to construct a locker room and indoor sports facility at the football field. City Attorney Callahan indicated that the Council needs to determine the value, have a public hearing, and set a Resolution to donate the surplus personal property.

Liquor license renewals were discussed. The following businesses had complete applications for a 2023 Liquor license renewal: Idaho Grocery, Seasons, Gold Mine Idaho City LLC Gas Station, and BoCo. Councilmember Tom Secor made a motion to approve the 2023 Liquor Licenses for these establishments. The motion carried and was approved. The other Businesses: Diamond Lil's Steakhouse and Saloon, Gold Mine Solutions Born, LLC, and Trudy's Kitchen did not have complete license applications. Chief Otter suggested that a special City Council Meeting be held next week to approve the remaining three liquor licenses. City Council agreed to hold a Special City Council Meeting on Wednesday, August 31, 2022.

Regarding Ordinance No 325 and Resolution No 2014-23 an Event Checklist review, City Council discussed what changes needed to be made and decided that more discussion should occur at the next regular City Council meeting.

**Committee Reports:**

Parks and Recreation Commission was represented by Dax Olvera, who inquired what is required for him to step up and lead the Parks and Recreation Commission. He would like to build an additional ball field next to the softball field.

The Mayor said that land lease only allows for ball fields. Olvera would like to know what the boundaries are for this land to verify that there is enough room for a baseball field. Mayor Everhart suggested that Olvera contact Jason Rowe at the County for a map. Olvera said he will try to recruit additional members so the Parks and Recreation Commission can resume.

Marc Carignan, Planning and Zoning Chair, summarized the minutes of their last meeting on August 8, 2022. Planning and Zoning Commission also had a work session on August 15, 2022 to become familiarized with the duties of Planning and Zoning. They are working on definitions of the different types of residences and will propose the new definitions to City Council.

Councilmember Tom Secor made a motion pursuant to Idaho Code § 67-2345, to go into Executive Session to communicate with legal counsel regarding pending/imminently likely litigation [Idaho Code Section 74-206(1)(f)], this was seconded by Councilmember Ashley M. Elliott. All agreed and the Executive Session began at 6:54 pm. Mayor Everhart ended the Executive Session at 7:30 pm.

**Employee Updates:**

Public Works Director Tami Claus reported that the rodeo grounds are ready for the Jack Pine rodeo this weekend. There is a problem with a beaver dam by the sewer plant. Claus has permission from Jessica to enter her property to assess the situation and take care of the problem. Claus will repair the fire hydrant at the fire station this week. The sand bay at the RO was cleaned. Claus spoke to DEQ to get an extension to get the wells tested. Claus completed the Sanitary Survey.

Under Law Enforcement, Chief Otter reported that they have been extremely busy. There have been more calls for health and welfare, child welfare, and mental health issues. People are taking the City water from the RV dump for residential living. Otter suggested a shut-off valve for the line that only allows a limited amount of water to be dispensed at once or that they shut the water off at night. City Council needs to investigate if it is possible to turn off the water at night since the RV dump and water station was created through a grant. Council would like to

see the RV water station shut off while the water moratorium is in place. City Attorney Callahan will research amending the Water Moratorium Ordinance. Mayor Everhart suggested that barricades be placed with notice that the RV dump is out of service.

Law Enforcement received grant money. Additional patrols will begin this weekend. Speed limit signs will be purchased.

Law Enforcement had a meeting with the school to address emergency response. There will be additional trainings. Law Enforcement will have a booth at the upcoming High School parent teacher conferences.

Mayor Ken Everhart reported that Mores Creek Recreational Board is re-doing the walk bridge on the airport loop. Mayor Everhart inquired if there is still redwood available and the cost per board. Clerk Ptak replied that some of the redwood will be used for signs at the cemetery.

Mountain Waterworks is in discussion with an owner in Centerville to obtain permanent water rights. They will be starting the Water Facility Plan to prepare the City for grant opportunities. They are researching information on a sand separator for the RO building.

Meeting adjourned at 8:06 P.M.

**HORSESHOE BEND --**

**Football:** The Horseshoe Bend Mustang Varsity Football team defeated the Cascade Ramblers 66-14 in their 2022 season opener at home. Junior Kaelun Juns had 226 rushing yards, 21 receiving yards, 5 tackles, and 4 touchdowns during the 1A DII Longpin Division game. Senior Blayne Meyer had 178 rushing yards, 7 receiving yards, 1 quarterback sack, 8 tackles, and 3 touchdowns. Junior Carson Drake in his first game as starting quarterback had 72 passing yards, 9 rushing yards, and 1 passing touchdown. Senior Jedi Graham had 19 receiving yards and 5 tackles. Senior Seth Rubal had 25 receiving yards. Senior Joseph Wellan had 10 tackles and 1 quarterback sack. Junior Nic Cooper had 2 quarterback sacks and 2 tackles. Junior Gavin Tomlinson had 4 tackles and 1 quarterback sack. Sophomore Mason Beliveau had 5 tackles, senior Kash Smith had 2 tackles, and freshman Lukken March in his varsity debut had 2 tackles. ## Deer Valley Subdivision Development Agreement Passes Unanimously

HORSESHOE BEND --

The Horseshoe Bend City Council held a special meeting on Wednesday, August 24 at 6:00 p.m. to discuss and vote on the Deer Valley Subdivision Development Agreement. Councilmember Curtis Corvinus was not in attendance. The live audience consisted of two Horseshoe Bend Valley Chamber of Commerce members, one Boise County Deputy, and developer David Bailey, with one Zoom attendee. City attorney Tony Pantera presented the proposed development agreement to the council for their consideration. The plan consists of 144 building lots; 138 residential and 6 commercial lots.

Councilmember Stephen Chartier asked if anyone knew why the construction had halted at the development site, to which Bailey replied that they could not proceed without the development plan that was before

the council being approved. He indicated they were ready to go as soon as they received the green light from the council.

City Engineer Amy Woodruff said that once the construction drawings were completed and stamped, they would meet with the development company and construction could begin.

It was suggested that construction could begin as soon as the infrastructure was complete, perhaps as early as April 2023.

Councilmember Patti Burgess suggested that the development plan include some concessions to the community, perhaps by a donation of equipment to the fire department.

Woodruff explained that the development company was paying all fees upfront to assist the city in complying with a necessary redundancy program for the water system. The assistance would allow the city to update the water plant in 1-2

years instead of the previous proposal of 5-10 years and save the city 30 years of interest payments on a bond to finance the project.

Chartier asked if the city's water capacity was capable of handling a fire in the new subdivision. Woodruff said that the current residential water flow would be "sufficient for fire suppression." Chartier responded, "I just want to make sure we have enough water." Woodruff told the council that with

the developer taking care of the redundancy program it would free up funds for other water projects like a new water tank.

Mayor Pat Goff told the council that the redundancy program was mandated by Idaho's Department of Environmental Quality (DEQ). Councilmembers Marty White and Burgess pressed the idea of the developer providing additional equipment, to which Bailey responded that the fire district had not

expressed any additional needs but said he would be happy to meet with them again to make sure they can provide the level of service needed. After the discussion ended, Chartier made a motion to approve the Deer Valley Subdivision Development Agreement. White seconded the motion. The approval was unanimous.

The meeting ended at 6:33 pm and the council went into executive session to discuss pending litigation.

## Finding Drowned Victim in Lucky Peak Reservoir

**ADA COUNTY SHERIFF'S OFFICE** -- Ada County Marine deputies helped recover the body of Jose Nunez, a 46-year-old Nampa man, on Tuesday, August 23rd, from Lucky Peak Reservoir with the help from a volunteer organization Bruce's Legacy. The sheriff's office said, "Nunez was last seen by friends after he jumped into Lucky Peak for a swim around 7 p.m. on July 31. He went underwater and did not resurface. Our marine and dive teams searched the area of Lucky Peak in the days that followed but were not able to find him. The Nunez's family reached out to Bruce's Legacy, a Wisconsin-based non-profit volunteer agency that brought their equipment to Lucky Peak

and was able to use special side-scan sonar equipment to find Jose Nunez. He was about 150 feet down in the deep recesses of Lucky Peak -- several hundred yards from where he was last seen."

"The Bruce's Legacy team was able to send a retrieval device down that far to help move him towards the surface, where our marine deputies were able to recover him from the water and get him to Ada County Coroner's Office officials. Our agency deeply appreciates the help from Bruce's Legacy organization."

The Boise County Sheriff's Office thanked all involved for their help in finding Jose.

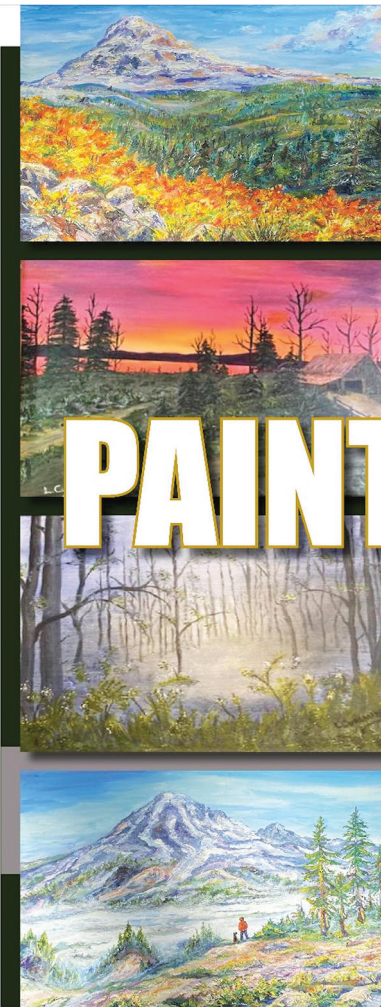

Mayor Everhart added, "On behalf of the City of Idaho City, I would like to thank DEQ for providing this funding to us and also our engineering firm, Mountain Waterworks, for staying abreast of all the grant opportunities that come available to benefit our city as we

continue to improve our city utilities."

"DEQ's Planning Grant Program provides assistance to eligible wastewater and drinking water systems. These grants are used to develop engineering reports identifying the most cost-effective, environmentally sound method of upgrading a system to achieve and maintain compliance with state and federal standards. Grants cover up to 50% of eligible planning costs, with the remaining cost as the grant recipient's responsibility."

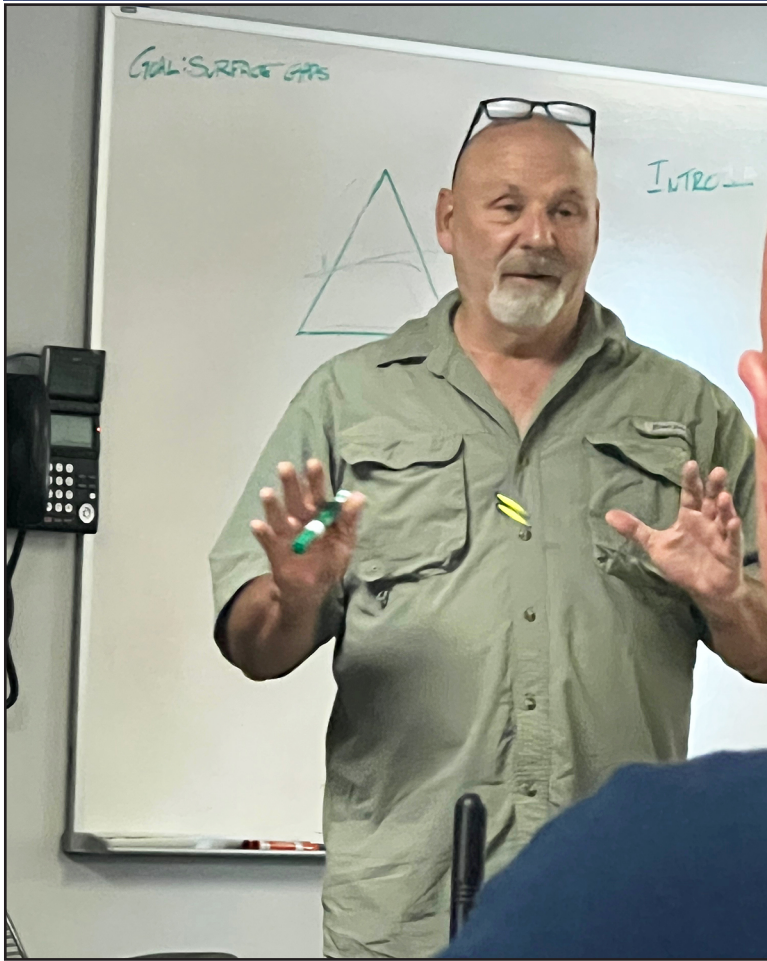

## Labor Day Road Safety

### Extra Labor Day Patrols Target Drunk Drivers

**BOISE COUNTY SHERIFF'S OFFICE** -- As Labor Day Weekend approaches, deputies from the Boise County Sheriff's Office join law enforcement agencies across Idaho to keep drunk drivers off our roads. Beginning Friday through September 5, officers will dedicate patrols to look for drivers under the influence of drugs and alcohol.

This enforcement effort comes as we near the end of the 100 Deadliest Days of Summer. This is the period of time between Memorial Day Weekend and Labor Day where there is typically an increase in fatal crashes – so far this summer, at least 72 people have been killed in crashes.

From families taking their

vacation to summer construction, there is a lot that happens on our roads in the summer. Impaired drivers put everyone else at risk when they choose to get behind the wheel.

According to data from the Idaho Transportation Department's Office of Highway Safety, nearly 40 percent of all fatal crashes in Idaho involve some form of driver impairment. Between 2017 and 2021, 453 people were killed in impaired driving crashes in Idaho – including 108 people who were killed in 2021.

This is a problem that affects all of us. It's going to take all of us working together to stop impaired driving.

While additional officers will be on the lookout for impaired drivers, we can all do our part to keep Idaho's roads safe. Cel-



celebrate with a plan and remember these safe alternatives:

- Plan ahead. Before you drink, designate a sober.
- Speak up. Do you have a friend who is about to drink and drive? Take the keys away and make arrangements to get your friend home safely.
- Call the Police. If you see a suspected impaired driver call 911, or \*ISP (that's STAR, I-S-P for Idaho State Police) or 1-800-233-1212.
