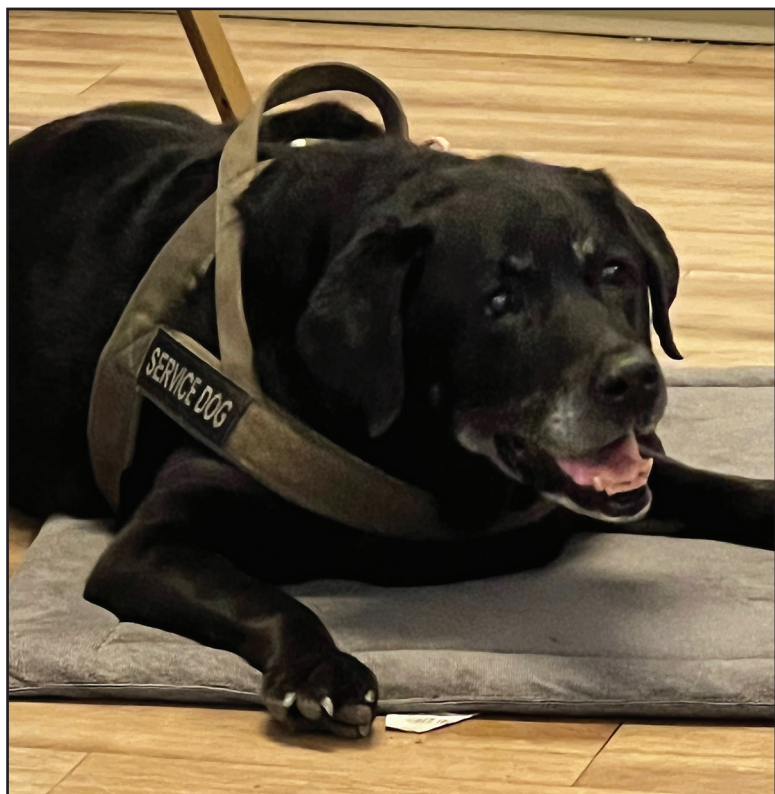
Congratulations to Post 142

Micron's Commitment to Invest in Idaho's Future Workforce

BOISE COUNTY -- The Micron Foundation is committed to greater STEM outreach and plans to extend investment in Idaho kindergarten through 12th grade. They are especially looking to invest in under-represented and rural students. Micron has also partnered with the College of Western Idaho to develop new curriculum that will lead the efforts in advanced technology in automation and semiconductors. Dee Mooney, with the Micron Foundation, says this will be an excellent opportunity for Idaho's workforce to increase their high tech jobs skills. She said this was the largest private investment to help develop future generations and grow the state's economy. Micron is also working with the State Board of Education, Next Steps Idaho, and Idaho Workforce. Building a new facility in Boise will require a large workforce, but Micron's stated purpose for building is to bring back chip memory manufacturing to the United States.

Assistant Superintendent for Basin School District ReBekha Lulu was at the official groundbreaking ceremony for the new facility and observed, "In the [educational] forum, they emphasized the need for creating a pipeline for Micron careers that includes K-12 and focuses more heavily on rural districts. This would be vital as the \$15 billion dollar investment will create thousands of new jobs locally. The panel also shared that there will be entry-level jobs that young people could access and they would then have access to Micron's em-

ployee education support program, which provides the funding for continued education. This would be a huge help for those who cannot afford to pursue a degree right out of high school, but are interested in the field."

Chelsea Garecht, a Micron Senior Manager, added, "As part of the company's ongoing commitment to invest in the Idaho community and further build our workforce, Micron will expand investment in K-12 STEM education programs and increase focus on reaching underrepresented and rural student populations.

Micron is also proud to announce a partnership with the College of Western Idaho to lead efforts in delivering key curricula, such as Advanced Mechatronics Engineering Technology, to prepare students for the Micron Technician Apprenticeship Program. This will include the College of Western Idaho classroom instruction on Micron's Boise Campus. Together with the College of Western Idaho, Micron expects to establish programs to reduce the financial burden for students to continue their education path. This would include, but is not limited to, scholarships, lab equipment, transportation and faculty support."

Garecht said, "Additionally, the Micron Foundation continues to increase opportunity and reduce access gaps to STEM education and careers through implementing a portfolio of initiatives related to K-12 such as our Chip Camp, Job Shadows, and Girls Going Tech programs."

September 6, 2022**Present:** Commissioners Steven Twilegar, Clay Tucker, and Ryan Stirm (via phone).**Pledge of Allegiance****CONSTITUENT INPUT:** Debra Jackson asked for an update regarding getting documents added to the agenda. Clerk Mary Prisco responded that the deputy clerk was on vacation and they would discuss it when she got back. Jackson asked, "Is this going to be an easy transition?" Prisco replied, "We're just going to link the PDF documents."**MINUTES:** Chairman Twilegar motioned to approve the minutes from August 30, 2022. All were in favor and the motion passed. He then motioned to accept the minutes from the special meeting on September 1st, which was seconded by Commissioner Tucker and the motion carried.**TREASURER:** Commissioner Twilegar asked for an update. Treasurer Gina Turner said, "It's terrible! I thought I was going to be coming in asking for a lot of money." Twilegar interrupted and said, "Thank you for not doing that." She responded that they were only able to "do it" for \$1400. Twilegar said he was surprised by that. Turner said, "There were a lot of issues when we rebuilt the tax roll and it was charging interest on the Circuit Breaker payments." Turner's employee was able to work around it, rather than write a whole new program. She added, "But then yesterday, I discovered there's about 2,000 parcels [of land] where the mortgage is paid, or the tax payments, all of those got interest applied even though it was backdated." Treasurer Turner is looking at going "into each parcel individually, reverse the payment, reverse off late charges interest, and then reapply the..." Commissioner Twilegar broke in and asked how many parcels, then said, "Oh, crap." Treasurer Turner said on a lighter note, "But, we rebuilt a tax roll from 2021. We were only off by 92 cents, verses last year when we built it. So, that's good." Chairman Twilegar responded, "That's impressive... Wow, what a mess."**SOLID WASTE:** There was an application for a new hauler out of the Garden Valley area. Chairman Twilegar made a motion to approve the application license and all were in

favor, motion passed.

PLANNING AND ZONING FEES: Administrator Alex Gross discussed a fee resolution that he was working on to increase their fees. He said they were using the data from 2015, and would like to use the current data with new evaluation data when it comes out. He said the international code council had been adopted by the state of Idaho, adopting building codes. Gross said the inspection fees would go down, but it increases the fees on the buildings. There are also inspections that they are not currently charging for, but would like to charge. It is not currently in their fee resolution, but the inspections are required. This change will require a public hearing.**CASTLE MOUNTAIN HOMES APPEAL - AVIMOR:** Gross reported to the board that the neighbors filed an appeal. He would like to get rolling on this and suggested November 3rd for the appeal date. The date was agreed on by the clerk, even though it will be close to the election. There was discussion provided by Prosecutor Adam Strong regarding being incorporated within a city, and whether they annex from the county. Commissioner Twilegar motioned to approve a letter to the city of Eagle, "recommending that the city annex Avimor." The motion was approved.**LICENSE RENEWAL:** Clerk Prisco said the license for the clerk's and assessor's office was last renewed in 2018, but now they cannot access files and needed to look back in the original records. Chairman Twilegar said, "We've gotta do what we've gotta do," and then motioned to renew the yearly license agreement for \$3,620. This motion was also approved.**IDAHO CITY HISTORICAL FOUNDATION:** A piece of property was discussed as a contribution to the ICHF. Clerk Prisco will put together a resolution for the Veterans Memorial park.**NEW TRASH HAULING CONTRACTS:** The updated contract for Miller Enterprises was presented by the prosecutor. Commissioner Twilegar joked that it was "a messy business" and then motioned to approve the contract with the trash hauling company. This was approved. Then he motioned to approve the con-

tract with Republic, which was also approved.

DEMAND WARRANTS: YMC had billed the county for twenty-five hours of labor, which concerned Prosecutor Strong. He called the company, who stated that they had made a mistake and the number of hours worked was actually nine. Strong presented the new invoice, which was \$2,000 cheaper. Chairman Twilegar brought this to the attention of all the county employees and charged them to be "super careful about this" and to use their best judgment. The commissioner thanked Prosecutor Strong.

Clerk Prisco brought up another issue with improving the courthouse's airflow and billing that was done by YMC.

Commissioner Twilegar motioned to approve the YMC invoice in the amount of \$887. This motion carried.

LOWMAN INN: There was a big push by local residents to reduce the speed limit through Lowman, Commissioner Twilegar said. The board put on the agenda that they would be at one of the community meetings on September 14th. On Tuesday, September 20th, the board will be looking at property - listed as "Field Trip" on the agenda.

Adjourned at 9:38am.

September 13, 2022**Present:** Commissioners Steven Twilegar, Clay Tucker, and Ryan Stirm via phone.**Pledge of Allegiance****CONSTITUENT INPUT:** None**MINUTES:** Chairman Twilegar motioned to approve the minutes from September 6th. All were in favor and the motion passed.**ROAD AND BRIDGE:** Comp time for employees was discussed. Curtis Dill said he spoke with his employees regarding vacation time to be taken soon and remaining comp time. Chairman Twilegar motioned to pay out one hundred hours of comp time for one employee. The motion passed.**SHERIFF:** Chairman Twilegar motioned to approve the staffing agreement between the Boise County Sheriff's office and 24/7 staffing. This was approved.**LEGAL SERVICE AGREEMENT:** Commissioner Twilegar motioned to

adopt a legal service agreement between Boise County and a company that handles conflict litigation. Clerk Prisco said that they have been good to work with. There were all ayes and the motion passed.

VETERAN'S PARK: Commissioner Twilegar spoke concerning the Idaho City Veteran's Park and Resolution 2022-31 to transfer land from Boise County to Idaho City Historical Foundation. Prosecutor Adam Strong asked that they table this, "to be on the safe side" and have it first drafted in the newspaper. The resolution will be tabled.**RESOLUTION 2022-32:** Twilegar motioned to increase the 2022 Sheriff's Vessel Fund for unanticipated expenses. Clerk Mary Prisco said it was part of the 2021 annual report, and the new truck needed for the vessel program. She said, "This is just amending the budget for that." Twilegar again motioned to adopt Resolution 2022-32 to increase the Sheriff's Vessel Fund for unanticipated expenses. The budget was \$39,197 and increases \$49,523, and the amended budget is \$88,720 for the new vehicle for towing the vessel. This was seconded by Commissioner Tucker and passed.**EMERGENCY MANAG-****ER:** Additional funds with no match were discussed. Commissioner Twilegar motioned to receive the additional funds from the Idaho Office of Emergency Management for 2020 grant in the amount \$13,885. All were in favor and the motion carried.**CATERING PERMIT:** Commissioner Twilegar motioned to approve a catering permit for a wedding. This was approved.**CLAIMS APPROVAL:** Chairman Twilegar motioned to approve the claims approval for \$366,173. All were in favor and the motion was approved.**FIELD TRIP:** Commissioner Twilegar spoke about the field trip, "We're seriously considering the long-term future and these buildings, and the fact that it seems like every month that we're replacing an HVAC unit in all. In all, these buildings are awesome, but in the future, it would be nice to have everybody in one building. Maybe the sheriff on one level, and hopefully pay for all that with grant money." Prosecutor Strong referred to a 20-acre lot that they will be exploring on September 20th, and may consider doing a land swap with the state land near the baseball field.

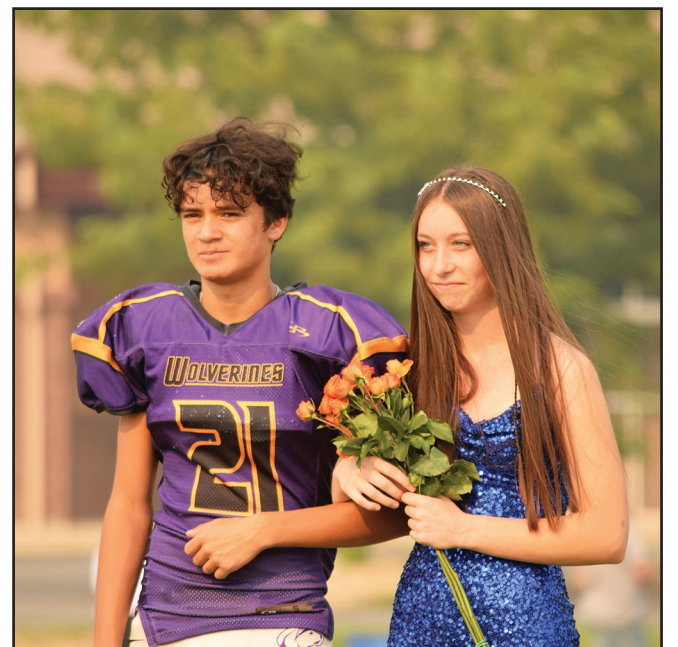

For the last four years, Josh has led a large reforestation program, helping to restore large fire scars from the 2016 Pioneer Fire, 2013 Pony and Elk complexes and has led in planning reforestation efforts following timber harvests to improve forest resiliency around the Bogus Basin area.

Horseshoe Bend City Council Meeting

The following is a synopsis of the Horseshoe Bend City Council meeting on September 14, 2022. Six people were in attendance for the meeting, along with two Boise County Sheriff Deputies. Three individuals appeared to join in via the city's Zoom link. All council members were in attendance.

Mayor Pat Goff made the call to order at 7:00 p.m. and then led the Pledge of Allegiance. After unanimous approval of the agenda, it was determined that approval for the minutes from the previous meeting, as well as the approval of bills to pay, was inadvertently left off the agenda. Both will be added to next month's agenda. Goff opened the meeting with a public hearing for the fiscal year 2022 budget, which had been amended. City Treasurer Terrie Nolan told the council that two grants were not accounted for in the budget, 250K for the sidewalks and 86K for the ozone generator. The budget was republished and with no comments for, against, or neutral, the hearing closed at 7:02 p.m. and the budget was passed unanimously without further discussion in the new business portion of the meeting.

Also in new business, the representative of the property owner residing at 120 River Avenue approached the council again regarding a zone change from residential to C-2 (general commercial). While the representative stated that they were "not here to make waves," they challenged the council to drive down River Avenue and look at all the other properties that are living and conducting business

on the premises. He described the area as "an island of residential in an industrial park." He stated that he wasn't asking for more than all his neighbors currently enjoy and he said he feels as though the city is discriminating against him.

City Attorney Tony Pantera said that a Planned Unit Development (PUD) was the process the property owner needed to embark upon. City Clerk Gina Elmer and Nolan both said that the other property owners each have two lots, one zoned residential and the other zoned commercial. He was then told that the clearest path would be through a lot split with one zoned residential and the other commercial. The representative balked at the idea because of the costs involved. City Engineer Amy Woodruff said that the PUD would need an engineer's report and that the lot split would be the most cost effective. Goff asked, "Can we get this done by next month?"

Councilmember Curtis Corvinus questioned whether anything could be done during the meeting to help the representative. Woodruff said, "Not really." She added that the most expedient method would be the lot split.

EMS: No report.

Public Works: The Department of Environmental Quality has been active in testing for algae bloom and the task has been challenging. The pump at the new Veteran's Memorial Park has been completed.

Grant Writer: Cheryl Pleak opened by stating, "The Sheriff's Office gave me 15 minutes tonight." Goff came

back with, "They don't have the authority, three minutes... now 2:50." Pleak stated that she had applied for a federal Parks and Recreation grant for the Veteran's Memorial Park that would share infrastructure expenses 50/50 with the city and that she had received a \$60,000 donation.

City Engineer: They have been supporting Public Works with the water quality and exploring tank ideas with the USDA. They have been working on the final details for the Deer Valley Subdivision development agreement

and indicated that they were not anticipating any changes.

City Attorney: Pantera said he was also involved with the finalization of the Deer Valley Subdivision development agreement.

Mayor Goff said he applied for and received a temporary permit for the new pump at the Veteran's Memorial Park. Gem County and Black Canyon have lodged protests against the permit, but Goff said that it looks like it will go through.

He then thanked the deputies for their attendance at the meeting.

Councilmember Patti Burgess asked the mayor what the new park will look like. Goff responded that right now they are just trying to get grass and parking ready. Burgess said she was worried that everything would be dug up at a later date for a "splash pad." Goff said that the plan right now is to have it set up for the planned Veteran's Day event on November 11.

The council went into executive session at 7:22 p.m. to discuss pending litigation. Upon their return, the council authorized the mayor to execute a settlement agreement.

Reporter's Notes: No mention was made of the actual case involved, but court records show the city's only active case is against Canyon Street MHP, LLC and Jon Dufresne, which was filed in July 2021.

In related news, council

member Curtis Corvinus had an amended complaint filed against him alleging he took \$3,668.53 from the Horseshoe Bend Fire Department's Burn Out Fund during his tenure as the fire chief. The amendment upped the charges to felony grand theft, asserting that Corvinus took the money with the "intent to appropriate to himself certain property of another." Corvinus resigned his post as fire chief in March of this year, but currently retains his seat on the city council. If Corvinus is convicted of the felony charge, he will give up his seat on the council. The Constitution of the State of Idaho states, "No person is permitted to vote, serve as a juror, or hold any civil office who has, at any place, been convicted of a felony, and who has not been restored to the rights of citizenship, or who, at the time of such election, is confined in prison on conviction of a criminal offense."

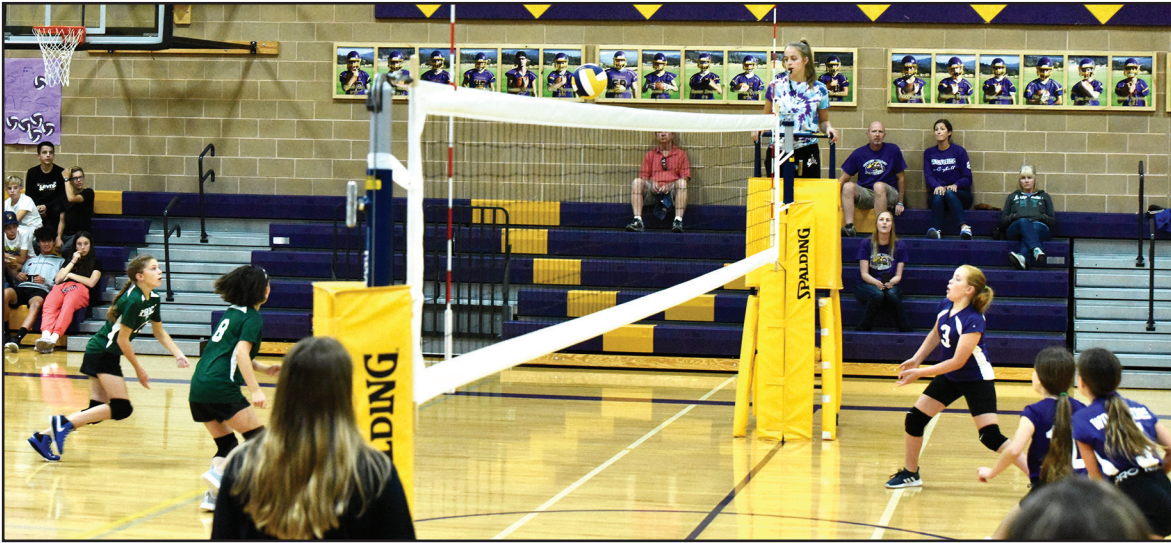

Family Advocates Volunteers Needed

BOISE COUNTY -- The Family Advocates Court Appointed Special Advocate (CASA) program is looking for volunteers to become Guardians ad Litem! Our mission is to strengthen families and keep kids safe by empowering everyday people to protect and enrich the lives of youth. In doing this we can create a stronger, healthier, and happier community.

A Guardian ad Litem (GAL) is a trained volunteer appointed by a judge to advocate for the best interests of an abused, neglected, or abandoned child. These volunteers spend time with the child at least once per month during scheduled or unscheduled visits, they speak with anyone who knows the child; family members, teachers, physicians, and social workers, and they review records and information pertaining to the child. They provide a report to the judge using the information they gather and are represented in court by a pro bono attorney that works with the 4th Judicial District CASA Program.

Children with a CASA volunteer supporting them are less likely to re-enter the foster care system and more likely to find a permanent home that is safe, either through reunification or adoption. Additionally, they are more likely to have better psychological wellbeing,



improved academic performance, and positive social relationships.

The Family Advocates CASA program operating in Ada, Elmore, Boise, and Valley counties is currently in need of 75 new Guardians ad Litem and 25 pro bono attorneys. In the last year, the number of children in these counties being served by the CASA program has increased by 10.2%. Currently, the majority of these children, 89%, are Ada County cases, 10% are Elmore County cases, and 1% composes Boise and Valley County cases. To volunteer as a GAL you must be at least 21 years old and able to pass a criminal history check through the Idaho Supreme Court. Volunteers are trained and supported throughout their case by the CASA team.

IDAHO CITY -- The Idaho City Regular Council meeting of September 14, 2022 was called to order at 6:00 p.m. Those present were Mayor Everhart, Councilmembers Tom Secor, Ashley M. Elliott, and Mari Adams. After the minutes were approved, Mayor Everhart decided to administer the oath of office to the new member, Ryan Heffington, so he could join the council and finish out the 4-year term of David Martin.

The bills/payable were approved from August 25, through September 14, 2022, in the amount of \$62,174.62.

The checklist for Mike Tam – “Java the Pup Celebration of Life” party was approved with a contingency on insurance. This will be held between noon and 6 p.m. on the block of Main Street in front of Harley’s pub, Councilmember Secor made a motion to approve an alcohol variance for that time.

The Engineers report was given by Mike Woodworth with Mountain Waters, he updated the council on the situation with the current water rights procurement. At this time, they have not found anything to purchase, but perhaps a long-term lease for the 1861 water right. There is also an option to be annexed into the Nampa/Meridian Irrigation District and use the water rights during ir-

rigation season. Council felt that it would be better to try to move forward with the lease option until the City could purchase a permanent water right. The water system facility plan is underway, a task order was provided for council review regarding the sand separator for the RO system and will be on the next agenda for approval.

Under old business, Superintendent Brian Hunicke from the Idaho High School asked for permission to use the building materials across from the City Shop to erect an indoor community sports facility. Public Works director Tami Claus did not have time to value the items for the structure. It was discussed, and Council believed the items were around \$3,000.00. It was determined that a resolution would be needed to donate the surplus materials to the school with an attachment fully describing the materials. This will be put on the next agenda as an action item. In the meantime, if the school needs to get measurements for future construction, they are free to do so.

A propane proposal was given by Shane McConnel from Valley Wide Propane, he presented the plan of action to get the propane transferred over to Valley Wide and get the City Hall propane generator hooked up soon. He will work with Clerk Ptak and Public works

director Tami Claus to organize a time to get the propane tanks emptied and set up new ones.

There was a discussion of the Idaho City Fire Protection District and the transfer of land deed. Clerk Ptak gave Council a written timeline of the fire station from the beginning and Idaho City’s involvement in the building. The Council has never said that they intended to evict the fire department from that building, that was a message that came up on social media and it is entirely false. At the time that the building was built, it was done with fundraisers, volunteers, and donations from patrons who wanted a Volunteer Fire Department in Idaho City. The City let them build on “City” property and have paid all the taxes, water, and sewer since.

Specific discussion was: “No one in our City Council wants to kick the fire district out. No one wants to hand it over without a fair trade to the City. It is beneficial to Idaho City to keep it and continue to lease it to the Fire District. If and when, the Fire District outgrows the need for this facility, the City would be able to use it for other uses. At this time, we will table this, until the City Council has been approached by the Idaho City Fire District with a proposal for us to consider.”

Regarding the approval

of CLG grant bills for the Idaho Heritage Conference, Rhonda Jameson was not able to be present, Clerk Ptak explained that in the past the City was the middleman, so to speak, for the CLG grants. The Historical Commission would provide the receipts, the City would pay them and be reimbursed for said receipts. This year, however, it may be more of a scholarship, and it has not been determined if the City will need to be involved financially.

Ordinance No. 325 and Resolution No. 2014-23 Event checklist review. Councilmember Ashley M. Elliott had written up some thoughts and ideas to add to the Park Usage in town, as she is also on the Idaho City Historical Foundation. They are currently updating their policies for the use of the parks and she thought that if Idaho City and the historical Foundation were similar it would create a clear understanding of what should be expected when any of the City properties are used for events. The City would need to update the current ordinance and checklist for events. Council will look over the proposal and add thoughts and ideas.

Resolution No 2022-07 – Authorizing destruction of records. Clerk Ptak provided the council with a few different options on how the City could safely destroy records. The best option was to have Amanda Leader, Boise County Community Justice Director, appoint a community service member to shred the documents while supervised. Council and City Attorney, Joan Callahan, has looked through the list and did not see anything that they felt needed to come out. Items of any significance have been scanned and the city has an electronic copy of the documents. Councilmember Secor made a motion to approve Resolution 2022-07 authorizing the destruction of records and allow Amanda Leader from

Community Justice to provide the means of the destruction of the documents. This was seconded by Elliott and all councilmembers agreed.

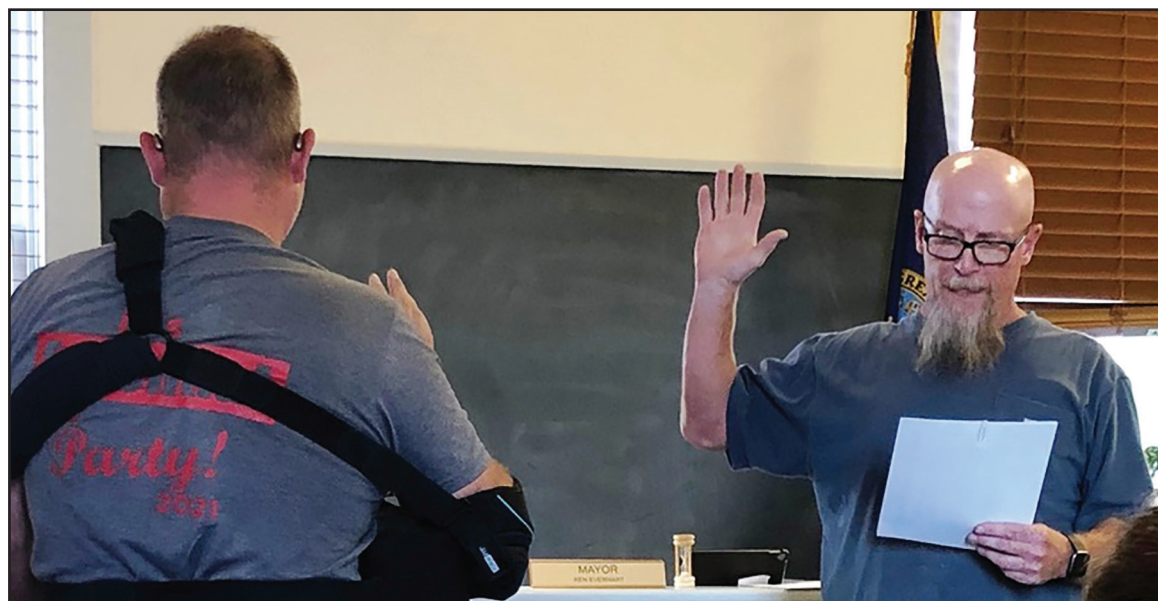
There was an Executive session and no action was taken.

Public works Director Tami Claus updated the City Council and introduced new hire Chad Sinclair. She discussed the sand bay cleaning, upcoming projects, and the needed repairs for the water main line in the next few weeks before winter freezing takes place in the Mores Creek Subdivision on Nugget Court. A message will need to be sent out to all of those affected as the water will be temporarily shut off. Once the details are resolved, Clerk Ptak will post on the website and send out letters to those customers. Councilmember Heffington will also give the same notice to the HOA of Mores Creek. There are at least 5 services that will be directly affected, but more could possibly be without water for a short period of time as the line gets buried deeper.

Under Law Enforcement, Clerk Ptak gave an update for Chief Otter. They have finished the first overtime grant and the City should see reimbursement soon. The grant for two electronic speed signs is underway. A grant for e-tickets and tough books for the police vehicles is also underway. The police force has been busy with citations. They have also been dealing with people taking water from private and public areas and have informed some of the public areas to lock their outside facets. They will continue to monitor.

Clerk Ptak presented the council with an application and contract for city water and/or sewer services for them to consider. The current ordinance would need to be amended to reflect any deposit over 50 dollars. This could be beneficial to

those who are constantly late on payments and to give any new residents a clear picture of what is required for them to have services. Council has reviewed the past due accounts. At the next Council meeting, adjustments and a few other questions regarding usage will be presented.

Clerk Ptak will be attending a "clerks" conference next week and will have the city laptop with her to keep on items as needed. She will post the next agenda from out of town, if council or mayor have anything they want or need she has asked them to email her.

Councilmember Secor asked about the generator that was delivered at the RO site, he stated that he would be willing to help with placement and needs to know the time. Sam Aarons has been finishing up with the Stamp Mill and it should be in place soon.

Mayor Everhart had an update regarding Parks and Recreation. He explained that Idaho State Parks and Recreation may have found money to help the City obtain the BLM property. Councilmember Secor will get more information and investigate this further.

Meeting adjourned at 7:45.

APPROPRIATION ORDINANCE AMENDMENT

AN ORDINANCE OF THE CITY OF HORSESHOE BEND, IDAHO, AMENDING ORDINANCE NO.266, THE APPROPRIATIONS ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2021, APPROPRIATING ADDITIONAL MONIES THAT WAS RECEIVED BY THE CITY OF HORSESHOE BEND, IDAHO IN THE SUM OF \$298,465.76; PROVIDING FOR REPEAL OF CONFLICTING PROVISIONS AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Mayor and Council of the City of Horseshoe Bend, Boise County, Idaho:

Section 1: That Ordinance No. 266, the appropriations ordinance for the City of Horseshoe Bend, Idaho, for the fiscal year commencing October 1, 2021, be, and the same is hereby amended as follows:

That the additional amount of \$298,465.76 be appropriated for the General Fund and Water Fund Grants to be used for sidewalks and Ozone generators.

Section 2: All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.
