Garden Valley Schools Impending Water System Failure & Public Meeting



Dear parents and community members,

A few years ago, our school district entered into a contract with Mountain Waterworks Engineering to conduct a study on our drinking water and wastewater facilities at Garden Valley Schools. This was done due to concerns around the capacity and functionality of these systems. Indications at the time were that these systems would be over capacity within the next 3-5 years. The Idaho Department of Environmental Quality also partnered with the school district to fund 50% of the costs of these engineering studies to determine what upgrades, additions, or changes need to be made to our systems. Mountain Waterworks has completed their study and will be presenting their findings, their recommendations, and various options available to us at a public meeting on **Wednesday, September 28, 2022 at 6pm** in the MPR at the Garden Valley School building.

grades or new construction will be needed within the next few years. These improvements come with a cost to the school district. We are seeking grant funding and government funding for these improvements, and we will continue to explore all opportunities and options for funding from many different sources. However, there could be some cost to the taxpayers of our school district in order to fund these needed improvements. As such, it is important that everyone in the public have a voice in the decision process.

We invite you and encourage you to attend this important meeting and give us your input. We also ask that you encourage your friends, your neighbors, and your fellow community members to attend. We value the input of our key stakeholders when making important decisions that affect our school district and our community.

Pledge of Allegiance

CONSTITUENT INPUT:

Debra Jackson asked again about documents being added to the agenda by the clerk. She requested an update. Clerk Mary Prisco said the problem was with the For the Record (FTR) audio recording system and they will need to change out the computer. She said the FTR version they have is from 2008 or 2006, "It's thousands of dollars." Prisco said last time it was \$3,000, but they are looking into getting a system from the state court rather than paying for a new license. Chairman Twilegar stated that they were working on it, but, "It's not going to happen overnight."

SHERIFF: Sheriff Scott Turner spoke about the desks that were breaking or broken, and the cabinetry is from over 30 years ago, when the county had a jail at the sheriff's office. There's also problems with the cables and wiring. He described a plan where "they would do all the work themselves" and get wiring straightened out, pull out the plywood cabinets, flooring, painting, etc. Sheriff Turner discussed

buying some desks for the dispatch station and some floating bookcase shelves for items that they share daily. The sheriff is hoping these will last them another 30 years.

Commissioner Twilegar motioned to approve "the purchase of two banana control room desks" and a rotating bookcase in the amount of \$17,026.

MINUTES: Chairman Twilegar motioned to approve the minutes from Tuesday, September 13, which was seconded by Commissioner Stirm. The motion carried.

SHERIFF: There was discussion regarding mapping [GIS], shared between the Sheriff's and Assessor's office, that was up for renewal. Commissioner Twilegar motioned to enter into the contract with Motorola - GIS services for one year in the amount of \$8,169.

CANINE DONATION: Sheriff Turner said that several of the officers have reached out to him regarding getting another canine. He spoke with the prosecutor. A Boise County narcotic deputy is still a certified K-9 instructor, and the sheriff has a deputy that already had a K-9 that has been certified. The sheriff was contacted by "the head K-9 guy

from Canyon County and they offered to donate a K-9" that is a 1-year old lab or a shepherd.

Commissioner Twilegar asked the prosecutor what he thought. Prosecutor Strong responded that there was "a lot of drug activity going on in the county and I think it's a tool that will help CARES [Children at Risk Evaluation Services] office and us going forward." He said that the cost was fairly minimal.

Commissioner Twilegar asked which dog they were inclined on getting and the sheriff responded, "the lab." Sheriff Turner said, "It's just a detection dog, it's not a bite dog, it's not an apprehension dog." Commissioner Tucker said he had no problem with the dog. Twilegar said firmly, "I like the idea, the more we can get drugs out of here, the better." Chairman Twilegar made a motion "to accept this kind offer from Canyon County for one drug-sniffing dog." Commissioner Tucker quickly seconded. The motion carried.

PLANNING & ZONING: Alex Gross from Planning and Zoning presented the findings of facts and said, "The site specific condition, related to the sound test... we used what you said at the meeting and conformed it to state law."

COMMUNITY JUSTICE: The struts need replacing on their 2014 Chevy Equinox. It was stated that the Equinox was not suited for these roads. Commissioner Tucker questioned, "Why do we have a Chevy Equinox at all?" Amanda Leader said it was before her time and she was not here for that purchase. Commissioner Twilegar suggested fixing the vehicle for now and reevaluating it at the end of the year. He then motioned to accept the bid for \$2,202.20 for the struts.

Leader discussed the details of two bids received for ridding their building of bats. The bats will be leaving for the winter, sometime in October. The commissioners decided to address the issue in the early spring.

CHARGE TITLE COMPANIES: Commissioner Twilegar made a motion to rescind the motion made in June to charge title companies for services rendered. He will address this at a later time.

PUBLIC DEFENDER CONTRACT: Commissioner Twilegar motioned to accept two contracts for public defenders. Clerk Prisco gave the commissioners a heads up that there would be one more public defender contract.

BOISE COUNTY RESO-

LUTIONS: A resolution to increase all Boise County funds, departments for salary budgets for the FY22 budget. Clerk Prisco said, "It's a large amendment" because it encapsulated all payroll. She explained that they budgeted for the normal 26 pay periods, and this year there will be 27. Prisco said, "Without doing this, we're going to run negative in pretty much all of our salary." Commissioner Twilegar asked how often this happened, the clerk estimated every ten years, and someone else said every fourteen years. Clerk Prisco joked that she would not likely be around for the next time and Twilegar said the only one that would be around would be Commissioner Clay Tucker.

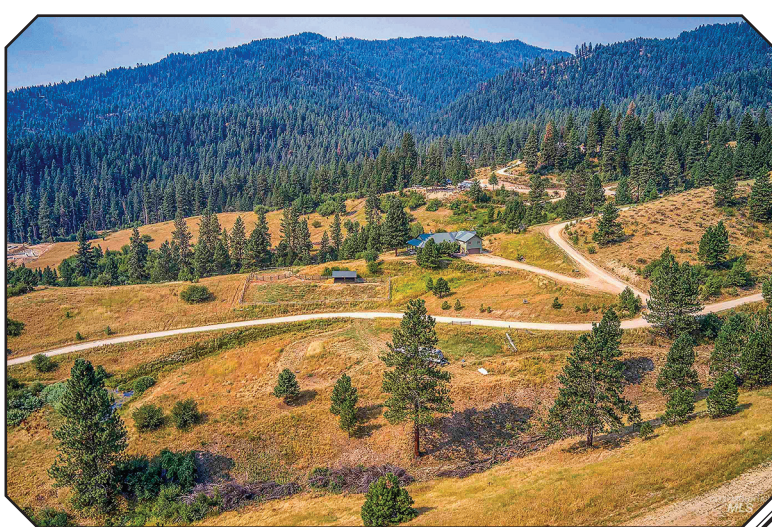
Chairman Twilegar motioned to adopt Resolution 2022-33, and Tucker quickly second. All were in favor and the motion carried.

Boise County Resolution 2022-34 a declaration of intent to abandon, and vacate, or validate Confederate Gulch and Quartzburg Road. Prosecutor Strong said they should form a resolution and then provide a public notice on this. He said this starts the process, "This doesn't really bind you to anything, it's just saying this is

our path. We're holding public hearing on this and we'll take public testimony."

Commissioner Twilegar asked regarding Forest Service Road 399 and other roads that are being gated off by private entities from Texas. The prosecutor recapped his discussions from three years ago with the Forest Service, but Twilegar would like to put on a future agenda to discuss Forest Service Road 399, "people are still talking about it. I would like to settle it once and for all. I guess I don't understand how a private entity could gate a Forest Service road."

Prosecutor Strong said it was complicated, "just because it has a Forest Service number, doesn't necessarily mean that it is." Strong said that a RS2477 road was a term for the legislation for certain public roads that he would discuss with the board at a later time. Twilegar pointed out, "There's a lot of people still pissed off about it."

Chairman Twilegar motioned to adopt Resolution 2022-34 a Boise County resolution to abandon, vacate, or validate Confederate Gulch Road and Quartzburg Road.

Resolution 2022-35, a Boise County resolution amending

the Planning and Zoning budget was discussed. Clerk Prisco stated, "We are significantly over in the legal fees budget. This increase is based on the additional legal fees revenue or reimbursements, if you will, that have come in, as well as what is anticipated to come in that's out there... This is basically the result of certain legal costs that the county incurs and then we pass on to the customer." Chairman Twilegar asked if this "were primarily due to appeals and so forth?" She said some were, but there were smaller ones too. Prosecutor Strong clarified, "Those costs do get passed on to the, either the applicant or appellant, whoever is doing it. So, we pay them and then we get paid back by the applicant for the amount." Commissioner Twilegar motioned to adopt Resolution 2022-35 to adjust the Planning and Zoning budget. The motion passed.

Resolution 2022-36, Clerk Prisco said was for the vehicle that was totaled. The insurance proceeds were reflected in this resolution and the capital account. This resolution was motioned, adjusting the Sheriff's Department budget. This was approved.

Resolution 2022-37 was to

adjust the fuel budget for the Sheriff's Department. Clerk Prisco said there would also be a resolution to adjust the Road Department's fuel budget and parts/ maintenance. She said, "It's basically budgetarily transferring from one department into another." All were in favor and the motion carried.

Resolution 2022-38 was an adjustment to the general fund, including maintenance on the vehicle in the Planning and Zoning office, and the refunds from the P&Z office count as an expense. All were in favor of this motion and the motion passed.

PAYROLL BUDGET: Commissioner Twilegar motioned "to approve the final approved payroll budget for the year 2022." All were in favor and the motion carried.

LIQUOR LICENSE: Commissioner Twilegar asked if a business "had to be in an incorporated city to have a liquor license?" Clerk Prisco clarified that it was for hard alcohol. The license for the Clear Creek Lodge was for beer. Twilegar made a motion to approve this retail beverage license for the Clear Creek Lodge. All were in favor and the motion carried.

EAST BOISE COUNTY AMBULANCE DISTRICT: Chairman Twilegar motioned to accept the final approval for payroll budget 2023 for EBCAD, which passed.

EXECUTIVE SESSION: A closed session for pending litigation. [Time 10:06 am to 10:12 am] No action was required.

FIELD TRIP: Commissioner Twilegar said they were going to take a field trip "regarding potential trade of land with the Forest Service."

APPEAL: Twilegar said a motion to approve the findings of fact, conclusions of law, and order an appeal 2022-003. This was seconded and the motion carried.

AGENDA ITEMS: The Board of County Commissioners planned to meet next on Monday, September 23rd for a few action items and then attend a meeting with the Idaho Association of Counties on Tuesday. Clerk Mary Prisco recounted the primary things on Monday morning would include a levy certification for all of the taxing districts and the public hearing for the 2022 budget. There's also a resolution for the Road Department.

The board left for a field trip at 11:04 am.

Horseshoe Bend Volleyball & Football

Volleyball: At home on Tuesday, September 23, the Horseshoe Bend Varsity Mustang Volleyball team defeated the Tri-Valley Titans in 1A DII Long Pin Division conference play 25-18, 25-11, 25-16. Statistical standouts were junior Abby Howerton with 10 kills (an attack on the ball which is not returnable by the opposing team), 2 aces (a serve which is unable to be played or returned by the opposing team) and 10 digs (passing a spiked or hard hit ball). Sophomore Aliyah Meyer had 4 kills, 8 aces, 10 digs and 26 assists (pass, set, or dig ball to another player who gets the kill), while sophomore Ashlyn Wolsleben contributed 1 kill, 1 ace, 13 digs, and 4 assists.

In Council on September 23, the Mustangs came in on top 25-16, 25-22, 25-22 in a conference game against the Lumberjacks. Stat leaders were junior Annelie Wilson with 18 kills, 2 aces, 2 blocks (blocking the ball into the opponent's court leading to a point or side out), 5 digs, and 1 assist. Howerton

had 8 kills, 3 aces, 21 digs, and 1 assist, and teammate Wolsleben had 1 kill, 4 digs, and 36 assists.

On their home court on Monday, September 26 the Mustangs faced off against a non-conference rival, the Adrian Antelopes, and won handily with 25-12, 25-19, 25-5. Helping in the stat department were Wilson with 11 kills, 3 aces, 5 blocks, 5 digs, and 4 assists. Meyer with 7 kills, 1 ace, 15 digs and 21 assists, and Howerton came in with 6 kills, 4 aces, 1 block, and 9 digs.

The team has some time off until Friday, 10/7 when they host the Garden Valley Wolverines at 5:15 (JV at 4:00). The team is 13-1 overall for the season and 5-0 in conference play.

Football: On the road to Council on Friday, September 23, the Horseshoe Bend Varsity Mustang football team fell short to the Council Lumberjacks 26-44. Junior quarterback Carson Drake raked up 224 passing yards with 4 touchdowns, but it wasn't enough

against the stronger Lumberjack team. Senior Blayne Meyer had 146 receiving yards, 23 rushing yards, and 3 touchdowns. Senior Jedi Graham had 71 receiving yards and 1 touchdown, while junior Kaelun Jones had 23 rushing yards and 4 receiving yards. Junior Gavin Tomlinson had 3 receiving yards. On defense, Tomlinson had 8 tackles, senior Zeke Ochoa had 6 tackles, as did Meyer. Graham, senior Kash Smith, and junior Nic Cooper each had 5 tackles and Jones had 4.

The Mustangs are at home against Long Pin conference rivals the Salmon River Savages (1-4 overall, 1-1 conference) in a homecoming showdown on Friday, September 30. Kickoff is at 7:00 with Homecoming festivities during half-time.

The Mustangs are currently 3-2 overall and 1-1 in conference play.

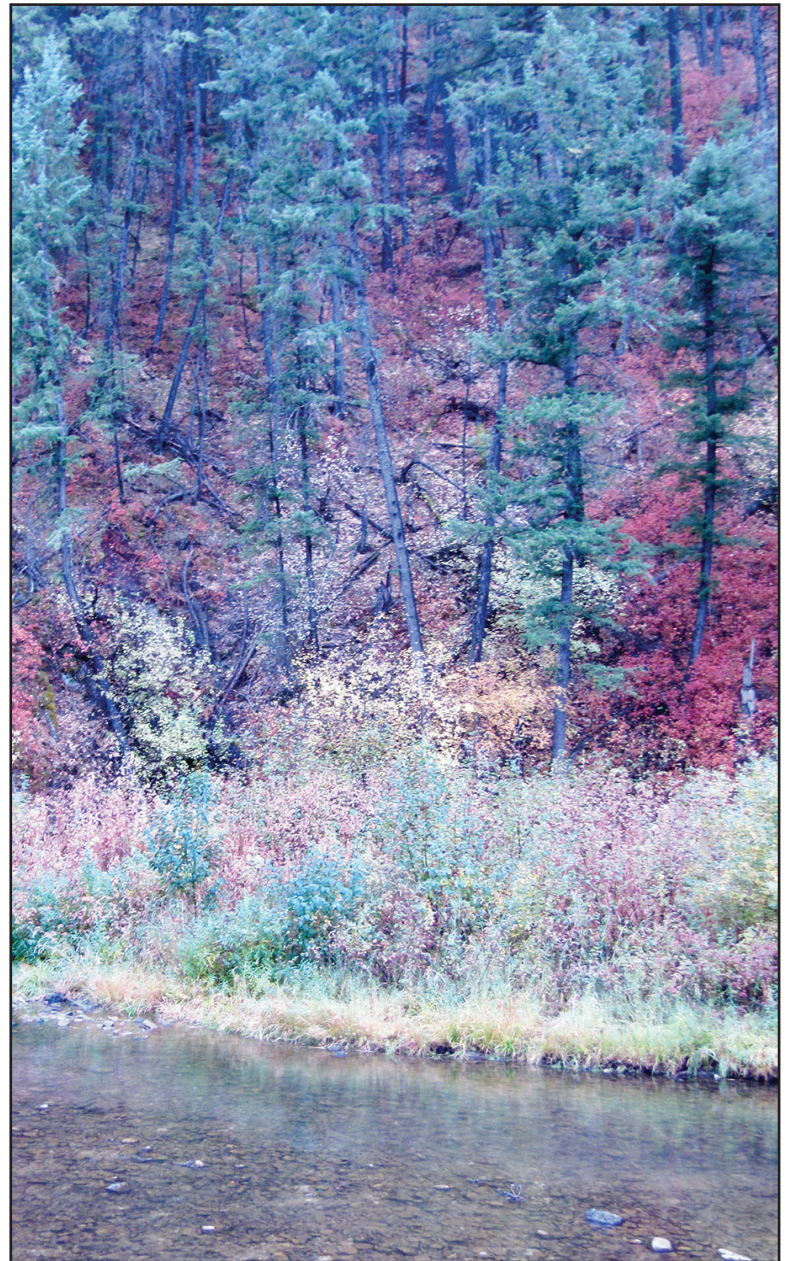

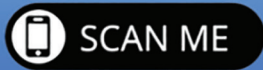

Idaho Constitutional Amendment SJR 102

Legislative Council's Statement of Meaning, Purpose, and Result to Be Accomplished
Currently, the Legislature may meet in a special session only upon call of the Governor. The proposed amendment would allow the Legislature to convene itself in special session if 60% of the members in each house submit a petition to the President Pro Tempore of the Senate and the Speaker of the House of Representatives. The

petition must specify the subjects to be addressed in the special session, and only those subjects could be considered during the special session.

The amendment also requires the Legislature to hold an organizational session in December following a general election. The purpose of the organizational session is to prepare for the upcoming regular session. The proposed amendment would formalize in the Idaho Constitution the Legislature's longstanding practice of holding an organizational session.

Statements FOR the Proposed Amendment

This constitutional amendment is needed to correct an imbalance of power among the three branches of government. The executive and judicial branches of government have no restrictions on their ability to conduct business when and as they deem appropriate, and the legislative branch should have the same power.

Idaho is one of just 12 states whose legislature has no power to convene itself into a special session under certain circumstances. The Idaho Legislature should not be dependent on the Governor to call it into special session when extraordinary events occur. For example, in 2020, the Idaho Legislature wished to convene to consider Covid-19 matters and the expenditure of federal funding related to the pandemic but the Governor delayed convening the Legislature. Idaho should join the 38 states (including all of Idaho's neighboring states) that recognize the legislative branch of government's right to determine independently when it should convene and conduct the business of the people it represents.

Authorizing the Legislature to convene itself into special session will prevent the need for one or both houses of the Legislature to defer adjourning sine die indefinitely as happened in 2021 when the House of Representatives wanted to preserve its right to take up anticipated issues later in the year. Deferring the date of adjourning sine die results in numerous administrative problems such as delaying effective dates of legislation and administrative rules. If the Legislature is able to convene itself, there will be no need to avoid adjourning sine die.

The proposed amendment contains sufficient safeguards against any potential abuse of power by limiting the subjects of legislation to be considered during a special session to those listed in the petition, just as a special session called by the Governor is limited to the subjects listed in the Governor's proclamation.

Statements AGAINST the Proposed Amendment

The Legislature has conducted its business for over 130 years without needing the ability to call itself into special session. This constitutional amendment is not necessary because the Governor has called and can continue to call the Legislature into a special session when necessary. Passing this amendment would remove a check and balance from the Idaho Constitution.

The Idaho Legislature is a part-time citizen legislature. The proposed amendment provides no limitations on how

often special sessions may be called or how long they may last. Idaho should not move toward having a full-time legislature, and Idaho's part-time citizen legislators with other careers should not be burdened with sudden, unpredictable special sessions.

Idaho businesses and citizens need the stable, predictable, and routine timeline of the regular legislative session to communicate with legislators regarding the effects that pending legislation may have on businesses and citizens. The ability of the Legislature to convene itself into various special sessions may result in the passage of legislation that has not been properly vetted and could result in unintended consequences for Idaho businesses and citizens.

The proposed amendment requires a petition signed by only 60% of the members of each house of the Legislature. This threshold is too low. Many states require a higher percentage, such as 67% or 75%. A higher percentage would deter the Legislature from convening itself for subjects that may be trivial, vague, or not widely agreed upon.

Amendment Text

Section 8. SESSIONS OF THE LEGISLATURE. (1) The regular sessions of the legislature shall must be held annually at the capital of the state, commencing on the second Monday of January of each year, unless a different day shall have been appointed by law, and at other times in extraordinary sessions when convened by the governor and in organizational sessions commencing on the first Thursday of December after the general election, unless a different day shall have been appointed by law.

(2) The legislature, while remaining a part-time, citizen legislature, must also be convened in special session by the president pro tempore of the senate and the speaker of the house of representatives upon receipt of a joint written petition of at least sixty percent of the membership of each house, specifying the subjects to be considered. Such special session must commence no later than fifteen days after the petition is received by the president pro tempore of the senate and the speaker of the house of representatives. At a special session convened pursuant to this section, the legislature shall have no power to consider or pass any bills or resolutions on any subjects other than those specified in the petition and those necessary to provide for the expenses of the session.

Falls Prevention Awareness

What a Difference a Few Simple Things Can Make

Every day, we look for ways to optimize our efforts. If we can find activities that accomplish multiple goals at once that is even better. This is especially true when it comes to things that benefit our health. For all of us, but especially those over age 60, a significant cause of accidental injuries and death each year are due to falling. Falls often result in expensive emergency department (ED) visits and hospitalizations. Older adults often end up in costly long-term care facilities. The financial cost can be overwhelming. Beyond the initial injuries, a person's ability to actively engage in life, impacting their physical and emotional health, can be the result. Wouldn't it be nice to be able to prevent falls from happening to begin with?

Yes, there is good news! Most risk factors that increase the likelihood of falling can be minimized or eliminated. A few of the most common risk factors and some solutions include:

- Trip hazards at home and work

Improve lighting, re-route cords across walking paths, remove clutter on the floor, remove or secure loose floor coverings, add non-slip mats to showers/tubs, fix uneven/loose steps and handrails.

- Inappropriate and poorly fitting footwear

Wear shoes that fit well and provide proper support for activities. Loose-fitting shoes,

untied laces or those that hang to the ground, and especially "open" shoes like flip-flops and open-back slip-ons can contribute to falling.

- Lower body Strength

Don't be a body builder but ensuring strength and flexibility in our back and legs can mean the difference between a stumble and a fall with injuries.

- Medication

Many common over-the-counter and prescription medications can cause issues with balance, reaction time, dehydration, and other contributors to falls. Work with your healthcare team to reduce or change problematic meds.

- Poor Vision

Wear glasses or contacts that correct your vision as much as possible. (Sometimes we can't fully correct all vision issues.) In addition, be sure to remove reading and computer glasses, and look through the top part of bi-focals or remove them before walking.

Every one of these risk factors can be identified and most can be completely resolved at little or no cost. At the same time, we can reduce the very

significant medical costs of fall-related injuries in Idaho, which is more than \$253 million each year (\$50 billion nationally).

Download the Idaho Power mobile app and sign up for push notifications to receive outage information specific to your home or business, or sign up to receive outage text or email alerts at idahopower.com/myaccount.

Prepare for medical needs, whether those are related to refrigerated medicine or electrically powered medical equipment.

Find a way to feed and water pets, service animals or livestock in case well pumps don't have power.

Learn how to manually open security gates and garage doors.

Gather an emergency kit with the following items to have on hand:

- Flashlights
 - Matches
 - Blankets
 - Bottled water (5 gallons per person)
 - Non-perishable food (canned goods, crackers, etc.)
 - Non-electric can opener
 - Baby food or formula and diapers, if needed
 - Pet food, if needed
 - First-aid kit and any prescription medications
 - Battery or solar-powered chargers for your devices
 - Battery-powered radio, clock and flashlight
 - Extra batteries
 - Board games or cards for entertainment
 - A block of ice in the freezer
