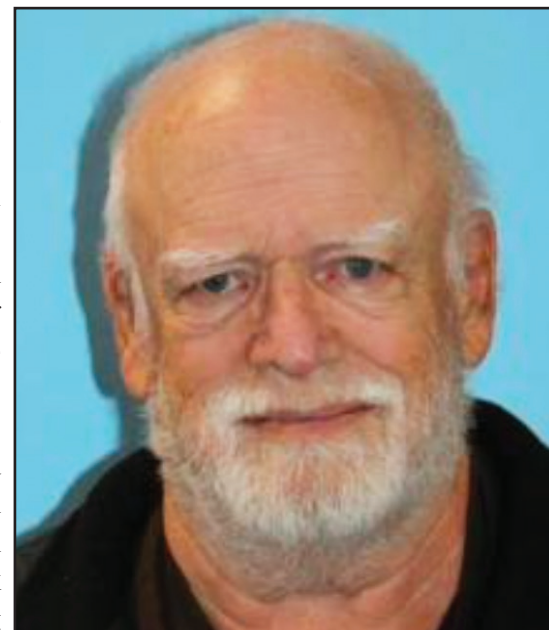

Endangered, Missing Person Found in Boise County

BOISE COUNTY --

Meridian detectives and the FBI used cell phone forensics to narrow down the search for a missing vulnerable adult, Robert Trotter. He was found on October 12th at about 1pm in the Porter Creek area. According to Boise County Sheriff Scott Turner, Idaho Mountain Search and Rescue had checked the area along Porter Creek, to the top of the mountain. Trotter, 77, was found down an old, unmaintained, road where he managed to drive his vehicle. Sheriff Turner recounted, "While hiking, he fell and made his way to the road where he was laying." A deputy got on scene and used a UTV from a hunting camp in the area to help transport Trotter to a Life Flight helicopter.

hydration, Trotter had last been seen leaving his church Sunday morning in Meridian on October 9th. His cell phone pinged in Horseshoe Bend and Banks later that same afternoon.

Sheriff Turner discussed the remarkable rescue and explained that the area had previously been searched by deputies and Search & Rescue, "They just happened to stop and walk down the old trail/ road and find him."

Present: Commissioners Steven Twilegar, Clay Tucker, and Ryan Stirm (via phone)

Pledge of Allegiance

CONSTITUENT INPUT:

None

MINUTES: Chairman Twilegar motioned to approve the minutes from October 4th. The motion passed.

TAX CANCELCATION: A tax cancelation was brought before the board for a piece of property owned by the federal government. Prosecutor Adam Strong explained, "We sent a bill to property that was owned by the federal government, and the federal government doesn't pay taxes." Treasurer Gina Turner further explained that the federal government does not pay taxes. Commissioner Twilegar motioned: "To approve the tax cancelation for the United States of America in the amount of \$31.72." The motion carried.

SCHOOL RESOURCE OFFICER: Chairman Twilegar motioned to approve the contract for the school resource officer in the Garden Valley School. This motion was approved.

CLAIMS APPROVAL: Clerk Mary Prisco explained, "This is a difficult time of the year for the financial reports that we receive and the bills, because the CAI financial cannot separate the 2023. It can

still do the 2022, because we haven't closed the books for fiscal year 2022. But, we can't separate out the '23." She said there were two bill cycles.

Chairman Twilegar motioned to accept the 2022 claims report in the amount of \$115,356.20. The motion carried.

DEMAND WARRANTS: Twilegar motioned to accept the 2023 demand warrant in the amount of \$1572.63.

EXECUTIVE SESSION: Closed session for a personnel issue. [Time 9:12am to 9:20am] Coming back into session, no action was required.

EXECUTIVE SESSION: Chairman Twilegar motioned again to go into executive session under pending litigation. [9:20am to 9:32am] Coming out of executive session, Twilegar said there was no action required.

CLAIMS APPROVAL REPORT: Commissioner Twilegar motioned to approve the claims approval [2023] report in the amount of \$182,386.90. The motion carried with all eyes.

RS2477 ROADS PROCESS DISCUSSION: Chairman Twilegar opened the discussion regarding blocking the RS2477 roads in the county. Prosecutor Strong said he didn't have research on any particular road, but "if it is a

public road, if it is a RS2477 road, that means you can't block it." He then started the discussion on what a RS2477 road was, "there are nine ways to create a public road in Idaho." Strong explained, "RS2477 is federal legislation from 1866 and is literally one line... And be it further enacted that the right of way for the construction of highways over public lands, not reserved for public uses, is hereby granted." He said it was repealed in 1976, "but that's proactive. You can't create any additional roads after 1976, but if roads were created under this legislative grant prior to 1976, then it is a RS2477 road even though the RS2477 statute was repealed in 1976." The road must be on "unreserved federal land." The Boise National Forest was formed in 1908. Strong said, "Prior to 1908, all Boise National Forest was unreserved, just federal land that was unreserved." Patented mining claims were not unreserved land, "but it doesn't matter what the current status of that land is, it matters what the status of it was when the road was first created, essentially." He clarified, "So, it has to be on unreserved land and then it has to be - the second prong is it has to have been accepted by the state or local agency." They would need a map and/or commissioner res-

olution prior to 1976 showing public access. There was also discussion regarding how to handle these roads if they've become part of a mining claim, private land, or national forest, and whether the roads were prior to this being used for any other purpose.

Prosecutor Strong said there was a hearing in two weeks on a RS2477 public right of way. "Currently, if there was a RS2477 road, prior to it becoming private land, you don't have the ability to block it, you don't have the ability to gate it, but sometimes finding the historical records to prove that is a RS2477 is usually the impediment to establish that." There was discussion of whether an RS2477 could be shown if it had been used as a road or trail prior to 1881, "then that's a road," the prosecutor said. Research will need to be done and Clerk Prisco recommended an individual with a law firm.

PUBLIC HEARING: Alex Gross with Planning and Zoning discussed two parcels of land in Duquette Pines subdivision, and a lot line adjustment, with direct access from Meadow Drive. The request is being made so that there's a

better place to build a house. Gross said the land was "consistent with comprehensive plan, in respect to private property rights." He added that, "We don't believe that there's any significant impact from this request at all" and advised that the commissioners approve the plot line adjustment.

Commissioner Twilegar motioned to approve the lot line adjustment for Section 13, Lot 21, Block 5 in Duquette Pines with conditions. The motion carried.

PUBLIC HEARING: Commissioner Twilegar opened the hearing for Old Mill Acres minor subdivision final plat approval. Mr. Gross recapped on the splits within the land parcel, located off of Clear Creek Road. There was a proposed name change for the road, Woodcutter Lane. Planning and Zoning recommended approval with six conditions.

Chairman Twilegar motioned to approve the minor plat adjustment for the Old Mill Acres subdivision, including the road change, and conditions read. All were in agreement and the motion passed.

Horseshoe Bend City Council Meeting

HORSESHOE BEND --

The following is a synopsis of the Horseshoe Bend City Council meeting on October 12, 2022. Four people were in audience for the meeting. Councilmember Patti Burgess was not in attendance. Mayor Pat Goff made the call to order at 7:00 p.m. then led the Pledge of Allegiance. After unanimous approval of the agenda, minutes from the previous meeting and the authorization to pay the city's bills, Goff opened the meeting with a public hearing for a variance request at 105 Folwell at 7:04 p.m. The applicant's representative requested that the council consider a setback variance from the required 30' to 20' 8". The previous property owners had a mobile home on the lot that had the smaller setback (it was grandfathered in). According to the applicant, a new home could only be 7' wide to adhere to the 30' setback.

City Engineer Amy Woodruff provided a site plan that was provided by the property owner and stated that she didn't think it would damage the area, nor would it impact area service providers. She added that many of the existing structures in the area were erected before city codes were put in place. Councilmember Stephen Chartier responded by saying, "I don't see a problem with it." Councilmember Curtis Corvinus replied, "Neither do I."

A neighboring property owner told the council that she was in favor of the variance. Other

than the positive support from the neighbor no one else came forward in support or opposition to the proposed variance.

Goff closed the public meeting at 7:10 p.m. and councilmember Chartier made a motion to approve the variance. It was seconded by Corvinus and passed unanimously.

EMS Report: Goff told the council that soon they would be able to house EMS personnel on site 24/7 and that he was working on pursuing an EMS District within the county.

Public Works Report: The department is currently working with the Idaho Department of Environmental Quality (DEQ) on the algae situation that is coming from Lake Cascade. The new ozone generator is helping to maintain the water quality.

Sand removal at the dam took place and work is underway on the new pumphouse. Last month's lightning strike in the city caused some damage to the sewer plant and the department is currently working to make the needed repairs.

Goff asked the department to look into getting a battery back-up for the system and eventually getting a generator for the plant.

Grant Writer: No report.

City Engineer: Woodruff told the council she's been dealing with citizens regarding setback and land use questions and wrapping up, with DEQ, the emergency funding grant to help with the current bacteria problem coming from Cascade reservoir.

City Attorney: City Attor-

ney Tony Pantera said he was reserving his comments for the executive session. Goff stopped the meeting at 7:19 to go into executive session to discuss pending litigation.

Editor's Note: Curtis Corvinus had a notice of arraignment in District Court with Judge Peter Barton, scheduled for October 14th; however, an entry of plea has now been scheduled for November 18 at 2:00pm. The felony grand theft complaint filed against him alleges that he took \$3,668.53

from the Horseshoe Bend Fire Department's Burn Out Fund during his tenure as the fire chief. Corvinus stepped down as fire chief in March of 2022, but retains his seat on the city council. If convicted of a felony, he would no longer be able to serve on the council.

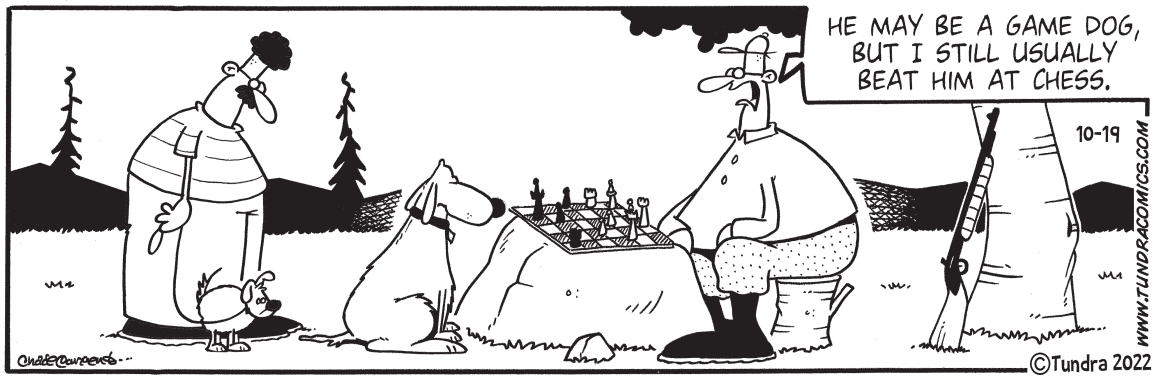

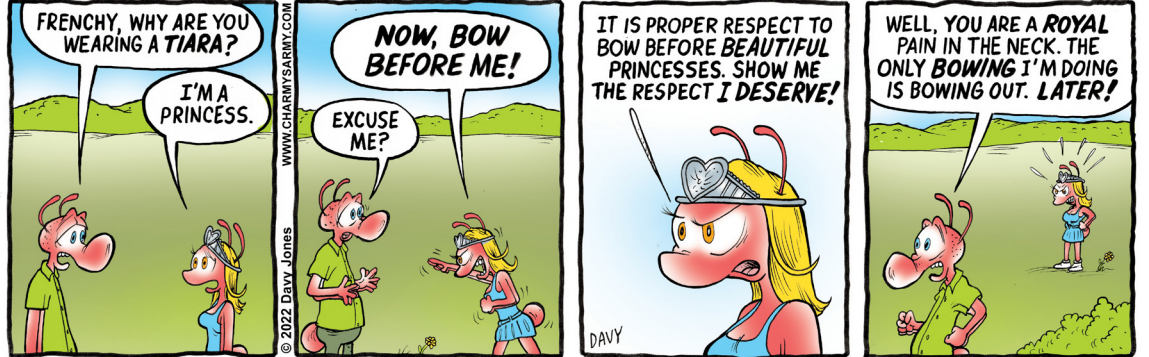

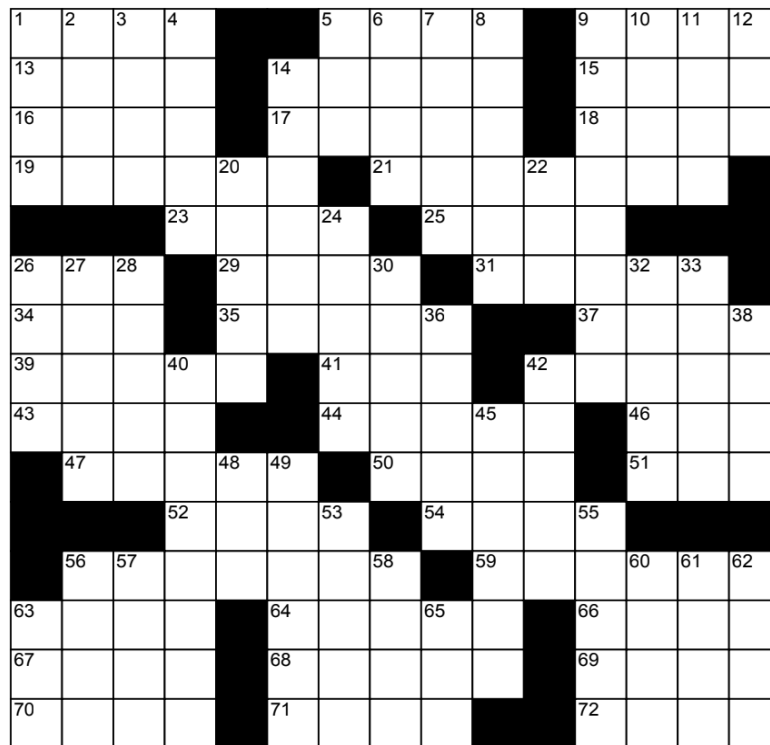

Idaho City Ghost Stories from the Past *Rockin' with Ghosts in the Hereafter*

Bill Stirling says, "I don't believe in ghosts." But when

asked about some of the properties he has owned, he says, nodding his head, "Oh yeah, there's a ghost there. . ."

Rupert Thorne (1899-1984) built his home on the East Hill, in Idaho City, and is said to still haunt his abode. The man came from a wealthy family in Scotland, a family that financed many of the mines in the Boise Basin. Rupert had been notorious for "storming around, and chasing chicks," said Stirling. "I know he's still walking around here. . ."

Many folks around town knew Rupert as, "The Cat Man." Rupert had many cats around his home, and enjoyed having a cat in his lap while he rocked in his high backed rocking chair.

After Bill purchased Rupert's home, he noticed that if someone sat in the chair during the day, "it would get rockin' that night." He advised, "Don't sit in the cat chair! I've seen it rock, personally. . ." When asked if he'd consider moving the rocker out of the house, he said with wide eyes, and shaking his head nervously, "Oh, no!"

Bill Sterling also related an incident that happened to him while he was living in Rupert Thorne's home. Some time ago, he invited Stan and Eileen Bartlett to come for a visit. They stayed in what Bill referred to as the, "Bridal Suite," off the side of the kitchen. The two men rose early the next morn-

ing and went to the kitchen to warm themselves by the cookstove. While in the kitchen, talking over coffee, they heard a "terrible commotion." Eileen Bartlett came running out of the bedroom with her, "nighty just a flyin'!" She was calling frantically, "Stanley! Stanley! Stanley!" She quickly reiterated that while she was in bed, she had assumed her husband had been by her side, but when she opened up her eyes, "There was nobody there!" Bill says with a laugh, "Rupert still likes to kiss the girls!"


Bill explained that Rupert use to, "walk to Martha Penrod's home, like for a Sunday dinner. She was an old girlfriend of Rupert's." Bill continued, with a bit of wonder in his voice, to explain that there was still a pronounced walking trail between the two homes.

Another home that Bill owns was Tom Adams, an early editor of the *Idaho World*. Tom Adams died in that house on East Hill, in Idaho City. Bill Stirling figures that lead poisoning, associated with the printing press, lead to his demise, sometime in the early eighties. Bill Stirling showed this reporter around Tom's house. There was an old printing press, some papers, and tin types that belonged to the former editor. Bill had in his pos-

session some original headline stamps from the old printing press. One was entitled "The Mountaineer," as the newspaper was called during a short period of time. Bill says that the house also seemed haunted, and suspects Rupert may have followed him over there.

Bill allowed this reporter, along with amateur ghost hunter Joyce Obland of Idaho City, to do some investigative work on the property. Joyce invited Tom, or Rupert, to "touch us. . ." Nothing at first was observed, other than goosebumps, by this reporter. As we made several passes throughout the house, attempting to communicate, we finally decided there was no interaction and turned to leave. At that moment, Joyce felt as if something, or somebody, brushed by her arm, which made her stop in her tracks, and quickly check a nearby closet.

Within that same moment, this reporter, felt the sensation of being poked in the left eye. The encounter did not seem intended to hurt, but rather felt localized to compress the eyelashes, and certainly gained immediate attention. The fascinating experience could not be explained with further inspection, indicating a spider web or other such abnormality, so we bid our undying friends farewell.

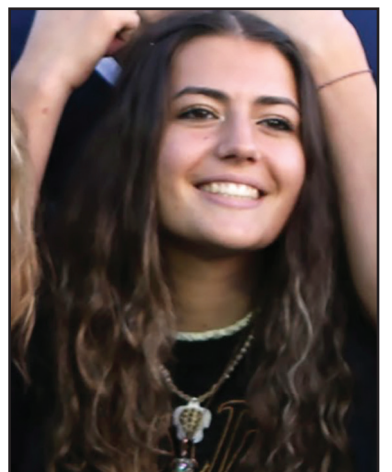

Idaho City Historical Foundation Celebrates a Year of Major Accomplishments

The Idaho City Historical Foundation will hold its 2022 Annual Meeting of the membership on Oct 23rd at 2 p.m. in Brogan Park, behind the Boise Basin Museum. The Annual Meeting is usually a highlight of the year, but this year brings special attention to several major accomplishments by the ICHF for the community.

The ICHF Annual Meeting is not just a gathering of the board, but of the wide community membership. This year, aside from the usual election and re-election of board members and officers and the sharing of financial reports, the ICHF will celebrate several major accomplishments, including the opening in 2022 of the new Kenn Smith Wild-fire Museum, the dedication of "The Ribbon Tree" in Smokejumper Park, the unveiling of a new ICHF website, and the dedication of the ICHF's Mining History Trail in Brogan and Naylor Parks.

It's been a very busy year.

The Mining Trail features a newly reconstructed three-stamp mill, restored by Idaho City's Sam Aarons and colorful

new, professionally designed, interpretive signage that illustrates the history of mining in the Boise Basin in (so far) six installations around the two parks. The trail of signage tells the story of early placer mining, industrial hardrock mining, and hydraulic and dredge mining--all illustrated by stations of equipment and historical photos of the equipment in use. The Mining Trail is a project long in the making, made possible by grants from the Idaho Humanities Council, the Idaho Heritage Trust, the donations from friends and the membership, and the hard work of many volunteers.

Immediately following the Annual Business Meeting, the Mining History Trail will be officially dedicated by ICHF President Beth Wilson.

Featured speakers will be Rick Ardinger, who helped the ICHF's Mining History Trail Committee, and Tom Blanchard, a Wood River Valley scholar of early Idaho mining history.

In addition to the newly reconstructed, monumental three-stamp mill, the trail features a dredge wheel-gear sprocket that ran the "digging ladder" on a local dredge displayed on a stand built by Dave Selene, a compressor donated

by the Al Larsen family from the Golden Chariot Mine, and many other mining artifacts owned by the Foundation.

New interpretive signage details how the artifacts were used in mining. QR codes on

the signs link to the ICHF's website, which provides even more information--and videos--about the history of mining practices in the Boise Basin.

ICHF Board members will provide refreshments follow-

ing the ribbon cutting.

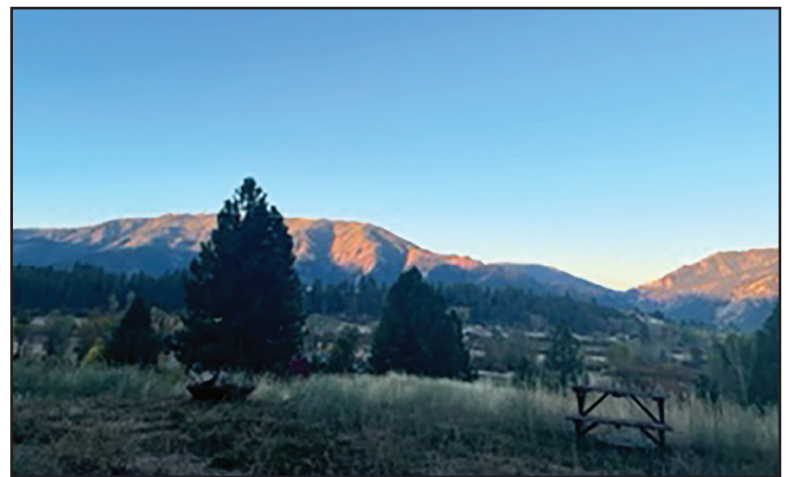
The team's final home game was scheduled for this Friday, 10/14 but the New Meadows Mountaineers forfeited.

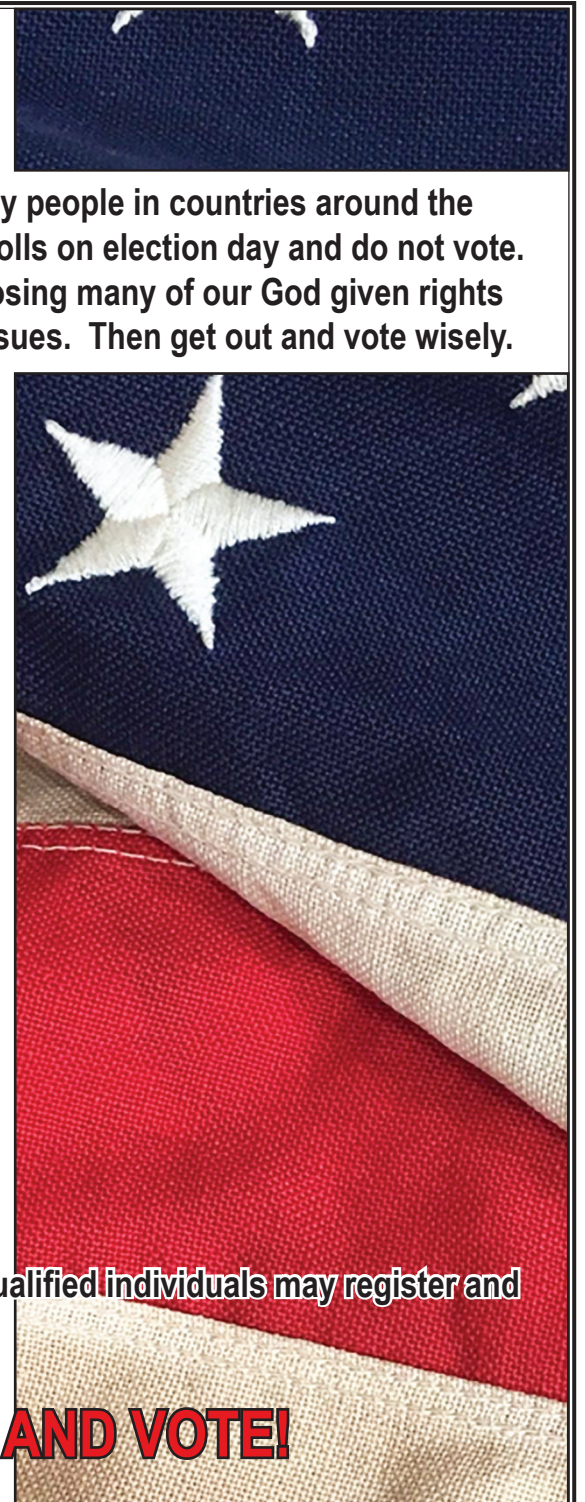

Idaho Constitutional Amendment SJR 102

Legislative Council's Statement of Meaning, Purpose, and Result to Be Accomplished

Currently, the Legislature may meet in a special session only upon call of the Governor. The proposed amendment would allow the Legislature to convene itself in special session if 60% of the members in each house submit a petition to the President Pro Tempore of the Senate and the Speaker of the House of Representatives. The petition must specify the subjects to be addressed in the special session, and only those subjects could be considered during the special session.

The amendment also requires the Legislature to hold an organizational session in December following a general election. The purpose of the organizational session is to prepare for the upcoming regular session. The proposed amendment would formalize in the Idaho Constitution the Legislature's longstanding practice of holding an organizational session.

Statements FOR the Proposed Amendment

This constitutional amendment is needed to correct an imbalance of power among the three branches of government. The executive and judicial branches of government have no restrictions on their ability to conduct business when and as they deem appropriate, and the legislative branch should have the same power.

Idaho is one of just 12 states whose legislature has no power to convene itself into a special session under certain circumstances. The Idaho Legislature should not be dependent on the Governor to call it into special session when extraordinary events occur. For example, in 2020, the Idaho Legislature wished to convene to consider Covid-19 matters and the expenditure of federal funding related to the pandemic but the Governor delayed convening the Legislature. Idaho should join the 38 states (including all of Idaho's neighboring states) that recognize the legislative branch of government's right to determine independently when it should convene and conduct the business of the people it represents.

Authorizing the Legislature to convene itself into special session will prevent the need for one or both houses of the Legislature to defer adjourning sine die indefinitely as happened in 2021 when the House of Representatives wanted to preserve its right to take up anticipated issues later in the year. Deferring the date of adjourning sine die results in numerous administrative problems such as delaying effective dates of

legislation and administrative rules. If the Legislature is able to convene itself, there will be no need to avoid adjourning sine die.

The proposed amendment contains sufficient safeguards against any potential abuse of power by limiting the subjects of legislation to be considered during a special session to those listed in the petition, just as a special session called by the Governor is limited to the subjects listed in the Governor's proclamation.

Statements AGAINST the Proposed Amendment

The Legislature has conducted its business for over 130 years without needing the ability to call itself into special session. This constitutional amendment is not necessary because the Governor has called and can continue to call the Legislature into a special session when necessary. Passing this amendment would remove a check and balance from the Idaho Constitution.

The Idaho Legislature is a part-time citizen legislature. The proposed amendment provides no limitations on how often special sessions may be called or how long they may last. Idaho should not move toward having a full-time legislature, and Idaho's part-time citizen legislators with other careers should not be burdened with sudden, unpredictable special sessions.

Idaho businesses and citizens need the stable, predictable, and routine timeline of the regular legislative session to communicate with legislators regarding the effects that pending legislation may have on businesses and citizens. The ability of the Legislature to convene itself into various special sessions may result in the passage of legislation that has not been properly vetted and could result in unintended consequences for Idaho businesses and citizens.

The proposed amendment requires a petition signed by only 60% of the members of each house of the Legislature. This threshold is too low. Many states require a higher percentage, such as 67% or 75%. A higher percentage would deter the Legislature from convening itself for subjects that may be trivial, vague, or not widely agreed upon.

Amendment Text

Section 8. SESSIONS OF THE LEGISLATURE. (1) The regular sessions of the legislature shall must be held annually at the capital of the state, commencing on the second Monday of January of each year, unless a different day shall have been appointed by law, and at other times in extraordinary sessions when convened by the governor and in organizational sessions commencing on the first Thursday of December after the general election, unless a different day shall have been appointed by law.

(2) The legislature, while remaining a part-time, citizen legislature, must also be convened in special session by the president pro tempore of the senate and the speaker of the house of representatives upon receipt of a joint written petition

of at least sixty percent of the membership of each house, specifying the subjects to be considered. Such special session must commence no later than fifteen days after the petition is received by the president pro tempore of the senate and the speaker of the house of representatives. At a special session convened pursuant to this section, the legislature shall have no power to consider or pass any bills or resolutions on any subjects other than those specified in the petition and those necessary to provide for the expenses of the session.
