

**Volleyball:** With a week off, the Horseshoe Bend Mustangs have been preparing to play A1 DII Long Pin Conference rivals the Garden Valley Wolverines at home on Friday, October 7. Junior Varsity begins at 4:00 pm, followed by the Varsity team at 5:15pm. The Varsity Mustangs are currently in first place in their division, with a record of 5 wins and no losses, and 13-1 overall. The Wolverines sit in 4th place in the conference with a record of 2 wins and 4 losses.

Horseshoe Bend will be holding their annual Pink Out Night for Breast Cancer Awareness. The community is encouraged to wear pink and to bring extra cash for the bake sale, hula hoop serve, and "best seat in the house" raffle! This will be the team's last home game of the season.

Football: The Horseshoe Bend Mustangs hosted the Salmon River Savages during their Homecoming match up at home on Friday, September 30. The Varsity Mustangs defeated the Savages 46-8, placing them in third place in the 1A DII Long Pin Conference.

Statistical standouts were junior Kaelun Jones with 165 rushing yards and two touchdowns with 3 receiving touchdowns and 1 interception. Senior Blayne Meyer had 93 rushing yards with 2 touchdowns and 32 receiving yards. Senior Jedi Graham had 59 receiving yards with 1 touchdown and 1 interception. Junior quarterback Carson Drake had 148 passing yards with 1 touchdown and 5 rushing yards and 1 interception. Junior Gavin Tomlinson had 54 receiving yards and 1 interception and senior Seth Rubal had 4 rushing yards with 1 touchdown.

The team is at home again on Friday, October 7, against their conference rivals, the first place Garden Valley Wolverines in the annual Timber Ax Battle. Kickoff is at 7:00 p.m. The team will also be celebrating the senior players during the half-time festivities.



### IDAPA 08 - STATE BOARD OF EDUCATION

08-0111-2201, Registration of Postsecondary Educational Institutions and Proprietary Schools. Zero Based Regulation (ZBR) chapter rewrite sets requirements for the registration of postsecondary educational institutions and proprietary schools required to register with the Board.

08-0113-2201, Rules Governing the Opportunity Scholarship Program. ZBR Chapter Rewrite establishes eligibility, application, and selection process for the Opportunity Scholarship Program.
