BOISE COUNTY COMMISSIONERS

Transcribed by Eileen Capson

November 10, 2022

(This was pushed from the regular Tuesday time schedule to accommodate for the election.)

Present: Commissioners Steven Twilegar, Clay Tucker, and Ryan Stirm (via phone conference).

Pledge of Allegiance

Chairman Twilegar congratulated all those that won the election. He stated, "No surprises anywhere."

CONSTITUENT INPUT:

None

MINUTES: Commissioner Twilegar motioned to approve the minutes from November 1st and Commissioner Tucker seconded. The motion carried. Twilegar then motioned to approve the minutes from November 3rd, and the motion carried.

BOISE SNOWMOBILE CLUB: The donation of two snow shelters from the club to Boise County was discussed. Clerk Mary Prisco spoke with Valley County about their donation of snow shelter(s) and said that the prosecutor will draw up a Memorandum of Understanding document.

JUVENILE JUSTICE: Chairman Twilegar shared the report for Juvenile Justice and said "they got a lot of restitution, more than normal -- \$700 to \$800 bucks."

HEAT EXCHANGE UNITS: Commissioner Twilegar said they received proposals from three companies for the heat exchange units for the Miner's Exchange building in Idaho City, a county office. There was discussion that the bids weren't "apples to apples" proposals, then Twilegar reached out via phone conference to Commissioner Ryan Stirm about HVAC units for three bids.

Chairman Twilegar motioned to approve the proposal from YMC in the amount of \$19,612 for a five ton HVAC unit for the county building. There were all ayes, and the motion carried. Twilegar stated, "I'm glad we got that done and over with."

JUVENILE JUSTICE: Commissioner Twilegar motioned to approve the Juvenile Justice report. The motion carried.

TAX CANCELATIONS: Commissioner Twilegar made a motion for sixteen separate tax cancelations, as requested by the assessor. All were in favor and the motion carried.

ROAD DEPARTMENT:

An employee in Garden Valley offered to go from part-time to full-time. Curtis Dill and Commissioner Twilegar indicated they were very thankful. Dill added, "A previous employee that worked for us last year quit due to a money situation, but he's still working another job, but understands our situation and is willing to help part-time with the rock runs and give our guys a break now and then." Twilegar said, "Excellent!" Dill continued, "Because these guys are just running ragged. I mean, we can't keep up the roads we have right now, and I have guys in Idaho City going over to Garden Valley to help out. We're doing what we can. We're concentrating on main throughfares, and then work through the secondaries as we have time." He said the road department was still down one person in Horseshoe Bend and three in Garden Valley. Dill added that thankfully they now have two full-time people in Garden Valley. "I'm excited," Dill said about having another full-time employee.

NEW VEHICLE: Commissioner Twilegar motioned to approve the purchase for one 2023 Ford F-350XL Super Cab with an eight foot box at \$47,660. All were in favor and the motion was approved. [It was unclear for which department this truck would be used.]

AUTOPSY SERVICES: Commissioner Twilegar motioned to approve the agreement for pathology services between Boise County and Ada County. The motion carried. [No cost was included in the motion.]

SNOW REMOVAL: Commissioner Twilegar motioned to approve the contract between Boise County and Tom Secor Construction through the winter for snow removal. Commissioner Tucker seconded and the motion passed.

CLAIMS REPORT: Commissioner Tucker commented that there was "a lot of red on here" and Chairman Twilegar agreed. Clerk Mary Prisco

said, "Yeah, it's not accurate. I haven't found a single one that's truly negative." Twilegar questioned approving the report, and Prisco responded, "Yeah, it's okay to approve the bills." She referenced another report with the original budget and actual expenses. Clerk Prisco added, "The fact that these negative balances and the budget remaining column, on the far right, was not accurate. I don't know why." Commissioner Twilegar said, "I'm sure you'll find out." Clerk Prisco agreed, "I sure will."

Commissioner Tucker had questions, but Twilegar said, "You can be specific and ask, but it sounds like none of them are right. [We've] still got to pay the bills. Wow." Twilegar asked if it was due to switching over from the year to year, but Prisco indicated that it may have to do with their software.

Chairman Twilegar said "I trust that you'll figure that out," and made a motion for the "grand total of \$116,208.89 for the claims approval report." The vote was unanimous and the motion carried.

AMATEUR HAM RADIO OPERATORS: Clerk Prisco said she wanted the board to be made aware of the request to operate a repeater from a tower in the Grimes Pass area. An individual from the county said he requested more information from the amateur HAM radio operator group and did not hear back.

INVOICE: An invoice to Amazon was approved for a purchase [assumed made by the IT person] for county use, [which was unknown] for \$254.39.

EXECUTIVE SESSION: Closed session for pending litigation. Coming back into session, Commissioner Twilegar said, "No action required."

EXECUTIVE SESSION: Closed session for exempt records. Coming out of executive session, Chairman Twilegar made a motion to approve a payment of \$900 to a Boise funeral home for cremation. There were all ayes, and the

motion carried.

EBCAD: A motion was made as the East Boise County Ambulance Governing Board to pay for a lunch after an ambulance call for \$15.24. The motion carried.

Adjourned at 10:12 am.



November 15, 2022

Present: Commissioners Steven Twilegar and Clay Tucker

Absent: Commissioner Ryan Stirm

Pledge of Allegiance

CONSTITUENT INPUT: An individual recommended that commissioners consider holding a meeting once a month in the evening, "so to all the working citizens of Boise County the ability to attend meetings and give verbal input to the commissioners." He also asked about the present status of plans to livestream or record the meetings. The individual concluded, "The technology is here, it takes the desire of the commissioners to get it done. *Let's get it done.*" Commissioner Twilegar said, "I agree. I like it." The commissioner said he would talk with the IT person and said it would help with transparency.

MINUTES: Commissioner Twilegar motioned to approve

the minutes from November 10, 2022. The motion carried.

TAX CANCELATION: An individual's house burned down, so there was a request for a tax cancelation for a manufactured home in the amount of \$25.72. He motioned for another land parcel tax cancelation in the amount of \$106.39. The motions carried.

DISPATCHER PAY: Sheriff Scott Turner requested that the board approve the addition of a dollar increase across the board for dispatchers. "But, I've got to do something. I've got one dispatcher out sick with COVID again, and so I've got two dispatchers banking forty hours of overtime this week, because I don't have anybody else." Chairman Twilegar said, "Yeah, I get it." Sheriff Turner said they are "getting burned out."

Commissioner Twilegar motioned to approve these pay raises for the dispatchers starting next pay period. Commissioner Tucker seconded and the motion carried.

911 SYSTEM: Sheriff Turner explained that the expense was for their yearly maintenance fee for their 911 system. "It's the server that controls all the 911 lines, that trumps everything into dispatch and provides all the data, the 911 data." The quote is for six months, because the Sheriff's office has recently submitted

for a grant with Elmore County through the Idaho State Emergency Communications Board. He said the system normally costs about \$25,000 a year to maintain, and about \$400,000 to replace it every seven years. Sheriff Turner said that every time they have been able to replace the system on grant money. He said they were able to get the grant with Elmore County, which was for almost \$700,000. They will share the maintenance costs and will be online with Elmore County, in a remote site. "The next couple of years, we will be able to save some money in that e-911 fund on maintenance, the grant paying for that two years of maintenance on this, being a remote site with Elmore County." Commissioner Twilegar said, "Excellent, thank you Elmore County!" Sheriff Turner added, "Hats off to Elmore County, because they did all the legwork for us and it worked out well in our favor." Sheriff Turner said there was a grant to pay for dedicated internet services for that system, so there's no cost to the county. Sheriff Turner said, in addition, Elmore County is taking care of all the funds, so there is no additional work for the Boise County Clerk's Office. "This is a win, win," said Sheriff Turner. The Sheriff's Office was working with Canyon County, but the grant application had not yet come together when Elmore County reached

out with this offer.

Chairman Twilegar motioned to approve the service agreement in the amount of \$13,210.19. The motion carried.

AGREEMENT WITH TITLE COMPANIES: Chairman Twilegar made a motion to approve the Boise County subscription agreement for title companies, for \$50 a month, to get access for one computer, and up to five computers for \$100 a month, effective January 1, 2023. All were in favor and the motion carried.

ELECTION CANVAS: Chairman Twilegar motioned to approve the General Election unofficial results from November 8, 2022.

CERTIFICATE OF RESIDENCY: Chairman Twilegar motioned to accept the certificate of residency.

DEMAND WARRANT FOR CAR WASH: Commissioner Twilegar commented, "Does he know that's a waste of time and money? It's in Boise County." There was a chuckle heard. Commissioner Twilegar motioned to reimburse for car washes and sand for the back of the pickup truck in the amount of \$55.37. The motion carried.

Commissioner Twilegar motioned to approve another demand warrant for a car wash in the amount of \$38. This was also approved.

DUES: A demand warrant for Idaho Emergency Manager dues was motioned and approved for \$150.

VERIZON WIRELESS: There was an invoice for the Emergency Manager. Commissioner Twilegar motioned to approve the cell phone bill for Verizon in the amount of \$52.96. The motion carried.

GAS: A motion was said to reimburse for gasoline in Garden Valley in the amount of \$70.60. The motion carried.

HAWLEY TOWER: Commissioner Twilegar made a motion to pay the invoice for the replacement of the Hawley solar charge controller in the amount of \$3,979. The motion was carried.

COFFEE POTS: A motion was made to reimburse the purchase of coffee pots from Costco in the amount of \$33.99. The motion carried.

INTERNET SERVICES FOR BOISE COUNTY EMERGENCY SERVICES: Chairman Twilegar motioned to approve this monthly service in the amount of \$206.60. The motion carried.

INTERNET SERVICES IN GARDEN VALLEY: Chairman Twilegar motioned to approve this invoice in the amount of \$230.36. The motion carried.

EXECUTIVE SESSION: Commissioner Twilegar motioned to go into executive [closed] session for exempt records and pending litigation. [Time 9:29 am to 10:08 am] No action was required.

LAND SWAP WITH U.S. FOREST SERVICE: Assessor Chris Juszczak discussed

several sites, for a new landfill transfer station including one on Grimes Creek near Clear Creek subdivision. However, there were some drawbacks to considering this location, because the turn is dangerous coming from Grimes Creek Road onto Highway 21.

Another location was considered near Idaho City. Commissioner Twilegar asked the solid waste administrator, "You don't think we would get any pushback having it so close to town?" Paul Rekow responded that it was a transfer station and not a landfill. Another location was considered up Bear Run Road. Another consideration was near Star Ranch subdivision.

Prosecutor Adam Strong advised the board as to what the criteria was for the U.S. Forest

Service. Commissioner Twilegar said they were looking to trade 60 acres. Several properties were identified. Twilegar asked that Juszczak map it off for him, and was particularly interested in properties near Idaho City by the baseball field, and another land parcel north. Commissioner Twilegar then said they had another twenty acres to swap. The board is looking to build new county office buildings, because these are 150 years old. There was some question whether they could build the buildings outside of town. Prosecutor Strong said, "You're allowed to build buildings outside the county seat." He added that you can't change the county seat without a 2/3 vote.

Adjourned at 10:52 am.

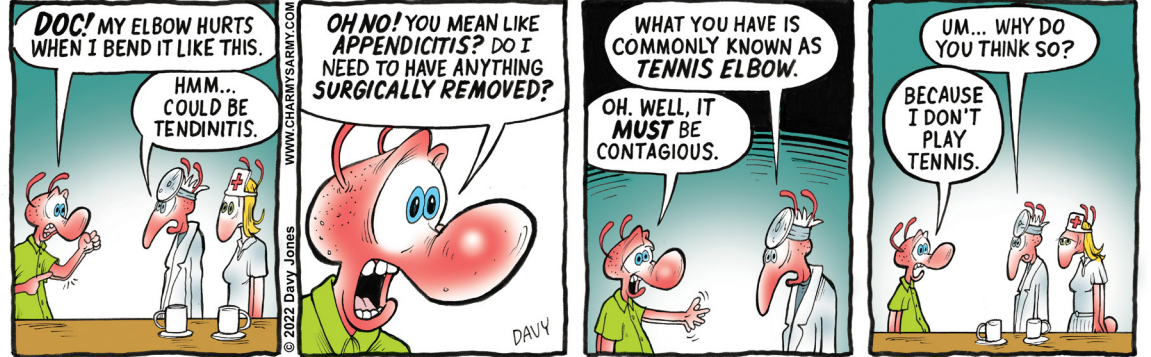

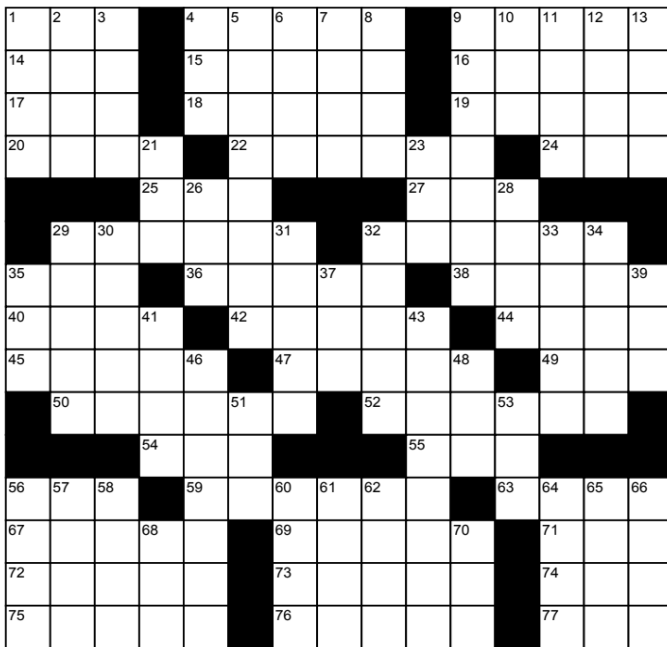

Local Recipe Tuna Stuffed Jumbo Shells

Tuna Stuffed Jumbo Shells

10 jumbo pasta shells
 ½ cup mayonnaise
 2 Tbls sugar
 1 can (12oz.) tuna drained
 1 cup diced celery
 ½ cup diced green onions
 ½ cup diced shredded carrot
 2 Tbls minced fresh parsley

Creamy Celery Dressing

¼ cup sour cream
 ¼ cup sugar
 ¼ cup cider vinegar
 2 Tbls mayonnaise
 1 tsp celery seed
 1 tsp onion powder
 Lettuce leaves and red onion rings optional.

combine mayonnaise and sugar. Stir in tuna, celery, onions, green peppers, carrot and parsley. Spoon into pasta shells, cover and refrigerate.

For the dressing, combine sour cream, sugar, vinegar, mayonnaise, celery seed and onion powder.

Arrange lettuce and onion rings on a serving platter, drizzle with dressing.

Yields: 5 servings

Note: I have used cooked chicken (or turkey) instead of tuna at times, and this is very good.

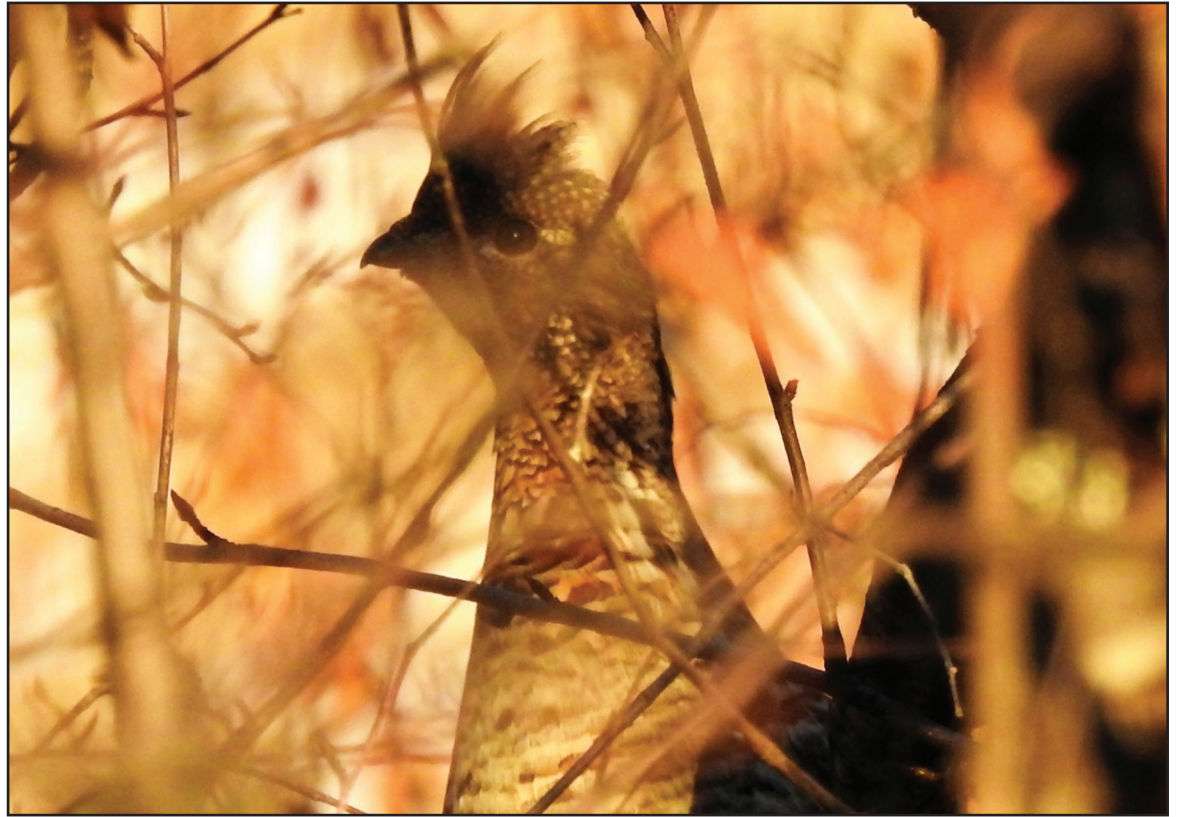
