Vandalism of Historical Items in Idaho City

Idaho City employs surveillance cameras to combat vandalism of Idaho City historical displays

IDAHO CITY -- New historical displays and interpretive signage in Idaho City's Brogan and Naylor Parks have become targets for vandalism twice over the past month. The displays and signage that interpret the history of mining in the Boise Basin, developed and paid for by the Idaho City Historical Foundation, have been attacked by vandals in separate incidents around October 8th and again around October 29th.

"This isn't only a crime against the Idaho City Historical Foundation, it's a crime against our whole community," said Idaho City Historical Foundation President Beth Wilson. "The historical signage cost the Foundation thousands of dollars, but the hours of volunteer labor that went into the project so far is really immeasurable."

The Idaho City Historical Foundation's "Idaho City Mining History Trail" is a project years in the making, comprised of professionally designed signage identifying 19th and early-20th century mining equipment in six interpretive stations

in the two Idaho City Parks. Funded by grants from the Idaho Humanities Council, the Idaho State Historical Society, the Idaho Heritage Trust, and donations from the community, the historic Mining Trail was unveiled in a ribbon-cutting ceremony at the ICHF's October 23rd annual meeting.

One major attraction in the Mining Trail is the reconstructed stamp mill, erected by Sam Aarons of Idaho City. Signage explores how important a stamp mill was to industrial mining in the Boise Basin. Another station explores the story of hydraulic mining and dredging in the Boise Basin, with a wheel gear from a Boise Basin dredge erected alongside a hydraulic giant nozzle. Signage features historical photographs of the equipment in action. Other stations in the trail tell the story of placer mining in the 1860s, the arrival of Chinese miners and merchants in the Basin, and the story of industrial mining.

In one incident, two signposts were tipped over the day after they were planted. More recently, the hydraulic giant nozzle was rolled over and new fencing broken.

"It's dispiriting to do all this volunteer work for the community and to have it purpose-

fully attacked in this way," said Wilson.

Thousands of visitors and school children visit Idaho City annually, and the new outdoor interpretive signage offers visitors an opportunity to learn more about Boise Basin history during the hours and months when the Boise Basin Museum is not open.

Idaho City Police say they have increased night surveillance of the parks, and have purchased several cameras to post in the two parks in an effort to thwart future vandalism. The ICHF is considering some solar lighting over several of the installations.

Established in 1958, the Idaho City Historical Foundation is an all-volunteer organization dependent on memberships and donations. It receives no regular financial support from either Idaho City or Boise County, but manages several parks, the Boise Basin Museum, the Pon Yam interpretive center, the new Kenn Smith Wildfire Museum, the Idaho City Cemetery, and several other buildings that tell the story of Boise Basin history.

November 1, 2022

Present: Commissioners Steven Twilegar, Ryan Stirm (via phone), and Clay Tucker
Pledge of Allegiance

CONSTITUENT INPUT:
None

MINUTES: Commissioner Tucker made a motion, because Commissioner Twilegar was absent, to approve the minutes from October 25th. Commissioner Stirm seconded and the minutes were approved.

SHERIFF'S OFFICE: There was discussion regarding raises to get people to apply for the dispatch position. Chairman Twilegar suggested they table this discussion to talk with Sheriff Turner.

TAX CANCELATION: Assessor Chris Juszcak said, "Most of these are due to our House Bill 389 that allows for our people to apply for homeowners exemption throughout the whole calendar year. So, they buy their house in June and didn't previously have a homeowners' exemption on there, then we have to apply the full exemption." Commissioner Twilegar asked, "So, we're statutorily obligated to do this?" Assessor Juszcak confirmed that the board was obligated. Chairman Twilegar motioned to approve the tax cancelations, listing the corresponding parcel numbers, name of the owner(s), and the amount.

BATTERY POWER: There was a purchase request for battery power, to be covered with grant money, for a radio repeater on Hawley Mountain. Commissioner Twilegar said this was something they needed to do. The radios and equipment will be in the amount of \$4,555 and a service program for installation is estimated in the amount of \$4,321, for a total of \$8,876. Commissioner Twilegar asked if there was any discussion on this, and Commissioner Tucker replied, "Better hurry up and get it done," [before the snow comes]. Chairman Twilegar motioned to approve this purchase for services and equipment in the amount of \$8,876. Tucker seconded and all were in favor. The motion carried.

HEATING: Juvenile Justice Amanda Leader said that the commissioners may have noticed that it wasn't very warm in the building, and that was because the "motherboard was dead" and that a new motherboard would be about

\$4,000. Commissioner Twilegar mentioned \$8,000 and then said he would like to get another bid, and then seemingly joked that a pellet stove would likely be cheaper. He added, "All the more reason to build a new building. This is insane. These old buildings are nickeling and diming us to death, \$8,000 bucks at a time."

GROUND LEASE: The annual snowmobile ground lease was discussed. Commissioner Twilegar motioned to approve this lease between the county and the property owner for the parking of vehicles in Garden Valley in the amount of \$800. All were in favor and the motion passed.

GRANT AWARD: Chairman Twilegar motioned to "receive this money from the State Homeland Security program grant award in the amount of \$26,067.68." This was for training for the county's emergency manager.

SNOWMOBILE CLUB: A representative that is also part of the snow grooming program said in the last three years the club has purchased "safety shelters. We've worked with the Forest Service, got permits, and we've placed them [at Pilot's Peak and another location]... and this year we've purchased another one." This one would be below Thorn Creek. He said they had gone through the permit process with the new District Ranger, but they are now requiring a different kind of insurance, to insure the entire United States. He said it was a problem for these safety shelters and "it's got us in kind of a bad spot."

The insurance specialist with the club said, "With this situation with putting property on federal land, and the federal government wanting to be insured as an entity, *there's not a company out there in the world that will do it...* But when it comes to insuring the entire United States as an additional, insured on your policy, *that's just never going to happen.*" He said their hands are tied

and that they've run out of options. He discussed donating the shelters to the county and that the county carries insurance themselves and it doesn't matter if they list the United States. "It's just a normal thing for them," as they have done in Valley County.

The first individual said this was a huge financial expenditure for the club, and that the structures have been utilized for rescues by the Sheriff's Office. He said that the club would still be "happy to maintain" the safety structures, "like normal."

Commissioner Twilegar would like to know who Valley County talked with at the insurance company ICRMP for the two counties, "so we don't have to reinvent the wheel." The representatives will get the information to Clerk Mary Prisco.

FLOOD PLAN: A FEMA flood plan for Horseshoe Bend was discussed in regards to private property and surveys. Prosecutor Adam Strong explained the document, "This is basically the county asking people nicely to allow them to..." Commissioner Twilegar cut him off and then made a motion "to approve this letter for the introduction of field surveys in Idaho City." All were in favor and the motion passed.

BILLS: A motion was made for coffee pots for the Clerk's office in the amount of \$37 and approved. Another motion was made for an attorney's office for a conflicting case in the amount of \$2,163. The motion carried.

"Idaho City area fuel" in the amount of \$4,338, all were in favor and the motion carried.

Middlefork Road guardrail repair in the amount of \$3,500 was motioned and approved.

A motion was said for office supplies for the prosecutor's office in the amount of \$250.95, which was approved.

LAND SWAP: Discussion about land swaps with state or federal land were discussed

with the county's grant writer. She would like to keep moving forward with this and Chairman Twilegar encouraged her to get on the commissioners' agenda.

EBCAD: As the East Boise County Ambulance Board, the commissioners motioned to approve the cost for a battery in the Unit 12 ambulance in Lowman, in the amount of \$303.90. Twilegar then motioned to approve an invoice for White Cloud Communication in the amount of \$3,933 for the new ambulance. The motions carried.

EXECUTIVE SESSION: The board went into a closed session per pending litigation. Coming out after about twenty minutes, Chairman Twilegar

said there was no action required.

EXECUTIVE SESSION: Chairman Twilegar then motioned to go back into executive session for exempt records, "nonmedical assistance." Coming back into session after about twenty-five minutes, Twilegar motioned to "reimburse said individuals for commission services up to \$900." Commissioner Tucker seconded and the motion carried.

Recessed until 9:30am for a public hearing on November 3rd. The next regularly scheduled meeting is to be held on November 10th at 9:00am.

Your Mandatory Hunter Report Helps Idaho Fish & Game Track Deer and Elk Herds

BOISE COUNTY -- Everyone who bought a deer, elk, or pronghorn tag needs to fill out a report.

Deer, elk, and pronghorn hunters are reminded that their Mandatory Hunter Reports are due within 10 days of their hunt ending. Hunters can download Idaho Fish and Game's mobile app to quickly fill out their reports, or go online to gooutdoorsidaho.com, or call (877) 268-9365. If you call in, please have your hunting license number handy.

You will be asked the following questions:

- Did you hunt?
- What units/how many days?
- What weapons?
- Did you harvest?
- What did you harvest?

If each deer and elk hunter spends a few moments filling out a hunter report, they make a valuable contribution to wildlife management that can lead to better hunting.

What does Fish and Game do with hunter reports?

They're an important tool for wildlife managers because deer and elk harvests tend to reflect game populations, and managers can gauge whether there are changes that need to be addressed.

Fish and Game uses aerial surveys to count big game herds. A thorough explanation of that process can be found on the site idfg.idaho.gov. But because there can be years between aerial surveys in each area of the state, mandatory hunter reports help managers understand what is happening with herds in between flights.

Aerial surveys backed by hunter reports have for decades been the mainstay of data used by biologists across most of Idaho. But in thickly wooded portions of northern Idaho, aerial surveys are not as effective. In those places, hunter reports are the best tool wildlife managers have to gauge the health of herds, so good data is even more critical.

What happens if I don't report?

In recent years, only about 60 percent of hunters filled out their mandatory hunter reports, which meant biologists had to fill in those blanks with expensive telephone surveys, or use statistical estimates to round out the data, neither of which is as accurate as hunters taking a few minutes to fill out a report. It's a simple way hunters can do their part to help manage deer and elk.

It's also important to know if a hunter didn't harvest, and even if they didn't hunt, so everyone who bought a deer, elk, or pronghorn tag needs to fill out a harvest report.

Will this be used against me?

No. We're not trying to track individual hunters and give away where they killed a deer

or elk. Harvests are tallied by units, and overall harvest data is available in the popular and widely used Hunt Planner, which provides the previous year's harvest stats.

Many hunters have asked why we ask how many antler points were on their buck or bull, and it's a fair question. That's another way of knowing the ballpark age of the bull or buck, and it's another piece of information for the wildlife manager to assess if the current harvest is likely to be sustainable, or if more harvest could be allowed.

How better data means better hunting

The more accurate hunter re-

ports are, the better biologists understand what's happening to deer and elk herds on the ground, and wildlife managers can react with any needed management changes.

When biologists receive fewer hunter reports, they have to rely on estimates while also trying to filter out statistical biases.

For example, successful hunters tend to report at a higher rate than unsuccessful hunters, which means if you take the success rate of the 60 percent who reported and apply it to the 40 percent who did not report, you would likely end up with a higher harvest estimate than what actually occurred. That could lead managers to

believe a population was over harvested, and result in more conservative hunting seasons.

Biologists can correct some of those statistical inaccuracies, but with more hunters reporting, there's less need for estimates. If wildlife managers are unsure of the data, they err on the side of caution when proposing upcoming hunting seasons, particularly the number of tags available for controlled hunts.

Hunter reports are an effective tool for wildlife management, and hunters reporting accurately and in a timely manner is a critical part of the process.

Cowboy Campground at Legacy Park, Idaho City The New Generation

IDAHO CITY -- Many calls received during the pandemic were life changing, often with negative overtones. However, on a Tuesday evening in July 2020, Bob and Sabrina Amidon received a phone call from a friend which would culminate in a very positive outcome. All the caller said was, "I know you are avid horse people; did you hear that Cowboy Campground in Idaho City is for sale?"

Quick research confirmed the details of the news. A plan was put together, and with the help of a private finance company, an offer was turned in just 14 hours after receiving the phone call. Crazy times often demand quick actions. In this case, a rapid response saved Cowboy Campground and opened the way for its continued preservation. Only an hour's drive from Boise, it will continue not only as a horse rider's first resource for camping in the Boise National Forest, but now features campsites for all outdoor enthusiasts, most recently welcoming the OHV camper community since 2021.

The Amidons received the assistance of other like-minded horse people like Pastor Frank and Kim Hartmann of Boise, and thereby raised the needed down payment in record time to make sure the closing agreement could happen. They created Cowboy Campground LLC, got their business licenses, and capped off their first few months of ownership with a huge fundraiser. Wanting to start updates, Cowboy Campground at Legacy Park was established and renovated with 17 newly sponsored horse campsites. Now increasing to 24 in total, each campsite features between 1-3 safe horse paddocks for the equine community. The sponsored sites include the contributor's name, new panels, new picnic tables and, of course, a lil' bit of love. Phase II of the renovations is now under way and the Ami-

dons are looking for sponsors for the general sites, which could include shade/weather covers, new picnic tables, and fire rings. New contributors even have the option of being involved in planning amenities for their designated spot.

The little cabins which had been a part of the previous campground have received some long-needed TLC and been repainted, with three cabins now fully renovated. One is now a dedicated chapel to hold weddings and a variety of other functions. There were lots of commitments by like-minded horse friends and companies in helping with endless hours and hard work. Please take a moment and see the wonderful list of volunteers and supporters at the CowboyCampground.com website. The owners were blown away at times with the thoughtfulness and volunteer hours they have received in the last 26 months and appreciate every moment, including the great feedback received on social media, as well as in person.

Legacy Park will soon be a great destination for retreats, youth camps, educational clinics, Equine Sport challenges and, of course, long trail rides and trips to Idaho City. With that said, they are looking for sponsors and grants to help create an amazing park for the City of Idaho City and Boise County to be proud of.

The future for these 15 acres will be preserved as it is intended to be: "a Campground and Event Space" for future generations to enjoy with their horses and families. The next step was completed in early 2022, with the creation of a non-profit 501(c)3 organization to oversee and run this gem in the rough and grow it to be a marvelous destination for future generations to enjoy. Legacy Park Trust Inc. is actively looking and asking for grant money to grow and purchase the land to complete the goal of being preserved and never sold. Due diligence



and extra hours of work have paid off, highlighted by the recent acceptance into the Idaho Gives program and to a crowd-funding website. A new grant writer is on board and excited to help them reach their goals.

Cowboy Campground at Legacy Park has been an ever-expanding horse campground for over 25 years and now features a park that can offer so much more. Education, training, and competitive events along with short and long trail rides, large gatherings for groups, weddings, memorials and anniversaries have been held, yoga/health retreats, events and seminars, 4-H, youth, rodeo, bible camps, and off-road enthusiasts have already booked their events. Continued expansions are allowing for all recreational vehicles and tent enthusiasts to enjoy the campground and have a safe place to be, especially with the changing world that we are currently experiencing. The upper tier is known as the horse area, which sports an arena and two round pens for our equine friends, the lower tier has great sites for non-motorized and OHV campers. With changing the former courtyard into a beautiful, rustic, event area, and turning a small building into a practical, little chapel; Hosting weddings, family events, corporate dry camping retreats - in addition to horse camps and educational events - has become a charming, full functional addition. Sadly, a few events weren't able to be hosted this year, including a few veterans groups and one special needs event, since the grounds are in need of full-service sites currently, which they are working diligently to change. Hookup fees were paid for last year April and a grant has been approved to finish the

sewer hookups from a family trust donation. This work will proceed as soon as we get the final approval from the city. Plans and state permits are ready.

Also in the planning stages and waiting for a sponsor is a challenge walking trail, that will also offer educational/historic/forestry references and will feature fitness tips for beginners to challenge the athlete in everyone. Not only do they have great plans already in the works, but to secure the ongoing success and keep this gem in the rough in the hands of owners with the foresight to keeping it as intended, open ground, for which the 501(c)3 foundation has been created. Legacy Park Trust Inc. will oversee and run Cowboy Campground at Legacy Park to ensure it will be conserved for future equine lovers and camping families to come after it is purchased from the current owners LLC. With losing so much private land to developers, this is a pertinent piece of property that needs saving and preserving. They are looking into partnering with amazing companies and people to conserve this great place.

The Home Depot Foundation joined in July 2022 and has been an awesome partner in contributing a gazebo, seating area with fireplace, and a flagpole with our country's glorious red, white and blue flag, this will be a distinguished addition to the area. Everyone is beyond excited to have this completed by May 1st 2023. Apple has just contributed a corporate matching gift to a donation received and Legacy Park Trust is excited and grateful to work with a new grant writer on future gifting.

The park's name is tribute to

everyone that had a hand into planning this place, ie. the Sterling Family and Bill's group of friends that worked long hours on this project over the years. Another great story to tell. 2022/2023 was the starting point of being able to receive funding and accept donations at a Trust Account at Wells Fargo, which will hold in-trust the donations received to purchase the land. After the purchase the Nonprofit Board will help grow and run this great facility and allow for other nonprofit organizations to use it for camps and events, at no charge to them if need arises, and keep this wonderful gem in the rough from being developed into housing or commercial property.

One huge project that will serve all of the community, guests, and future travelers is the build of full service sites for the summer season. They are not planning to be a year round RV or Trailer Park, but a summer destination helping the community of Idaho City continue to grow and offer additional community services.

Cowboy Campground's owners have been great supporters of the Idaho City Community, strong members of the Idaho City Chamber, and are always willing to help. They have been supporting Idaho City Days, the Chili Cook Off, sharing leftover Halloween candy with the police department to hand out, and had a blast participating with the Trunk-or-Treat.
