### House Fire in Lowman is a Total Loss for Longtime Residents

**LOWMAN** -- On Friday evening, January 7th at about 6:00 pm, a call went out to the Lowman Volunteer Fire Department describing a structure fire not far from Station 80. The volunteer fire personnel phone calling tree was immediately activated. The home of Jan Felty, who has been the Lowman Ranger District secretary for many years, was on fire. Twenty-one volunteer firefighters and Lowman neighbors arrived on the scene as soon as possible, but it was already too late. The house was completely engulfed in flames. Firefighters spent the rest of the evening and into the early morning hours ensuring no other building on the property caught on fire. Sadly, the Feltys have dealt with fire in the past, when

a wildfire claimed their home in 1989. The cause of Friday's fire is still under investigation, but it is thought that a potential cause may have been the fire-place coals that were placed in a bucket on the porch. However, through it all, there is reassurance in that no one was seriously injured, and all pets and livestock were kept safe.

# BOISE COUNTY COMMISSIONERS

**January 3, 2023**

**Present:** Commissioners Steve Twilegar, Clay Tucker, and Ryan Stirm (via phone conference).

**Pledge of Allegiance**

**CONSTITUENT INPUT:**

None

**MINUTES:** Chairman Twilegar motioned to accept the minutes from December 27<sup>th</sup>, 2022. The motion carried.

**TAX CANCELLATION:** Assessor Chris Juszczak explained that the cancellation was for a property that had changed ownership. Twilegar made a motion to approve the tax cancellation for the property, which was approved in the amount of \$1,922.

**ATTORNEY:** Encouraged by Planning and Zoning, Chairman Twilegar motioned to sign an engagement letter for a law firm at \$200 an hour. The motion carried.

**SHERIFF:** Vacation accruals were discussed with Sheriff Scott Turner, regarding two employees that were not able to take time off due to a shortage of staff. Chairman Twilegar motioned to allow the exception of over 160 hours for these two employees.

**MOTION:** Commissioner Twilegar considered inflation and made a motion to approve the procurement policy with one change, to repair vehicles, to move from \$1,000 to \$1,500.

**MOTION:** Chairman Twilegar motioned to sign a letter for the Idaho Parks and Recreation on behalf of the county and their snow grooming program. The motion carried.

**RESOLUTION:** Chairman Twilegar motioned to adopt Resolution 2023-01, a Boise County Procurement Policy and Procedure.

**RESOLUTION:** Clerk Mary Prisco referenced the sheriff's employees with extensive vacation hours, and spoke of a formalized budget amendment and pay increase. Commissioner Twilegar motioned to adopt Resolution 2023-2 to increase the Boise County Justice Fund Dispatch Department for the 2023 budget. The motion carried.

**PLANNING AND ZONING:** A motion was said for a refund for an application fee in the amount of \$1,000. The motion carried.

**SNOW REMOVAL:** Assessor Juszczak referred to three locations in Idaho City that were plowed.

Chairman Twilegar motioned to approve the invoice

for \$1,470. All were in the affirmative and the motion carried.

**MOTION:** Commissioner Twilegar motioned to pay \$800 for a ground lease agreement in Garden Valley.

**EXECUTIVE SESSION:** Closed session for risk management. Coming out of executive session, Twilegar said there was no action required.

**EXECUTIVE SESSION:** Closed session for pending litigation. Coming out of executive session, Twilegar said, "No action required."

Recessed at 10:00 am, until January 9<sup>th</sup>.

**January 9, 2023**

**Present:** Commissioners Steve Twilegar, Clay Tucker, and Lindy Lindstrom

**FAREWELL:** Chairman Twilegar invited Commissioner Ryan Stirm to say his farewell, via phone conference, to all gathered in the Commissioners' Room. "I just really enjoyed my time as a county commissioner. I appreciate everyone that I worked with during the time... Lindy, I hope you have a great time doing it. There's a lot to learn. You kind of get a trial by fire, in an in-

advertent kind of way. It's been a pleasure working with everybody."

**SWEARING IN OF COUNTY OFFICIALS:**

Clerk Mary Prisco read the oath, which Clay Tucker repeated from the first time when he was sworn in on July 5, 2022 when District Two Commissioner Ted Holmes vacated the office early and Tucker was appointed to fill the interim by Governor Brad Little. Commissioner Twilegar remarked after Tucker was sworn in a second time, and during the applause, "Welcome aboard again, I guess."

Clerk Prisco then provided the oath for Lindy Lindstrom to "solemnly swear" that he would uphold the Constitution of the United States and the Constitution of the State of Idaho. That he would faithfully discharge the duties of the office of Boise County Commissioner, District Three, to the best of his abilities.

Commissioner Twilegar then swore in Assessor Chris Juszczak to support the Constitution of the United States and the Constitution of the State of Idaho, and faithfully discharge the duties of Boise County Assessor to the best of his abilities, "so help me God."

Chairman Twilegar repeated the oath for Clerk Mary Prisco, Coroner Pamela Garlock, and Treasurer Gina Turner.

**REALIGNMENT OF THE BOARD:** Commissioner Tucker nominated Steve Twilegar as Chairman of the Board of County Commissioners. Twilegar abstained, but Tucker and Lindstrom voted in favor of the motion.

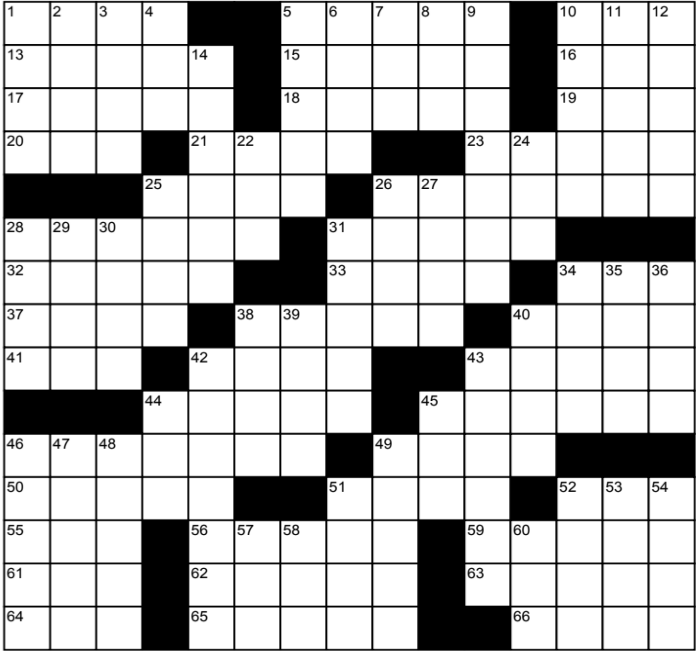

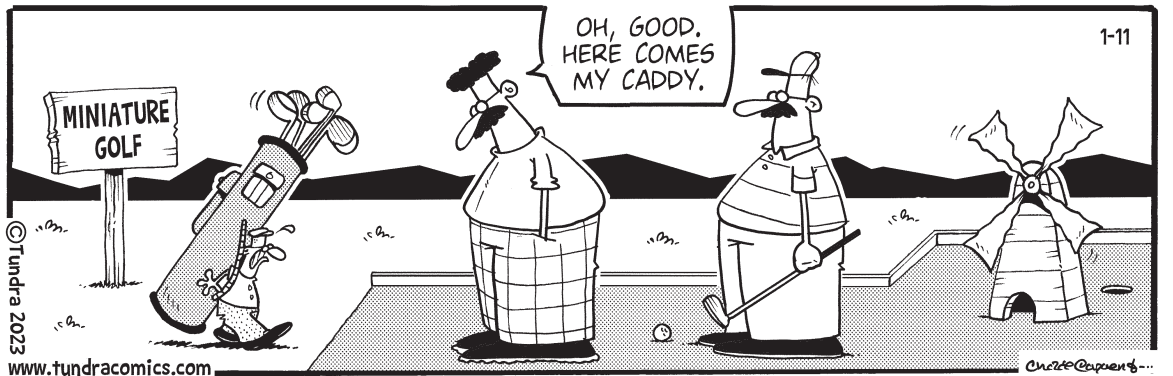

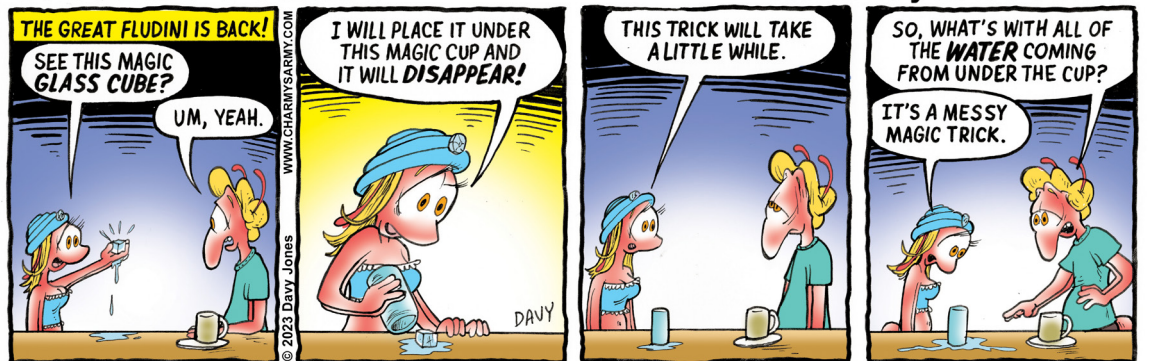

Commissioner Twilegar motioned to approve a request for tax cancellation by the treasurer in the amount of \$469. All were in favor and the motion carried.

**GRANT:** The Emergency Manager Performance Grant for 2022 was discussed by Clerk Prisco, which is a matching grant to cover a portion of the salary for the county's emergency manager. Twilegar motioned to accept this grant on behalf of the county. It was seconded and the motion carried.

**CLAIMS APPROVAL REPORT:** Chairman Twilegar commented, "I didn't see anything new that concerned me at all. It looks like we're on target." Commissioner Twilegar motioned to approve the Claims Approval Report in the amount of \$142,665. The motion carried.

**GARDENA BRIDGE:** Trevor Howard, an engineer who has worked with the Boise County Road Department for the past fifteen years, said the Gardena Bridge was funded on the federal aid bridge program and the county did not decide to pursue the funding at that time. He said they have since put in an application for the local bridge program "that requires no match." It's estimated to be a \$12 million dollar

project, and would receive \$3 million in grant funds. It could be constructed in five years, but the county would have to find additional funding for the \$9

million dollars. The deadline for the grant is mid-January. Twilegar thought there wasn't any harm in submitting the application.

There were other projects discussed for county roads, including chip sealing.

**EXPENSE:** Chairman Twilegar motioned to approve the

expenditure at Home Depot for the Horseshoe Bend water heater in the amount of \$317.

Twilegar motioned to approve an invoice of \$547 for IT purchases, which was approved.

Recessed until January 17<sup>th</sup> for their regularly scheduled meeting.

## Sheriff's Office

### Attention Skiers and Snowboarders,

The Boise County Sheriff's Office has had significant increase in 911 calls generated by the fall sensors on smart watches. Many of the smart watches come with an automatic fall detection that automatically calls 911 if it detects you have fallen. The watch gives you a 1 minute countdown before it automatically calls 911 and leaves the line open for dispatchers to communicate with you. Unfortunately, many people don't see or hear their watch alarm under their winter clothing to be able to cancel the 911 emergency call.

Our dispatchers are receiving between 10 to 30 emergency calls from the Bogus Basin

area daily. The dispatchers can clear some of these calls as they can hear the watch user is ok on the other end of the line. Each call has to be treated as a real event and resources have to be assigned to ensure there isn't a real emergency. With limited resources, these calls can easily take resources from real emergencies.

This is a newer technology so some people might not even know their device is sending these alerts. We need the public's assistance to get this message out so we can reduce the amount of false emergency alerts inundating our dispatchers.

Remember, you don't need to enact all your resolutions at once. Take small steps throughout the year so that you're ready to weather the unexpected.

**Here are some ideas to get you started.**

- Make an emergency plan. Choose a safe place to meet, learn evacuation routes, and establish an out-of-town contact.
- Take stock of your emergency supplies. Use those that will expire soon and add new ones as needed.
- Sign up for alerts and warnings. Download the FEMA app to get real-time alerts, safety tips, and locate open shelters.
- Snap pictures of your property for insurance purposes.
- Take a current photo of you and your pet together in case

you get separated during a disaster.

- Snap photos of important documents and save them in a secure place or online. In addition, consider filling out FEMA's Emergency Financial First Aid Kit to keep all your documents and important information in one place.
- Set up group text lists so you can communicate with friends and family during emergencies.
- Take a class in CPR and first aid.
- Have back-up power sources available to charge devices in case of a power outage.
- Check your insurance for coverage of disasters such as floods, hurricanes, and earthquakes.
- Save for a rainy day! Start and grow your emergency fund by adding a small amount at the start of each month.

## Challenging Rescue Despite Avalanche Danger

**BOISE COUNTY** -- Idaho Mountain Search and Rescue Unit [IMSARU] was called out late Monday night to assist in finding a skier that had detoured from the area of Bogus Basin. Fifteen IMSARU volunteers broke into two ski teams, one snowshoeing team, and command and operations team. On the backside of Bogus, there was real concern for an avalanche risk, so team members used snow probes, avalanche beacons, and even dug a snow pit to assess the risk. While maneuvering in the dark, team members were able to eventually triangulate a voice contact somewhere in the deep back-county. The individual was located in the early morning on Tuesday, January 10th. He had apparently lost both skis in a small avalanche, but was otherwise uninjured. Due to heavy fog, the Idaho National Guard was unable to bring in aircraft to assist. The IMSARU team members were able to help guide the male individual to a Bogus Basin ski patrol snow cat for further transportation.

This was a team effort by the Boise County Sheriff's Office, Bogus Basin Mountain Recreation Area ski patrol, and IMSARU.

### Prize Winners in the Garden Valley District Library

**Garden Valley, ID** – The Garden Valley District Library is participating in the reading program 'Let's Talk About It! Since 1985, Let's Talk About It (LTAI) has been bringing adult reading discussion groups together with humanities scholars in Idaho's public libraries to discuss literature. These book readings and discussions explore American values, history, culture, aging, classics, and much more. The presentation by, and interaction with, a program scholar is what sets these sessions apart from traditional book club discussions.

This year, the Garden Valley District Library is working with the theme 'Prize Winners.' Awards for literature are numerous--almost two hundred larger and smaller prizes are awarded in the US alone--and diverse. Prizes are awarded to works of fiction and non-fiction, books of poetry and books of academic criticism. Writing prizes may be awarded by grants established by donors (like the Pulitzer Prize), or by a nonprofit organization (like the National Book Award or the various PEN America awards). Sometimes, literary awards are created by genre associations; each year, the British Science Fiction Association awards its Arthur C. Clarke Award, and the Horror Writers Association bestows its Bram Stoker Award. Publications are also frequently the source of prizes. *The Los Angeles Times*, *The Paris Re-*

view, and *The Chicago Tribune* give yearly book awards. Books may win recognition from the NAACP, GLAAD, or the American Association of Hispanics in Higher Education. The Newbery Medal is awarded by the American Library Association to books for children, and the Pushcart Prize is given to a book published by a small or independent press. Some of these awards come with cash prizes, from the nearly £50,000 payout for the Booker Prize in the UK to the \$10,000 prize for the National Book Award. Some offer only the recognition of the award itself.

Winning a major award, like the Pulitzer Prize, Booker Prize, National Book Award, or one of the PEN awards, can mean not only a monetary payout, but can also bring cultural prestige and commercial success to a book and its author. Lifetime awards, like the Nobel Prize, almost certainly secure an author's place in "the canon." In some cases, even being a finalist for an award can bring a measure of recognition and a subsequent career boost.

Wednesday, January 25th

at 7 pm will be our first Book Talk. We will discuss the book *Nickel Boys* by Colson Whitehead. Wednesday, February 15th at 7 pm we will discuss the book *All The Lights We Cannot See* by Anthony Doerr, and Wednesday, March 15th at 7 pm we will discuss the book *March* by Geraldine Brooks.

All titles can be checked out at the Garden Valley District Library.

The Let's Talk About It program is made possible by the Idaho Humanities Council, the National Endowment for the Humanities, a grant from the Institute of Museum and Library Services which administers the Library Services and Technology Act, and the program is administered by the Idaho Commission for Libraries.
