WHEREAS, the Central Committee of the Republican Party passed Resolution 2023-6 at their January 6, 2023 meeting, affirming support for legislation protecting minor children from procuring puberty blockers, cross-sex hormones and sex reassignment surgery; and

WHEREAS, Resolution 2023-6 was presented in House Committee by the Chairwoman of the State Republican Party to support the passage of House Bill H0071 as well as the same being relayed to both the House and Senate Legislative Liaisons of the Party; and

WHEREAS, Boise County is one of the four Counties in

Legislative District 8 represented by Matthew Bundy who did not vote according to the Resolution of the Party or the vote of Boise County at the State Central Committee meeting;

# BOISE COUNTY COMMISSIONERS

Transcribed by Eileen Capson

**February 14, 2023**

**Present:** Commissioners Steven Twilegar, Clay Tucker, and Lindy Lindstrom

**Pledge of Allegiance**

**CONSTITUENT INPUT:** Idaho City Fire Chief Terry Teeter explained that he would like a letter from the commissioners regarding their fill station for the breathing apparatus, which has some mechanical problems. The department has currently submitted a proposal for a grant with FEMA, but would like a letter of support from the county.

**MINUTES:** Chairman Twilegar motioned to approve past minutes, which were missed, from July 28, 2022. The minutes were approved for this special meeting. He then motioned to approve the minutes from February 7, 2023. The motion carried.

**BUDGET PROCESS:** With the board, Clerk Mary Prisco reviewed the budget process and all the pieces of that process. She provided a timeline of the budget cycle and the statutory requirements. She also addressed the taxing districts, reporting to the state, and potential revenue.

**PERSONNEL POLICY:** Clerk Prisco said they were looking to update the person-

nel policy for the county and found a sample on the insurance company's website. Clerk Prisco, with two others in her department, revised the personnel policy document to fit the requirements of Boise County.

She addressed a question they were faced with in the employment application, "Have you ever been convicted of a criminal offense?" And then if "yes," it asks for a written explanation. Then it reads, "Please note that criminal convictions do not necessarily disqualify you from employment with Boise County." She explained that a transgression may have occurred in their youth and shows up on their record, but this gives them an opportunity to explain. Clerk Prisco said that in the sample personnel policy, there was no mention of this question.



Prosecutor Adam Strong addressed this by saying, "A lot of states have passed legislation banning that question. Idaho has not. So, there is a trend nationwide, going in a direction, not asking that question. Especially if you have operations in multiple states, because a lot of states have banned that question."

Chairman Twilegar inquired about a background check. Clerk Prisco responded that they do a background check through "Good Hire. Of course, the sheriff's operations do much more beyond that." Good Hire only goes back seven years in its criminal background check.

Prosecutor Strong advised that the county inquire with the insurance company because they may have left that language out of the template. He then went on to clarify that states have not banned that question all together, but just for the initial application. This way, the question is not used as a screening tool.

Strong said the board could move forward with the document presented for the general application of potential employees. The clerk advised that the question regarding a background check could be in

a separate document, within the personnel policy.

Chairman Twilegar motioned to approve the new application form for the county. All were in favor and the motion passed.

**RACE TO ROBIE CREEK:** The mass gathering for the nonprofit organization that sponsors the Race to Robie Creek was reviewed. Chairman Twilegar motioned to approve the mass gathering permit, which was seconded, and the motion carried.

**EBCAD:** Administrator Melissa Potts spoke regarding the Race to Robie Creek and the fees for East Boise County Ambulance District. There will be four EMTs present for the race.

Chairman Twilegar motioned to approve the ambulance fees for the Race to Robie Creek.

**OPIOID SETTLEMENTS:** Prosecutor Strong said these are a new round of opioid settlements, which resemble the ones they approved last year. Drug companies and those that disburse, like Walgreens, CVS, and Walmart, are settling roughly \$90 million for the state of Idaho. Strong said 40% goes to the state, 20% goes to health districts, and 40% is dis-

tributed to local jurisdictions based on population. He said it's about \$150,000 for Boise County, and the last one was around \$180,000. The money is to be specifically used for drug intervention and some law enforcement training. Signing means that the county will wave any other claims they have against these companies.

Chairman Twilegar motioned to accept the settlement in behalf of Boise County, including the five companies. The motion carried.

**RESOLUTION:** Chairman Twilegar motioned to adopt Resolution 2023-06 to amend the Boise County Road and Bridge fund for the 2023 budget.

**CERTIFICATE OF RESIDENCY:** Chairman Twilegar motioned to approve the certificate of residency and the motion carried.

**CLAIMS REPORT:** Chairman Twilegar motioned to approve the Claims Approval Report in the amount of \$171,634.

**BILLS:** Twilegar motioned to approve the internet bill for the Sheriff's Office in the amount of \$206, and the motion carried. He then motioned

## City Council Meeting in Idaho City

**IDAHO CITY --** During the regular City Council meeting on February 22, 2023, CarrieAnne Kowalczyk attended to discuss Montgomery Street. She was riding her four-wheeler with a plow attached on the front down Montgomery Street earlier in the month. When she hit a pothole, the blade of the snowplow clipped another pothole and tipped the four-wheeler over. Fortunately, was not seriously injured. Now, she is determined to find someone responsible for maintaining the road and making improvements.

Clerk Ptak stated that there is no paperwork as to who is responsible for Montgomery Street. She said she had some minutes from 1999, discussing the road, but that was all.

According to the City Attorney, Joan Callahan, "The question is who is responsible, Idaho City or the County?" In regard to solutions, Callahan stated, "the City is looking at all alternatives and options to maintain the road."

## Idaho City Police Crack Down on Chronic Nuisances

**IDAHO CITY** -- Idaho City Police Chief, Mark Otter, gave each of the councilmembers and the mayor a copy of a Chronic Nuisance Property, at the regular City Council meeting in February 22, 2023. This document defines the conditions that constitute a Chronic Nuisance. Any property within the city of Idaho City upon which three (3) or more of the listed behaviors occur during any sixty (60) days period as a result of three (3) separate factual incidents that have been independently investigated by the Idaho City Police Department.

Any felony;

- Domestic battery, Idaho Code section 18-918;
- Stalking, Idaho Code section 18-7905;
- Battery, Idaho Code section 18-903;
- Assault, Idaho Code section 18-901;
- Violation of a protection order, Idaho Code section 39-6312;
- Violation of a no contact order, Idaho Code section 18-920;
- Disturbing the peace Idaho Code section 18-6409;
- Refusal to disperse, Idaho Code section 18-6410;
- Indecent exposure, Idaho Code section 18-4116;
- Any firearms violated listed in Idaho Code sections 18-3301 through 3324;
- Any drug related activity

listed in Idaho Code sections 37-2701 through 2751;

- False alarms, Idaho Code section 18-6711A;
- Fighting, section 4-12-5 of this title;
- Resisting and obstructing officers, Idaho Code section 18-705, and
- Any attempt to commit and/or conspiracy to commit any of the above activities, behaviors or conduct.

If the Idaho City Police find three occurrences of these activities within sixty days, they will notify property owners and the property will be in danger

of being declared a chronic nuisance property. If the property owner or person in charge fails to respond to the notice of chronic nuisance, the matter shall be referred to the office of the city attorney for further action. If the district court determines the property to be a chronic nuisance property, the district court may order the property closed and secured against all unauthorized access, including use and occupancy for a period up to six (6) months, and may impose a civil penalty and costs.

to approve the "dispatch project," the purchase of cables and electrical supplies, in the amount of \$260. This was also approved.

**ASSISTANCE:** Twilegar motioned to approve a non-medical application for assistance, which was in agreement.

**MONTGOMERY STREET:** CarrieAnne Kowalczyk-Gonzalez reiterated her experience of driving her 4-wheeler down Montgomery Street, with a snow blade on the front, "as I'm driving down, there's a pothole in the middle that is full of water. So, I'm not even aware of how bad that pothole is. I hit that pothole and stop suddenly. My blade hits the center of that pothole." Kowalczyk-Gonzalez explained that she came close to flipping off over that snow blade and asked, "Is it going to take a lawsuit to get this road fixed?"

Chairman Twilegar sympathized with the situation, living in Idaho City. He said he had also hit the pothole on Montgomery Street, "It is pretty severe. So, the reality though is that nobody can produce a document saying that it belongs to the county. And Idaho statute says, if a road is in a city, the city is responsible for it." Prosecutor Strong added that if the city had a road department, it was the responsibility of the city. The prosecutor said that a document has never been produced stating the ownership of the road. Twilegar said, "I hope somebody does provide a document, because I would really love to pave that thing."

Prosecutor Strong stated: "The county could step in and help the city." However, he questioned if it was fair to all the other people residing in other cities? "The county is bigger than Idaho City," Strong said. He referenced that there

were allocations from the State Highway Department based on miles of road, "and that's what funds most road departments, cities and counties. Under the statute, that is within the city limits, so absent some other agreement, the statute is clear that that would ultimately be a city responsibility."

Twilegar said that the board had met with the city representatives and offered to buy the pavement materials, but they went with millings of old blacktop.

Clerk Prisco spoke about each of the taxing districts, "each of those are very separate. And each of those are responsible for establishing their own tax levies." She reported that the city is collecting taxes within the boundaries of Idaho City for their streets. In addition, she pointed out that the county no longer has paving equipment and paving projects had been contracted out.

Chairman Twilegar said, "We all agree on the subject, *the road is a pile of junk*. I would just like to see it torn up." Kowalczyk-Gonzalez asked what it would take to get something done, and Twilegar replied, "by policy, we could agree to pave it. We absolutely could, but..." Prosecutor Strong interjected, "with the consent of Idaho City." Then the chairman spoke about the city raising their road tax, and what was fair for the county's tax-base.

**EXECUTIVE SESSION:** Chairman Twilegar made a motion to go into executive session to discuss acquiring property. Coming back into session, there was no action required.

**EXECUTIVE SESSION:** Chairman Twilegar motioned to go into another closed executive session for a personnel issue. There was no action required.

Adjourned.

**HORSESHOE BEND** -- The Horseshoe Bend boys varsity basketball team entered into the 1A DII Long Pin District tournament seeded in 3rd place. This year's district tournament was hosted by Council. They opened the tournament in game number 2 on February 14 against the 6th seeded Salmon River Savages where they took the win, setting them up to play in game number 4 on February 15. Game number 4 placed the Mustangs against their Boise County rivals, the Garden Valley Wolverines, who had a bye

in the first round after finishing as the second seed in regular season play.

Spring sports are on the horizon. The Horseshoe Bend Varsity Baseball team plays its season opener at home on Friday, March 10 in a double header non-conference game against Marsing. First pitch is at 10:00 a.m. The Varsity softball team starts their season in a home game against Idaho City on Tuesday, March 14.

This proposed amount would be for the salary and benefits of the Forester, expenses for transportation, office and operations for the Forester, revision and maintenance of the Boise County Community Wildfire Protection Plan, and wildfire hazard mitigation and response planning, per the Boise County Community Protection Plan. Assist homeowners with professional management advice and modification of fuels within the home ignition zone.

Funds to reimburse the County for emergency services performed on Federal land:

\$15,234 for the Boise County Sheriff

This amount would be to reimburse the Sheriff for anticipated search and rescue emergency services performed on federal land and paid for by the County.

The reimbursement will be for the salary or wages of emergency response personnel deployed during an emergency response, the replacement of equipment, material and supplies expended, damaged or destroyed during an emergency response, the repair of equipment damaged during an emergency response, and the maintenance of vehicles, equipment, and facilities during an emergency response.

**Public comments**

The County is holding a 45-day comment period which will end at 5:00 pm on March 18, 2023. The board is also sending this proposal to the Southwest Idaho Resource Advisory Committee pursuant to Section 302(b)(2) of PL 110-343. Please send the County any feedback, suggestions, or concerns that you may have regarding these proposed uses of these federal funds. ## Boise County Sheriff's Office Participates in Statewide Effort to Calm Aggressive Driving in Idaho



**BOISE COUNTY** -- The Boise County Sheriff's Office and law enforcement partners across Idaho are working together to educate drivers and stop aggressive driving. February 26 through March 11, 2023, our officers will dedicate enhanced patrols watching for danger-

ous, aggressive drivers.

According to preliminary data from the Idaho Office of Highway Safety, in 2022 aggressive driving contributed to more than 14,000 crashes in Idaho. Last year, 39% of all fatal crashes involved some form of aggressive driving behavior.

Examples of aggressive driving include:

- Speeding
- Tailgating
- Driving too fast for weather conditions
- Cutting in front of another driver and then slowing down
- Failing to stop for red

lights or stop signs

- Failure to yield
- Weaving in and out of traffic
- Changing lanes without signaling
- Blocking cars that are attempting to change lanes
- Passing a vehicle on the wrong side of the road or on the shoulder
- Screaming, honking, or flashing lights
- Making hand gestures or facial expressions at other drivers

Boise County Sheriff's Office urges Idahoans to stay calm on the road and have patience for other driv-

ers so we can keep our communities safe together. The choices you make while behind the wheel can make the difference in whether you get home safely or not.

Funding for extra patrols and overtime work focused on aggressive driving en-

forcement is provided by a grant through the Idaho Office of Highway Safety and the National Highway Traffic Safety Administration.

### Proposed Mining Operation Near Idaho City



**BLM seeks public input on analysis of proposed mining operation near Idaho City**

**BOISE COUNTY** --The Bureau of Land Management (BLM) has analyzed a proposed placer gold mining operation in Granite Creek, located 12 miles northwest of Idaho City, and will accept public comments on the environmental assessment through March 26, 2023. Placer mining is the act of removing precious metals from the sand and gravel deposits of streams. Mountain States Mining, LLC proposes an approximately five-acre project area on BLM-managed public lands in Boise County. If authorized, the mine would be seasonally occupied by two to seven workers, while mining and reclamation activities occur.

A decision to allow Mountain States Mining, LLC to begin mining operations would be contingent upon them receiving

all the required permits from other federal and state permitting agencies.

**Jim Bronson**  
1944 - 2023

On Tuesday, February 21, 2023, Jim Bronson, loving husband, father, brother and friend, passed away at the age of 78. Jim's story began in Townsend, Montana on April 1, 1944. He was born to Helen (Seth) and Vance Bronson, the 2nd child amongst 3 sisters. He graduated from Mt. Baker High School in 1963 and then moved to Seattle, WA where he trained to become a welder at Northwestern Glass. On July 26, 1969, he married longtime family friend Jeanne York. He and Jeanne moved to Boise where he began to work for Yanke Machine Shop. They welcomed their children into the world, Kevin and Janeen, teaching them life skills and instilling a strong work ethic. In 1977, Jim moved his family to Merced, California, to start a farm and animal equipment company with family friends. At Triangle Bar Manufacturing, he helped design and build automatic gates which gave

him the opportunity to work all over the states. In 1994, he and his wife moved back to Boise to help his parents manage the responsibilities of the mountain homestead. As his children were grown, he went back to school and graduated from Boise State University with an associate's degree specializing as a machinist. This skill set took him to work at Weyerhaeuser until he retired in 2012. But retirement only meant that his work moved from Boise up to his mountain shop on Clear Creek.

Jim Bronson was a gifted man. His imagination and artistic ability allowed him to bring ideas from the ether into the world of application. These talents, along with his stubborn work ethic, were the bedrock of his life. He had the canny ability to visualize and then build, whether it was works of art or industrial machinery. He never met a piece of steel he didn't love.

Family traditions were very important to Jim. He followed in his father's footsteps and built his own dune buggy which took his friends and family on many adventures. Jim was an active father who participated in his children's interests and education. He spent many hours working with the YMCA Indian Guides, Soccer and the Merced Marching 100. His dedication to blacksmithing, antique gas engines, and tractors resulted in his involvement with the California Blacksmith Association, Idaho Knife Association, Idaho Tool and Trades Historical Society, and

the Treasure Valley Flywheel Engine Club. He was one of the founding members of the Snake River Antique Power Association. He loved educating the public about rope making, corn shelling, and early day gas engines at the Museum Comes to Life in Boise and at Mountain Kids Day Camp in Idaho City. Jim could create both practical machinery as well as functional, whimsical works of art. His most favorite work of art was his interactive antique water faucet display that was a spectacle at fairs and shows throughout the Pacific Northwest. His artistic work enchanted others.

Jim was known for being a kind and compassionate man who was always giving of time, experience, and heart. He was a man of few words and did not like a lot of attention. He showed his character in his actions, mentorship, and hard work. Despite his declining health, his last days were spent with family and friends up at the mountain he loved so much. Jim was preceded in death by his father Vance and mother Helen. He is survived by his wife Jeanne; his two children: Kevin and Janeen; his grandsons: Vance, Orrin and Benjamin; his sisters: Carolyn Anderson, Jane Bronson and Anne Pelletier (partner Chris Knowles); and several cousins, nieces, and nephews. A celebration of his life will be planned in the late spring of 2023 after the snow melts; and with a meadow picnic to be enjoyed by all, just the way Jim would have wanted.
