Horseshoe Bend's Wall of Shame and Recall of Corvinus

HORSESHOE BEND --

The process of recalling Horseshoe Bend City Councilmember Curtis Corvinus is underway. A group of citizens started the recall petition and gathered the required twenty signatures to begin an official recall. That petition has been delivered to the county for verification. Once verified, the group will have seventy-five days to collect the required number of signatures, which is 20% (46 voters) of the electors registered to vote in the city of Horseshoe Bend. If enough signatures are gathered, the recall petition will be returned to the Boise County Clerk for verification, during which the clerk will have fifteen business days to certify the petition's signatures and return it to the filing officer, who will determine if there are enough signatures to call a special election.

If the recall petition is confirmed, Corvinus will be given the opportunity to resign, rather than being subject to removal by special election. Corvinus has been the subject of community discord since it came to light that he allegedly misappropriated funds while serving as fire chief for the Horseshoe Bend Volunteer Fire Department. He has been charged with felony grand theft (Idaho statute I18-2403(1) (F)) and is set to face a trial by jury at the end of May, following a pre-trial conference scheduled

for May 12.

Corvinus' undoing began in April of 2022, when his replacement as HSB Fire Chief, Jeff Johnson, posted on Facebook that an internal investigation had uncovered the theft of monies from the department and that the individual accused of taking the funds had admitted to the theft. It later came to light that the accused was Horseshoe Bend Councilmember Corvinus. Almost immediately after Corvinus was identified and charged with the theft, calls for his resignation appeared all over social media, but he has chosen to remain in office, which is his right under

Idaho State law. Only if convicted of a felony will Corvinus be forced to vacate his office.

Morgan Boydston, a reporter for KTVB News Channel 7 posted on HSB Politics Facebook page last week asking for residents to contact her if they were in support of Corvinus and against the recall. It is unclear if anyone has contacted her privately. Her report, which aired on Friday, March 25, had only one interviewee, former Boise County Commissioner Ryan Stirm, who used to be part of the volunteer fire department. During the interview, Stirm said he was with the fire chief when they heard that

someone had taken thousands of dollars from the fire protection district. "You're taking from a community of people that are giving what may be the last of what they have," Stirm told Boydston. Stirm also told the reporter that Corvinus was his best friend and that he was shocked and doubtful until he saw the evidence.

The complaint that was filed with the Boise County Prosecutor's Office states that Corvinus misappropriated over \$3,600 during the time he was the department's chief, between November 2021 and March 2022.

Stirm continued in the interview, stating, "Pretty much everyone in this town, at some point or another, has managed to donate to that fund and then you're taking it? You're taking it from your friends? You're literally stealing from your friends." Stirm agreed that Corvinus should not hold his position as a councilmember. "The major portion of your responsibility as a city councilmember is to be fiscally responsible and obviously, you're [Corvinus] not completing that duty."

What happens with Corvinus remains to be seen. If con-

victed of a felony, his office may become vacant per Idaho Code 59-901. However, until that time, Curtis Corvinus is presumed to be innocent. His innocence or lack thereof may be a moot point in terms of his council position if the community backs the recall effort against him. Stirm's full interview can be seen on ktvb.com

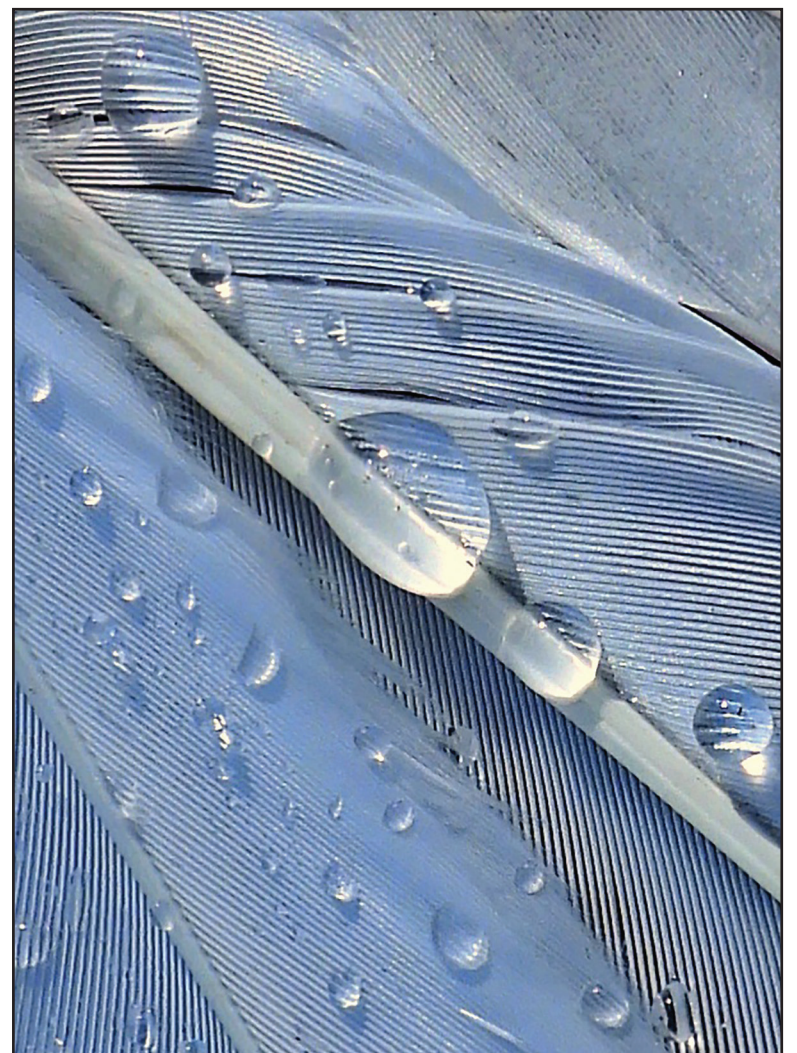

BOISE COUNTY COMMISSIONERS

March 21, 2023

Present: Commissioners Steven Twilegar and Lindy Lindstrom

Absent: Commissioner Clay Tucker

Pledge of Allegiance

MINUTES: Chairman Twilegar motioned to approve the minutes from March 14, 2023. Commissioner Lindstrom seconded the motion and the motion carried.

CANVASING THE VOTES: Clerk Mary Prisco spoke regarding the vote in Horseshoe Bend for the school levy. Twilegar motioned to accept the canvas for March 14, 2023, voting statistics. The motion carried.

DEPARTMENTAL ISSUES:

SHERIFF: Sheriff Scott Turner discussed the event coming up for the Boise Ridge Riders (motorcyclists). Commissioner Twilegar motioned to approve the agreement to provide law enforcement to the Boise Ridge Riders, Inc, for the Idaho City 100 Enduro, June 3rd and June 4th. The motion carried.

PROSECUTING ATTORNEY: Adam Strong addressed the vacancy for Boise County Prosecuting Attorney. He has given his two-week's notice and will be concluding his job with the county as prosecutor. The Boise County Republican Central Committee has 15 days from the date that notified the commissioners to select three names of qualified candidates. Strong offered a proposed advertisement, should three candidates not be found living within the county.

As the newly appointed magistrate judge for Boise

County, Strong said, "I will not be in Boise County the first few months. Just because, I can't be the judge over cases that I was prosecutor. So, they are going to have me down in Ada County the first three or four months."

The official swearing in ceremony will be on April 7th, 2023.

AUDIT REPORT: Chairman Twilegar motioned to accept an audit report from Bailey and Company, dated March 8, 2023. The motion carried.

RACE TO ROBIE CREEK: Chairman Twilegar motioned to approve a liquor catering permit for the Race to Robie Creek.

COUNTY SNOW REMOVAL: A bill was discussed for general snow removal for 11 hours at \$105 each hour, totaling \$1,155. Twilegar motioned to approve the bill and the motion carried.

SQUAW CREEK SOIL CONSERVATION: Twilegar motioned to approve the demand warrant for Squaw Creek Soil Conservation District for \$2,750. The motion carried.

EXECUTIVE SESSION: A motion was said to enter into a closed executive session for a personnel issue. [Time 9:18 am to 9:35 am] Coming back into session, Commissioner Twilegar said there was no action required.

MONTGOMERY STREET DISCUSSION: Led by constituent CarrieAnne Kowalczyk, and accompanied by Idaho City Mayor Kenny Everhart, and Idaho City Director of Public Works Tami Claus. Kowalczyk went through past Boise County minutes from February 13, 1978 concerning a Forest Service ranger asking if Montgomery Street could be used by

logging trucks for their timber sales. She surmised that, "this is obviously a county road, because why would they be coming to ask the commissioners for permission for that?" She then quoted from minutes in the following year describing where the county would purchase traffic control signs and the city would install the signs. The county also purchased culverts for the city, who would then install them.

Kowalczyk went through several other minutes to prove there were multiple documentations.

Prosecutor Adam Strong addressed the documentation and encouraged the county and city to "work together to figure this out." He continued, "It doesn't necessarily matter what a commissioner in 1979 thought or what a city attorney in 1979 thought... That doesn't impact who owns the road. It just doesn't, who's responsible for the road. We have very specific laws." He then quoted Idaho Code 50-313: "The city councils of cities shall have the care, supervision, and control of all public highways and bridges within the incorporated limits and shall cause them to be opened and repaired." He said that didn't mean that the county couldn't enter into some sort of agreement with the city to help them out.

Mayor Everhart stated that Montgomery Street was designated as a county truck route and they have historic maps dating back to 1950. There was also a portion through Crouch that was designated as a truck route, "and the county repaved that." He questioned why there was so much resistance, if

Montgomery was also designated as a truck route.

Chairman Twilegar said he was hoping that the city could bring them a signed document of a formal motion or agreement. He then asked if there was any consideration to remove the blacktop and revert it back to gravel. Mayor Everhart said that was a route they were considering. Twilegar inquired about Main Street, and Everhart said they would not consider removing the asphalt on Main Street because "it's in fairly good shape." Twilegar stated that there are three commissioners, but speaking for himself, he would be willing to "help with some of the costs on that." Main Street will continue with the "large patching," the mayor said. Everhart continued, "With the direction that it seems this meeting is taking, we're going to return it to ground." Chairman Twilegar agreed, "I think that's a great idea, anyway."

Strong said, "There is nothing preventing you from working with the city to bear some of the costs of doing that."

Prosecutor Strong went further into official motions recorded and voted actions ac-

cepted by the board. Unless there is something specific, the road remains the city's responsibility.

UPCOMING AGENDA ITEMS: The commissioners discussed upcoming public hearings. Title 3 funds were also discussed, including what that money can be used for specifically.

PROSECUTOR: Strong confirmed that this would be his last commissioners' meeting. Chairman Twilegar commented, "We are going to miss you. I just want to take an opportunity to say, you have done an amazing job. Thank you very much, on behalf of the county and the commissioners."

Strong responded with thanks, "It's been a fun five years. The county has done a lot of things and I think they'll continue to do a lot of things. I'll be just across the street most of the time."

Twilegar wrapped up, "Great, good luck to you, Judge. We're proud of you."

Strong encouraged everyone to help themselves to the muffins and fresh fruit that he brought to share.

Adjourned at 10:10 am.

When to Call and Report a Fire

BOISE COUNTY -- It is never too late to think about fire safety. When we live in an area where wildfires can overcome large swathes of land in a fairly short time, we all tend to pay closer attention to how we take care of campfires and how visitors to our area behave with fire. It is something in the forefront of our mind, even before the snow is gone.

What some of us do not consider very often is at what point it is okay, or even prudent to report a possible fire at home or at the neighbor's. Reporting potential fires is a step that seems to be not as commonly taken by new residents or those who live in the mountains seasonally. However, calling 9-1-1 to get the fire department to respond to your emergency is much more time critical here in the mountains than in places with fully 24-7 manned fire stations and 5-minute response times.

Here in Boise County, there are ten rural fire departments, all dispatched by the Boise County Sheriff's Office.

None of these departments are manned 24-7, and at times, like when the volunteers may be at work or away from the area for other reasons, there may not be enough personnel to respond effectively or in a timely fashion. At the same time, the equipment that each department has to operate with is most likely aged or a hand-me-down from a valley department that can afford new equipment.

When is it prudent to call 9-1-1 to get the fire department headed your way? Realistically, time is precious, so do not hesitate to make that call to protect yourself and your neighbors' property. If it turns

out that the fire department is not needed, you can always call back and have dispatch cancel their response. However, keep in mind that a small fire can grow amazingly fast within the right conditions, consuming homes and spreading to become an out-of-control wildfire burning thousands of acres. Your local, rural volunteer firefighters are invested in their community. They are often credited with containing the fire, with a shorter response time, before firefighters from the Idaho Department of Lands or U.S. Forest Service can even arrive on the scene.

BOISE COUNTY -- On Monday March 13, 2023, the Boise County Sheriff's Department received a call from the Lowman Ranger District that an employee had not showed up for work. Deputies responded to the area and determined that Tyler Beyer, 30 years old, left his residence in Lowman by snowmobile on Sunday in the Lick Creek area. Idaho Mountain Search and Rescue, Boise County Search and Res-

cue, Boise County Sheriff, Forest Service law enforcement, and local snowmobilers all began searching the area.

Due to the weather and extreme avalanche conditions, searchers had a hard time accessing the area. Throughout the week, additional resources from the National Guard, volunteers, and a private helicopter searched the area.

Avalanche forecasters were brought in to evaluate the area and assist with efforts. Over 300 avalanches were located in the area, making things difficult. Tyler did not have avalanche equipment such as a beacon or pack. It was common for him to ride alone. We were able to confirm from a hunter in the area that Tyler did go into the Lick Creek area on Sunday, March 12th around 4pm.

As of Saturday, March 18, 2023, organized efforts have been paused.

Searchers remain in the area daily to continue recovery efforts as conditions change. Given the weather patterns over the last week in the mountain areas, with still more to come, the area remains very dangerous and unstable.

We would like to remind the public to check conditions before going out and follow social media pages covering snow conditions. The mountain areas have experienced several different weather patterns in the past weeks, causing conditions to change daily. We continue to keep Tyler's family in our thoughts and prayers as they navigate this difficult time.

National Forest Tree Sale

U. S. Forest Service News Release

BOISE COUNTY — Landowners who need trees and shrubs to create windbreaks and improve wildlife habitat on their property are encouraged to come to the Boise National Forest Lucky Peak Nursery's annual surplus seedling sale.

The surplus seedling sale will begin Saturday, April 8,

from 8 a.m. to 3 p.m. Seedlings will not be available Sunday, April 9. The seedling sale will continue through the end of April, Monday through Friday, from 8 a.m. to 3 p.m., as supplies last. The price is \$30.00 for 50 seedlings.

The minimum quantity that can be purchased is 50 seedlings of each species. Each customer will be able to purchase



a maximum of 500 seedlings. First-come, first-served, no presales.

All sales on Saturday, April 8, will be drive up. CASH or CHECK only.

This year's available species are ponderosa pine, Wyoming big sagebrush, and a few antelope bitterbrush. Seedlings will be available on a first-come, first-served basis. Sagebrush is highly desirable for improving big game habitat in the foothills. In forested areas, ponderosa pine is typically found on drier sites.

Please note: This year's seedlings are all bareroot. The ponderosa pine is from Arizona seed sources and is a different variety than found here in Idaho. We do not recommend these seedling be planted to reforest forest lands such as after wildfires or harvest. Windbreaks and screening plantings are the best use of these seedlings.

The seedlings are best suited for landowners with property in rural areas. They are not intended for homeowners in urban areas to plant in their backyards. Landowners who purchase the 1-year-old trees can expect the majority of them to grow and thrive if planted correctly. Written planting instructions and technical assistance will be available.

Each year, the Lucky Peak Nursery produces over 3 million one and two-year-old trees and shrubs. These seedlings are used for public land reforestation activities in the intermountain west disturbed by wildfire, timber sales, or other events. When the nursery has produced more seedlings than needed, the surplus becomes available to rural landowners for conservation plantings.

The Lucky Peak Nursery is located 16 miles northeast of Boise on Highway 21. For more information about the annual seedling sale, call (208) 343-1977.

Prescribed Burning for the Boise National Forest

U. S. Forest Service News Release

BOISE COUNTY — As part of the Forest Service's Wildfire Crisis Strategy, the Boise National Forest is planning a more active and robust prescribed fire burning season this spring. This investment is made possible through the Bipartisan Infrastructure Law.

Fire managers anticipate favorable spring weather conditions for planned low-intensity prescribed fires. These low-intensity prescribed fires reduce the risk of large wildfire potential to communities and other critical resources such as municipal watersheds and powerlines while promoting the growth of fire resilient trees and improving wildlife habitat.

Weather and conditions permitting, prescribed burns are scheduled to start in March and continue through June. Approximately 4,670 acres are planned for ignition in 11 project areas throughout the Boise National Forest.

Public and firefighter safety is the top priority in all public land fire operations. Fire managers develop burn plans accounting for safety, specific fuel and weather prescriptions, and smoke management. All prescribed burns are closely evaluated and are only approved when favorable conditions are present.

Prescribed burns may affect people sensitive to smoke and may impact access to burn areas and travel routes. Fire officials strongly advise forest visitors and homeowners to prepare and plan activities around the proposed dates and locations of burns and to use extreme caution near prescribed fire areas.

Please be aware of firefighters and equipment in the area and on roadways, comply with posted notices, and drive slowly in areas with decreased visibility. Information and signs will be posted on roads that access burn areas in advance of ignitions and remain in place through burn completion.

The Idaho Department of Lands and Boise, Payette, and Sawtooth National Forests' planned prescribed fire treatments are featured and updated annually. Planned Boise National For-

est fall prescribed burns include:

Idaho City Ranger District
Alder (250 acres): located 3 miles north of Placerville, Idaho. This is a landscape burn (ground fire) using hand ignition to reduce fuel in the wildland urban interface.

Boise Basin Experimental Forest (300 acres): located 2 miles east of Idaho City, Idaho. This is a landscape burn (ground fire) using hand ignition to reduce fuel in the wildland urban interface.

Little Ophir (300 acres): located 4 miles west of Pio-neerville, Idaho. This is a landscape burn (ground fire) using hand ignition to reduce fuel in the wildland urban interface area.

Mores South-Boulder Creek (250 acres): located 3 miles east of Idaho City, Idaho. This is a landscape burn (ground fire) using hand ignition to reduce fuel in the wildland urban interface.

Mountain Home Ranger District

Lower Feather (752 acres): located approximately 3 miles north of Featherville, Idaho, in the Feather River and Lincoln Creek drainages north of National Forest System (NFS) road 156. This is a landscape burn (ground fire) using hand ignition to reduce fuel in the wildland urban interface and may require multiple days of ignition.

Lowman Ranger District

West Lowman (1,007 acres): located northeast of and immediately adjacent to Lowman, Idaho, This is a landscape burn using hand ignition over multiple days to improve wildlife habitat and forest health conditions.

Emmett Ranger District

Williams Creek (174 acres): located approximately 8 miles north of Banks, Idaho. This is a landscape burn using hand ignition and aerial ignition to reduce activity fuel created by timber harvesting operations and to improve forest resiliency.

Pinney Slope (960 acres): located approximately 6 miles north of Crouch, Idaho, in the Pinney Creek drainage. This is a landscape burn (surface fire) using hand and aerial ignition to promote restoration of the forest landscape.

Training Volunteer Firefighters in Idaho City

EAST BOISE COUNTY – A big shoutout to the collective twenty volunteer firefighters from Robie Creek Fire, Wilderness Ranch Fire, Clear Creek Fire, Centerville Fire, and Idaho City Fire for completing 50 hours of Fire Fighter 1 Basic Essentials, and 10 hours of scenario and live fire work. Their communities are very lucky to have these dedicated volunteers who embraced the importance of serving with a big heart, are willing to spare precious time, and continue to work with the untold dedication and devotion they have to their communities and fellow firefighters. Instructor John Ward recognized this commitment and asked, “Please make sure you thank these ladies and gentlemen for all they give so freely and the sacrifices they make. They learned about fire dynamics and behavior, how to understand it, and read it, which helps them predict what

it is doing and going to do and how it reacts in a compartmentalized situation or structure fire.” The basic essentials class included instruction for using firefighting tools, and how to use this equipment properly to their advantage while combating a fire. The class also covered gained knowledge in fire ground and scene safety and Personal Protective Equipment (PPE) and Self-Contained Breathing Apparatus (SCBA) usage, capabilities, and limitations. Firefighters were also instructed in their various roles and responsibilities for fire teams and in tasks that should be performed on the scene of a fire. Ward said, “The big thing they learned is safety for themselves, for their fellow team members, and their community.” The last part of the class included a live fire burn box, which allowed them to gain

confidence in their PPE and SCBA. They also gained firsthand knowledge of fire behavior, how to initiate ventilation effects and methods, and then conducted extinguishment tactics.
