Swift Water Rescue Techniques and Actual Implementation

EAST BOISE COUNTY --

Our volunteers, along with some from Robie Creek Fire, Idaho Mountain Search and Rescue, Boise County Search and Rescue, and East Boise County Ambulance District came together to train both on shore and in the cold water on Saturday, April 15th. It's important for us to train together frequently so we can operate cohesively in a real situation. We trained on our basic swift-water rescue skills such as wading, rope throwing, swimming, self-rescue, etc. We then went through several scenarios to test our training with these skills. We utilized our new rescue raft as a platform to hold our "patient" in the middle of the creek. In most scenarios, the raft was meant to be a vehicle in the water. In some ways the raft is actually harder to reach than a car would be, as it doesn't create an



A trained rescue swimmer with Wilderness Ranch FPD crossed the swiftly moving water in Mores Creek to assess the situation and then tossed a rope back over to shore, to a group of other rescuers acting as the "belayers." The swimmer then hooked into the rope using their rescue personal flotation device (PFD), put a PFD on the patient, and used a pendulum technique, letting the current push them back to shore, where additional rescuers assisted in getting the patient up to the ambulance.

The accident occurred on the evening of April 11th. There was one individual in the vehicle headed northbound on Hwy. 21 when he left the roadway at about mile marker 29.5. He was flown by helicopter to St. Al's hospital and then released. Boise County Sheriff Scott Turner indicated that alcohol was a factor in this accident.

Horseshoe Bend's City Council Meeting

HORSESHOE BEND

-- The following is a synopsis of the Horseshoe Bend City Council meeting that was held on Wednesday, April 12, 2023. All council members were present with the exception of councilmember Patti Burgess, who was not in attendance. The meeting was delayed three minutes to allow for city attorney Tony Pantera to arrive. There were seven spectators in the audience, including a Boise County Sheriff Deputy.

Mayor Pat Goff made the call to order at 7:03 p.m., then led the Pledge of Allegiance. After unanimous approval of the agenda, minutes from the previous meeting of March 15, 2023, and the authorization to pay the city's bills, Goff opened the meeting with new business.

First up on the agenda was a lot split requested by the Keeths, who were not in attendance, so the matter was tabled due to a setback issue.

Goff requested that the council consider an EMS stipend increase from the current twenty-five dollars per run to seventy-five dollars for all EMTs and an increase from twenty-five dollars to fifty dollars per run

for ambulance drivers. He also suggested that everyone placed on an on-call standby without a run receive twenty-five dollars. Councilmember Martye White was the first to comment, "In the past we've had trouble with people hogging runs." He implied that some EMS personnel had been making a living off of stipends and wanted to see proof that the problem is fixed before an increase is given. Goff indicated that he didn't think anyone would be able to monopolize the runs, because there will be a calendar system in place. White told the council that there was a calendar in place before. Pantera interjected and told the council that it had been 20 years since the last stipend increase. A representative from Acute Rescue & Transport, who are partnering with the city for EMS services, showed the council the EMS Departments calendar from her smartphone. Goff said the increase is needed because McDonald's is paying seventeen dollars per hour with paid time off. White said that he "just wants to make sure we're not setting ourselves up for failure. I want the stipend to go

House Fire in the Clear Creek Area

EAST BOISE COUNTY -- A house fire was called in by passing motorists on the morning of April 11th at around 5am. A closed gate blocked emergency responders from entering immediately, and by the time they removed it to gain access and arrived on the scene, the home was fully engulfed. Luckily, no one was home at the time of the fire when Clear Creek and Thorn Creek volunteer firefighters arrived, and they were able to contain the fire with the help of the snow. Fire Chief Marvin Jennings with Clear Creek Fire said it could have been much worse if this fire had occurred during the hot summer months. Jim Stringfellow, who had a personal tie to the cabin, reminisced on its history, saying, "Rev. Robert Stringfellow and [his] wife Rosalie bought the

place in 1936 from a miner and added a kitchen to the two-story dwelling near a spring. His joy was grafting six varieties of apples onto a tree beside the place.

"Walter, one of the couple's four sons, and wife Nancy took their children up there all the time.

"A flood destroyed the structure in the early 50s, so Walt and his son Jim started building a new building on the other end of the flat in 1956. Walt and Nancy moved in, commuting to Boise for her work at The Book Shop until she retired and made it their home.

"Walt died from a ruptured ulcer and Nancy lived there until she was unable to do so. Their daughter Rosalie Sorrels moved in and made it a center for friends and family for years, until she passed away."

Stringfellow also shared some fond memories of the cabin, "I was brought there over the creaking cable bridge from age two months and [remember] winding the old Victrola record when I could finally reach the handle, sleeping in the loft, eating grandma's pancakes, and stuffing moss in the trough that brought water to the back of the kitchen."

"Pappy taught himself the rudiments of log cabin construction and we and a good friend went to China Creek for logs, hand-mixed cement to make bricks, cranked up a cement mixer of dubious parentage, and hauled the slurry up a hill to pour the foundation."

"One memorable winter, we snowshoed in with the plate glass window for the front and were able to install it on the second story while standing on

Present: Commissioners Steven Twilegar, Clay Tucker, and Lindy Lindstrom

Pledge of Allegiance

CONSTITUENT INPUT: None

MINUTES: Chairman Twilegar motioned to accept the minutes from April 4th, which was seconded, and passed.

DEPARTMENTAL ISSUES:

ROAD DEPARTMENT: Curtis Dill spoke about a system that was so old on a truck that they could no longer get parts for it. Chairman Twilegar inquired, "So, if I'm hearing you correctly, your duct tape is no longer working anymore? Have you tried bailing wire?" Dill joked back, "Yeah, we're all out." Twilegar filled in, "We're all out of options?" Someone recommended bubble gum.

Chairman Twilegar motioned to approve the purchase a piece of equipment in the amount of \$11,655. All were in favor and the motion carried.

BOISE STREET BRIDGE: Twilegar motioned to approve the Boise Street Bridge flood development permit application. All were in favor and the motion carried.

TECH: Robert McCracken reported, "Our backup server lost its power supply on Friday, sometime during the night, I'm sure. Rather than replace it, with the exact same model, we're going to upgrade with double the storage space,

double the cloud backup, and they're giving us a smoking deal on it." Twilegar was in favor. McCracken was hoping to have the server overnight delivery.

Chairman Twilegar motioned to approve the upgraded server in the amount of \$6,840, and the backup appliance in the amount of \$14,729.

SHERIFF: Chairman Twilegar questioned an x-ray machine, and asked if it were something the sheriff's office was trying to liquidate. Sheriff Scott Turner corrected that it was something they were trying to buy and said they wanted to purchase a walk-through metal detector for the courtroom. Currently a deputy hands people before they enter the courthouse. There was a discount of \$500. Chairman Twilegar motioned to purchase the x-ray machine for the courthouse in Idaho City in the amount of \$3,500. The motion carried.

NOXIOUS WEEDS: Paul Rekow presented an annual agreement and said, "We don't spray the highways, but we have the ability to go in and take care of certain areas."

Chairman Twilegar motioned to approve the agreement between Boise County and the Idaho Transportation Department for noxious weed control. It was seconded and approved.

MASS GATHERING: An annual music mass gathering in Horseshoe Bend was discussed, and to provide law enforce-

ment. Twilegar made a motion to approve the agreement for the sheriff's office to provide law enforcement to the Connection Music Festival from June 15th through June 18th.

SHERIFF: An annual agreement with the U.S. Forest Service was discussed to patrol certain areas, like campgrounds during the summer. Sheriff Turner said, "The only difference between this year and last year's, is because the Forest Service is so far in the red, they cut our equipment money, and our dispatch money out of it. They cut it all with \$16,000, compared to what it previously had been."

Twilegar motioned to approve the agreement between the USDA Forest Service and Boise County. The motion carried.

CLAIMS APPROVAL REPORT: Chairman Twilegar motioned to approve the claims approval report in the amount of \$104,863.70. The motion carried.

GOOD NEIGHBOR AUTHORITY GRANT: Interim Prosecutor Alex Gross advised the board on the progress of the grant. Commissioner Tucker expressed some concerns regarding verbiage.

EXECUTIVE SESSION: Closed session to discuss a personnel issue. [Time 9:22am to 9:57am] Twilegar said after coming back into session, "No action required."

Adjourned at 9:58am.

Stringfellow recalled that another individual had bought the cabin a few short years ago, "and put much love and money into the old place. Sadly enough, the fire took it from us. Memories remain."

According to Knute Sandahl, Idaho State Fire Marshal, this is still an ongoing investigation and will take another three weeks in order to make a determination as to the nature of the fire.

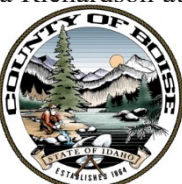

up,” but he implored the council to ensure that accountability measures were employed. Goff said that an updated EMS handbook would handle such concerns and that the EMS Director should be able to watch the calendar and make sure that the signups are done fairly and equitably. Councilmember Stephen Chartier motioned for the stipend increase to be approved, councilmember Curtis Corvinus seconded, and the motion passed unanimously.

In other new business, the Horseshoe Bend Valley Chamber of Commerce’s Treasurer/Secretary Nicole Cundiff, along with the representative from Acute Rescue and Transport, told the council that they were working on a marketing campaign for recruiting EMS employees, as well as planning a fundraiser to help with the costs of certifying emergency medical technicians. They are also looking at grants to help with other department needs. They presented the council with several documents to look at. Goff recommended that the matter be tabled so the council would have time to review the

documents. Pantera said he had reviewed them and that there were only small grammatical errors in some of the documents.

One part of the package contains a commitment for EMS volunteers to sign that states they would pay back monies for training if they did not stay in service with the department for a certain amount of time. Pantera said that it would be difficult to recoup any money for training when someone quits. The Acute representative said that the grammatical issues will be cleared up by the next meeting. Cundiff told the council that she thinks the contract to recoup training funds will hold people more accountable. White commented that by paying for training he “doesn’t want Horseshoe Bend to become the training center for Idaho.” Corvinus made a motion to approve the new EMS documents, minus the new handbook which hadn’t been completed. Chartier seconded. Pantera told the council that the grammar corrections weren’t substantive. Motion passed.

Next on the agenda was former Horseshoe Bend mayoral candidate Dave Jakovac. Ja-

kovac opened on the dais by asking who the current EMS Director was. He was told that Tren Long and Rindy Quijas are currently serving as interim directors until a new director can be appointed. He then asked what the city funded for the EMS Department. He was told supplies, ambulance, gas, and stipends. Terri Nolan, the city treasurer, said that invoices for rides should pay for EMS. The Acute representative said that the state of Idaho does not deem EMS departments as essential services, so no funding comes from the state. Jakovac asked how many certified EMTs the department had. He was told four with two more coming, to which he replied, “Good. Glad to hear that.” He recounted a story that he heard that people had to pay for their ambulance rides and then requested reimbursement from the city. Nolan said that the city had never reimbursed anyone. The city employs a billing service to assist users of the EMS service. Jakovac asked how many calls the department had last month and Quijas told him seventeen. He then asked what the response time was. Quijas said that it takes about six min-

utes to pull out for a run once everyone is at the station. She said that, as to when they arrive at the destination, it depends on where they have to travel to.

Goff interjected and told Jakovac, “This is not a Q and A.” Jakovac replied, “I’m trying to figure this out,” then thanked the council for addressing the EMS issues. White told Jakovac, “Dave, I’ve been here for twenty-five years. EMS and law enforcement has been a concern with this city every day. That’s the way it works in a rural city.” Jakovac then said that he had heard of forty-five-minute response times and that was “unacceptable.” White replied, “That’s rural America, you can’t fix that. How do you propose we fix that?” Jakovac said that they needed to get the EMS department to be functional. The Acute representative jumped in and said that there was no state funding and that even an empty ambulance costs a half million dollars. She continued, saying that the department doesn’t have enough calls to be on duty 24/7 and that there currently is a huge shortage of volunteers. Goff added that they were currently working on securing grants to help pay for the service. Jakovac said, “The priority of the council is skewed,” and maintained more time should be spent on the EMS department. Goff said, “My main priority is about the safety of the citizens.” Jakovac stated, “It’s nonfunctional,” then walked out of the meeting.

The last piece of new business on the agenda was the Horseshoe Bend Valley Chamber of Commerce. They needed the council’s okay to host an MMA Exhibition at the Veteran’s Memorial Park. The item

was tabled at the suggestion of Pantera, who wanted to wait until the insurance paperwork was completed. He said that he didn’t have any concerns about the showcase fight, but needed to see an insurance rider that indemnified the city. White said, “I don’t want to see it turn into a circus. The mayor replied, “No, no, no.” Goff asked the council to schedule a special meeting on Friday, April 14 to deal with the MMA Exhibition as well as approving the Boise County Sheriff Department contract, which was left off tonight’s agenda. White also asked the mayor to check in with Sheriff Turner to find out why the city council hadn’t been receiving monthly reports from his department.

Public Works: The work on the levy is complete, the department repaired a hole where previous work had been done. The department is gearing up for the spring run-off and they are already seeing dirty water. Spring maintenance has started on tools as well as filling potholes. They will do road patch work when the weather permits.

City Engineer: Supporting the public works department was discussed, along with work on the Boise Bridge project. The engineer will be attending a meeting regarding Phase I of the Deer Valley subdivision the week of April 16.

City Attorney: The attorney had nothing new to report, which was not already mentioned. Mayor Goff closed the meeting by telling the council, “Thanks for being here again, for this thankless job. Hope to see you on Friday.” With no executive session, the meeting adjourned at 7:40 p.m.

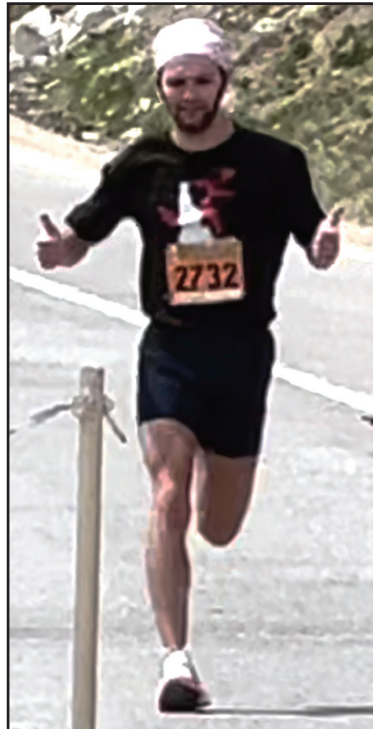

ORDINANCE NO. 375

AN ORDINANCE ESTABLISHING GENERAL FUND ADMINISTRATION AND LAW ENFORCEMENT FEES AND ESTABLISHING THE PURPOSES FOR WHICH SAID FEES MAY BE USED.

BE IT ORDAINED by the Mayor and Council of the City of Idaho City, Boise County, Idaho:

SECTION 1. RESOLUTION OF FEES. The General Administration and Law Enforcement fees imposed and collected shall be established by resolution adopted by the Council of the City of Idaho City.

SECTION 2. USE OF FUNDS. All fees collected for General Administration and Law Enforcement shall be set aside in the General Fund to be used for maintenance, upkeep, and for any other expenses that shall be incurred by the City in its operation.

SECTION 3. SAVINGS CLAUSE. If any section, paragraph, sentence, or pro-circumstance shall ever be held invalid or unenforceable, such holding shall not affect the remainder hereof, which shall continue in full enforce and effect and applicable to all circumstances to which it may validly apply.

SECTION 4. EFFECTIVE DATE. This Ordinance shall take effect and be in full force upon its passage, approval, and publication in one (1) issue of the *Idaho World*, a newspaper of general circulation and the official newspaper thereof.

SECTION 5. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION 6. This ordinance shall take effect and be in full force upon its passage, approval, and publication in one issue of *The Idaho World*, a newspaper of general circulation in the City of Idaho City, and the official newspaper of said City.

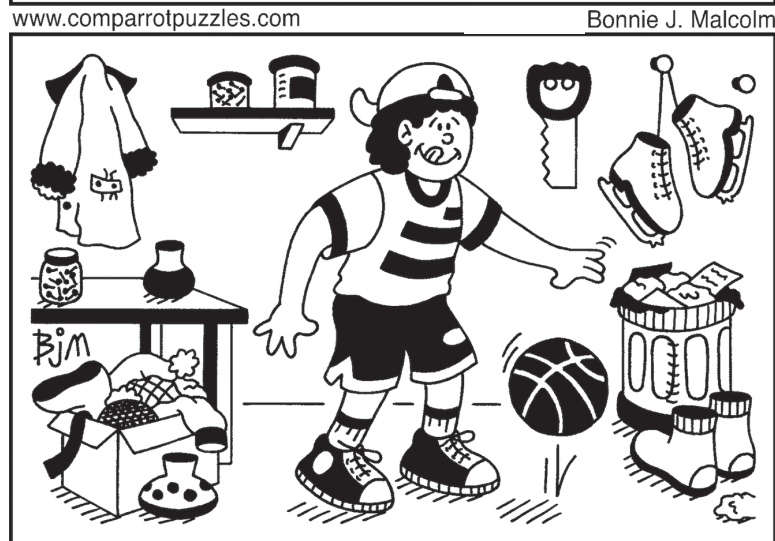

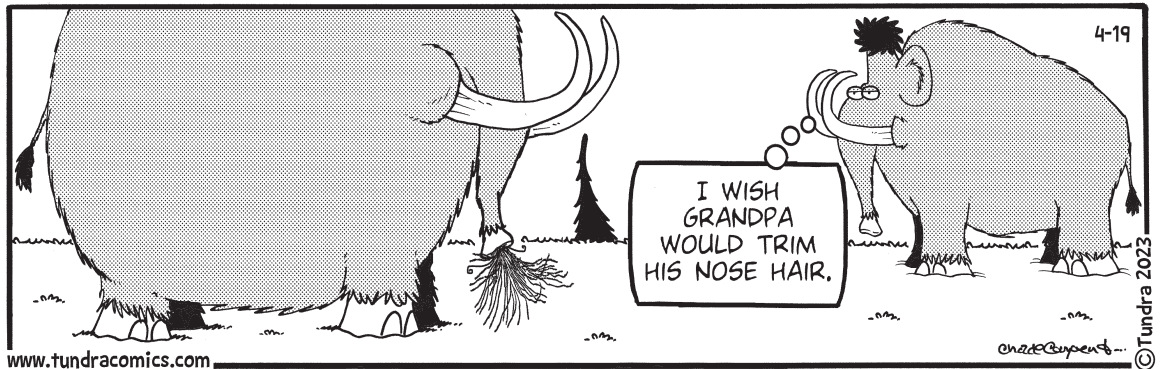

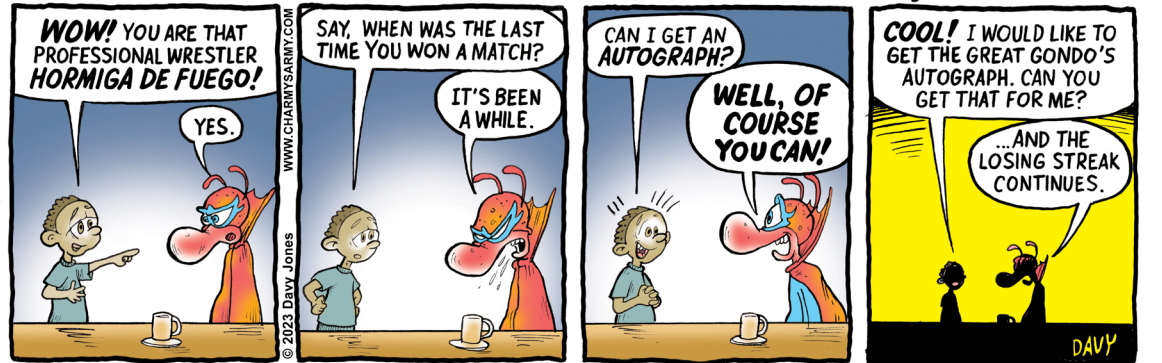

SUMMARY OF ORDINANCE NO. 374

AN ORDINANCE OF THE CITY OF IDAHO CITY, IDAHO, AUTHORIZING AND PROVIDING FOR THE ISSUANCE OF A WATER REVENUE BOND, SERIES 2023, IN THE PRINCIPAL AMOUNT OF \$2,400,000, FOR THE PURPOSE OF FINANCING THE ACQUISITION OF IMPROVEMENTS TO THE DOMESTIC WATER SYSTEM OF THE CITY; DESCRIBING THE BOND; PROVIDING FOR THE COLLECTION AND DISPOSITION OF REVENUES; PROVIDING FOR THE PAYMENT OF THE BOND; ESTABLISHING FUNDS AND ACCOUNTS; PROVIDING COVENANTS RELATING TO THE BOND; PROVIDING FOR THE SALE OF THE BOND TO THE STATE OF IDAHO, DEPARTMENT OF ENVIRONMENTAL QUALITY; PROVIDING FOR RELATED MATTERS; AND PROVIDING AN EFFECTIVE DATE

A summary of the principal provisions of Ordinance No. 374 of the City of Idaho City, Boise County, Idaho, adopted on April 12, 2023, is as follows:

Section 1: Defines the terms and phrases used in the Ordinance.

Section 2: Describes the water improvement project to be constructed with the proceeds of the Bond authorized by the Ordinance, and states that \$2,400,000 of the cost thereof is to be paid from the sale of the Bond of the City described in Section 3 and authorized at a special election held on August 3, 2010, and the balance of which is to be paid from other lawfully available funds of the City.

Section 3: Describes the City of Idaho City Subordinate Lien Water Revenue Bond, Series 2023 (the "Bond"), and provides for the terms of payment and the maturity of the Bond.

Section 4: Provides for the manner and method of execution of the Bond.

Section 5: Provides for the place and manner of payment of the Bond.

Section 6: Appoints the City Treasurer as Bond Registrar.

Section 7: Provides for the prepayment of the Bond.

Section 8: Provides for water rates and charges.

Section 9: Pledges the Net Revenues of the domestic water System for the payment of the Bond, subordinate to the City's Prior Obligations.

Section 10: Establishes

the "City of Idaho City Water Project Capital Improvement Fund."

Section 11: Establishes the Water Subaccount within the Water and Sewer Revenue Fund.

Section 12: Establishes the City of Idaho City Water Revenue Bond Fund.

Section 13: Provides for a Debt Service Reserve Fund.

Section 14: Provides for the disposition of surplus funds.

Section 15: Establishes the conditions of and limitations on the issuance of additional bonds or other obligations.

Section 16: Provides for the investment of surplus funds.

Section 17: Provides certain general covenants of the City with the Registered Owner of the Bond.

Section 18: Provides certain special covenants of the City with respect to the exclusion of interest, if any, on the Bond from income taxation.

Section 19: Provides for the sale of the Bond to the State of Idaho, Department of Environmental Quality.

Section 20: Provides for method of amending the Ordinance and adopting supplemental ordinances.

Section 21: Recites that the Bond is issued pursuant to the Idaho Revenue Bond Act.

Section 22: Provides for remedies of the Registered Owner of the Bond.

Section 23: States that the Ordinance constitutes a contract with the Registered Owner of the Bond.

Section 24: Provides for severability.

Section 25: Repeals prior inconsistent ordinances, to the extent of any inconsistency.

Section 26: Authorizes the Mayor, City Clerk, and City Treasurer to execute any additional documents necessary to sell and deliver the Bond.

Section 27: Provides for the publication of the Ordinance or a summary thereof and the effective date of the Ordinance.



OBITUARY



David "Bruce" Reay
1938 - 2023

David "Bruce" Reay passed away peacefully on April 4, 2023, surrounded by his loving family. Bruce was born on December 16, 1938 to David E. and Mary Beulah Reay in Boise, Idaho. Although Bruce was raised in Garden Valley, he spent his youngest years living near Forest Service CCC camps in close proximity to his dad's work for the Forest Service. Accommodations ranged from a 20-foot camp trailer with an attached wall tent for his mom's washroom to a 2-story log house in Landmark where Bruce learned to ski off the rooftop during a winter that brought 11 feet of snow and -60-degree weather.

When Bruce was five years old, his dad was drafted to the South Pacific Theater in the Marine Corps for two years during WWII. This was a trying time for the family, as his mom continued raising 4 young children on the home front. Bruce did chores to help as "man" of the house, being the oldest child yet not even school-aged himself. He would often stand at the fence and yell longingly for his dad to return.

Bruce began his formal education in a one-room schoolhouse north of Crouch, Idaho, and later graduated as valedictorian of his class of 3 at Garden Valley High School, enjoying many shenanigans along the way. He attended Boise Junior College, where iconic football coach Lyle Smith was his PE teacher, and later transferred to University of Idaho where he graduated with a Bachelor of Science in Forestry and emphasis in forest and range management.

As a teenager, Bruce started a small cattle operation with his parents to build his college fund. He often traveled long distances in dangerous conditions to care for the cows,

crossing the river in a hand-operated cable car and walking miles through timberland to the barn where he would cut and pitch the hay. He had many other jobs during those teenage years, including haying for \$30 per summer, working on a Forest Service Road survey crew where he was treed by a bear on his first day, and renting ground to farm, but his favorite job during that time was for two weeks every spring when he would cowboy for the Garden Valley Cattle Association, moving 500 cows from Garden Valley to Bear Valley, usually on a wild horse.

When Bruce was 18, his parents bought the Lily Pond Campground above Crouch. Nearly twenty years earlier, a wildfire had burned the area and left behind a heavy Ponderosa Pine seed crop that sprouted 100,000 seedlings per acre. The area looked more like a wheat field than a forest. Bruce saw the need to manage the timber and thus started the process of pre-commercial thinning and slash control, doing all the cutting and piling by hand. This was the beginning of a lifelong labor of love dedicated to responsible forest management that inspired his education and career in forestry.

During the summer after Bruce's first year of college, he attended Smoke Jumper Training School where he was proud to win a contest that included a training jump and a one-mile competitive race carrying 100 pounds. Over the following summers, he jumped on several fires and later looked back on this as one of the most challenging and exciting work experiences he encountered throughout his entire career.

Because Bruce received a military draft deferment to finish his college studies, he was automatically drafted the fall after he graduated. He went to Army basic training, followed by paratrooper school. He served two years active duty and four years of active reserves, receiving his "Discharge/Vietnam Era" in 1968.

Upon returning from active duty, Bruce hooked logs and cruised timber before meeting the love of his life, Linda Valentine. After a short courtship, they were married on October 22, 1966, and began a 56-year run that led to a cherished fam-

ily with three children, seven grandchildren, and three great-grandchildren, of which Bruce was very proud.

During their early years of marriage, Bruce went to work for Boise Cascade Corporation as a choker setter, then crew leader for the high lead logging side of the business, later becoming the head rigger for their experimental helium balloon logging project. Because of Bruce's fearless nature, he volunteered to jump from a helicopter to the top of the helium balloon to untangle the lines, a stunt surely frowned upon by today's OSHA standards. This was the start of his 30-year career at Boise Cascade, the bulk of which was spent fueling his passion for silviculture as their fee lands manager for southern Idaho, an area comprising 125,000 acres.

In 1975, Bruce and Linda decided to raise Christmas trees for extra income at their 12-acre place in Horseshoe Bend, thus beginning The Pine Patch Christmas Tree Farm. Starting with Scotch Pine and later adding several Fir species, they ran a "choose and cut" Christmas tree business for 40 years that provided a treasured family tradition for thousands of customers, not to mention employment and much-needed college money for their kids and friends.

Bruce lived a lifetime of service, putting his family first while also trying to be helpful and considerate to others. He was initiated into The Grand Lodge of Idaho in 1970 and was a Master Mason for over 50 years. He also spent 12 years on the Horseshoe Bend School Board and was proud to be part of the successful effort in 1990 to finally build a high school in the community after two previous failed attempts. He viewed this period of service, along with his time in the military, as his most important contributions of giving back to society.

Bruce was a man of long-term vision and worked diligently on many projects that would only show the fruits of his labor many years down the road. His contributions will live on in their benefits to his family, community, country, and earth - a true legacy.

The Reay family would like to extend a heartfelt thank you to Keystone Hospice for their top-notch care and guidance through Bruce's peaceful and comfortable journey home.

Bruce is survived by his

children Kari (Jess) Cooper, Tye (Tina) Reay, Abby St. Germain; seven grandchildren, Sydney, Lainey, Drake, Brittani, Parker, Nicholas, and Easton; two great-grandchildren, Briella and Nora; sister Kathy (Ron) Kulm, and brother Miles (Stacey) Reay. He is preceded in death by his parents Dave & Beulah Reay, great-grandson Oliver, and sisters Barbara Nunes and Nancy Logan. In lieu of flowers, the family requests memorials be sent to the Horseshoe Bend School District, 398 School Drive, HSB, ID 83629, for the

purchase of a retractable American flag for the gymnasium in his honor.

Memorial service will be held Sunday, April 30th at 1:00 PM in the Horseshoe Bend School Gymnasium. Potluck to follow at the Masonic Lodge in Horseshoe Bend.
