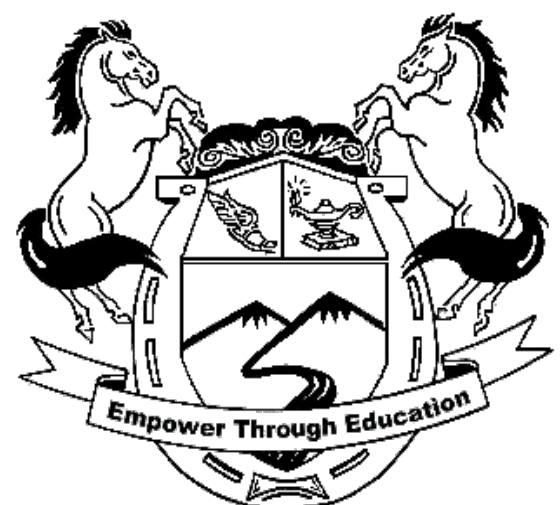
HORSESHOE BEND -- High School Graduation Ceremony on Saturday, May 27th, from 10am to 11am in the gym.

## Boise National Forest Conducts Prescribed Burns

**BOISE COUNTY** -- The Boise National Forest has been conducting several prescribed fire burns in Boise County. Prescribed burns are fires that are intentionally started and controlled in the forest under the management of the trained wildland firefighters in the Forest Service. According to Ryan Shannahan, a fuels expert with the Boise National Forest, "By pre-burning these fuels [needles, downed logs and branches], it reduces the risk of a high severity wildfire in the future because there is less combustible material on the forest. Prescribed fire is a proactive way to fight fire, and vital to the protection of communities in the Wildland Urban Interface!" The Wildland Urban Interface (often referred to as WUI) is the area where homes and communities meet the forest.

There were five prescribed fires in Boise County this past week. The Pinney Slope Prescribed Fire Unit plans to burn 960 acres. As of Monday, May 22, they completed 860 acres. Firefighters used aerial ignitions from drone

and helicopter on Sunday May 21, to aid in fire development. This prescribed fire is located about 6 miles north of Crouch, near West Scriver Road. The Williams Creek Prescribed Fire unit had approximately 40 acres accomplished as of May 22, of the 150 total acres planned. This fire is located about 6 miles north of Banks, near Forest Service Road 643. Near Idaho City

is the Boulder Creek Prescribed Fire unit. This fire had about 100 acres completed as of May 22, of the 427 total acres planned. This unit is being burnt in small pieces to reduce the amount of smoke for Idaho City residents. The location of this unit is about 8 miles north-east of Idaho City, near Idaho State Highway 21. The prescribed fires in Lowman are named Lick

Creek 1 and Clear Creek 5. As of May 22, approximately 45 acres had been completed out of the 122 acres that are planned. These units are located about 1/2 mile east of Lowman (Lick Creek 1) and 2 miles north (Clear Creek 5) of Lowman, near Idaho State Highway 21.

The Boise National Forest states that these burns are scheduled to continue but will be postponed if weather conditions, such as temperature, wind, or humidity do not meet the criteria outlined in the prescriptions that are formulated by teams of experts who are thoroughly familiar with the areas.

### CITY OF HORSESHOE BEND NOTICE OF HEARING TO CONSIDER THE FILING OF A PETITION FOR JUDICIAL CONFIRMATION

**NOTICE IS HEREBY GIVEN** that on Wednesday, the 14<sup>th</sup> day of June, 2023, at 7:00 o'clock P.M., or as soon thereafter as the matter may be heard, at the Horseshoe Bend City Hall, 112 Ada Street, Horseshoe Bend, Idaho, the City Council of the City of Horseshoe Bend, Idaho (the "City"), will conduct a public hearing to consider the filing of a petition for judicial confirmation under the Idaho Judicial Confirmation Law, Title 7, Chapter 13, Idaho Code. The proposed project is to make immediate and necessary improvements to the existing water system.

The proposed petition would seek judicial confirmation of the power of the City (1) to incur an indebtedness as an "ordinary and necessary expense" of the City authorized by the general laws of the State, within the meaning of Article 8, Section 3, of the Idaho Constitution, in a principal amount of approximately \$2,000,000 for public water system improvements and to pledge the City's water system revenues for the payment of such indebtedness for a term of years.

Information relating to the proposed project is available at the Horseshoe Bend City Hall during normal business hours of the City. Interested persons are encouraged to attend the public hearing and to present comments. Comments may also be submitted to the City in writing prior to and at the hearing.

## Idaho City Student Athletes Compete at State in Track & Field

**IDAHO CITY** -- Idaho City High School has had a thrower finish 2nd place in either shot or disc for the past 5 years, but this year we finally have a State Champion!

**Brody Backus** had a first-place throw in discus Friday afternoon in the Idaho State meet in Middleton, Idaho. Brody unleashed a throw measuring 161' 8". Only a few feet off the 1A state record set by Tyrel Nelson of ICHS in 2001. Congratulations to Brody, your 2023 Idaho State Discus Champion!

In addition to first in Discus, **Brody** also placed 5th in shot put with a personal best throw of 46' 11".

Junior **Rauri Mulrey** also had an amazing weekend at state. Rauri started the weekend off with a huge PR [Personal Record] in Discus, throwing 156' earning him a second-place finish behind teammate Brody. After throwing, he was off to the track where he just

missed finals in the 300 hurdles but finished his 110 hurdles in 5th place overall in preliminaries, earning him a spot in finals. On Saturday, Rauri came out of the blocks on fire. As he was moving down the track, Rauri was leading the way till the second to last hurdle when he just clipped his heel on one of the hurdles and ended up finishing 6th place.

Junior **Selena Exon** found some hardware in the High Jump event this year, finishing 6th place with a great jump clearing 4' 8". Selena also competed in the long jump and finished 18th with a jump of 13' 1".

**Makayla Barber** competed in high jump for the first time at the State tournament. As a sophomore she finished in 9th place, clearing the bar at 4' 6".

**Mary Plumlee** accomplished what every athlete wants at the state meet with a PR. Mary ran in the 300 hurdles Friday afternoon and finished just shy of making finals, but was able to

improve her personal best with a time of 52.35. As a sophomore, this was Mary's second appearance in the state track meet.

Seniors **Liam Barber** and **Ian Roeber** both threw shot put at the state meet. Liam threw a personal best 44' 10.5" earning him a spot in finals where he finished in 8th place. Ian Roeber had a respectable placement in his first State appearance, finishing 11th place overall with a throw of 42' 8.5".

A sealed bid auction will be conducted at the Idaho Department of Lands office, 3284 W. Industrial Loop, Coeur d'Alene, Idaho 83815, at 1:00 PM local time, on Tuesday, June 6, 2023 for an estimated 4,515 tons of timber, marked or otherwise designated for cutting. In addition, there is an unestimated volume of forest products that may be removed at the option of the purchaser. Prior to bidding, eligible bidders shall present a certified check or bank draft payable to Idaho Department of Lands, or a bid bond acceptable to the State, in the amount of \$3,121.81 which is 10% of the appraised net sale value of \$31,218.10. The average minimum bid price is \$8.54 per TON. The successful bidder's deposit will be forfeited to the State should the bidder fail to complete the contract. The State will not accept bids from parties who are delinquent on payments on existing state contracts.

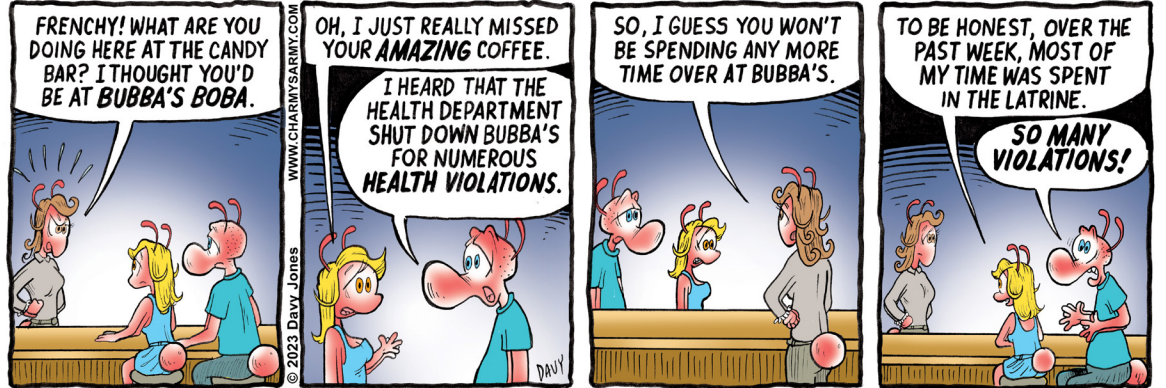
