## **Boise County Declares Disaster**

#### **RESOLUTION #2023-12** A BOISE COUNTY RESO-LUTION TO DECLARE A **DISASTER EMERGENCY**

to life and property in BOISE COUNTY as the result of high temperatures and the threat of rain combined with high snow pack, frozen waterways, and earth which could result in damage to critical infrastructure by flooding, rock, mud and/or landslides; and

WHEREAS, a disaster emergency as defined in Section 46-1002, Idaho Code, has been verbally declared by the Chairman of the County Commissioners in accordance with Section 46-1011(1), Idaho Code on April 29, 2023, and is therefore in existence in BOISE COUN-TY, due to the imminent threat to life and property created by localized flooding and earth movement; and

WHEREAS, Section 46-1011, Idaho Code, authorizes the Commissioners of BOISE COUNTY, Idaho to declare a disaster emergency to authorize the furnishing of aid and assistance and to consent to the Chairman's verbal declaration to extend the declaration of

emergency until terminated by this Board:

NOW THEREFORE, be it resolved and declared by the WHEREAS, there is threat BOISE COUNTY Board of Commissioners, as follows:

- 1. A disaster emergency is hereby declared to exist within BOISE COUNTY, created by the flooding and earth movement creating an imminent threat to life and property; and
- 2. This declaration is effective as of April 29, 2023; and
- 3. These conditions require the activation of the response

and recovery aspects of all applicable local disaster emergency plans; and

- 4. Such disaster may require state emergency assistance to supplement local efforts to protect, rehabilitate, and replace public property and to provide a coordinated multi-agency effort to mitigate, avert, and lessen the threat and impact of the disaster; and
- 5. This declaration shall be in effect until terminated by this




## **Idaho Falls' Missing** Juvenile Results in an **Arrest in Boise County**

**BOISE COUNTY --** A missing person's alert went out on April 25th to law enforcement and was released to the news media for Maya Jones, a 16-year-old from Idaho Falls. She was believed to be endangered and traveling with 32-year-old suspect Tigan Howes.

Boise County Sheriff Scott Turner indicated that shortly after the flyer was released, the Idaho Falls Police contacted Boise County. They had cell phone data that possibly linked the pair to the Idaho City area.

Deputy Wes Crawford and Idaho City Police Chief Mark Otter set out to patrol some of the common areas in which the individuals might be found. The deputy located who he thought may have been the pair setting up a camp just north of Idaho City in the Granite Creek area. The officers detained both individuals until their suspicions were confirmed. Howes was arrested on a warrant out of Bonneville County and taken to the Ada County Jail. The juvenile was transported down to the Ada County Juvenile

Center, where she was reunited with her parents after they traveled from Idaho Falls to pick her up.

Howes was arraigned on April 26th in Boise County Magistrate Court on the outof-county warrant. Bonneville County is expected to transport Howes back to their county to face two felony sexual battery charges of a minor. There will likely be additional charges added to this case.

The Boise County Sheriff's Office released a statement: "Great police work by Boise County's Corporal Crawford who recognized the suspect vehicle in the Idaho City area. Crawford, with the help of Idaho City Police, apprehended the suspect and made sure the juvenile was reunited safely with parents."

### BOISE COUNTY COMMISSIONERS

**April 25, 2023** 

**Present:** Commissioners Steven Twilegar, Clay Tucker, and Lindy Lindstrom

#### Pledge of Allegiance

**PUBLIC INPUT:** Steve Moore, Boise County Central Committee, brought up the long-discussed topic of the Zoom capability of the Commissioners' room. Moore said there was a member of the BCRCC that had experience and offered to help with IT, "because there was a lot of concern, a lot of interest in the people being able to watch the meetings." Chairman Twilegar said he would talk with the county's IT person about the issue and reported that there was another failure to their server last week.

MINUTES: Chairman Twilegar motioned to approve the minutes from April 18 and special meeting from April 20, 2023. All were in favor and the motions carried.

**COMPENSATION PAY** STRUCTURE: Clerk Mary Prisco indicated, "We are a county that has never had a structure for our compensation," and some departments have been more highly compensated than others. She explained, "The whole purpose of a compensation evaluation project is to work towards establishing a system in which we can have some sort of equity across departments, so across the county operations." Prisco said professional services were budgeted for, up to \$25,000, related to the compensation project. She said her goal would be to have something prepared before the 2024 budget. Employee evaluations were discussed at length. Twilegar explained that this would create a ladder for employees to look at and decide if they want to switch jobs, get more education, or are happy where they are currently. Another individual recognized that some employees were carrying on more duties and said, "You don't want to be a socialist county. I mean, you can give little raises, but to give everybody across the board the same raise, that's not in my humble opinion, equitable."

Chairman Twilegar motioned to approve a proposal for workplace management solutions for up to 65 hours of work, and Clerk Prisco will head the proposal for the commissioners. The motion carried.

**RADIOS:** Twilegar motioned to accept a bid for government radio equipment for communication in the amount of \$4950. For a portable radio quote, Twilegar motioned approve the amount of \$2701. The motions carried.

**ROAD DEPARTMENT**: Curtis Dill spoke about software updates. Twilegar motioned to approve a purchase for software and equipment in the amount of \$10,996.

JUVENILE JUSTICE: Chairman Twilegar motioned to accept the subgrant agreement with Central District Health. All were in favor and the motion carried.

**SHERIFF:** The annual contract with the City of Horseshoe Bend was discussed. Chairman Twilegar motioned to approve this agreement to provide law enforcement and protection between the county and Horseshoe Bend.

**CLAIMS REPORT**: Commissioner Twilegar motioned to accept the claims report in the amount of \$149,416.71. The motion carried.

**ALCOHOL LICENSE**: Twilegar motioned to approve the liquor license for a store in Placerville.

**RADIO SERVICES**: Chairman Twilegar motioned to approve the radio services in the amount of \$7,652. The motion carried.

**K-9:** According to Sheriff Scott Turner, the K-9 "got into something" and became very sick, but she's good to go now. Chairman Twilegar motioned to accept this vet bill for \$1,161.47. All were in favor and the motion carried.

BANKS LOWMAN HIGH-WAY: Discussion began with a recap of the history of Banks Lowman Highway and continued with the current matter of returning the road to the state of Idaho. Twilegar said there was a section that could be turned over to the state. Commissioner Tucker commented that according to a past document, it did not appear that the state had the authority to hand the road over to Boise County --"We could go back and say this was never our road." Twilegar recounted that there were different governmental agencies with easements on that road. Tucker said, "I haven't seen all the paperwork, there's a lot of it, but the original agreement that I saw was, the county road was from Banks intersection to Crouch." Commissioner Lindstrom said he would be meeting with past Commissioner Alan Ward to see what documentation he had on the road. It was the consensus that they would pick up where the past board left off. Twilegar stated, "We've met our obligations, according to that contract [with the state of Idaho]," and would like to ask the state to take over one section.

**SOFTWARE:** Clerk Prisco discussed the county's current software and other software available.



and Jones on the mound. Huston came out on top offensively with 2 hits and 2 runs, and Graham had 2 hits with 1 RBI. Junior Layth Bromgard had 1 hit and 2 runs. Hampton came in with 1 hit and 1 run, Bauer had 1 hit, and senior Blayne Meyer had 1 run with 1 RBI.

## Cassin's Finch Has Returned

By Idaho World staff BOISE COUNTY -- One of the first migratory birds that shows up in Boise County every year is the Cassin's Finch. The male Cassin's Finch is similar in appearance to a house sparrow, but with a red peaked 'crown.' The male house finch also does not have the redwashed back of the male Cassin's finch. The female is, like most female songbird species, drabber in color. They are stocky, brown and white with a moderately streaked breast. Cassin's Finches breed mostly between 3,000 and 10,000 feet of elevation, from May 15th to June 15th. They live in mature forests, primarily of lodgepole pine and ponderosa pine, but are also found in several other pine species, as well as quaking aspen. Many Cassin's Finches may nest in the same tree. Trees sometimes have ten

They winter at lower elevations as far south as Baja California and mainland Mexico. Though Cassin's Finches are a common site in the spring and summer in Boise County, they are considered "Birds of Breeding Concern." They have experienced widespread declines of about 16%.

#### Windows in homes are one of the main causes of death of birds

Window strikes are among the top three human-related causes of bird deaths. Other human-caused mortalities are a result of cats and habitat destruction. According to the Audubon Society up to one billion birds die each year in the United States due to collisions with windows and research shows that 54-76 percent of window collisions are fatal. Many of the deaths do occur in large buildings but surprisingly dows in homes. The good news from ten feet away. Dots work

is that you can greatly reduce the danger your home's windows pose to birds with some simple remedies. Here are some considerations to keep in mind when making your windows bird safe: Most birds will avoid glass with vertical or horizontal stripes (or other markings) spaced 2" apart. Stripes should be at least 1/8" wide. A good rule of thumb is you should be even more are a result of win- able to see the pattern clearly great too, as long as there are less than 2 inches apart. Use your imagination when it comes to designs. It's the spacing that matters! Here are a few suggestions for your windows:

- Move feeders very close or far away from your windows. If feeders are 1.5 feet or closer birds won't be able to build up enough momentum to hurt themselves if they do fly against the glass.
- Close curtain and blinds, when possible, to break up the illusion of clear passage or reflected habitat.
- 'Paint' windows with chalk paint. This can be a demonstration of your art skills or be a fun family activity.
- Buy window decals. There are many designs to choose from.
- Install screens for windows that open.
- · Keep lights off at night. Migrating birds use light cues from the moon and stars to direct them. Outside, as well as inside lights, can confuse them, resulting in window strikes.
