High Speed Chase Results in Accident

IDAHO CITY -- The Boise County Sheriff's Office received a report of several shots fired at the Gold Mine Grill and Saloon in Idaho City on Saturday, June 24, shortly after 9:30pm. Deputies from the Boise County Sheriff and officers from the Idaho City Police Department responded. According to Sheriff Scott Turner, it began as a domestic incident, which progressed with an individual firing a gun, but the shots did not strike any one person.

According to Idaho City Police Chief Mark Otter, there was an altercation with law enforcement across the street at the post office, and the bikers from the Vagos Motorcycle Club of Boise were uncooperative. The suspect took off on his motorcycle and officers gave chase but were unable to catch the individual who exceeded speeds of 90 mph on Highway 21. He eluded of-

icers for more than eighteen miles, when at approximately mile marker 19.5, where construction had begun to incorporate a new wildlife overpass, the motorcyclist lost control and crashed, which resulted in traumatic injuries. Emergency Medical Services arrived quickly to the scene and a Life Flight helicopter was called in to transport the patient to St. Alphonsus hospital in Boise.

A domestic battery investigation is currently underway,

to be conducted by the Idaho City Police Department. The Idaho State Police are also conducting an investigation into the crash and for eluding officers. The individual is reported to be in critical care. Charges are still pending and the name of the injured motorcyclist has not yet been released. According to Boise County Sheriff Turner, there was no damage to the Idaho City Post Office, where the gunshots were fired.

HORSESHOE BEND -- A fire broke out on Scenic Byway 55 in Horseshoe Bend on Sunday, June 25 on the northbound side of the highway disrupting the weekend flow of traffic as travelers headed back to the Treasure Valley.

The fire was handled by the Horseshoe Bend Fire Department along with Boise Fire Department, Eagle Fire Department, Star Fire Department, and the Bureau of Land Management (BLM). A BLM Helitack crew was dispatched and

remained on duty throughout the night to make certain the doused fire remained out.

Make sure all loads are secure and not dragging. Check tires for proper pressure, check for gouges or missing pieces. A blowout is not only dangerous, but it could cause one of these highway side fires.

Present: Commissioners Steven Twilegar, Clay Tucker and Lindy Lindstrom

Pledge of Allegiance

CONSTITUENT INPUT:

A constituent from Wilderness Ranch subdivision commented on the last Planning and Zoning meeting regarding the Unified Land Ordinance proposed changes. She supported section 5, concerning the division of lots, and said, "We really need to think about water. I was surprised by when I looked at Idaho that you don't need water rights to drill a well for a residence. A lot of the surrounding states, Utah, Montana, do require that. I think we need to think about sewer, and we also need to think about traffic."

Chairman Twilegar thanked her.

MINUTES: Twilegar motioned to approve the minutes from June 6th and June 13th, which were approved.

ROAD AND BRIDGE: Superintendent Curtis Dill spoke regarding the Gardena Bridge and its ranking for replacement. Trevor Howard, an engineer, said federal funding was capped at \$3 million, "so the county's got to come up with \$11 million dollars." Chairman Twilegar said dryly, "A piece of cake." The engineer recommended a certain loan for up to 50% or the potential of a bond, which would first come before the taxpayers for a vote. The bond would last for 20 to 30 years.

Commissioner Lindstrom, from Horseshoe Bend, said he attended a meeting recently with a representative from LHTAC [Local Highway Technical Assistance Council] who "seemed very optimistic" that this project was going to progress and there wouldn't be much cost to the county. He added, "They're waitin' for the federal to bite on it, and then see what they do, and then the state can come in, too. That was the impression I got. *Like she was excited.* She says, we can't say nothing now because we've got to see what the feds will do."

The Centerville culvert was discussed and the updated price to replace it is \$50,000. The engineer stated that the road is privately owned, "the county does not have a deeded right-of-way, but we can do whatever we need to, to fix it." Commissioner Tucker asked about funding. Dill replied that the county did not qualify for funding for the culvert replacement.

Dill said that the county has spent \$50,000 on dust abatement to put down on all the roads. Chairman Twilegar said, "Keep it comin'."

JUVENILE JUSTICE: Amanda Leader said the department has a 2014 Chevy Equinox with 70,000 "hard miles on it." She said there have been problems with it and requested that they look at other vehicles.

She said that the last power outage fried a power cord and their internet was down. Leader would like to look into purchasing a surge protector.

Twilegar gave an update: "Just so everybody knows, Idaho Power is back in town. They're working on that last line, the Horseshoe Bend line. Hopefully we'll have that done by winter."

Twilegar asked if there was any other "fried" equipment and Assessor Chris Juszczak added, "Just that power switch. Our server room is completely fine."

SOLID WASTE: A motion was said to hire a part-time employee, which was approved.

CLERK: Mary Prisco spoke of a conference that she attended in Moscow for clerks and commissioners. Chairman Twilegar motioned to accept the invoice for the clerk's office in the amount of \$527.94. All were in favor and it was approved.

SHERIFF: The sheriff's office has been looking to get some off-road vehicles and discovered a place in Lewiston that offers deals to law enforcement. Sheriff Scott Turner said, "It's no cost to us, other than maintenance and putting it on our insurance." Chairman Twilegar motioned to approve the signing of the letter, once it was

looked over by the prosecutor, for free equipment from Yamaha. The motion was approved.

FUEL TANKS: The county has purchased fuel tanks that are saving the road department and law enforcement fifty cents per a gallon.

EXECUTIVE SESSION: Closed session for a personnel issue. [Time 9:29am to 10:20am] Coming back into session and after break.

BUDGET: Clerk Prisco presented slides with insight into the budget process with the commissioners. To make it "fun" she decided to enlist Assessor Juszczak to offer candy to the board for asking questions, answering questions, or making "valid comments."

"We're seeing a flattening of the state revenues," Clerk Prisco said. "We saw a big boom, in part related to Covid, the sales tax on liquor went up. It went way up!" She said through the CARES Act, the county has received a one-time distribution of a total of \$4.2 million, and have received \$1 million thus far.

She then spoke about PERCI retirement, and how the percentage is going down for the employees and employers for the 2024 budget. However, for public safety, it's going up. Prisco added, "I do not know what the reasoning was behind that, but it's it will have a serious impact on the counties."

Property tax revenue is the largest revenue source for the county. Prisco said, "Historically, our county government has had a 3% cap on property tax. The new law has effectively made it, increased it to - we still take the 3%, but calculation for new construction is done differently. And the two combined has an 8% cap on it."

She addressed elected officials' salaries and how they cannot earn overtime. "We cannot raise or lower an elected official's salary during the year. I'm sorry to say that our county has attempted to do that *twice*, that I know of, and have gotten in trouble for it. Once with the sheriff and once with the prosecutor."

"The number one item to remember," Clerk Prisco said, "is that these are public funds. It's really important to keep that at top of mind in everything that we do. Not just in setting the budget, but how we spend our budget."

She later said, "When you talk about budget, it's a different thing than actual. When you budget, it's what you anticipate is going to happen, but what actually happens is always different." Prisco then addressed cash reserves and the general fund. "We create a budget, but there's going to be changes to it. But there are laws out there that allow us to handle that when there are changes to it."

She then addressed what was required for local taxing districts. Prisco said she had a constituent ask about a taxing district, "Where there's an alleged misuse of funds, etcetera." She said they were well under the minimum amount, \$150,000, where you're required to do an annual audit. Prisco spoke about the summaries that need to be published in the newspaper.

Prisco stated: "Our county, specifically my office, we had someone who was embezzling

funds in 2013 - well, mostly in 2014. It was very ugly. It went to court. There was testimony that's very ugly, but the one good thing that came out of that is that is that we developed a cash handling policy." She said most counties don't have a policy, "I don't call it prevention. We cannot *prevent* fraud, but you can mitigate the chances of it happening."

FUTURE AGENDA ITEMS: Clerk Prisco will discuss the distribution of SRS [Secure Rural School] funds next week.

ASSESSOR: Chris Juszczak discussed the Board of Equalization and that Ada County had gone down in value about 30% in their housing market, "but that's a different market. So, when taxpayers ask you why we didn't go down and Ada County did? We don't analyze their information. We are a different real estate market, so that's why ours did not go down 30%."

Adjourned at 11:14am. The board will meet on Tuesday, June 27th. Further discussion will concern when to have the next meeting, considering the following Tuesday is July 4th.

First let me say that the Placerville Fire Protection District is run by 3 elected Commissioners who serve for a four year term and are re-elected every four years. The Secretary, Treasurer, and the Fire Chief serve at their pleasure. If anyone has a question or suggestion, it should be directed to the Commissioners, not to their appointed staff, especially when someone feels they should be trained to replace one or all of the appointed staff.

When you come to a staff member and say, train me, give me access to the checking account and all the fire department monies, then, when you do that, you need to retire and I will take over. This is a decision to be made by the Commissioners not the staff mem-

bers.

Mr. Andreason and Mr. Bourret have never joined the fire department, never attended training, and never offered to assist with equipment maintenance in any way. Both parties, and others, have waged an ongoing Facebook attack with misinformation, innuendos, and outright lies of irregularities within the fire department. Mr. Andreason did come to a Fire commissioners meeting and requested information at the next meeting. The information was available to him at the next meeting but he did not show up and then complained in public that the information was not supplied and hidden from him and the public.

These relentless and unfounded attacks on my wife Jessica Gasiorowski (Secretary) led her blood pressure to rise to dangerous levels, resulting in her immediate resignation at my insistence. In

support of my wife, I will be resigning as a firefighter effective July 5th. The reason for this date is that I did not want to jeopardize the Placerville 4th of July celebration. Without a Fire Department, there would be no fireworks.

At the June Fire Commissioners meeting, I suggested and they agree to place an ad in the *Idaho World* to hire a Fire Chief and the combined position of secretary/treasurer and pay them \$300 to \$500 a month depending on their experience. As of today, not a single response to that ad has been received by the Fire Department.

There is a lot more going on and the saga will continue but the current members are fed up and after July 5th, Mr. Andreason and Mr. Bourret can come forward with the many volunteers they allegedly have waiting in the wings to staff the department, after proper background checks and vetting. My guess is that none of them have had any training whatsoever or, if they have had some in the past, it is definitely NOT up to current standards.
