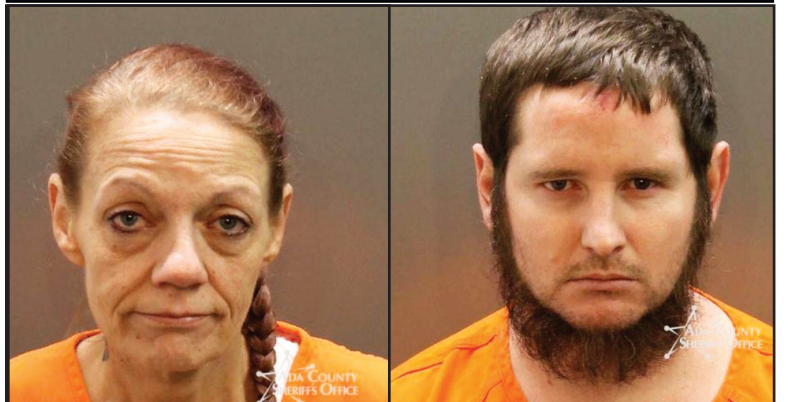

HSB Councilmember Not Officially Resigned

HORSESHOE BEND -- On May 12th, Curtis Corvinus, the former Horseshoe Bend Fire Department Chief, plead guilty to the felony offense of taking public money from the department's Burn Out Fund during his tenure. Corvinus stepped down as chief in March of 2022, but has retained his seat on the Horseshoe Bend City Council. The Idaho World reached out to the City of Horseshoe Bend and learned that Corvinus verbally resigned on May 12, 2023, but has yet to submit a formal letter of resignation.

Sentencing in this case has been scheduled for August 18, 2023.

GARDEN VALLEY -- The year was 2017 – and a group of energetic and motivated volunteers saw a need, had a vision, and made it happen. Payette Forward, Garden Valley’s premier thrift shop, opened its doors in 2018, and has never looked back.

Lead by founders Ruth Richter, the late Larry Gensing, and Pam Sprague, it can be said that Payette Forward has touched the lives of most who live in the Garden Valley area. Established as a non-profit Idaho corporation in 2018, the mission of Payette Forward is to provide goods and household items to people in need and/or in emergencies, and to provide monetary gifts to community service agencies such as schools, libraries, fire departments, and emergency and health organizations. This funding is only possible through the generous donations of goods from the community. From clothing to housewares, to furniture, toys, linens and tools of every kind, there is something for everyone at an affordable price.

Payette Forward is managed by a Board of Directors lead by President Pam Sprague, Treasurer Janet Watson, and Secretary Pauline Paxton. Sheila Schoettger and Phil Arnold

complete this dynamic team. The board is currently working on a strategic plan to ensure the future success of this great organization. Crucial to the success of Payette Forward are the efforts of the building owner, whose intent was to create a hospitable and lasting location “for the community, by the community.”

The lifeblood of Payette Forward is the volunteers, a fantastic group of over 20 hard workers with an average age of 65, who share their time and talent to sort, clean, repair, wash, organize, and price the volume of donations that arrive every day. Do we accept all donations? Unfortunately, no. Please stop by the shop and pick up the donations flyer. Two days a week, this crew puts their lives on hold to insure the shop is clean, organized, and fully stocked for the next shopping day (Wednesdays, Fridays & Saturdays from 11:00 a.m. – 3:00 p.m.). This is a labor of love, fueled by hard work and lots of laughter. Volunteers vote on each funding request received. We welcome new volunteers to the team!

In 2018, Payette Forward awarded its very first funding request to the Garden Valley Chamber of Commerce. Since then, over \$300,000 has been awarded to support community needs and better lives in Garden Valley. So far in 2023, almost \$50,000 has been award-

Life Jacket Loaner Stations

BOISE COUNTY -- A reminder that kids 14 years of age and under, on boats 19 feet or less, are required to wear a Coast Guard approved and properly fitting life jacket when boating. The Idaho State Parks and Recreation and Wear it Idaho have again partnered to supply life jacket loaner stations for anyone who needs one. Chevron in Horseshoe Bend provides a 'station' at their convenience center. Anyone needing one is welcome to borrow it and return it when finished.

As a reminder, here are the life jacket laws in Idaho (provided by the Idaho Parks and Recreation Department:

It is recommended that all passengers on boats wear life jackets – it can be the difference between life and death in an emergency (especially in cold water).

- PFD's (personal flotation devices) must be Coast Guard approved, properly sized, and in good condition (no broken buckles, torn straps, rips, tears, etc). They must also be within easy reach.

- Children 14 and under must wear an approved life jacket when they are aboard a boat 19 feet in length or less whenever the boat is underway or under power. This applies to manually propelled boats such as canoes and rafts in addition to powerboats, sailboats, personal watercraft (jet skis) and fishing

float tubes.

- Regardless of age, you must wear a personal flotation device (PFD) aboard a personal watercraft (jet ski) and when being pulled behind a vessel (I.e. - waterskiing, wakeboarding, tubing, etc.)

- The size of the boat determines the specific design types and quantities of PFDs required:

- Boats less than 16 feet long, as well as canoes and kayaks of any length, must have at least one (1) Type I, Type II, or Type III PFD for each person on board. A Type IV cushion or ring buoy will not meet this re-

quirement.

- Boats 16 feet and longer (except canoes and kayaks of any length) must also carry a Type IV PFD (ring or cushion buoy).

- A Type V is a special purpose PFD that may be used in place of a Type I, II, or III if listed on the label as approved for the type of boating the boater is doing, such as whitewater rafting.

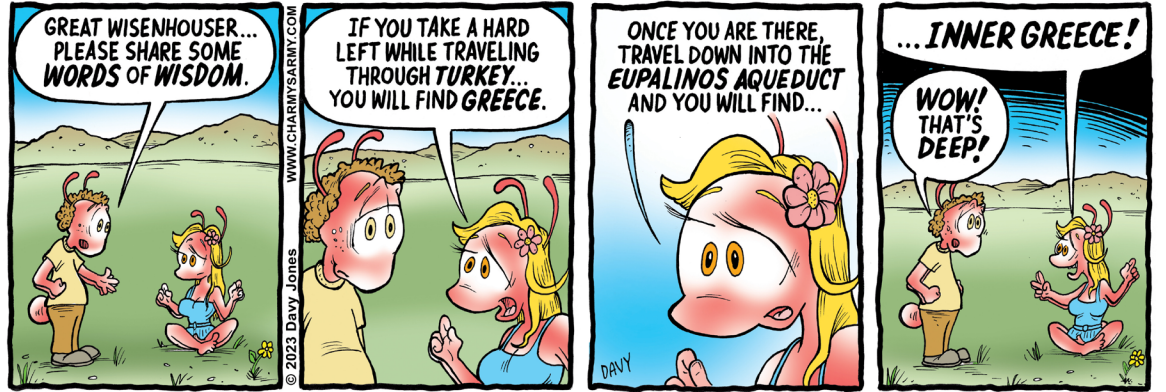

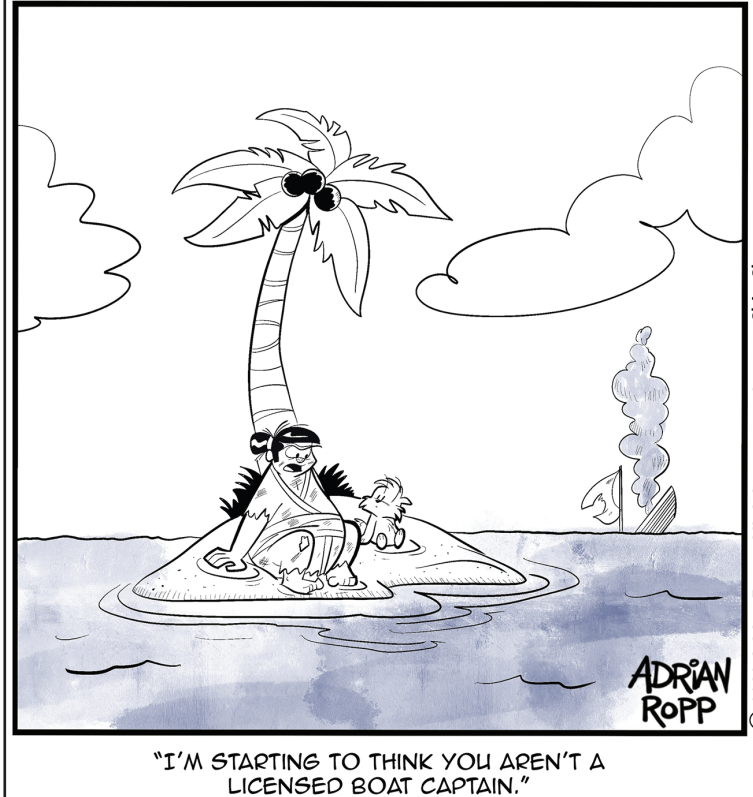
