Q&A followed the talks, focusing on grass-roots issues and how to make life better for everyday folks in Idaho -- great questions, helpful answers! We also had the opportunity to chat with our fellow citizens in person, making connections for helping one another in the future.

## BOISE COUNTY COMMISSIONERS

Transcribed by Eileen Capson

**August 15, 2023**

**Present:** Commissioners Steven Twilegar and Clay Tucker

**ABSENT:** Commissioner Lindy Lindstrom (via phone)

**Pledge of Allegiance**

**CONSTITUENT INPUT:** None

**MINUTES:** A motion was said to approve the minutes from August 8<sup>th</sup>. The motion carried. The minutes were also approved from the August 10<sup>th</sup> special meeting.

**RECORDING EQUIPMENT:** Chairman Twilegar said there was a request from Planning and Zoning Administrator Alex Gross for a "portable recording device for meetings." He continued, "We just spent, I don't know, \$33,000 dollars for several pieces of equipment," and asked for a discussion among the board. Twilegar would like to wait and table the discussion before spending \$5,000 for another system.

**TAX CANCELAN FOR THE UNITED STATES OF AMERICA:** Chairman Twilegar asked the assessor for some clarity regarding this tax cancellation. Assessor Chris Juszczak said, "It doesn't work out so well for us. *They refuse to pay.*" Twilegar asked, "Can we lien the United States of America?" Juszczak responded, "Not to my knowledge... Anytime a government entity acquires property," they can be exempt for a full year.

Twilegar motioned to approve the request for tax cancellation for the parcel of land in the amount of \$28.14 for the United States of America. The motion carried.

**SOLID WASTE:** There was a new hire presented for the board's approval. Twilegar motioned to approve the payroll addition. The motion carried.

**FORESTER:** Trinia Richardson discussed Title 3 funds for fire mitigation and matching funding. An application proposal was presented. The commitment would be \$10,000 each year for five years. There was not a lot of information provided, Richardson said, but the matching funds could bring in millions of dollars.

Twilegar made a motion to approve the agreement between the county of Boise and the United States Forest Service, Boise, and Payette National Forest, up to \$10,000 per a year for five years to apply for a grant. All were in favor

and the motion carried.

**SHERIFF:** Sheriff Scott Turner discussed the agreement for housing at the Ada County Jail. Chairman Twilegar commented that the county did not want to build a jail and motioned to approve the contract between Ada County and Boise County for \$89 per a day, through September 2024.

**AUDIO EQUIPMENT:** Twilegar motioned to approve the audio equipment in the amount of \$32,941. The motion carried.

**LIQUOR LICENSES:** Twilegar said there was "a whole pile" of liquor licenses to approve and listed each individually, following which they were approved.

**DEMAND WARRANTS:** A demand warrant for Miller Enterprises (trash collection) was motioned for \$18,695 for hauling and bin rental, Twilegar made a motion to approve. The motion carried. DL Wallis Trucking in the amount of \$25,473 for operation and trucking to the Horseshoe Bend Transfer Station, including additional expenses for the brush pile. All were in favor and the motion carried.

**CONFERENCE:** Twilegar motioned to pay for the corner and "crew" for lodging and meals at the ICA conference in Boise in the amount of \$1,785. All were in favor and the motion carried.

**AUTOPSY:** Twilegar motioned to approve the invoice for an autopsy "of a certain individual" in the amount of \$2,000. The motion carried.

**X-RAY:** Twilegar motioned to approve the invoice for a

full-body x-ray "of a certain individual" for \$200. The motion carried.

**SHERIFF:** Twilegar inquired about the outfitters that assisted the county in the recovery of a body. "Guided horse search and rescue, twelve horses for three days," in the amount of \$5,724. Twilegar said it "sounded pretty reasonable," for the amount of people and animals. The motion carried.

**ITD:** Chairman Twilegar said he had received word from the Idaho Transportation Department regarding a petition from the Atlanta Highway District. This topic will be put on the agenda for a future meeting.

**GOOD NEIGHBOR AGREEMENT:** Commissioner Twilegar made a motion to approve, with the understanding that the closure of Forest Service roads would only apply to new roads that are constructed for the treatment of forest, and not apply to existing roads to be closed. All were in favor and the motion passed.

**EAST BOISE COUNTY AMBULANCE DISTRICT:** A motion was said by Commissioner Tucker to approve the agreement to provide ambulance services for the Jack Pine Roundup rodeo. Commissioners Tucker and Lindstrom voted in favor, and Twilegar abstained.

**SQUAW CREEK SOIL PRESERVATION:** A representative spoke regarding letters of support for additional funding, trail use, committees, and the services they provide. Adjourned at 11:25am.

## FATAL CRASH ON HIGHWAY 21



**BOISE COUNTY** -- Idaho State Police is investigating a vehicle collision which occurred on Tuesday, August 22, 2023, at 3:56 P.M., on SH21 at mile marker 94 in Boise County.

A 2010 Chevrolet Silverado towing a camp trailer and an ATV trailer was traveling northbound on SH21. The driver drove off the right shoulder and struck a tree. The vehicle, trailer, and ATV caught fire.

The vehicle was occupied by a 77-year-old male driver and a 77-year-old female passenger, both from Nampa. The male was rescued from the vehicle and succumbed to his injuries on scene. The female

was transported by air ambulance to a local hospital. Both occupants were wearing their seatbelts.

Traffic on S21 was blocked in both directions for approximately 4 hours, allowing emergency responders to assist those involved and clear the scene.

This incident remains under investigation by the Idaho State Police.
