Successful Fundraiser to Protect K9 Officer

BOISE COUNTY -- On October 24, 2023 at the Boise County Commissioners' Meeting, a check was presented to the Boise County Sheriff's office for a protective vest for K-9 Roki. The fundraiser was spearheaded by Personal Touch Insurance and Benefits LLC, CarrieAnne Kowalczyk, who organized the event at Idaho City Days and also received many donations from the community. The amount of \$5,584.00 dollars was raised the very supportive community. Sheriff Scott Turner, Deputy Lee, and Roki thank the Boise County Community for the great support. Roki will be fitted for the vest shortly and when it arrives will wear it proudly.

Sheriff Turner spoke on behalf of the department, saying that they were so grateful and appreciative of CarrieAnne for organizing the fundraiser. "It's so nice to have citizens take part and show their appreciation for us and the things we do to keep them safe. So much effort and hard work went into

it." Special thanks to Personal Touch Insurance & Benefits -- CarrieAnne Kowalczyk for donating a Traeger grill, meat thermometer, and shirts.

Kowalczyk related how the idea first came to her several months ago, during a public meeting, when she inquired of Sheriff Turner whether there were funds to buy Roki a bulletproof vest. He had responded that there were not, and that K9 Officer Roki had actually been a gift from Ada County.

She did her own research, saying: "I did not realize all that goes into having a K9 officer. Good ol' Google. You search a few times for K9 working dogs and all of the sudden your internet is full of information and videos about these dogs and how hard they work. I had no idea what they do for the community. I learned a lot!"

Kowalczyk continued, "I was originally going to purchase the vest for Roki and just be done with it. I was given a discount to purchase a Traeger

grill and Meater thermometer. This was when I had the idea to do a fundraiser and raffle off items hoping we could get more money to cover the items Roki needs. With Deputy Lee's help we were able to get some smaller items for the raffle table as well. Tickets were \$5.00 for 6 tickets, or \$25 for the Traeger grill and Meater thermometer. Some people just handed

us cash and did not want any tickets. It was great to see the community's support. *Vests and other protective equipment for K9s are not standard issue, all donations will protect Roki and other K9 Officers of Boise County.*

"We were able to raise \$5,584.00. If you add up the cost of these items, it will total \$3,815.00. That is not a lot of money left over if we get a second K9."

"Still, I am super grateful for the community and the support that we received for this cause."

"Mayor Everhart was one of the largest contributors to the fundraiser and he was presented with a custom-made T-shirt to show our gratitude. On the sleeve, there is a K9-Roki logo, and on the back, it says "Sup-

porting the paws that enforce the laws." It was a great experience to work with Deputy Lee and Roki. If you have not had the chance to meet them, I would highly encourage it," said CarrieAnne Kowalczyk, Owner of Personal Touch Insurance & Benefits. (ad on page 5)

Sheriff Turner also indicated that the department was looking to bring aboard another K9, because Roki has been such an asset in catching larger amounts of drug trafficking throughout Boise County.

Present: Commissioners Steven Twilegar, Clay Tucker, and Lindy Lindstrom

Pledge of Allegiance

CONSTITUENT INPUT: None

MINUTES: None

ELECTION DAY: The commissioners' meeting conflicts with the Tuesday election, November 7th. The board will plan on skipping that week, unless something pressing comes up and they will hold a meeting on Thursday, Nov. 9th.

MOTION: Chairman Twilegar motioned to approve the new position of Wildfire Mitigation Coordinator in the Emergency Management Department. All were in favor and the motion carried.

Trinia Richardson, Emergency Manager, spoke concerning a training opportunity and the commissioners were in favor. Twilegar made a motion for Richardson to attend training out-of-state and the motion carried.

AUCTION ITEMS: The road department is still working on a list of auction items for a November surplus auction.

SHERIFF OFFICE: Body armor was discussed. Sheriff Scott Turner said that the armor expires between every five and seven years. Twilegar wanted to know what the department does with the old armor, and Turner replied that they keep it for backups.

Commissioner Twilegar motioned to approve this purchase of protection equipment for the Sheriff's department in the amount of \$9,161. All were in favor and the motion carried.

DEMAND WARRANTS: Sheriff Turner explained this was to be purchased with grant money. Twilegar motioned to approve the payment of an "e-ticket" SWET Interface for \$7,402. All were in favor and the motion carried.

SNOW GROOMER: Twilegar stated it was for the 2014 John Deere 644K loader, which is covered under a grant, the clerk reminded the board. Chairman Twilegar motioned to approve the payment of \$149,600, which was approved.

EXECUTIVE SESSION: Twilegar motioned to go into executive session for a personnel issue, per the request of Clerk Mary Prisco. [Time 9:22am to 9:30am] Coming back into session, Twilegar motioned to increase the Solid Waste wage for the Supervi-

sor's position 4%, "because we missed that." This would be retroactive and the motion carried.

EXECUTIVE SESSION: Chairman Twilegar motioned to go back into closed executive session under pending litigation. [Time 9:30am to 9:41am] There was no action required.

EXECUTIVE SESSION: Twilegar motioned to go into executive session for risk management. [Time 9:42am to 9:51am] No action was required.

EXECUTIVE SESSION: Twilegar again motioned to go back into a closed session for a personnel issue. [Time 9:52am to 10:01am]

EXECUTIVE SESSION: Twilegar motioned to go into executive session under Idaho code, for hiring an employee. [Time 10:01am to 10:21am] No action required.

Adjourned until October 24th.

CONSTITUENT INPUT:

Boise County Sheriff Scott Turner opened by saying, "I am very humbled and proud to see a citizen put so much work and effort into supporting our department and our program. And to the citizens of the county, it just goes to show how much support that we have in the county by how much money that was raised, it is a direct reflection of my employees, their interaction with the public, to have that support."

Kowalczyk stated that she had heard Sheriff Turner talk about their wonderful narcotics dog at a meeting in Garden Valley, and she inquired then if the dog had a vest, to which Turner responded that he did not. She offered to pay for the

vest outright, but then thought to do a raffle and was able to raise \$5,584 in two days during Idaho City Days. Already \$3,000 has been spent on the vest and she added, "I don't think people know how much money a K9 dog requires."

Deputy Lee honored CarrieAnne for doing an excellent job with raffle and read, "In recognition and appreciation of your tireless work, and steadfast support, for our K9 program, on behalf of the Boise County Sheriff's office, I would like to present you with this award." There was a round of applause and tears sprang to Kowalczyk's eyes. He continued, "We would not have had the money - just knowing the support, like the Sheriff said, to me as a K9 handler, I mean, I love working with the dogs, I work with the public every day, but when people truly step up and show their support, not just all the people financially, but we wouldn't know that or see that if CarrieAnne hadn't

stepped up and taken charge. I think it's just amazing. I want to thank you very much."

Idaho City Mayor Kenny Everhart was also recognized by Kowalczyk as a large financial contributor. She said out of gratitude, "I custom made

a shirt just for you," with Roki on the side. Mayor Everhart added, "We appreciate everything our Sheriff's department does for us, and whatever we can do for the dogs as well. It's amazing what those animals can do for us."

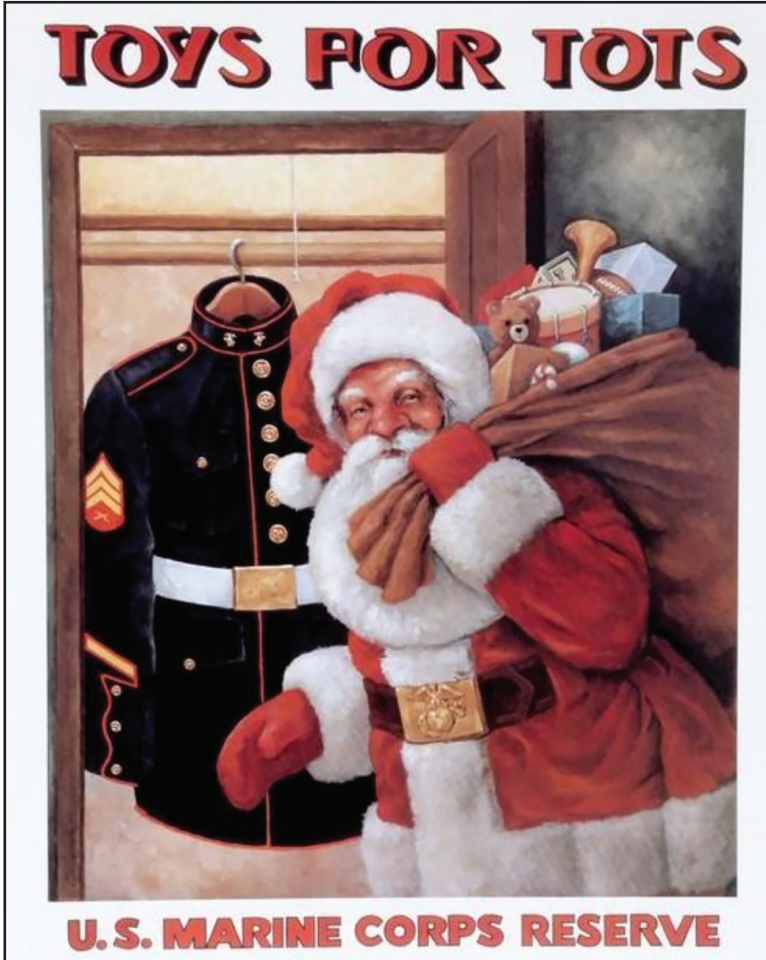
Toys for Tots Drive 2023

Idaho City Historical Foundation's Kenn Smith Wildfire Museum

IDAHO CITY CORRECTION: The Idaho City Historical Foundation article in the October 18th issue had an error regarding the name mentioned; "Kenn Smith's Smoke Jumpers Museum," was the name reported, but the precise name is the "Kenn Smith Wildfire Museum," which is located at the Strauss House in Idaho City. It is a work-in-progress, but hosted a smokejumper's reunion on August 13, 2022. Wayne Bushnell explained, "The purpose of this museum is to honor the thousands of wildland firefighters that have fought fire in the Boise Basin over the last 118 years. Although Smokejumpers are firefighters that are delivered to the fires via parachutes,

they make up only a small portion of the workforce that have fought fires in the Boise Basin. It is true that from 1949 to 1968 there was a group of smokejumpers (approximately 20 per year) based in Idaho City along with the other ground-based firefighters. There is a small portion of the Wildfire Museum that tells their story and is there in honor of Kenn Smith, one of those smokejumpers. Since Kenn donated the Strauss House to the ICHF, I thought having his name on the Museum was appropriate. The purpose of the Museum is to tell the story of all wildland firefighters, no matter how they got to the fire... I chose the name purposely to honor Kenn's gift and to honor all of those that do this valuable work."

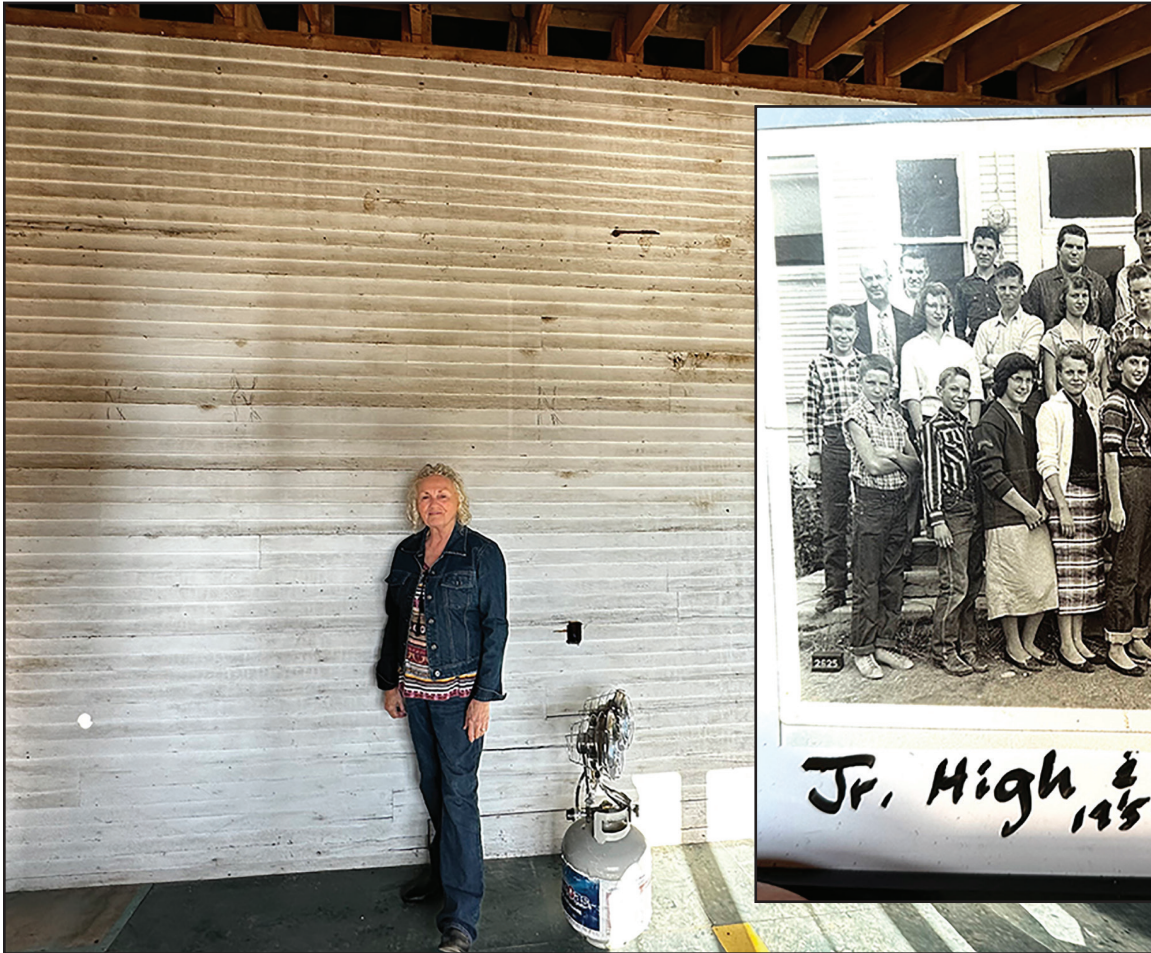
