# **Toys for Tots Drive 2023**





## Tis the Season for Boise National Forest Christmas Tree Permits

**BOISE COUNTY** – The Boise National Forest has begun selling Christmas tree permits online, at Forest Service offices, and at several businesses throughout southwest Idaho. These permits allow for Christmas tree cutting on Boise National Forest lands between Nov. 18 - Dec. 25.

Permits are \$10 per tree, with a purchase limit of three trees. Online purchases are available at www.recreation.gov/tree-permits for an additional \$2.50 service fee, and purchasers must have the ability to print the permits. Permits are nonrefundable, for personal use only, and purchasers must be at least 18 years old.

All permit holders must follow the requirements and the map that accompany their permit. These permits only allow cutting on Boise National Forest lands and it's the responsibility of the user to know where they are. Smartphone maps capable of being used without cell coverage are available through the Avenza app (www. avenza.com).

Be aware that forest roads at higher elevations can be covered with snow and ice. Forest roads are not plowed, and visitors should

use extreme caution when driving. Call ahead and check websites for road conditions before heading out. It is a good safety practice to let a friend or family member know precisely where you are going and when you plan to return. Cell coverage is limited or nonexistent over most of the Boise National Forest.

The Forest Service, in coordination with the "Every Kid Outdoors" (EKO) program, provide participating fourth-graders a free Christmas tree permit. The EKO program is a nationwide call to action to build the next generation of outdoor enthusiasts. Fourth-grade students must first go to https:// everykidoutdoors.gov/index.htm and complete the application process for a voucher. EKO vouchers can be used online and at Forest Service offices, but not at business vendors






