Suspect Shot and Served Guilty Verdict of Battery on Law Enforcement Officer

BOISE COUNTY -- Boise County Prosecutor Alex Sosa detailed the events to a jury that lead up to an encounter with law enforcement on August 18th, 2022. A parole officer traveled into Boise County, off of Brownlee Road in Sweet, Idaho, to check on Dustyn Vaughn, 37, due to an email that was received from the defendant that was concerning and was said to be "out of character." Officers observed that Vaughn had "bulging pockets" that he was feeling and he declared, "I'm in a state of emergency! I am declaring marshal law!" Vaughn then turned to leave the parole officer, who watched him walk away, picking up other items and dropping some of them. At this point, law enforcement requested additional support, and the suspected "slipped away." Parole Officer Katie Gibson had testified to hearing metal clapping and the wind, and although she had been to this residence several times, there were outlying areas that posed unknown threats. She was alone when she heard a noise behind her and turned to see Vaughn approaching. Gibson looked into his eyes, as he was charging toward her, and the man refused to follow instructions, shouting, "No, get out of here." She retreated, no weapons drawn, but he kept coming closer. According to

Sosa, Gibson retreated a second time, gun still not drawn, and retreated a third and final time. The prosecutor detailed, "She pulls a firearm, pleas with him, to please don't make me do this. Dustyn is so close that she can hear his breath. Terrifying. Katie shoots, there is nothing else that would have stopped Mr. Vaughn than that second shot that actually hit him." Sosa said pepper spray was not a viable option, or the use of a baton.

An audio recording of the incident detailed that he was chasing Gibson, she asked him stay on the ground, and tried to engage him in positive conversation. However, the probation officer was in tears, and was scared for her life.

The jury unanimously found Dustyn Vaughn guilty of felony battery against a law enforcement officer, and a misdemeanor charge of resisting peace officers. Vaughn was returned to

the custody of the Ada County Jail and he will not be able to post bond in this case. Along with the sentencing on December 15th, the judge ordered a substance abuse and mental health evaluation.

Need is Up and Amount of Food is Down at the Idaho City Foodbank

EAST BOISE COUNTY -- The Boise Basin Senior Center houses the Idaho City Foodbank, but no money from senior activities is used for the foodbank—that money is used to provide nutritious meals for our seniors as well as other activities.

The Idaho City Foodbank is the 2nd and 4th Wednesday of each month. Currently, we are serving between 45-50 families on these two days. The need is continuously going up and the amount of food that we get is down. We distribute food that we get from the Idaho Foodbank as well as food purchased from donations.

In the last year, and especially the last few months, the food that we are getting from the Idaho Foodbank has decreased dramatically. We have received no meat, eggs, protein items (tuna, peanut butter) for many months. As an example, the food that we will get from

the Idaho Foodbank for our November 8 Foodbank is milk, yogurt, corn, green beans, and fresh fruit. This is what the Idaho Foodbank has provided for a family for two weeks. We have used donations from the community to purchase tuna, chili, hot dogs, cheese, bologna, and other items.

When our donations run out we will only be able to distribute the food we get from the Idaho Foodbank. Our community has rallied around us before and any help we get is greatly appreciated.

We are asking that if you want to make donations—money or food please keep it local. You can visit us at the senior center any Tuesday or Thursday between 11-1. We accept donations on Tuesdays and Thursdays between 11-1. Please call 208-392-4918 for more information. Thank you for helping us feed the families of Idaho City and East Boise County.

October 31, 2023

Present: Commissioners Steven Twilegar, Clay Tucker, and Lindy Lindstrom

Pledge of Allegiance

CONSTITUENT INPUT: None

MINUTES: Chairman Twilegar motioned to approve the minutes from October 24th, Commissioner Lindstrom seconded, and the motion was approved.

TAX CANCELATIONS: Twilegar motioned to accept individual homeowners' exemptions for tax exemptions. Treasurer Gina Turner said there were thirteen. Each was addressed and their motions carried with some input from the treasurer for tax cancellations. Additionally, there were a few tax cancellations for those homes in the county that had experienced a fire.

COMPUTER PURCHASE: Twilegar motioned to purchase computer equipment from Dell, up to \$34,077. All were in agreement and the motion passed.

MOTION: Twilegar motioned to approve the Boise County Idaho Community Wildfire Protection Plan 2023. The motion carried.

MOTION: Surplus and an auction were discussed by Road and Bridge Dept. and Solid Waste Department. Twilegar motioned to adopt a Boise County Resolution to declare surplus from the Road and Bridge Department to sell at a live auction. The motion

carried.

MOTION: Twilegar also motioned on behalf of Boise County Ambulance District a resolution to declare a surplus and sell by live auction select items. This was also approved.

CLAIMS: Chairman Twilegar motioned to approve the claims approval report in the amount of \$82,320. There were no questions, and he moved on to the next claims approval report, motioning to approve it in the amount of \$132,981. The motions carried.

PLANNING & ZONING REFUNDS: Commissioner Twilegar motioned to refund several building permit fees, which were approved.

CORONER: Twilegar motioned to pay \$2,000 for the Ada County Coroner to do an autopsy. The motion carried. He then motioned to pay for a toxicology report in the amount of \$1,011, which was also approved. Twilegar motioned to approve an expense for a filing cabinet and chair for the coroner's office in the amount of \$413. He motioned for a "bed-side x-ray" in the amount of \$150, which was approved.

COMMUNITY JUSTICE: Amanda Leader said they are receiving more community service hours imposed through the court. She said that she is open to ideas and struggling to find work to fulfill the service requirements. Litter pickup was discussed. Twilegar suggested, "I'd like to see a formal program set up to where people are

out picking up garbage. 'I broke the law in Boise County,' a nice vest. I'm not kidding; I think it would be great!" He spoke more about a "formal clean-up all year round, especially when the weather permits, *obviously*. Get them going. Let's clean this county up! You break the law; you clean the county." There was also talk of working at the waste transfer stations.

EMERGENCY MANAGER: Trinia Richardson discussed the Firewise projects in Robie Creek and Clear Creek, and their funding. She addressed an upcoming all-county training May 2024, where they will simulate a mass casualty scenario with a school shooting in Garden Valley.

ROAD & BRIDGE: Curtis Dill said they are swapping out equipment in anticipation for the winter weather. They've hauled in sand, and have done some culvert repair. Dill said the department is still short-staffed.

Twilegar asked regarding the state of the Centerville Road culvert. Dill said they had reinforced it with blocks, because the culvert has not come in yet and the permits are still pending.

SOLID WASTE: Paul Rekow discussed getting some guardrail up. He discussed the disposal of tires, erosion control, and servicing the equipment.

EAST BOISE COUNTY AMBULANCE: Mari Adams said that Unit 14 ambulance

did break down on one of their calls. There are three volunteer mechanics that have donated their time and expertise to repair and keep the vehicles running for the ambulance district.

ASSESSOR: Chris Juszczak was pleased to announce that his department was fully staffed.

TREASURER: Gina Turner spoke regarding homeowner tax relief.

SHERIFF'S OFFICE: Scott Turner said, "It's busy. It hasn't slowed down for us."

PLANNING & ZONING: Alex Gross said, "That new \$10,000 scanner that we bought, when it works, it's awesome! We've been having a lot of issues with it."

He talked about a CuMo mine exploration project, and explained that it would require "additional use permits for our county. It will be probably the biggest hearing the county has ever had... This will require county approval as well. They have not approached us or talked to us, to take any position, one way or the other." He recapped that it was the third application for exploration in Boise County. Gross would like the Forest Service to be

aware that the mining company would need to also have approvals through the county. Chairman Twilegar said he would reach out.

PROSECUTOR: Alex Sosa said that his office is very busy, and they are still looking to fill a position. He added that they are rebuilding relations with the Sheriff's Office, "We will keep doing good things and keep the community safe."

CLERK: Mary Prisco said she had a draft of the financial statements from the 9/30/2022 audit. Her office is preparing for the election on Tuesday, Nov. 7.

EXECUTIVE SESSION: Closed session for "risk management." [Time 10:25 am to 10:39 am] Twilegar said the action was to "talk to said individual about what they discussed."

EXECUTIVE SESSION: Twilegar motioned to go into executive session per pending litigation. [10:39 am to 10:56 am] Coming back into session, Twilegar said there was no action required.

Adjourned at 11:00 am on November 14, 2023. [A week was skipped due to the election on Tuesday, November 7th.]

New Wildlife Overpass

EAST BOISE COUNTY -- Deer and elk are on the move as they head for winter range in Southwest Idaho, including the Boise Foothills.



Deer, elk and other big game animals will be crossing roads and highways in the process, which is risky to animals and motorists. Drivers are asked to keep a sharp eye out and avoid collisions, particularly near major migration routes such as Highway 21 between the Mores Creek Lucky Peak Bridge and Robie Creek, where thousands of deer and elk cross every year.

The good news for motorists and wildlife alike is the recently completed construction of a wildlife overpass structure along this stretch of Highway 21. Ultimately, the goal is for this new overpass to work in conjunction with an existing wildlife underpass structure to further reduce the number of wildlife-vehicle collisions and maintain habitat connectivity for big game. However, motorists should still expect to see deer and elk directly crossing

Highway 21 while the animals grow accustomed to using the new overpass.

"Using this overpass will be a learned behavior for deer, elk and other wildlife, and this is a completely new structure for them," said Ryan Walrath, regional wildlife manager. "While these animals are learning to use it, and as we approach peak migration for deer and elk, motorists should expect to see deer, elk and other wildlife along this migration

route, and some will likely still be on the highway. Being extra careful and watchful is a motorist's best defense."

Motorists should report any injury collision to the public safety dispatcher by calling 911, which will send officers to the scene. If possible, move your vehicle to a safe place and alert oncoming traffic with your emergency flashers until law enforcement authorities arrive.

The Struggle of Ambulance Services in East Boise County An Urgent Call for Volunteers

Introduction

Ambulance services play a critical role in healthcare, particularly in East Boise County where access to medical facilities is so far away; however, the struggle to maintain adequate ambulance availability in our community due to a shortage of volunteers has become a pressing issue. The shortage poses significant challenges in ensuring timely and effective emergency medical responses. This article sheds light on the predicament faced by East Boise County ambulance services and makes an urgent call for volunteers to aid in sustaining these vital services.

Challenges Faced by Our Ambulance Services

Rural areas of Boise County encounter challenges that intensify the scarcity of ambulance service. The geographical vastness means longer distances between towns and medical centers, resulting in extended response times. In such areas as ours, every minute during emergencies is crucial, making swift access to medical care a matter of life and death; however, the shortage of trained volunteers willing to serve as Emergency Medical Technicians (EMTs) or drivers in our remote locations further impedes timely responses. For example, it currently takes about an hour for the ambulance to reach a victim in the Lowman area.

The financial strain on our ambulance services is another significant issue. Our agency

operates on limited budgets, relying heavily on volunteers to fill our staffing gaps. With limited funding and a lack of full-time staff, our ambulance services struggle to provide consistent and reliable emergency response coverage. Many of the same volunteers are on the schedule weekly. Often, there are three employees working overtime to ensure coverage for any shift that has gaps, while we desperately scramble for another ambulance if we have back-to-back calls. Many of our volunteers that are active have fulltime jobs and yet, thankfully, they are putting in many hours to make sure that East Boise County is covered as much as possible, but we still need help to keep the ambulance responding.

Impact of Volunteer Shortage

The scarcity of volunteers in Boise County as well as other rural ambulance services has a direct impact on the communities we all serve. Our overburdened and understaffed ambulance units face increased pressure, leading to burnout among our existing volunteers and compromised service. In dire situations, some of our areas might even face temporary unavailability of ambulance services due to an ambulance already being out on a call, leaving residents vulnerable during emergencies.

Call to Action: Join and Support Rural Ambulance Services

The call to action is clear – East Boise County Ambulance service need more volunteers. If you have the passion to serve

and help others during critical times, consider volunteering as an EMT or driver. Your dedication can be instrumental in ensuring that individuals in our service areas receive timely medical assistance.

Community involvement is crucial; encouraging local businesses, organizations, and individuals supporting East Boise County Ambulance services can make a substantial difference. Financial aid, donations, and fundraising efforts can help bridge the funding gap and ensure that our services remain operational.

Moreover, government support is vital. Increased funding, incentives for volunteers, and policy measures aimed at bolstering rural healthcare infrastructure can significantly alleviate the strain on these essential services. There is a bill that is in the legislation to make EMS essential workers. As of right now we are not. Ambulance service is expected and should be considered essential work. Labelling EMS as non-essential overlooks the fundamental role it plays in public safety. It's paramount to ensure that the necessary resources, support, and acknowledgment are provided to sustain and improve these services. The well-being of our community and the lives of countless individuals depend on it.

Conclusion

The shortage of volunteers in our ambulance services presents a significant challenge, impacting the overall well-being and safety of communities. Addressing this issue requires a collective effort - from in-

dividuals willing to volunteer their time and expertise to local communities and government authorities providing support and resources.

By coming together and supporting our ambulance services, we can ensure that these vital lifelines continue to serve those in need, ultimately saving lives

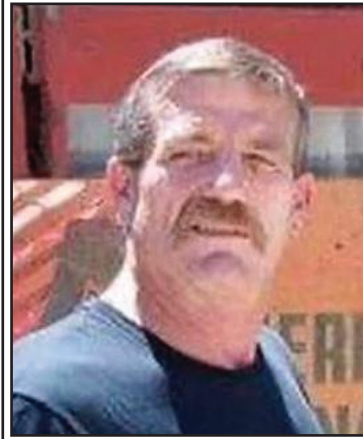
