### Requirements to Ride on Idaho Groomed Trails

**BOISE COUNTY** -- Idaho and Boise County have many miles of groomed trails during the winter season. They are used by many different people and Idaho regulates which motorized vehicles can use a groomed trail. To use any motorized vehicle in the snow, you are required to purchase and display a valid IDPR snowmobile certificate of number sticker. These are valid from November 1 – October 31. If you are riding Boise County, designate the area as 8A (Idaho City area) or 8B (Garden Valley area). This designation is important as it funnels funds to that area for grooming. Some counties have local ordinances and fees in addition to the IDPR certificate. Resident fees are \$45.50 and non-resident fees are \$59.50. Now the question is, who is required to purchase one? All recreational vehicles operating over snow are required to purchase and display the snowmobile certificate.

If you own an ATV or SXS and want to ride on a groomed trail, there are requirements to follow. First it must be tracked and be under 2000 lbs. unladen weight (The unladen weight of any vehicle is the weight of

the vehicle when it's not carrying any passengers, goods, or other items). The second requirement is to have the IDPR snowmobile certificate. There are no provisions in Idaho Code for any wheeled vehicles on groomed trails.

I know we all complain about the cost of state fees these days, but most of the fees for a snowmobile certificate go back to the user. Trail grooming gets most of the fee to maintain our trails and parking lots. The fee is split up four different ways. This is how they are split up:

- \$1.50 vendor fee
- \$1.00 snowmobile related Search and Rescue efforts
- 85% goes to the county operated snowmobile grooming

programs.

Up to 15% goes to administration fees and the printing costs of registration stickers.

Groomed trails and parking lots take a lot of time and effort to maintain each year. When riding these trails, remember that. Talking to the local groomer, if someone ruts up the trail it can take three or more passes with the groomer to fix the rut. There are no provisions for any wheeled vehicle on groomed trails.

We are starting to get some snow; groomers will be getting busy. Observe the few requirements and enjoy the many groomed trails Idaho has to offer.

### Know What to do in Case of a Chimney Fire

**BOISE COUNTY** -- On January 9<sup>th</sup>, I had a healthy reminder of why I always keep a chimney fire extinguisher near my fire place. I first noticed an odd smell in the house from the fireplace, and went to place my ear near the chimney and could hear a sizzling sound. I quickly ventured outside in the snow, in slippers, and took a look up at the chimney. Burning debris glowed in the darkness of the early morning and floated out of the chimney. The chimney top blazed orange and red. I had a chimney fire and I knew I had to act quickly. Considering that the local volunteer fire department did not have easy access to my house, due to snow and ice on the road, *I was on my own*. I ran back into the house, closed all the oxygen inlet vents off in the fireplace, and grabbed the chimney fire extinguisher, Chimfex, that had been sitting idly next to the fireplace for the past couple of years. The directions were basic, but I had never used one of these and I was definitely in an elevated state of anxiety. The directions said to remove the cap, then scratch the black plug with the cap and to point it away from you. I tried, but nothing happened. I instead just threw the entire device in the fire. Surprisingly, a few seconds later, it began spouting what looked similar to baking soda throughout the fireplace. The fire was not entirely extinguished, but it was enough to get it under control.

Now, I sit extremely thankful that my house did not burn down, but also with my primary heating source out indefinitely. I write this to remind Boise County residents that use wood to heat their homes to please always have on hand

something like Chimfex, which “extinguishes chimney fire in seconds.” They are not like regular extinguishers in which you squeeze a nozzle, but instead use chemicals to reduce the oxygen in the flue. There are several products on the market, but what I used was Chimfex, which basically resembles a road flare. These fire suppressant sticks emit smoke and particles designed to displace the oxygen within the flue, suffocating the fire and lowering the temperature in the flue. There are other brands that you simply throw in the fireplace to activate. Most importantly, always consider having something like Chimfex near your fireplace that's easily accessible when an emergency arises. If you do have a chimney fire and need to use the chimney fire extinguisher, be sure to *close* air inlet controls and *open* the damper prior to use.

I was lucky that this happened in the early morning when I was awake. This could have been deadly had it been in the night and is a great reminder to always check the batteries in your smoke detectors!

The National Fire Protection Association (NFPA) recommends that you install smoke detectors in the following locations:

- At least one smoke detector on every floor of your home, including the basement.
- A smoke detector should be installed inside each bedroom and outside each sleeping area.
- For levels without bedrooms, install detectors in the living or family room, or near the stairway to the upper level.

In the past year, we have seen several house fires in Boise County. Please folks, stay safe.

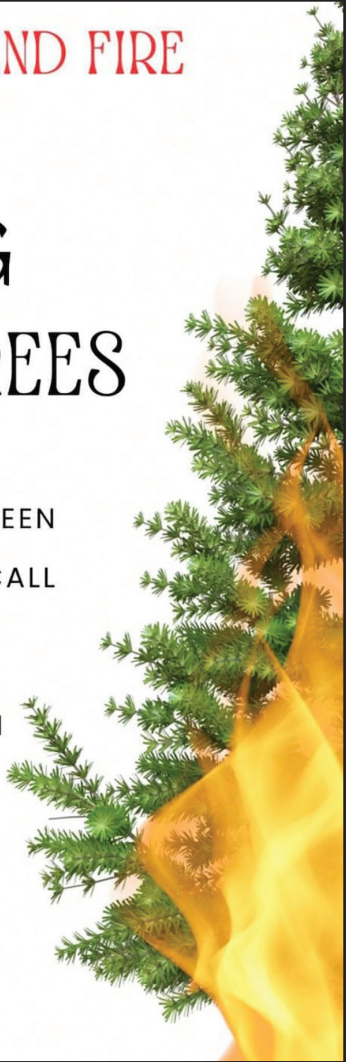

## Opinion ~ Idaho Republican Presidential Caucus 2024

**BOISE COUNTY** -- The Legislature failed to reconvene before the deadline set by the Republican National Committee, which means the Idaho GOP will hold a caucus on March 2, 2024, to determine our nominee for President of the United States.

The tradition of the caucus is as old as our country itself. When President George Washington declined to seek a third term in 1796, members of the two factions within his government each met in caucuses to choose their nominees for president.

Today, a caucus is a perfect opportunity to come together as a community to discuss the issues that are most important to us all. We will be hosting hundreds of caucuses throughout the state, bringing national politics to your front door. We will be meeting in schools, fire stations, granges, churches, and other community centers throughout Idaho. Families with children are more than welcome. This will be a wonderful chance to introduce young people to American civics.

Each candidate who participates in the caucus will have five minutes to share his or her vision for our country. This might be done in person, via a local representative, or by video. Once that's done, you will cast your vote and either head home or stay behind to witness the tally.

Rather than waiting until May, when the nomination will be all

but over, Idaho will be the fifth state in the nation to allocate its delegates. That means that whoever wins Idaho will have the early momentum that is so important for winning the nomination. Your voice is important in deciding which candidate takes Idaho's 32 delegates to the Republican National Convention.

Votes from every caucus location will be tallied by the state party, with paper ballots securely delivered for verification. If one candidate receives an outright majority of votes, then he or she receives all 32 of Idaho's delegates. If nobody has more than 50%, then the delegates will be allocated proportionally.

Make sure that you are a registered voter and affiliated with the Republican Party by December 31, 2023, because the next day we will download the voter lists and create poll books for each caucus location. Each caucus location will also have hand stamps and watermarked ballots in sealed boxes. You can rest assured that the vote you cast will be faithfully tallied. Don't forget your ID!

**Notice of caucus date, time, location and other details will be sent by post card from IDGOP. The postcard will include voter name, address, precinct number, caucus date, caucus location, caucus time and a recommendation to bring the card with you to the caucus precinct number is readily available.**

The Idaho Republican Party

remains committed to representing the vast majority of Idaho's citizens while upholding the principles of our Constitutional Republic, promoting a fair and transparent caucus, and providing the citizens of Idaho with the opportunity to make informed decisions about their future.

Idaho has six Presidential candidates that have signed up for the Caucus. Former President Donald J. Trump, Governor Ron DeSantis, Nikki Haley, former U.S. Ambassador to the United Nations and former Governor of South Carolina, Vivek Ramaswamy, Chris Christie, former Governor of New Jersey, and Ryan Binkley. Their announcements can be found on the IDGOP.org website under the news dropdown.

Boise County will caucus in 5 locations, depending on your precinct. Both precinct 30, Garden Valley, and precinct 60, Lowman, will caucus at Garden Valley High School. Precinct 40, Horseshoe Bend, will caucus at the Horse-

shoe Bend Mutual Improvement Club aka Ladies Club. Precinct 50, Idaho City, will caucus at the Ray Robison Community Center. Precinct 70, Mores Creek, will caucus at the Mountain Meadow Christian Center. Precinct 80, Centerville/Placerville, will caucus at the Centerville Fire Station.

## Future City Preparations in Garden Valley

**GARDEN VALLEY** -- On Friday morning, January 5<sup>th</sup>, three Garden Valley teams were anxiously engaged in preparing for this year's Future City Challenge. Idaho is one of forty regions included in the national competition. Garden Valley has been a top competitor under the tutelage of Meghann Donley for the past seven years. Our local teams have done extremely well, including several regional wins

and top five placements. One year, a GV homeschool team took 5<sup>th</sup> in the National Competition in Washington, DC.

Each year poses a new theme and challenge for the youth competitors. This year is "Electrify the Future," and preparations began back in August. The three teams usually meet three times a week outside of school time, including during Christmas break, to develop their concept, write the

1500-word essay, write a script for their skit presentation, and build their working models. With guidance from teachers, parents, and grandparents, the 6<sup>th</sup>, 7<sup>th</sup>, and 8<sup>th</sup> graders work together to accomplish their tasks. Students are only allowed to use \$100 on materials, and they are creative in their use of recycled materials, incorporating a variety of items such as pop tops, plastic bottles, nut shells, mini lights, costumes, wood, etc.

The regional judging will again be held at Boise State University in February. Students invite the community to come to the GV school to view their performance on January 17<sup>th</sup> at 5:30PM, when local professionals will also pose pertinent questions to the competitors.

The winner of the Idaho region will advance to the nationals to compete against 39 other regions, including some international teams.

The students must be able to address many facets of their working model, including areas of concern, such as transportation, pollution, use of water,

The Horseshoe Bend Mustangs went 1 for 3 at the truck-stop.com tournament in New Plymouth during winter break, with a 44-56 loss on Thursday, December 28 against the 1A Snake River Conference Carey Panthers. They had a 75-30 win against the junior varsity Ontario High School Tigers from the 4A Greater Ontario Conference, and a 45-55 loss to the 1A West Idaho Conference Vision Charter Eagles.

Back at home on Monday, January 8, the team took a loss against 1A DII Long Pin Conference rivals the Council Lumberjacks.

The Mustangs are on the road Thursday, 1/11, to take on another Long Pin Conference team, the Tri-Valley Titans. Tip-off is at 7:30 p.m.

Horseshoe Bend will play host to the Garden Valley Wolverines on Monday, 1/15 with a starting time set for 7:00 p.m. Stat leaders for the team

include senior Layth Bromgard (19.5 average points per game, 15.6 average rebounds per game and 2.9 average assists per game). Senior Kaelun Jones is averaging 3.2 steals per game. Points leaders are Bromgard with 214, senior Porter Larson with 120, and Jones with 106. The team is 7-5 overall and 2-2 in 1A DII Long Pin Conference play for the season.

### Varsity Girls Basketball:

The Mustang Ladies took a loss at home on Monday, 1/8 against the Council Lumberjacks and will travel with the boys on Thursday, 1/11 to Council. 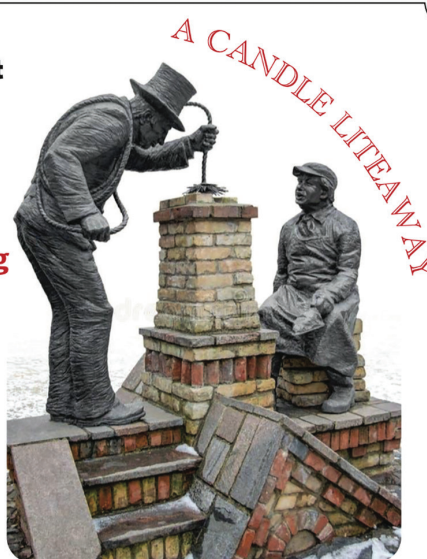

## Be Prepared and Stay Safe If Winter Weather Causes Power Outages



**BOISE COUNTY** -- Idaho Power keeps the lights on 99.9% of the time. While most customers are without power fewer than two hours a year, weather-related outages can last longer. As winter weather hits our region this week, Idaho Power offers the following important reminders to help customers stay safe and prepared for outages.

Visit My Account to ensure your contact information is up-to-date and sign up to receive outage alerts for your home or business.

Download the Idaho Power mobile app to sign up for outage-related push notifications, view the outage map, and track your power status.

Prepare for medical needs, such as refrigerated medicine or electrically powered medical equipment. This could

mean finding a place you can go during an outage or buying a backup generator.

Maintain both home and car emergency kits with water and other essentials. For a full list of items to include in your kit, visit [idahopower.com/outagetips](http://idahopower.com/outagetips).

Keep a block of ice in your freezer in case the power goes out, and if it does, keep your refrigerator and freezer doors closed to keep items cold longer.

**If your power goes out:**

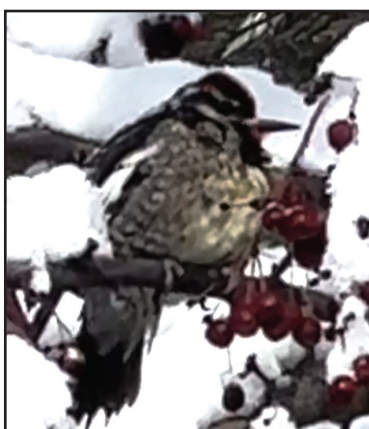
Check the app, visit Idaho Power's online Outage Map, or call 1-800-488-6151 to view or report outages.

To protect your appliances, turn off any that were in use when the power went out — especially electric ranges and space heaters — to prevent the possibility of a fire if you're away when power is restored.

Only use generators in well-

ventilated areas and follow all manufacturer recommendations. Never connect a portable generator to house wiring or plug it into an outlet.

Falling trees, high winds, and car accidents occasionally knock power lines to the ground. If you come across a downed line, always assume it is energized and dangerous. Stay clear (at least 100 feet), keep others away, and immediately call 911 or Idaho Power at 208-388-2323 in the Treasure Valley or 1-800-488-6151.
