Fire Department's Training in Ice Rescue



EAST BOISE COUNTY

— “We of course chose the coldest day of the year to do it, but that added some realism, as emergencies don’t wait for good weather,” explained Wilderness Ranch Fire Protection District Chief Colton McCarthy. The team of volunteers took advantage of the icy water in Mores Creek to train with some newer equipment on Saturday morning, January 13th. The temperature was around 11 degrees, and those that had contact with the creek water quickly found their gear crusted with ice.

Trying out the personal protective equipment was key during these ice rescue scenarios, and team members learned potential limitations, but also how to trust that their equipment would serve them well in an emergency. Chief McCarthy said, “This training helps prepare us for several potential incidents, such as someone

simply falling through the ice, or a vehicle sliding off into the icy creek.”

The training took part near the Daggett Creek Bridge, where the crew cut a hole in the ice with a chainsaw, and then WRFPD members took turns acting as the victim in the water and were instructed by rescuers how to attempt to self-extricate. Carrie Wiss, a WRFPD member, explained, “Rescuers then practiced using a cold-water rescue sling to secure the victim and assist them out of the water. Drills also included practicing different means of deploying WRFPD’s rapid deployment rescue craft to access and extricate victims from the water. This training resulted in several lessons learned about the functionality of WRFPD’s rescue equipment and personal protective equipment (PPE) in wet, cold conditions, and the satisfaction of a hot lunch.”

Chief McCarthy summed up the training, “For being icy cold and miserable outside, our firefighters had a good time and better yet, feel confident in their new skills should we need to use them for real.”

Present: Commissioners Steven Twilegar, Clay Tucker, and Lindy Lindstrom

Pledge of Allegiance

MINUTES: Commissioner Twilegar motioned to accept the minutes from January 2nd. The motion carried.

CONSTITUENT INPUT: None

DEPARTMENTAL ISSUES

COMMUNITY JUSTICE: Review of hiring an administrative assistant. Chairman Twilegar made a motion to advertise this open position. All were in favor and the motion carried.

SANITATION LICENSING: Chairman Twilegar motioned to approve several sanitation licenses, including collection and transportation of solid waste. Each of these motions passed.

SHERIFF'S DEPT. K9: A Labrador was received by the county last week. Twilegar said, "He's already marking and doing cool stuff."

CLAIMS APPROVAL REPORT: Chairman Twilegar motioned to approve the Claims Approval Report in the amount of \$77,679.51. The motion carried.

SNOW GROOMING: Twilegar explained that the 8A

program is again applying for a grant and asked for a letter of support to bring the building up to code. They would also like to apply for a new snow plow. A motion for letters of support was approved.

TAX CANCELATIONS: Chairman Twilegar motioned to approve several tax cancellations and each motion carried.

EXECUTIVE SESSION: Sheriff Scott Turner asked to have this closed meeting to address a personnel issue and for risk management. [Time 9:24am to 9:54am] Twilegar said there was no action required.

EXECUTIVE SESSION: Twilegar entered back into executive session to address pending litigation. [Time 9:55am to 10:09am]

PLANNING & ZONING: A lot line adjustment within a subdivision was discussed in the Robie Creek area. Administrator Alex Gross said there were no public comments, "I don't see any significant impacts." Twilegar motioned to approve the partial plat line adjustment. The motion was approved.

Mr. Gross then brought another issue before the board regarding a lot that was jointly owned by adjoining property owners. There was no objection, and Twilegar motioned to

approve the minor subdivision lot adjustment. All were in favor and the motion carried.

EXECUTIVE SESSION: Chairman Twilegar motioned to go back into executive session to discuss a personnel issue. [Time 10:21 to 10:45am] No action was required.

EXECUTIVE SESSION: East Boise County Ambulance District asked for an executive session to discuss pending litigation. [Time 11:01am to 11:40am] Twilegar said there was no action required, after coming back into session.

EXECUTIVE SESSION: Chairman Twilegar motioned to go back into executive session to discuss a personnel issue. [11:41am to 11:48am] There was no action required and Twilegar said that the board would break until 2pm.

SOLID WASTE SUPERINTENDENT/ NOXIOUS WEEDS JOB APPLICANTS: Twilegar made a motion to enter into executive session to hire an employee. [Time 2pm to 4:58pm] Commissioner Twilegar motioned to make an offer to one of the individuals that the board interviewed for the solid waste superintendent application.

Adjourned at 4:58pm.

Public Notice from Boise County Sheriff's Office Regarding Smart Watch "Fall Detection" 911 calls.

BOISE COUNTY --

Dear Skiers and Snowboarders, The Boise County Sheriff's Office is issuing an important advisory due to a significant increase in 911 calls triggered by the fall detection feature on smart watches. This feature, designed for user safety, automatically contacts 911 if a fall is detected, providing a one-minute window for cancellation before the call is placed. However, it has been observed that many users, especially in winter attire, are unable to notice or deactivate the alarm in time, resulting in inadvertent emergency calls.

Our dispatch center has been receiving an alarming number of such calls, primarily from the Bogus Basin ski area. While our dispatchers are adept at discerning false alerts by assessing the situation over the call, each incident

requires the same level of response and resource allocation as a genuine emergency. This influx of calls poses a significant challenge, potentially diverting resources from actual emergencies.

We recognize that this technology is relatively new, and some users may not be aware that their devices are capable of sending these alerts. We urge the public to familiarize themselves with their device's settings and help spread awareness about this issue. Your cooperation is vital in ensuring that our emergency services are not overwhelmed by false alarms and can respond effectively to real emergencies.

Thank you for your understanding and assistance in this matter.

Agriculture All-Star Legislative Award



Representative Matt Bundy (District 8) received the Ag All-Star Award from Food Producers of Idaho this past week. This award shows support for the agriculture interests in Idaho and is based upon a legislator's voting record on selected pieces of agriculture legislation from the 2023 Idaho Legislative Session. Rep Bundy also received the award in 2022. Food Producers of Idaho, representing over 45 different agriculture commodity and farm organizations in Idaho, annually honors legislators based on their legislative voting record. According to Executive Director Rick Waitley, the first year a legislator is honored, the award is an Ag License plate that reads, "AL STR". Each year after the initial award, a smaller plate with that year engraved on it is presented to each honoree. Representative Bundy represents Elmore, Boise, Valley and Custer Counties. All four counties have a strong agriculture presence in local, state, and national economies. Milk, dairy, cattle, potatoes, and sugar beets are all major Idaho exports and commodities of this area that benefit Idaho and our local communities.

Letter to the Editor

I have been reading with interest the articles on Chimney Fires and would like to add a few suggestions.

The first thing you might consider is having your local chimney sweep come and do his thing. If you suspect a chimney fire, first call 911 then take a towel, soak it in water, and throw it on the source of the fire and close the door, or if a fire place, stand back. You can buy products and should, but if you do not have them this will work. If you put the fire out, still have the fire department look things over. We have had an incident where they put the fire out but it had gotten into the attic and the house burned down.

Next, your basic smoke detector is only good for 10 years, so if you have older ones you will need to replace them. Most fire departments have the tools to test your smoke detectors to make sure they work. The more smoke detectors the better, and if you need some contact your Fire Department and they can get them for you free of charge.

One last thing: burn well-seasoned wood, best to let it age over the summer before winter.

Avalanche Across Highway 21

BOISE COUNTY -- The mountains received an excessive amount of snow on January 9th and 10th, and by January 11th at approximately 9pm, an avalanche occurred which closed part of Highway 21 between Idaho City and Lowman. The Idaho Transportation Department recounted the events of that evening, "Four vehicles, including one from the Custer County Sheriff's Office, were traveling through the avalanche-prone section at the time. A truck was pushed by the snow, but there were no injuries and no vehicles were buried. All occupants were able to get into the deputy's vehicle and drive out of the area safely. A separate car, traveling in the opposite direction, tried to drive over the debris field and got stuck. ITD used a loader to get their vehicle out

and back on the road in the opposite direction." Bill Nicholson, a leader of the avalanche team explained the, "avalanche cycle was driven by a perfect storm of weather. We had very high precipitation intensity, increasing temperature and extremely high winds from the southeast. These are very unusual conditions for this zone." ITD's avalanche team and the Lowman maintenance crew have gone through avalanche rescue training. "The number one thing to do if stuck in an avalanche zone is to never get out of your car," Nicholson said. "It will protect you from being crushed by any additional snow or debris and makes it easier for rescuers to find you." According to Nicholson, there are more avalanche paths now than when he started over

a decade ago. A wildfire burn scar has changed the landscape. He said, "When I first got here there were 62 avalanche paths, but on one side of the canyon there was a forest fire. All the trees are now gone. There are not any anchors in there anymore. This area that was not even considered a problem has now become one of our biggest problems. We have around 70 avalanche paths now." The avalanche team relies on specialized weather reports from the National Weather Service, as well as mini weather stations that have been placed in risky areas. There are only three highways in the United States that fall under the 'High' category in the Avalanche Hazard Index: SH-21 in Lowman, State Highway 210 in Utah, and U.S. Highway 550 in Colorado.

The area along State Highway 21, approximately milepost 48, north of Idaho City was back open after 8 hours of cleanup on Monday, January 15th. Sophia Miraglio, an ITD representative, assured the public, "As for any upcoming storms, we have a phenomenal team of avalanche experts in place that live in the area and continuously monitor that section of SH-21."

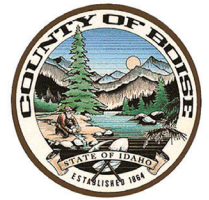

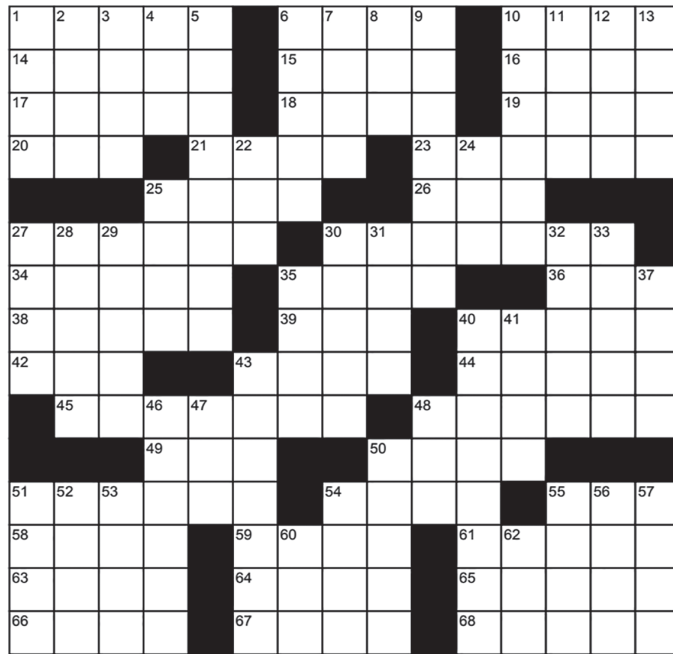

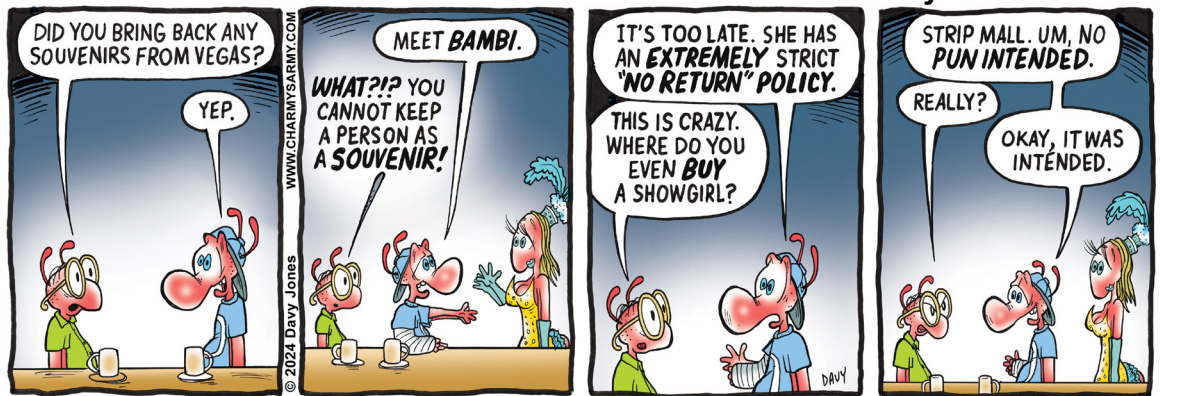

Special City Council Meeting for Idaho City January 15, 2024

Present: Mayor Kenny Everhart, Council Members Tom Secor Jr., Mari Adams, and Ashely Elliott.

Council Member Ryan Heffington was absent.

Pledge of Allegiance

MINUTES: A motion was said to approve the minutes from Dec. 27th. The motion carried.

BILLS: Bills from December 28th through January 10th were discussed and reviewed. Council Member Secor motioned to pay these bills in the amount of \$25,908. Counselor Elliott seconded and the motion passed.

ELECTED: There were two council members, Mayor Everhart explained, "elected by default." Mari Adams and Tom Secor were sworn in.

ENGINEERING REPORT: Documents had been submitted and an individual said that the city applied for a grant for a water improvement project a year ago, and the city has been a recipient of that funding. "The water intake is absolutely huge to us," Council member Secor said. A motion was said to allow the mayor to sign the resolution for funding authorization agreement for the water improvement project.

A contract with an engineering company was presented to the board and included a preliminary design, construction of the intake, and planned fol-

low-up with water quality testing. The gentleman said contractors will need to, "supply American steel."

Council member Secor motion to authorize the mayor to sign the agreement for the water improvement project with the engineering company. Mayor Everhart thanked all involved.

He discussed the upstream stream bank that had sloughed off and the trouble getting water out of their collection wells. He would like to get on this problem in the spring, so the city doesn't have problems all summer.

LIQUOR LICENSES: A motion was said to refund all current liquor license holders \$100. The motion carried. Clerk Nancy Ptak explained that Idaho City, "was not the only city to say 'Huh?'"

TINY HOMES: There was some discussion regarding tiny homes and cabins rentals, like at the Gold Mine. Ptak explained that the city would need to revisit this issue.

LOADER AND ROAD CREW: Mayor Everhart said the loader has been working without issue and they have a full road crew. He also thanked all for keeping the roads clear of snow.

TREASURER REPORT: There are fewer shut offs. There are a few leaks that are known, but there is nothing that can be done until spring.

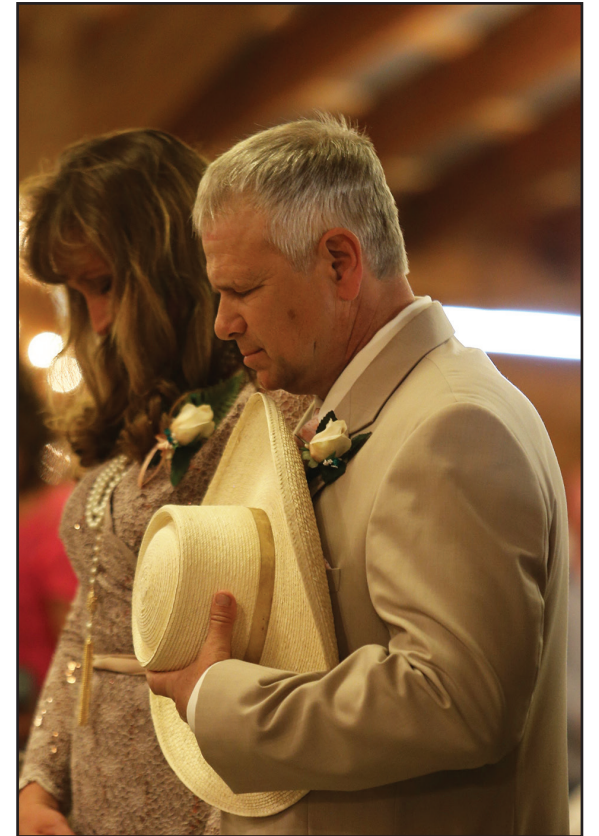
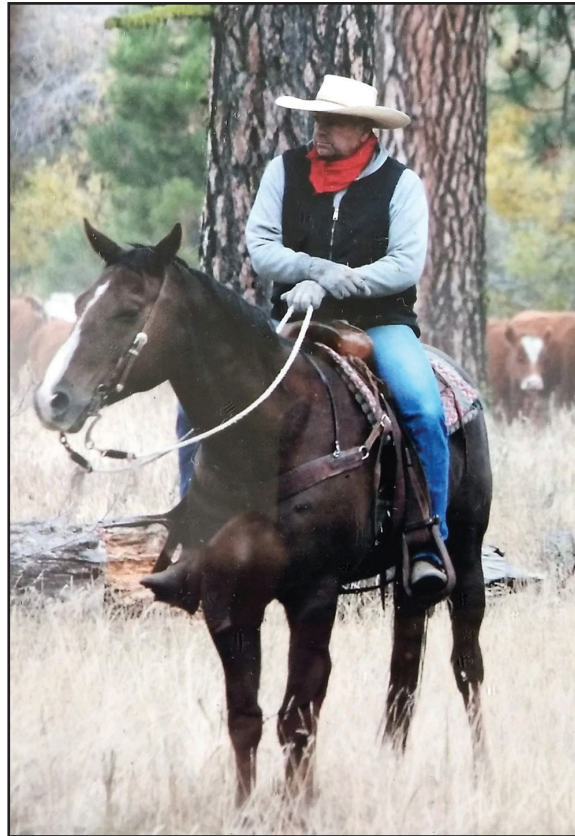

ther-in-law Doug Robeson, 23 beautiful grandchildren, and several nieces and nephews—all of which he loved dearly.

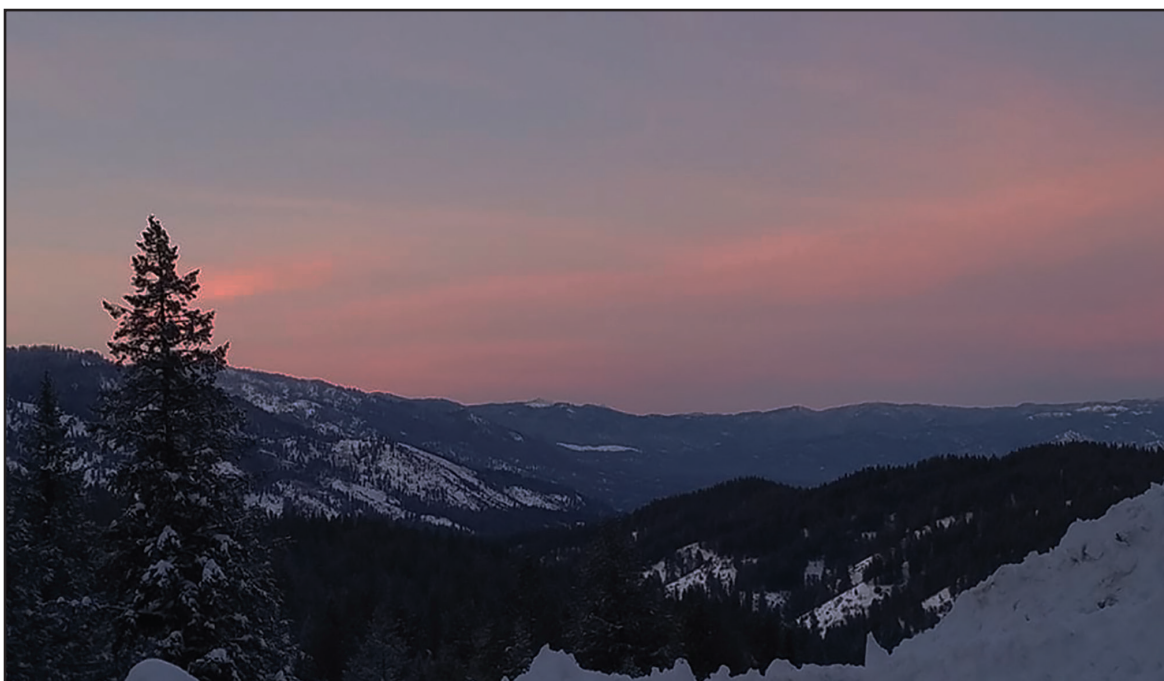
