Future Cities Winners!

Garden Valley students were all-in and in a great position to take the 20th Idaho Future City Regional Competition once again. Dedicating over 100 extracurricular hours, quantifying nearly 40 days to complete a five-month course, these middle schoolers were beyond prepared to rightfully claim their prize.

The 20th regional competition was held over the weekend at Boise State University, and after only competing for seven years, the Garden Valley teams have become the teams to beat in Idaho. Garden Valley teams have placed in the top five in the Idaho Region three times! “We have a strong program with bright, dedicated, and determined students,” said Senior Projects Manager and Mentor for the Garden Valley Team, Meghann Donley. There was a total of 35 teams from 20 Idaho schools competing at the BSU competition.

The 2023-2024 theme was **Electrify Your Future**, a challenge to design a healthy and safe en-

Emergency SOS Features on Cell Phones

-- Most newer phones come with an Emergency SOS feature on them. It allows you to make emergency calls when you are not in cell reception areas or don't have Wi-Fi. It will allow you to make 911 calls or texts. If you have an Apple device and have your Medical ID set up, it will also automatically notify your emergency contacts via text. Each phone manufacturer has a different way of using this feature, so you will have to research your particular phone. You must have a clear line of sight to the sky for it to work. It will not work every-

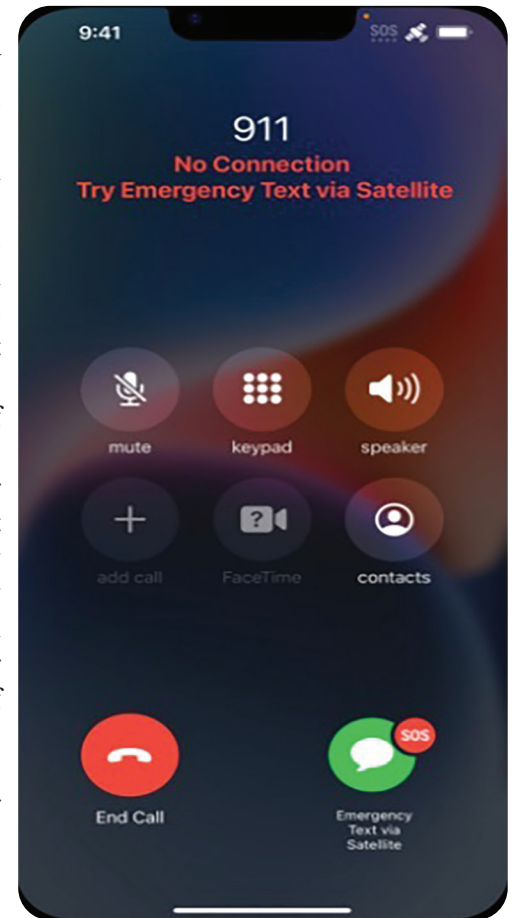
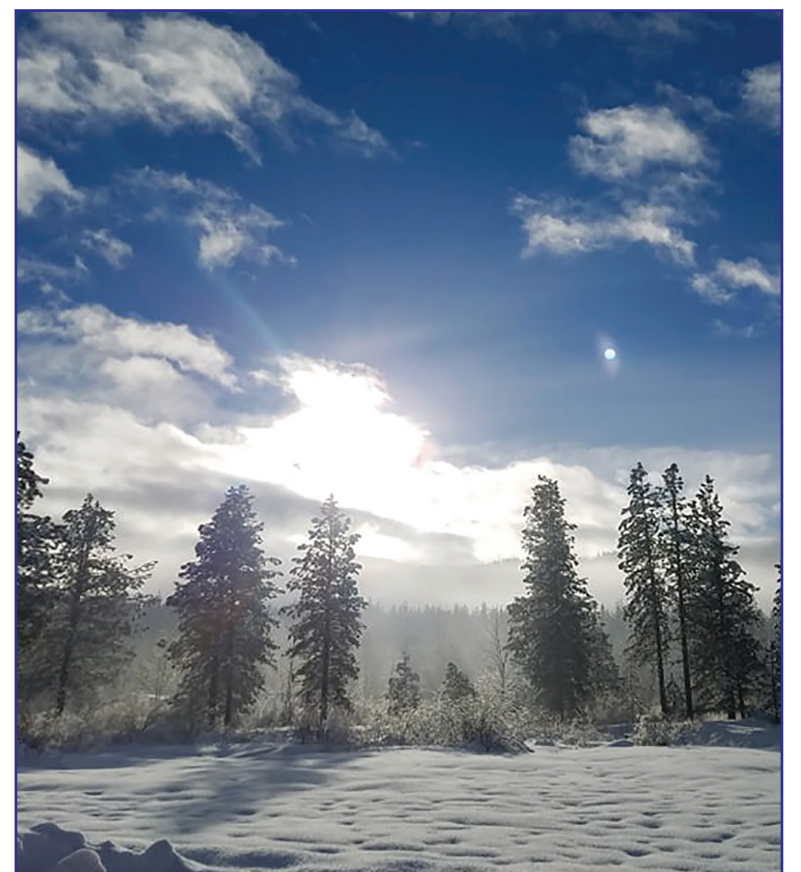

where. This feature became available to some phones as far back as November 2022.

This is a feature a lot of people don't know exists or know how to use. With most of Boise County out of cell range when you leave town, it is worth learning how to use it with your current phone. There will be some phones that don't have this feature. You will have

to either Google your phone or talk to your cell provider to see if it is an option for you. Coming up Hwy 21, I personally have the SOS feature active for a lot of the trip. I have seen it available also while exploring the mountains in Idaho. Knowing about this feature and how to use it will enable you to get help in case of an emergency and might even save a life.

environment for citizens in their city with 100% of the energy from generated electricity. Participants were to write a 1,500-word essay, build a scale model from recycled materials, include a project plan, present their plan to the judges, and then stand for questions.

Donley explained their winning strategy, "Something that is unique to Garden Valley is how I set up the teams. They obviously have a say in who's on their team, but after they've worked together for a couple weeks, they pick the Project Manager, Essay Lead, Presentation Lead, Model Lead, and Special Award Lead, so they all have a role and are empowered. However, they are told this is just the task they are responsible for making happen, but they all have to help with all the aspects so they are well-rounded, which they all are by competition day." Donley added that, actually, the three teams from Garden Valley scored well enough to

sweep the first three places of competition; however, only one team from GV was allowed to advance.

Fundraising efforts are in the works. The Family Fun Night Fundraiser will be held on Wednesday, February 7 from 6-7:30 at River Canyon Retreat and costs \$5/person or \$30/family. The Garden Valley Market will also have a prompt at their register to round up to the nearest dollar to support the Middle School Future Team competitors. There are bake sales being organized and all donations are tax deductible through Garden Valley School's 501c3 designa-

EAST BOISE COUNTY AMBULANCE: There was discussion about whether to dissolve EBCAD and how to follow steps like Valley County, to "reform it." A legal description was discussed and contacting the State Tax Commission to determine a levy.

Acting Chairman Lindstrom asked about the Lowman Fire Extrication, and Paul Rekow explained that the training had been done. A motion was said to table the Lowman Fire and

EXECUTIVE SESSION: Lindstrom motioned to go into executive session to address pending litigation. [Time 9:32am to 9:39am] A motion was made to approve a letter for an EMT service agreement.

ROAD & BRIDGE: Supervisor Curtis Dill extended a "big thank you to Commissioner Lindstrom," for donating his time to help out with the equipment last week. The department had been short a man in Garden Valley. Dill said, "He made a bid difference."

EXECUTIVE SESSION: A motion was said to have an executive session, closed session, to address a personnel issue. [Time 9:41am to 10:00am] No action required.

IT: Commissioner Lindstrom made a motion to approve an IT committee which includes all department heads, elected officials, and Steve Twilegar for meetings once a month.

IT ASSISTANT: Advertising for the job of an IT assistant was discussed by Clerk Mary Prisco. This position had been budgeted for.

NEW COUNTY WEBSITE: Commissioner Tucker informed those present that the developer of the new website for the county would be present during a commissioners' meeting to discuss aspects with each department head.

Boise County Sheriff's Office Fun Antics & Common Sense When Encountering a Slide-off

BOISE COUNTY -- A few tips on slide-offs from Deputy Squatch.

Y'all listen up, here's what to do if y'all find yourselves slidin' off the road in a snowstorm:

1) First things first, don't be a sitting duck! If you're slidin' off the road, chances are the next fella might too. Flash them hazard lights like a Christmas tree and scoot your boots to a safe spot. You don't wanna be playin' bumper cars out there.

2) Got signal on your cell? Ring up the police dispatch, tell 'em where you're at and that you've done a snow dance with your car. They need to know so they can figure out who to send and how fast to get there.

3) No signal? Well, shoot. Once you find some bars on that phone, let dispatch know what happened. Also, tell 'em your game plan for fishin' your car out of the snow. Cops can't hang around all day waitin', so they need to know your plan.

Remember, the police are gonna come check out most slide-offs. They'll jot down what happened and help out if they can. But they might be busier than a one-legged man

in a butt-kickin' contest, so it could take a bit for 'em to reach you.

If your ride's got damage over \$1,500, law says you gotta call it in. And don't worry, just 'cause they're makin' a report, don't mean you're in hot water. The most common ticket is for drivin' too fast for the slick roads. They'll snap some pictures and write it up for the insurance folks.

So, y'all drive safe now, hear? Buckle up, and remember, the Boise County Sheriff's Office is here to help when you're in a pickle.

Boise County Snowmobile Safety Tips

Basic Snowmobile Safety Tips

Well folks, we got our snow, and the sleds are ready to hit the mountains. Snowmobiling is a lot of fun, and many memories are made while up on the mountains. I hope this article will help you make many more and not let the unthinkable stop you in the future. I will cover basic safety tips; not enough room to cover the topic completely and in detail. The main objective is to get you out to have fun and back home again. The topics will be trip planning, communications, and basic gear.

TRIP PLANNING – The most important tip for trip planning is to ensure that you don't go out alone and that you tell someone where you are going, when you are leaving, and when you plan on being back home. If you don't show up on time, they can get someone out looking for you, increasing your survival rate. If you are new to an area, research the location. I suggest getting on social media and find the groups

that ride locally. They can give you information that could be vital to the area you are riding in. The last thing you want to do is check the weather forecast and avalanche warnings for the area. For avalanche warnings, simply go to avalanche.org.

COMMUNICATIONS – There are so many options here, yet the most basic is your cell phone. On the mountain you can normally find spots of reception and be able to call for help. If you can't get reception, check to see if the SOS option is available on your phone. It will always allow you to make emergency calls and texts via satellites. Each phone is different, so research how to use yours prior to your trip. A GPS would be useful also. It will help you get back to your starting point, and if you are able to contact someone, you can give your location. There are a lot of phone apps that will track your progress on a trip and let you backtrack to your vehicle. OnX is a great one and I use it a lot in the mountains. With modern technology you can get emergency satellite phones.

They normally get reception most places and allow for limited calling. This is on my must-buy list this spring. If you are riding in Avalanche areas (most Idaho riding), investigate an Avalanche Beacon. If you get trapped by an avalanche it sends a signal with your location. This could be a life saver. No matter what devices you choose, ensure the batteries are fully powered when you leave your vehicle. The cold weather discharges batteries faster.

BASIC GEAR – This topic is big, and I will only go over the basics. Just think to yourself if I am stuck on the mountain for a night, what do I want or need to survive? There is so much information on this topic and I suggest reading up on it and being as prepared as you can be. Always ensure you have food and water. Pack easy food like jerky and so forth. It doesn't take up a lot of room and will provide you with the calories you need to survive till help comes. A shovel is a must so you can either dig out your sled or make a place to stay the night. Waterproof matches,

a lighter, and some firestarter will help you keep warm and dry off. Under the bows of a big pine is the perfect place. I ate a lot of lunches and dried my clothes while resting under a big pine. A small first aid kit would be helpful in case you get hurt. Silver emergency blankets will help keep you warm and they take up little space.

These are just basic tips and not meant to cover everything. We all go out and the goal is to have fun and make a lot of memories when riding. Hopefully, this information will help you get home if the unexpected should happen. Most of these tips can be useful both in the winter and the summer. Have fun sledding.

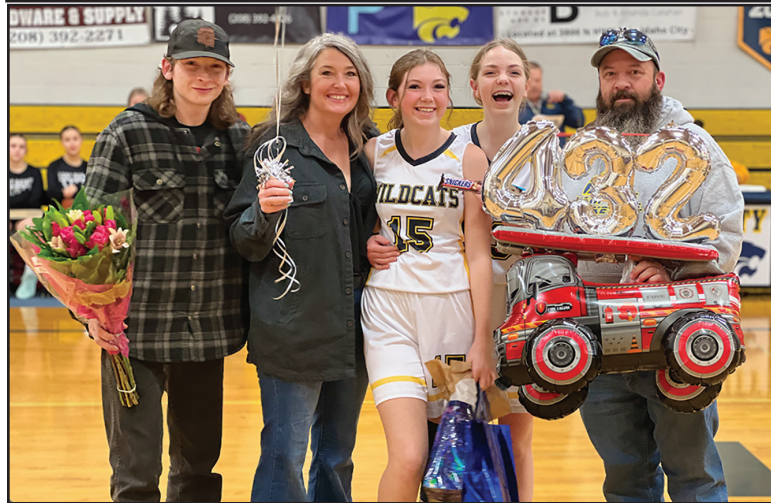

Horseshoe Bend Basketball

HORSESHOE BEND

Boys Basketball: Horseshoe Bend finds themselves in third place in the A1 DII Long Pin conference with a 3-3 win/loss record behind first place Cascade (4-0) and second place Garden Valley (5-1). A 71-42 loss to the Garden Valley Wolverines at home on Monday, 1/15 and a 68-52 win in Rig-gins against the Salmon River Savages kept the varsity team even.

The Mustangs are on the road to Cascade to take on the first place Ramblers on Thursday, 1/25 (JV at 4:30, Varsity at 7:30) and at home for a non-conference matchup against the Notus Pirates on Saturday,



The Horseshoe Bend Boys Junior Varsity team fell to Garden Valley at home on Monday, 1/15. Their district tournament will be in Garden Valley on February 2, time TBD.

1/27 (JV at 3:30, Varsity at 6). They will play host to the Ramblers on Monday, 1/29 (JV at 5, Varsity at 7:30) before traveling to Midvale to take on the Tri-Valley Titans on Tuesday, 1/30 (Varsity only-7:30).

Statistical standouts for the

season are senior Layth Bromgard who is leading in points per game (18, 252 total for the season), rebounds (14.9 per game) and assists (2.9 per game). Senior Kaelun Jones is leading in steals, with an average of 3.1 per game, 43 total for the season. The Mustangs are 8-6 overall for the season.

Girls Basketball: The Horseshoe Bend Varsity Girls are 2-8 overall for the season, but have not been able to get a win in their 1A DII Long Pin Conference yet. A 27-39 loss at home on Monday, 1/15 against Garden Valley followed by a 27-53 loss on the road at Salmon River on Saturday, 1/20 did not improve their last place standing.

The Lady Mustangs have a chance to improve their standing as the season winds down. With only three games left in conference play, Horseshoe Bend needs a win. The team will be in Cascade against the Ramblers on Thursday, 1/25, at home against the Ramblers on Monday, 1/29, and at Tri-Valley against the Titans on Tuesday, 1/30. All games have a 6:00 p.m. tip off time.

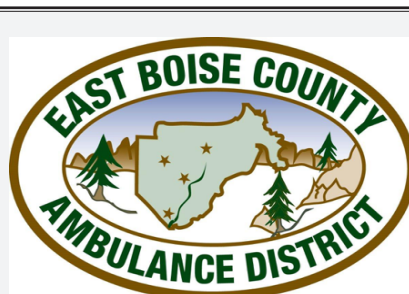

BOISE COUNTY -- One of the more interesting buildings in Idaho City is the Boise County Courthouse located at Main and Wall Streets. Boise County Court House was originally built by Reverend C.S. Kingsley as a general store. As an excellent example of fire prevention measure, they used bricks instead of wood and the future courthouse was built to be fireproof in 1873 following Idaho City's most destructive fires, the first on May 18, 1865 and the second on May

17, 1867, which destroyed almost all of Idaho City's earliest buildings. It is also the most formal and best crafted institutional building in Idaho City. With concerns of fire after Idaho City had already burned down, it was decided to be built with bricks and the doors would be of solid folding iron doors, each weighing a half ton. Doors were made in San Francisco, barged up the Columbia River, and carried overland by horse and ox teams to Idaho City. The attic was filled with three feet of dirt as a precaution

and preventive to fires. Reverend Kingsley sold the store in 1880 to John Kennally, a local miner and merchant. Kennally used the store as a hardware store. He sold hardware, glassware, and harvesting machinery. In 1880, Kennally rented the store to Alex and Mary Orchard, who then converted the building into the Orchard Hotel. In 1909, Boise County bought the building for \$1,000 and brought it into another new life as a courthouse and offices.
