## Residents Residing Within the Idaho City Fire Protection District

**IDAHO CITY** -- The City of Idaho City will be hosting a special meeting regarding the Idaho City Fire Protection District's leased property with the city and has asked for the members of the Idaho City Fire District to join them on March 20th at 6pm. This meeting will be held at the Idaho City Community Hall, 206 W. Commercial Street, and the city highly encourages the public to attend and have their voices heard. This meeting will not be available by Zoom. Comments may be dropped off at City Hall or sent to [idahocityclerk@cityof-id.org](mailto:idahocityclerk@cityof-id.org), 511 Main Street, no later than Wednesday, March 20th at 8am. Clerk Nancy L Ptak, City Clerk/Treasurer, encouraged folks to, "Please come join us, if you have any questions feel free to contact city hall at 208-392-4584."

The city did not respond with a statement in time for publication; however, in the November 1, 2023, edition of the *Idaho World*, within the detailed coverage of this city council meeting, the subject was discussed at length. Mayor Kenny Everhart stated that the building was, "an asset of the city... and for twenty years it was administered, and it was maintained, and everything was done by the city. Paid for by the residents of the city. There were no funds paid by what is now the Fire District."

The city attorney Joan Callahan added, "We cannot give away real property. There has to be something of value, and once or when that exchange is through, you're supposed to be accountable for that amount or exchange."

At the time of this Novem-

ber meeting, the Fire District's representative Brent Adamson offered a donation of \$65,000 to the Public Works Department, from the fire district, should the city be willing to offer the building in exchange. In this November meeting, Adamson recounted that in about 1994-95, the Idaho City Fire District acquired a government entity grant to build a firehouse, and the city of Idaho City was asked by the firefighters to administer this grant. When the firehouse was completed, the city neglected to transfer the deed back to the volunteers, which was thought to be the agreement among all the volunteer firefighters that put in much of the labor and additional funds to construct the firehouse. Adamson recently submitted further history on the fire station, indicating, "In a move to provide satisfactory shelter for the fire trucks in the 90's, volunteers secured a grant for building a fire station. The grant needed to be managed by a government entity, and Idaho City agreed to this function. The fire fighters and community contributors provided the fundraising, labor, and materials for raising the building, and Idaho City contributed about 10% of the building cost in cash. The city then included the fire department in its budget, with a cash amount from \$4,000 to \$10,000 before the Protection District was created. The fire department held fundraising events and charged for incident responses to maintain its funding."

"When the Fire Protection District was put to a vote, it was easily passed, and those city residents would now have

a different entity taking care of the fire protection. Currently, the city leases the fire station to the Fire Protection District for \$1000/year; as they have been unwilling to transfer the building. The fire fighters feel that the Fire Protection District should have ownership of the building and property, as it was built by volunteers and their funding. They have every expectation that the equipment and building would be theirs to take care of with new taxpayers helping to bear the cost. The Fire District would like to expand and improve the existing building, but would need ownership of the facility before this could occur. Searching for grants has been a lost cause, as the district does not own its building, and that is required to qualify for grants."

"The other consideration is that the City is tightly constrained by a low fund balance in their budget. The Protection District has offered to make a donation to help them in their time of need. Perhaps they could put it to road repair or some other current need."

Attorney Callahan stated in the November meeting: "First of all, we need an appraisal, second part is to negotiate. They have kind of given you a first offer, although you can't take any action tonight. It seems to me, you have a potential willing seller and a willing buyer, and it's coming to agreeable terms that would be appropriate. To be mutually agreed upon. Once you have a comfortable level with 'yes,' we are willing to sell for this amount, 'yes,' we are willing to buy for the same, that's when we would go to the pub-

lic process." She added, "Now we have two parties willing to negotiate, now we just need to negotiate and see if we can come to terms with acceptable proposals. I would say it's hopeful." Mayor Everhart had said in this November meeting that the council was going in this direction, to accept the proposal, but he wanted an official appraisal.

The public meeting has been scheduled for March 20th at 6pm to determine the fate of the Idaho City Fire Station.

In addition, the Boise County Board of Commissioners will hold a Public Hearing on the

petition to create a Robie Creek Fire Protection District. The Public Hearing is scheduled for 11:00 a.m., Tuesday, March 19, 2024 at the Boise County Commissioner Chambers, 420 Main Street, Idaho City, ID. The proposed boundary map is available in the County Clerk's Office. The notice reads: "Any taxpayer within the proposed boundaries may, on the date of the hearing, appear and offer testimony pertaining to the organization of such a district, property boundaries thereof, or the inclusion or exclusion of any real property therein or therefrom."

**Present:** Commissioners Steven Twilegar, Clay Tucker, and Lindy Lindstrom

**Pledge of Allegiance**

**CONSTITUENT INPUT:** None

**MINUTES:** Commissioner Twilegar motioned to approve the minutes from February 27. The motion was approved.

**VOTING:** There were some concerns with voting at the Garden Valley School last year. According to Clerk Mary Prisco, "It was brought to my attention, some of the details of what happened at the last election in terms of, you know, school's still going on. There was basketball practice in the morning while they were trying to set up. It was sort of chaotic." She said there were also privacy issues. Sheriff Scott Turner mentioned that there were also concerns with registered sex offenders at the school. Clerk Prisco said a contract was drawn up between the LDS church and Boise County for the use of the facility. She explained that Steve Raddigan,

the Chief Judge, has submitted numerous photos, "Based on what I've received so far, it's a substantially better location to use." She brought up this topic to take care of the change in a voting location. The commissioners were also agreeable and commented that there would be enough parking. A motion will be made at a later time.

**RESOLUTION:** Prosecutor Alex Sosa spoke regarding two resolutions that were not properly noticed on an agenda and would therefore be void. Updated resolutions will be presented again to the board for approval. Commissioner Twilegar motioned, due to insignificant notice requirements, to make null and void Resolutions 2024-12 and 2024-11. The motion carried.

**RACE TO ROBIE CREEK:** Sheriff Turner said it was the same annual agreement that they provide every year. Twilegar motioned to approve the agreement to provide law enforcement services and traffic control. The motion carried.

**PLANNING & ZONING:**

Twilegar motioned to sign the amended Unified Land Use Ordinance 2024-02. The motion carried.

**COPIER:** Chairman Twilegar motioned to approve the lease of a new printer/copier for the Road and Bridge Department. The motion carried.

**DEMAND WARRANTS:** There was a demand warrant from the coroner for two autopsies in the amount of \$4,600. Twilegar asked if there were any questions and then commented, "There's not much you can say about that." He motioned to approve this invoice and the motion carried. He then motioned to approve the dues for the coroner with the Idaho Association of Counties in the amount of \$400. The motion carried.

**LEASE:** A motion was said to approve the payment for the 2022 Caterpillar in the amount of \$37,165. The motion carried. Another motion was made to approve the payment of \$38,257 for a 2022 Caterpillar to the bank. A third motion was made of \$39,261 for another

2022 Caterpillar. The motions were approved.

Chairman Twilegar then motioned to approve the payment for a "reader board" and batteries in the amount of \$13,910. The motion was approved.

He then motioned to approve a payment to a vehicle dealership for a "P-29 repair exhaust after treatment system" in the amount of \$6,812. The motion carried.

Twilegar motioned to approve the payment for the audio system in the Commissioners' room in the amount of \$2,905. The motion was approved.

**COUNTERFEIT BILL:** Twilegar inquired if the counterfeit money was taken at the Sheriff's office. The Treasurer asked to be reimbursed for the amount. Clerk Prisco said that both the Sheriff's office and East Boise County Ambulance District accept cash, and the transmittal indicated it was from either department. Clerk Prisco said, "I think if it was the Sheriff's office, that would be really bold." Twilegar chimed in, "Or ignorant. I could guar-

antee you, everybody in this room has passed counterfeit money." Sheriff Turner said that counterfeit money does come in to his office. Prisco said that this particular bill it took three strikes of the special pen to actually reveal that it was a counterfeit. Commissioner Tucker inquired how often this happens, and Clerk Prisco said it was the first time in her recollection, "but they're getting *really* good."

An individual mentioned that there were likely several circulating through town. Sheriff Turner agreed and said, "We've had quite a few businesses in town get counterfeit bills in the last year. And a lot of it stems from the groups that travel through the valley and they pass counterfeit money around the valley, and they bump up here every once in a while. It's a thing."

Twilegar motioned to approve the demand warrant for \$100, "because we got counterfeited." The motion carried.



The following is some of the history of our great state of Idaho. Idaho became a territory on March 4 of 1863. It went on to become a state on July 3, 1890. We were the 43rd state in the United States. There is an interesting fact about the date of our statehood. The original Idaho delegation wanted our date to be on the 4th of July. When they went back to D.C., they learned that to have our star added to the flag that year, we had to become a state prior to the 4th of July. Benjamin Harrison signed the law, and the rest is history. The date was accepted, and we became a state on the 3rd of July 1890.

**State Name** – There are many different reports on how our state got the name Idaho. The most accepted, for a long time, was that it was a Native American name “E-Da-Hoe” meaning the Gem of the Mountains. Later it was found out there was no Native American word, and it was just made up. There are no historical records that document who started using the name.

**State Nickname** – Idaho has the nickname “The Gem State” We got the name for the same reason as mentioned above. The nickname first came into
